**DESCRIPTION**

FIG. 1 is a perspective view of a top of a dental flosser in accordance with the present invention.

FIG. 2 is another perspective view of the top of the dental flosser of FIG. 1.

FIG. 3 is a plan view of the top of the dental flosser of FIG. 1.

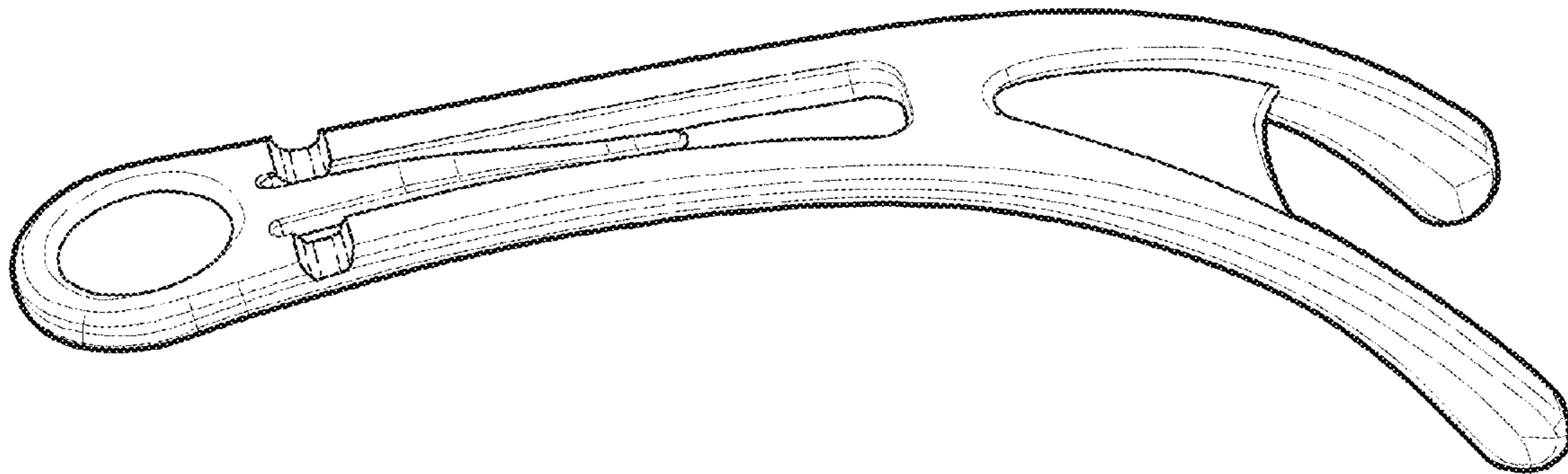
FIG. 4 is a plan view of a bottom of the dental flosser of FIG. 1.

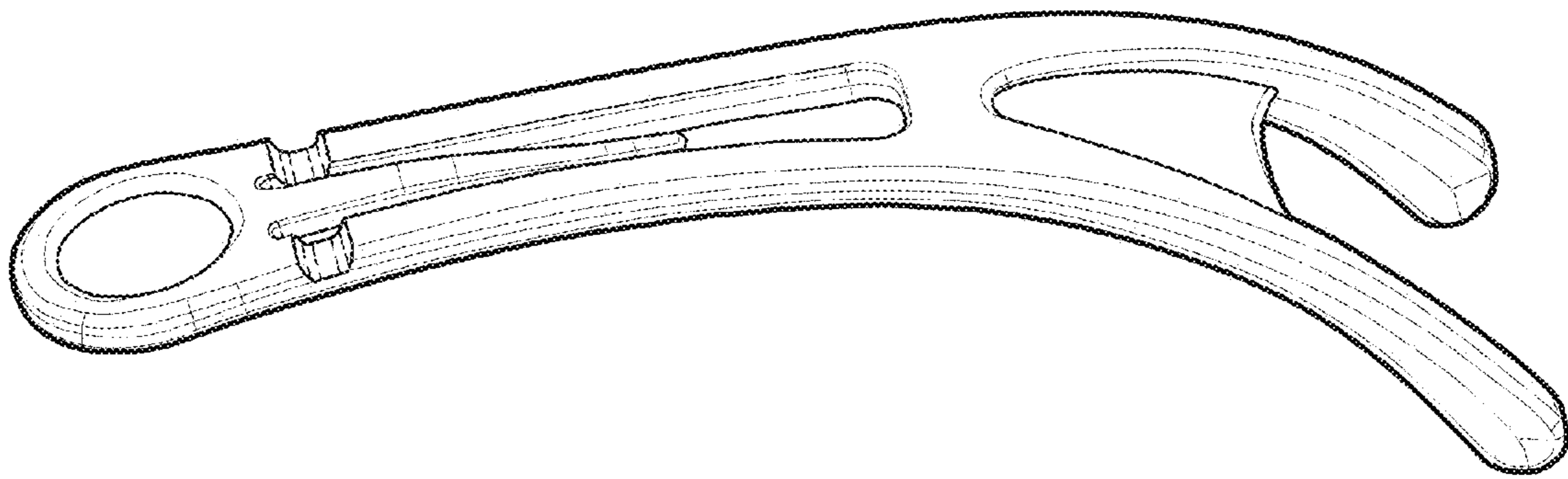

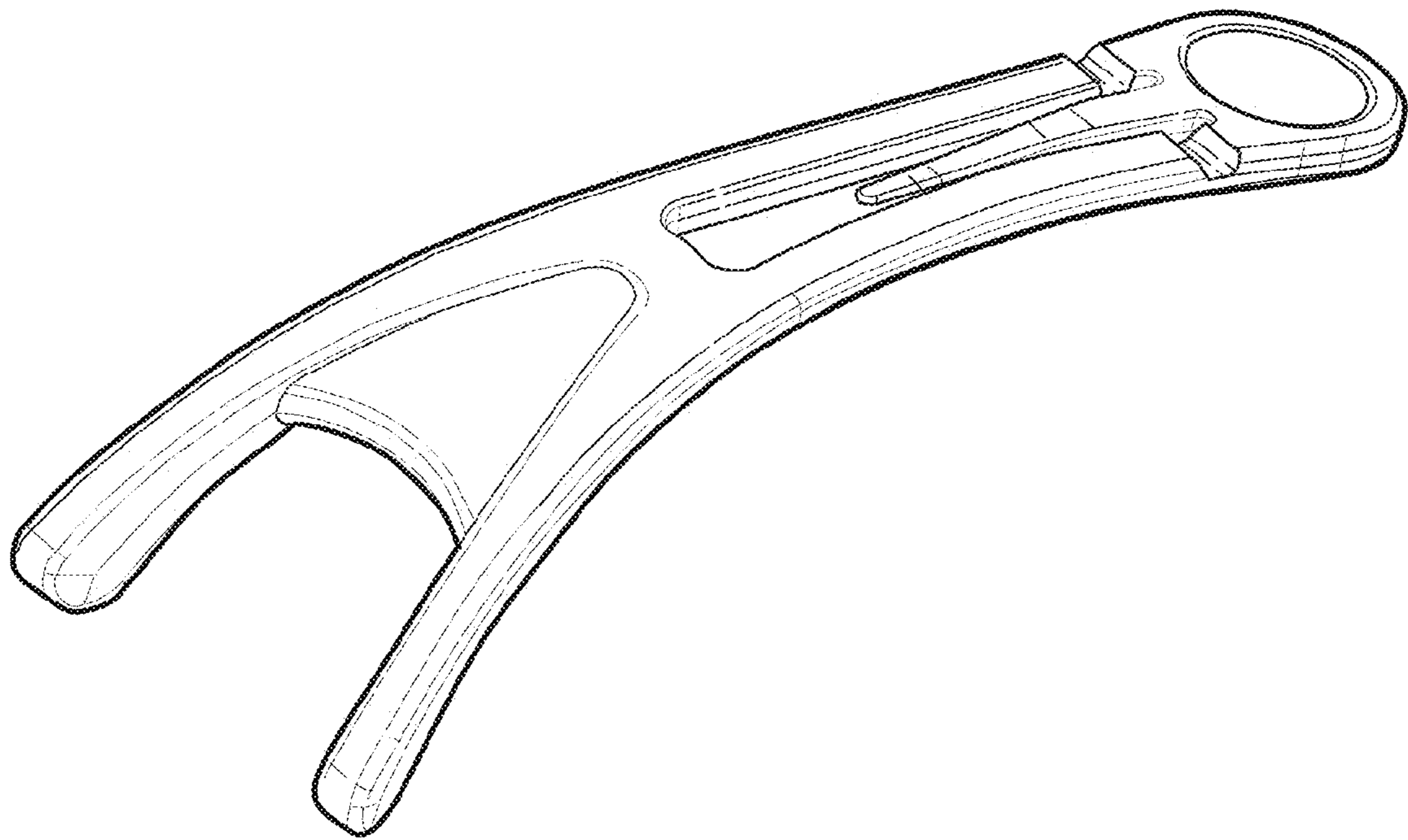

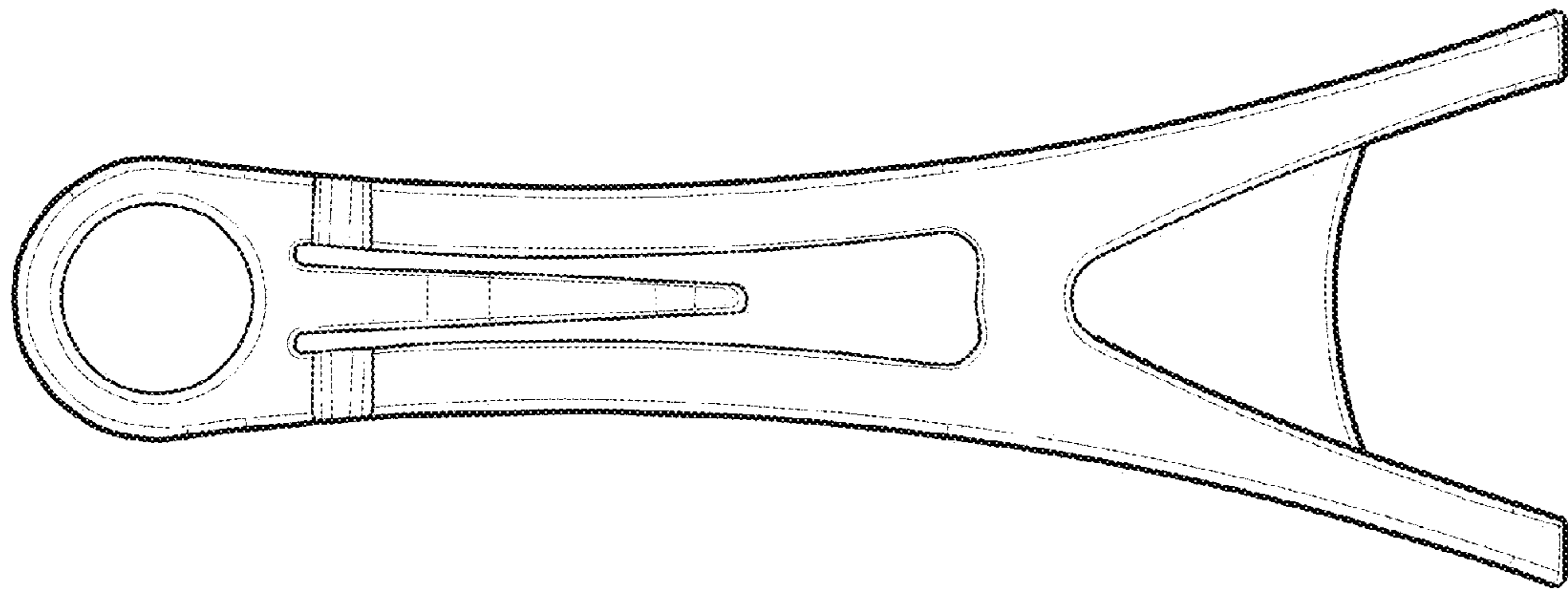

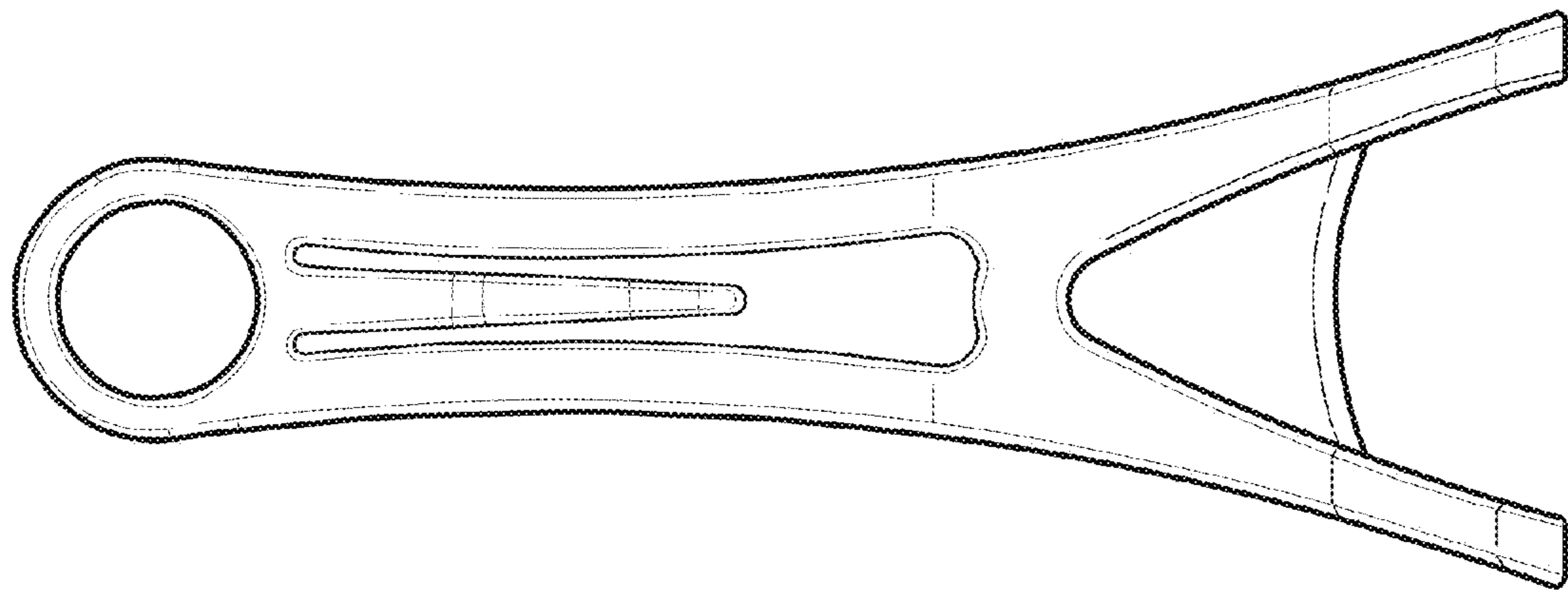

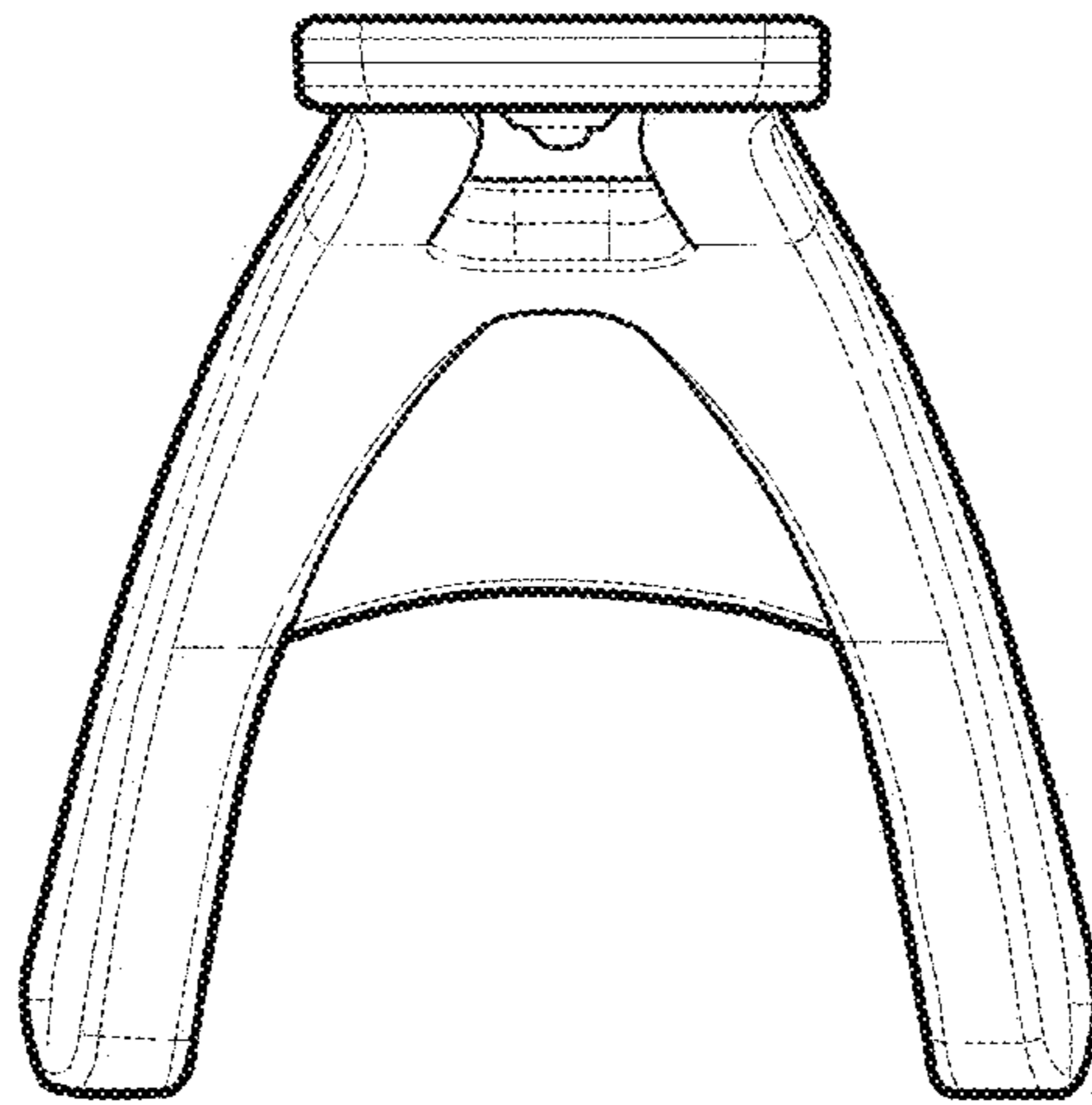

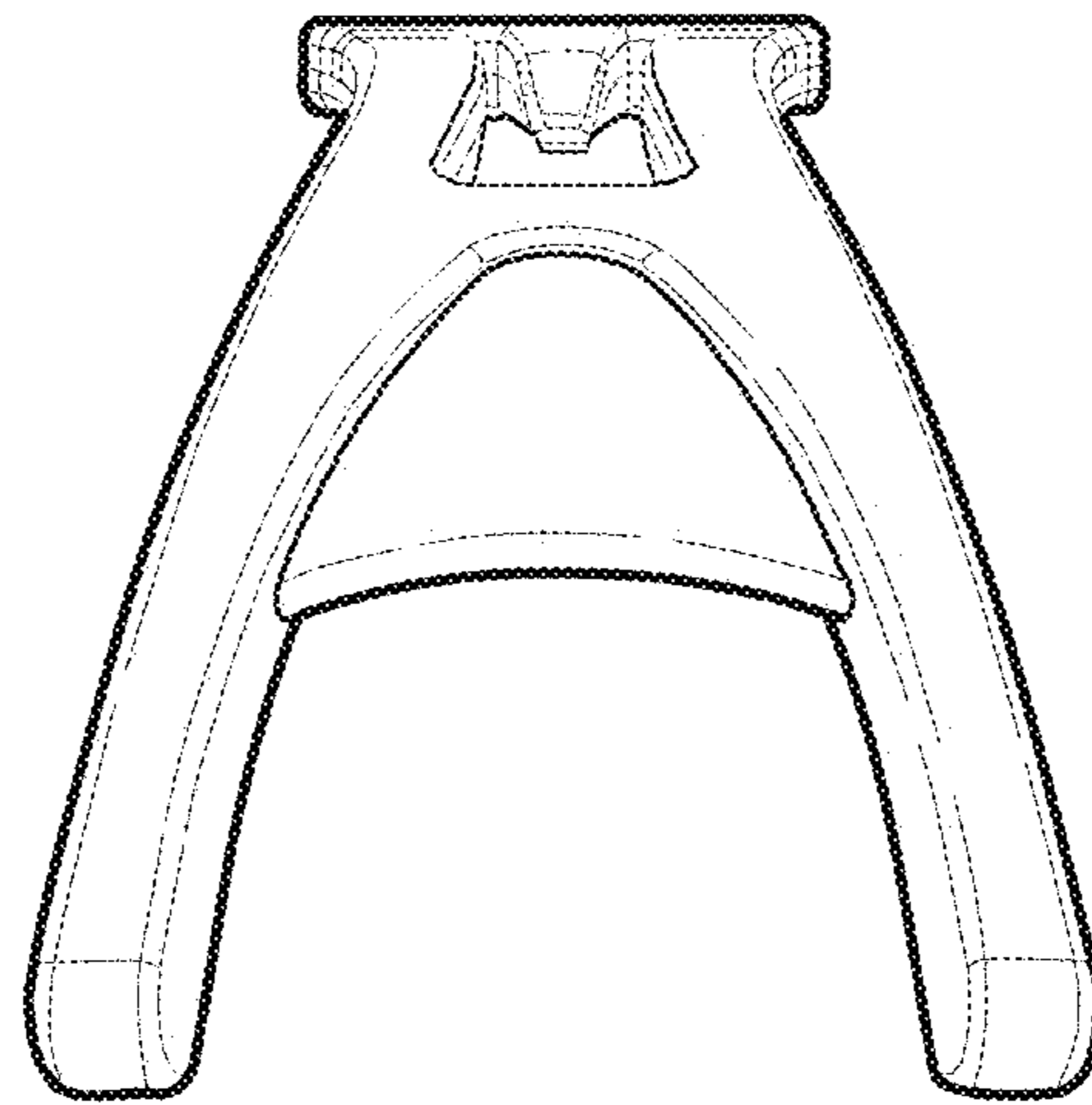

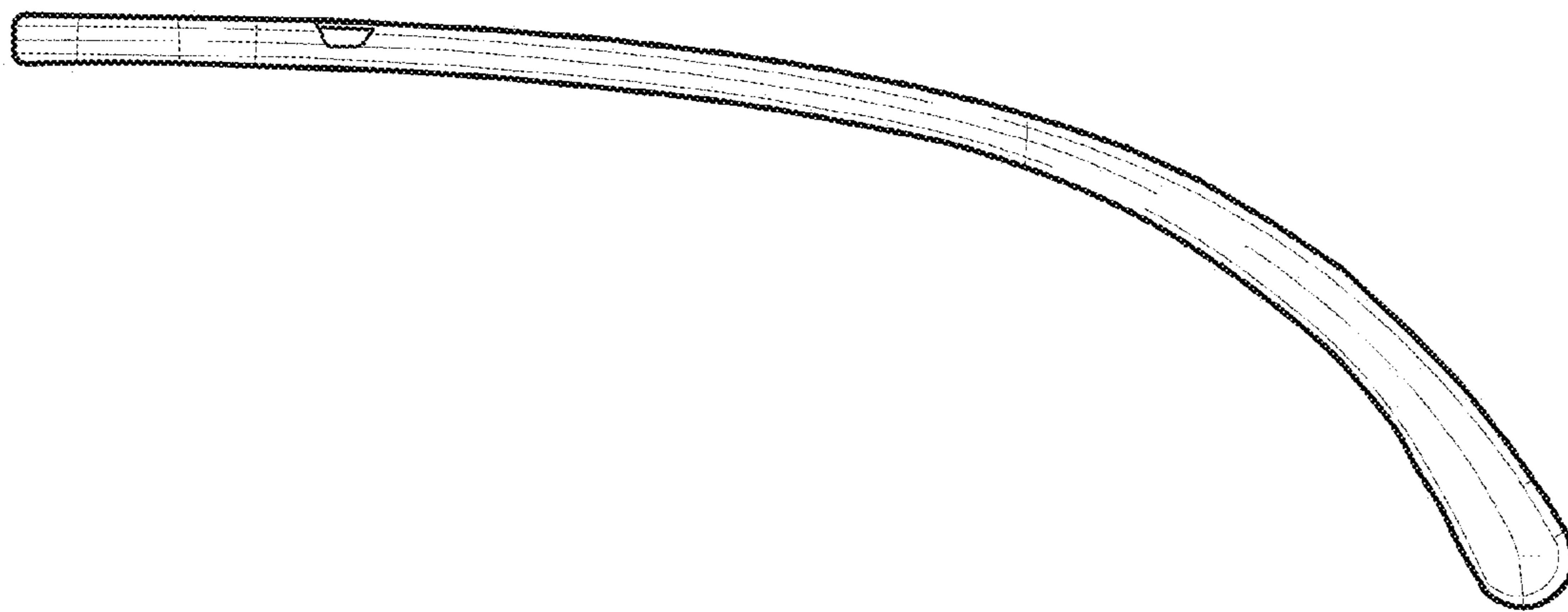
