The ornamental design for a cleaning article, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the new design for a cleaning article;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof, a right side view being a mirror image thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is a top view thereof.
The portions of the cleaning article in FIGS. 1-6 shown in broken lines are included to show features that form no part of the claimed design.

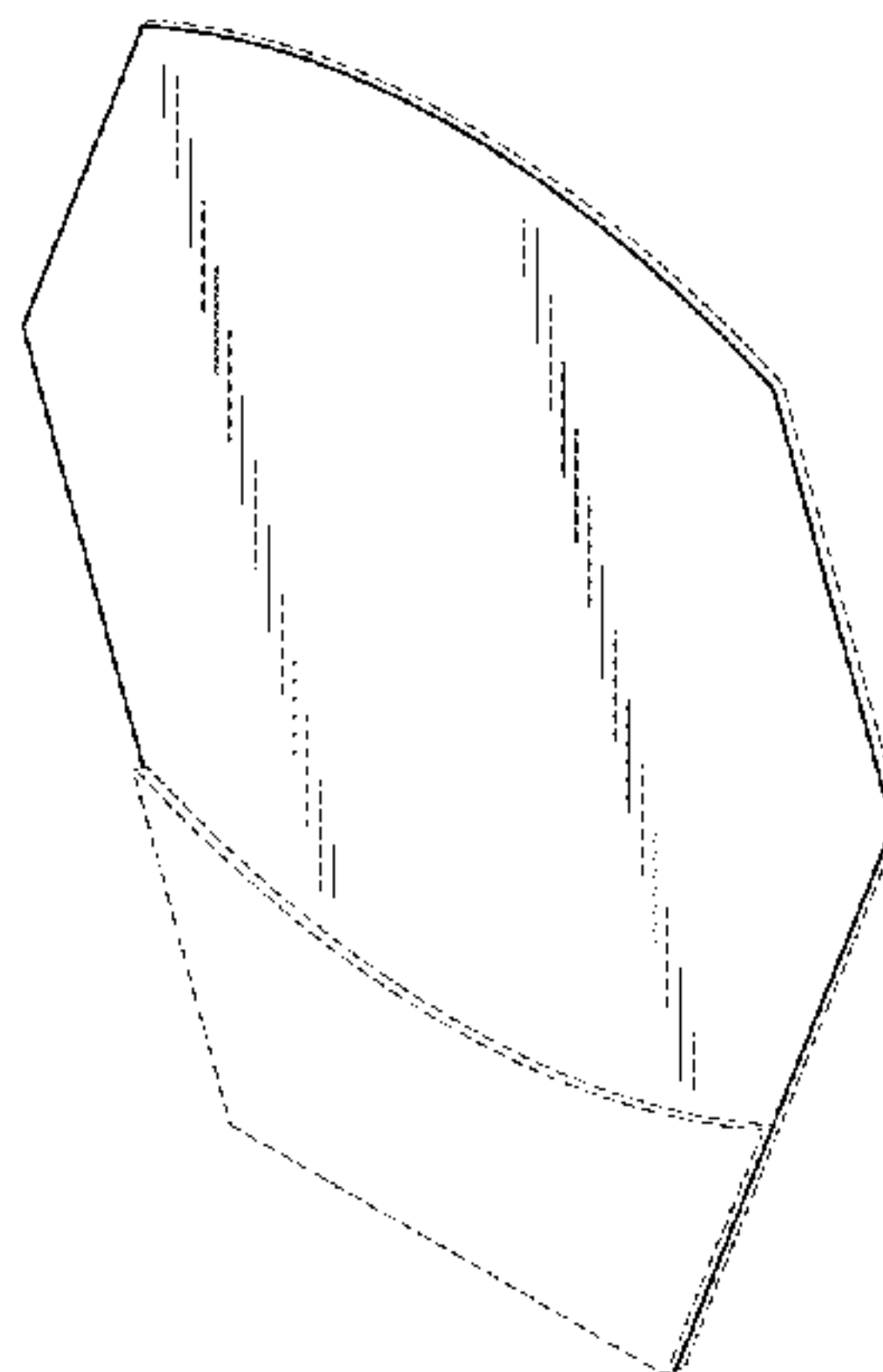

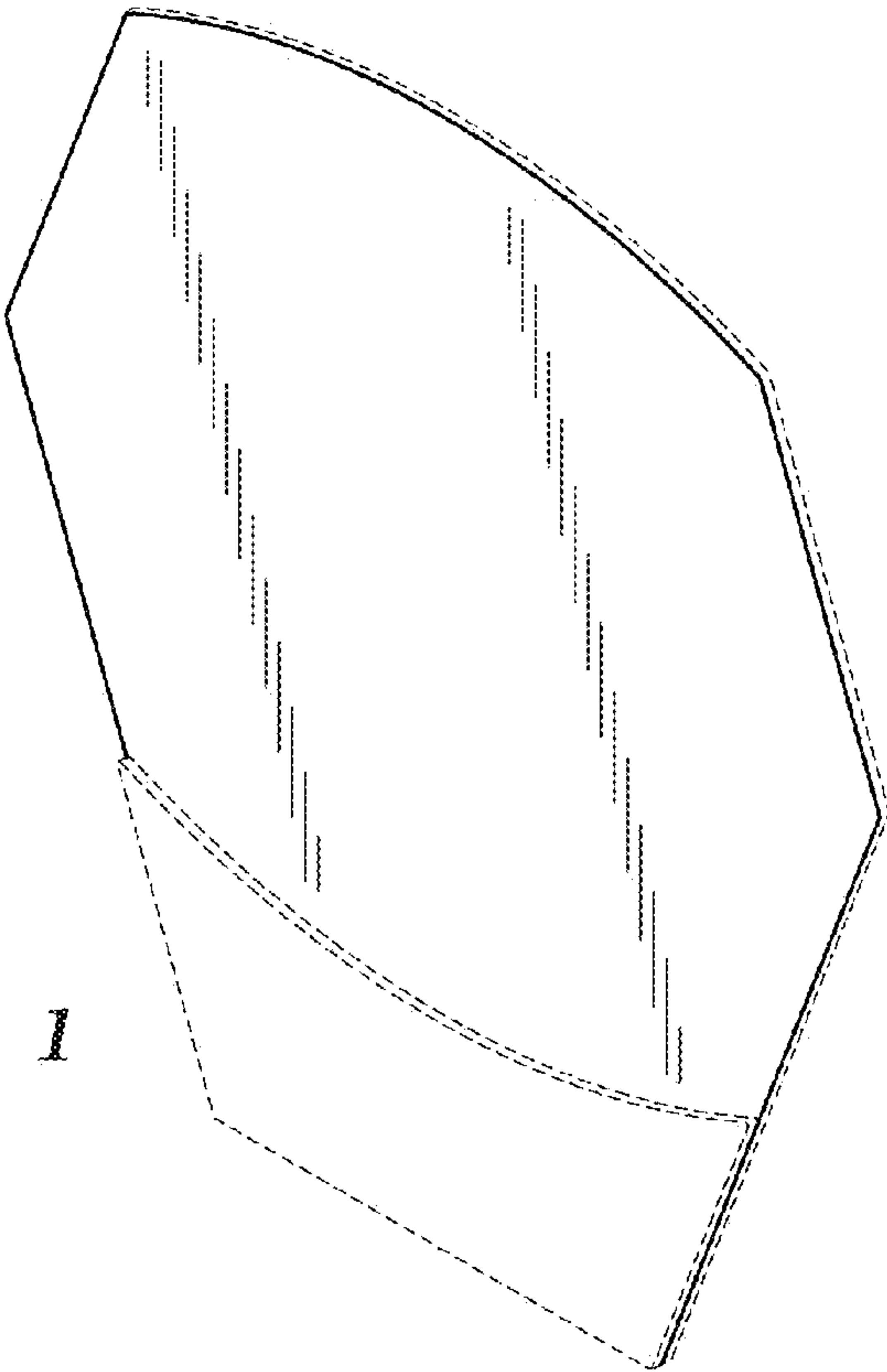
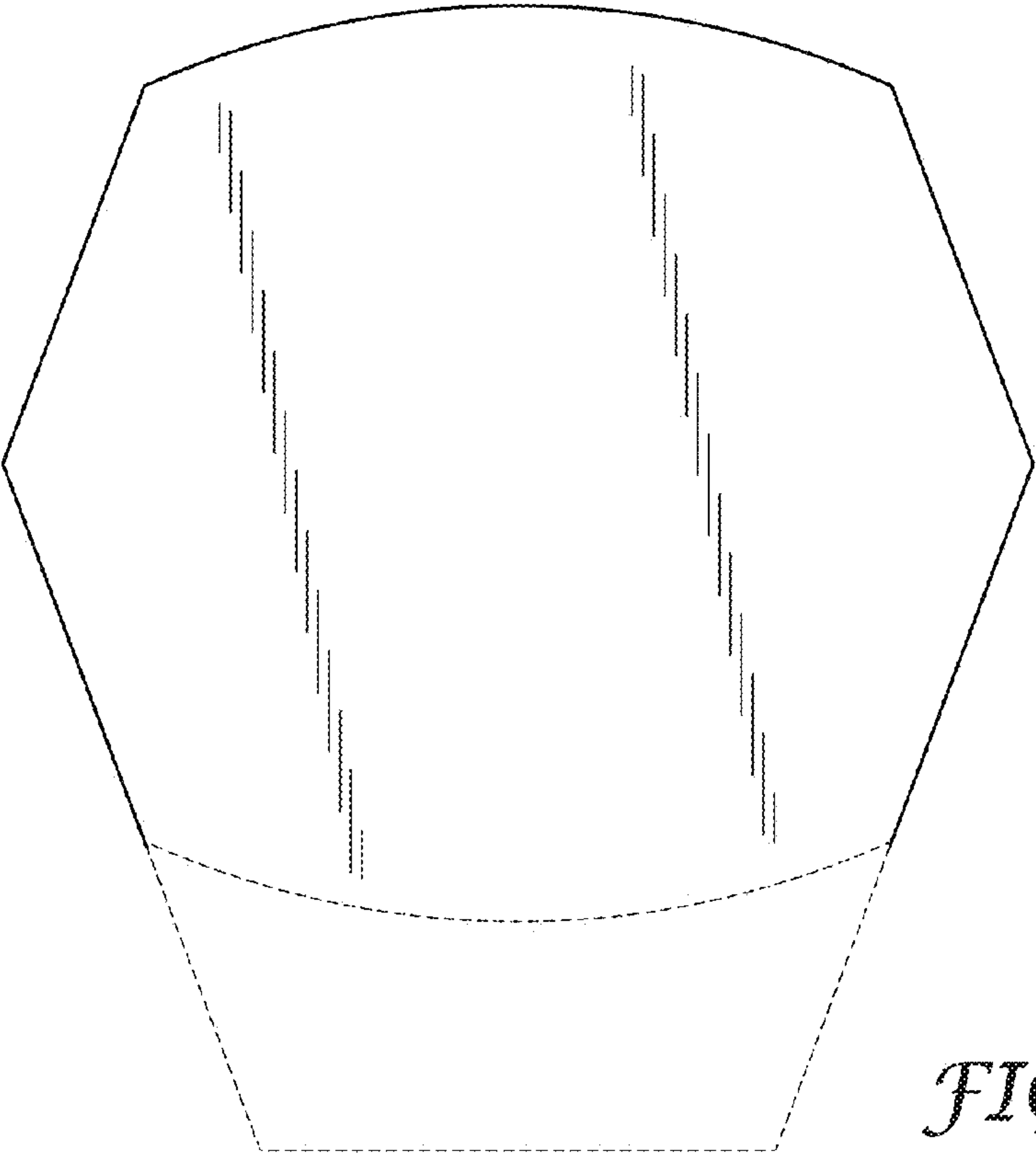

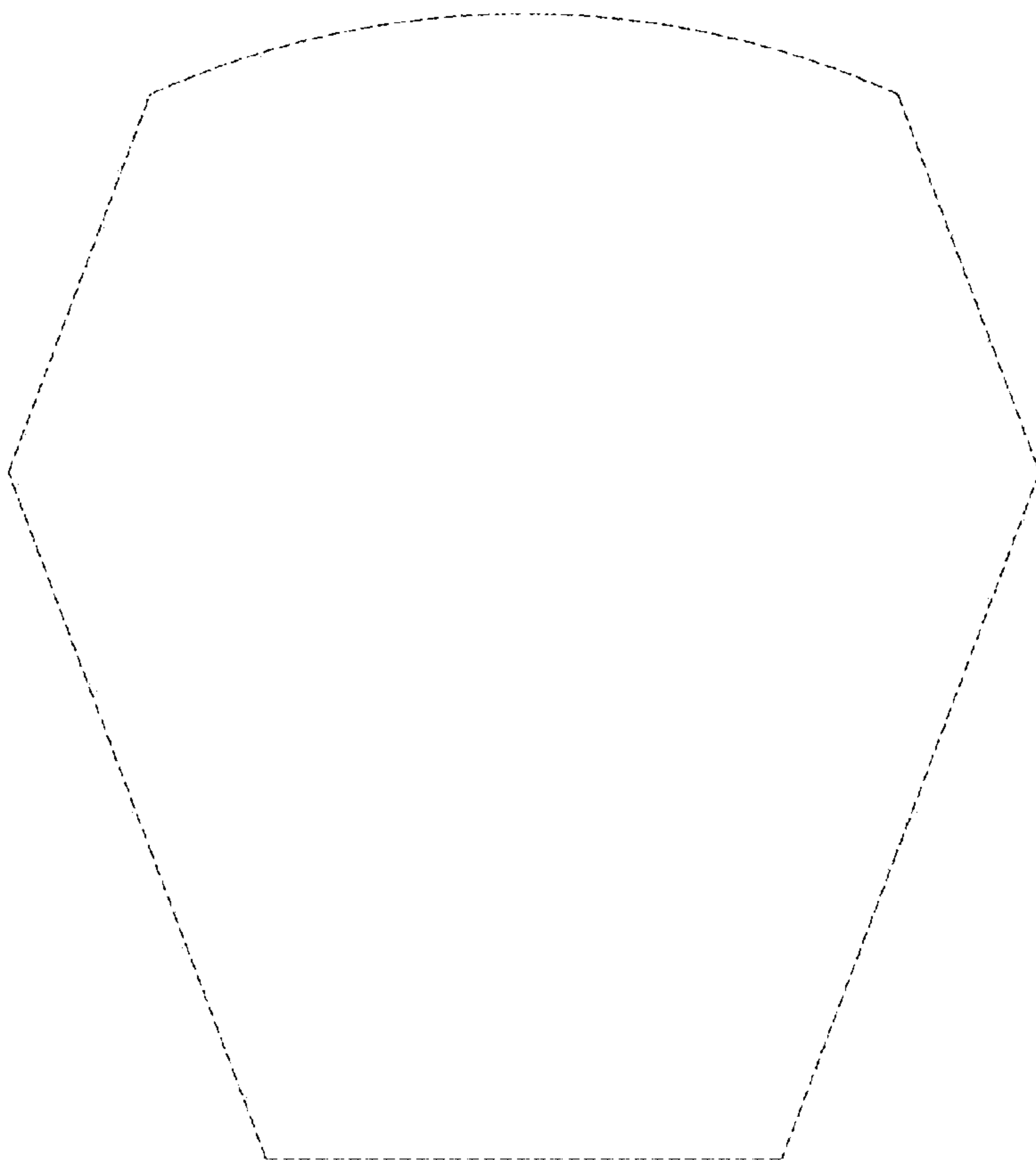

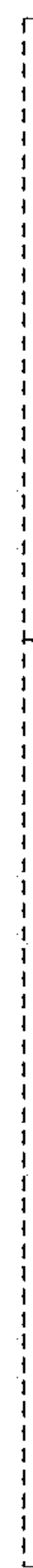

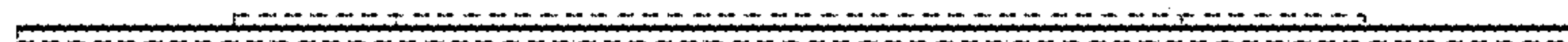
