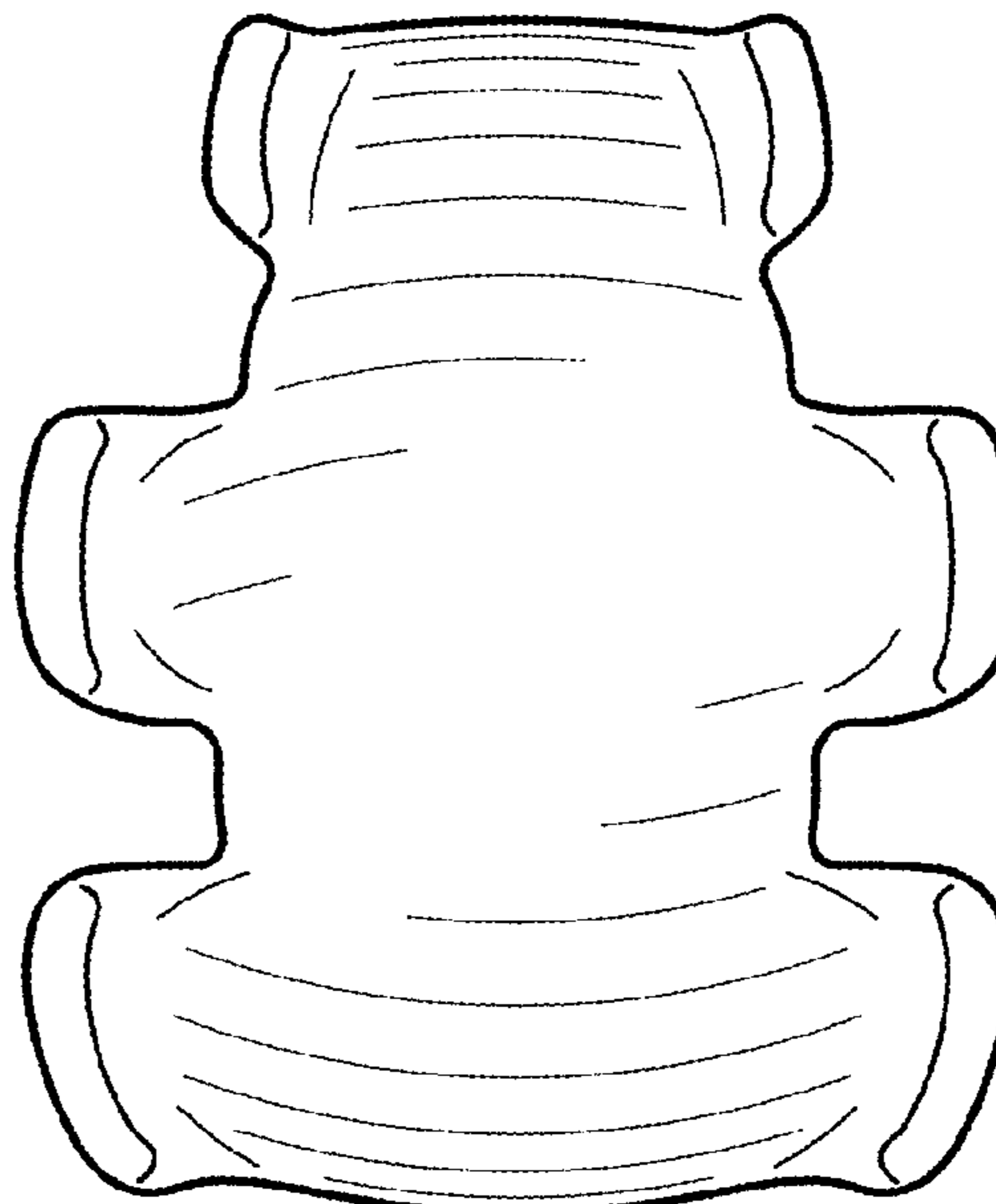
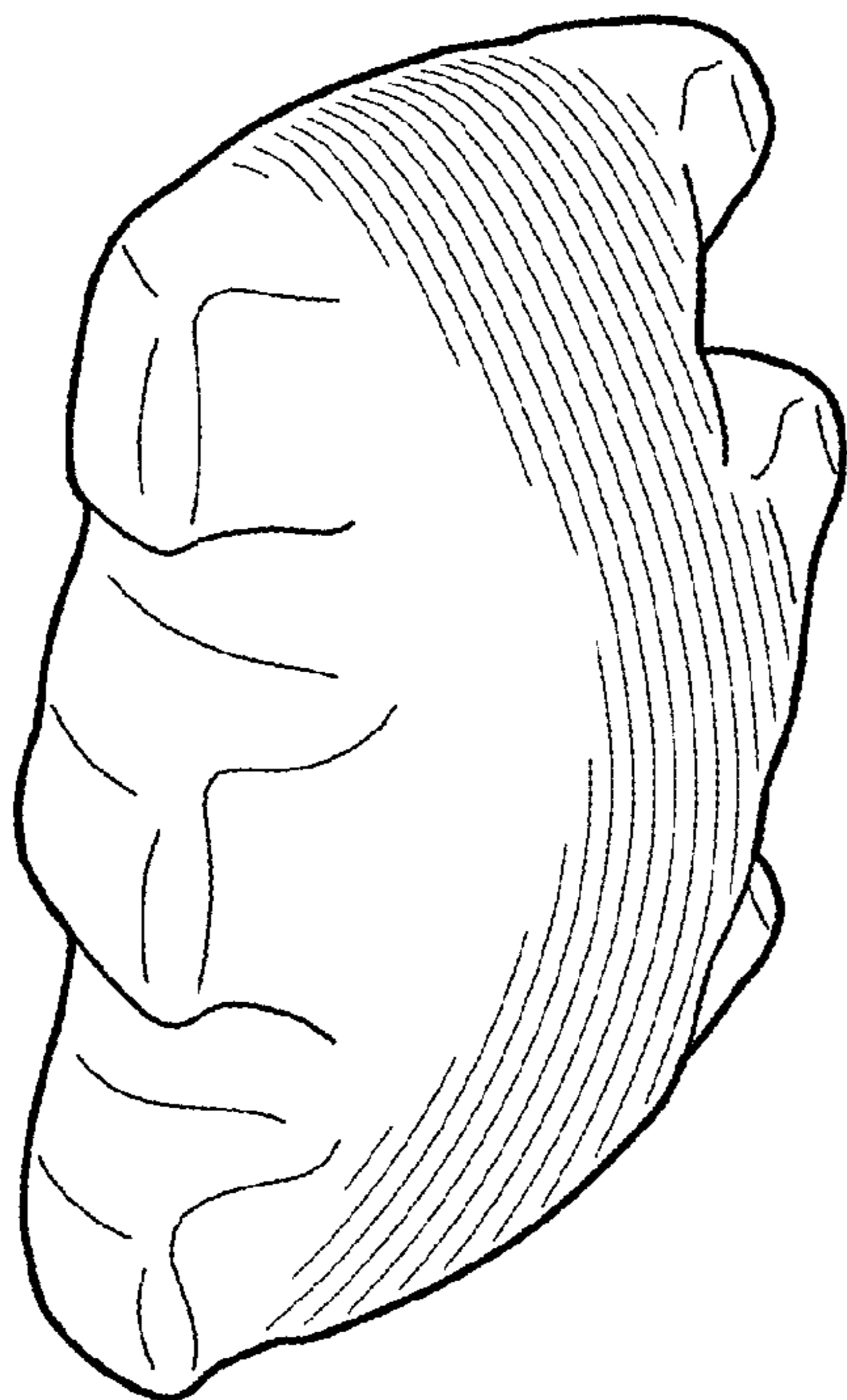

The ornamental design for a kibble, as shown and described.

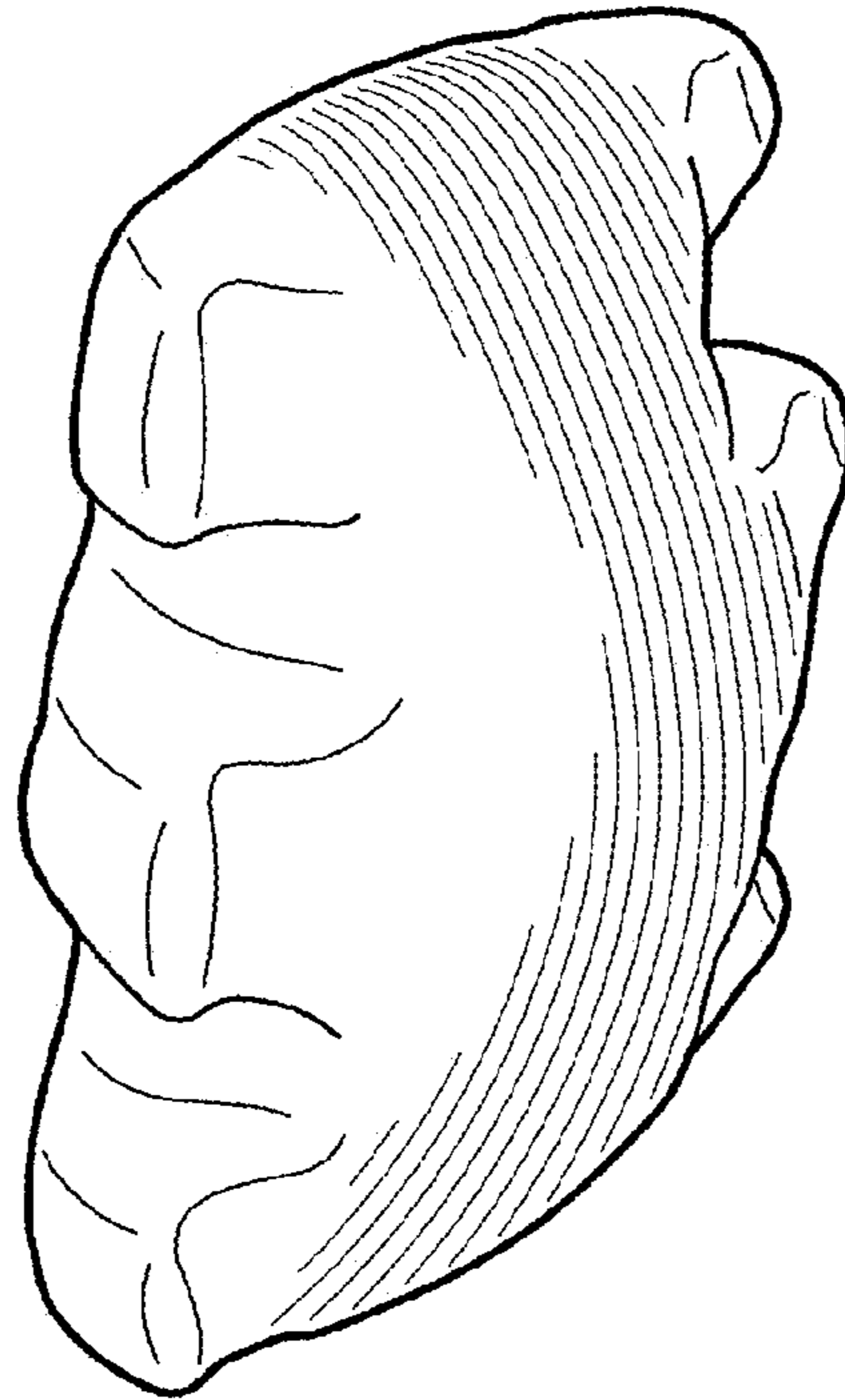
**DESCRIPTION**

FIG. 7 is a second side elevational view thereof.

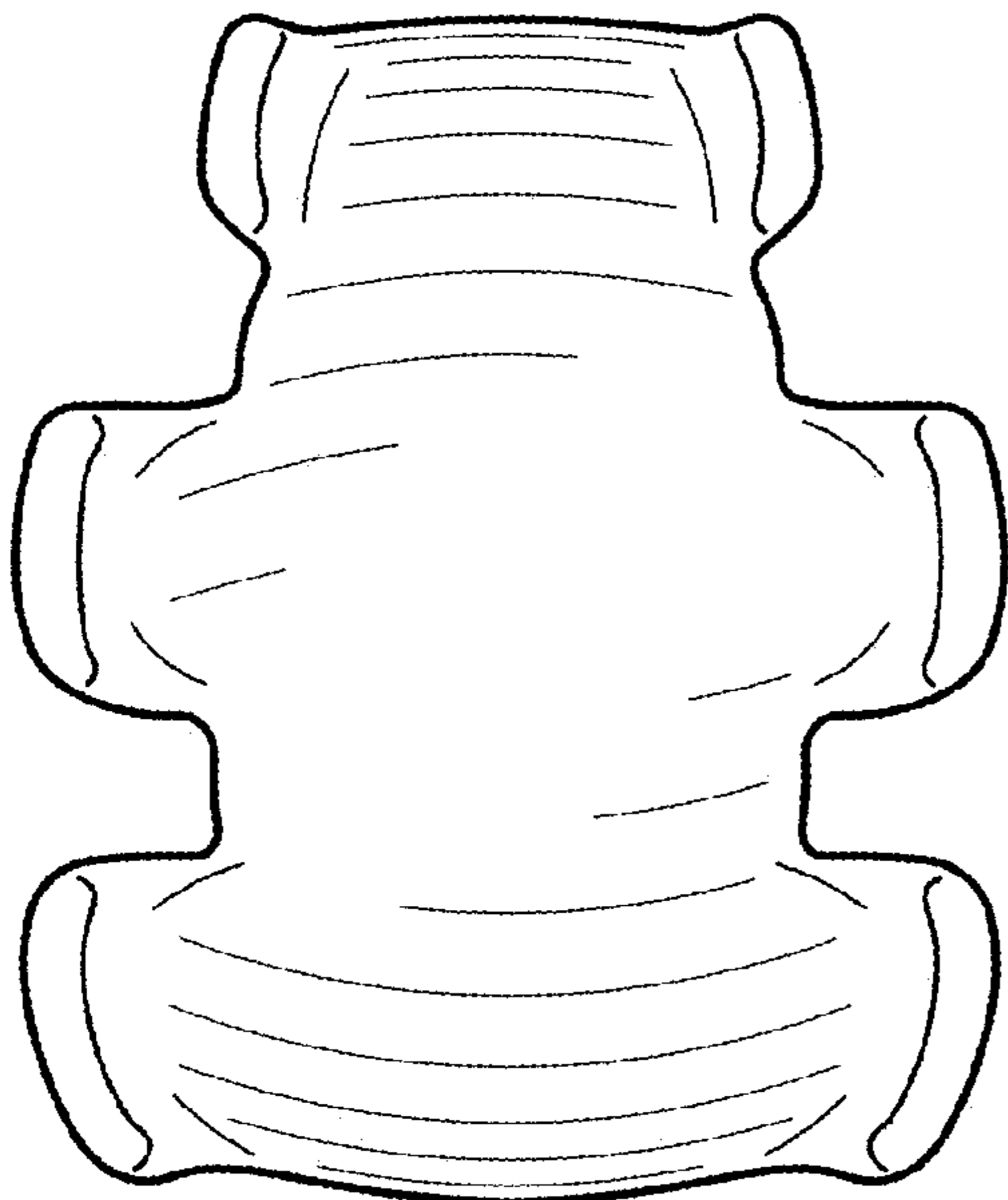

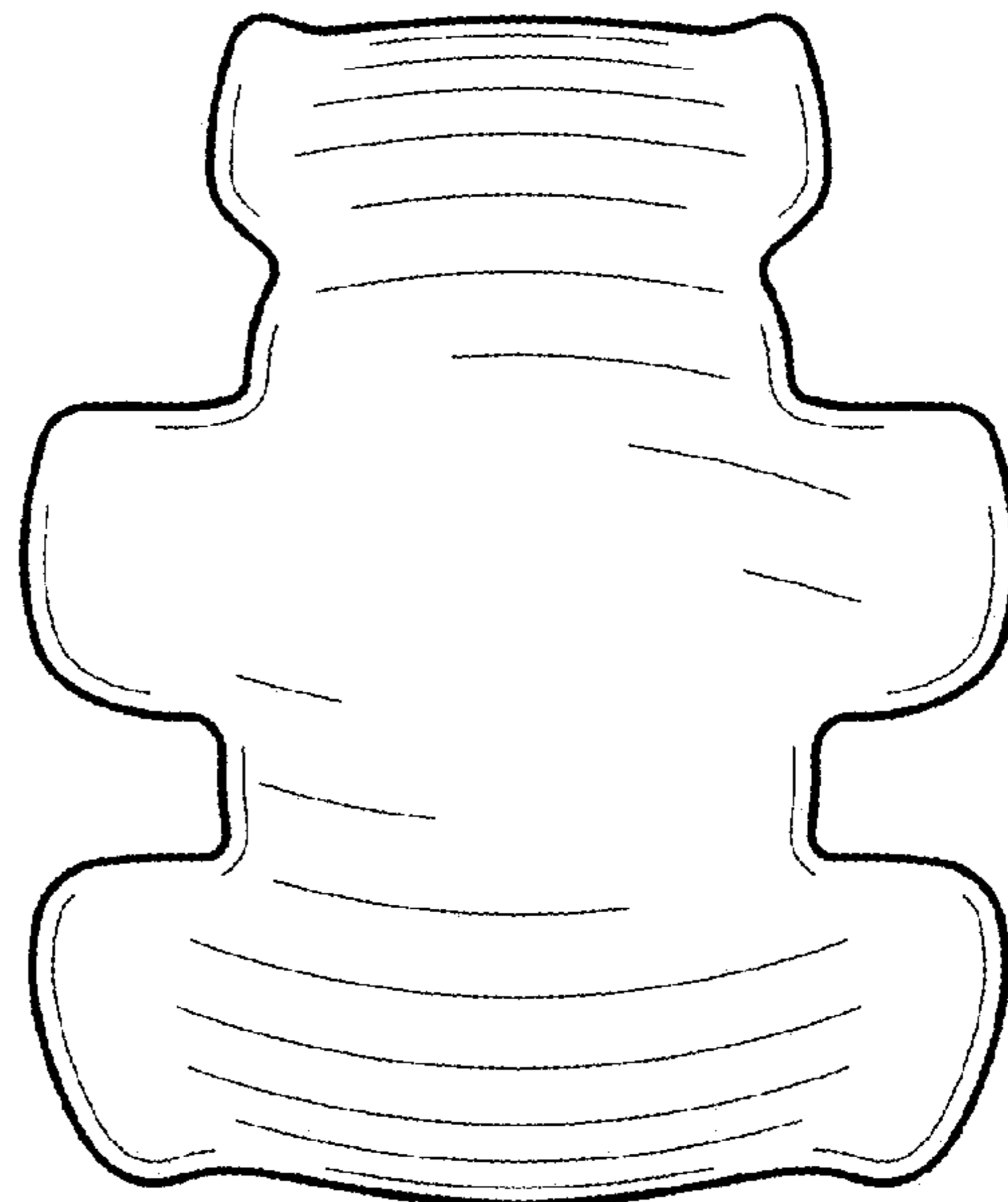




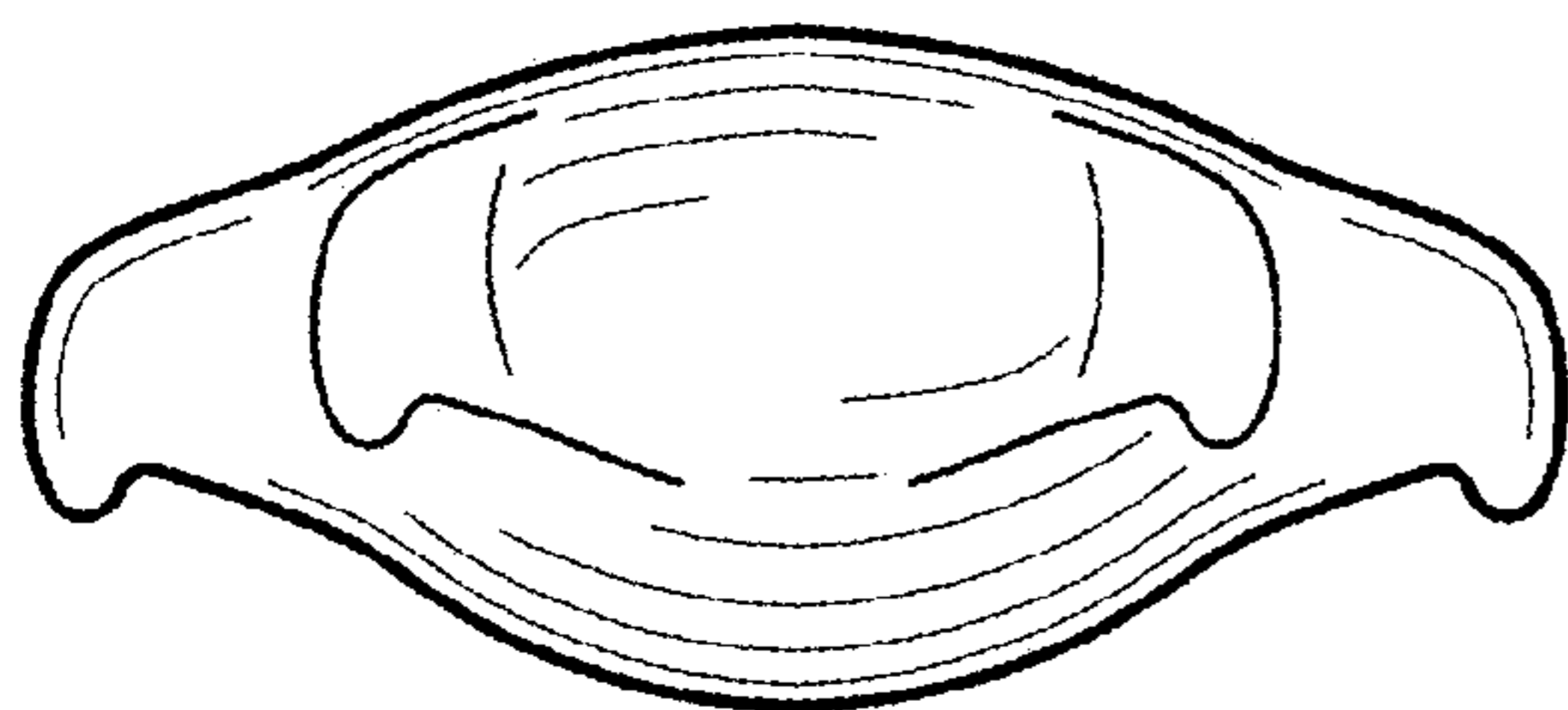

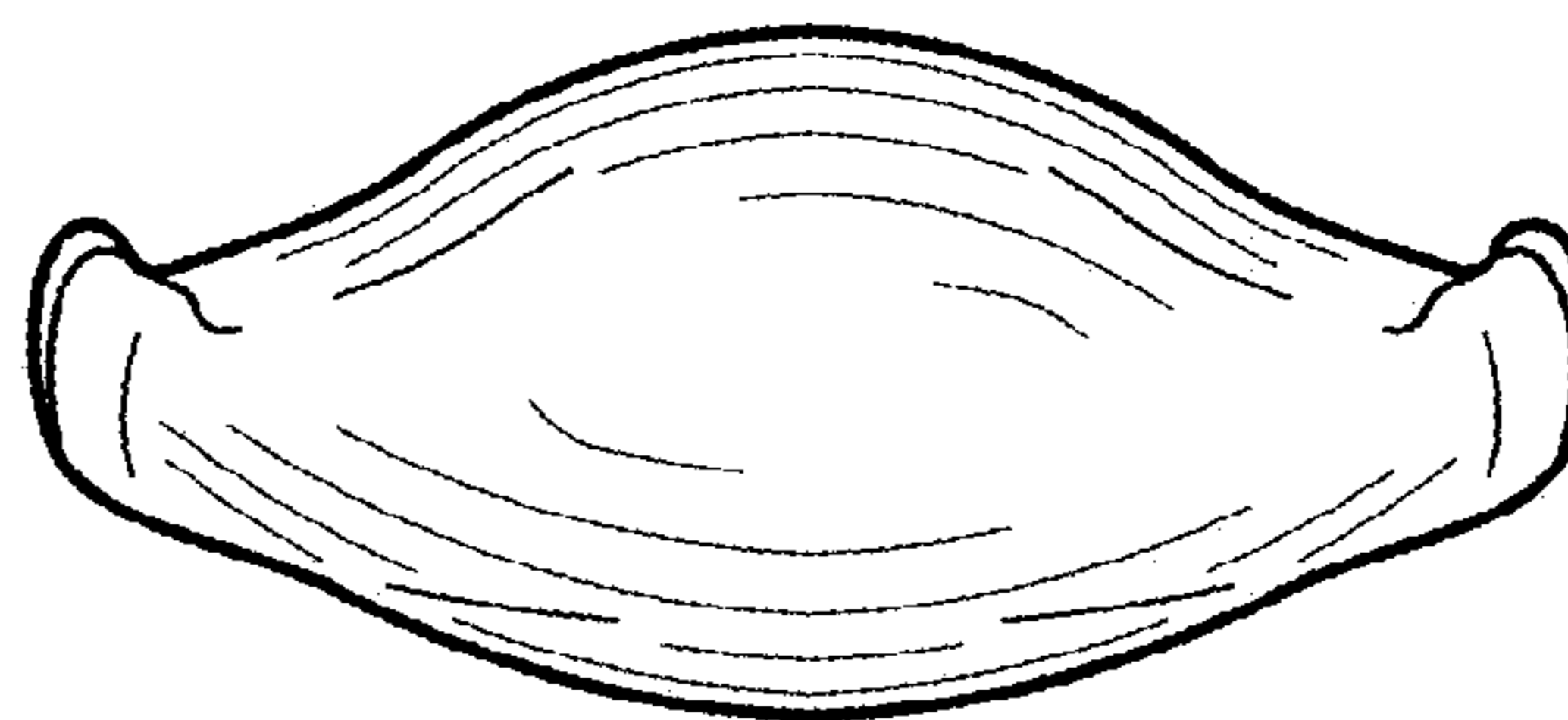

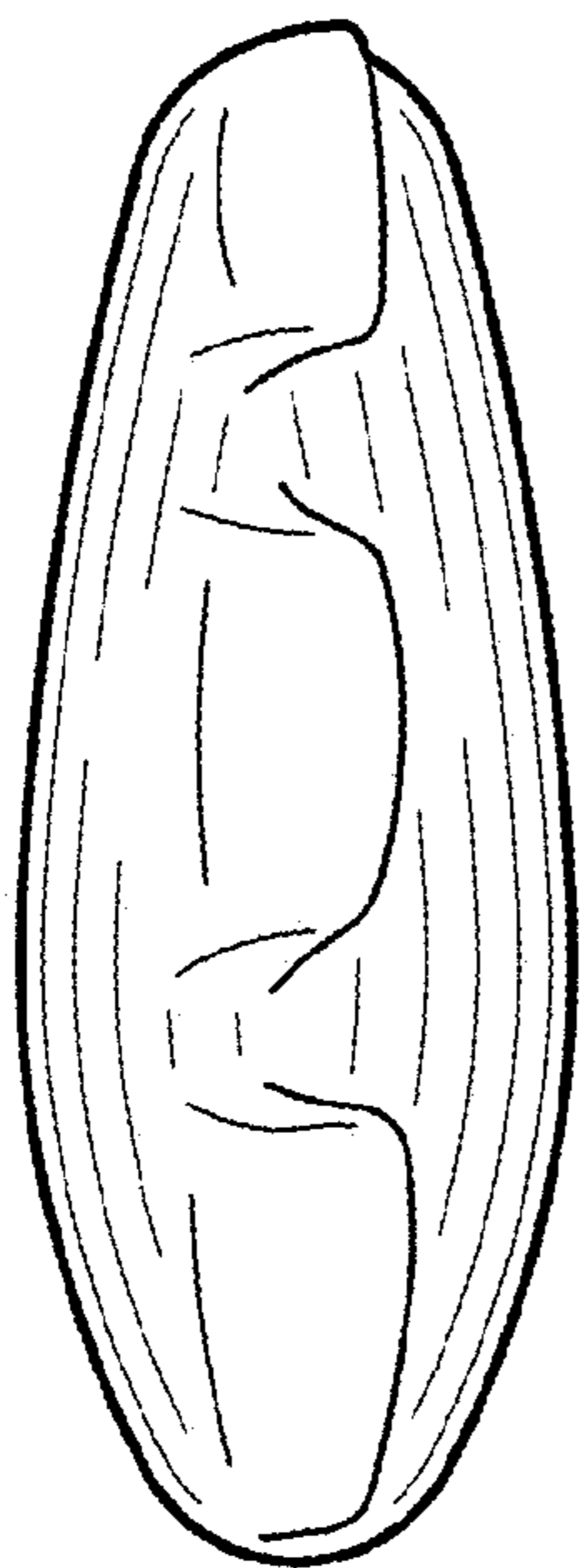

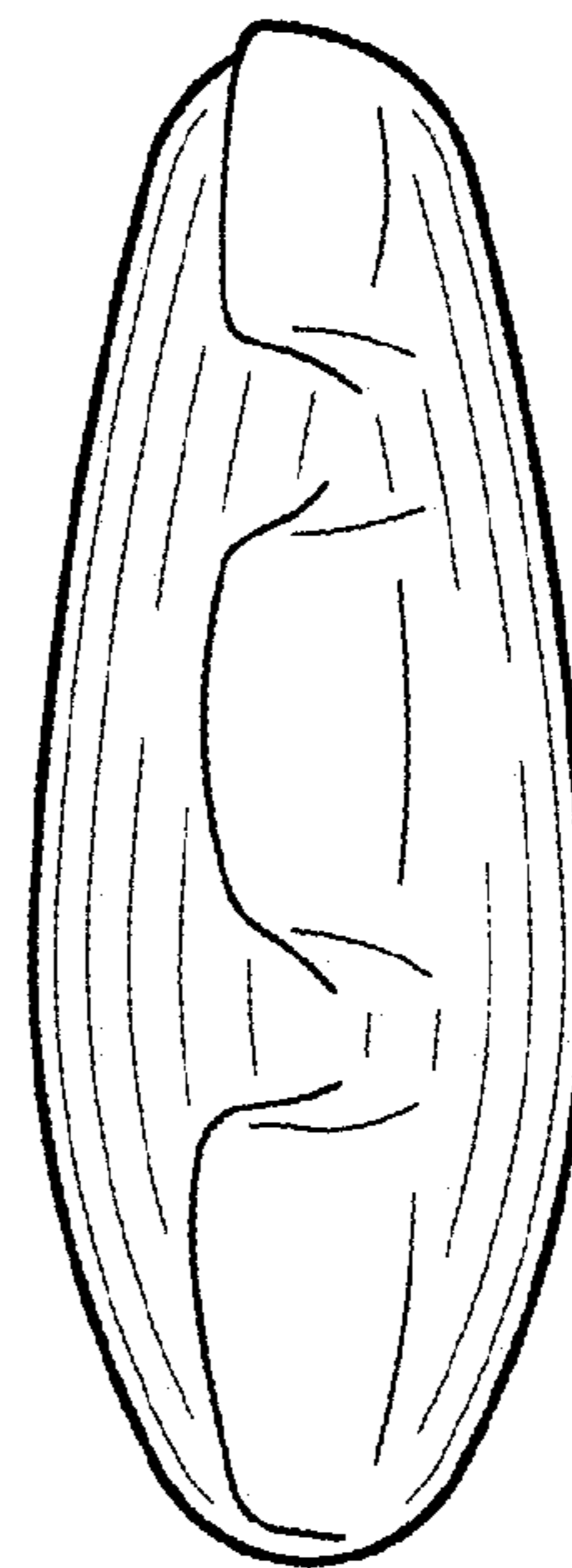
