(57) **CLAIM**

The ornamental design for a chain ornament for articles of clothing, as shown and described.

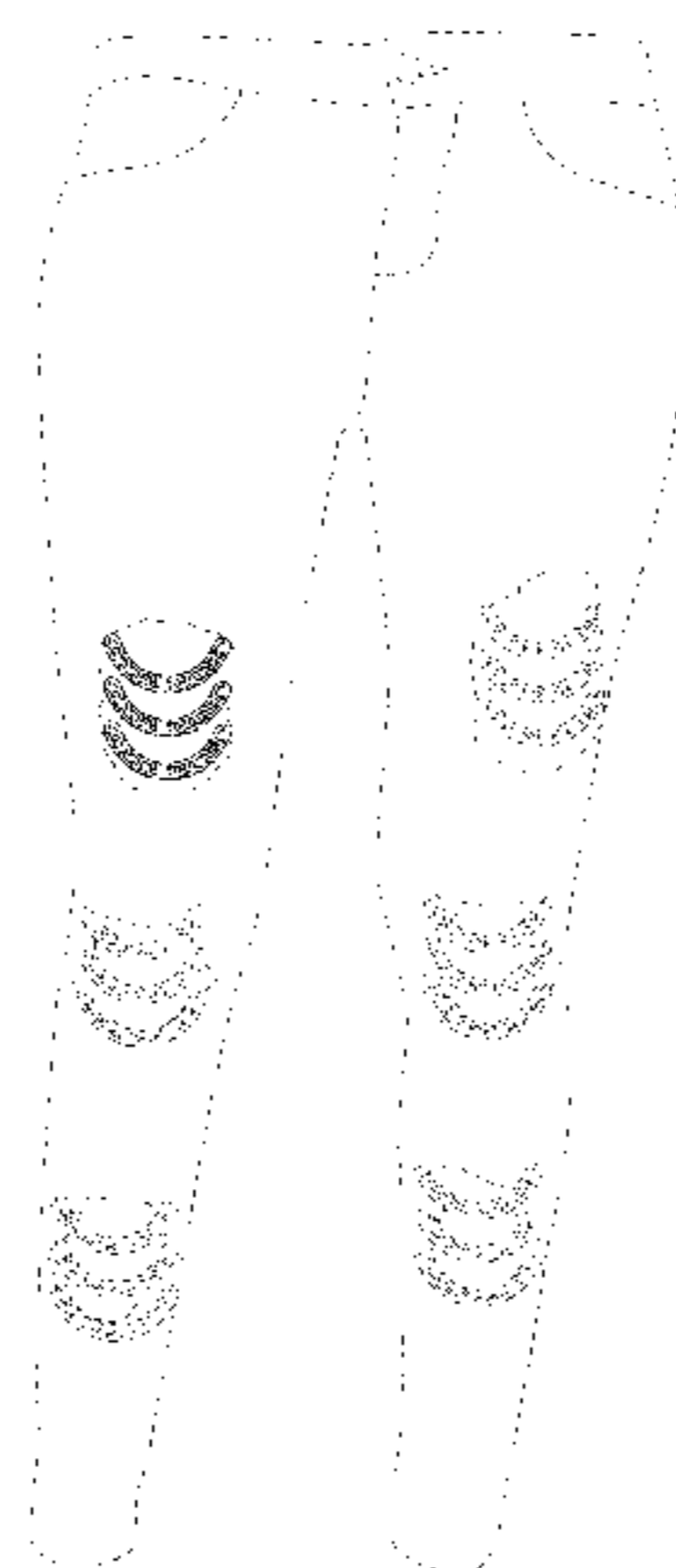
**DESCRIPTION**

FIG. 1 is a front view of a chain ornament for articles of clothing, shown in use;  
FIG. 2 is a perspective elevation view thereof;  
FIG. 3 is a front elevation view thereof, the rear elevation view being a mirror image thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a right side elevation view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.

The broken lines shown in the drawings illustrate portions of the chain ornament for articles of clothing that form no part of the claimed design.

The cutaway symbols illustrated in break lines in the drawings indicate a symbolic break in the length of the design for the chain ornament for articles of clothing. The appearance of any portion of the article between the break lines forms no part of the claimed design.

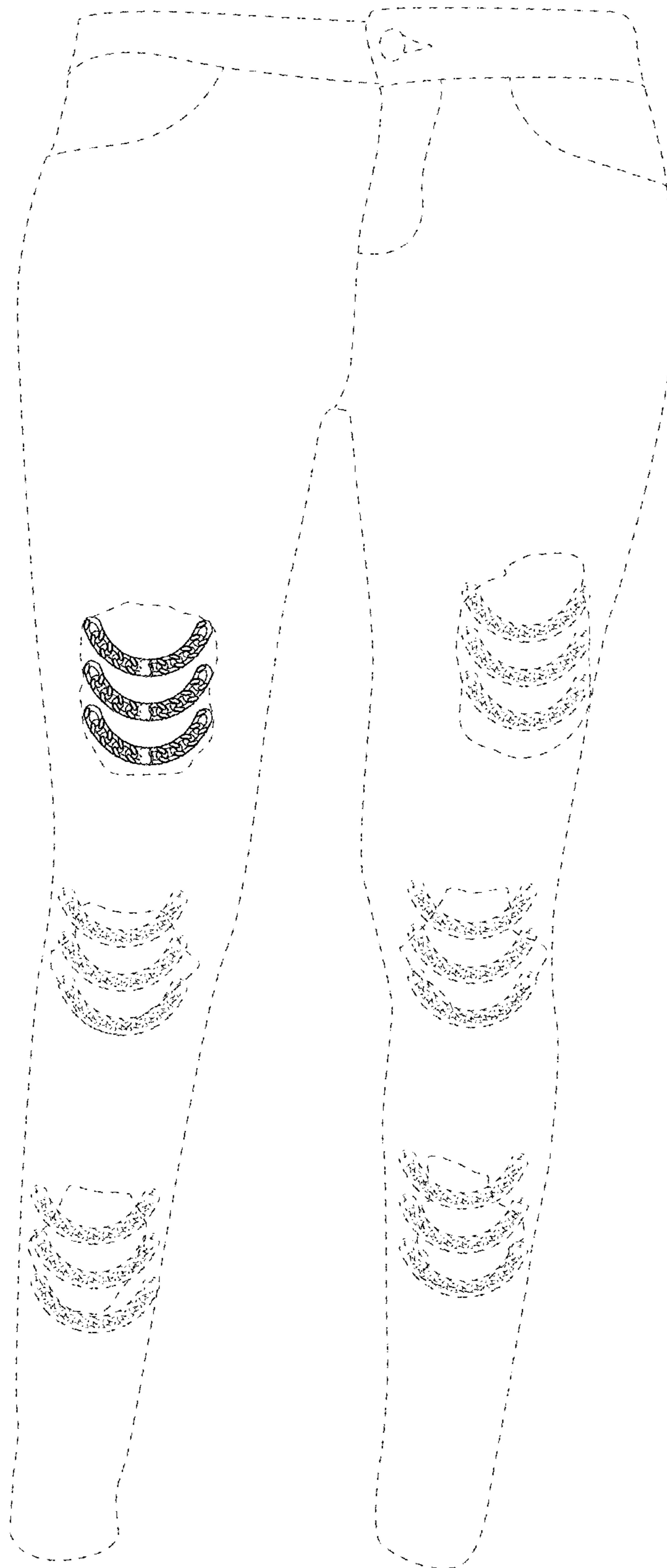

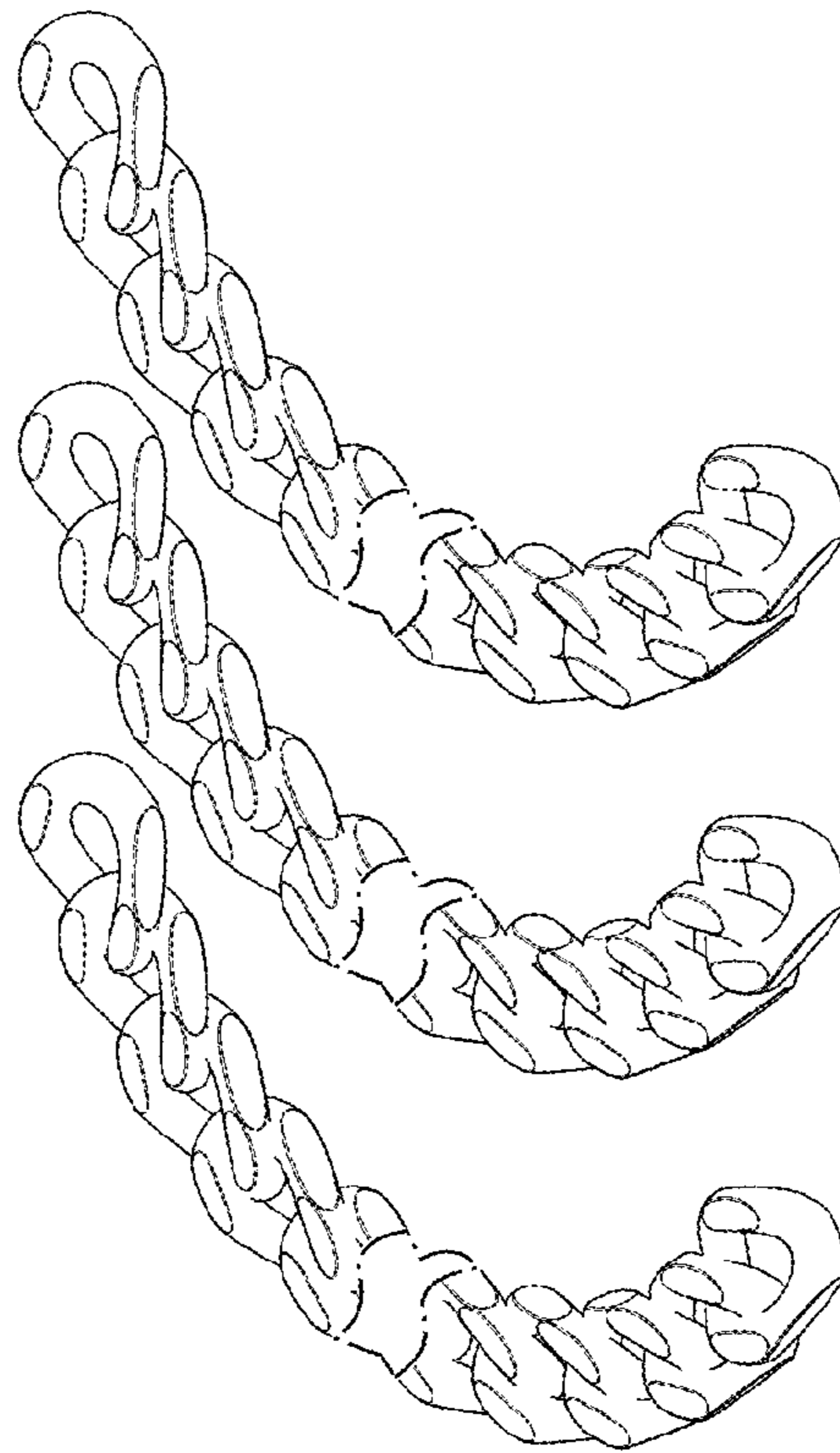

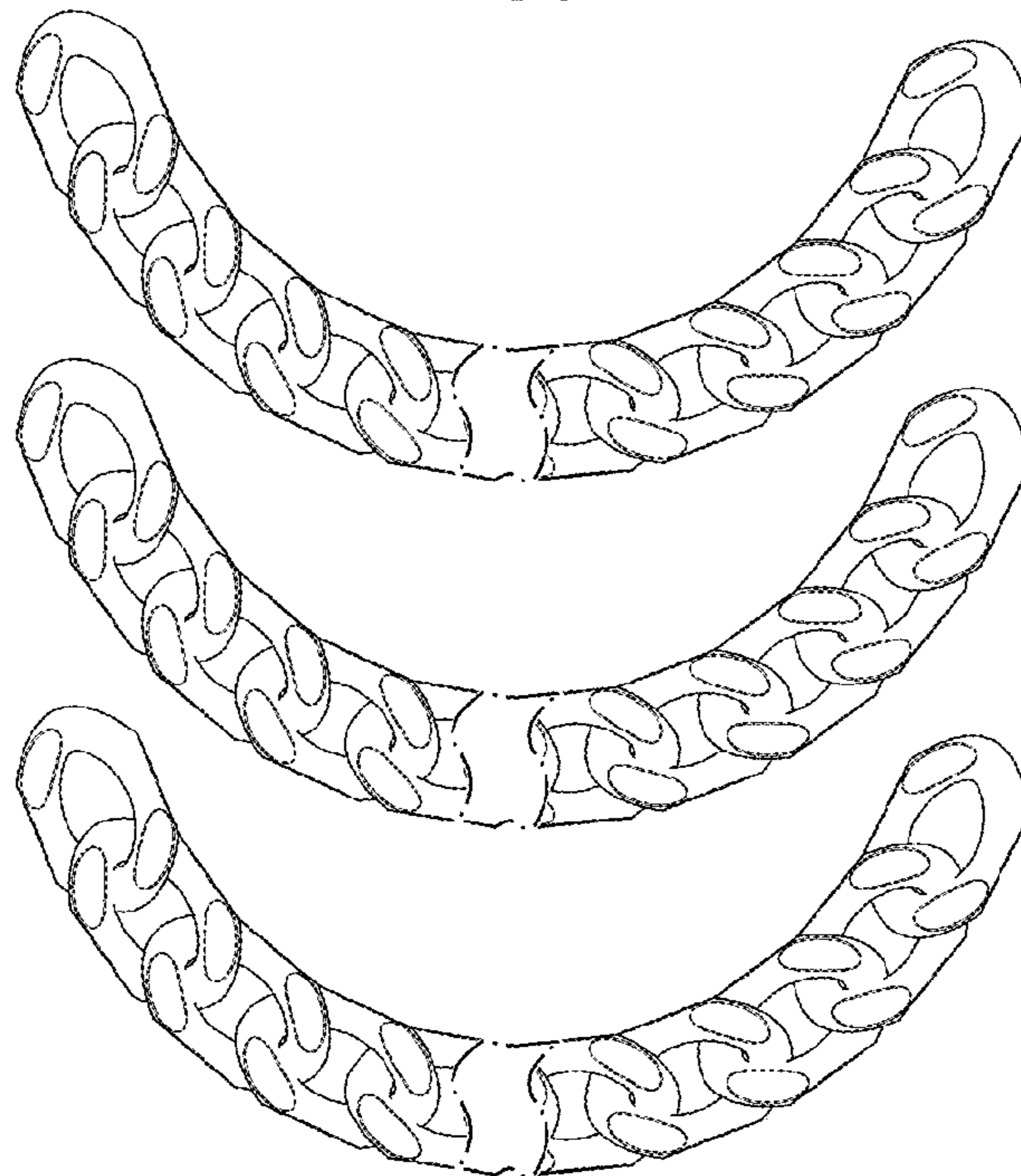
