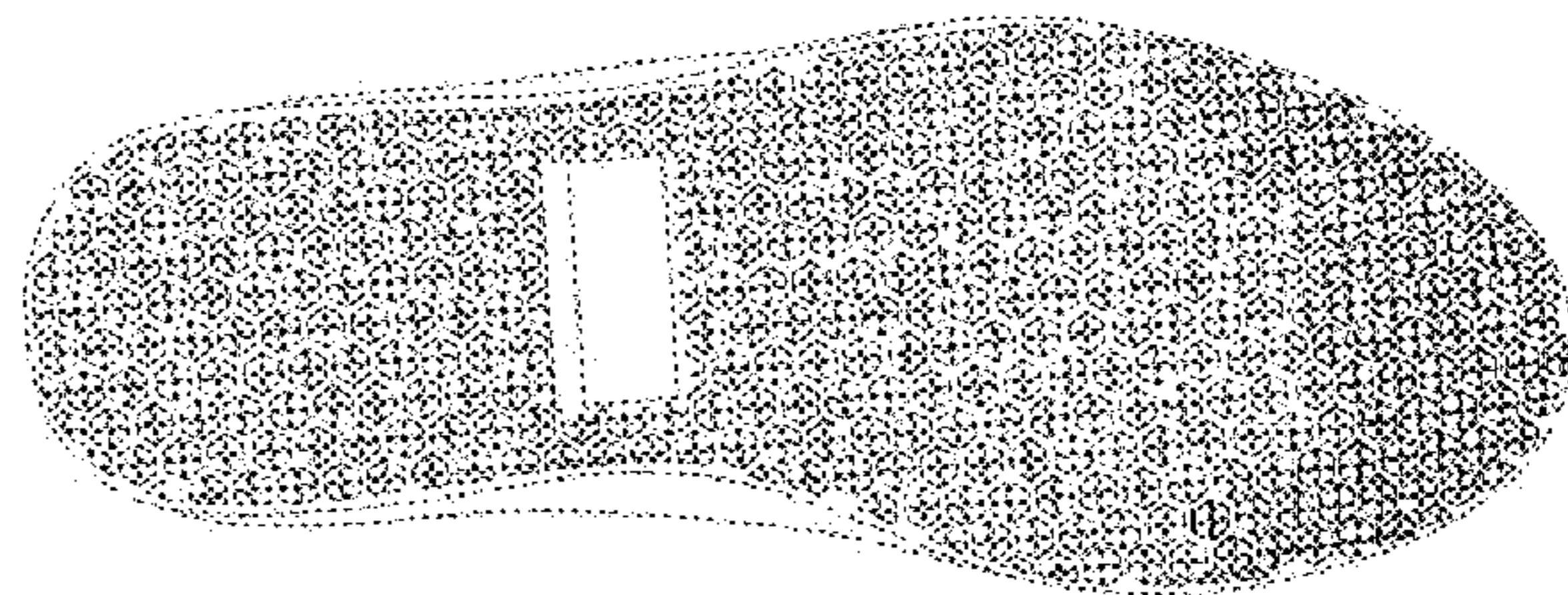
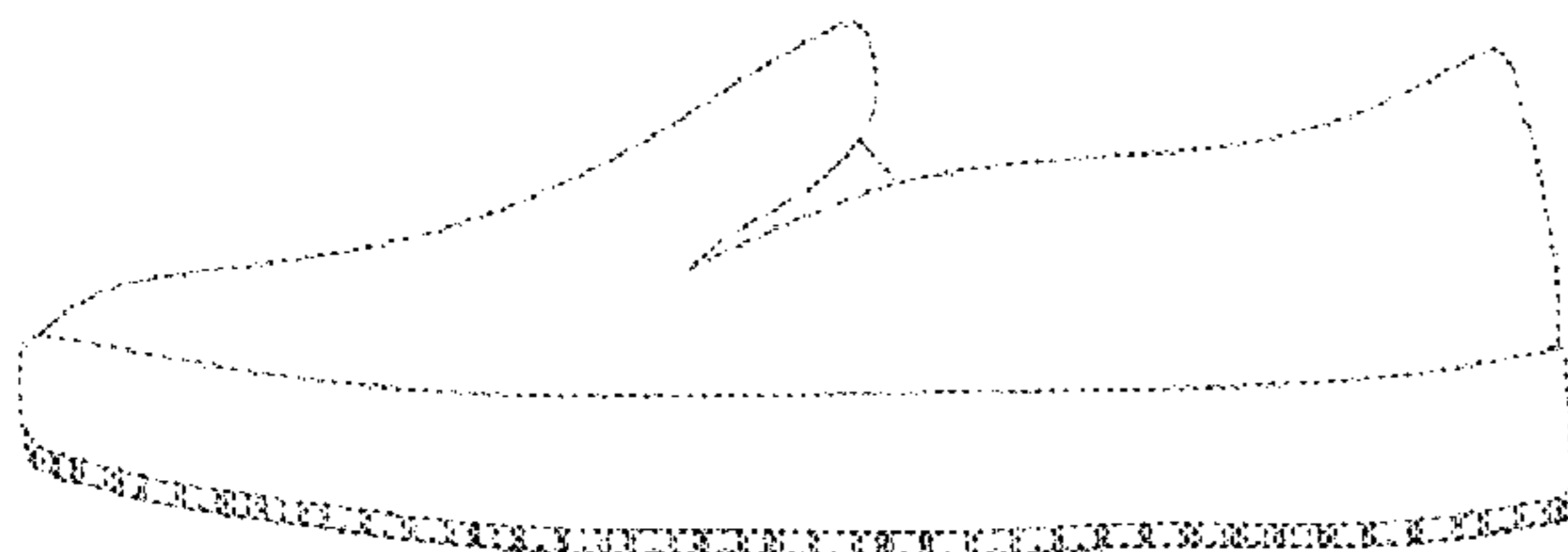
(57) **CLAIM**

The ornamental design for a shoe sole tread, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a shoe sole tread incorporating my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof; and,
FIG. 6 is a bottom view thereof.
The broken lines depict environmental structure associated with the shoe sole tread. The broken lines and structures they depict form no part of the claimed design.

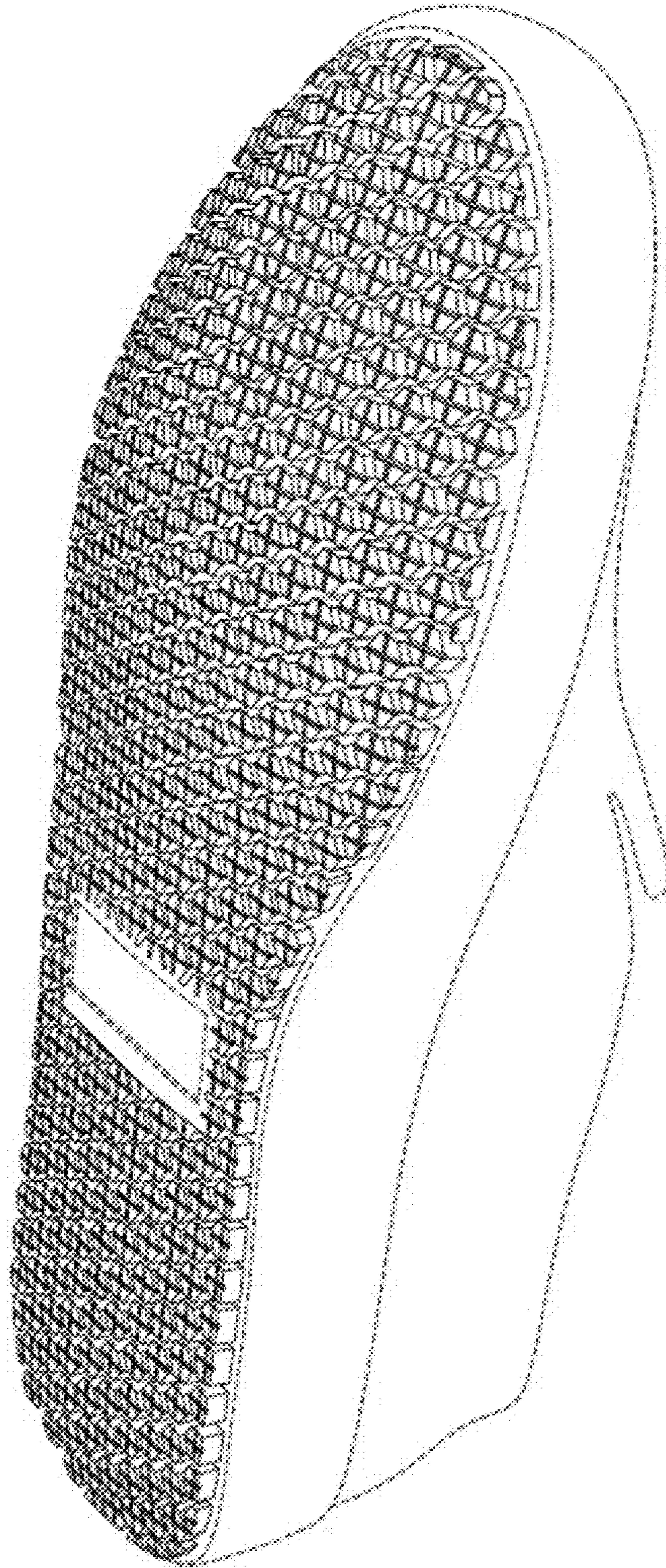

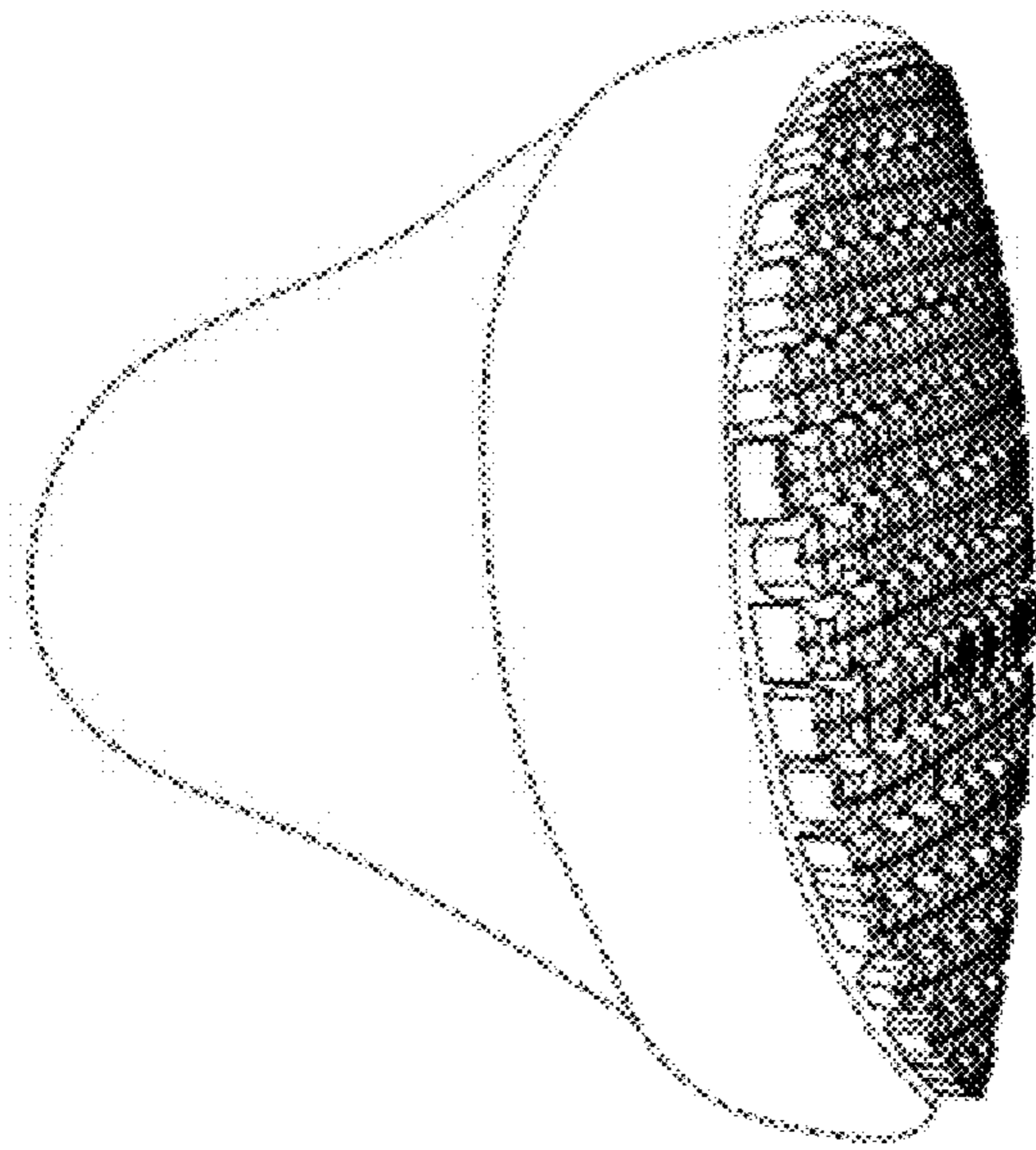

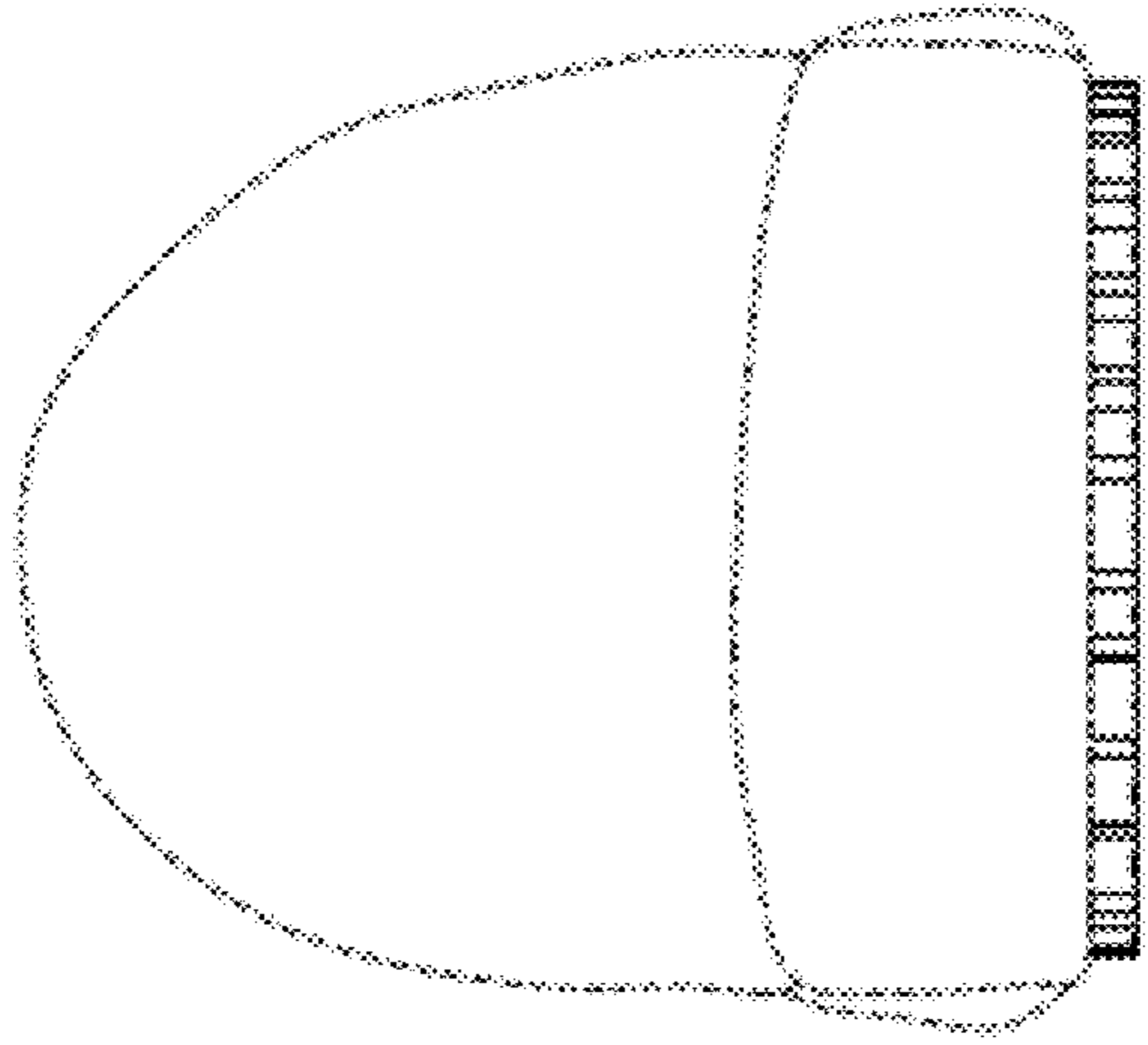

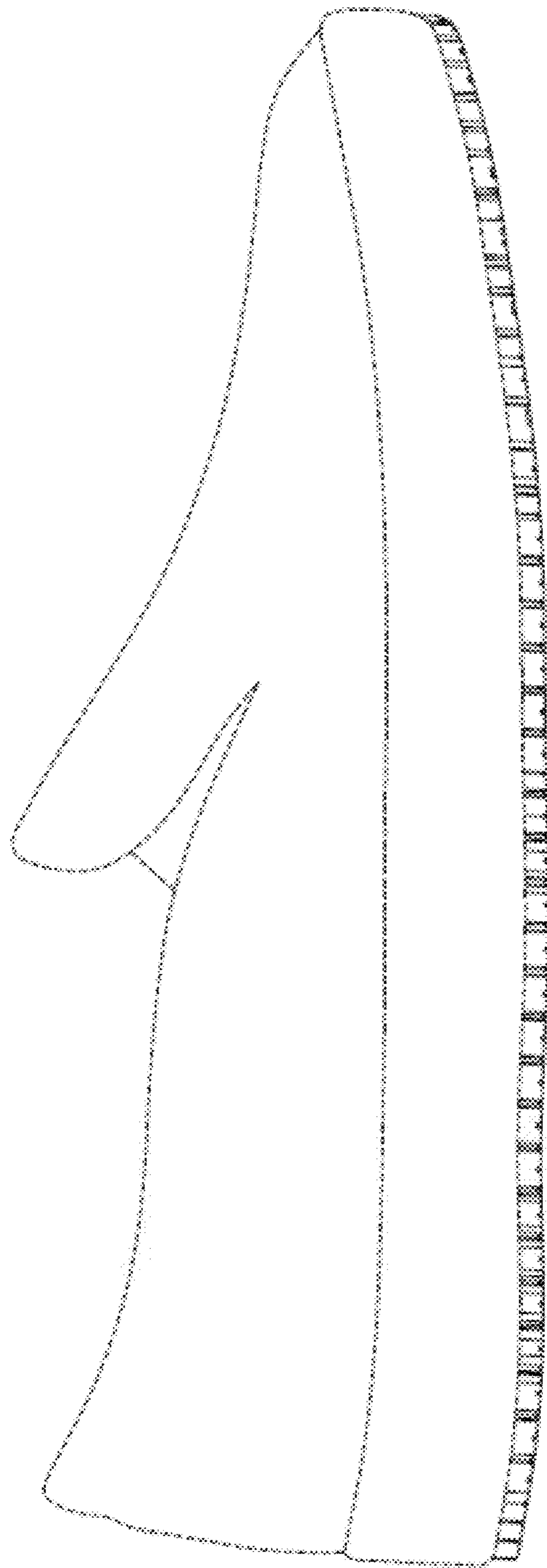

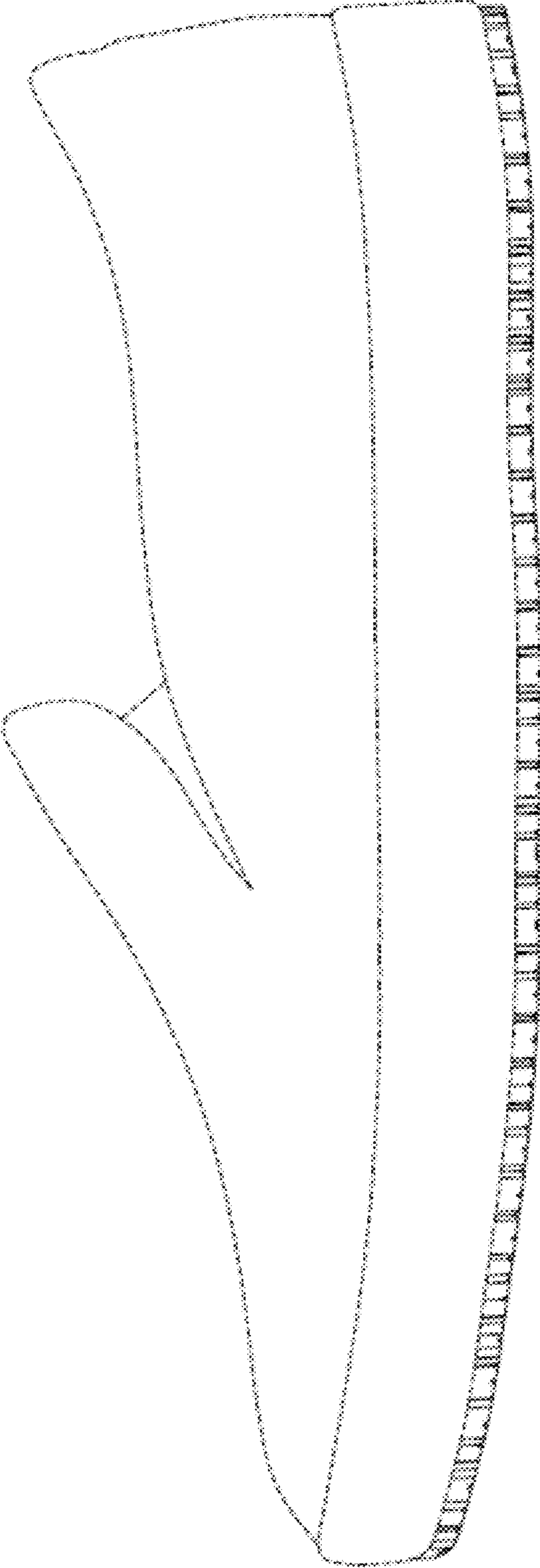

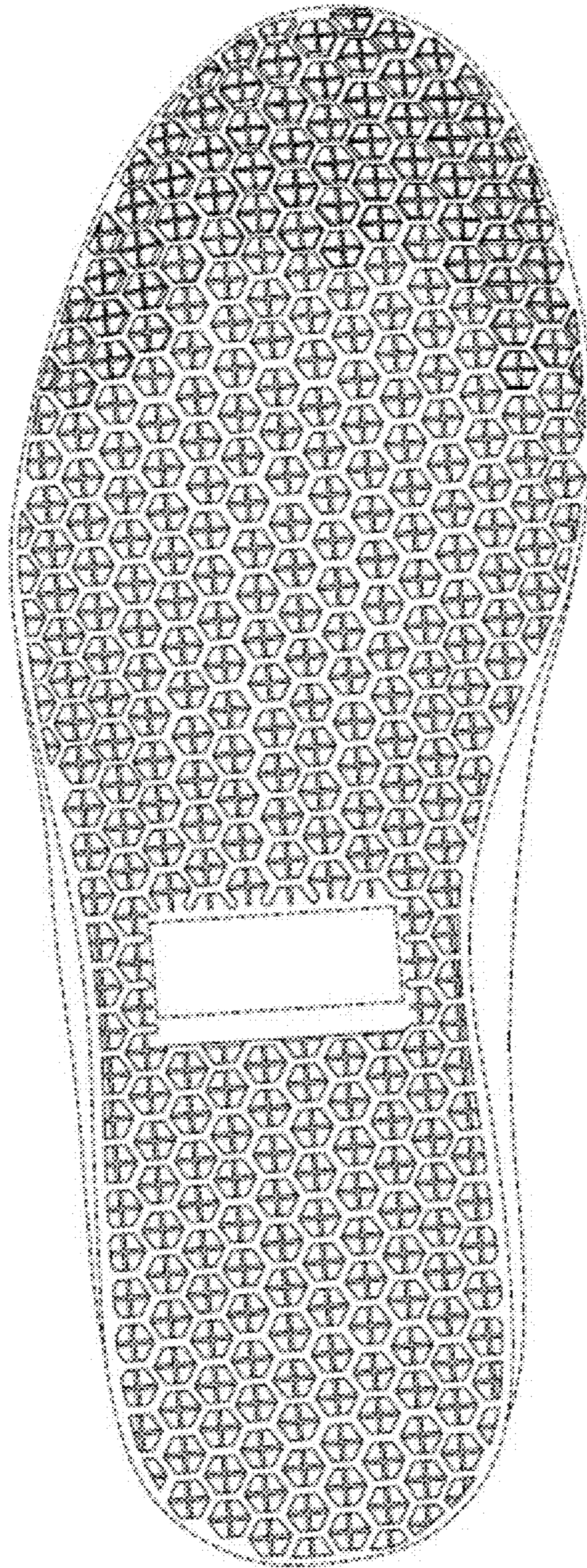
