(57) **CLAIM**

The ornamental design for a combined cow shaped brush and dish, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view showing the brush only of a combined cow shaped brush and dish, embodying my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a front perspective view of the dish only;

FIG. 5 is a top plan view thereof;

FIG. 6 is a side elevation view thereof;

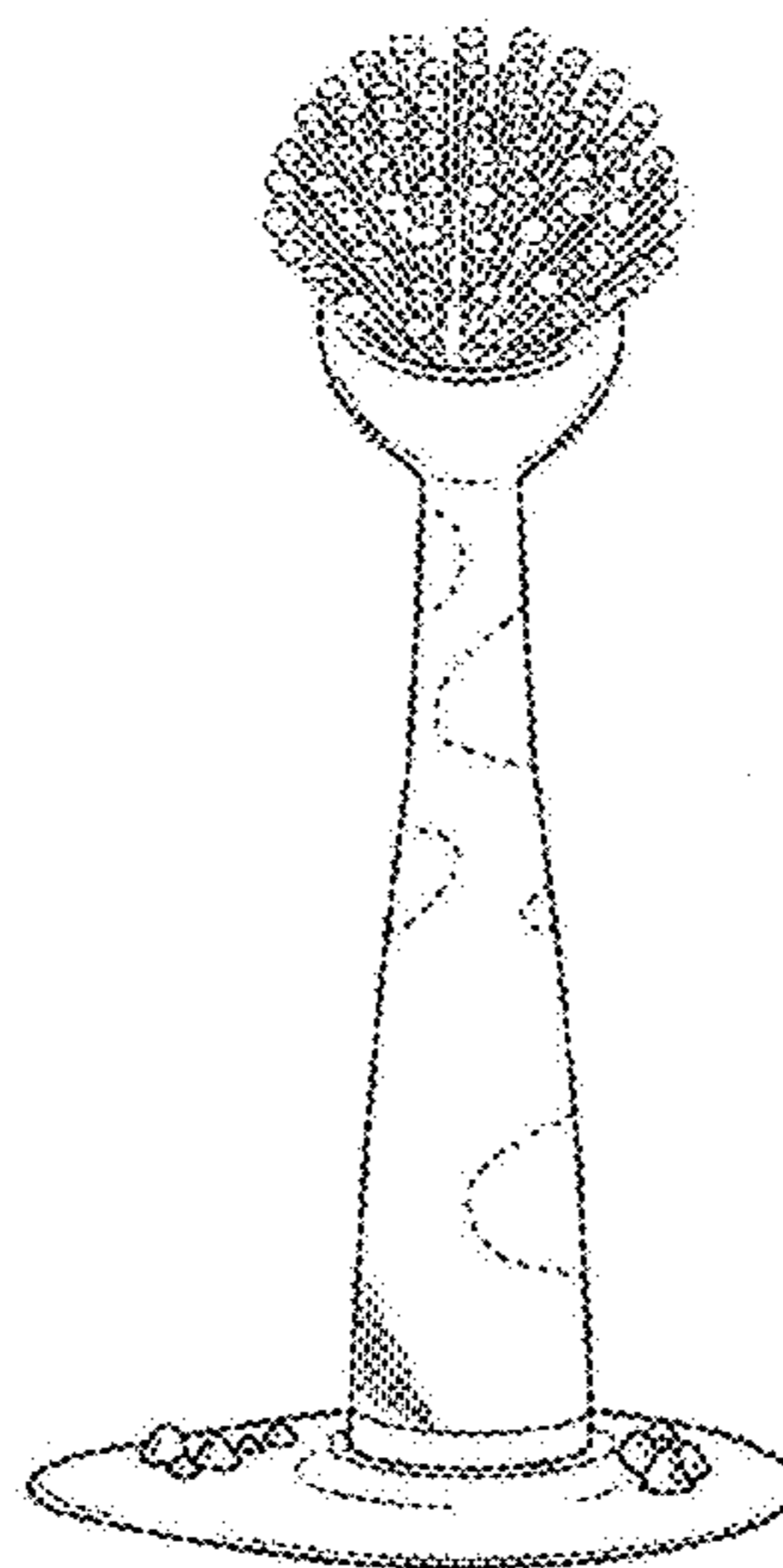
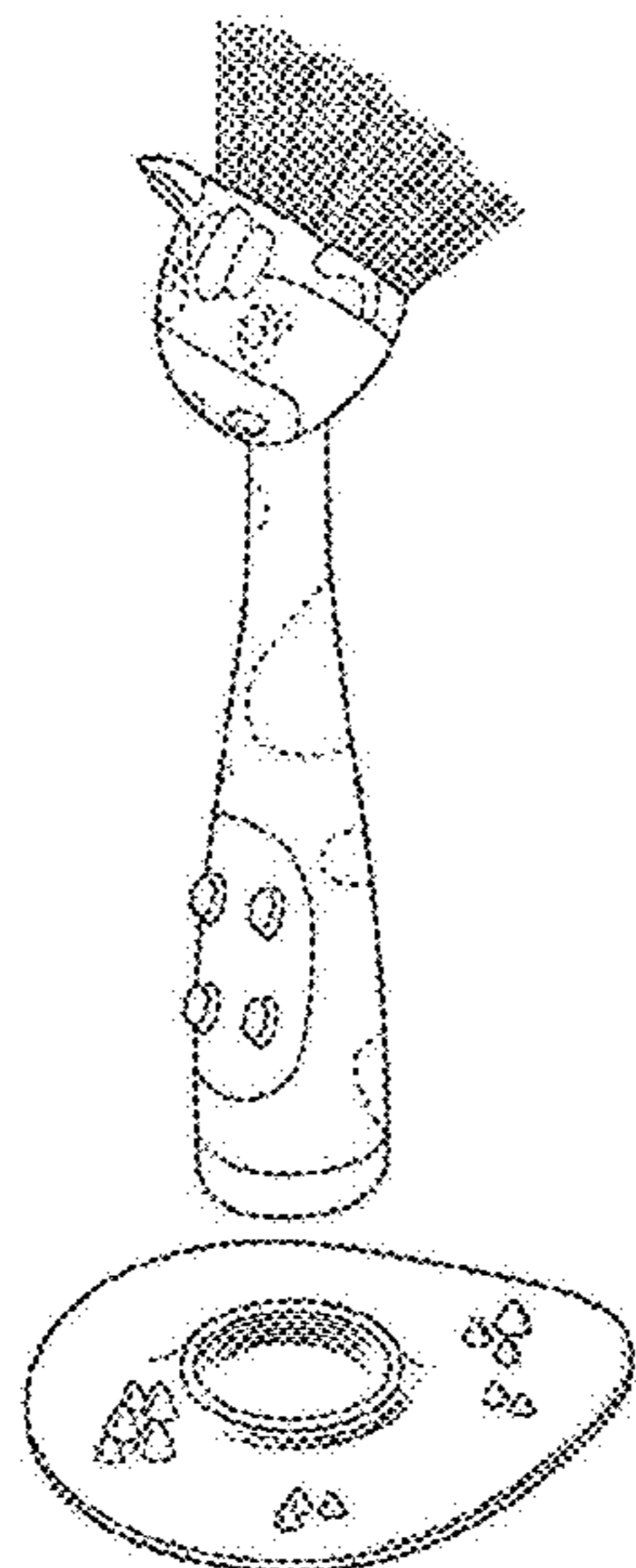
FIG. 7 is a front perspective view of the dish and brush together;

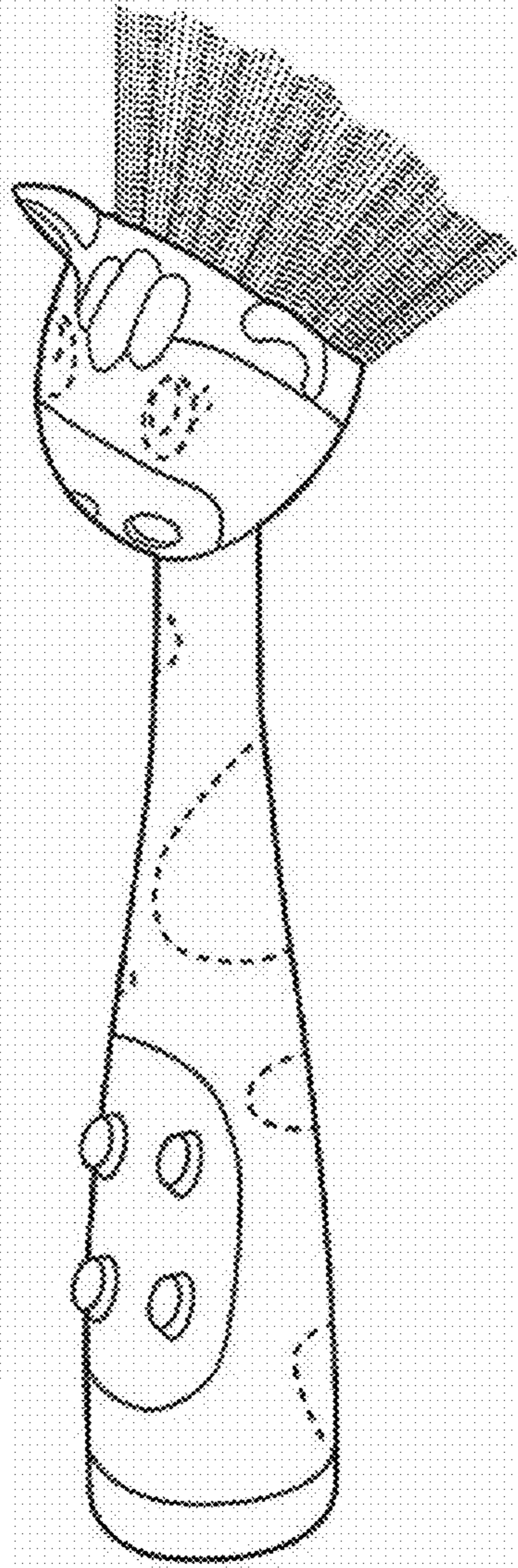

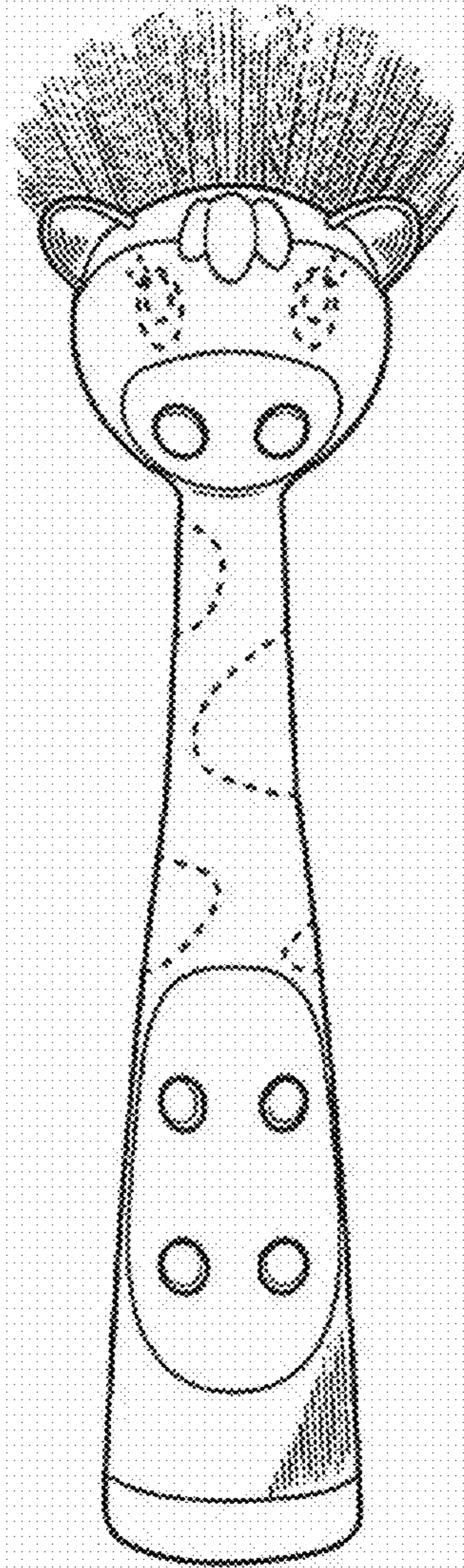

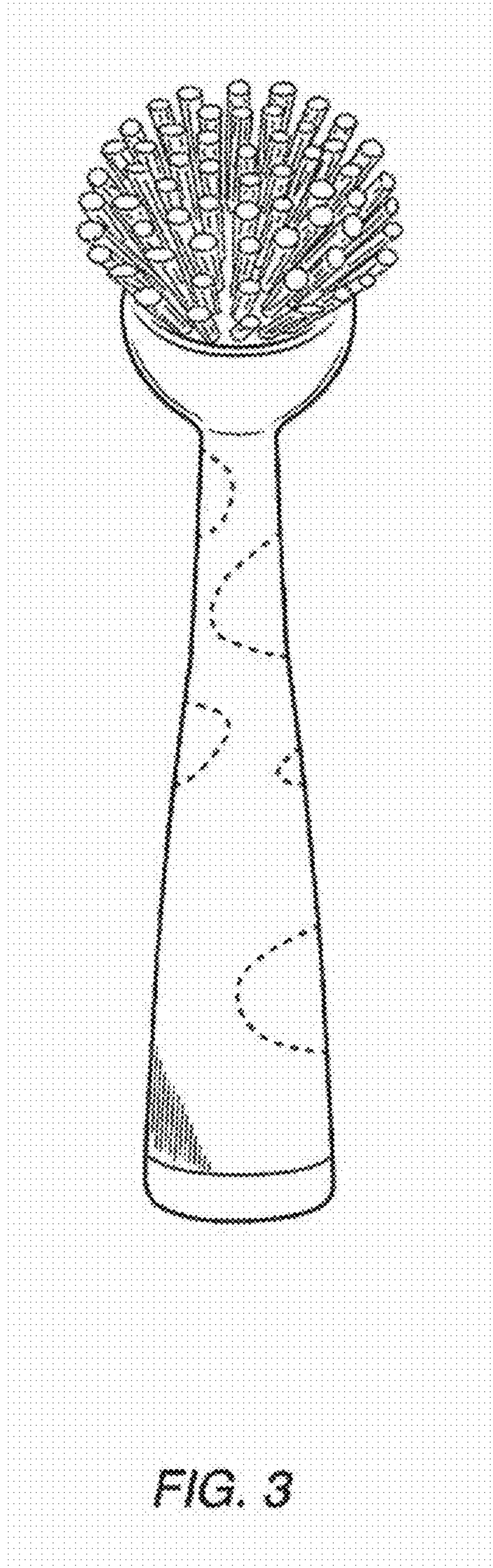

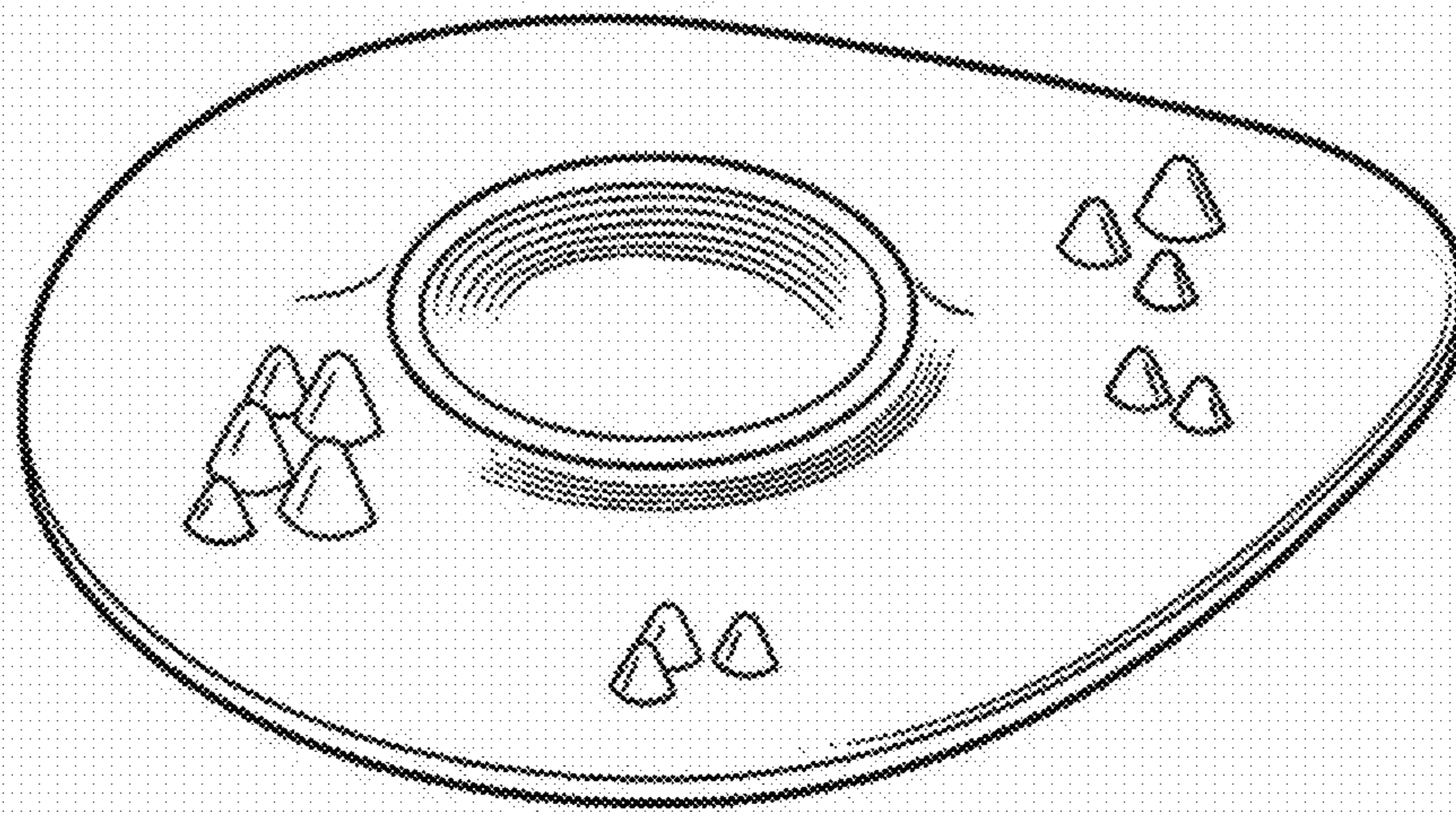

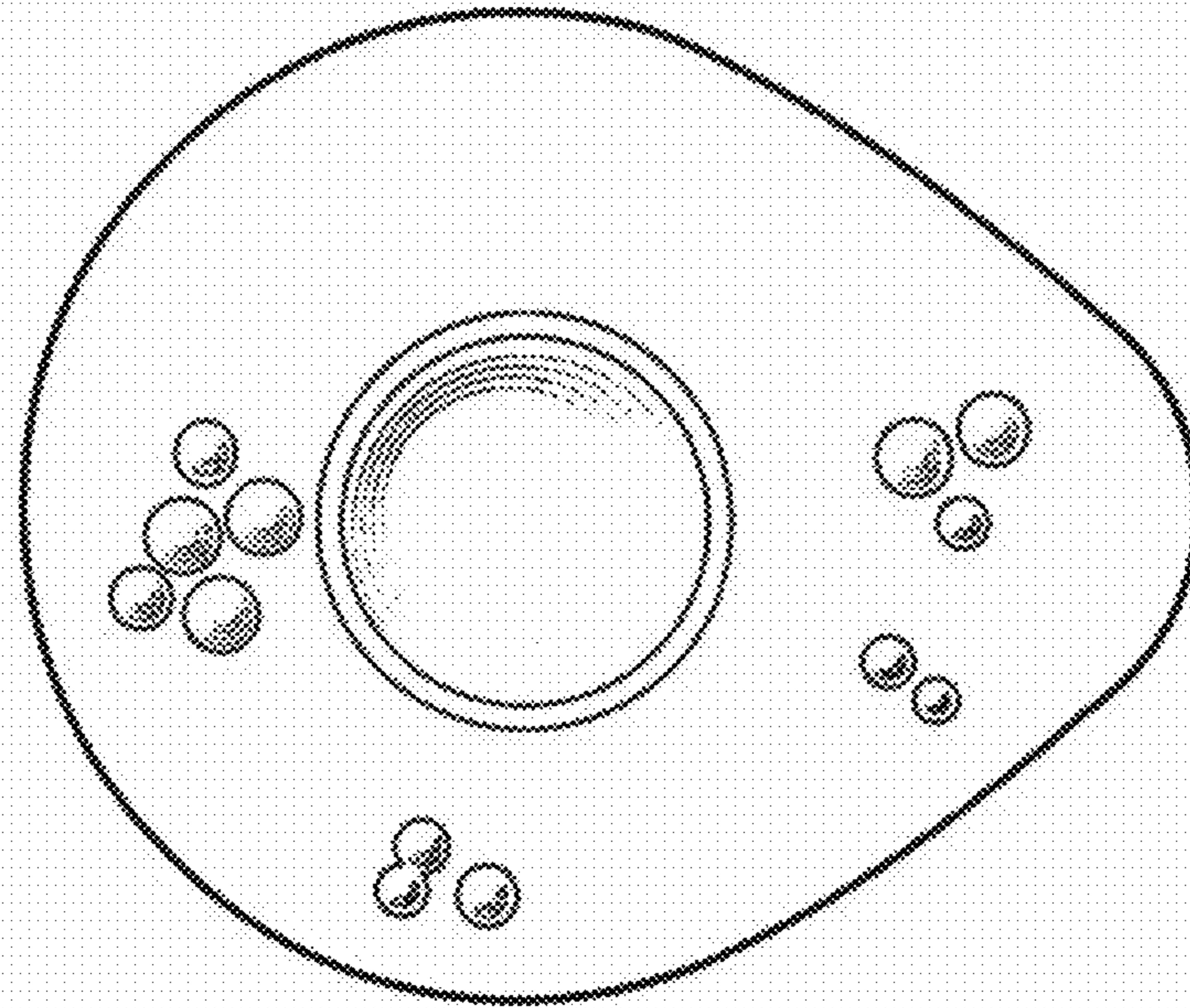

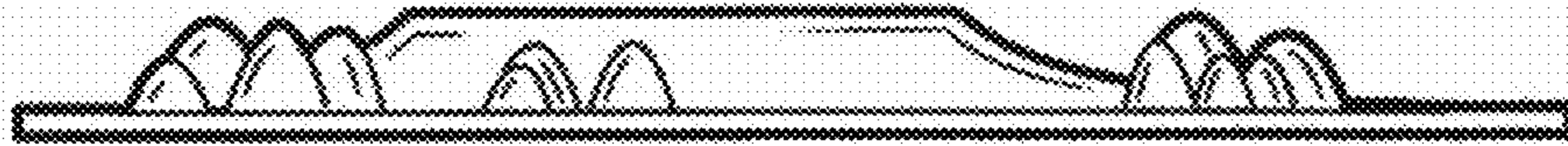

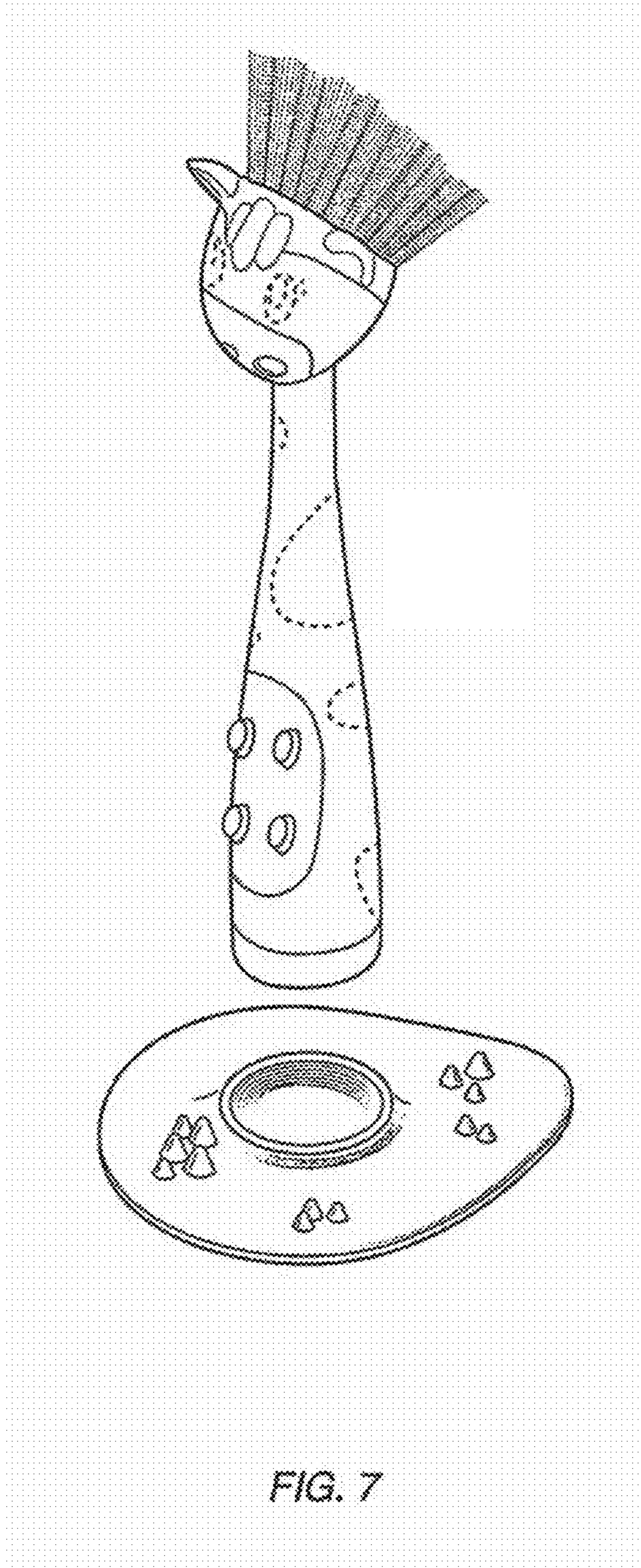

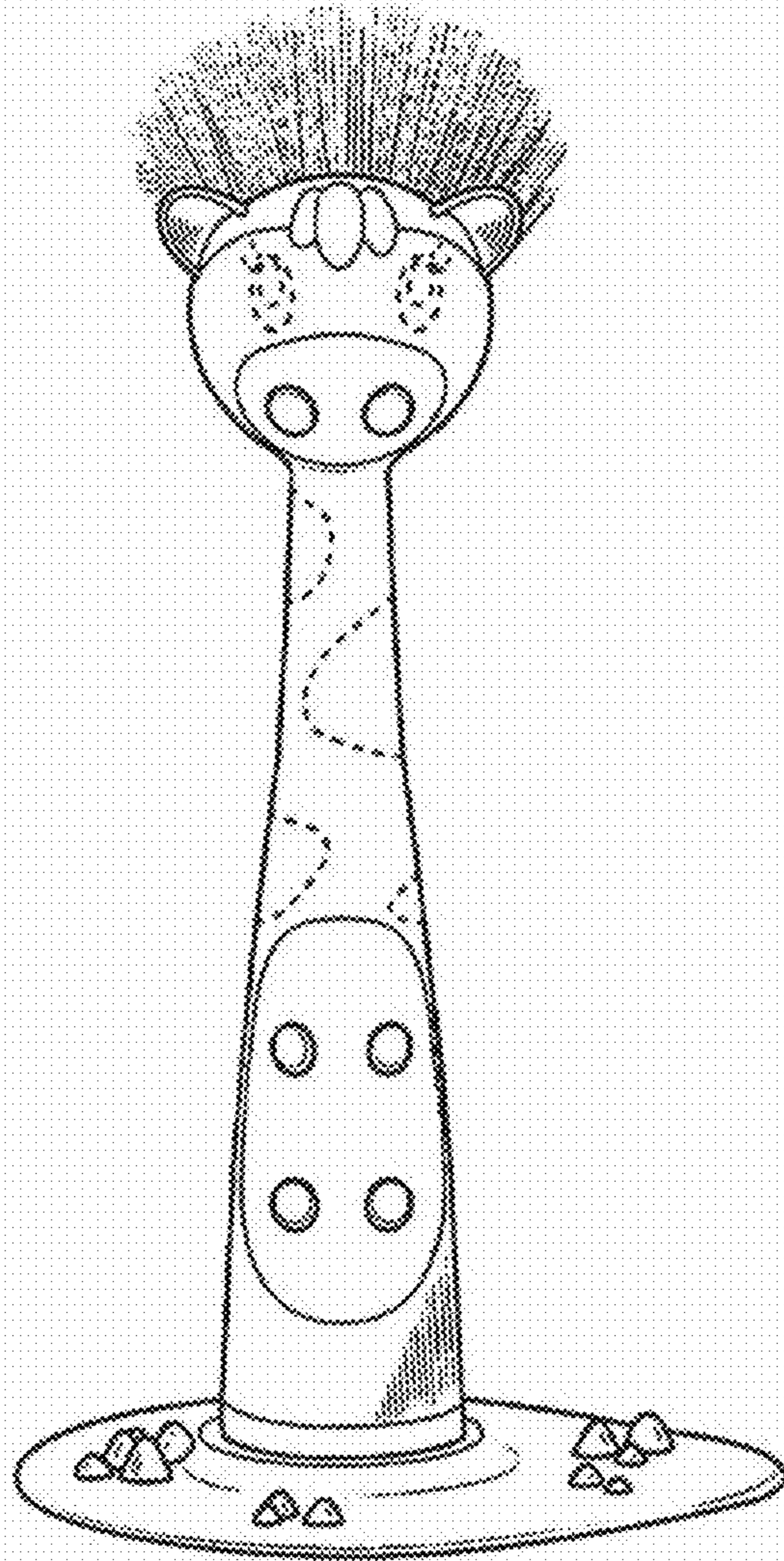

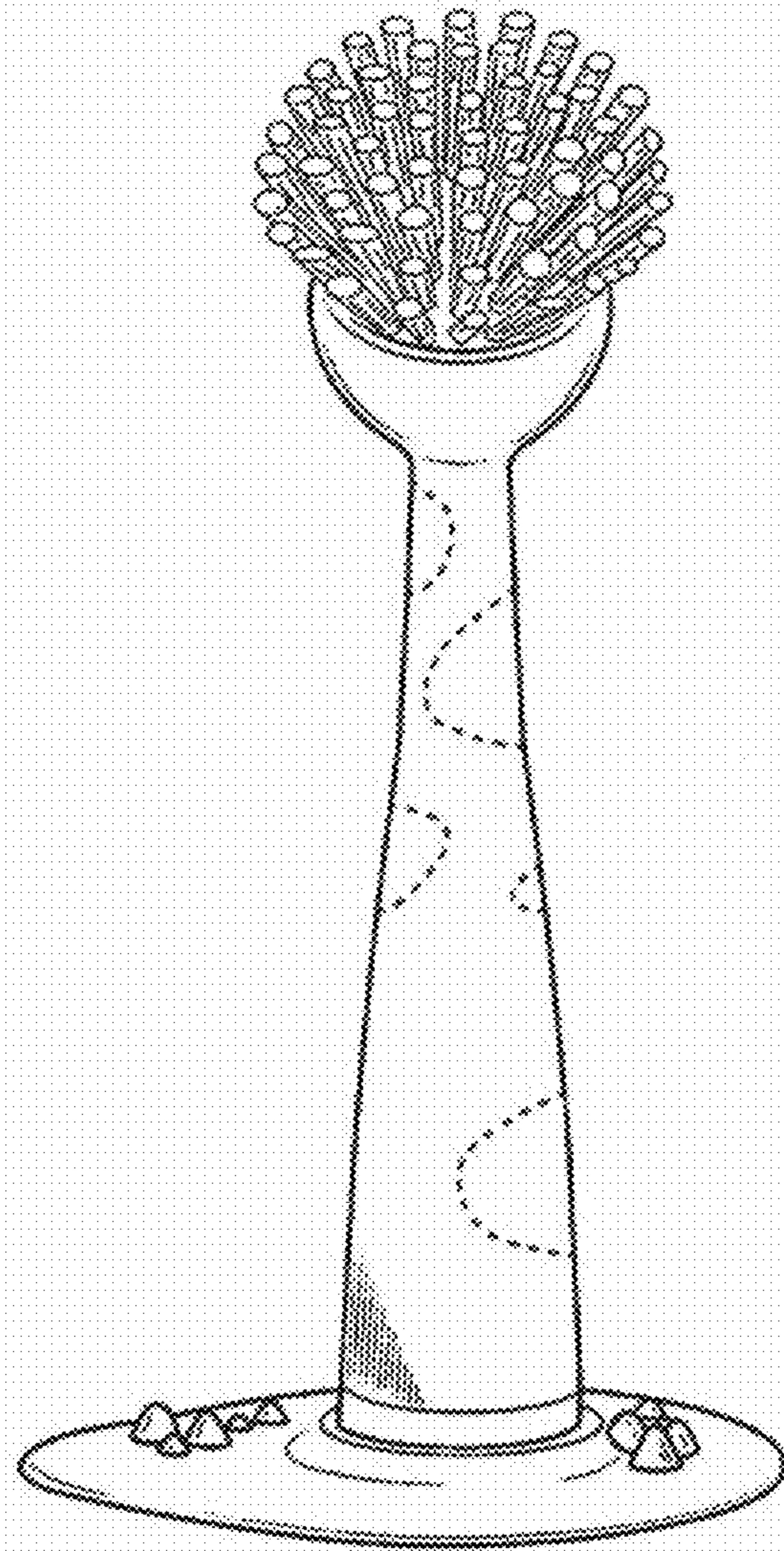
