(57) **CLAIM**

The ornamental design for a butterfly craft fabric, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the butterfly craft fabric according to the present design;

FIG. 2 is a front view of the butterfly craft fabric as shown in FIG. 1;

FIG. 3 is a rear view of the butterfly craft fabric as shown in FIG. 1;

FIG. 4 is a front perspective view of a second embodiment of a butterfly craft fabric shown in an environment of use on a pillow; and,

FIG. 5 is a top view of the butterfly craft fabric as shown in FIG. 4.

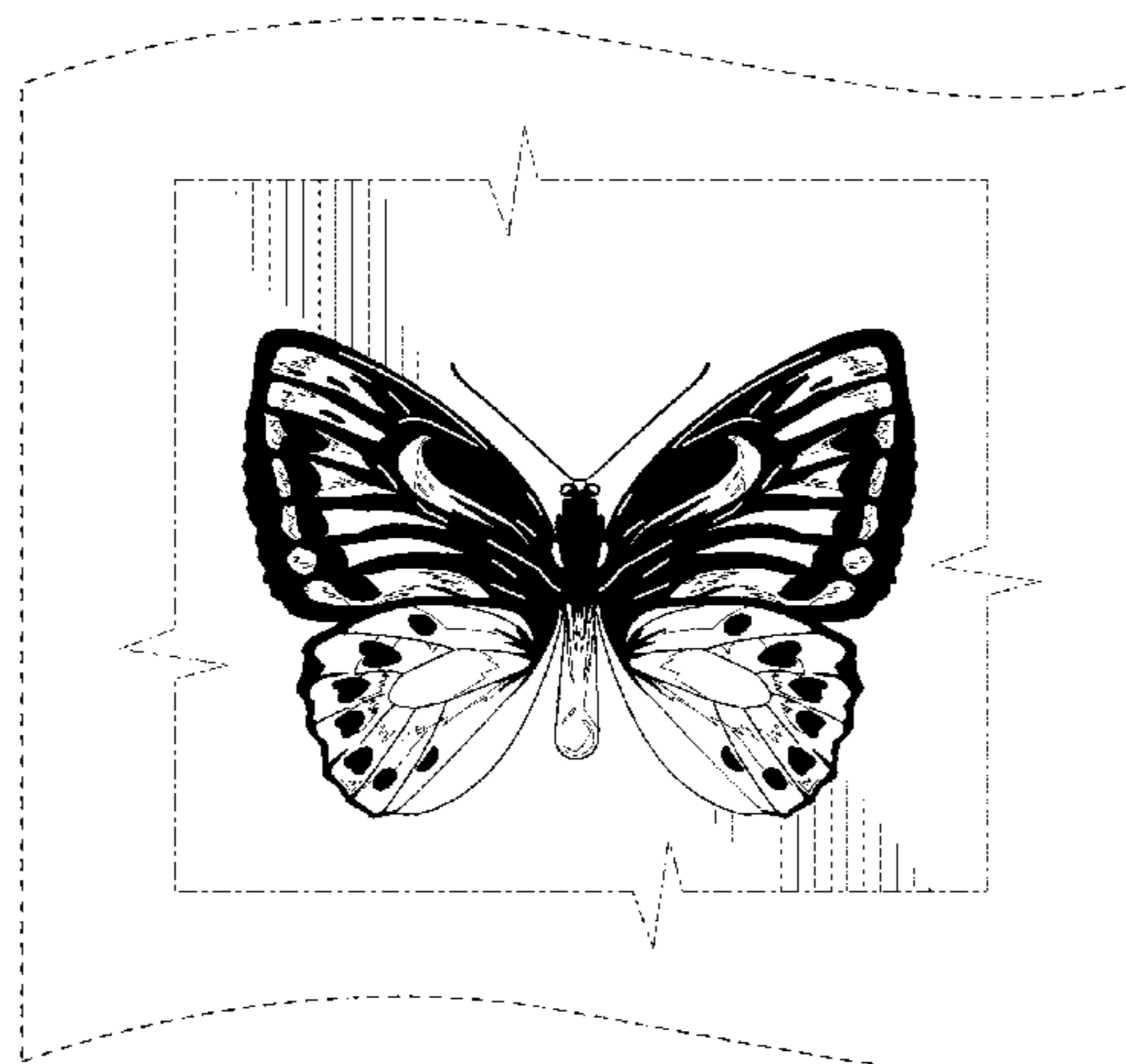

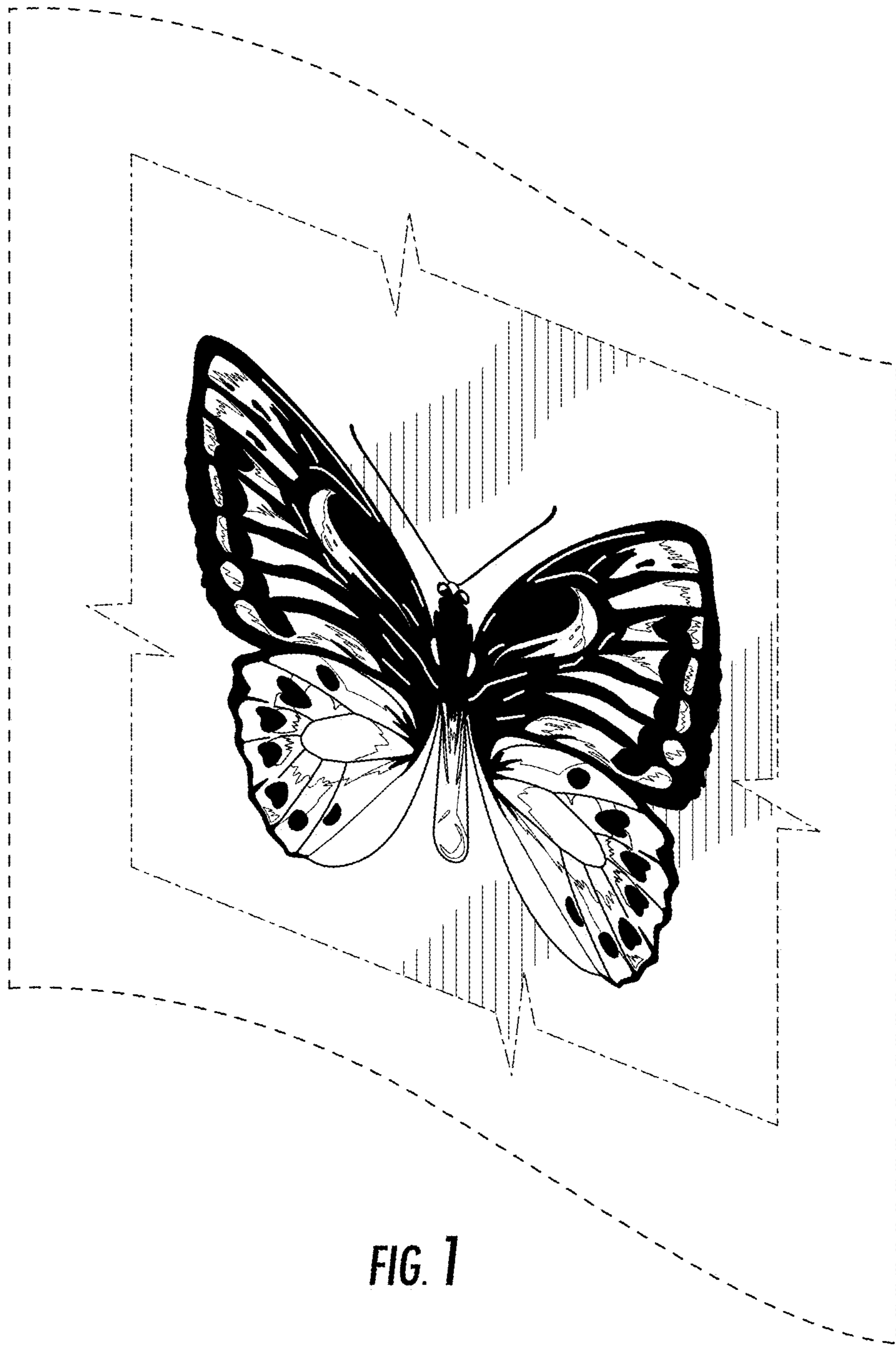

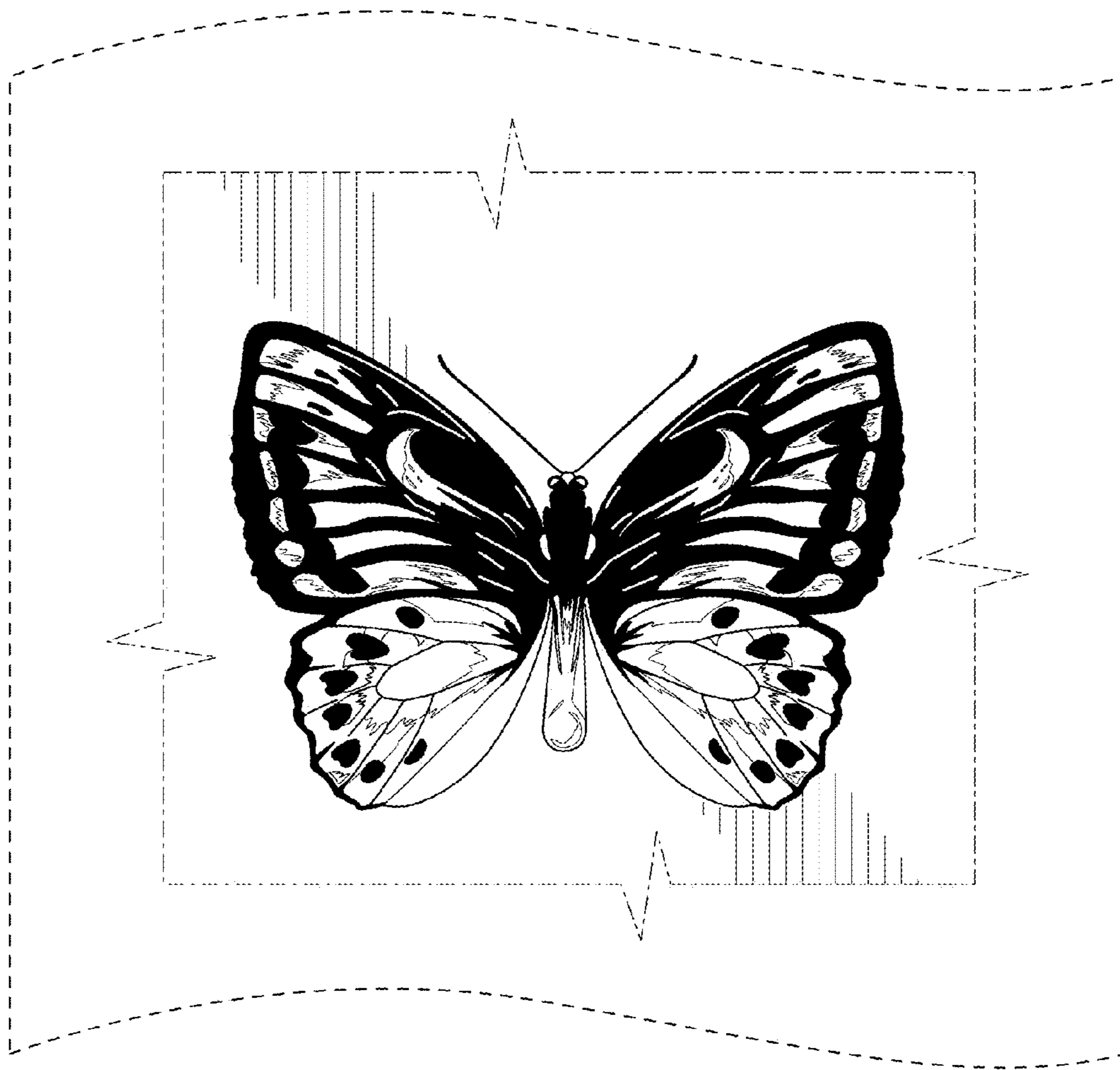

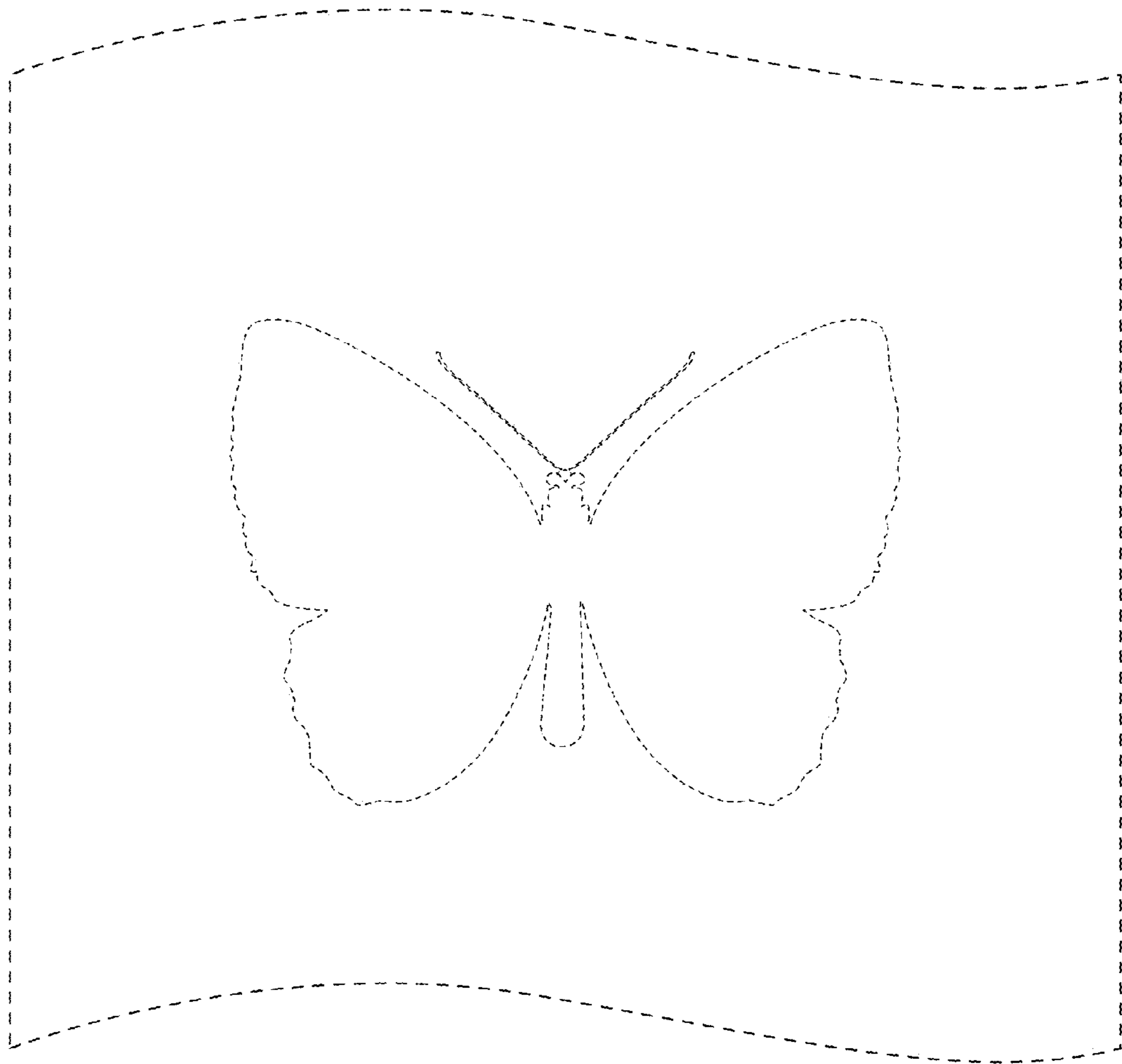

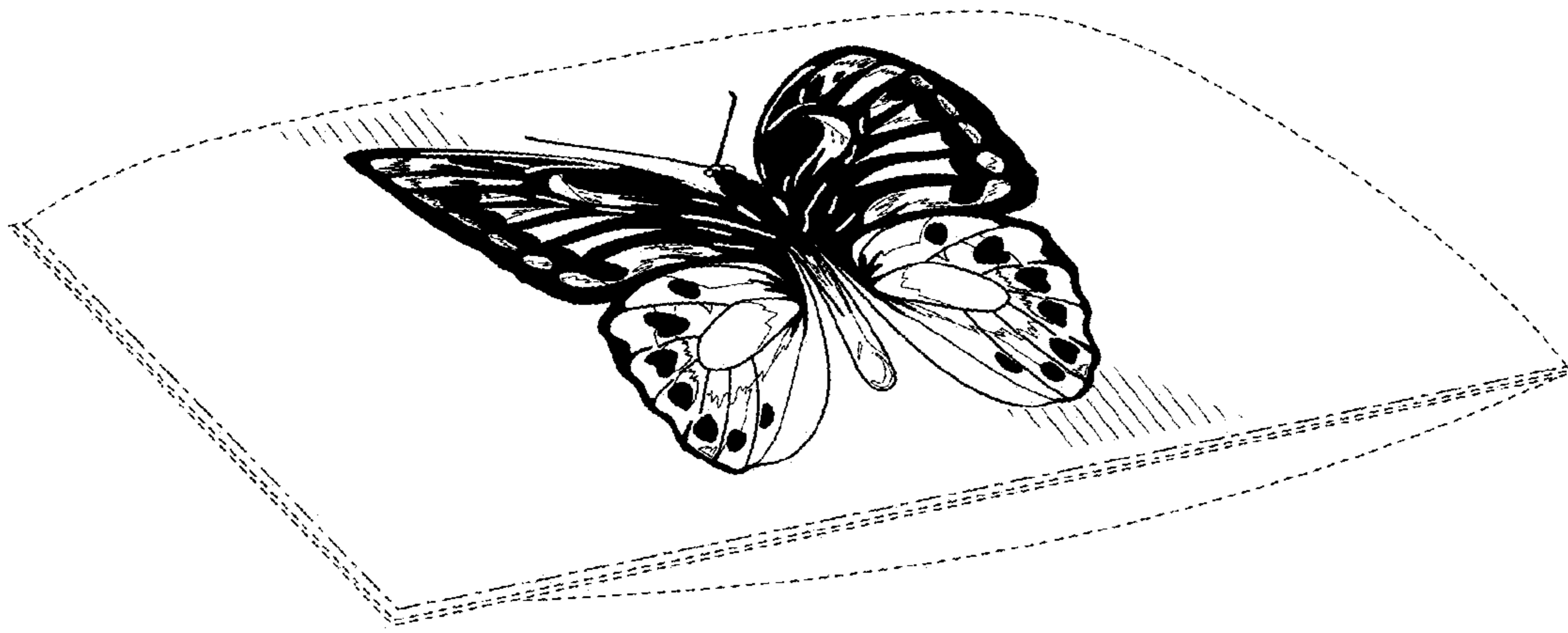

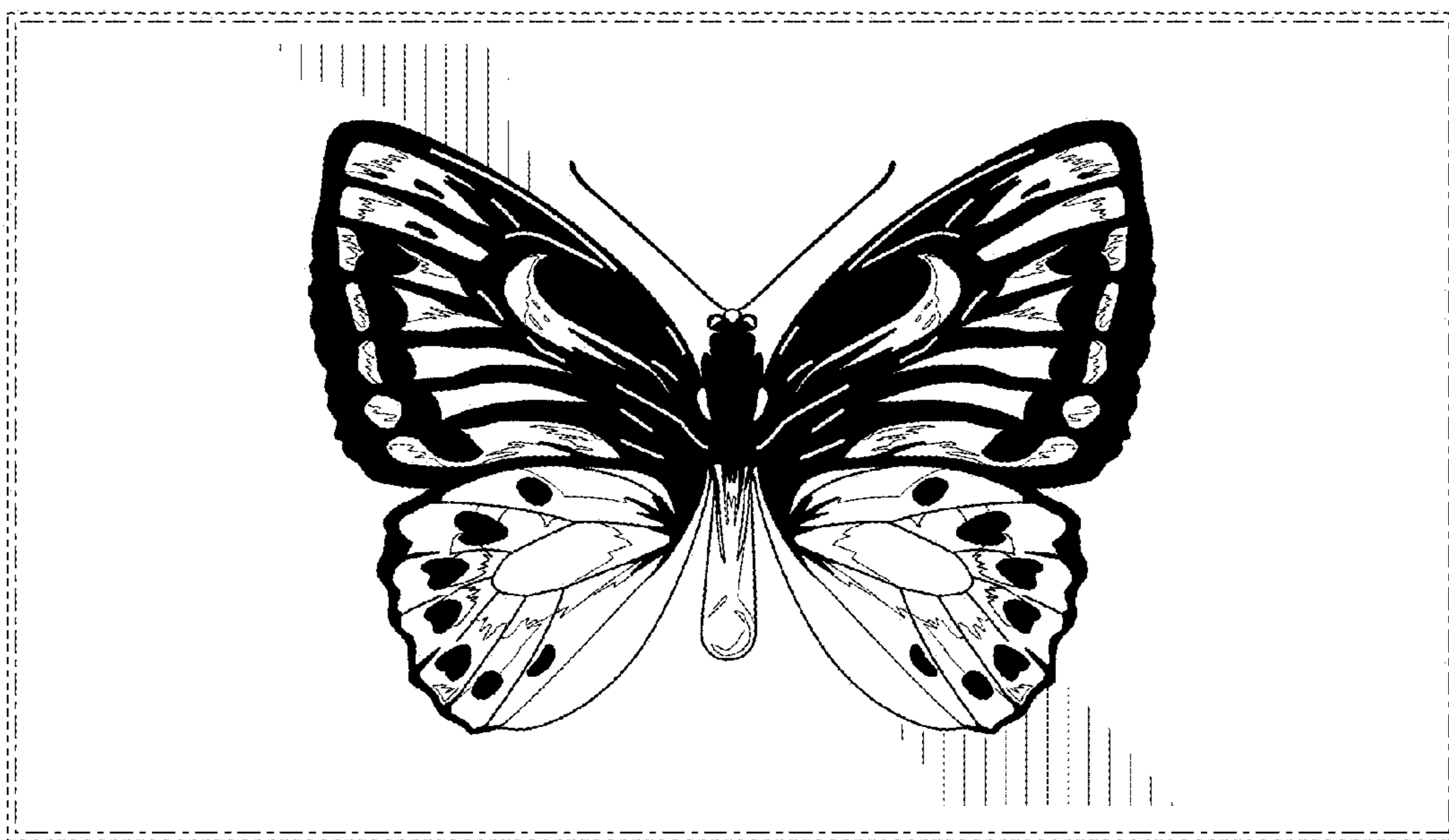
