(57) **CLAIM**
The ornamental design for a swivel lounger, as shown and described.

DESCRIPTION

FIG. 1 is a front-right perspective view of a first embodiment of a swivel lounger showing my new design, the front-left perspective view being mirror-symmetrical thereto; FIG. 2 is a front-right perspective view thereof showing the lounger portion rotated relative to the base position; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a right view thereof, the left view being mirror-symmetrical thereto; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. The short dash broken lines illustrate unclaimed features that form no part of the claimed design. The long dash-short dash lines represent boundaries of the claimed design.

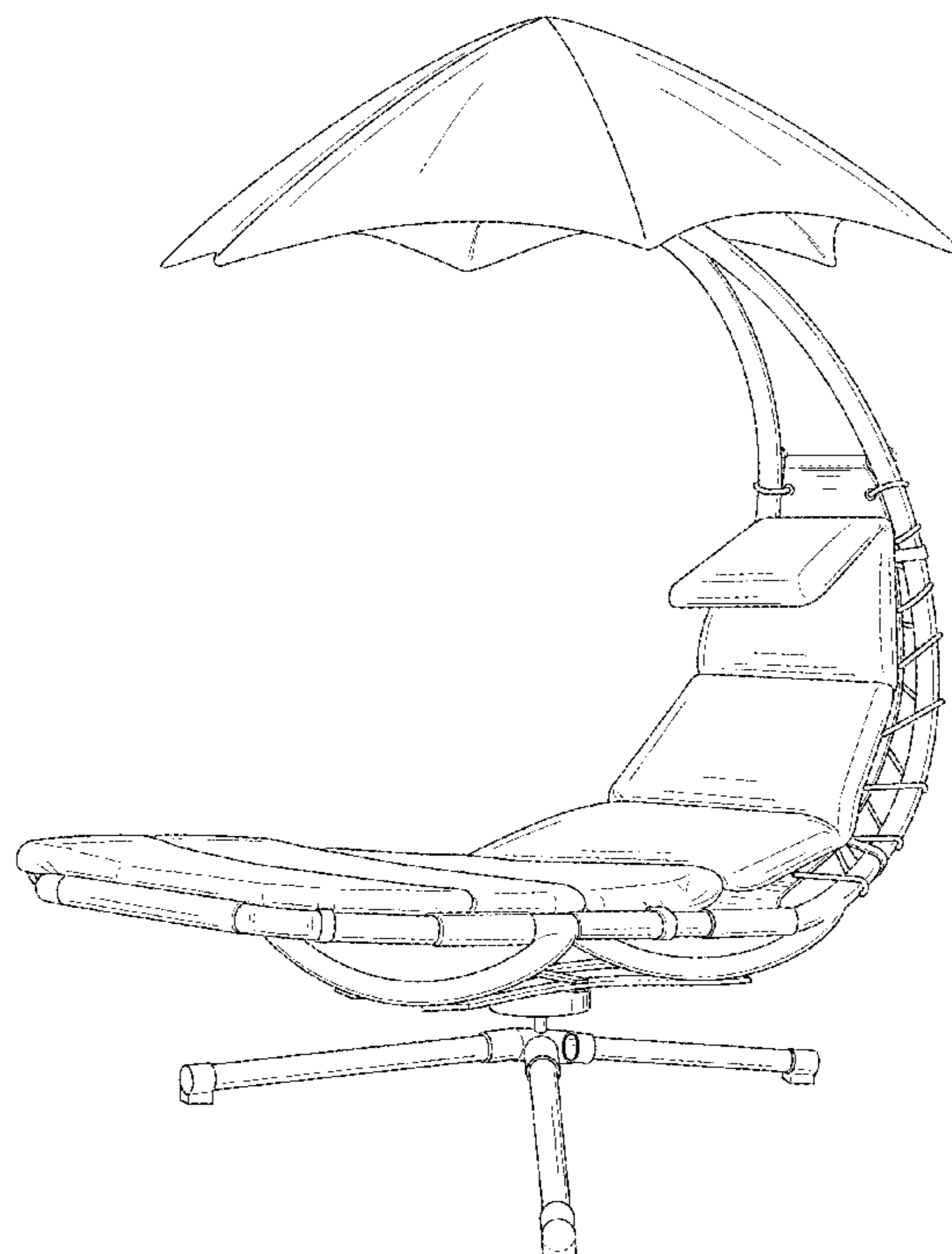

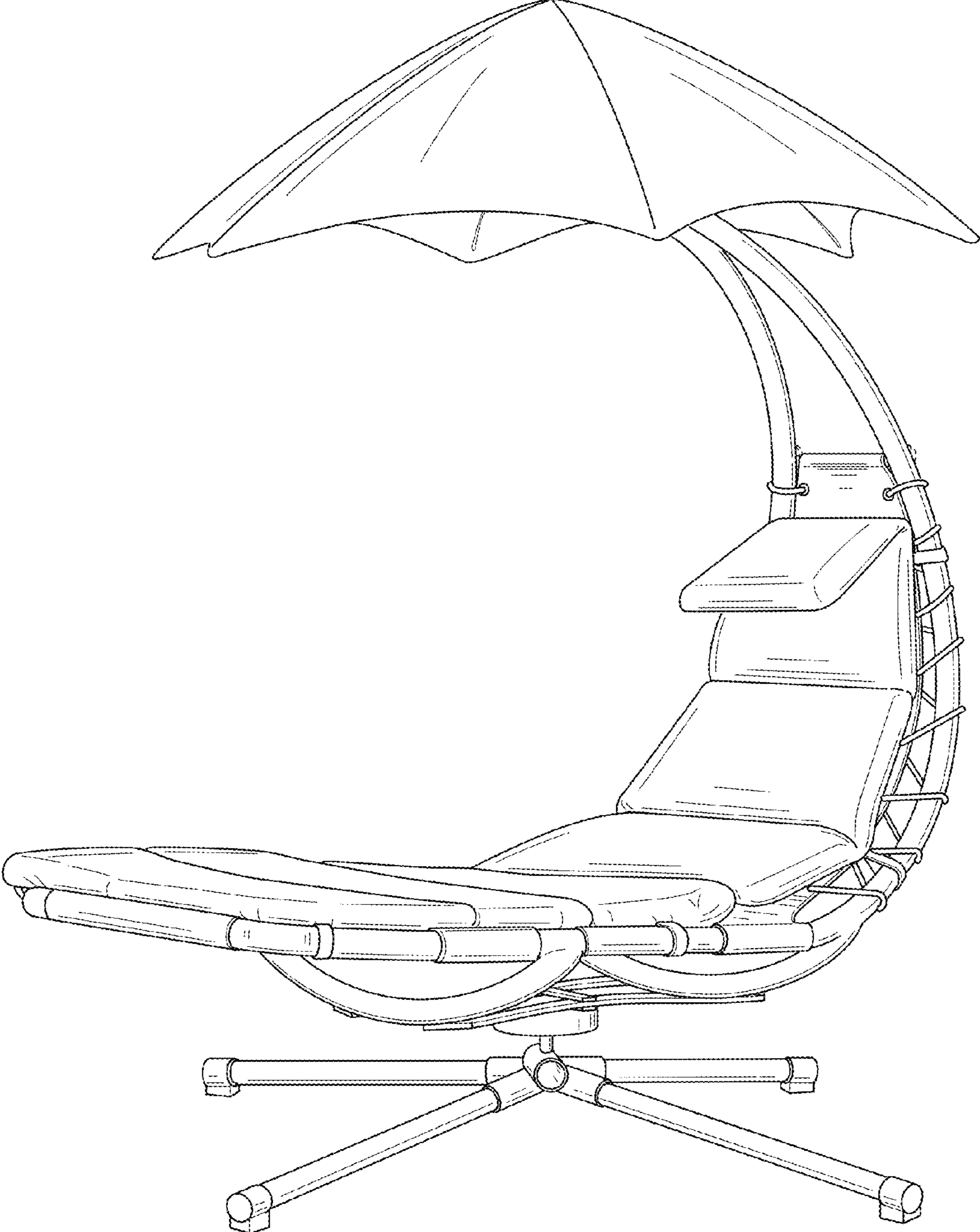

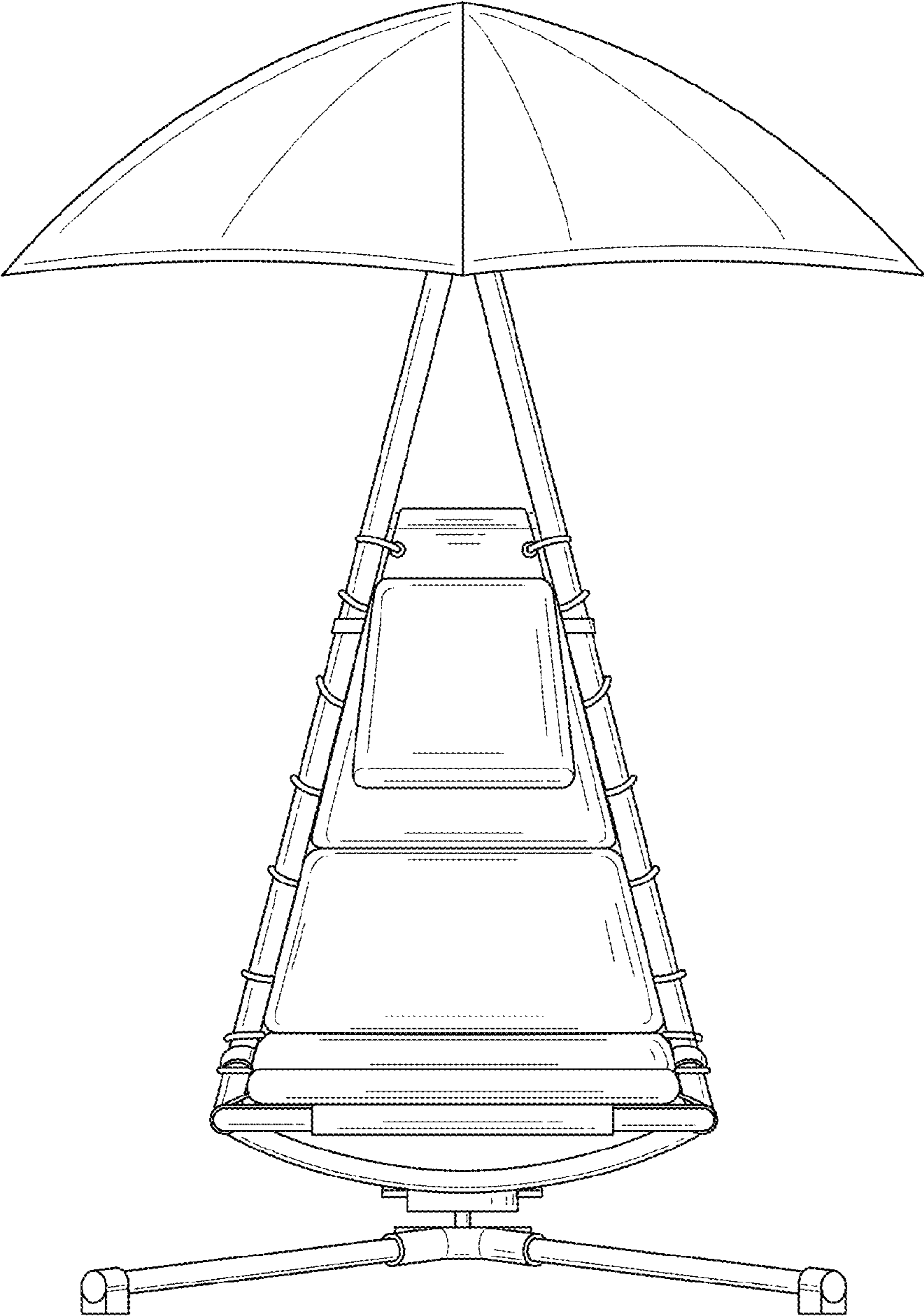

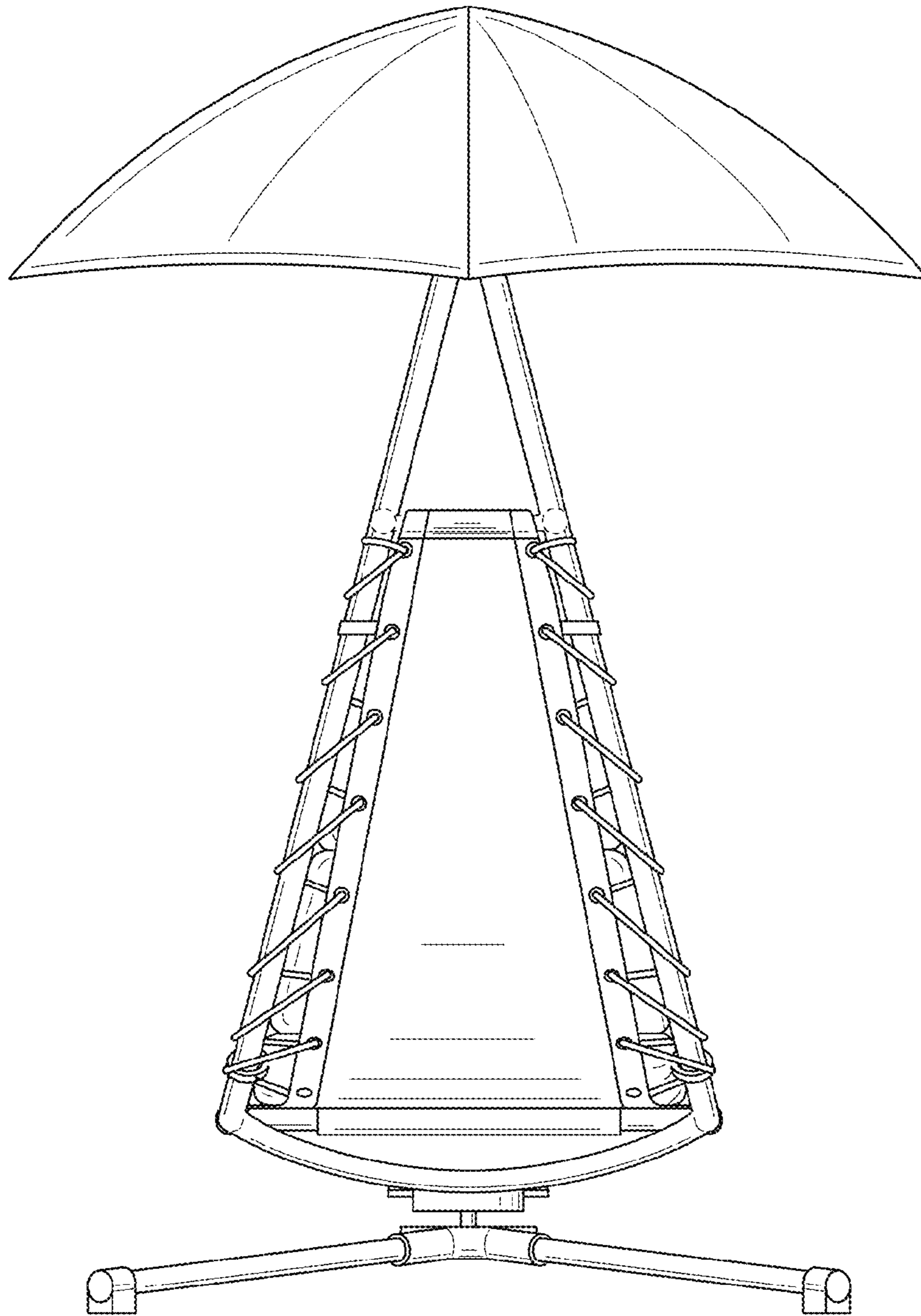

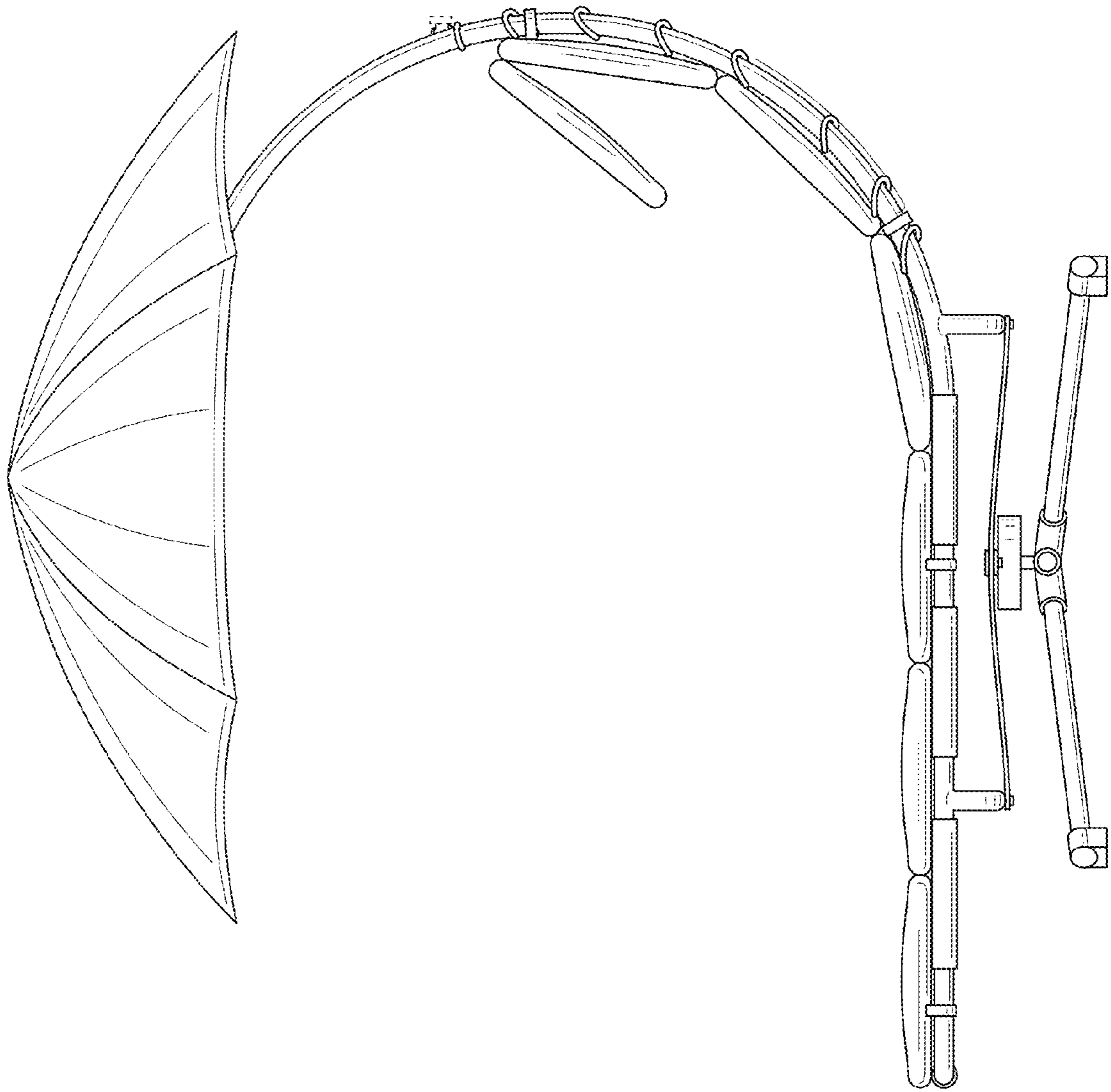

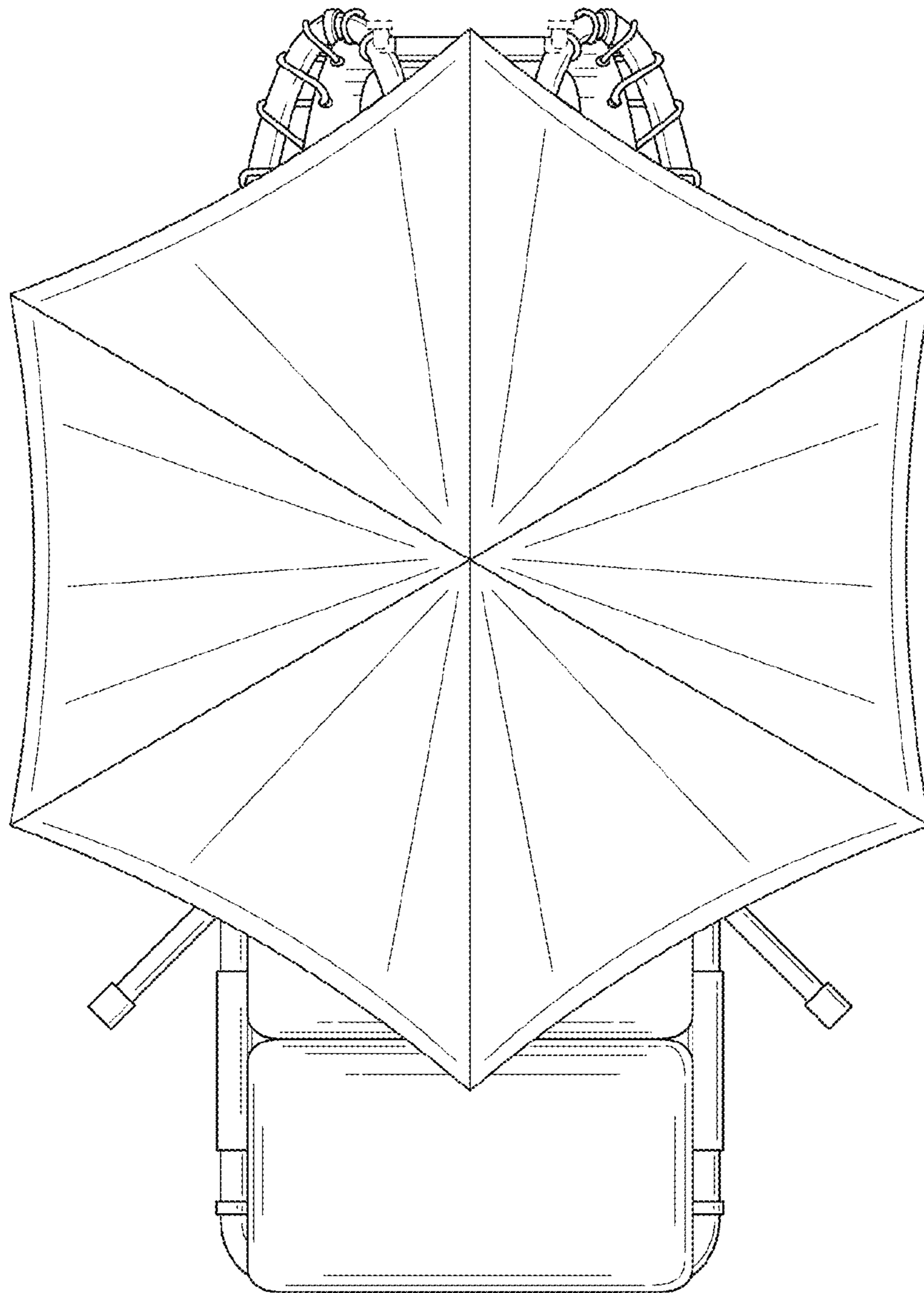

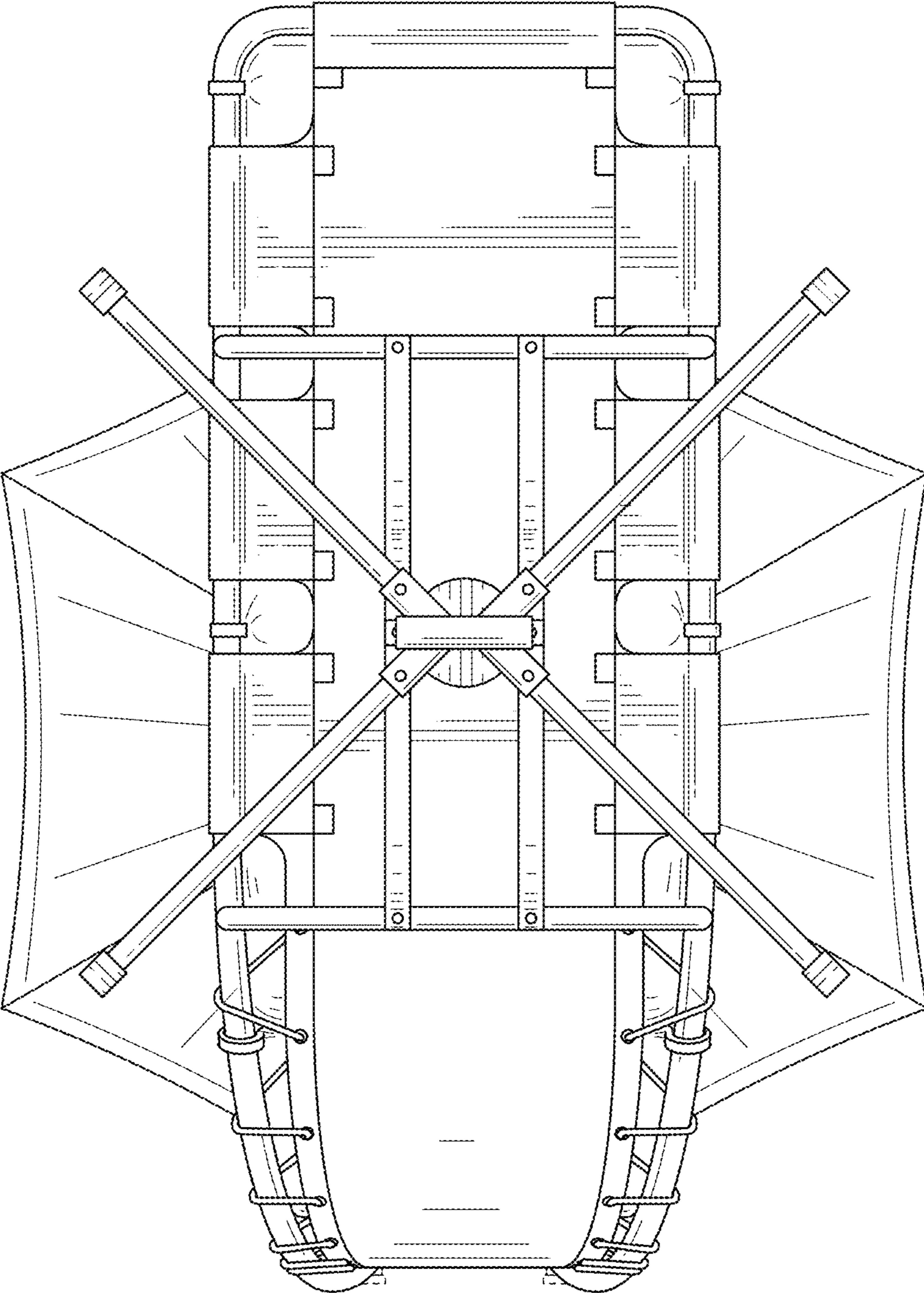
