The ornamental design for a decorated blanket, as shown and described.

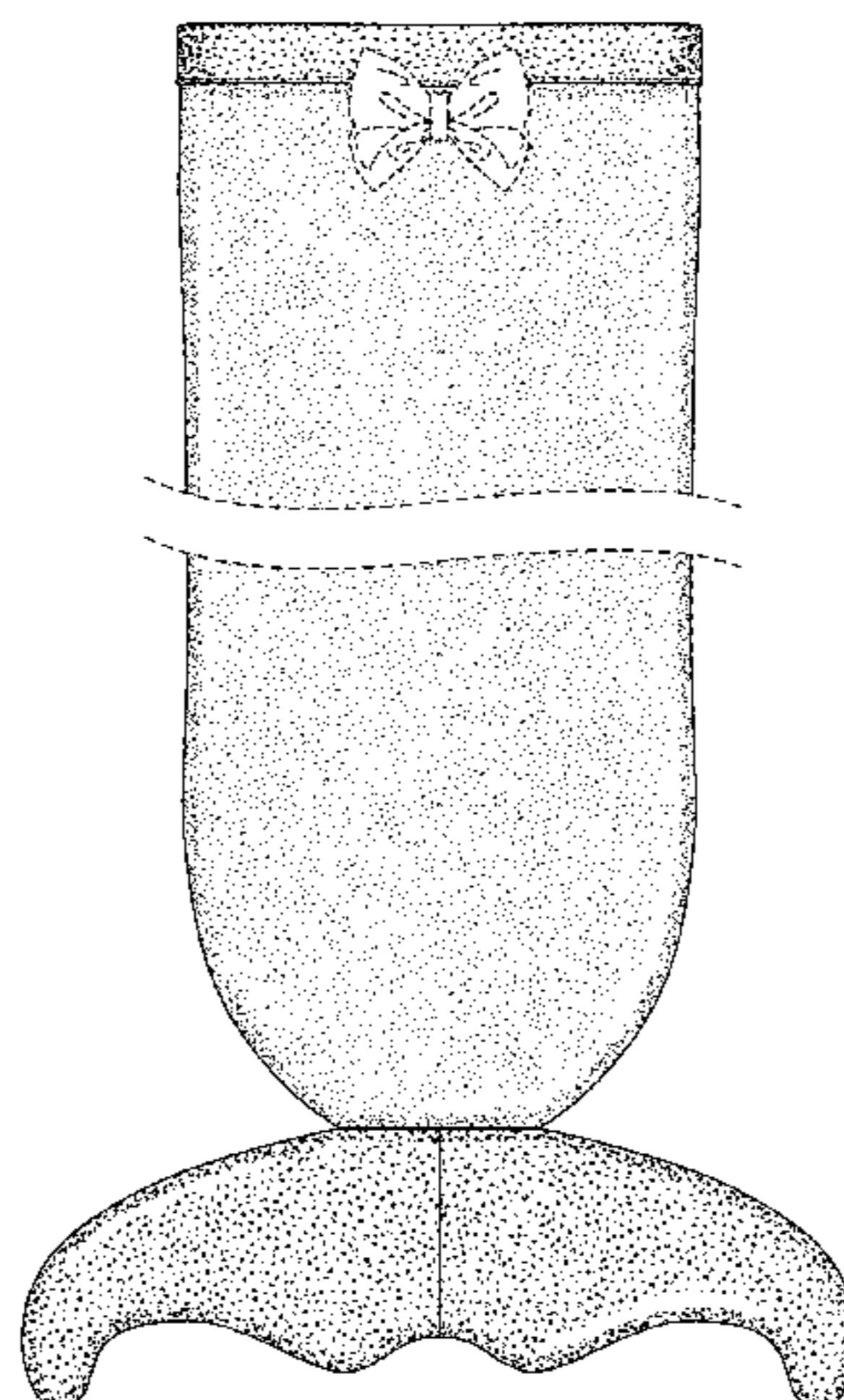
DESCRIPTION

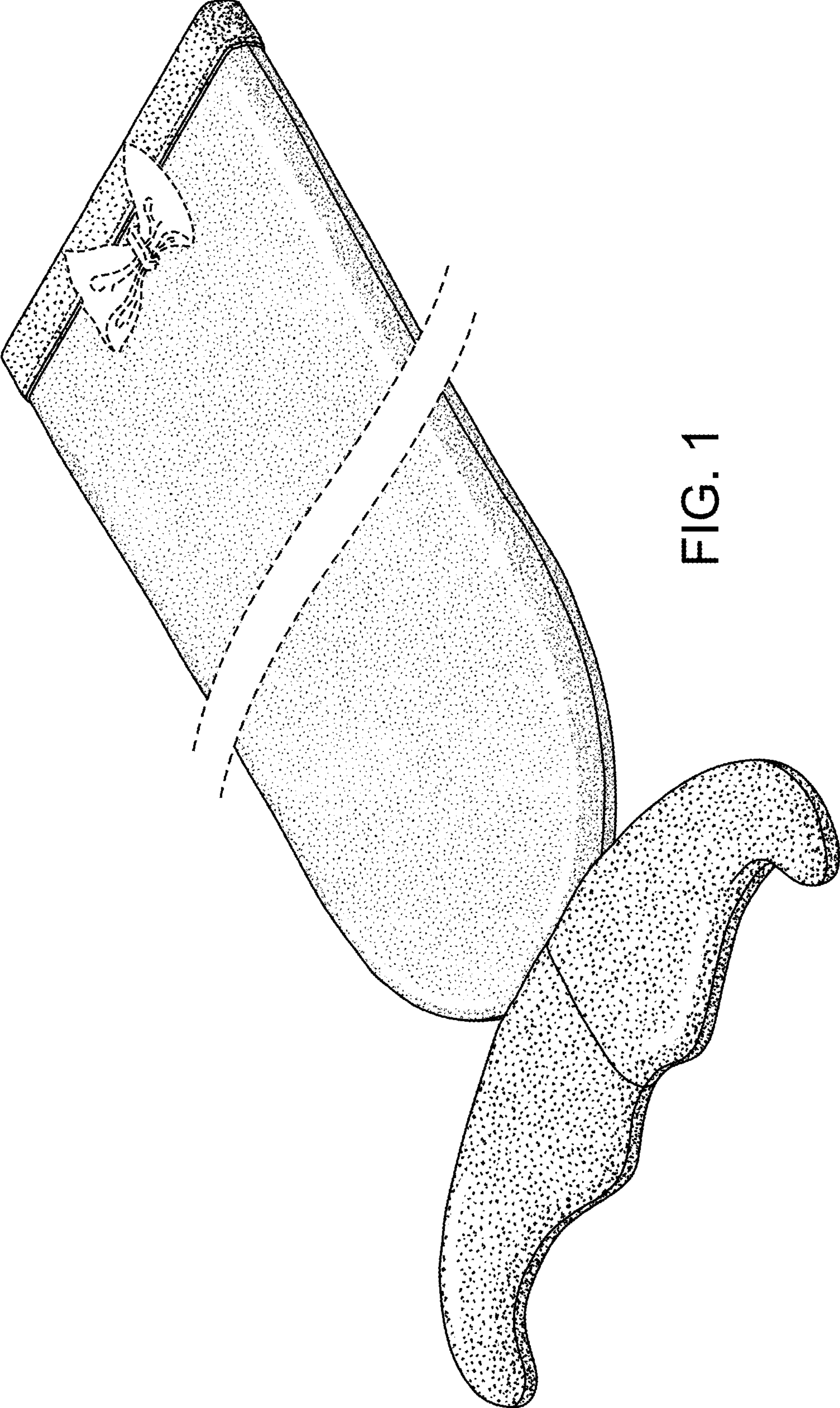

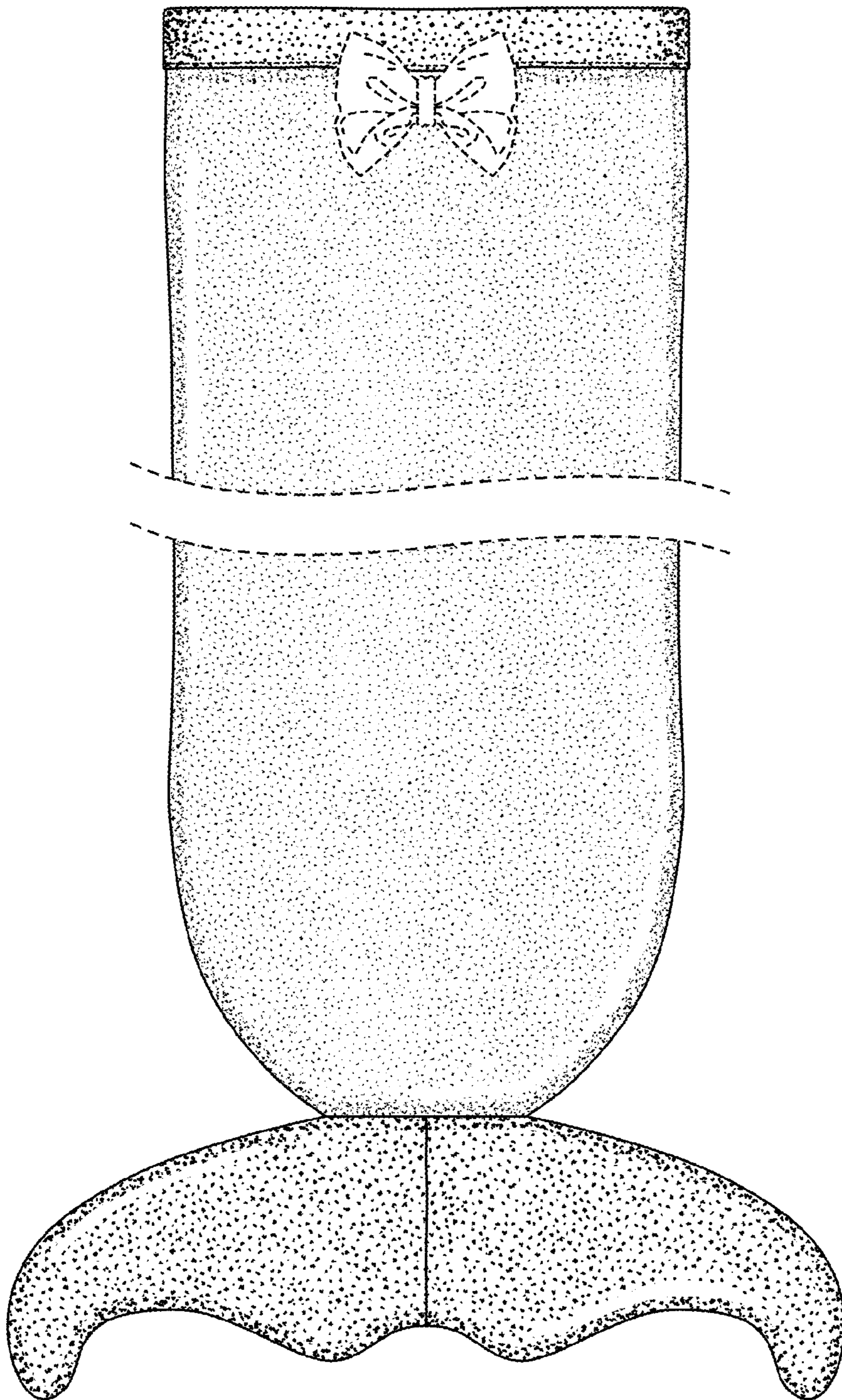

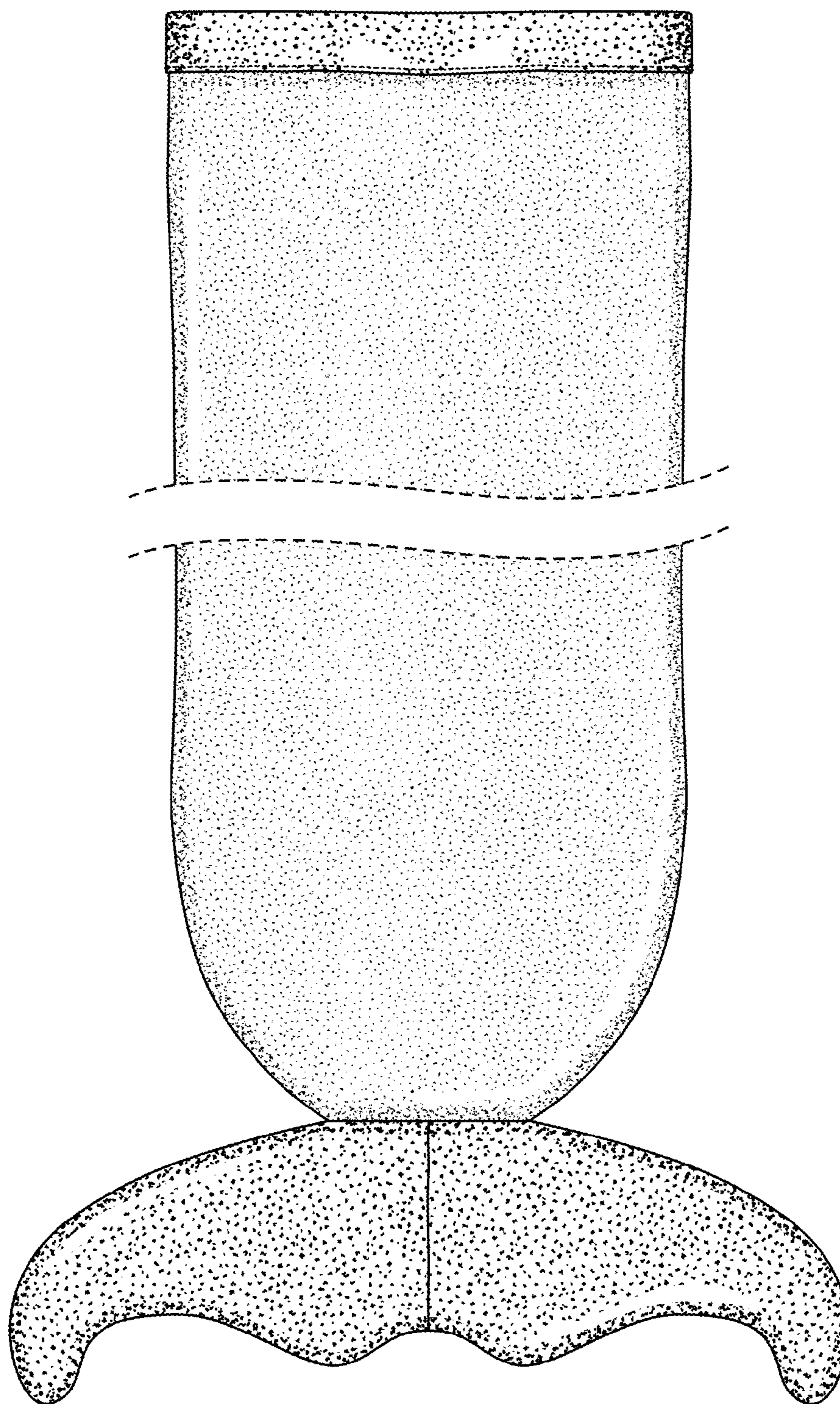

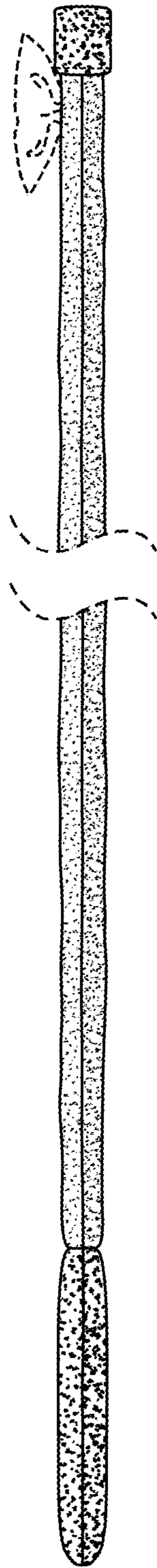

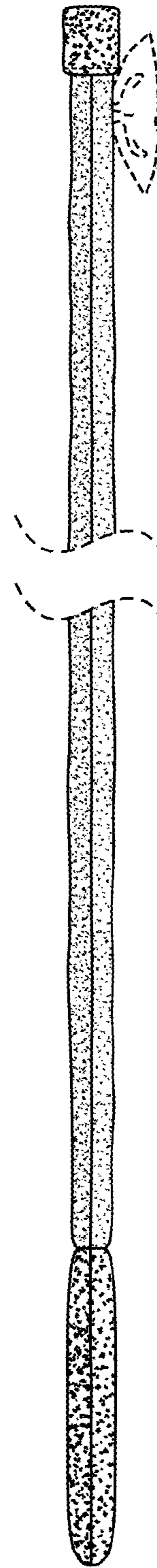
