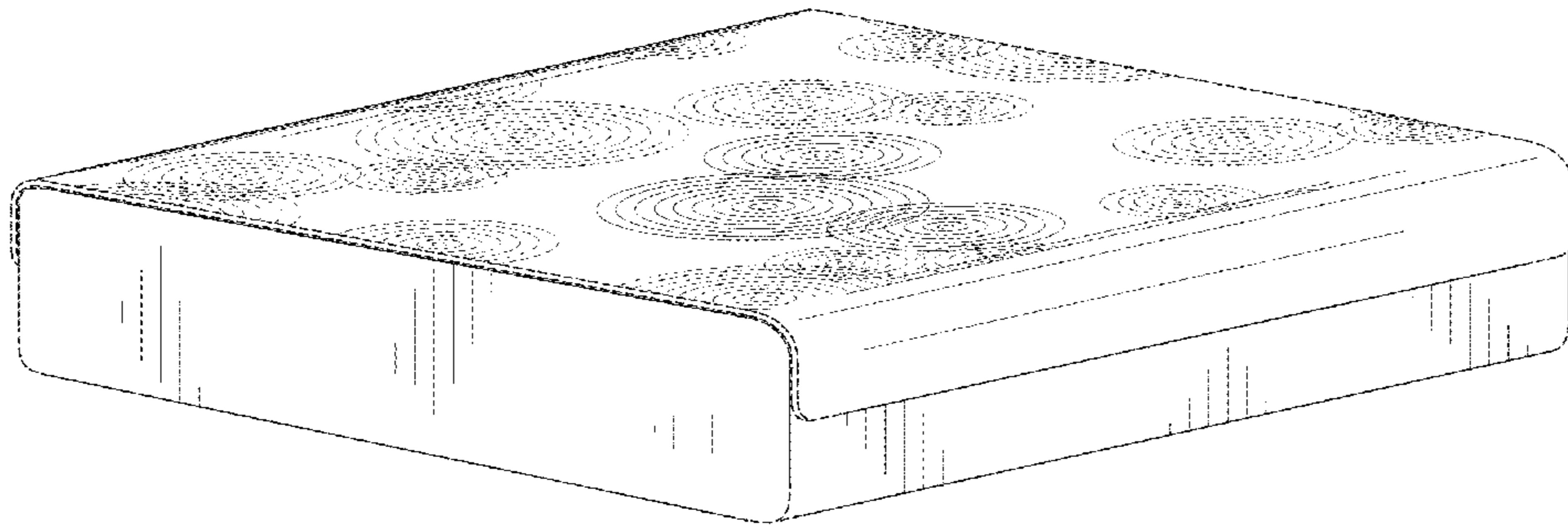

**DESCRIPTION**

FIG. 1 is a front elevational view of the mattress cover  
assembly of the present invention;

FIG. 3 is a left side elevational view of the mattress cover

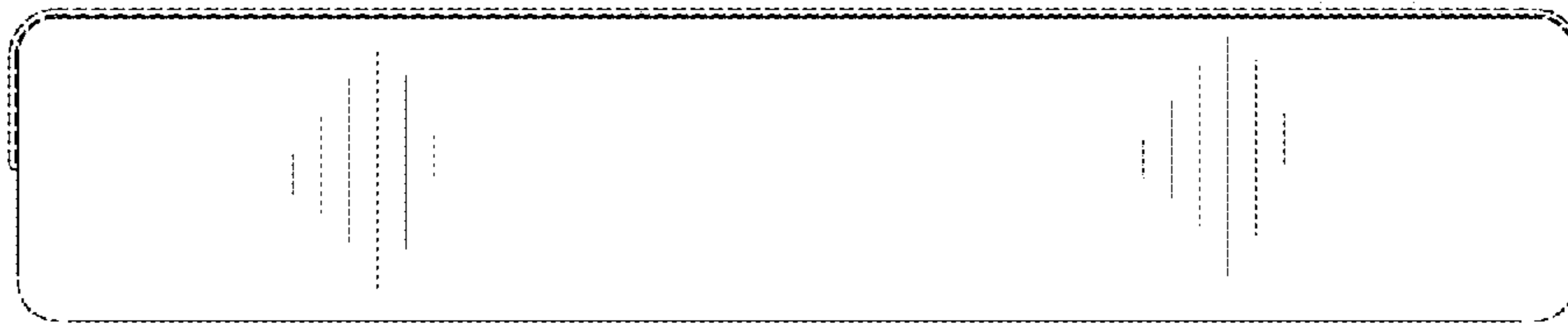

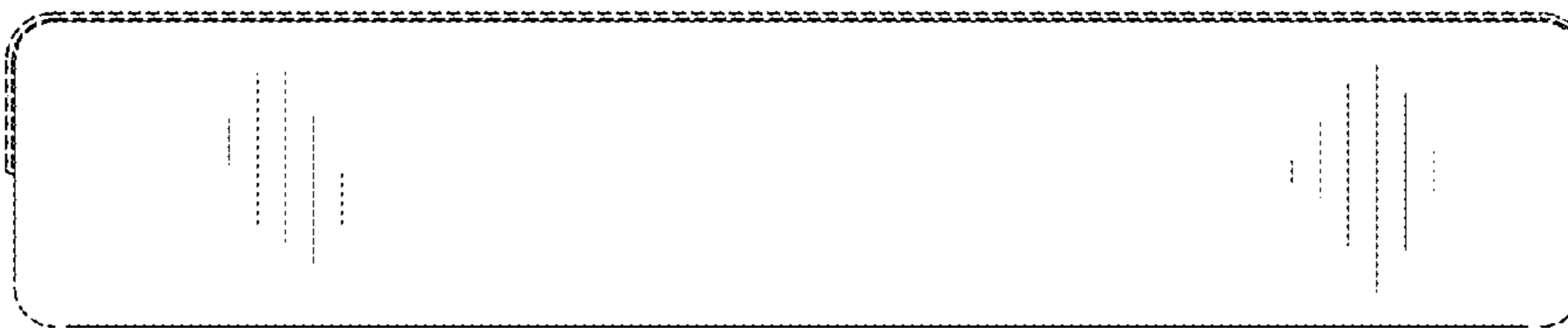

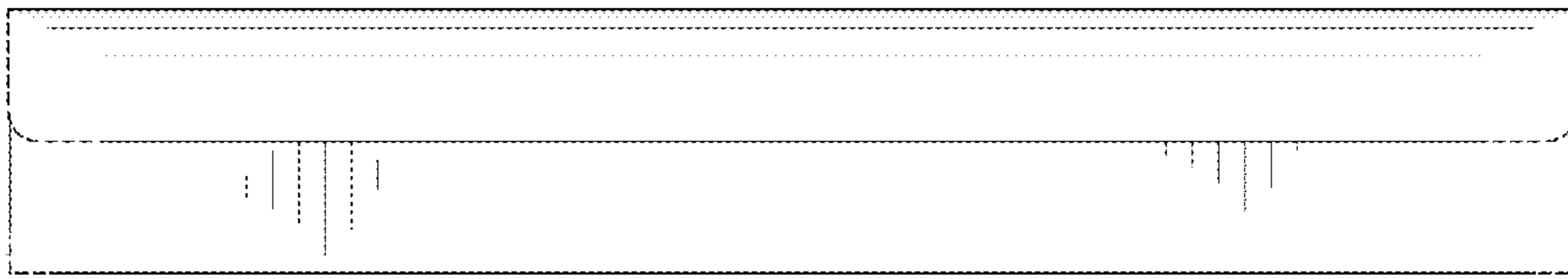

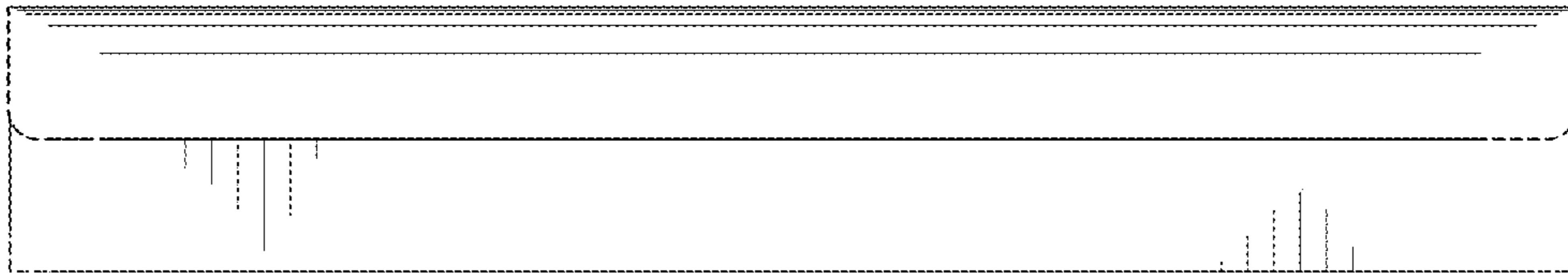

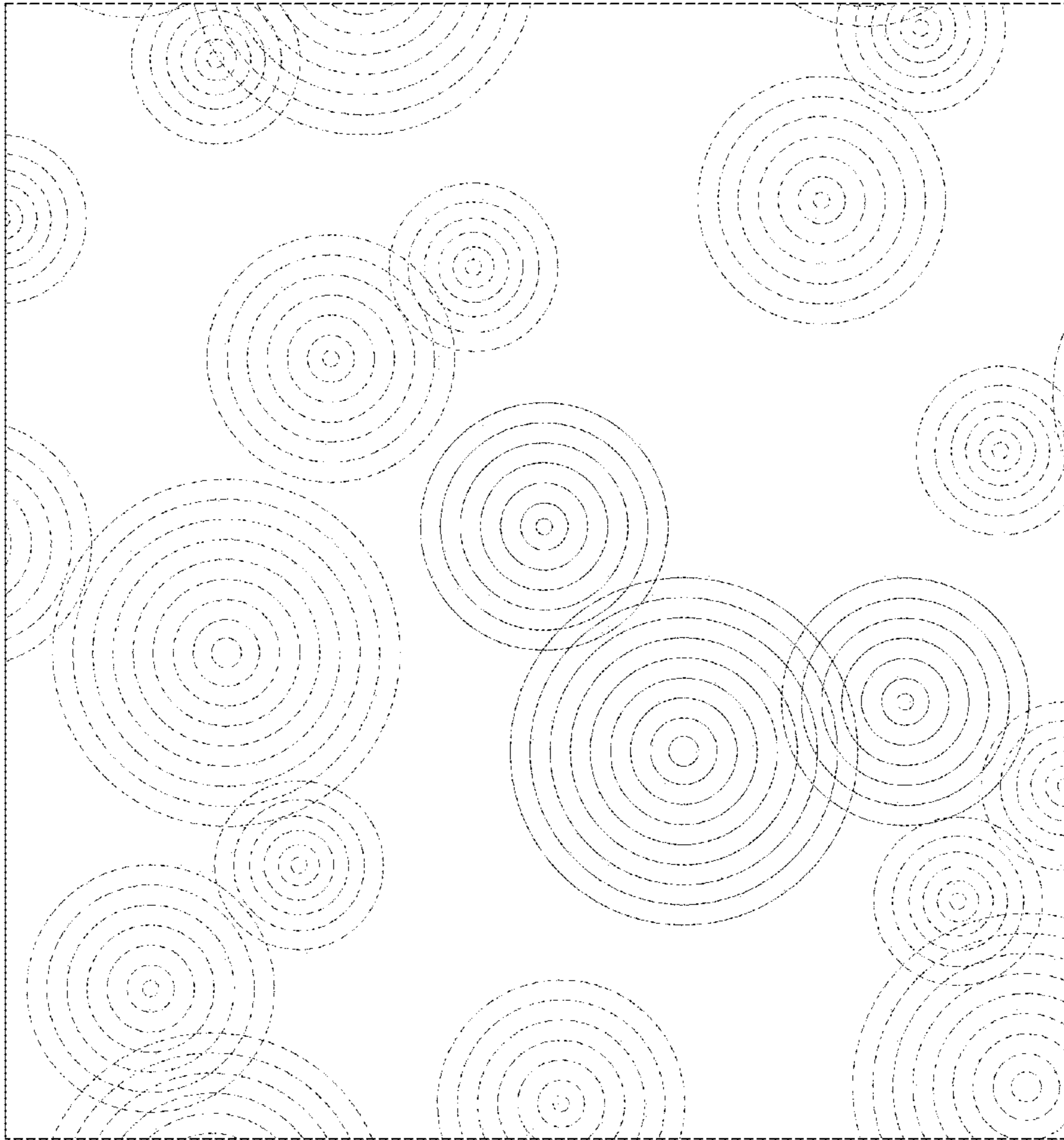

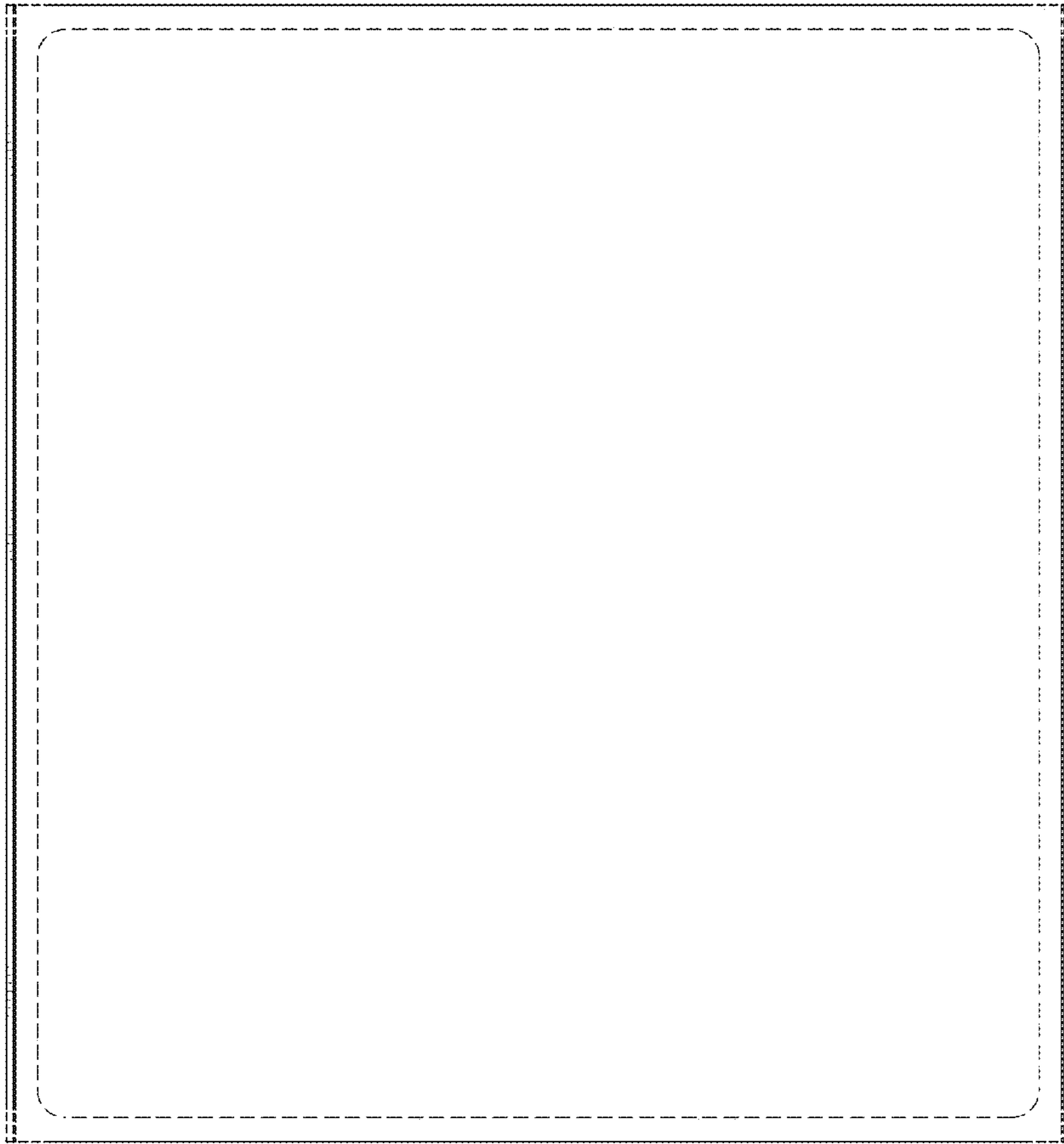

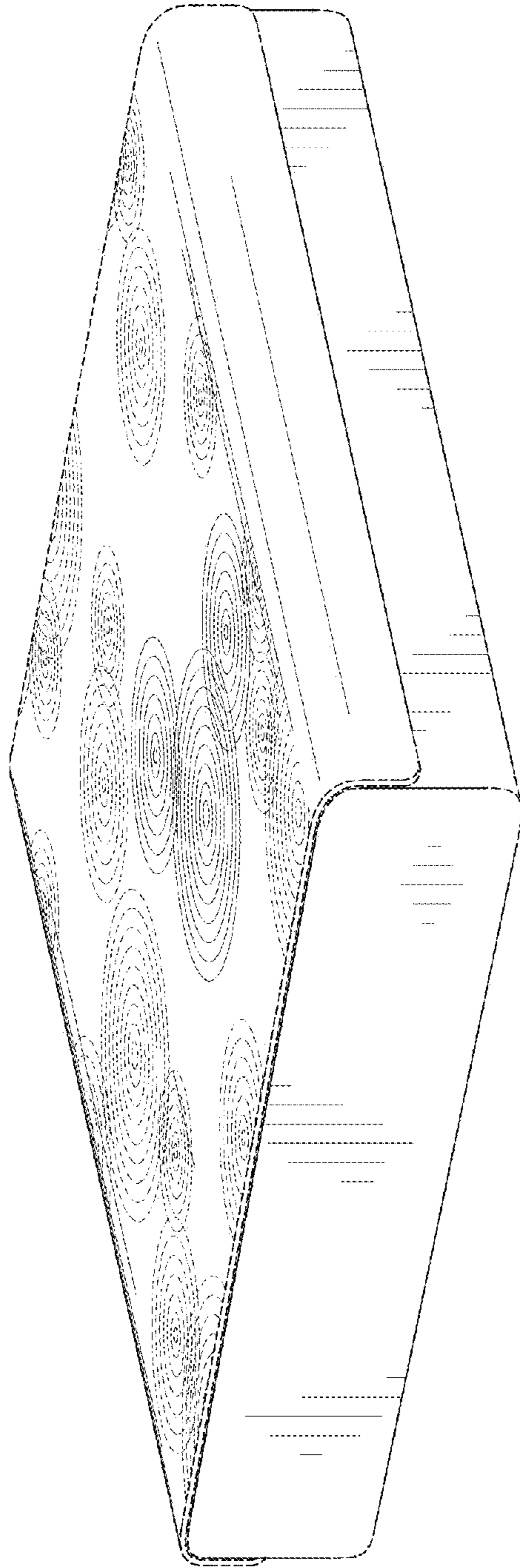
