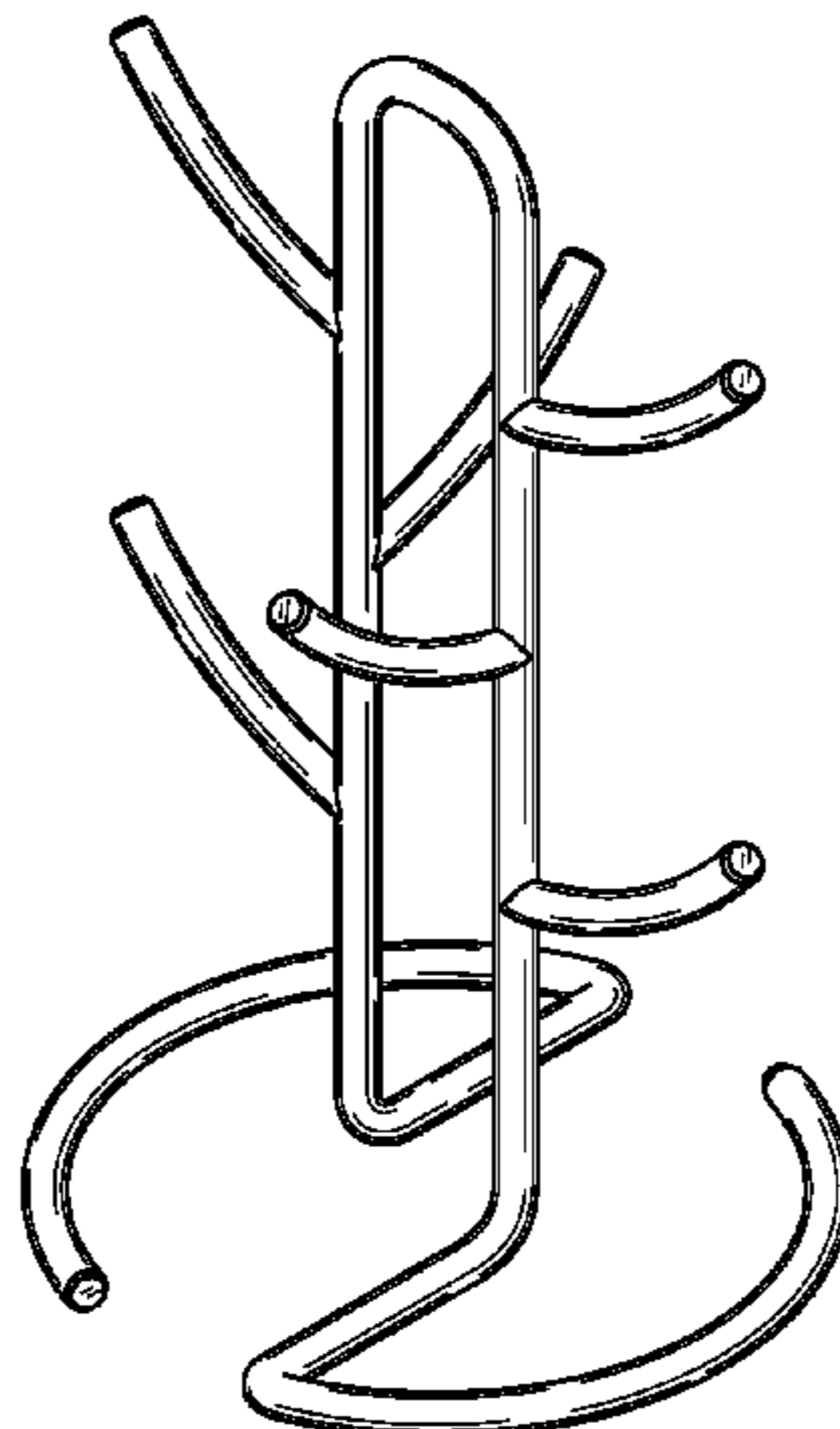

DESCRIPTION

FIG. 1 is a top, front and side perspective view of a mug tree showing our new design;
FIG. 2 is a side view thereof, the opposite side view being the mirror image thereof;
FIG. 3 is a front plan view thereof, the rear plan view being the mirror image thereof;

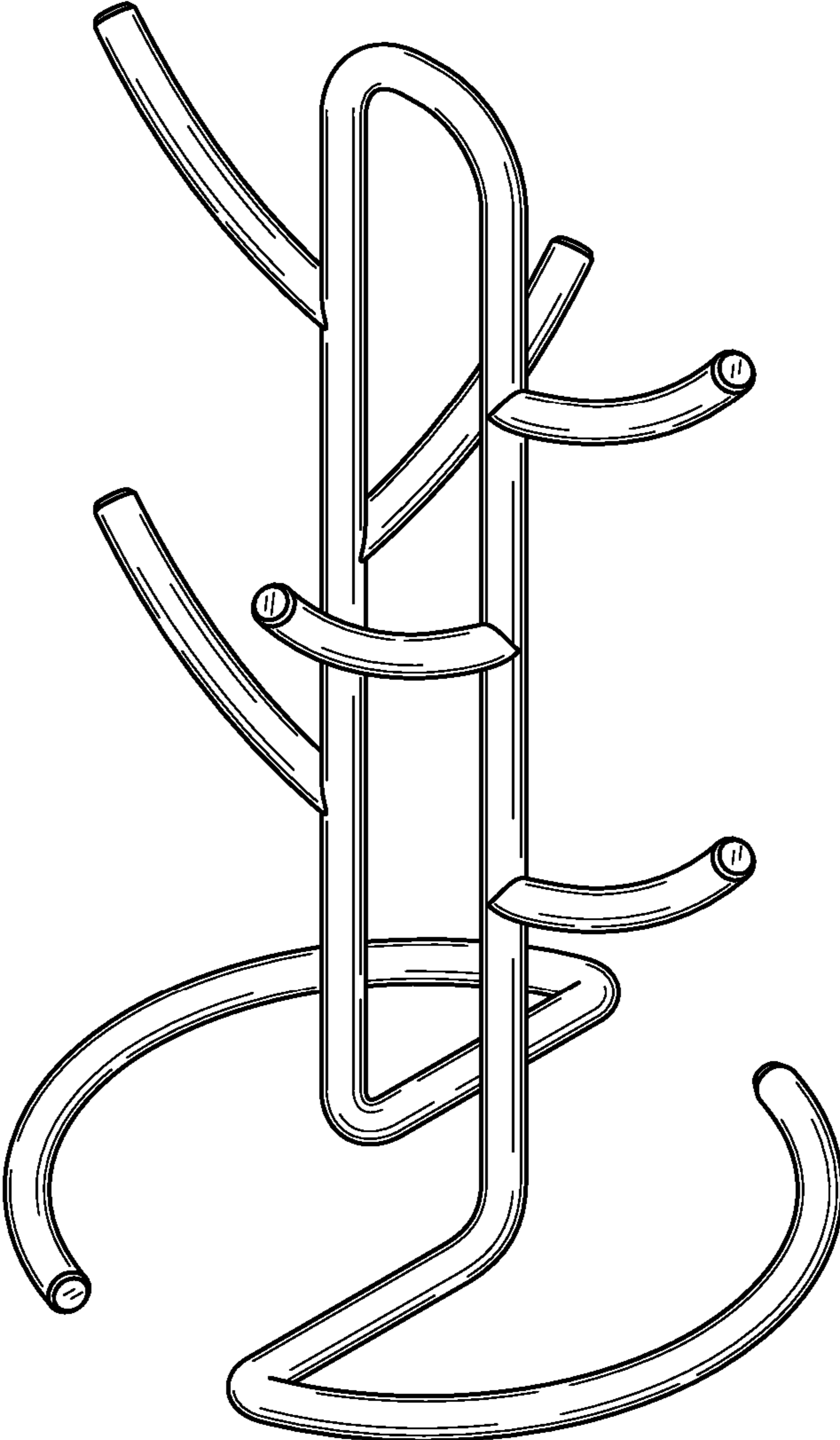

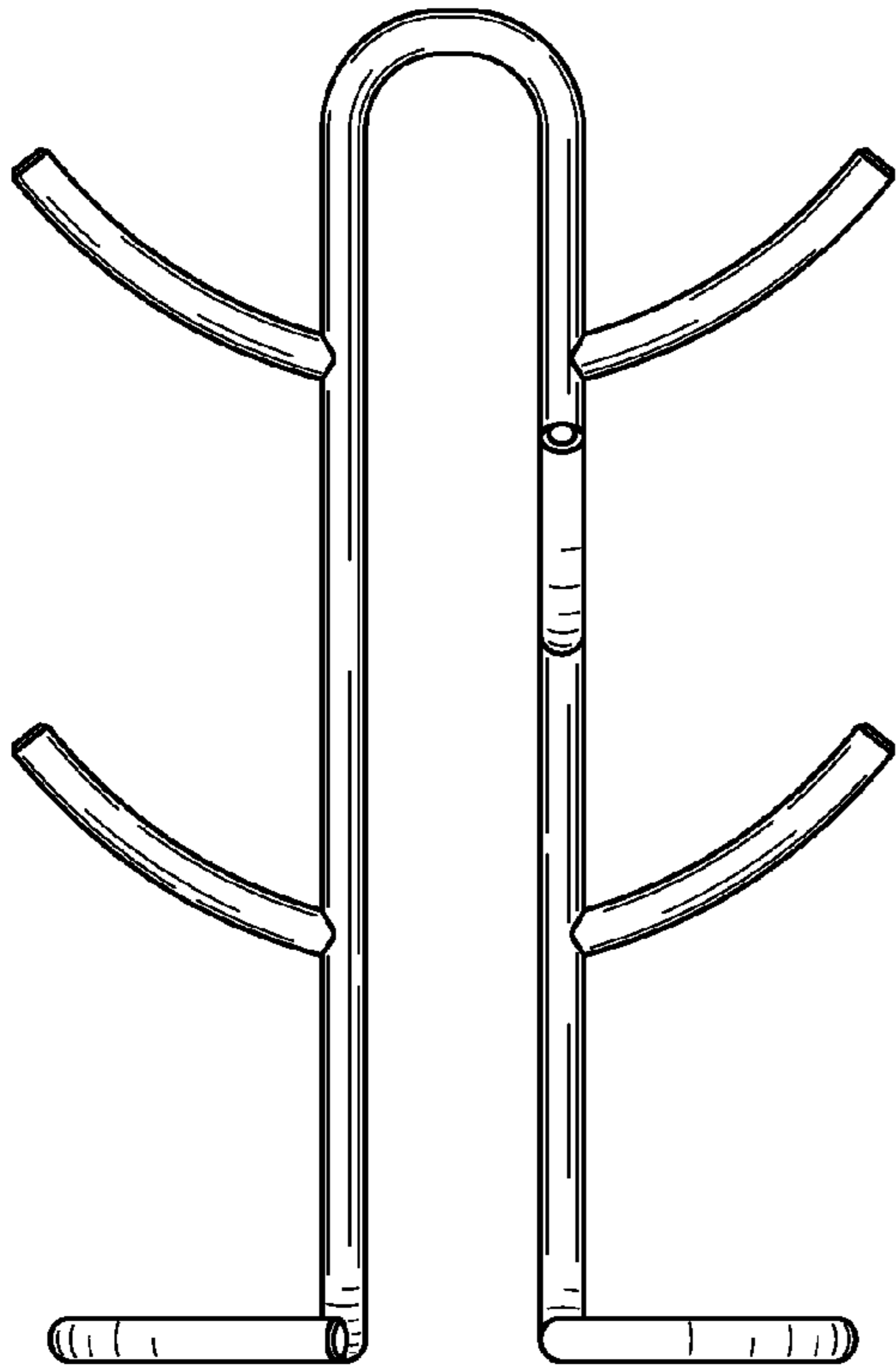

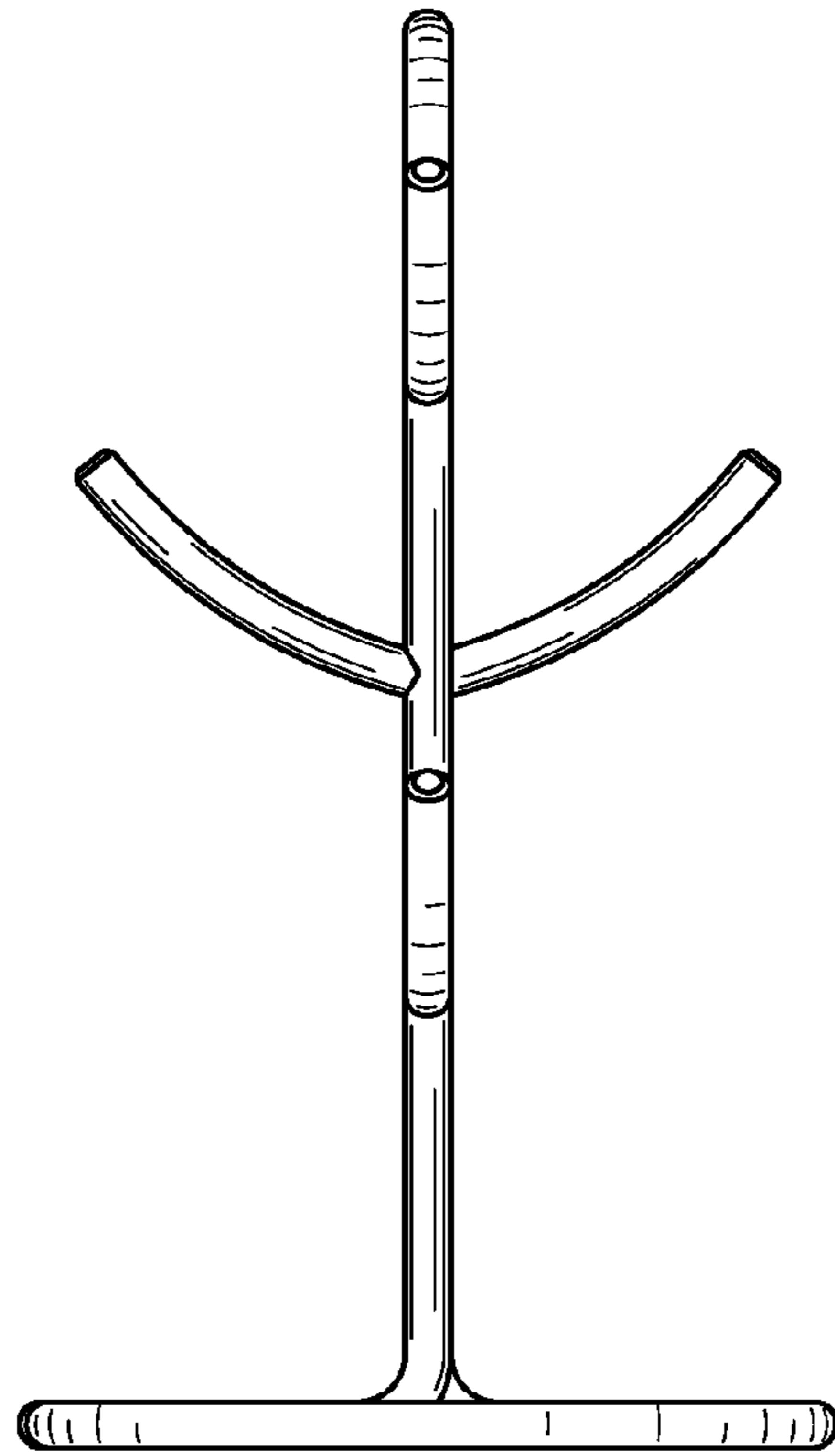

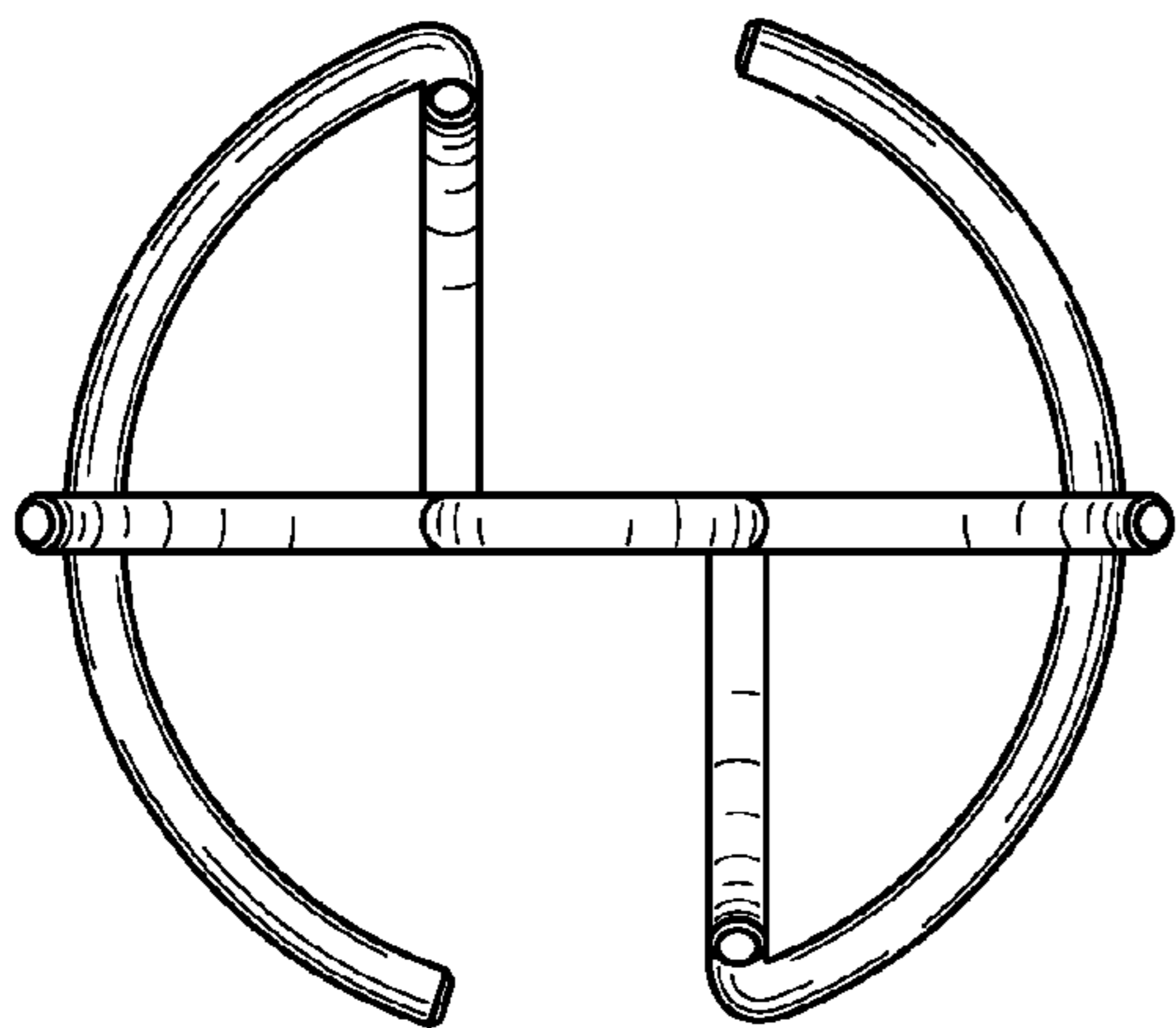

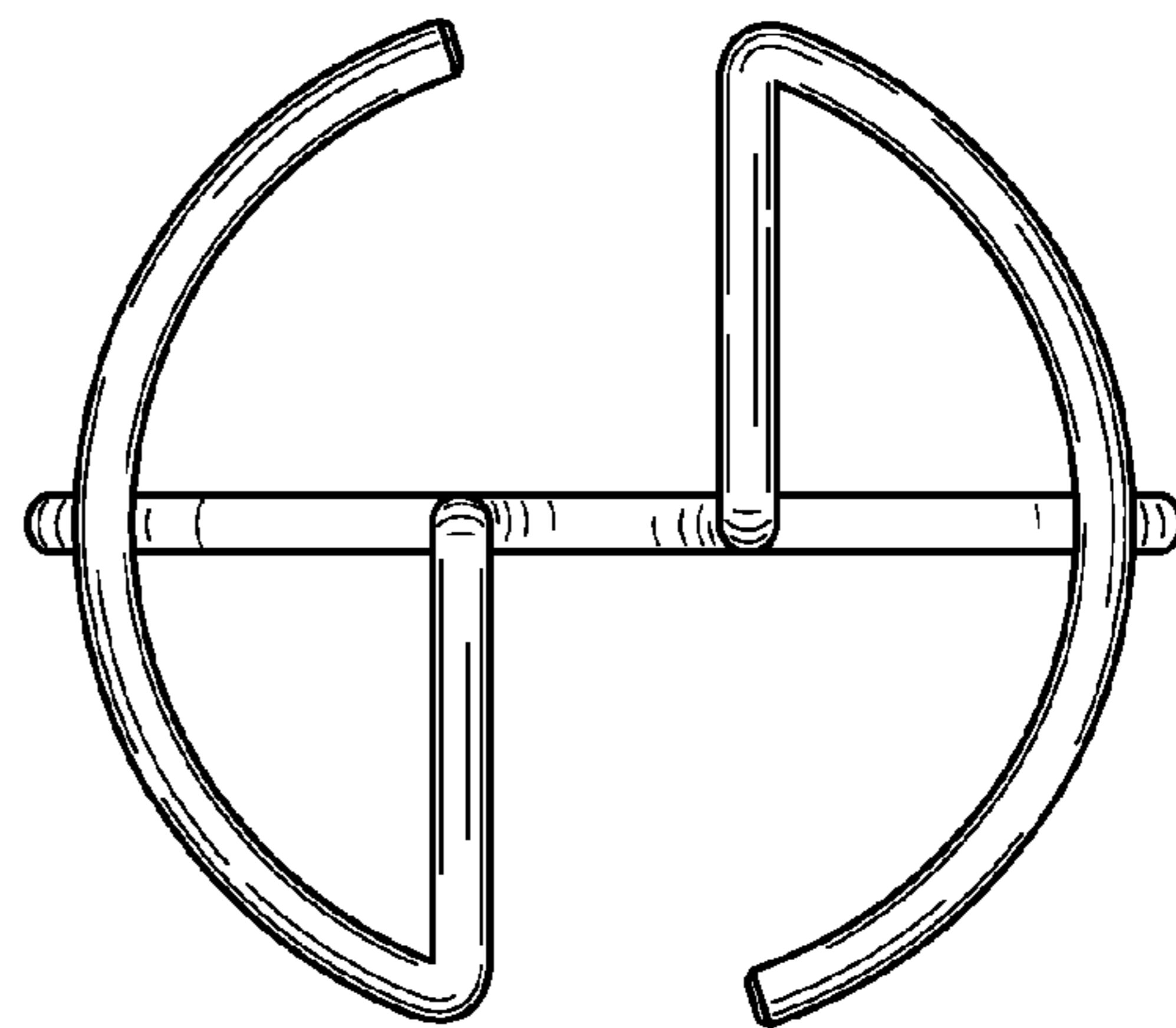
