(57) **CLAIM**

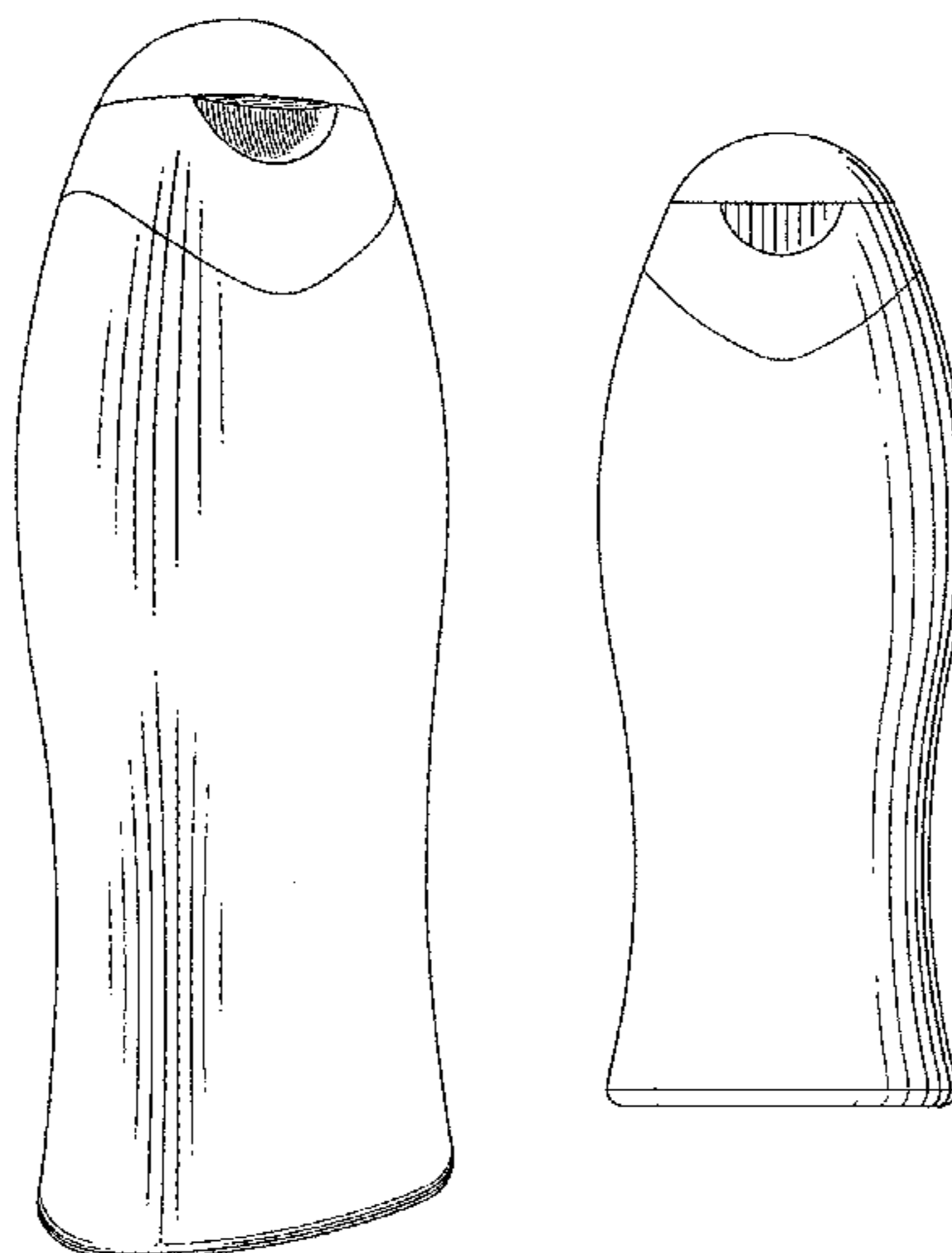
The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the container;
FIG. 2 is a side elevational view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a side elevational view as seen from the right hand side of FIG. 3;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

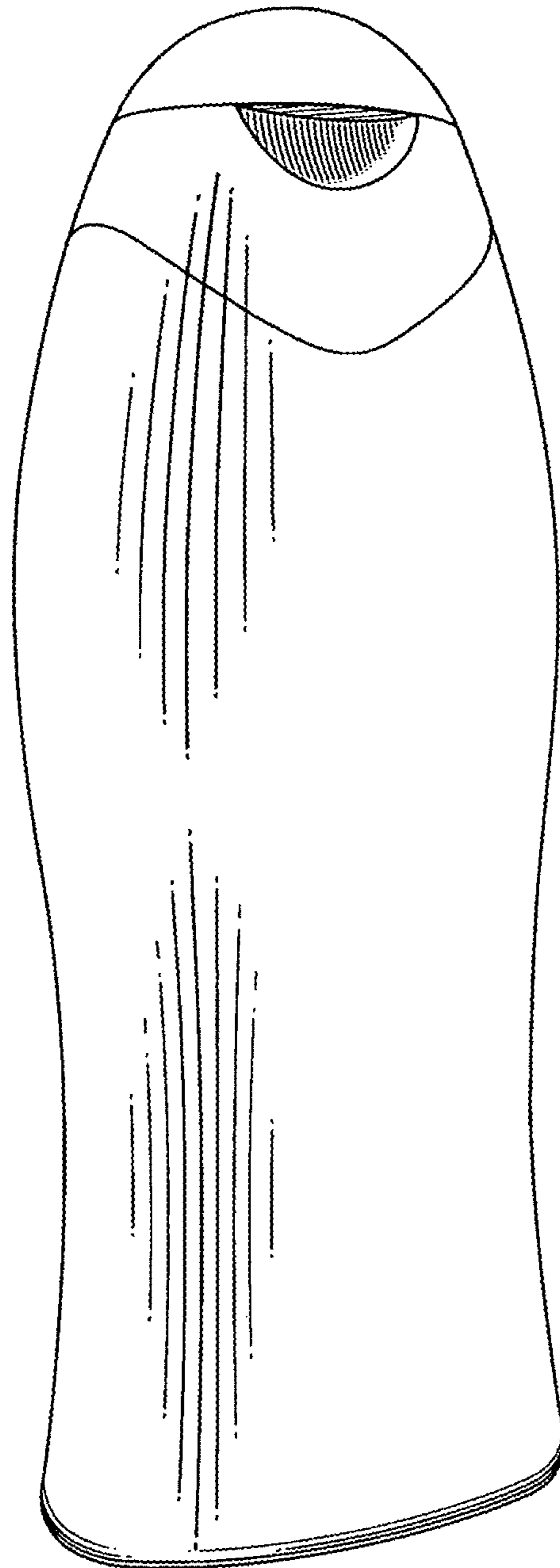

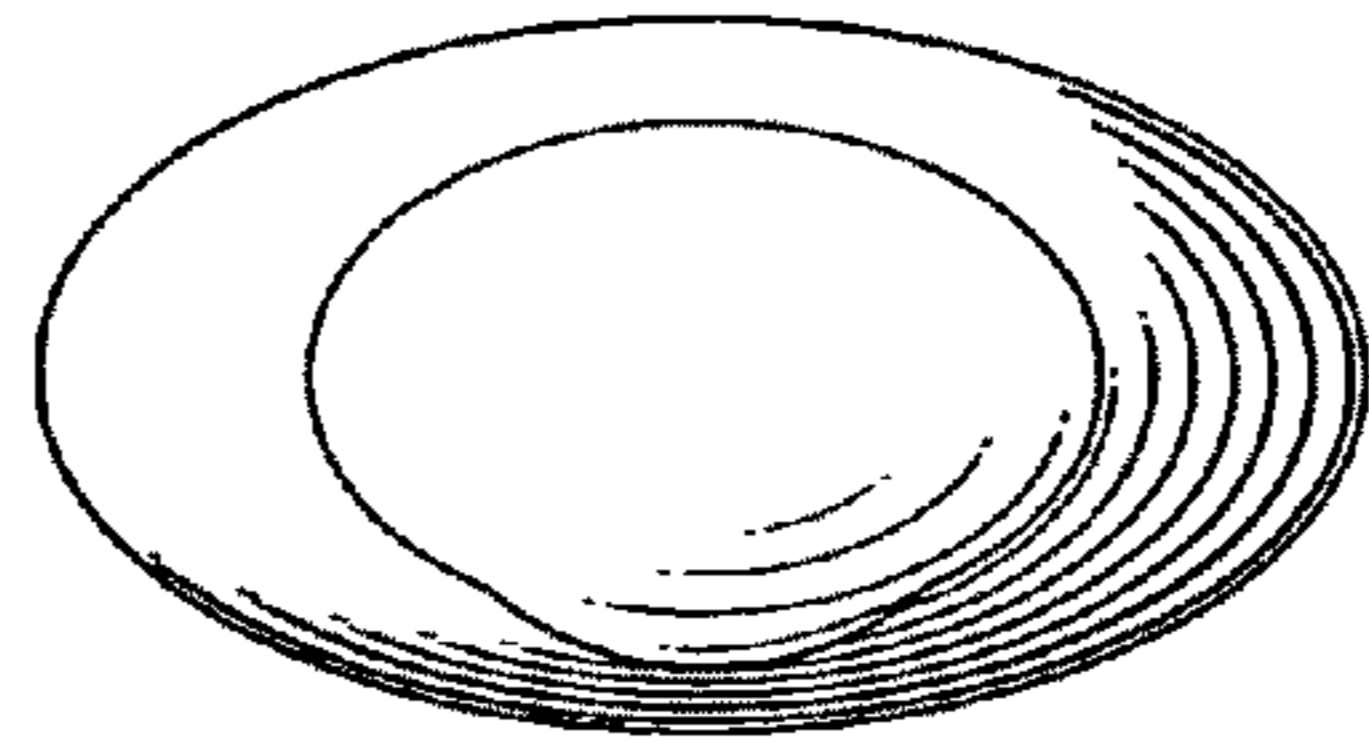

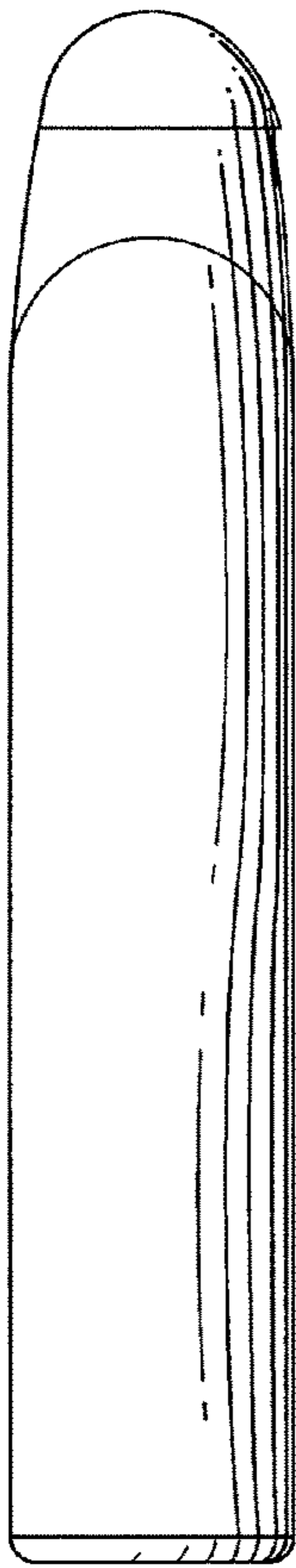

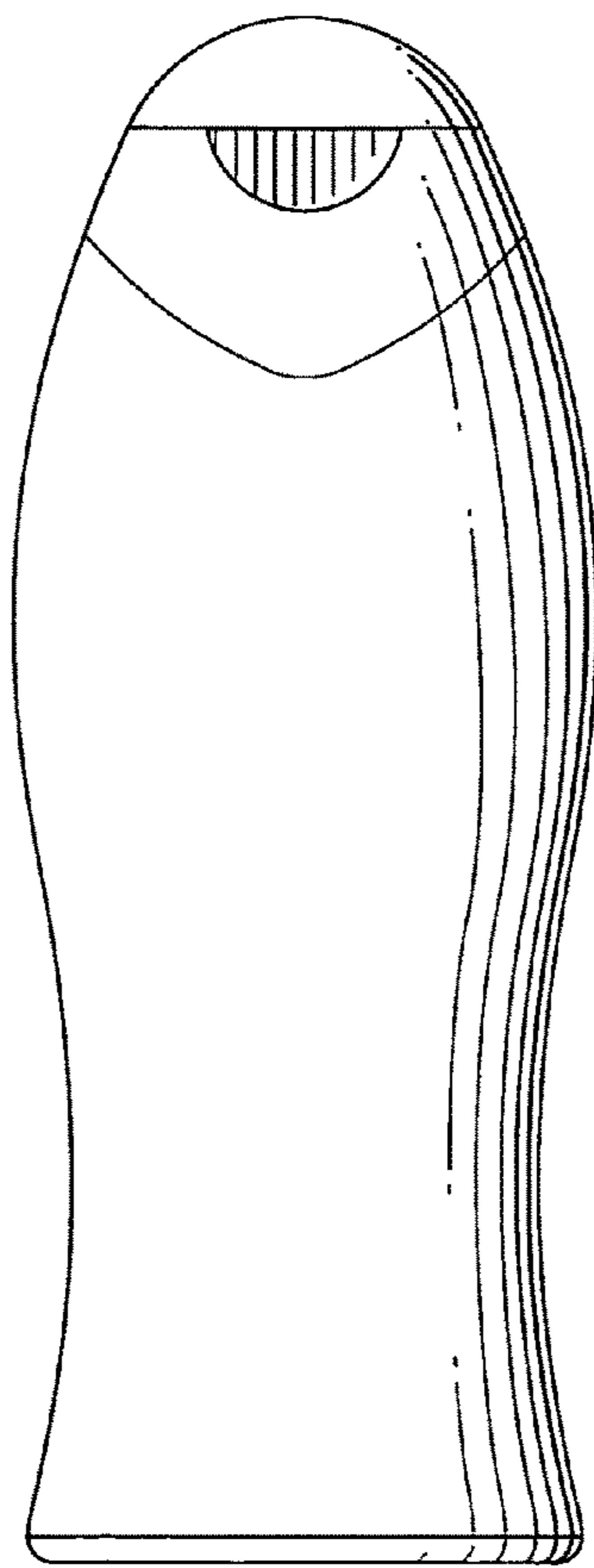

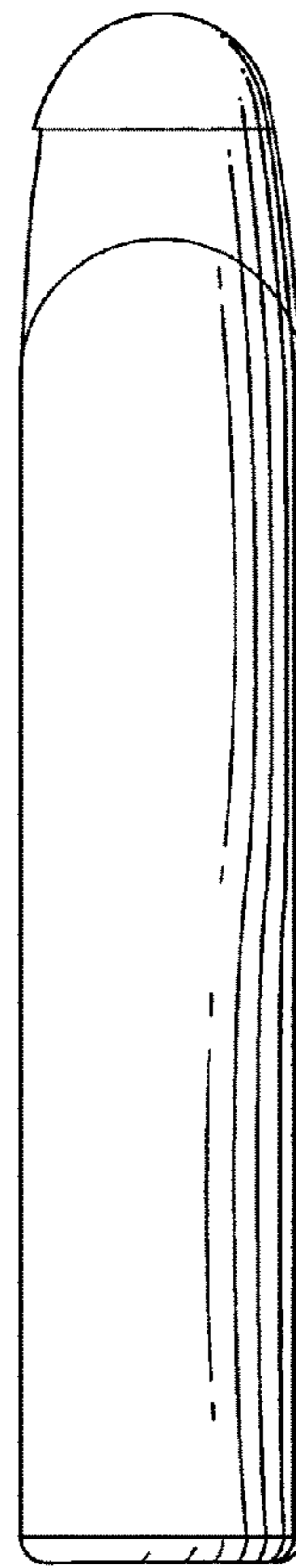

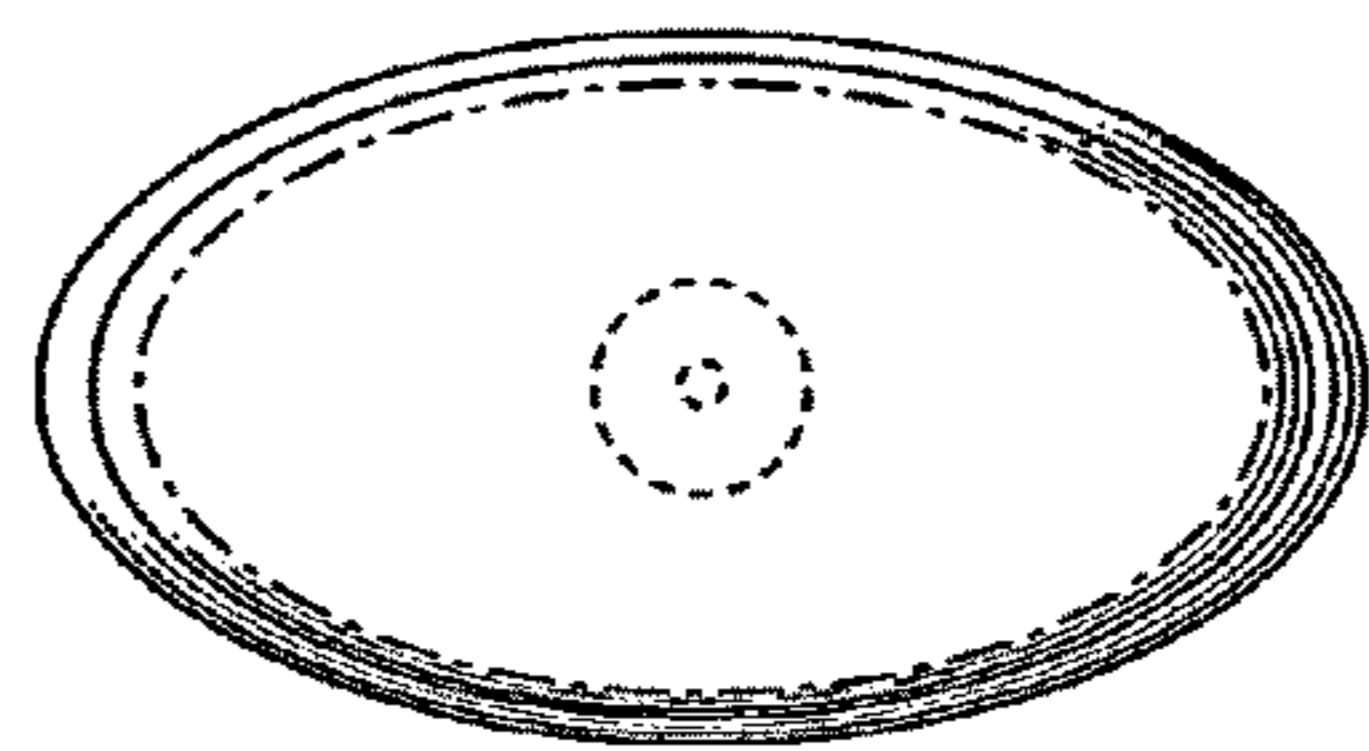
