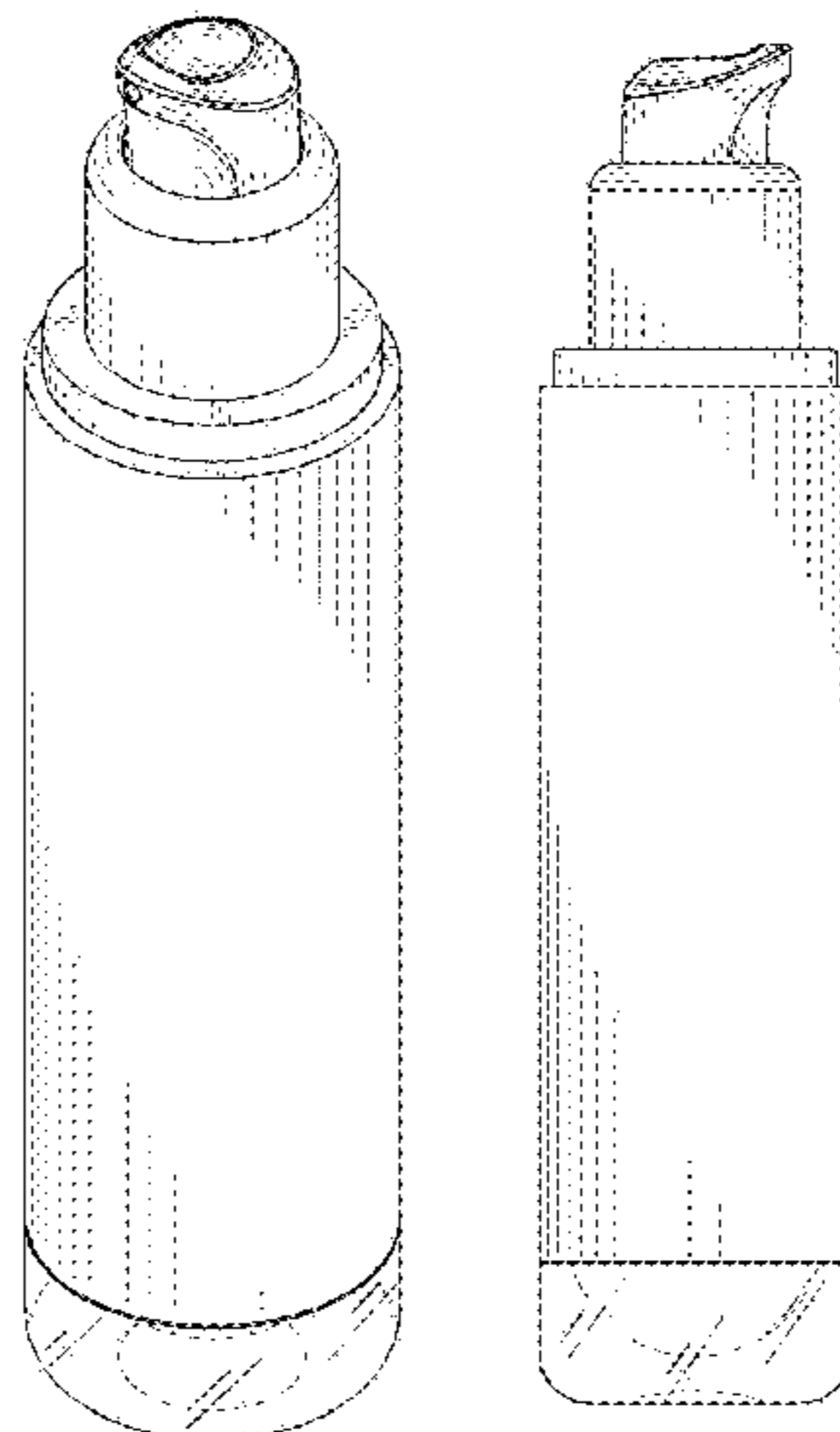
(57) **CLAIM**

The applicant claims the ornamental design for a pumping vessel for packing cosmetic products, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pumping vessel for packing cosmetic products showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof, a right side elevational view is a mirror image of the left side elevational view; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof. The broke lines depicted in FIG. 6 are included for the purpose of illustrating the interior features that form no part of the claimed design.

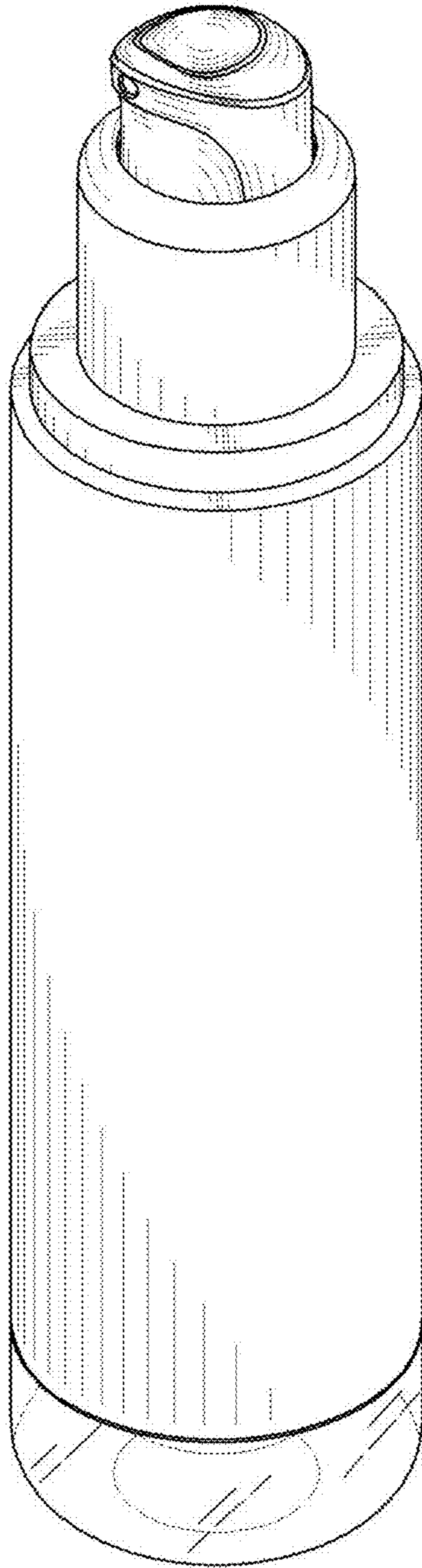

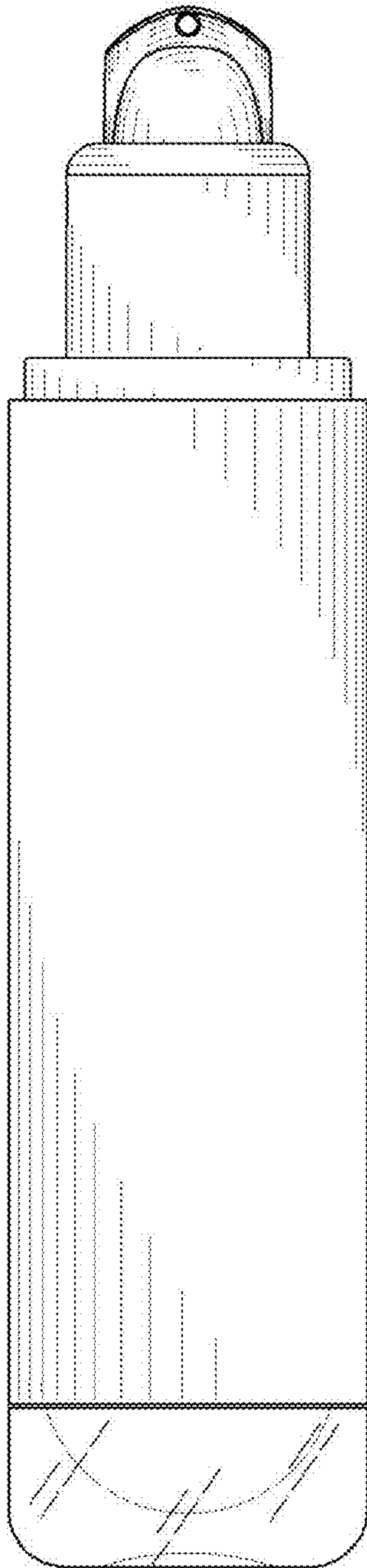

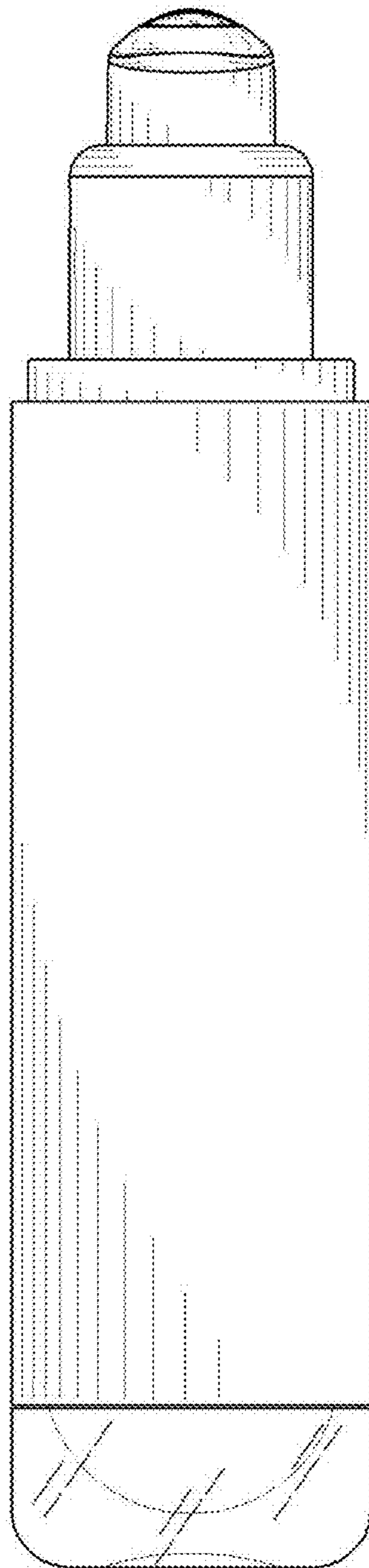

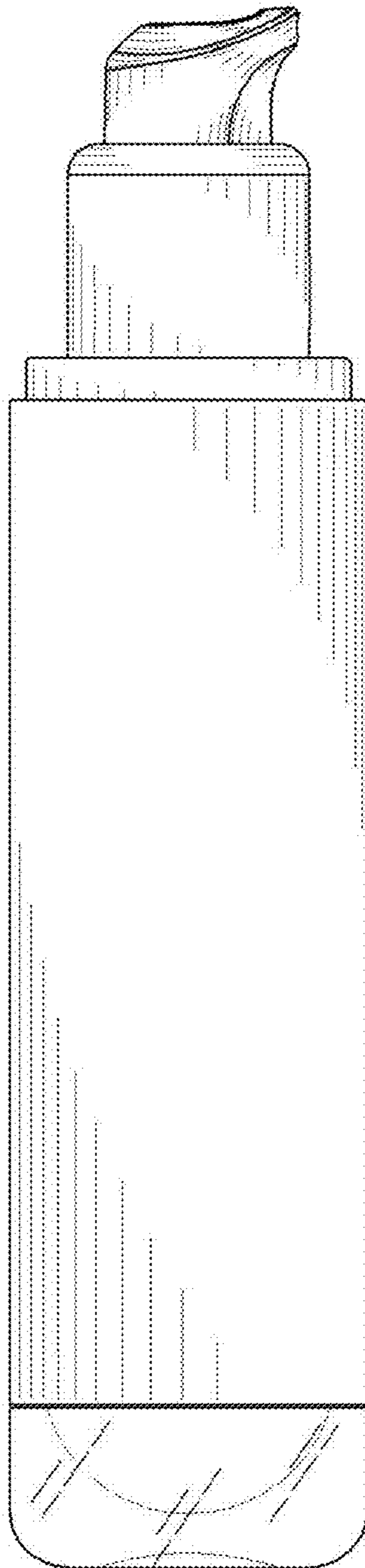

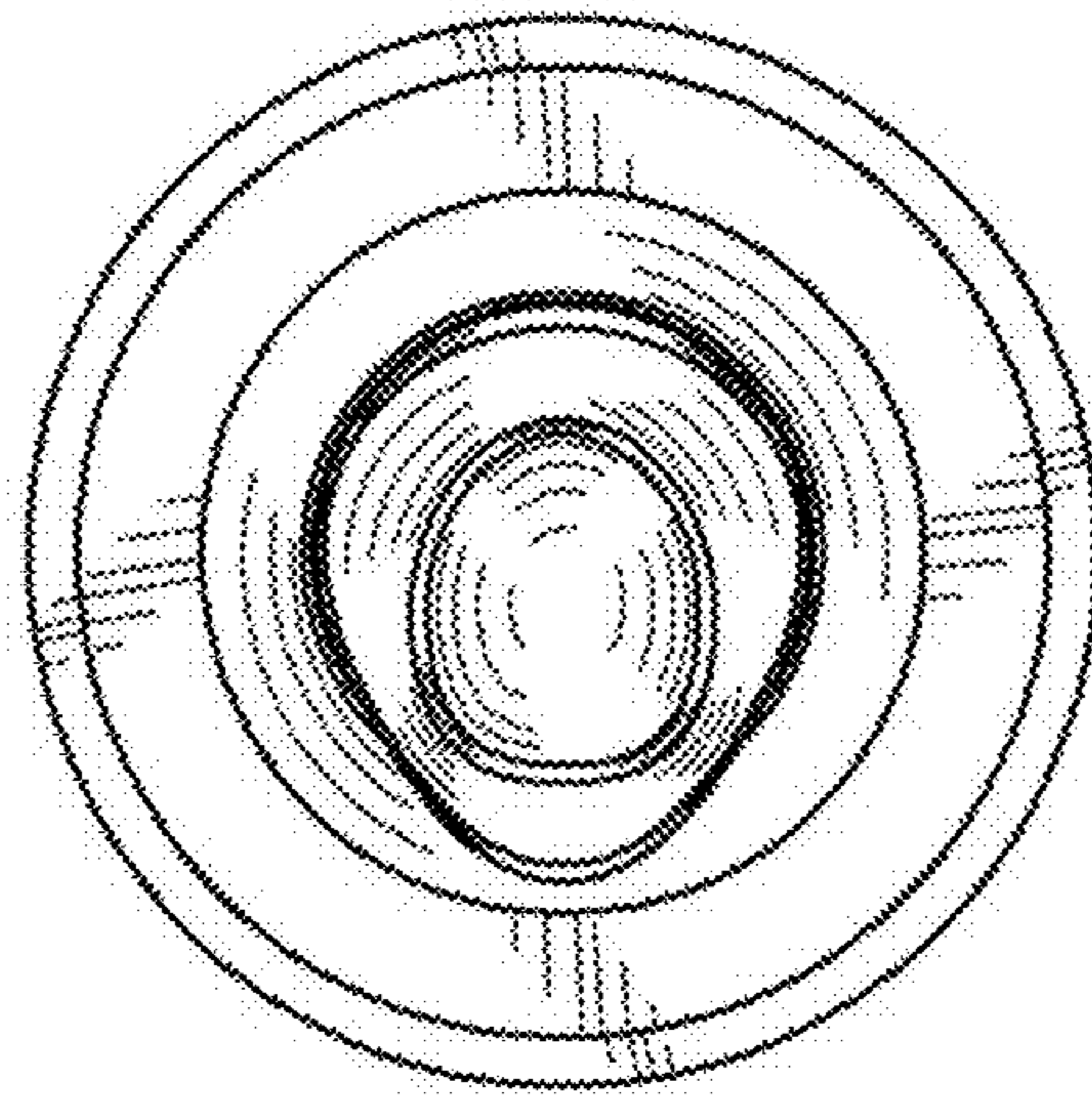

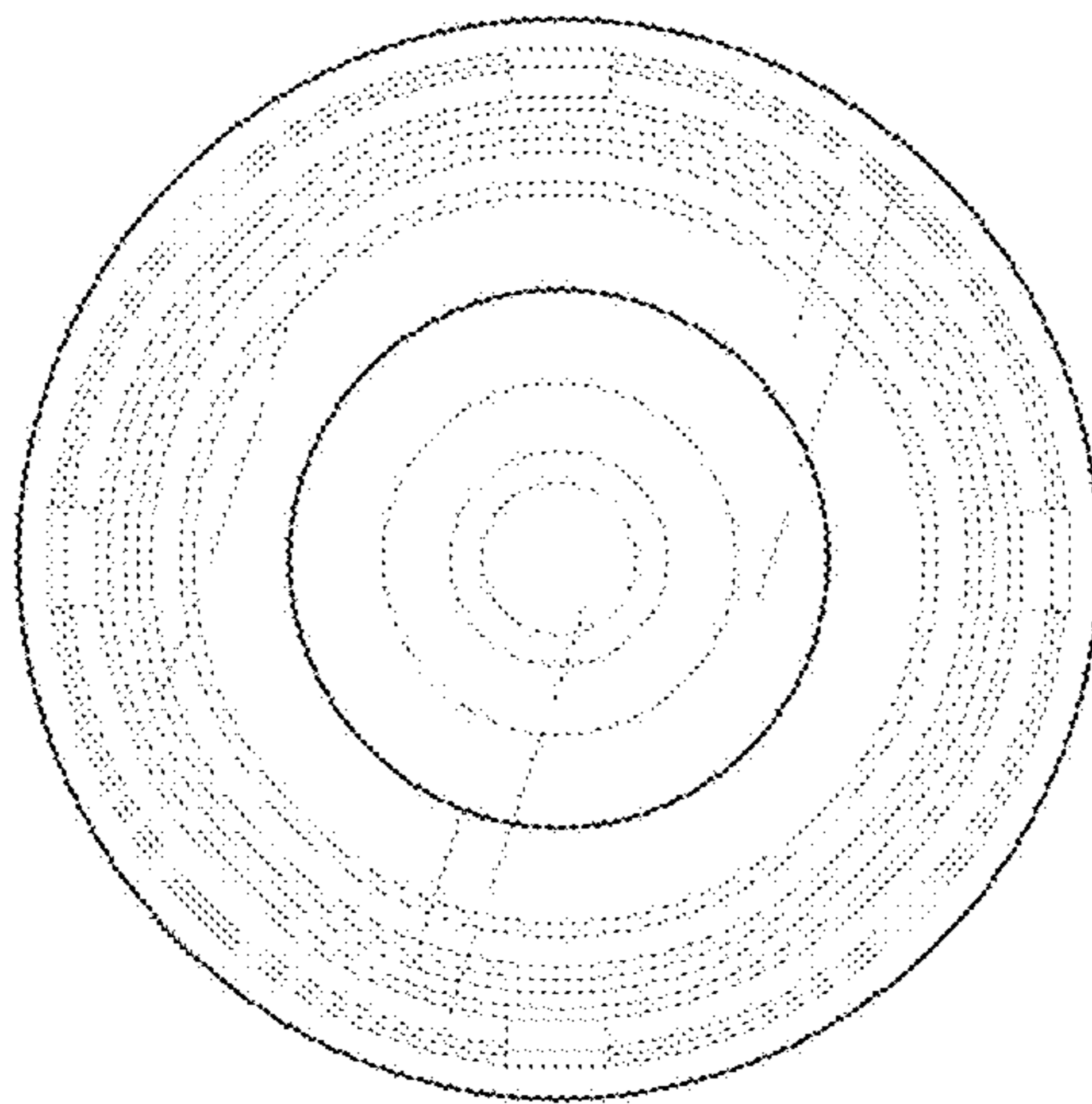
