FIG. 4 is a left-side view thereof.

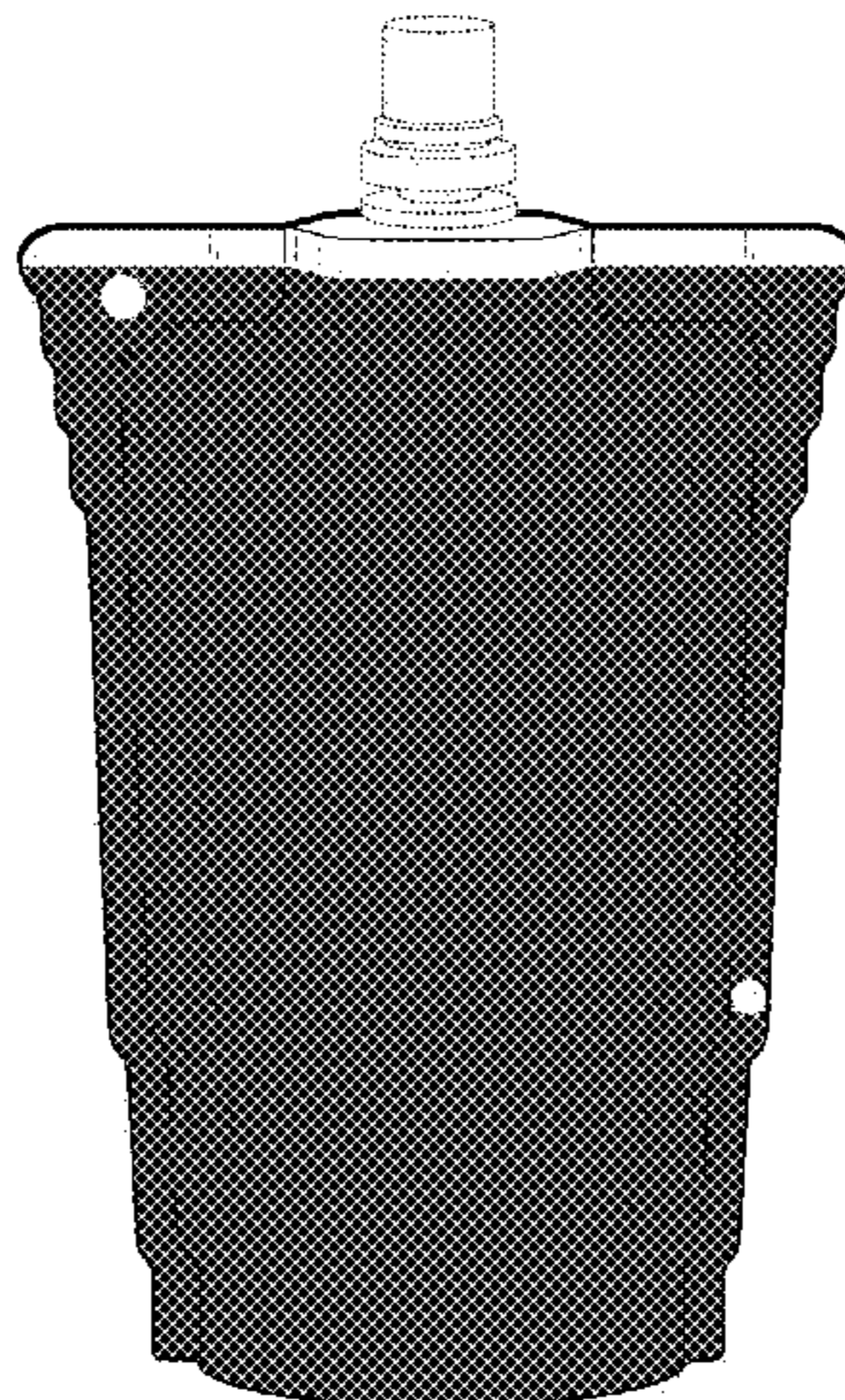
FIG. 5 is a rear view thereof.

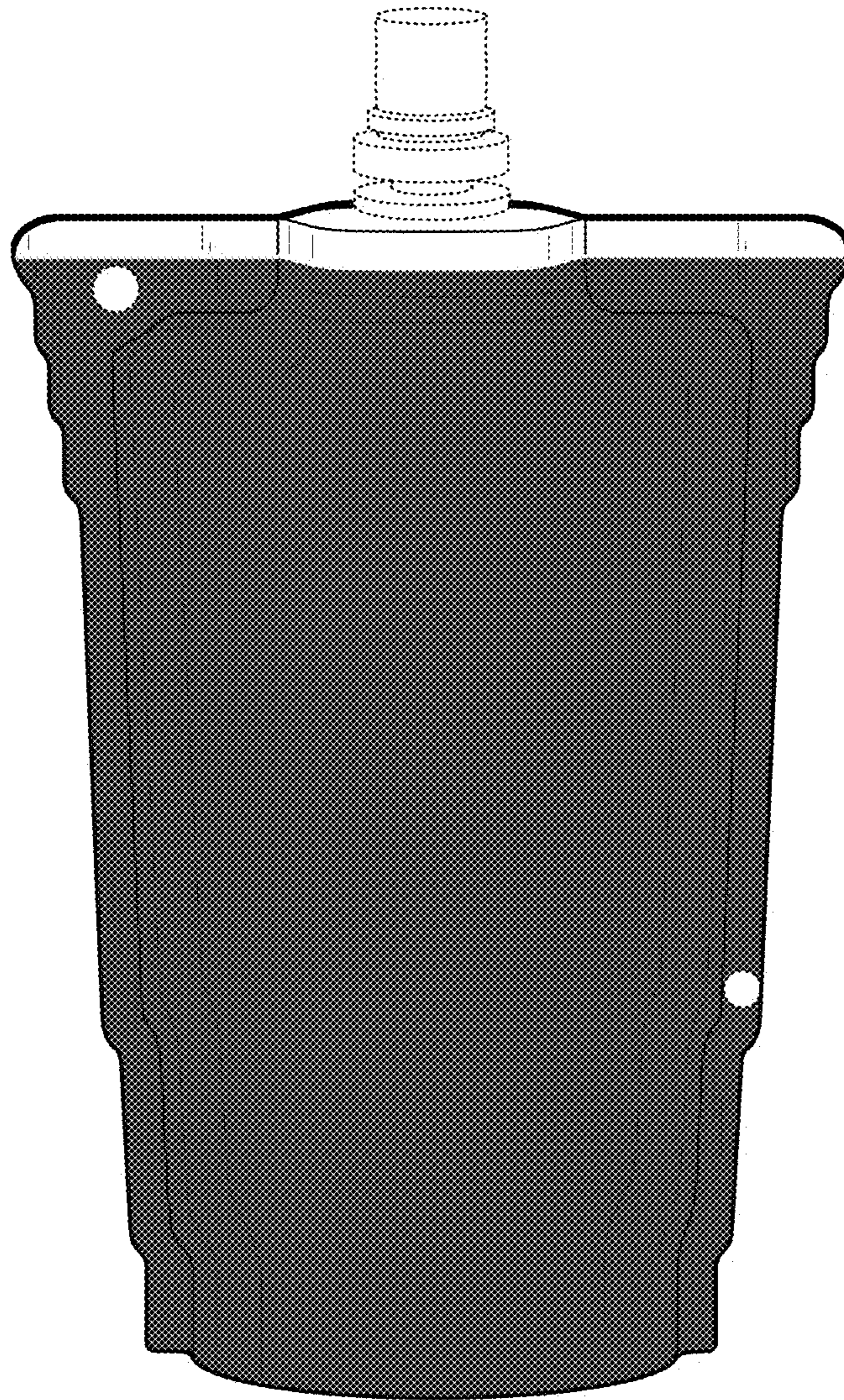

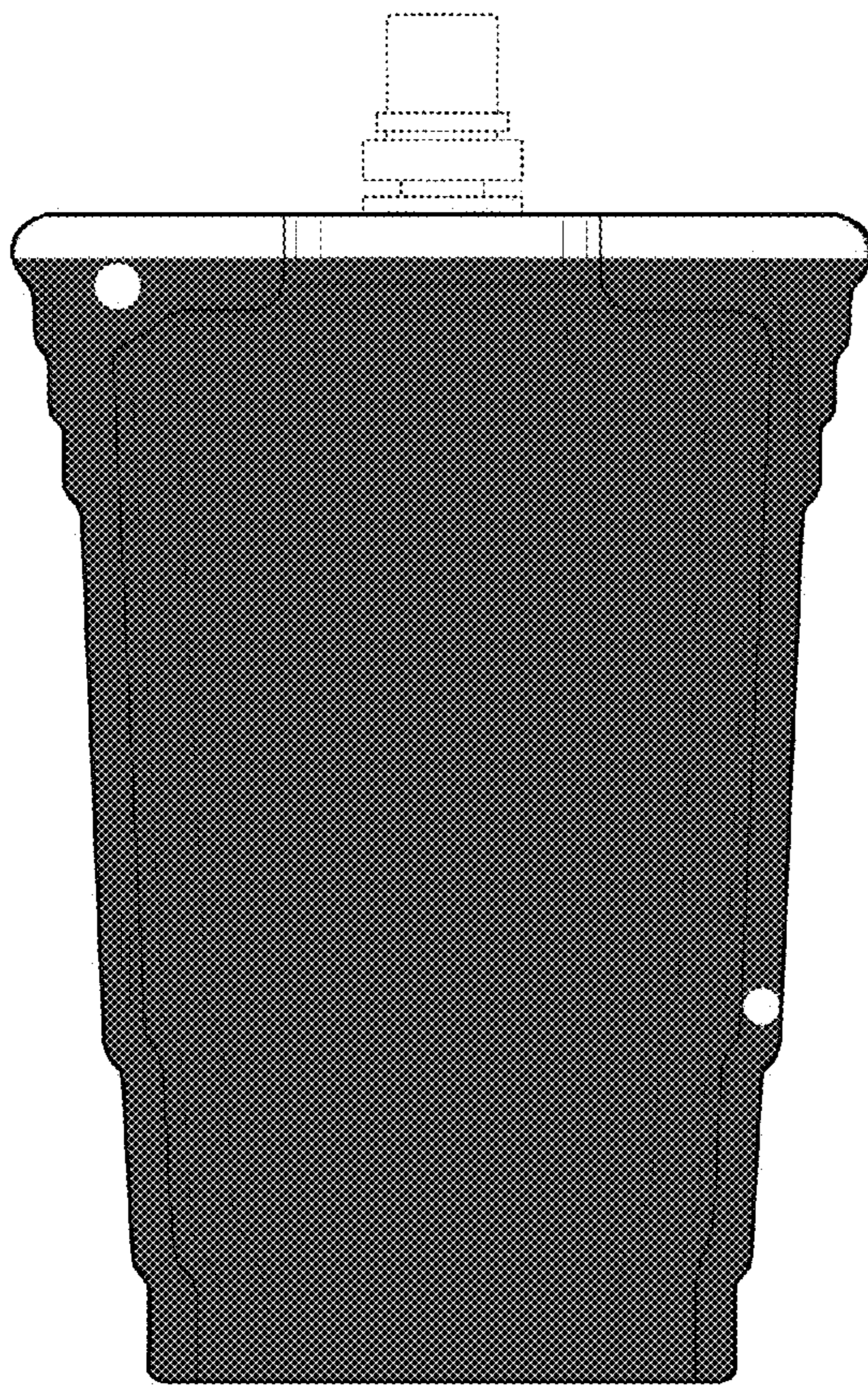

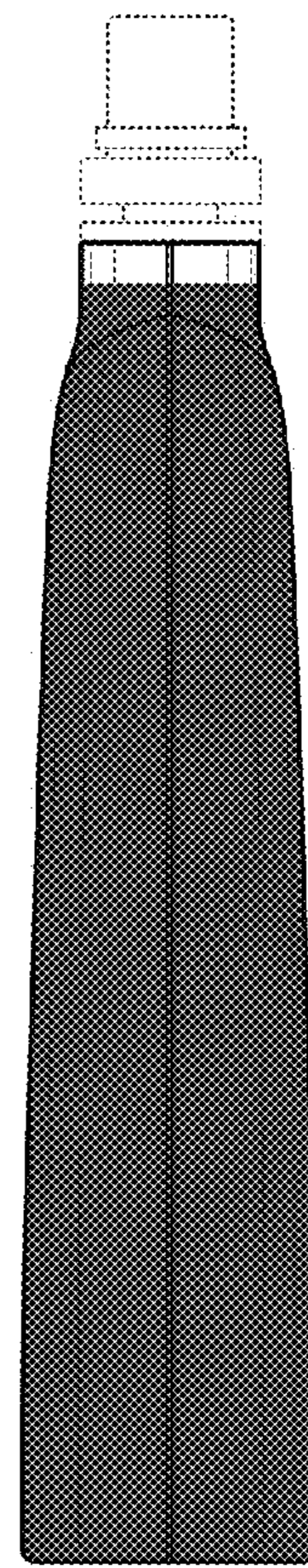

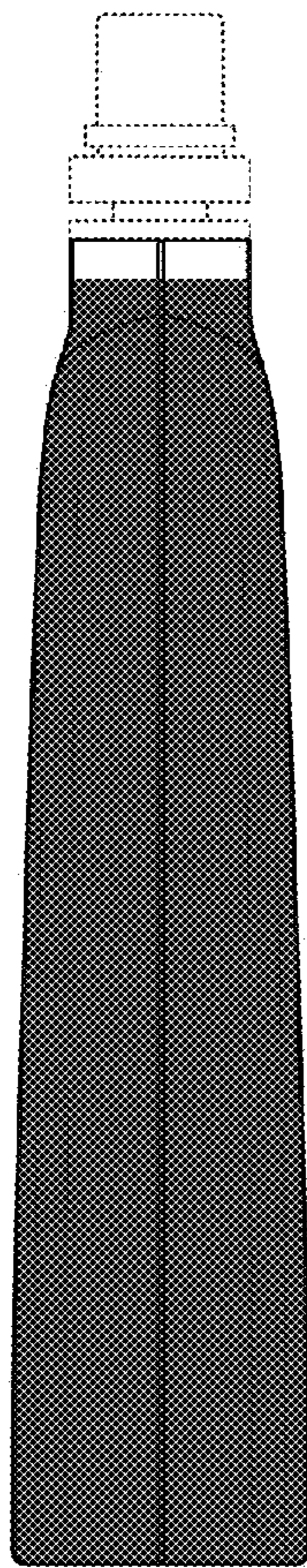

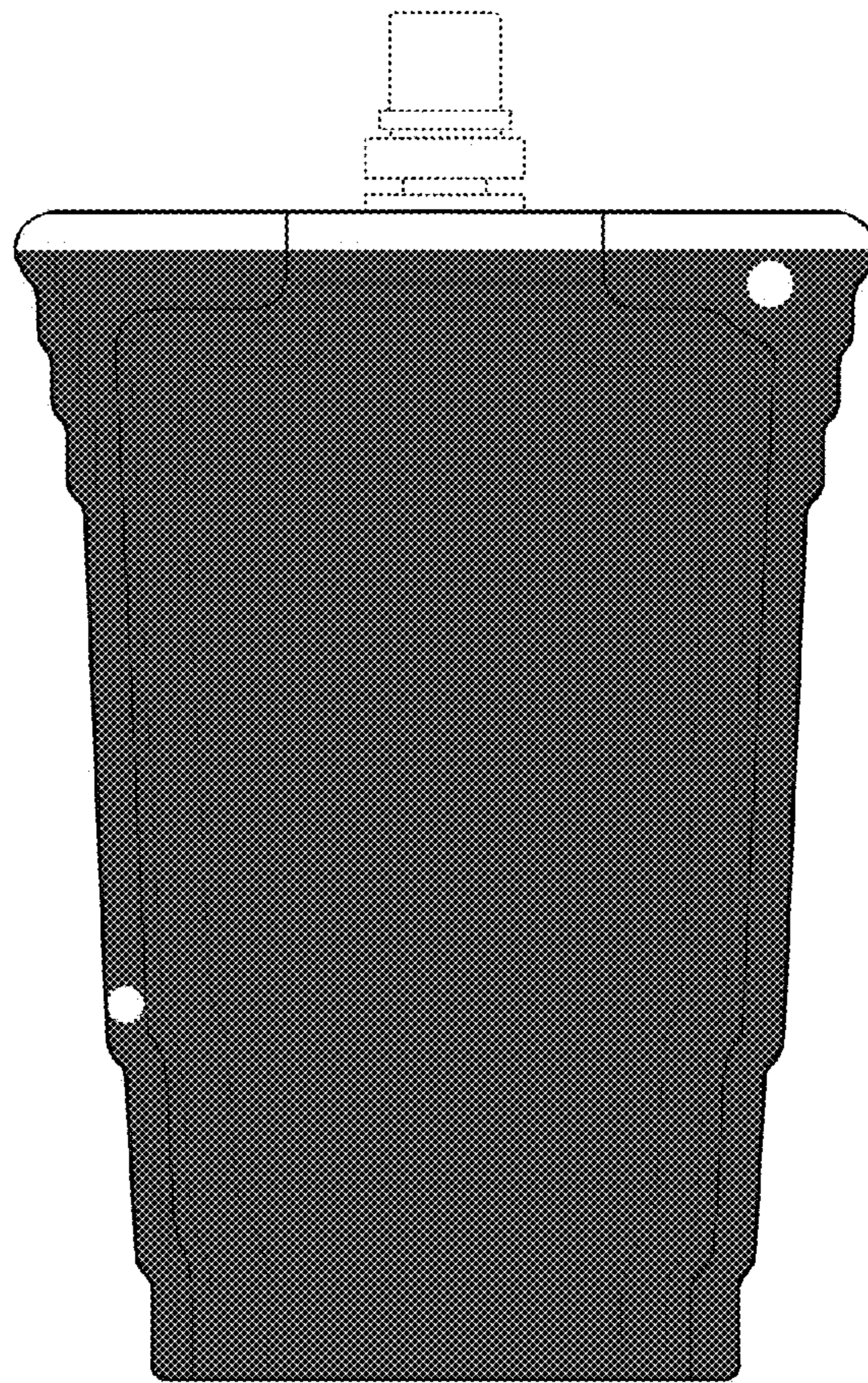

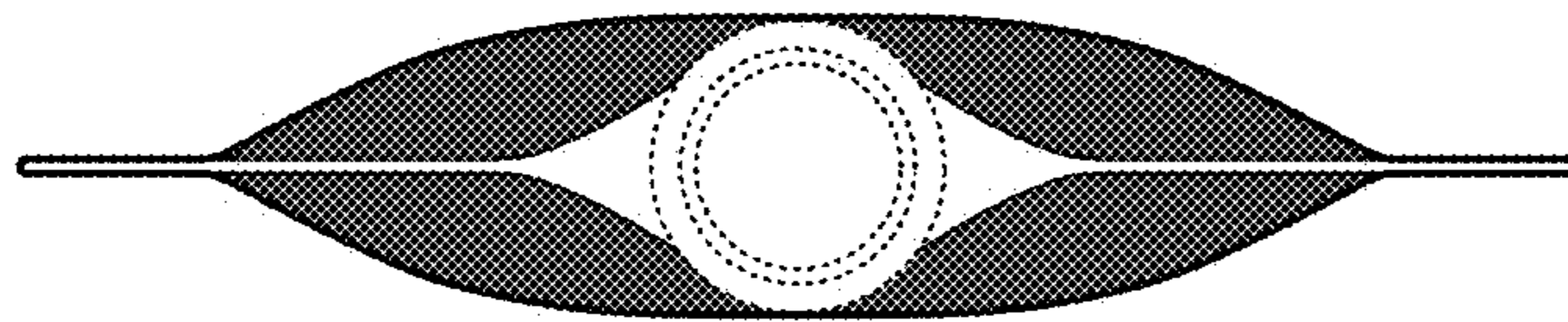

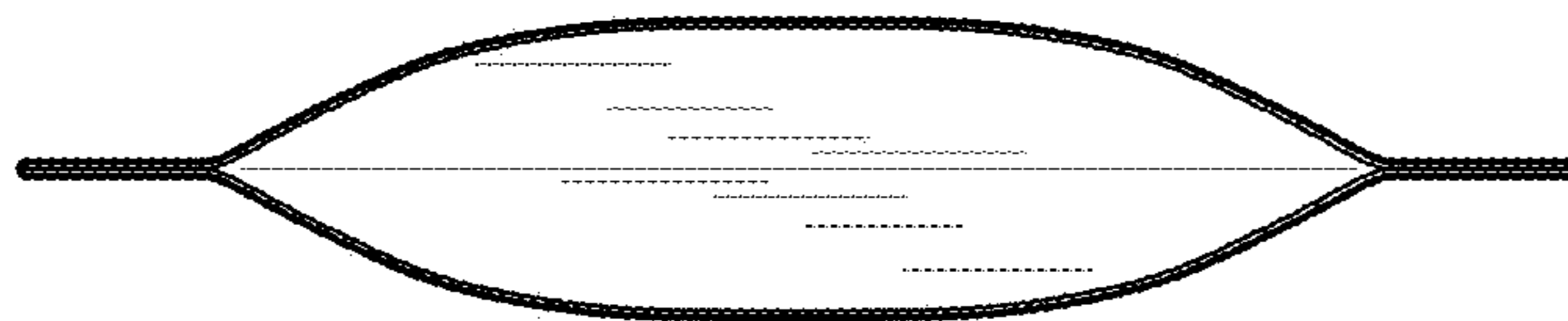
