**DESCRIPTION**

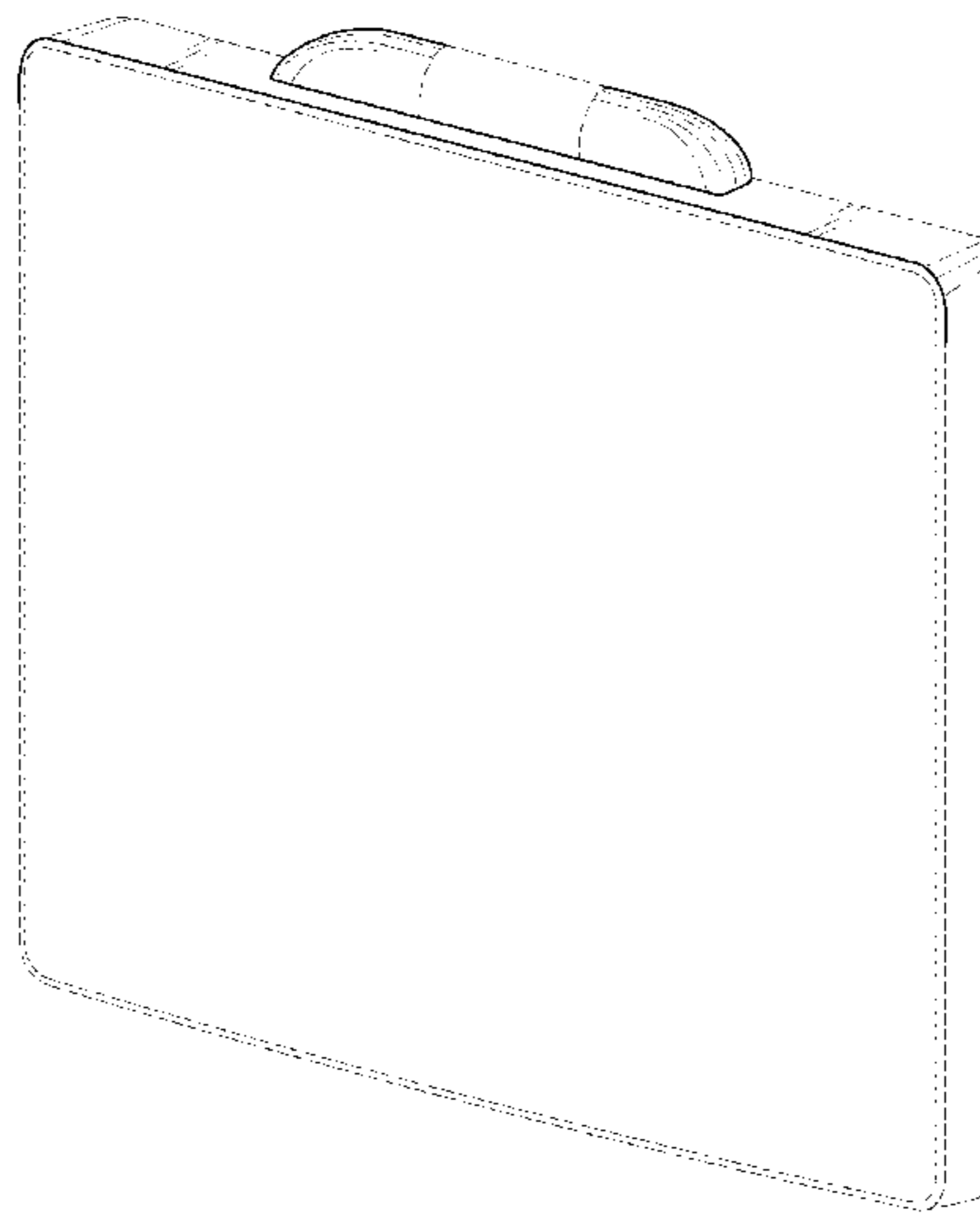
FIG. 1 is a perspective view of an embodiment of a status light bar on a monitor;  
FIG. 2 is a front view of the design of FIG. 1;  
FIG. 3 is a rear view of the design of FIG. 1;  
FIG. 4 is a left side view of the design of FIG. 1, the right side view being a mirror image of the left side view;  
FIG. 5 is a top view of the design of FIG. 1; and,  
FIG. 6 is a bottom view of the design of FIG. 1 in which no features of the claimed design are depicted.  
The broken lines in the figures depict unclaimed environmental subject matter and do not form a part of the claimed design. The shade lines in the figures show contour, not surface ornamentation

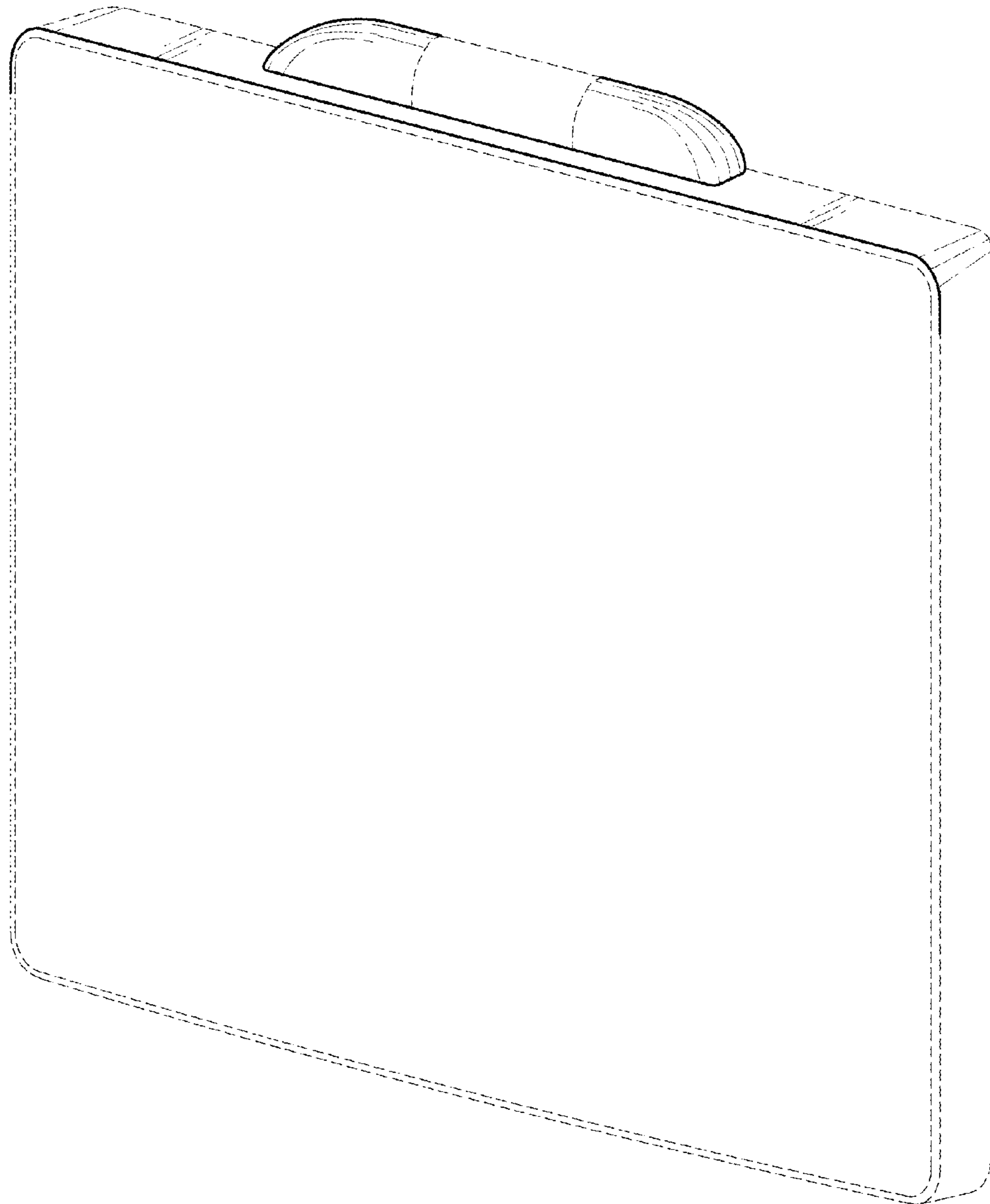

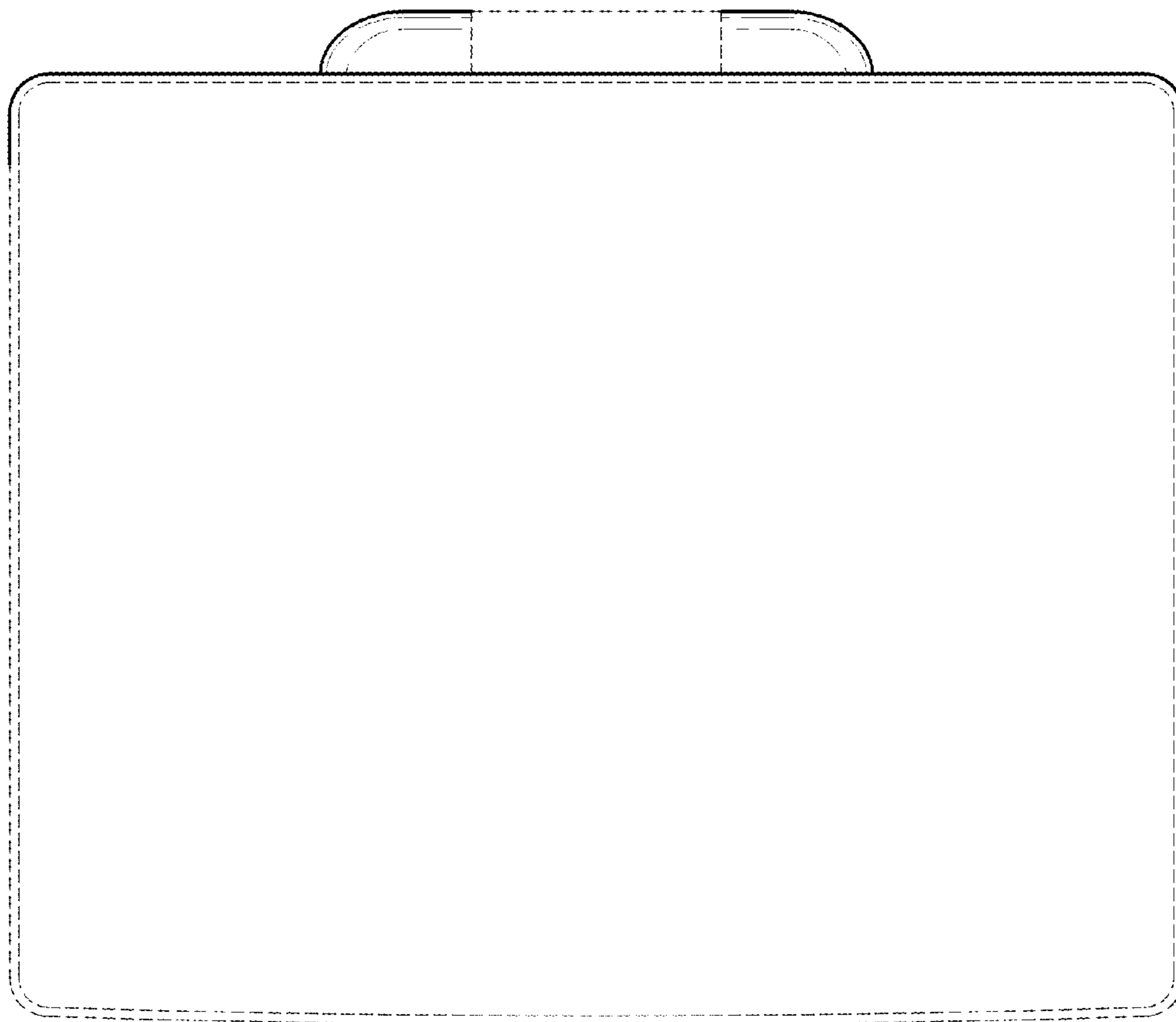

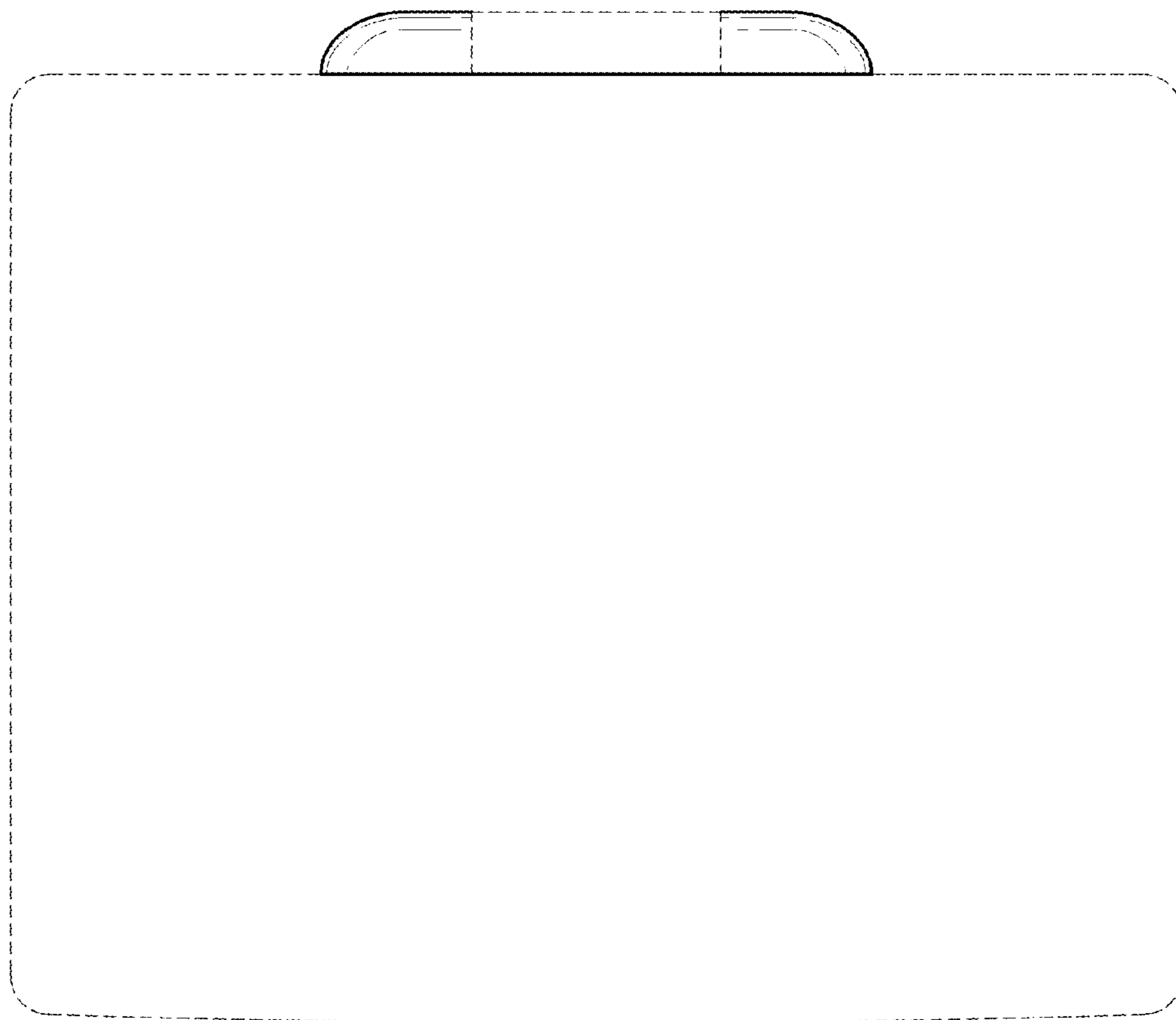

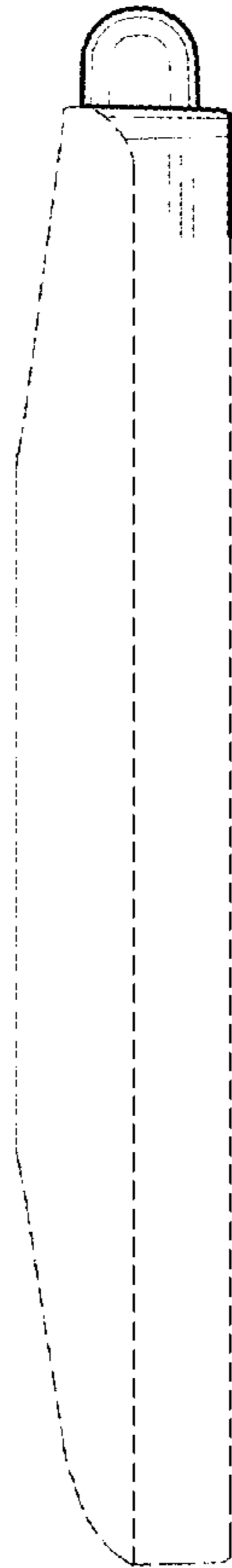

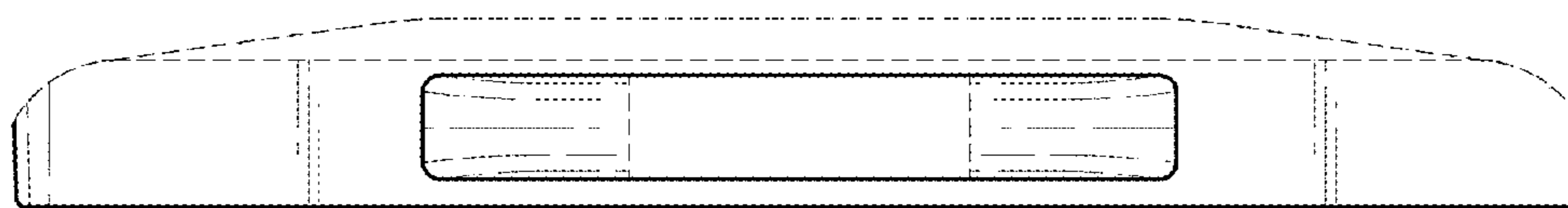
