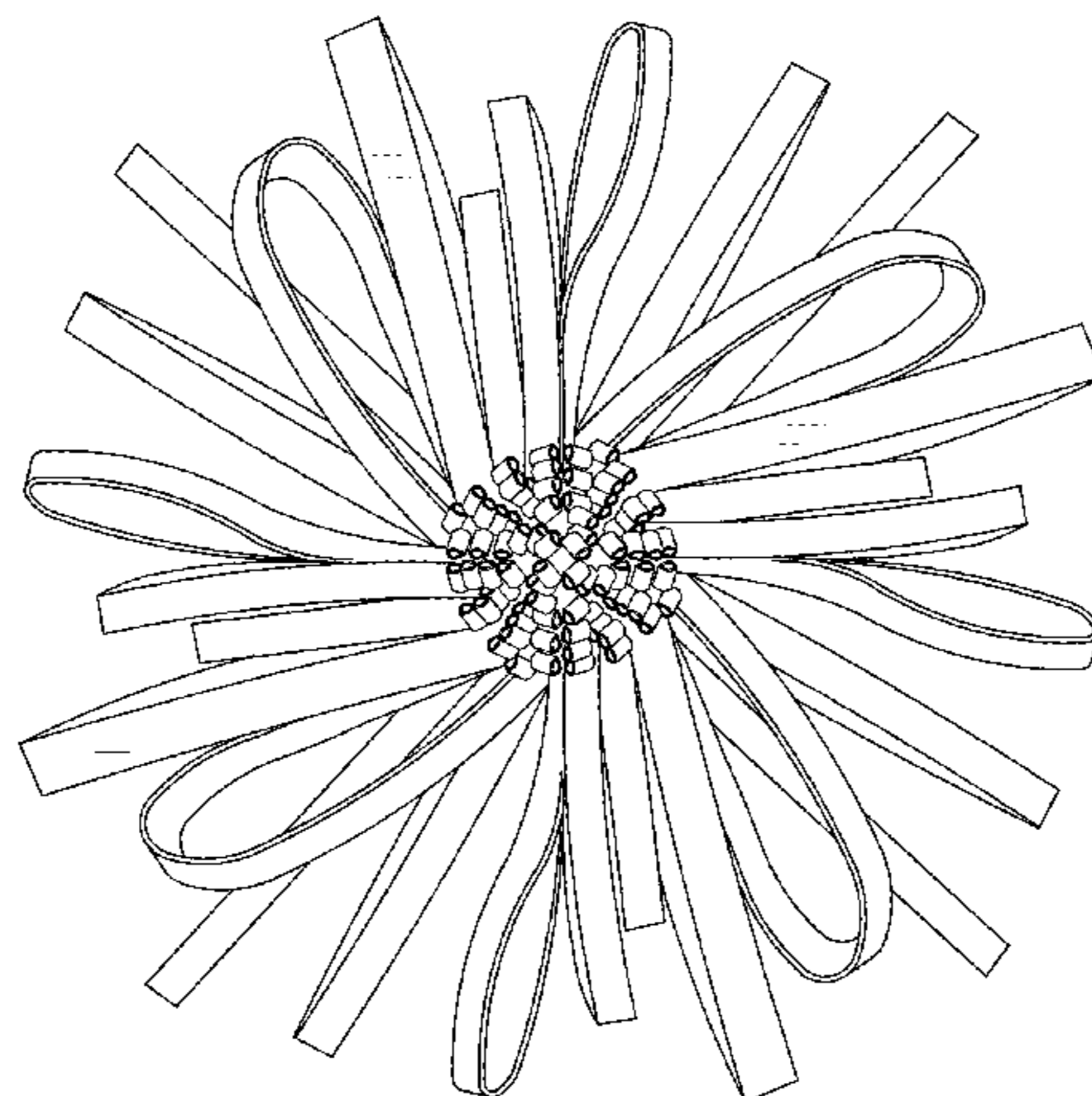
(57) **CLAIM**

The ornamental design for an adhesive gift wrap bow sticker, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an adhesive gift wrap bow sticker showing my new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a right side elevation thereof, the bottom view being the same; the left view and top view are each mirror images thereof; and,
FIG. 4 is an isometric view thereof.
The broken lines in FIG. 4 of the drawings depict a gift box as environmental subject matter only and form no part of the claimed design.

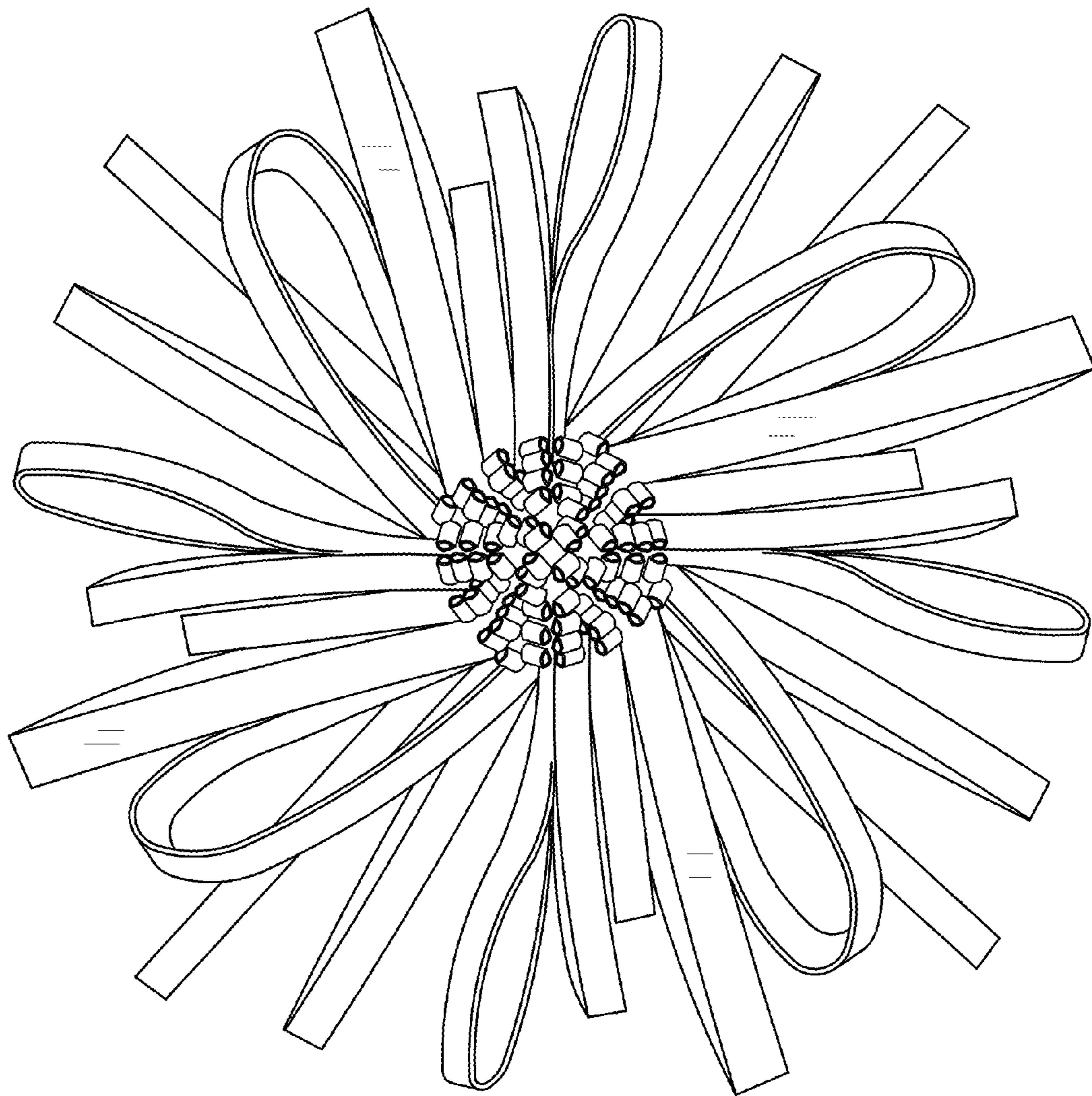

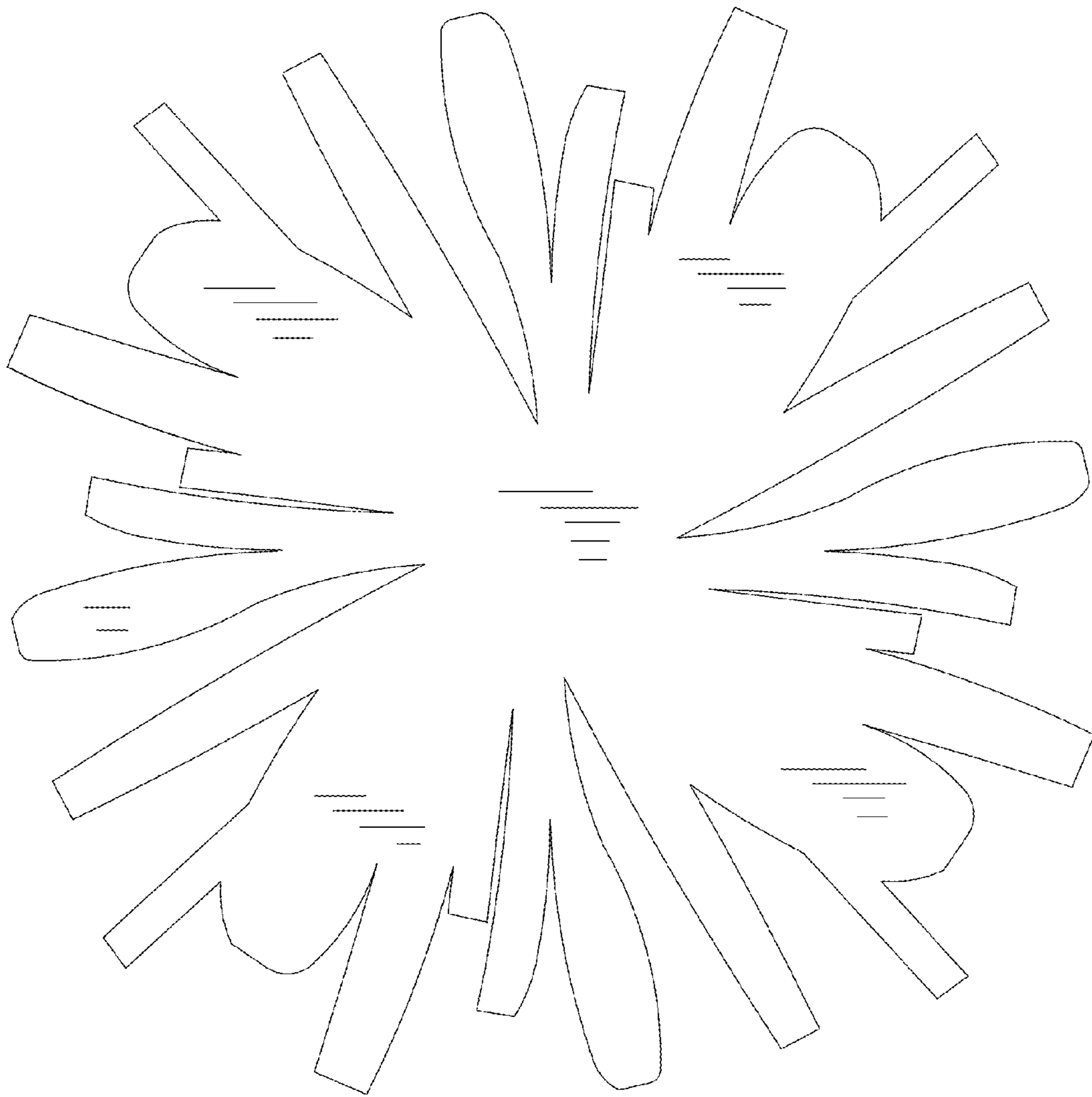

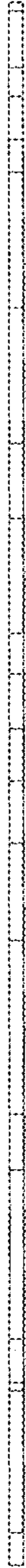

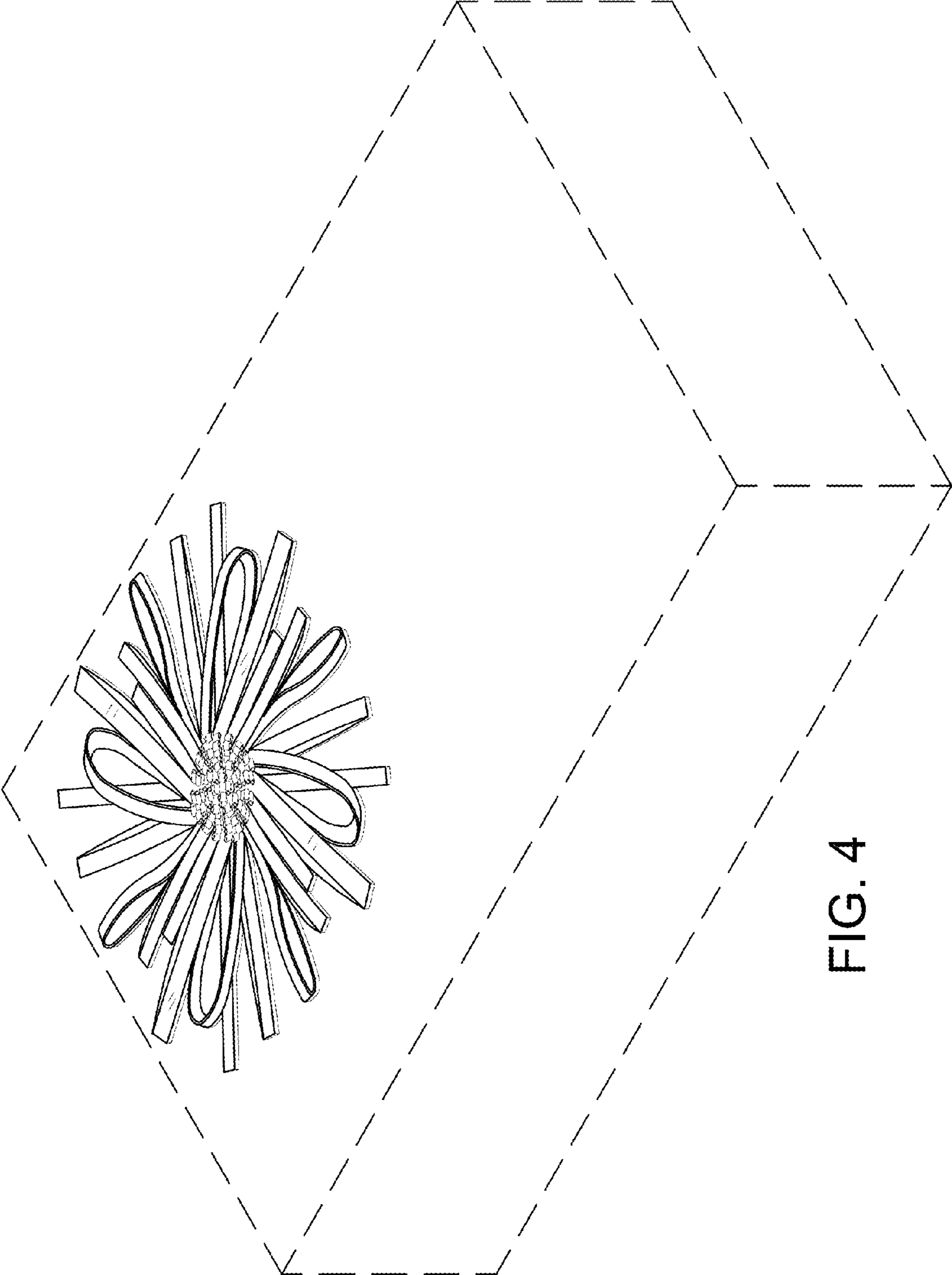
