**DESCRIPTION**

FIG. 1 is a front perspective view of a router and switch bracket;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

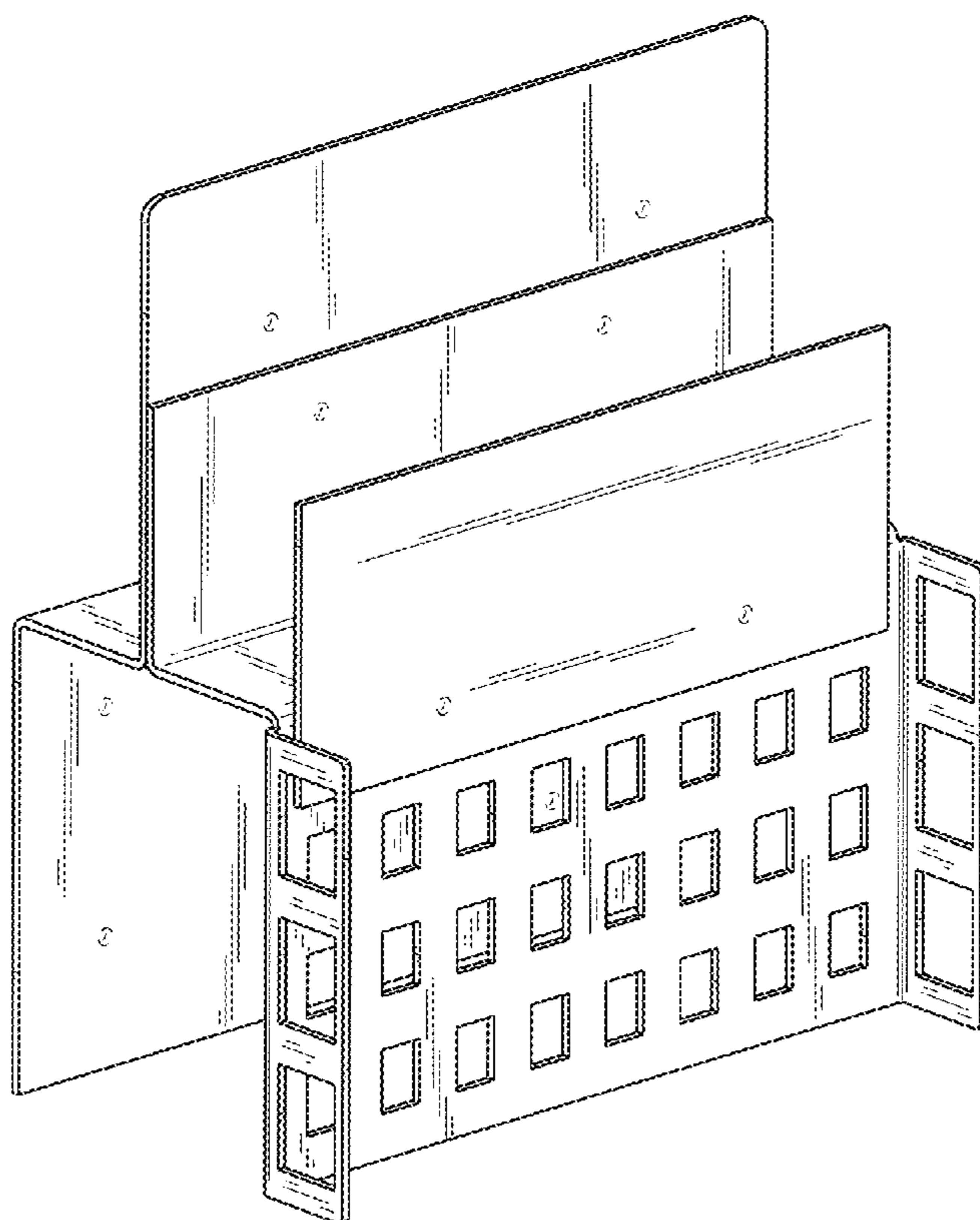
FIG. 4 is a left side elevation view thereof, the right side elevation view being a mirror image thereof.

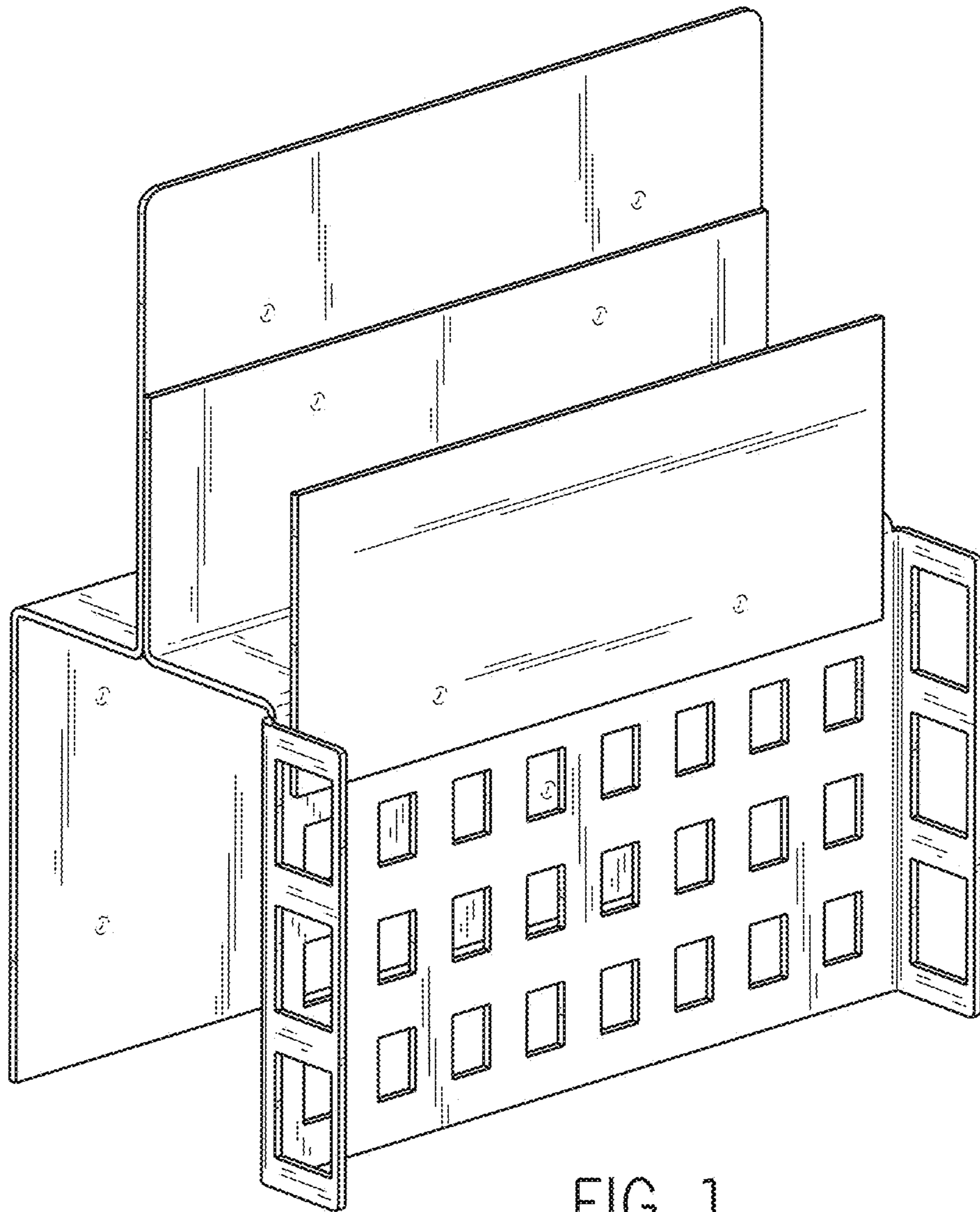

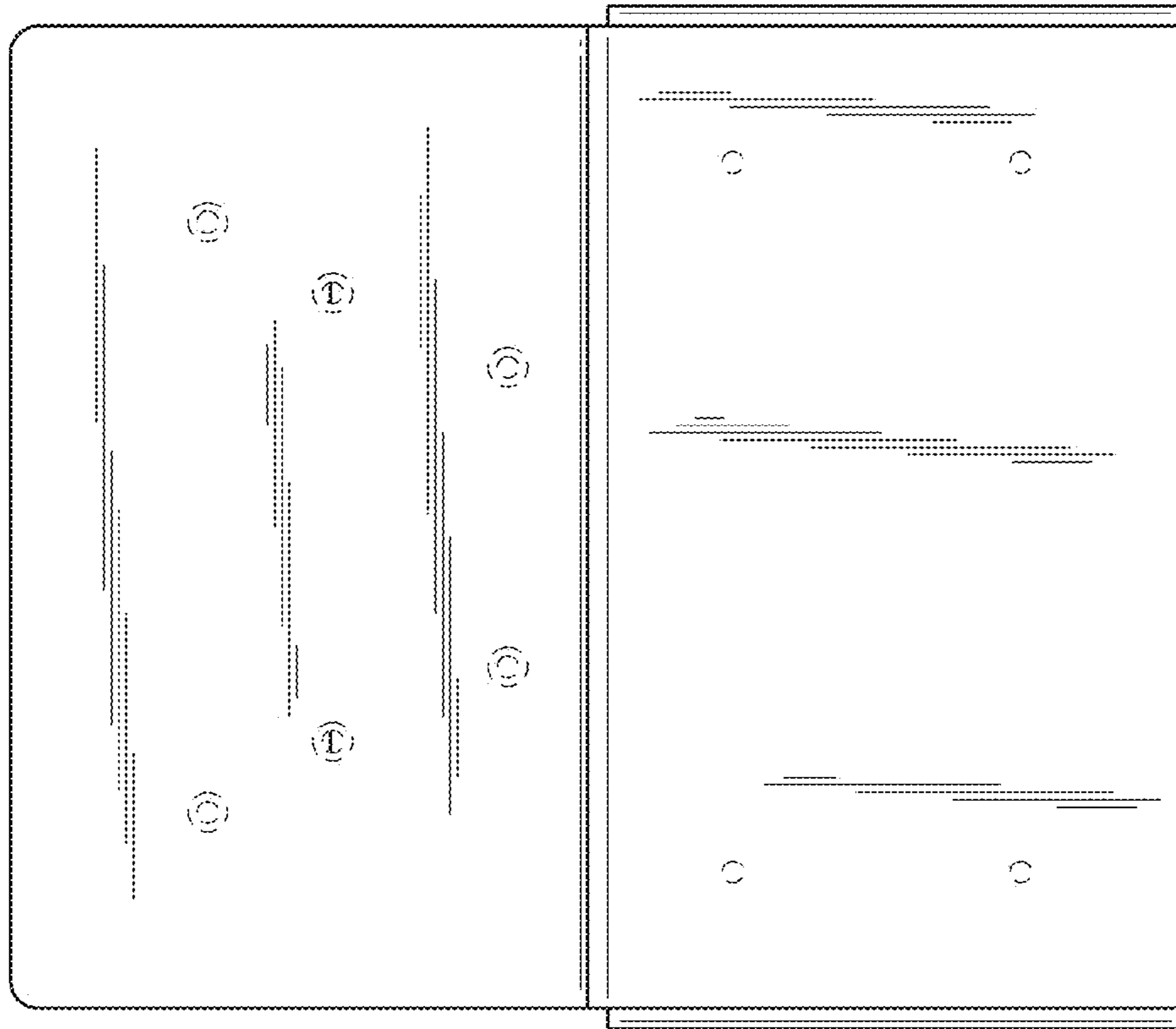

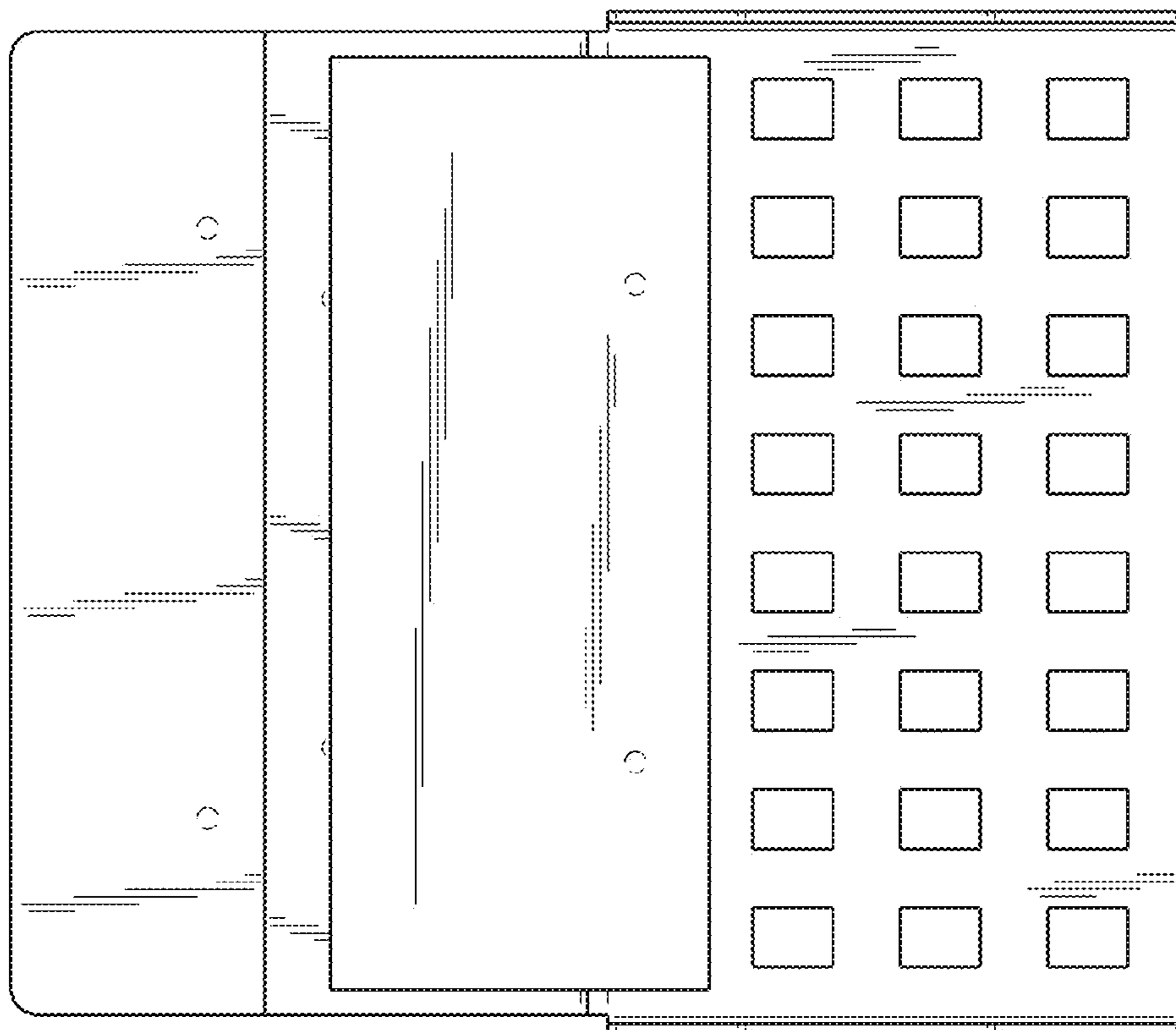

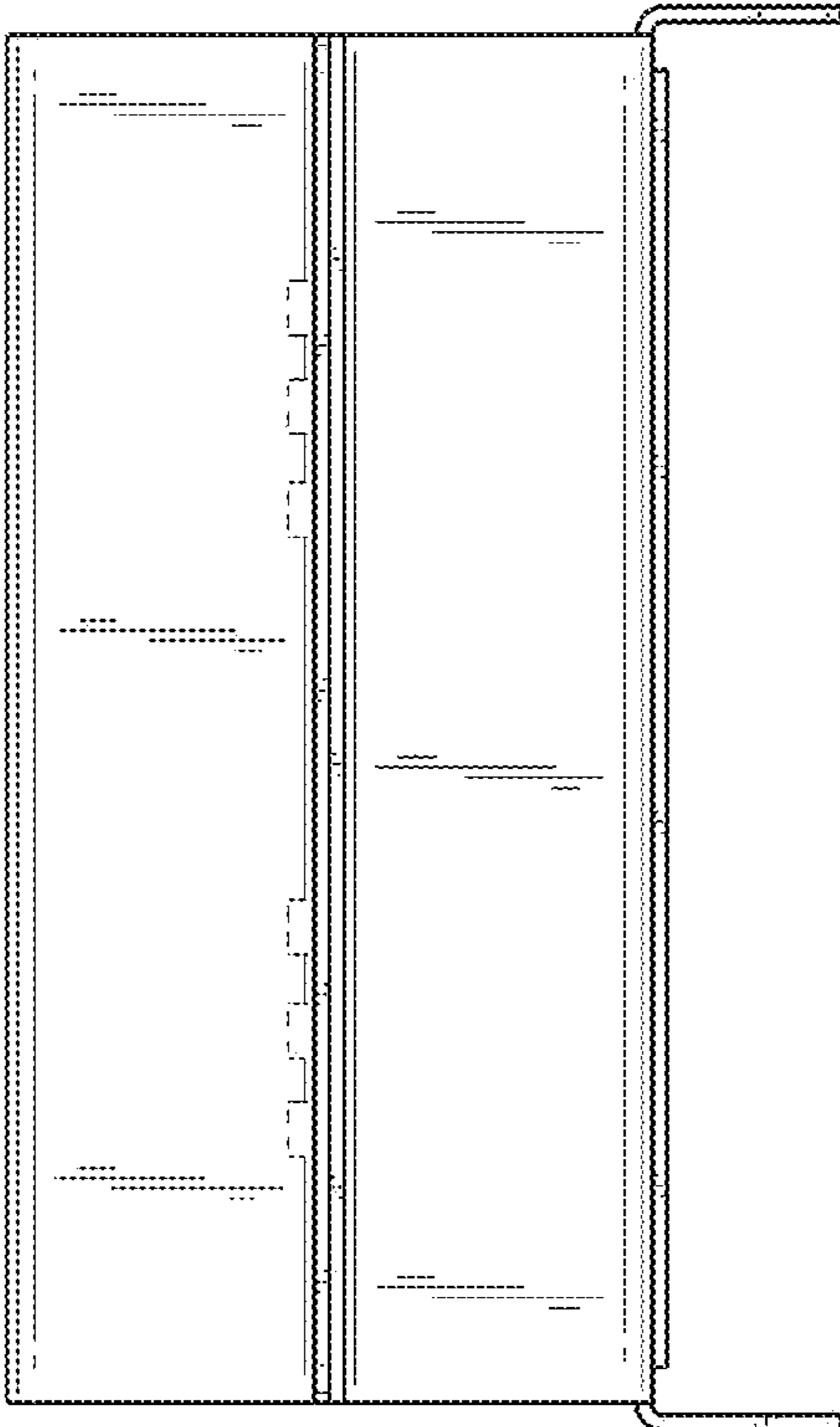

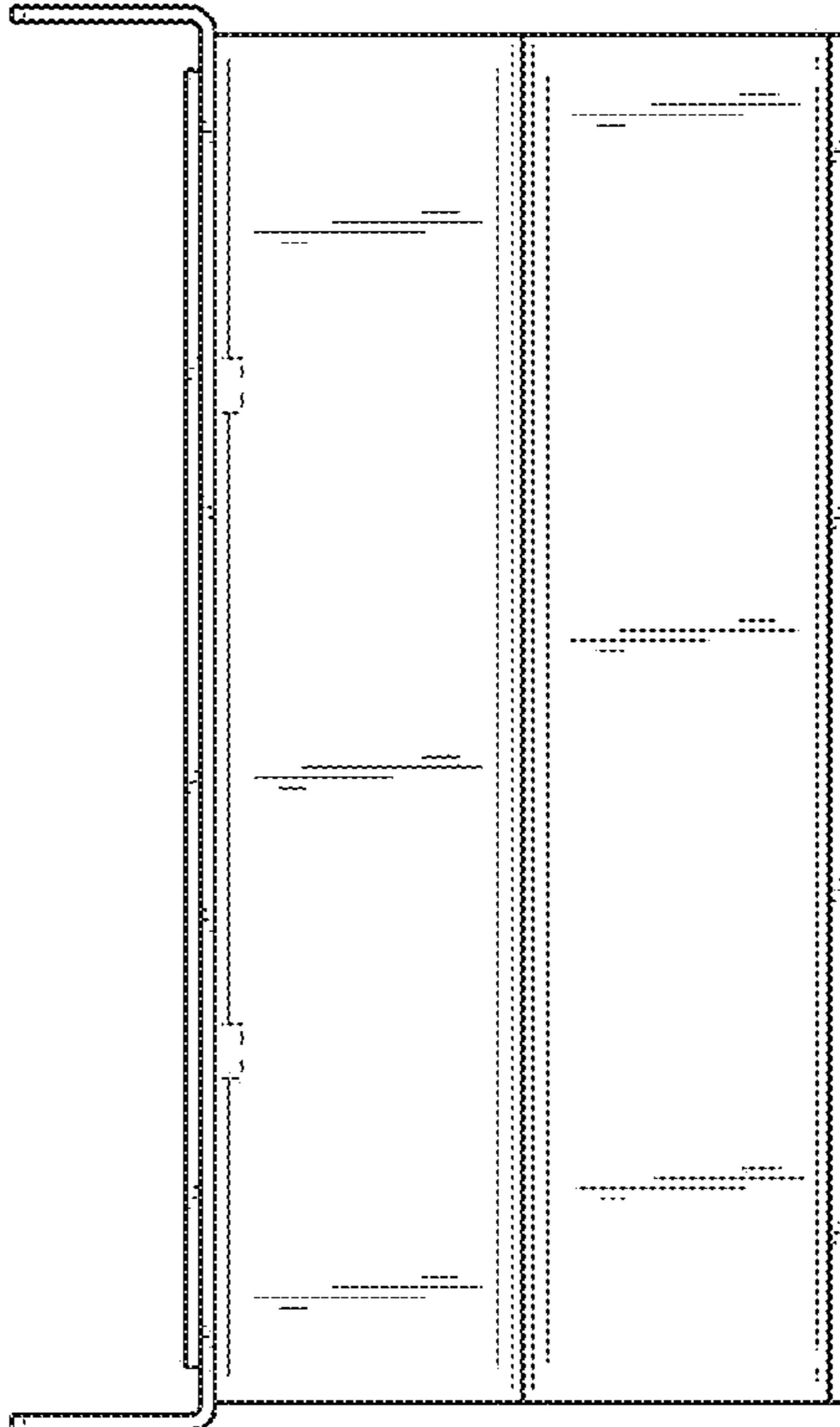

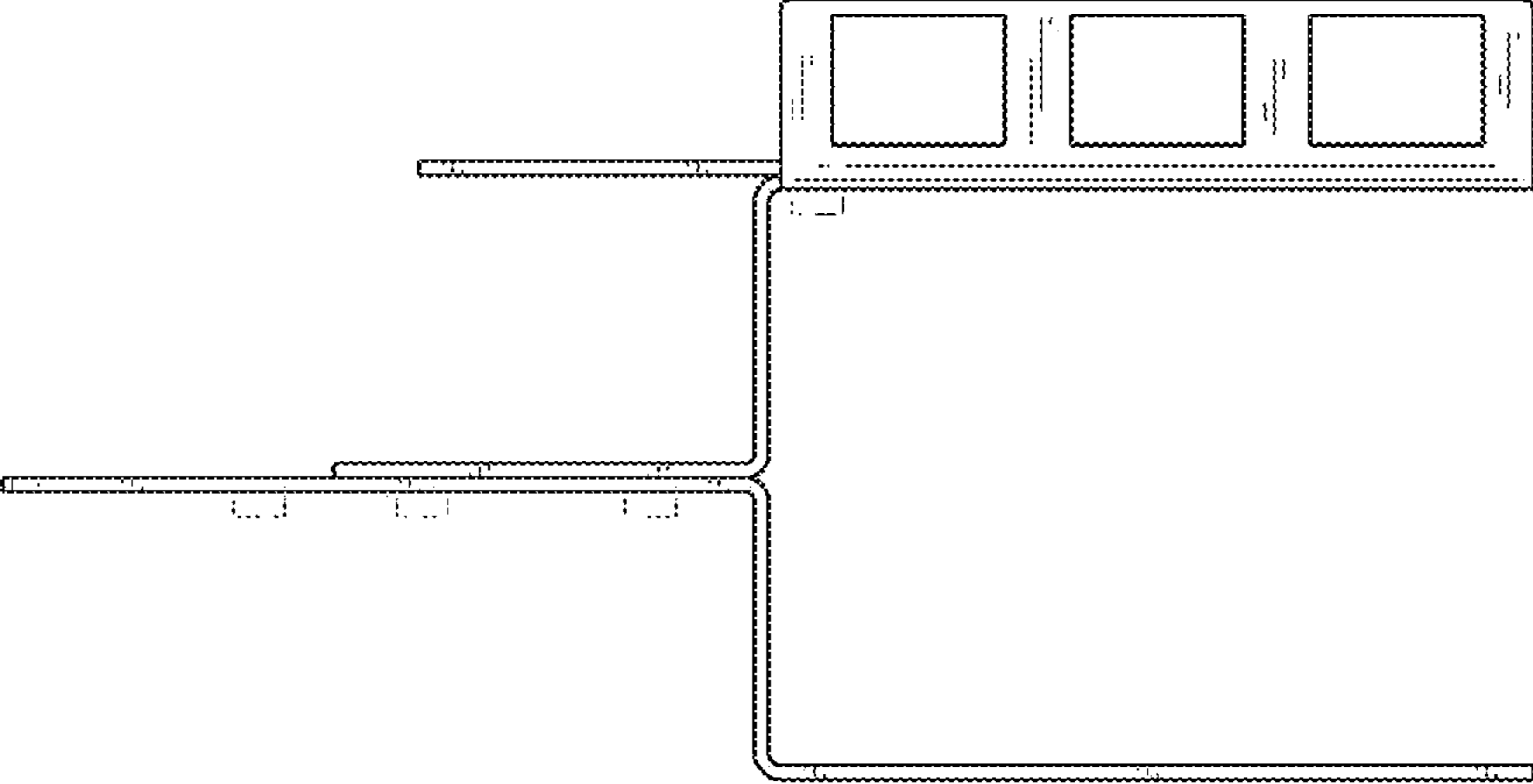
