(57) **CLAIM**

The ornamental design for a speaker with lighting, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a speaker with lighting showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is a right view thereof; the left view being a mirror image thereto.

The broken lines shown are included for the purpose of illustrating portions of the speaker with lighting that form no part of the claim. The features shown behind the grill of the speaker with lightning are shown in broken lines and these features are disclaimed.

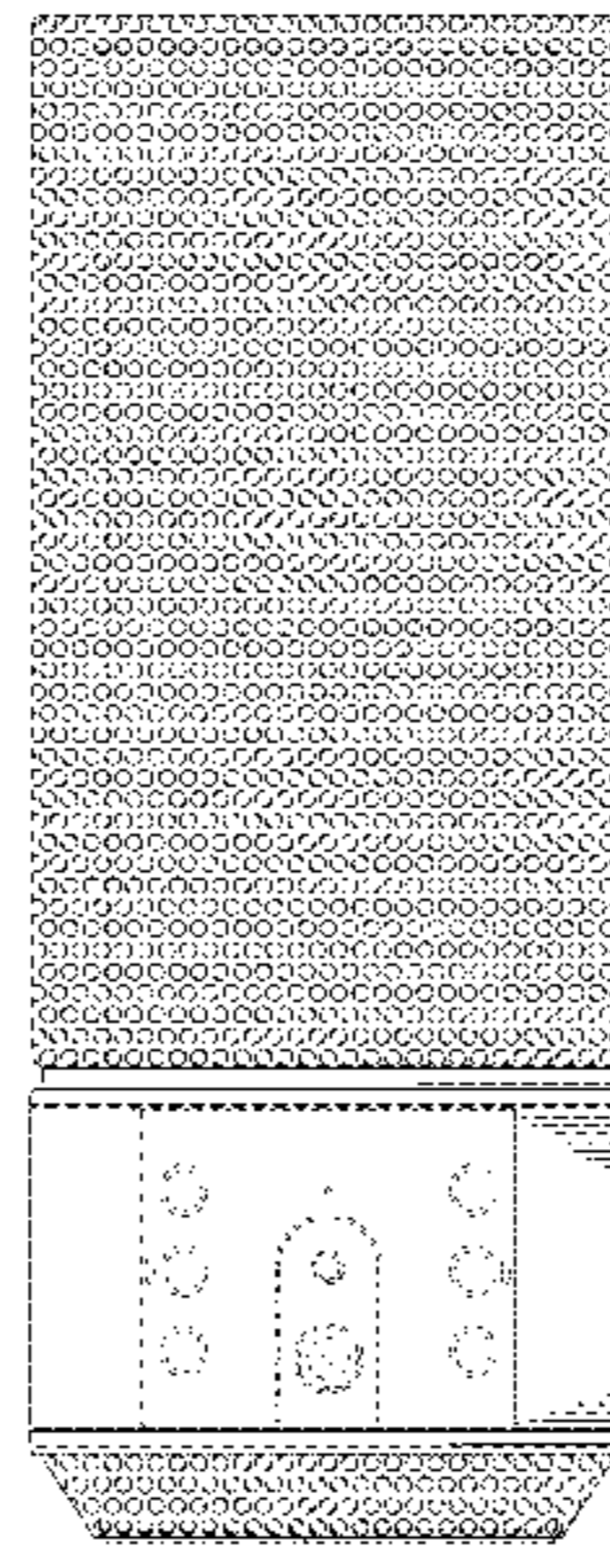
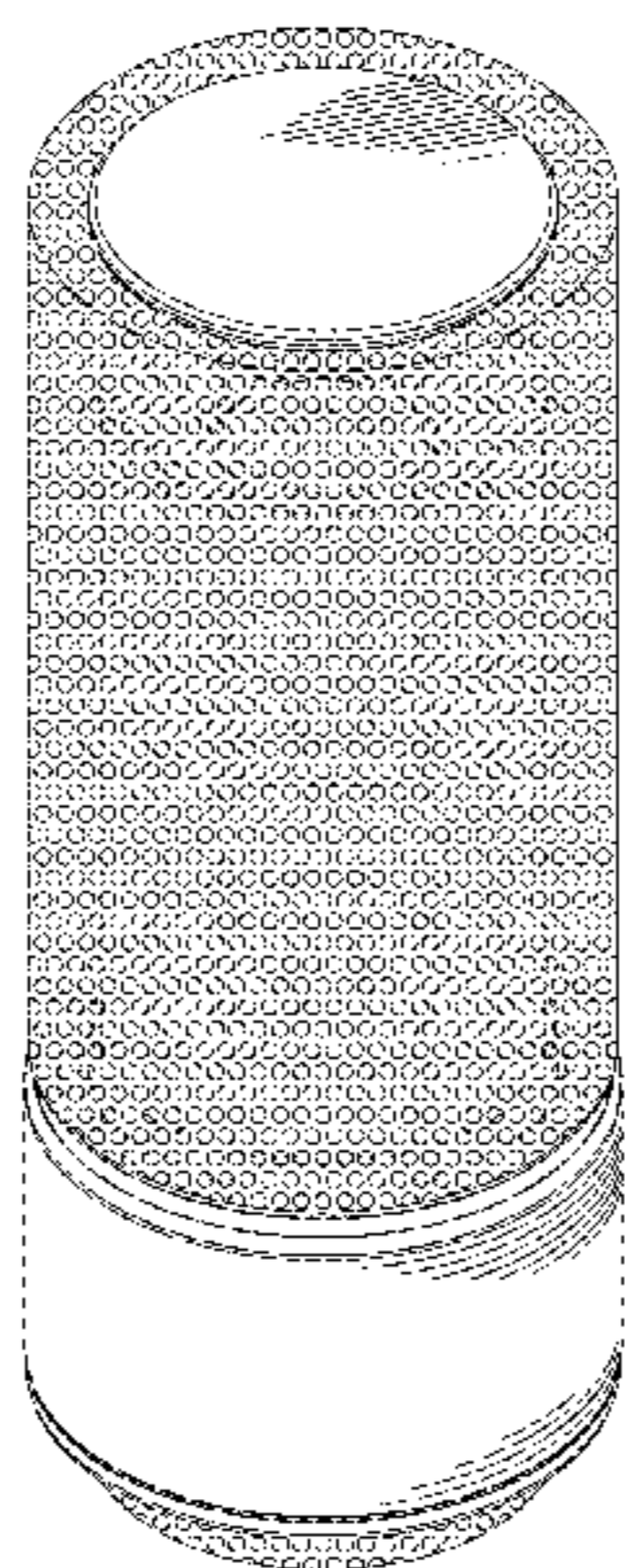

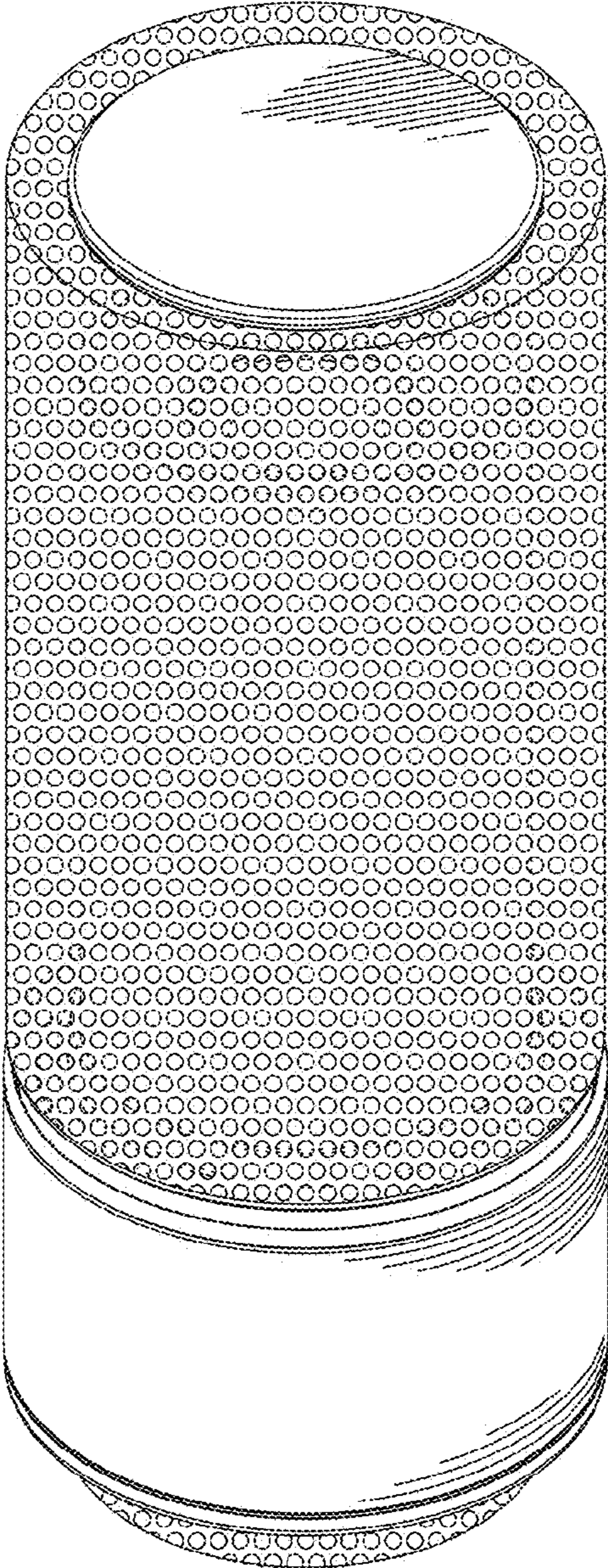

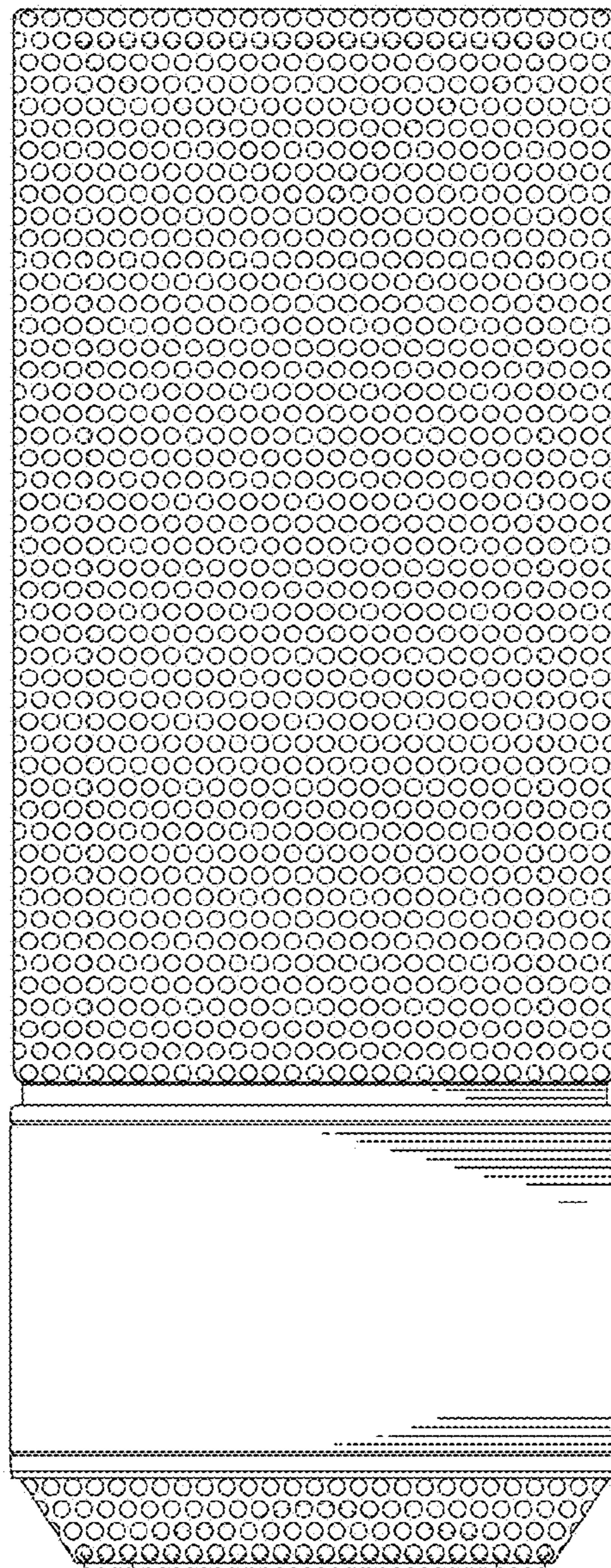

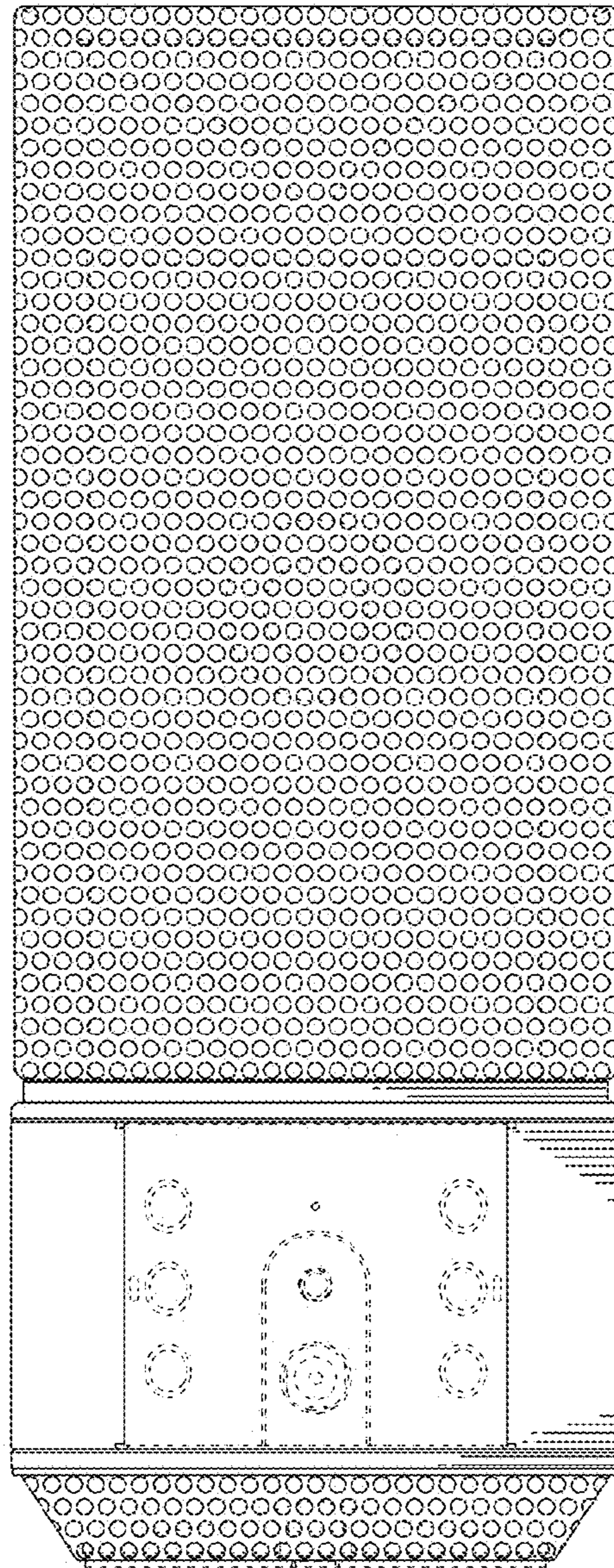

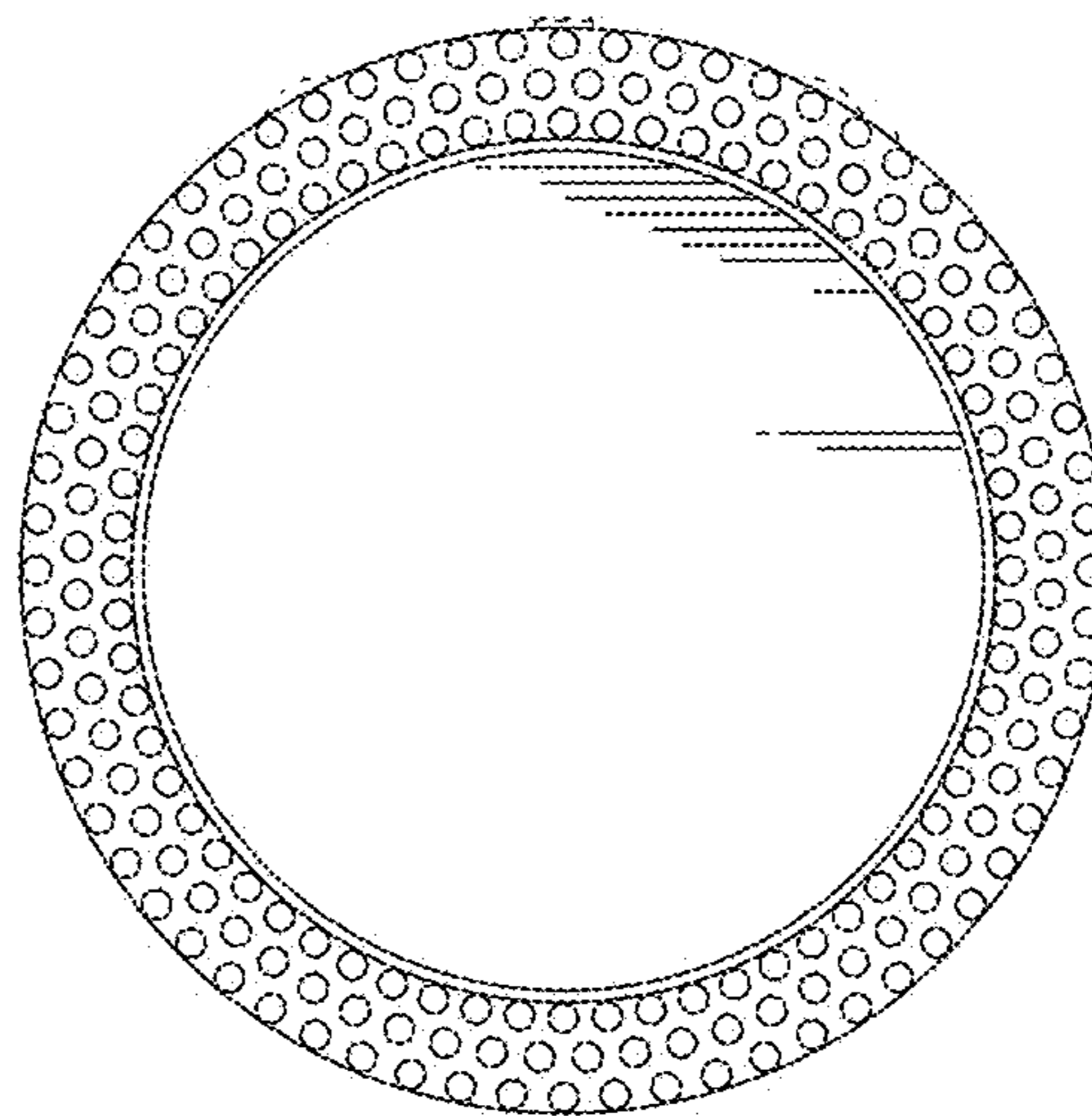

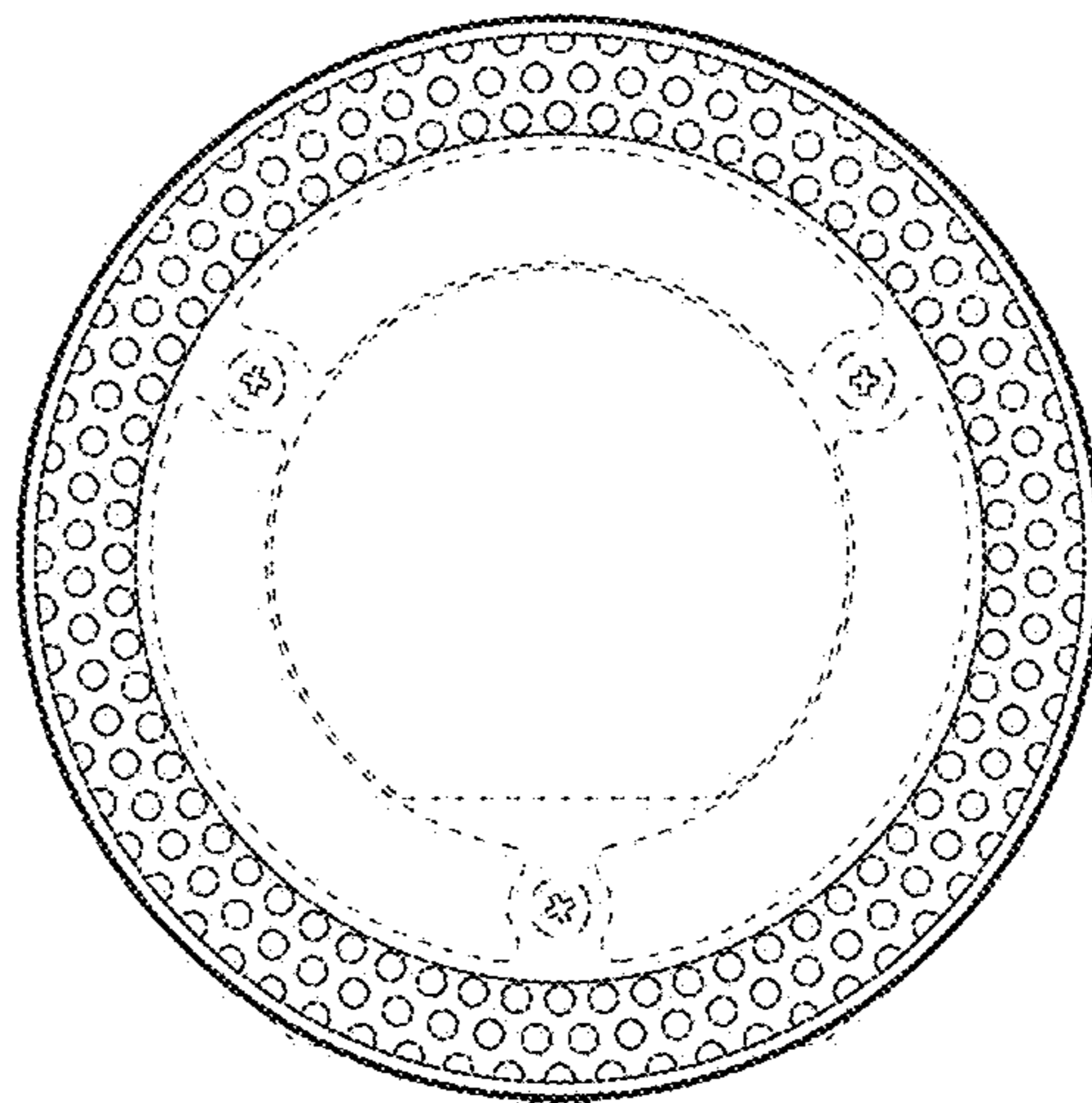
