(57) **CLAIM**

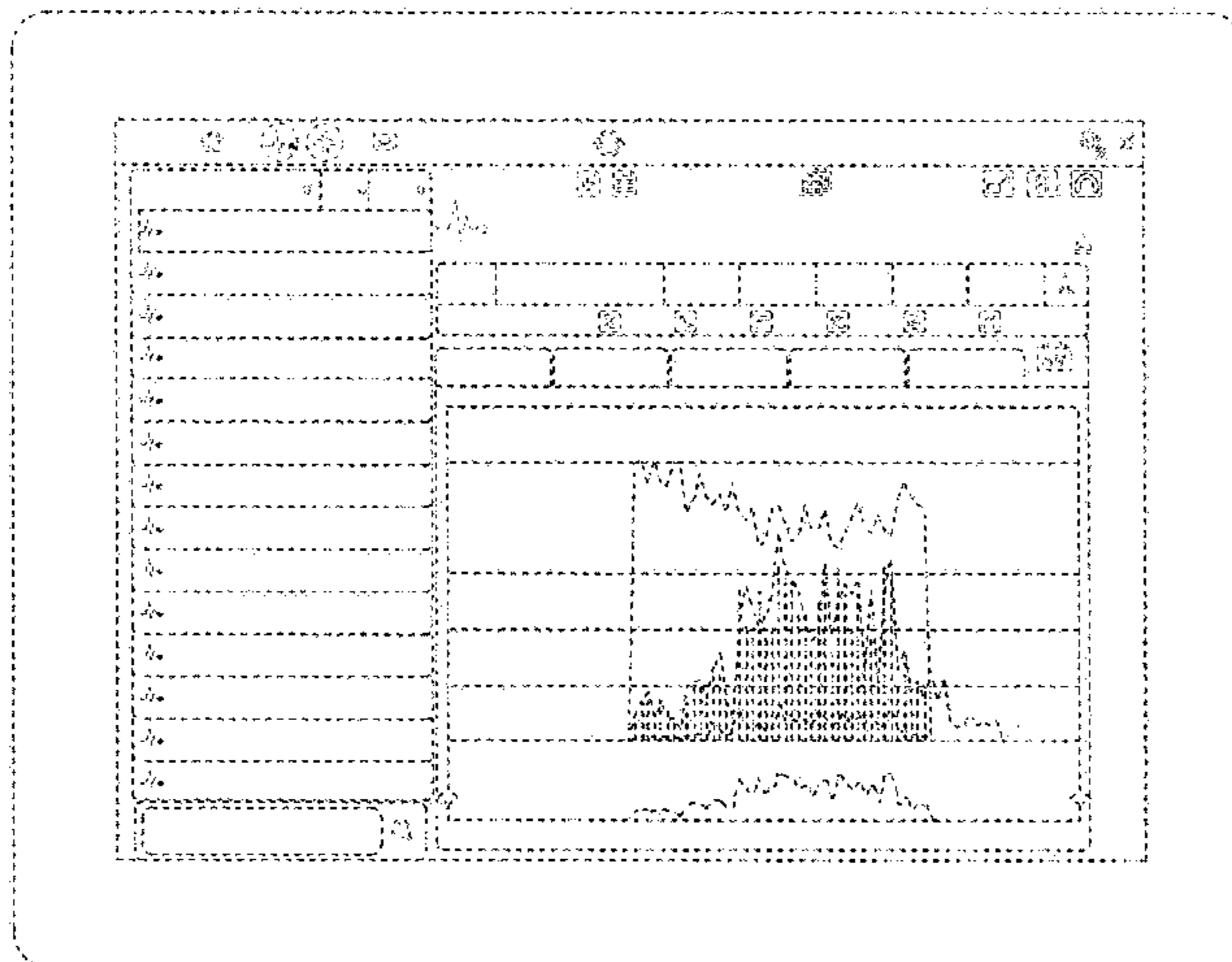
The ornamental design for a display screen for a personal digital assistant with graphical user interface, as shown and described.
