**DESCRIPTION**

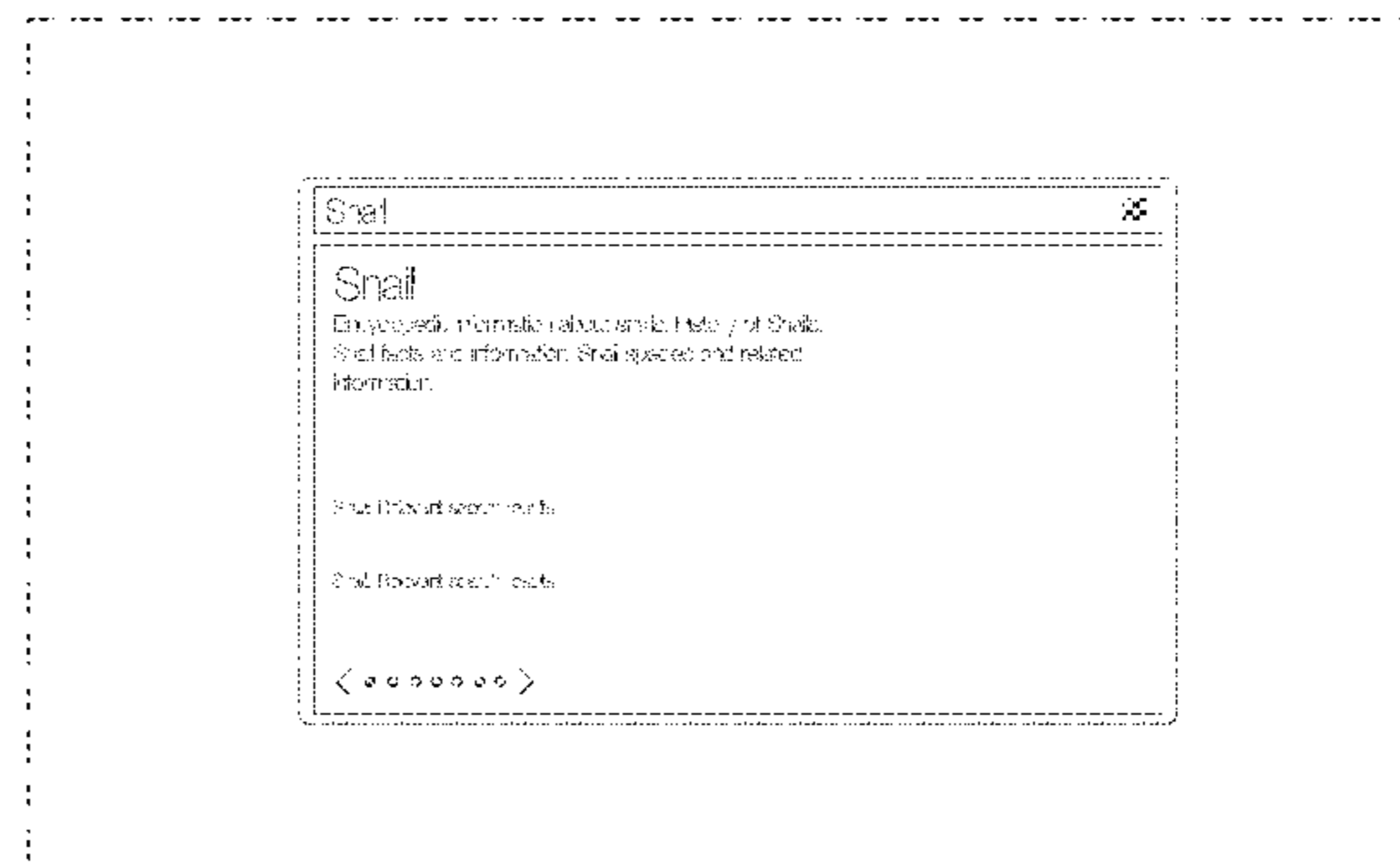
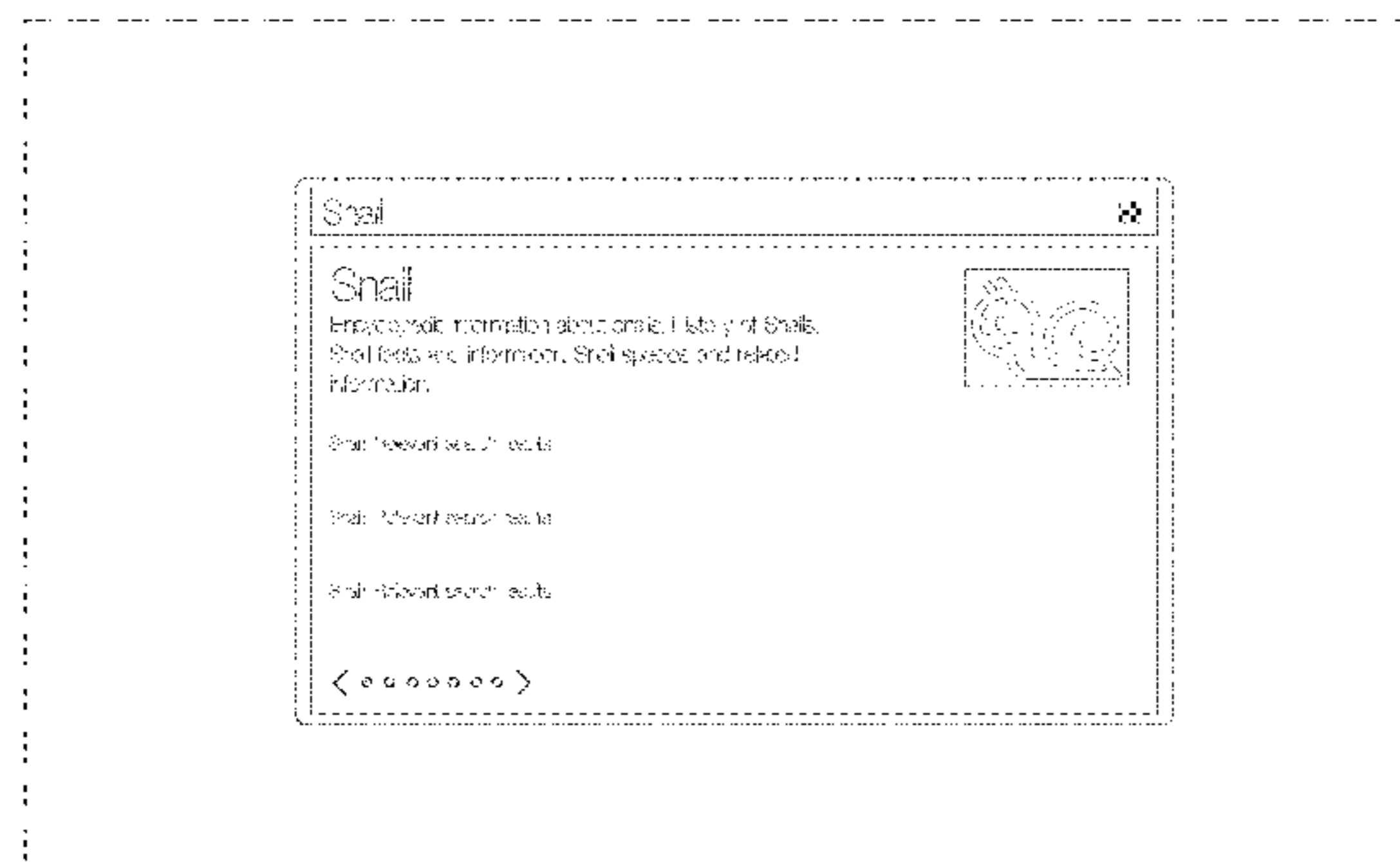
FIG. 1 is a front view of a display screen with a graphical user interface showing a first embodiment of our new design;

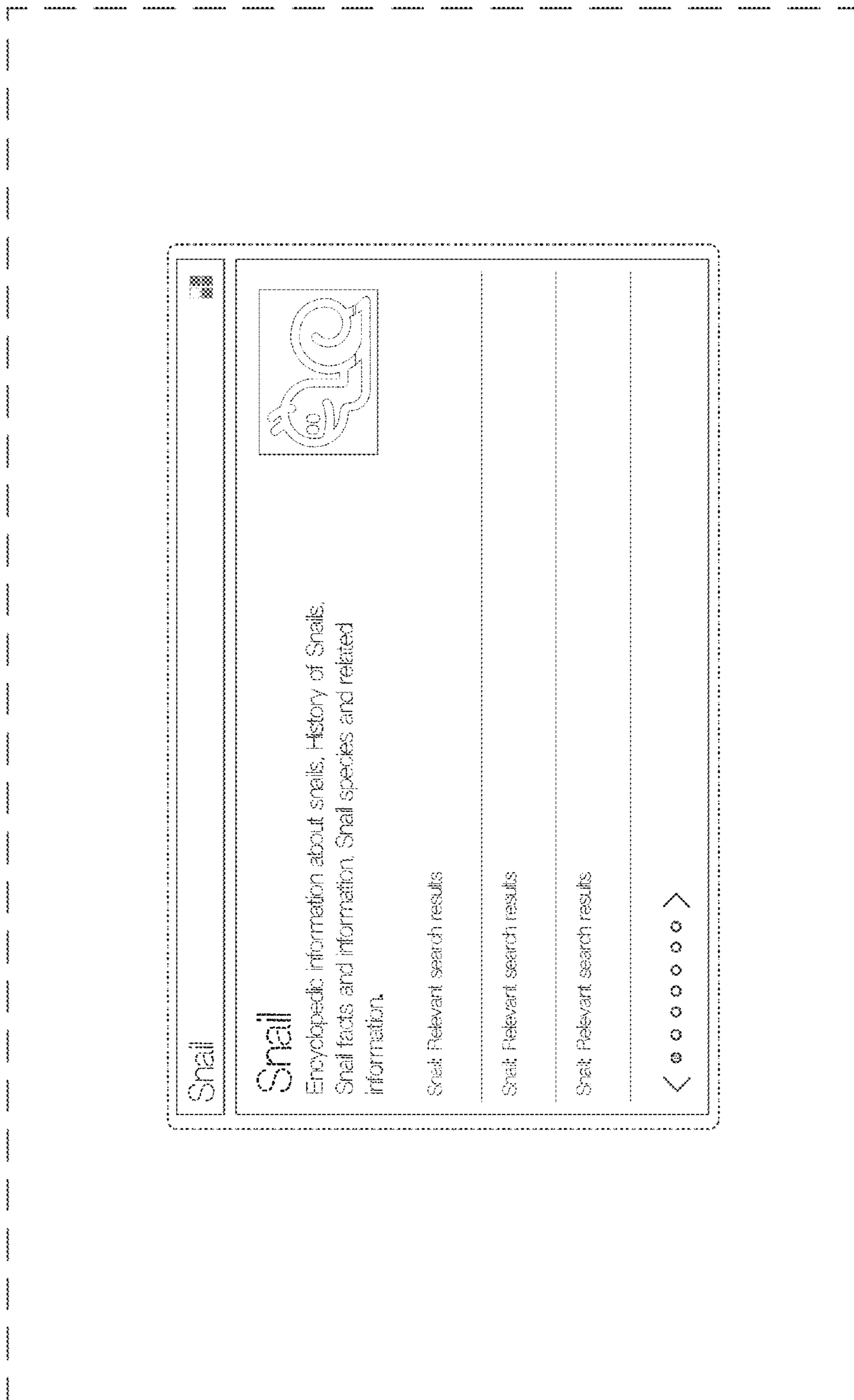

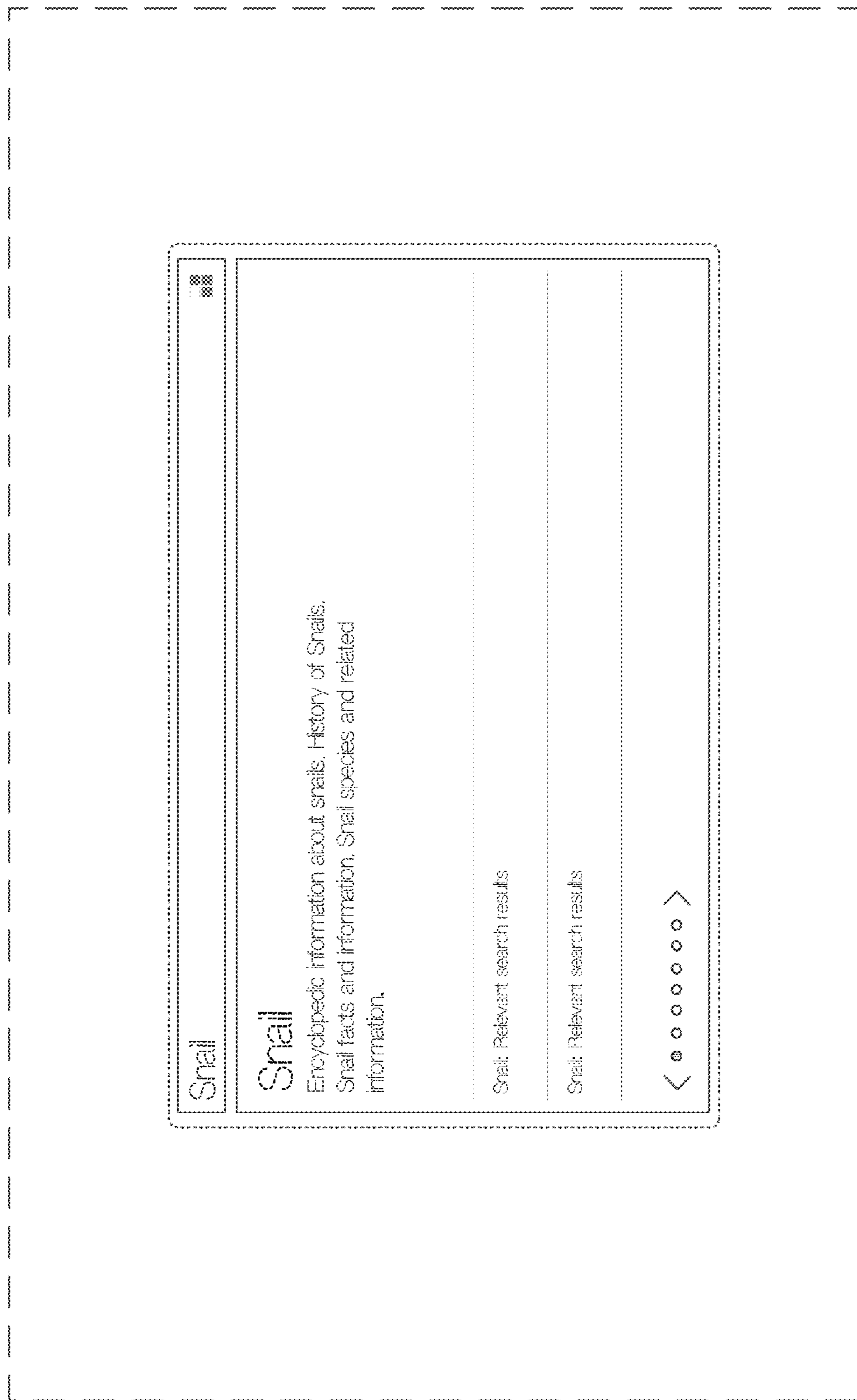

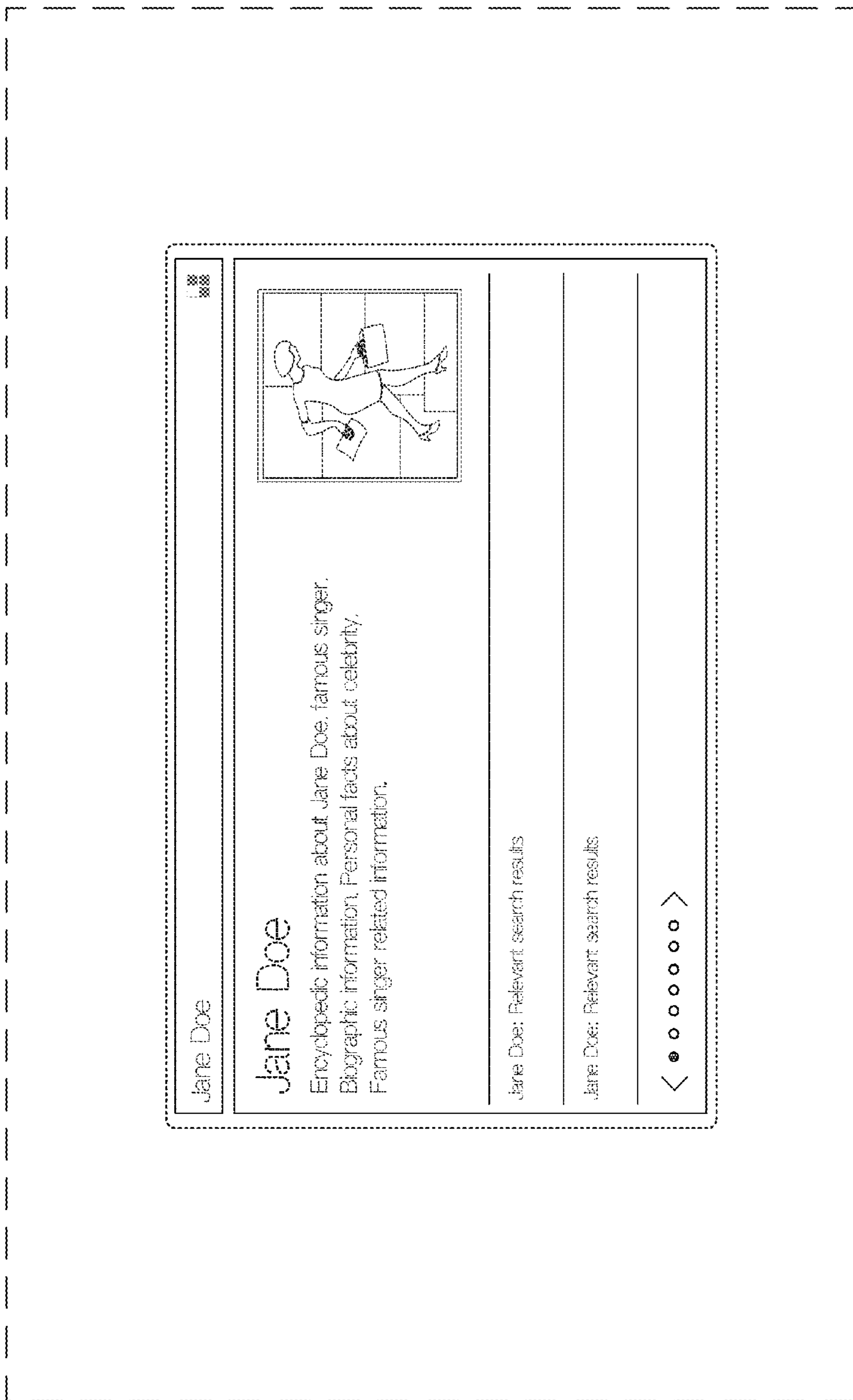
