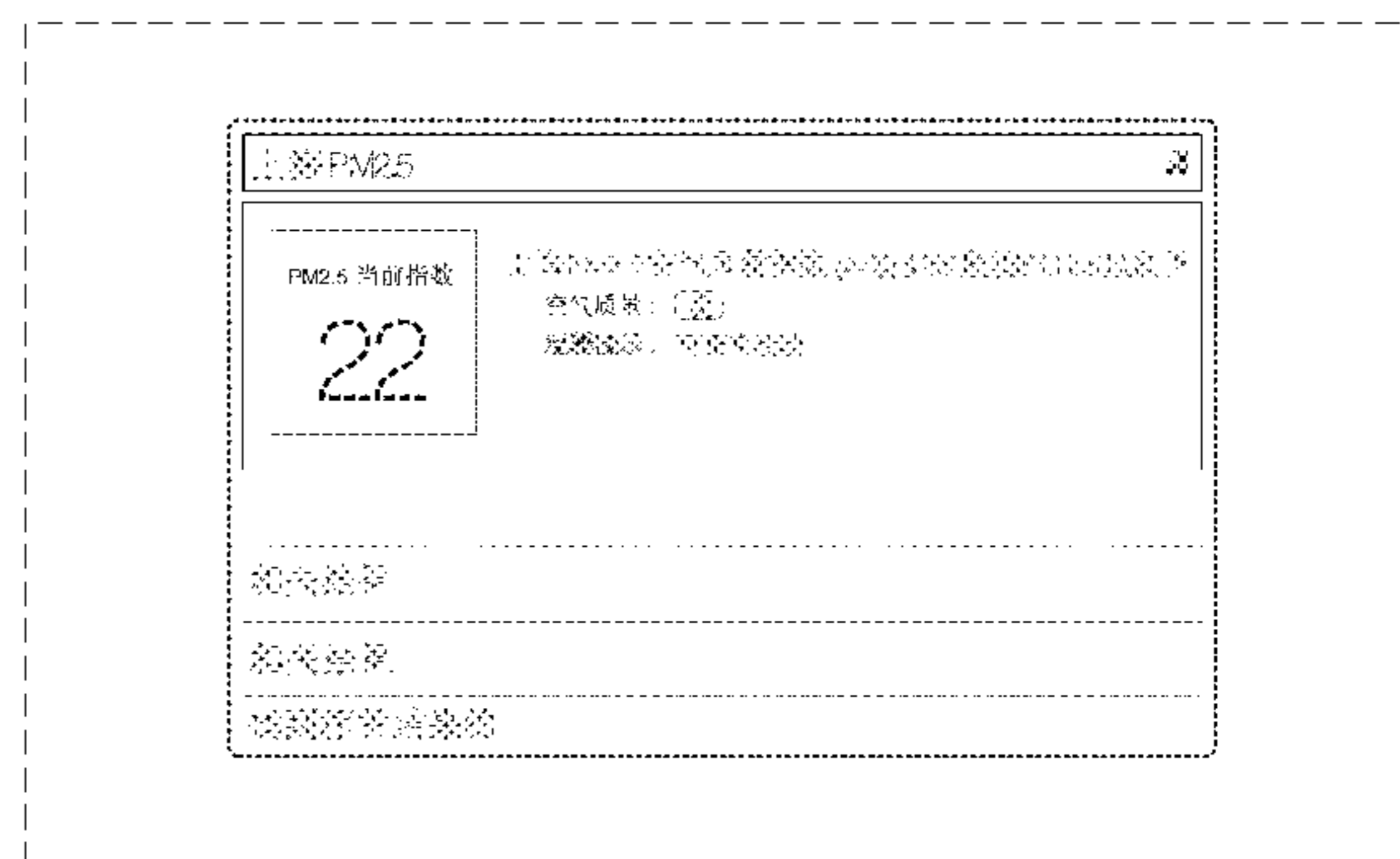
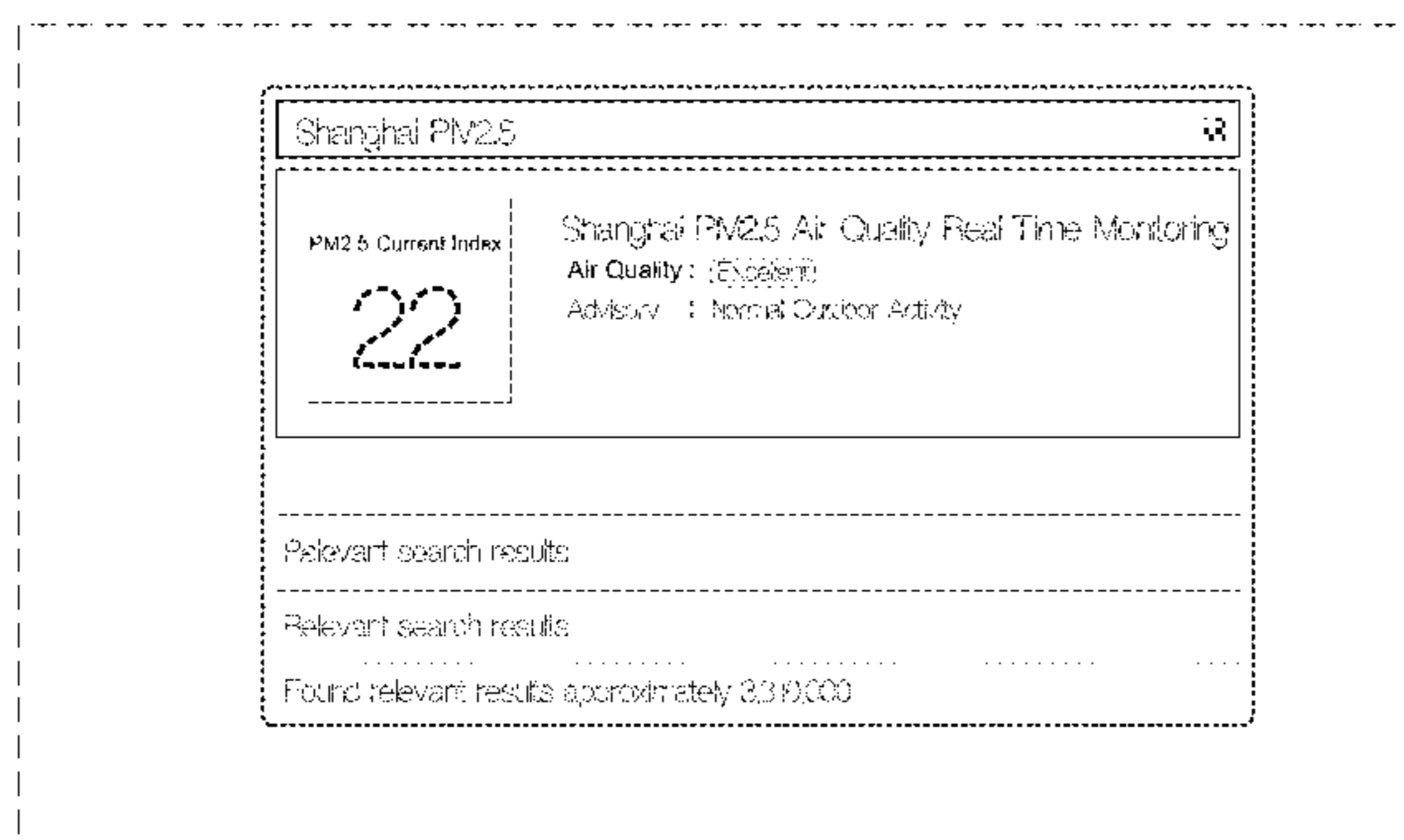

(57) **CLAIM**

We claim the ornamental design for a display screen with a graphical user interface, as shown and described.



DESCRIPTION

FIG. 1 is a front view of a display screen with a graphical user interface showing a first embodiment of our new design; and,

FIG. 2 is a second embodiment thereof.

The broken lines around the Figures show a display screen, and form no part of the claimed design. The broken lines within the Figures show portions of the graphical user interface that form no part of the claimed design.

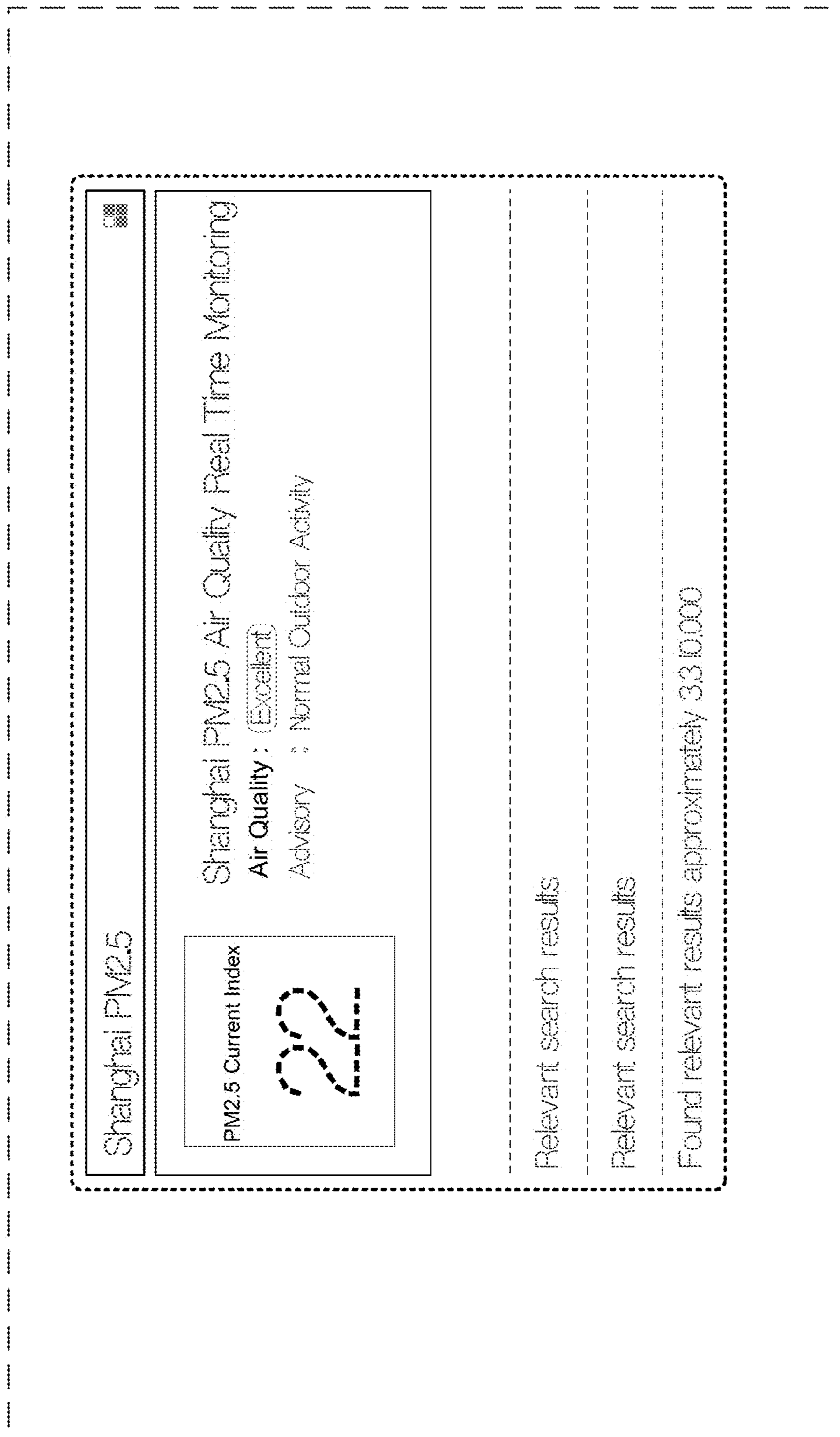

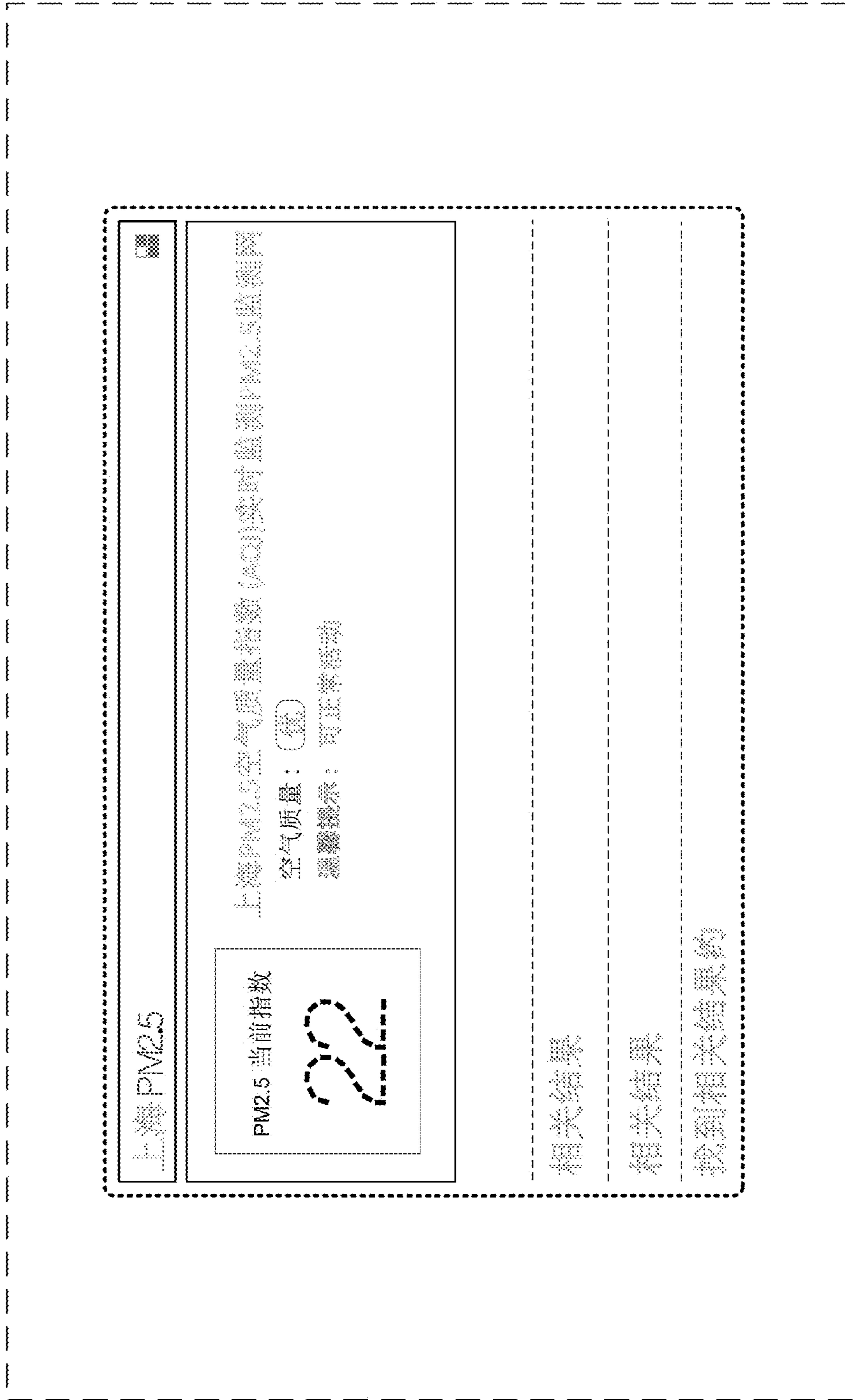
