The appearance of the animated user interface sequentially transitions between the images shown in FIGS. 1-15. The process or period in which one image transitions to another forms no part of the claimed design.

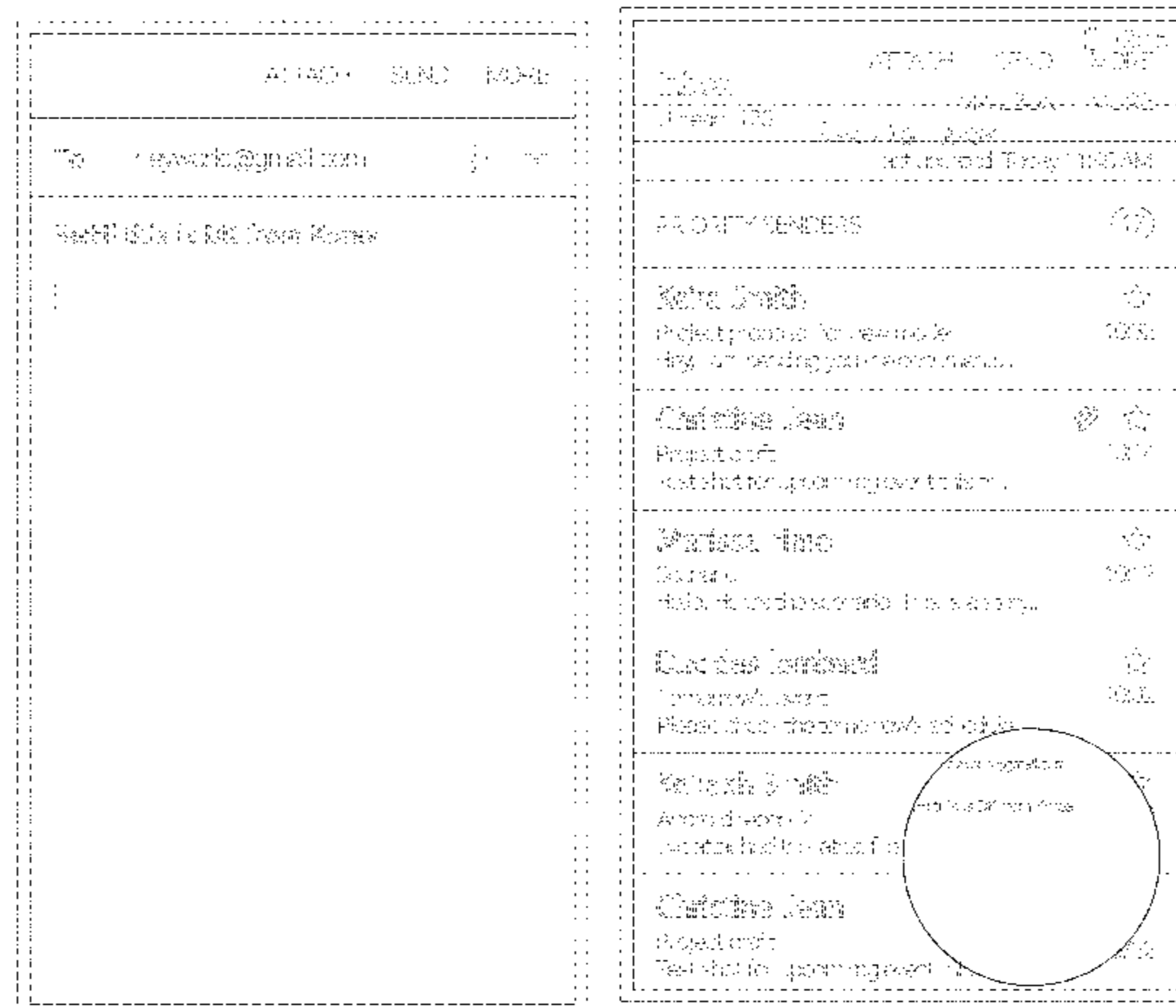

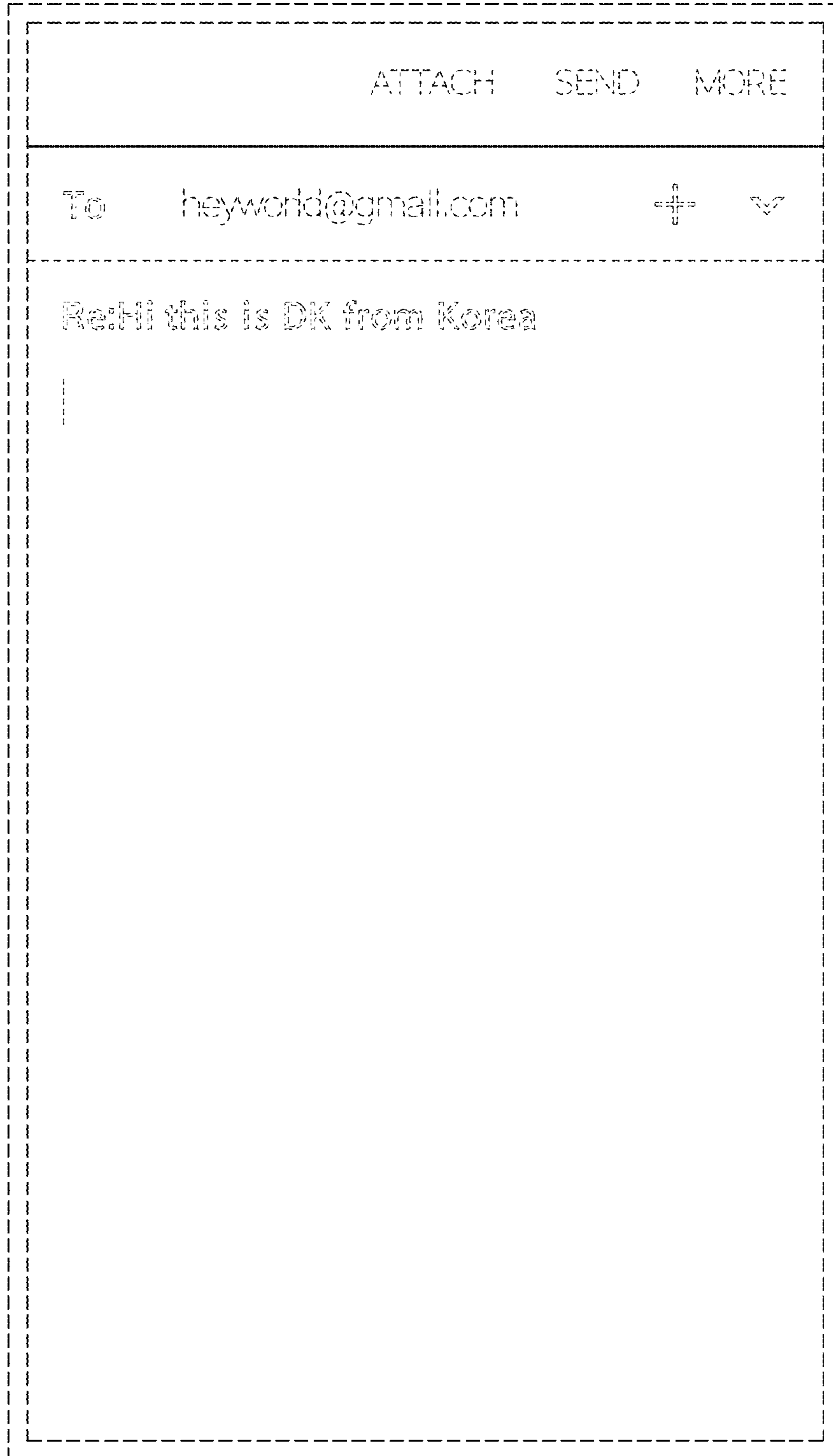

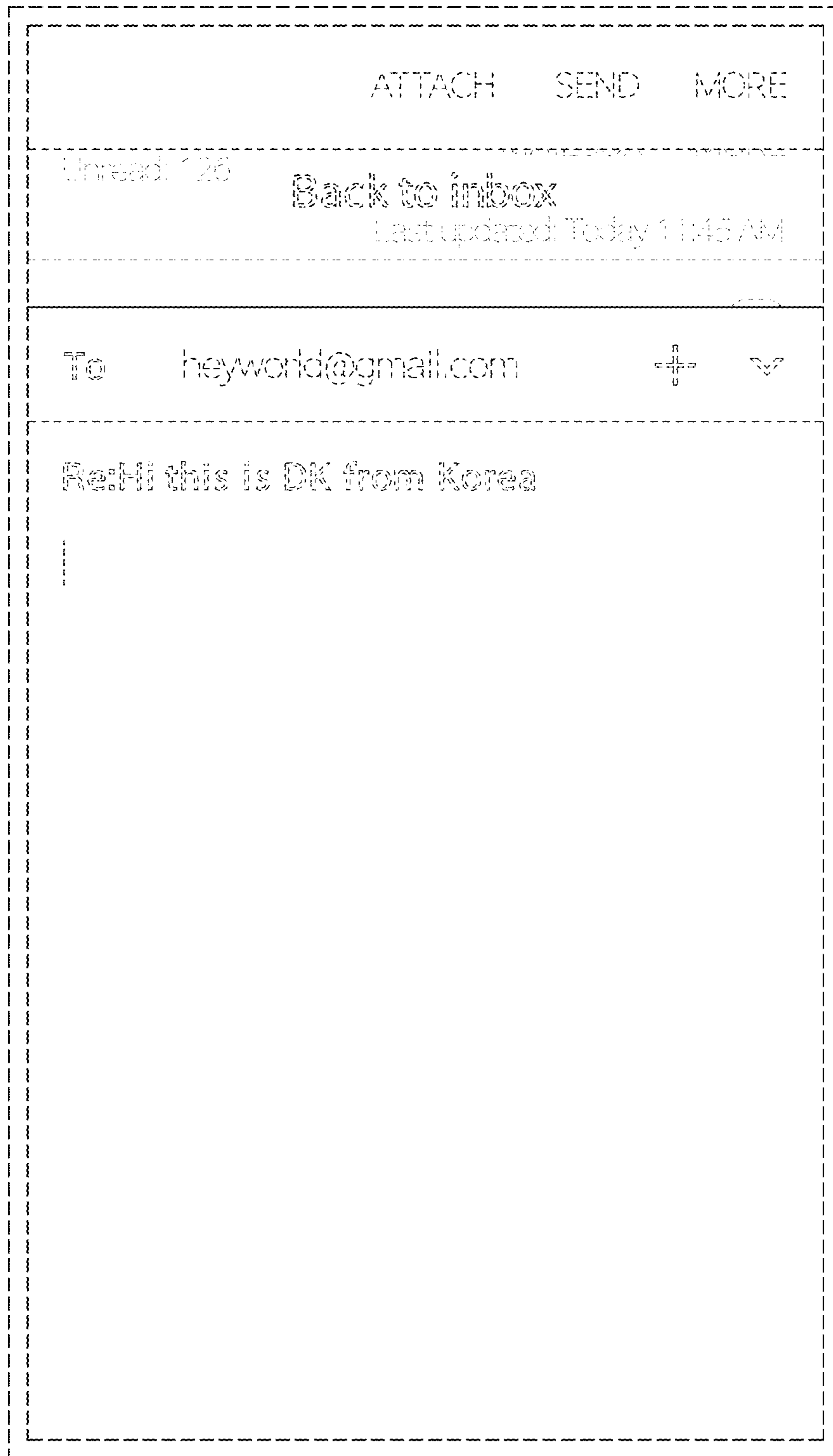

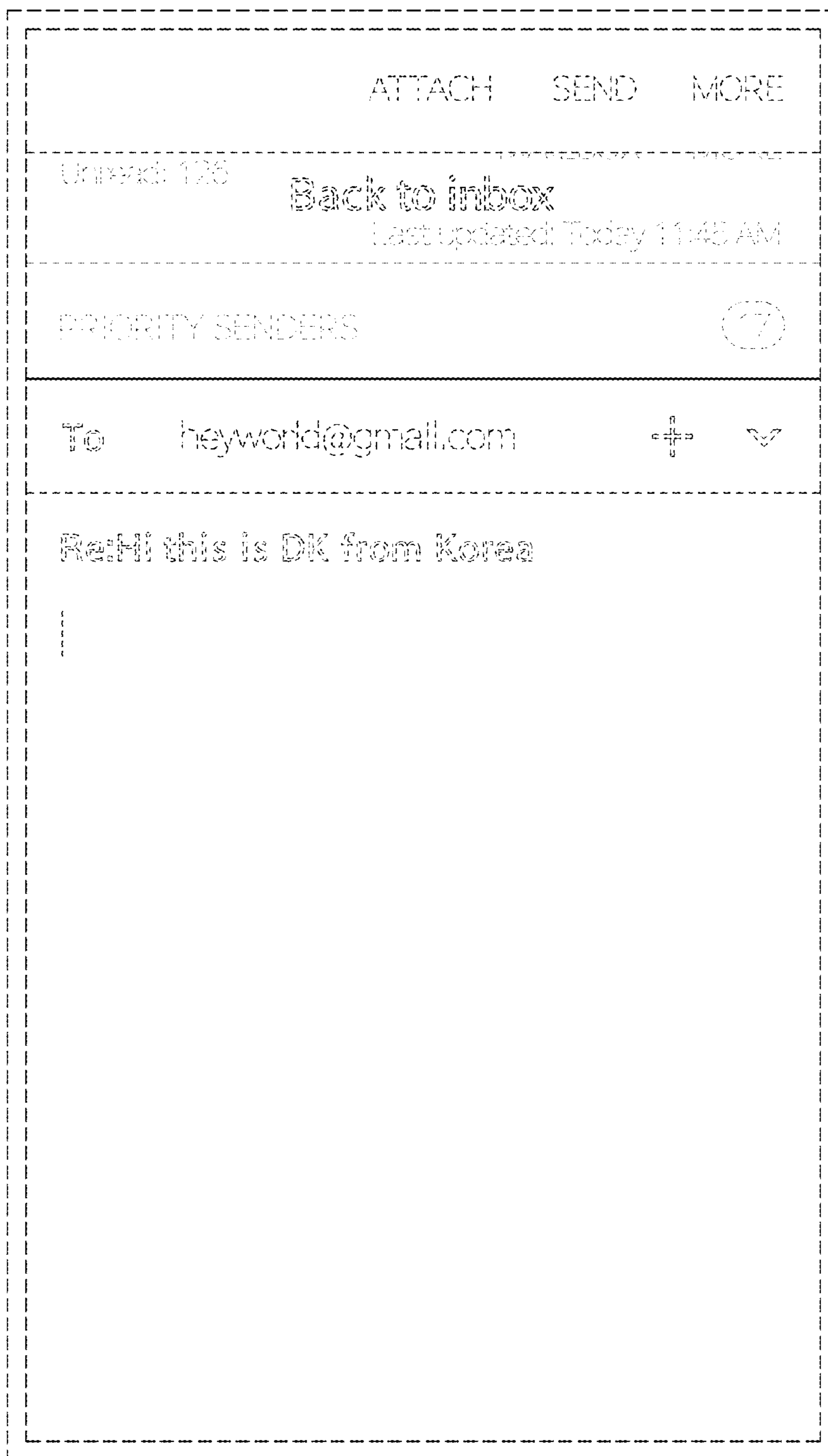

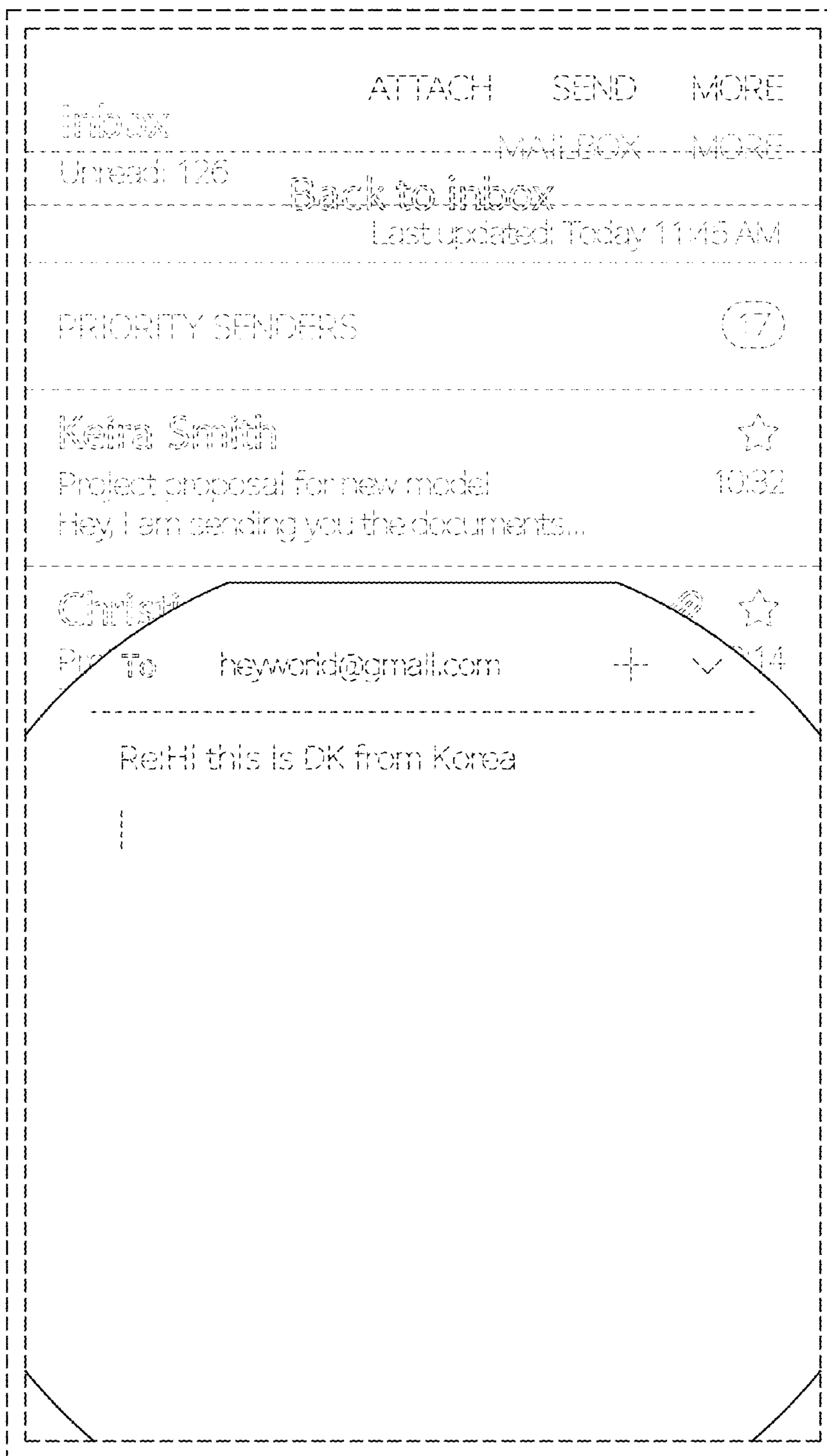

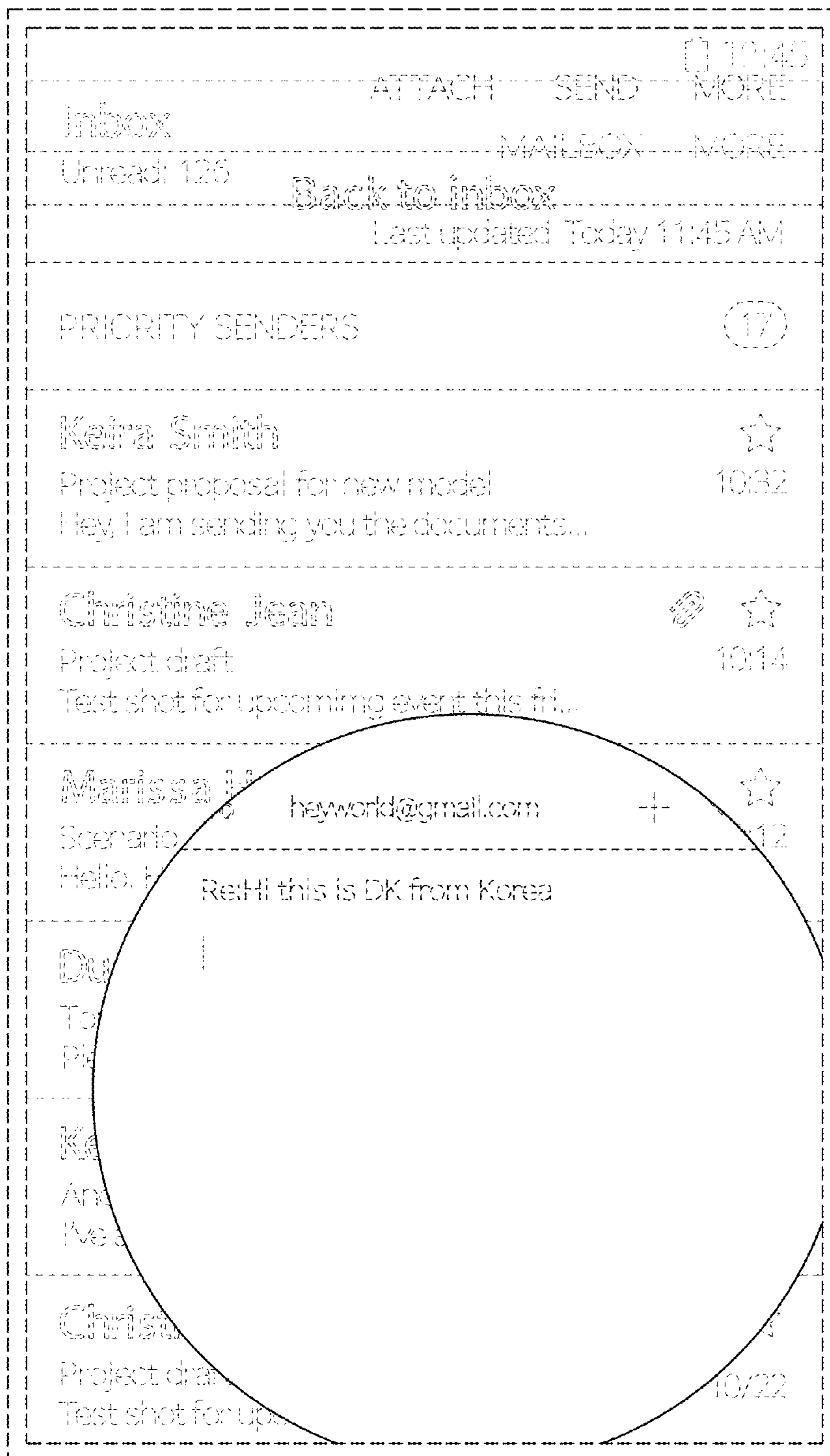

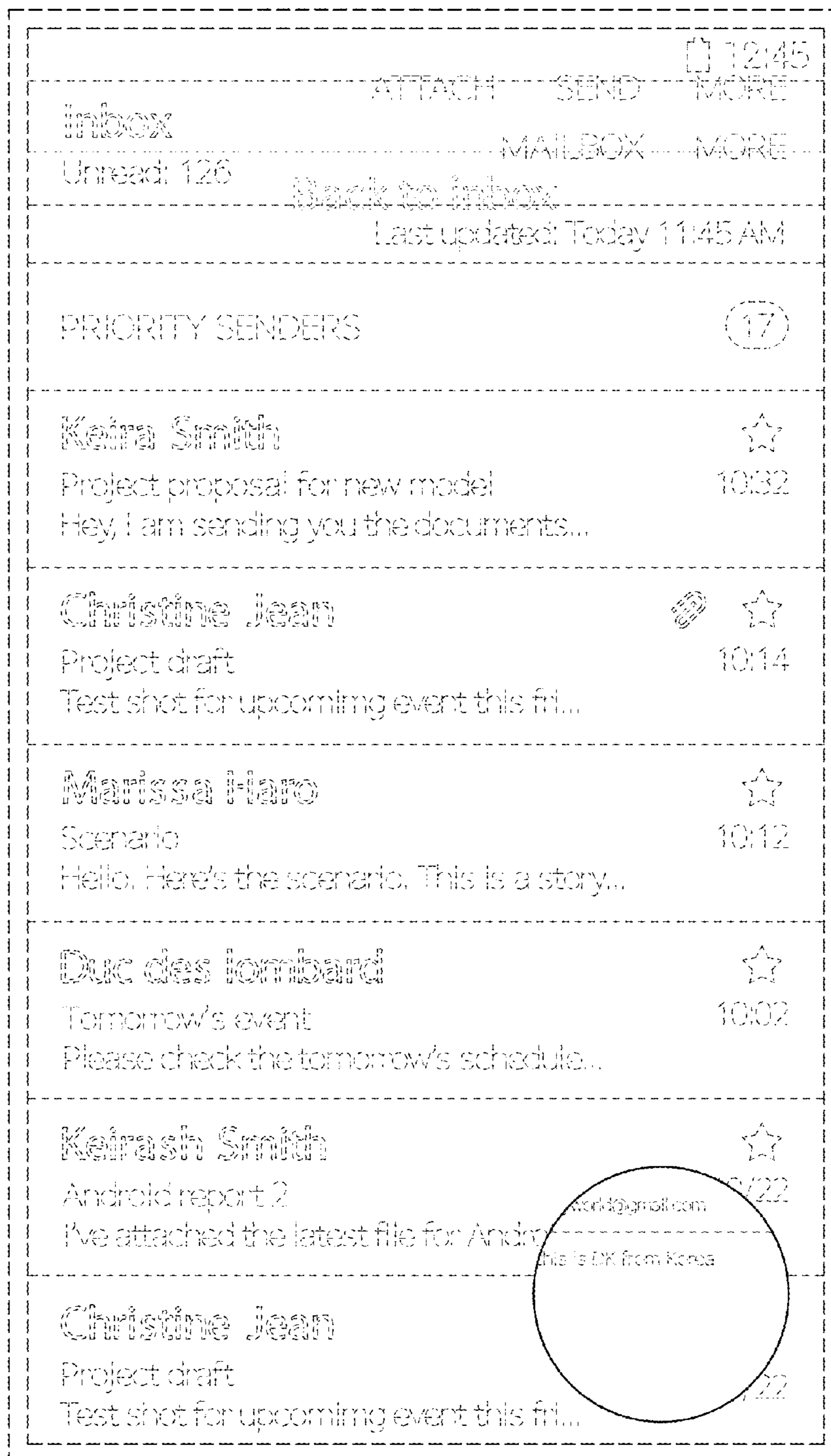
