The sole FIGURE is a front view of a touchscreen display or portion thereof with a graphical user interface, showing our new design.

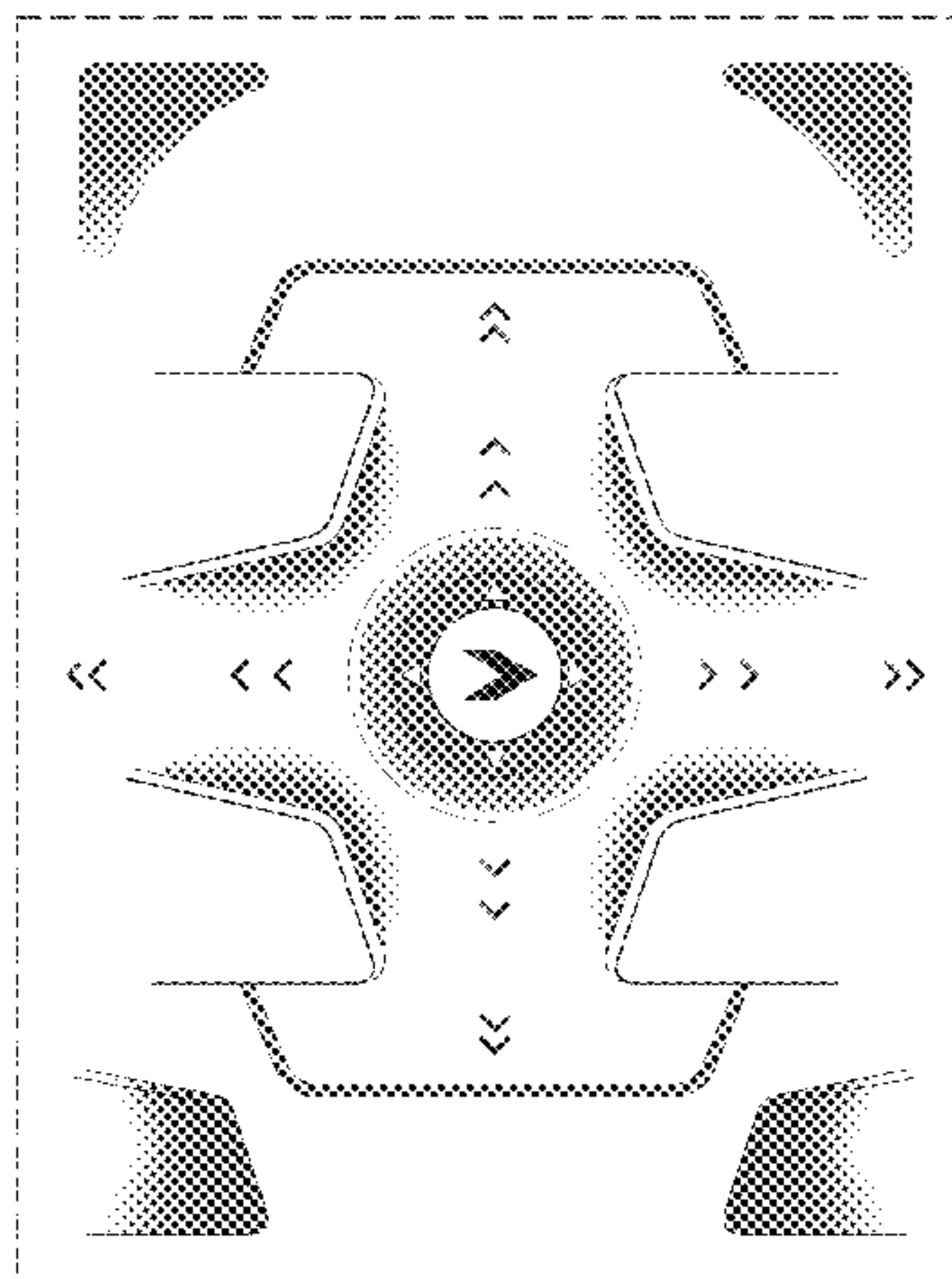
The broken line shown in the FIGURE represents the display screen and forms no part of the claimed design.
