(57) **CLAIM**

The ornamental design for a display screen with icon, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen with icon showing our new design;

The evenly spaced broken lines illustrate a display screen and portions of the icon. The dot-dash broken line illustrates a boundary of the claim. None of the broken lines form part of the claimed design.

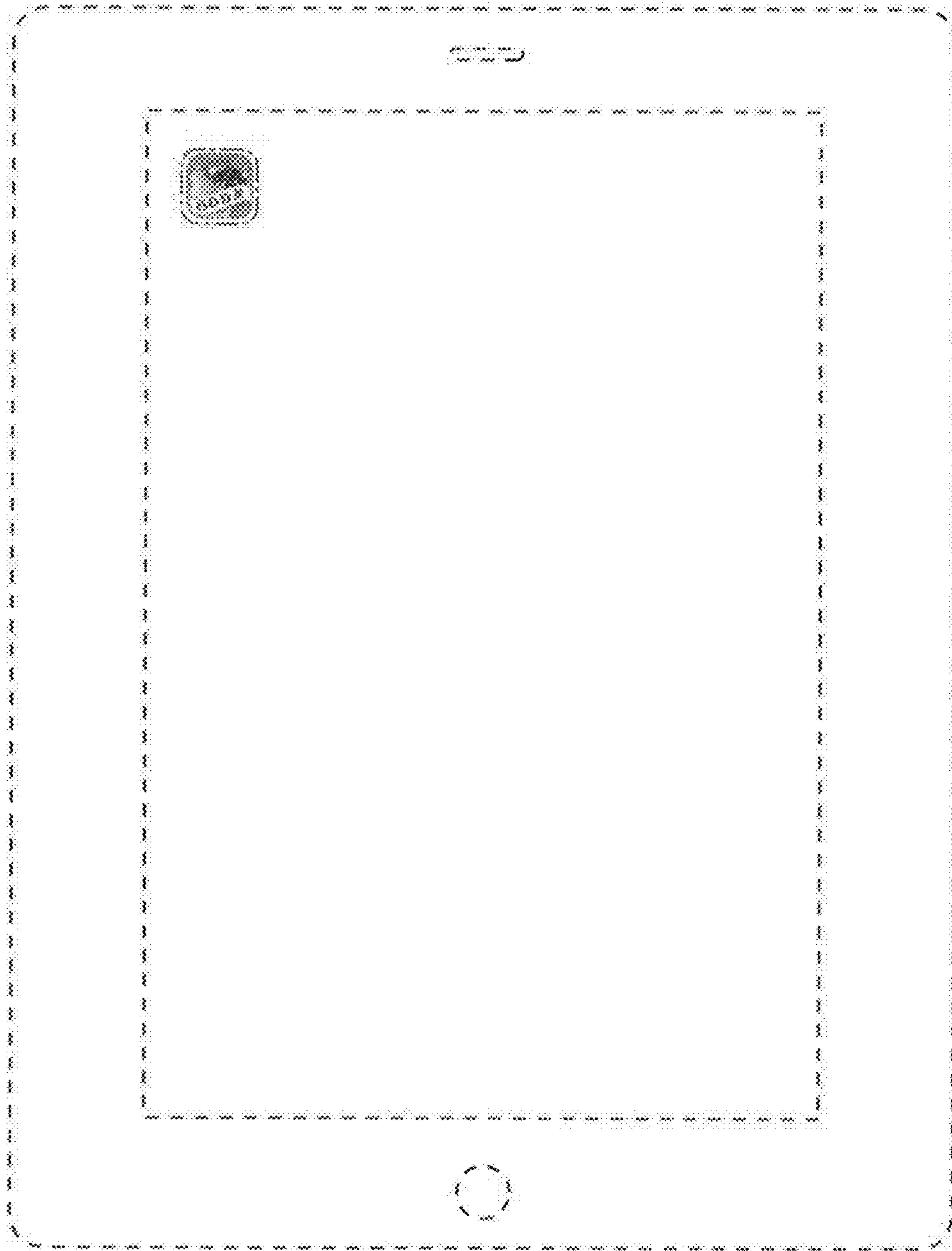
