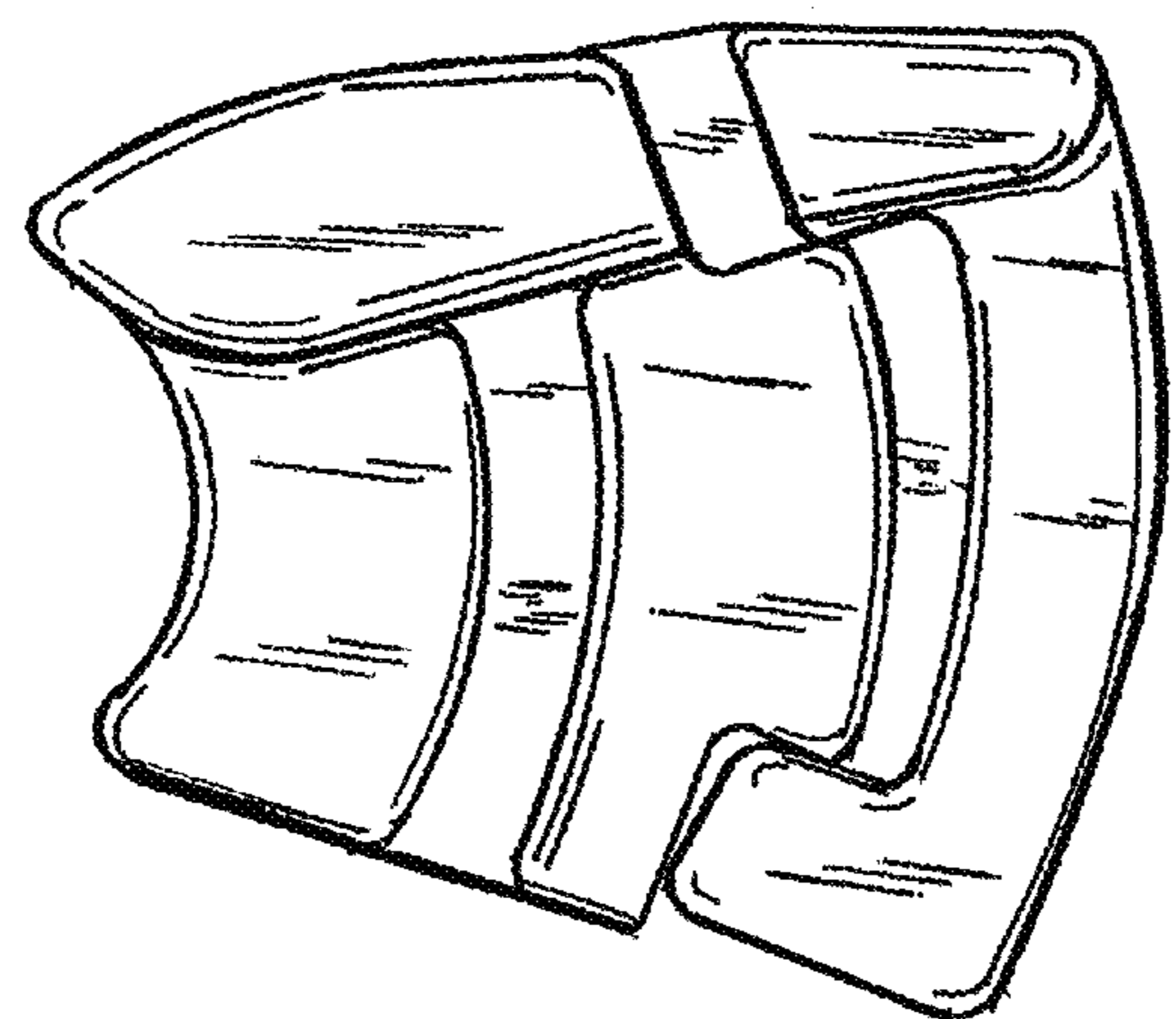

The ornamental design for a digging tooth assembly securement member, as shown and described.

DESCRIPTION

FIG. 1 is a front side elevational view of one embodiment of a digging tooth assembly securement member;
FIG. 2 is a rear side elevational thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side elevational view thereof; and,
FIG. 6 is a right side elevational view thereof.

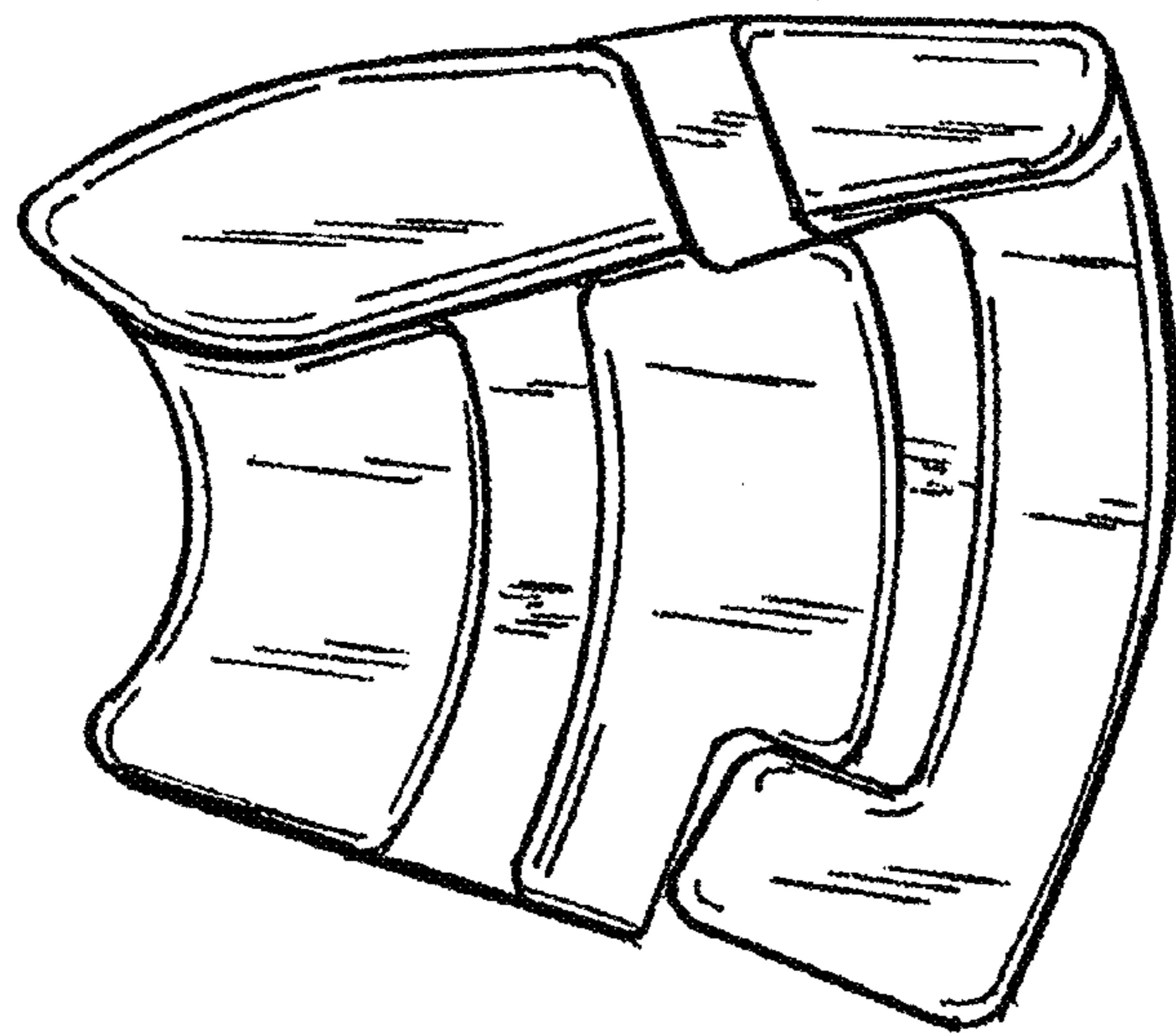

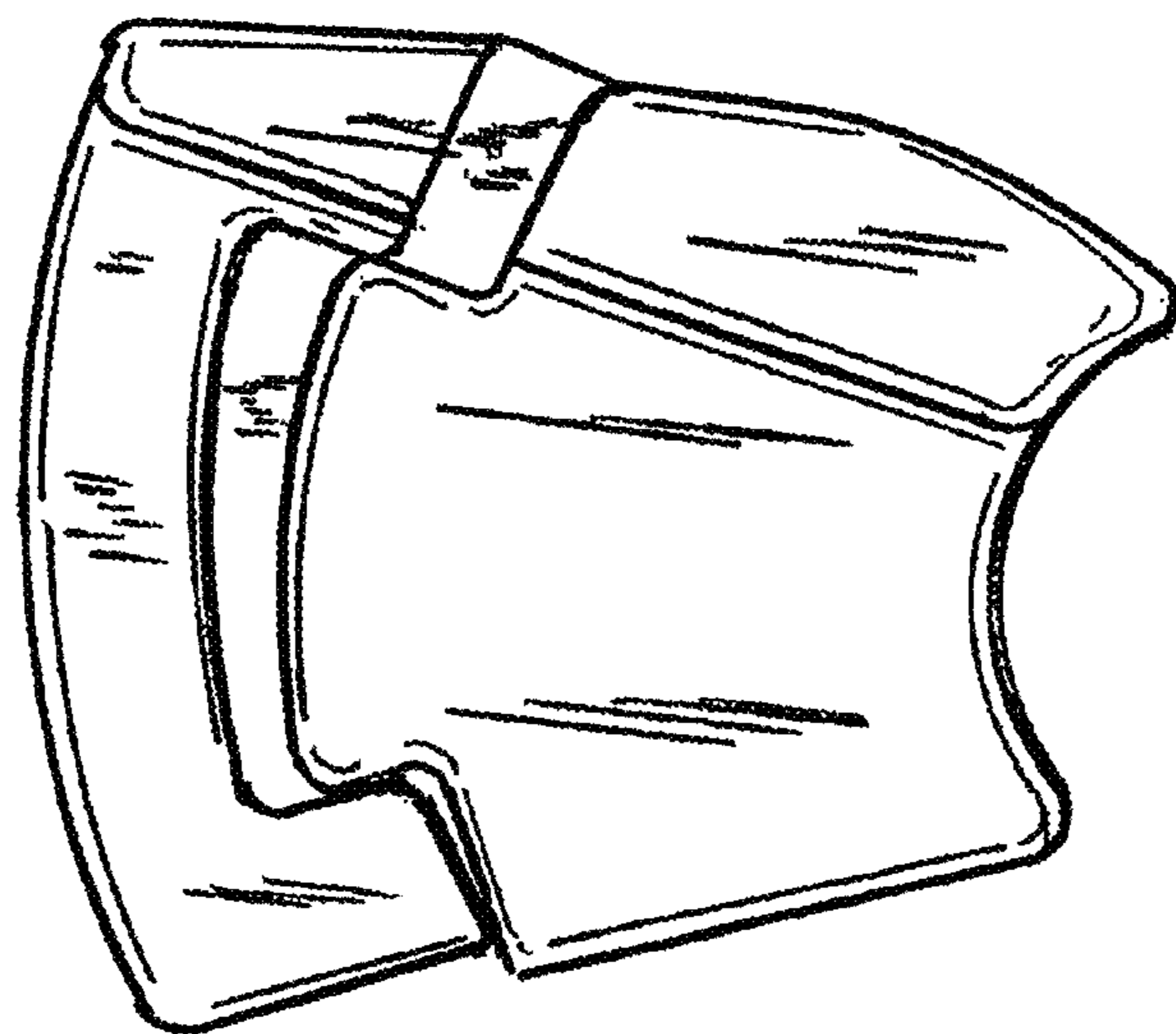

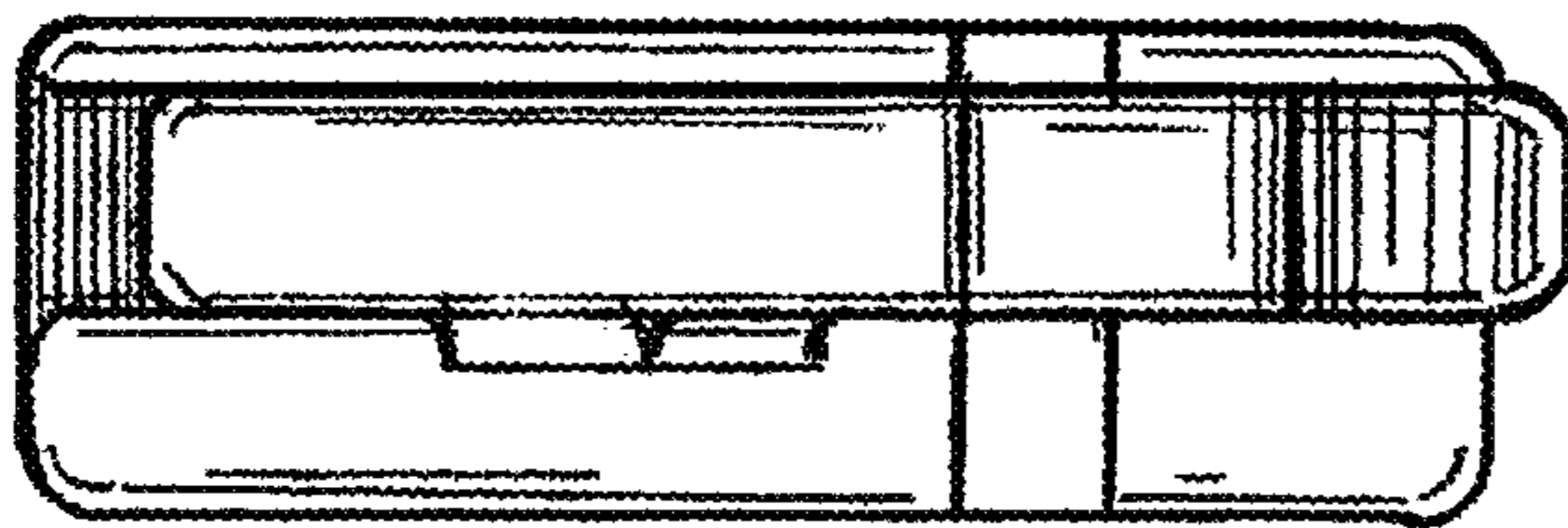
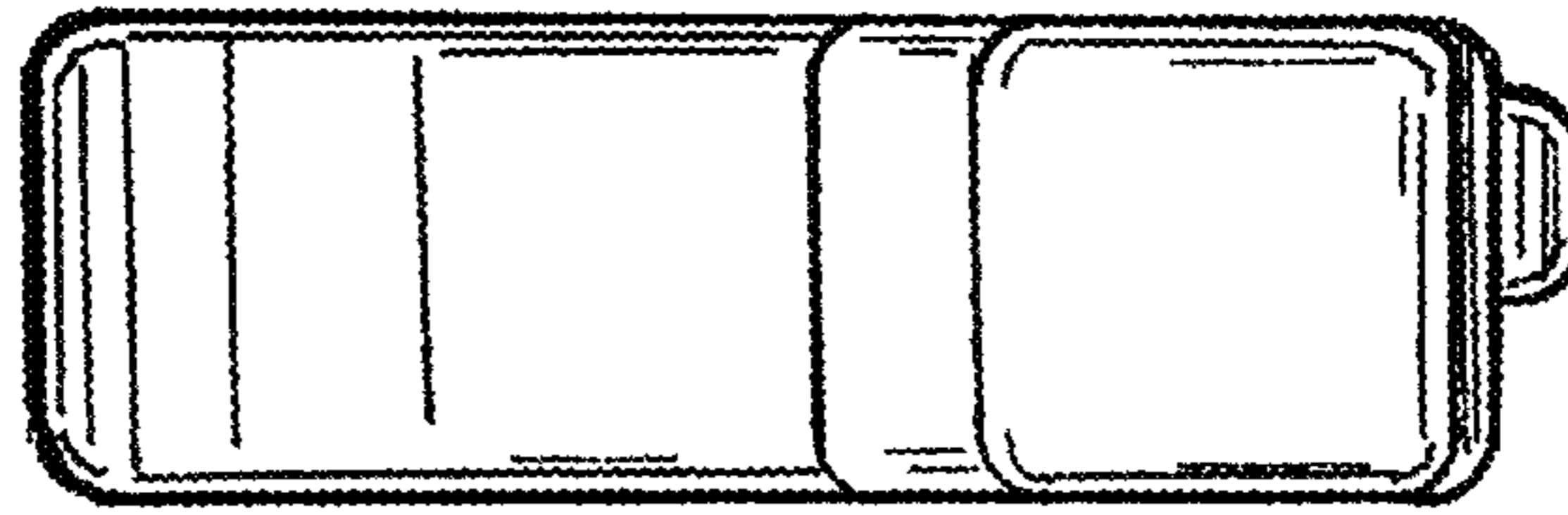

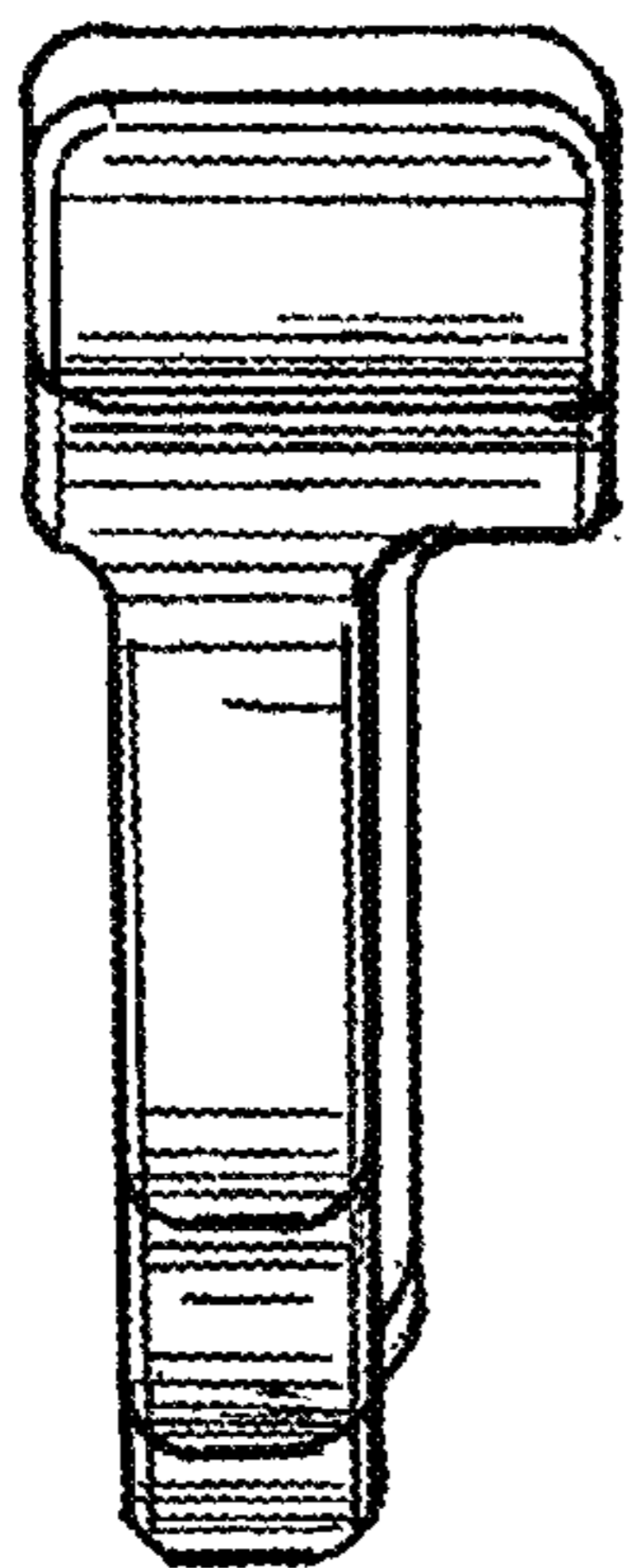

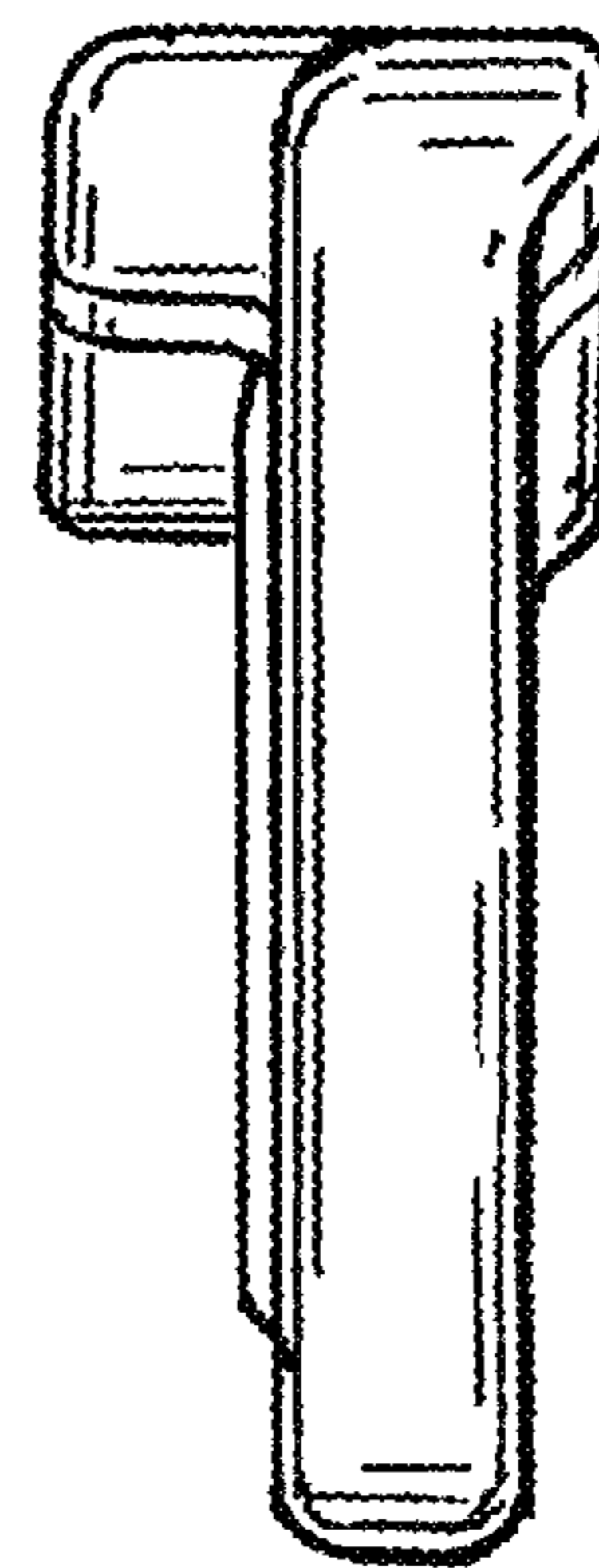
