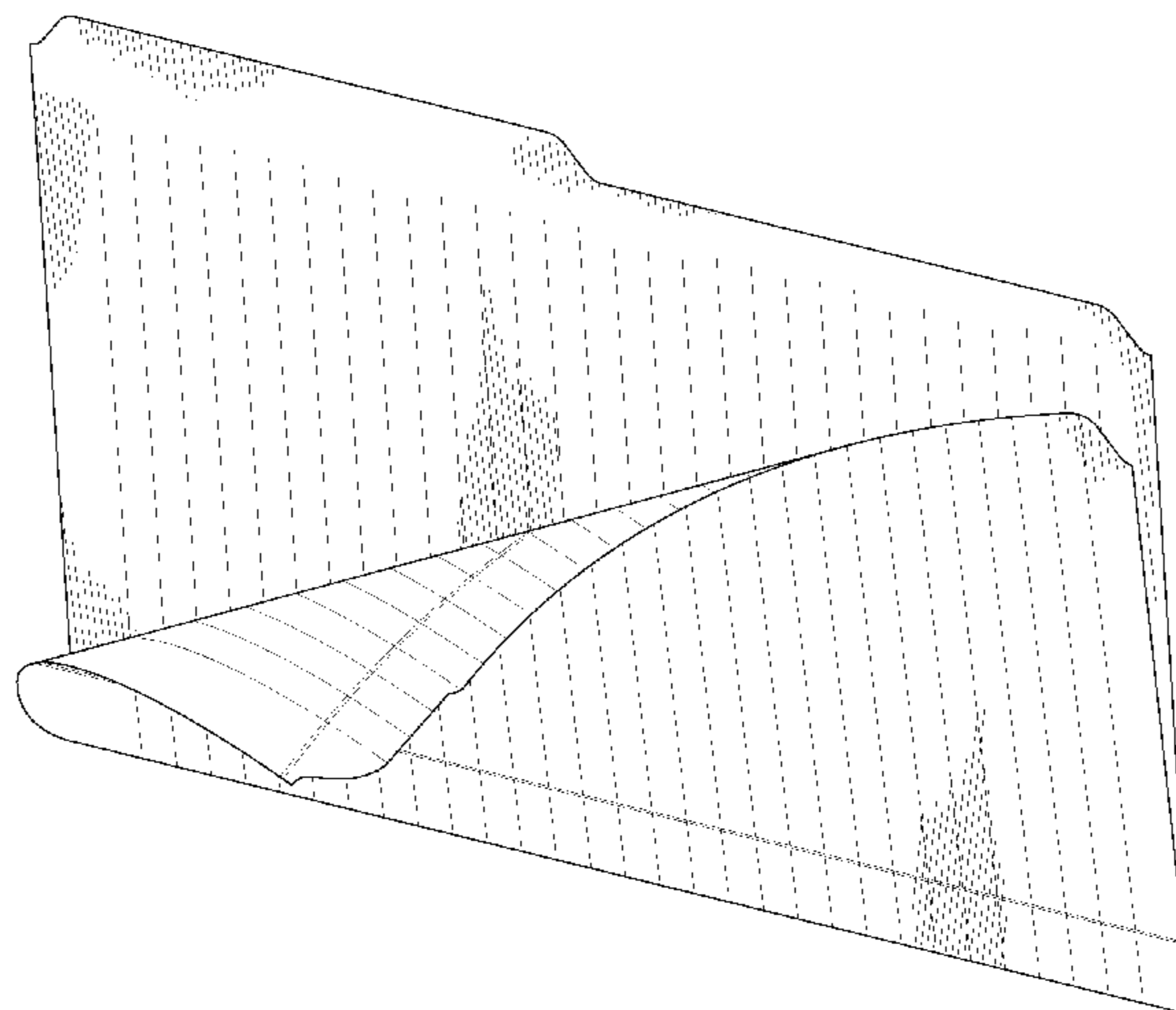
(57) **CLAIM**

We claim the ornamental design for a ruled file folder, as shown and described.

DESCRIPTION

FIG. 1 is a front/right/top perspective view of the first embodiment of a ruled file folder showing our new design; FIG. 2 is a front/left/top perspective view thereof; FIG. 3 is a front/right/top perspective view thereof, with a corner curled down to expose the interior of the file folder; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a right side elevational view thereof; FIG. 9 is a left side elevational view thereof; FIG. 10 is a front/right/top perspective view of the second embodiment of a ruled file folder showing our new design; FIG. 11 is a front/left/top perspective view thereof; FIG. 12 is a front/left/top perspective view thereof, with a corner curled down to expose the interior of the file folder; FIG. 13 is a front elevational view thereof; FIG. 14 is a rear elevational view thereof; FIG. 15 is a top plan view thereof; FIG. 16 is a bottom plan view thereof; FIG. 17 is a right side elevational view thereof; and, FIG. 18 is a left side elevational view thereof.

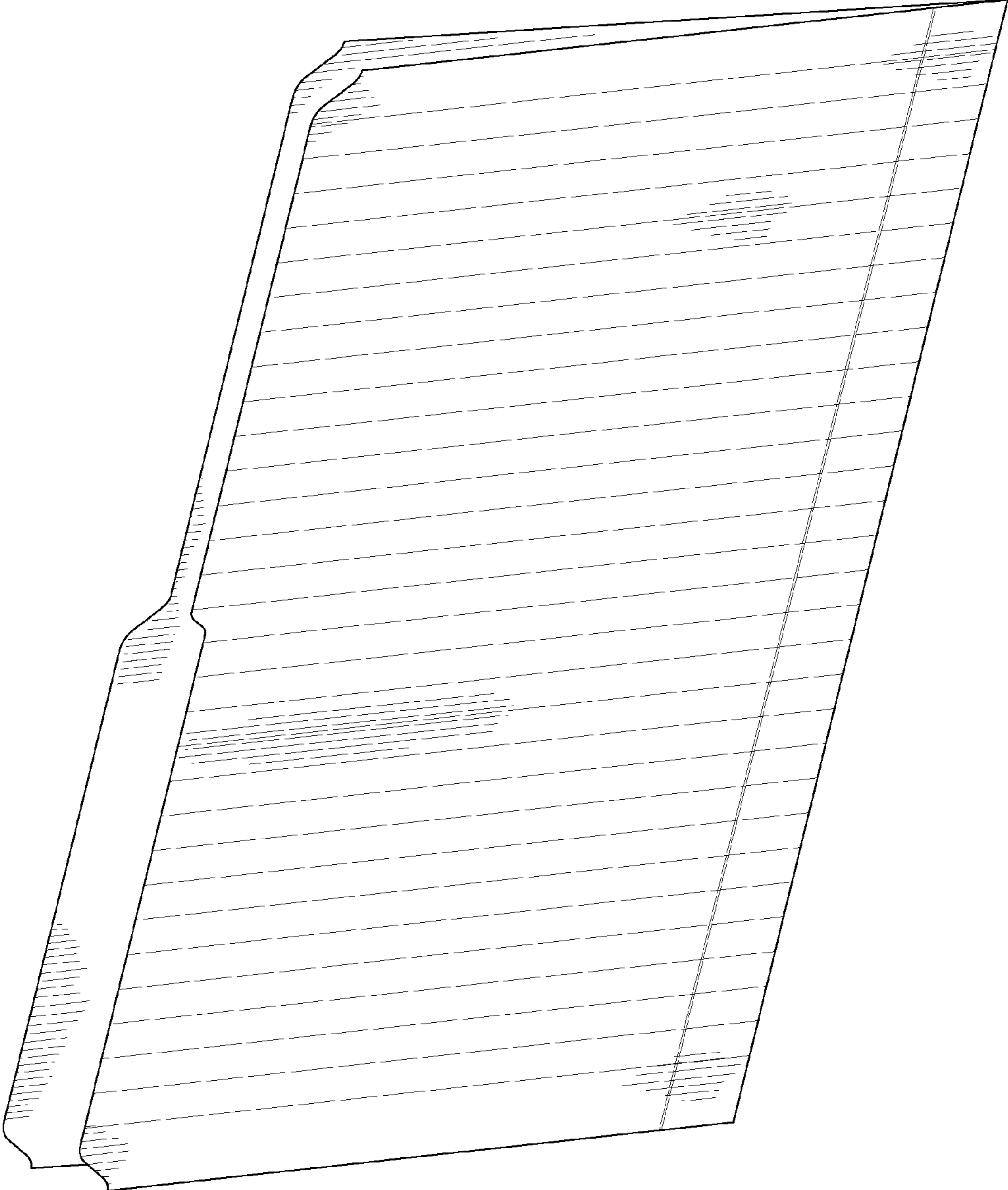

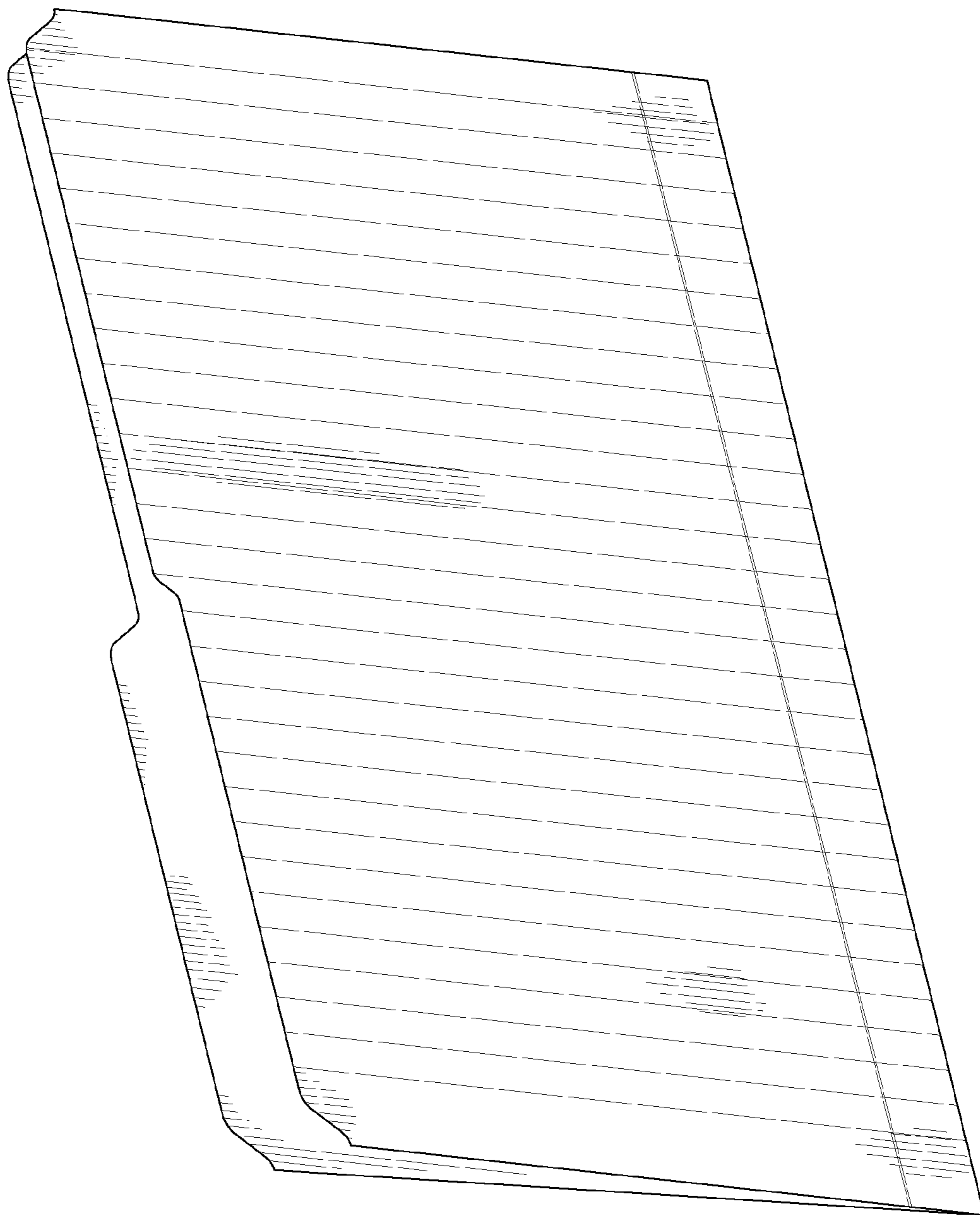

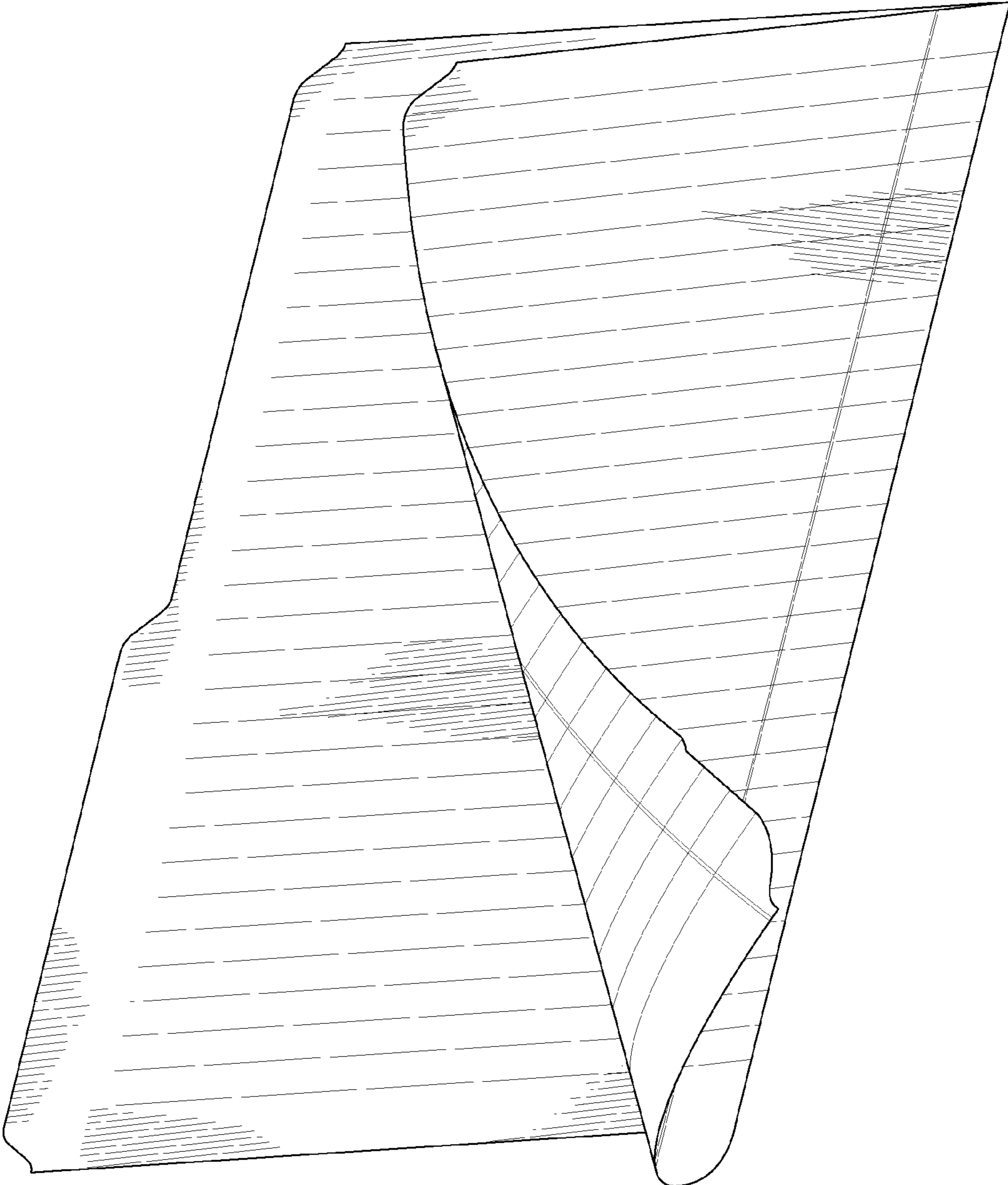

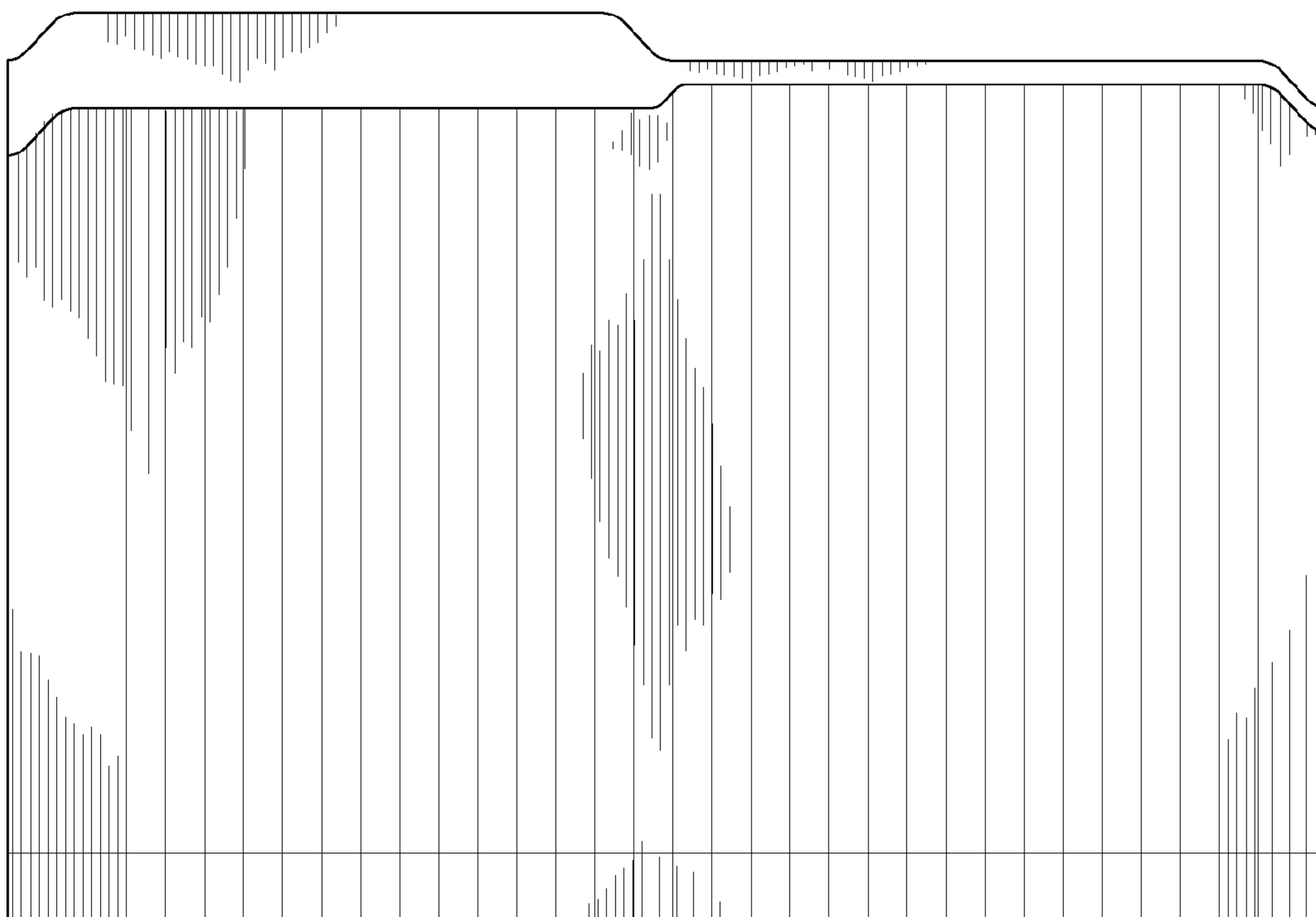

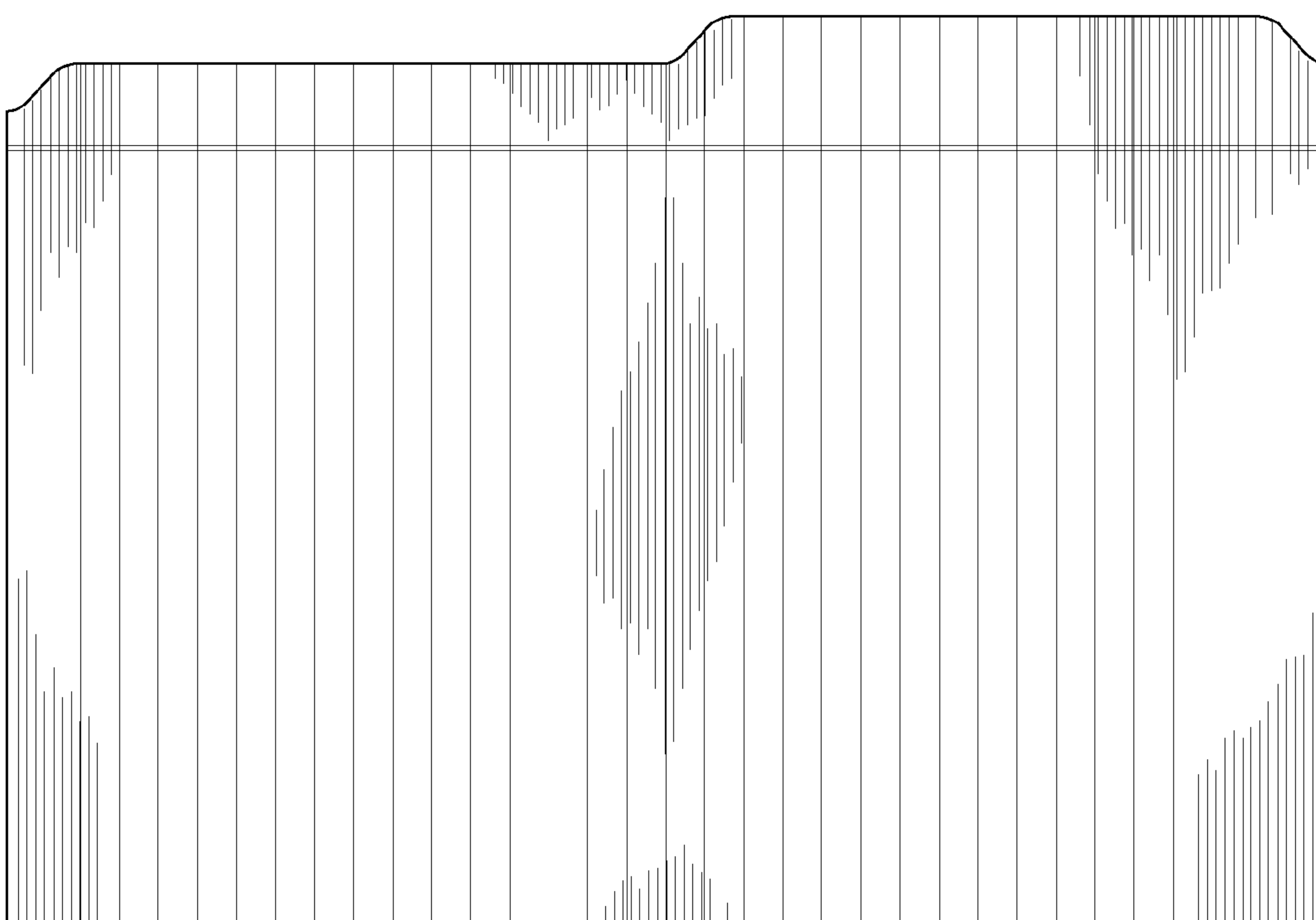

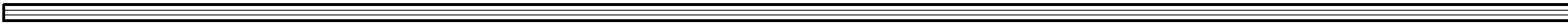

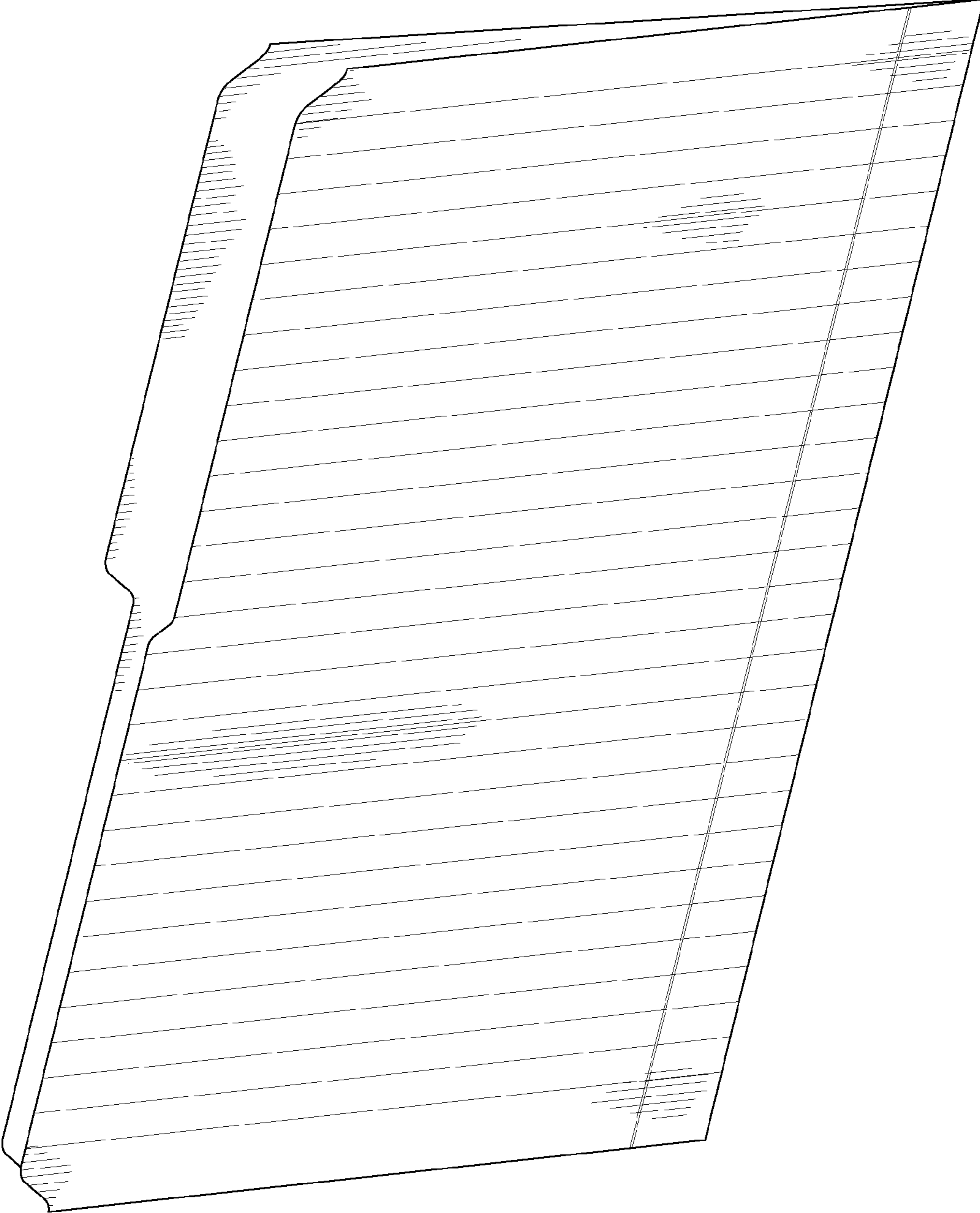

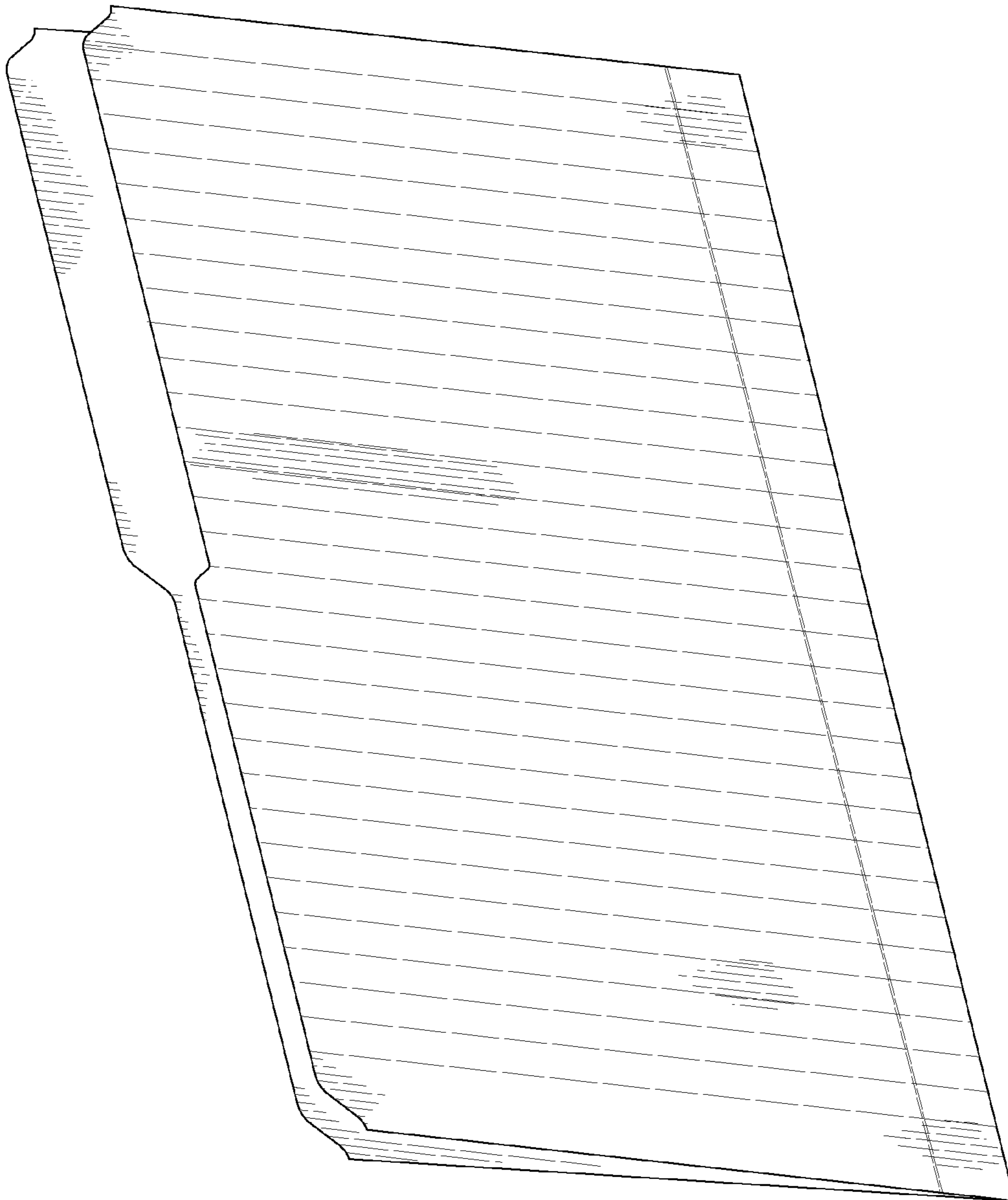

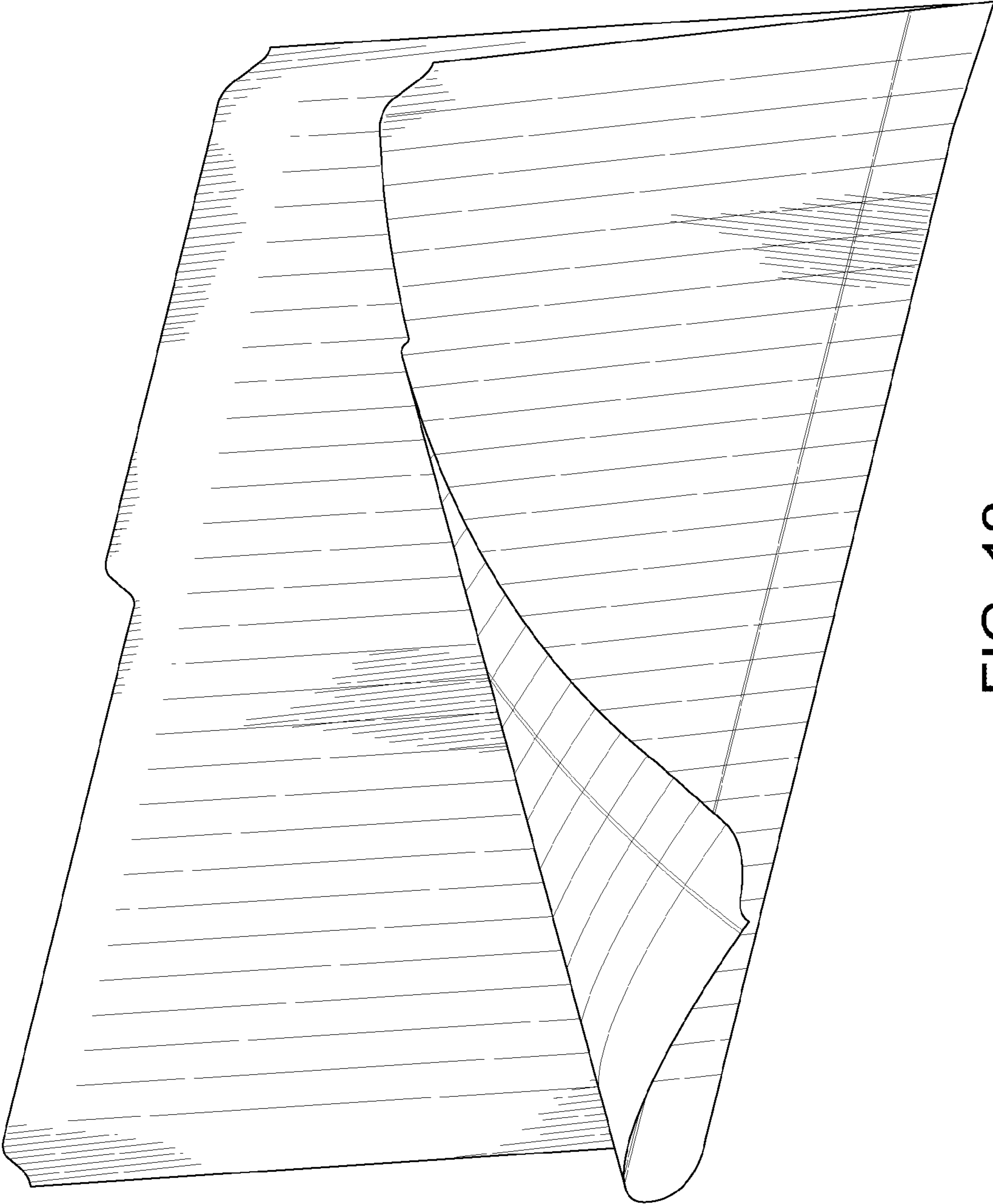

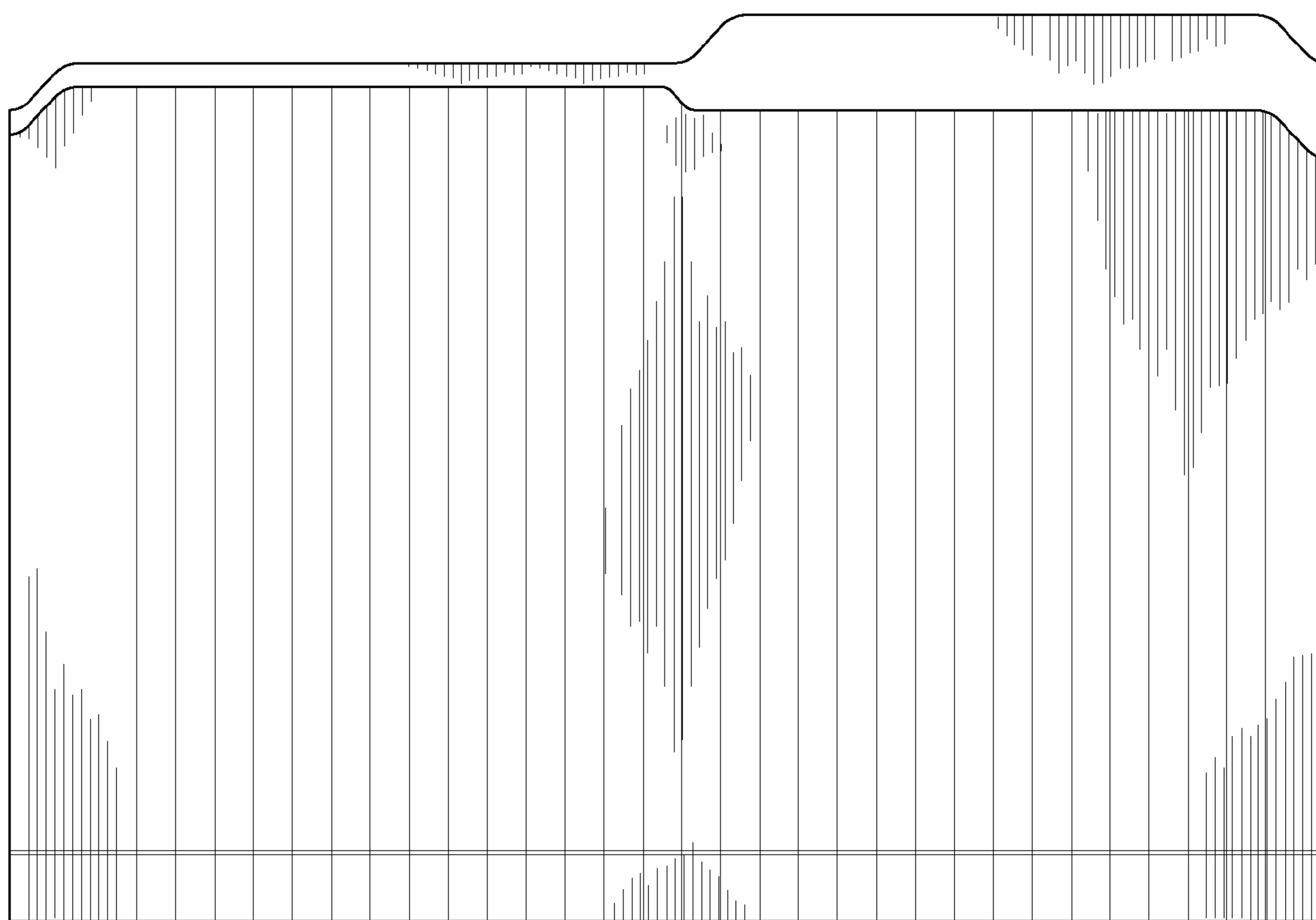

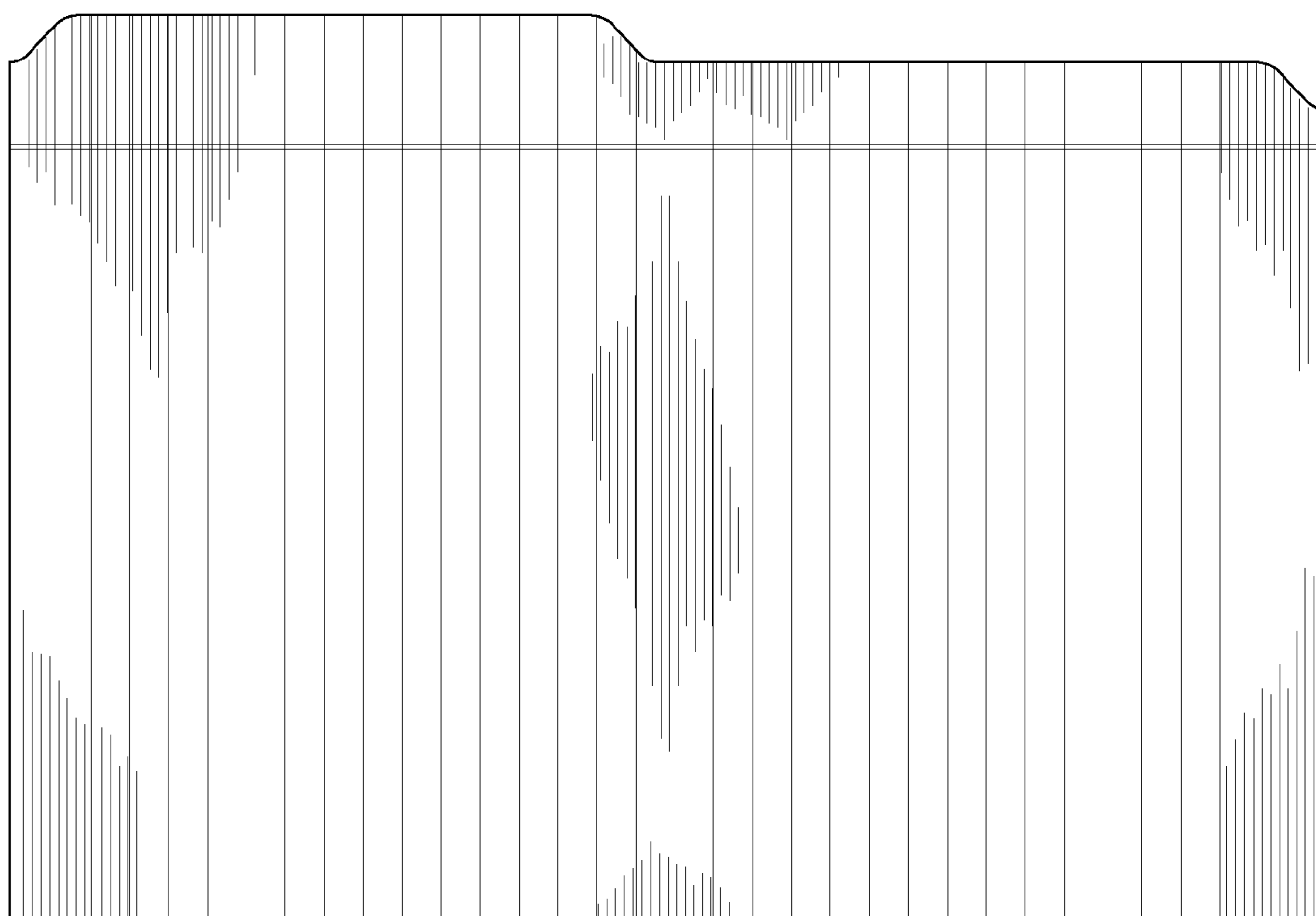

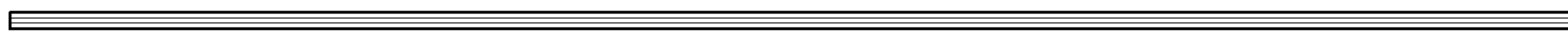

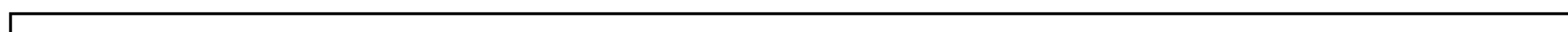
