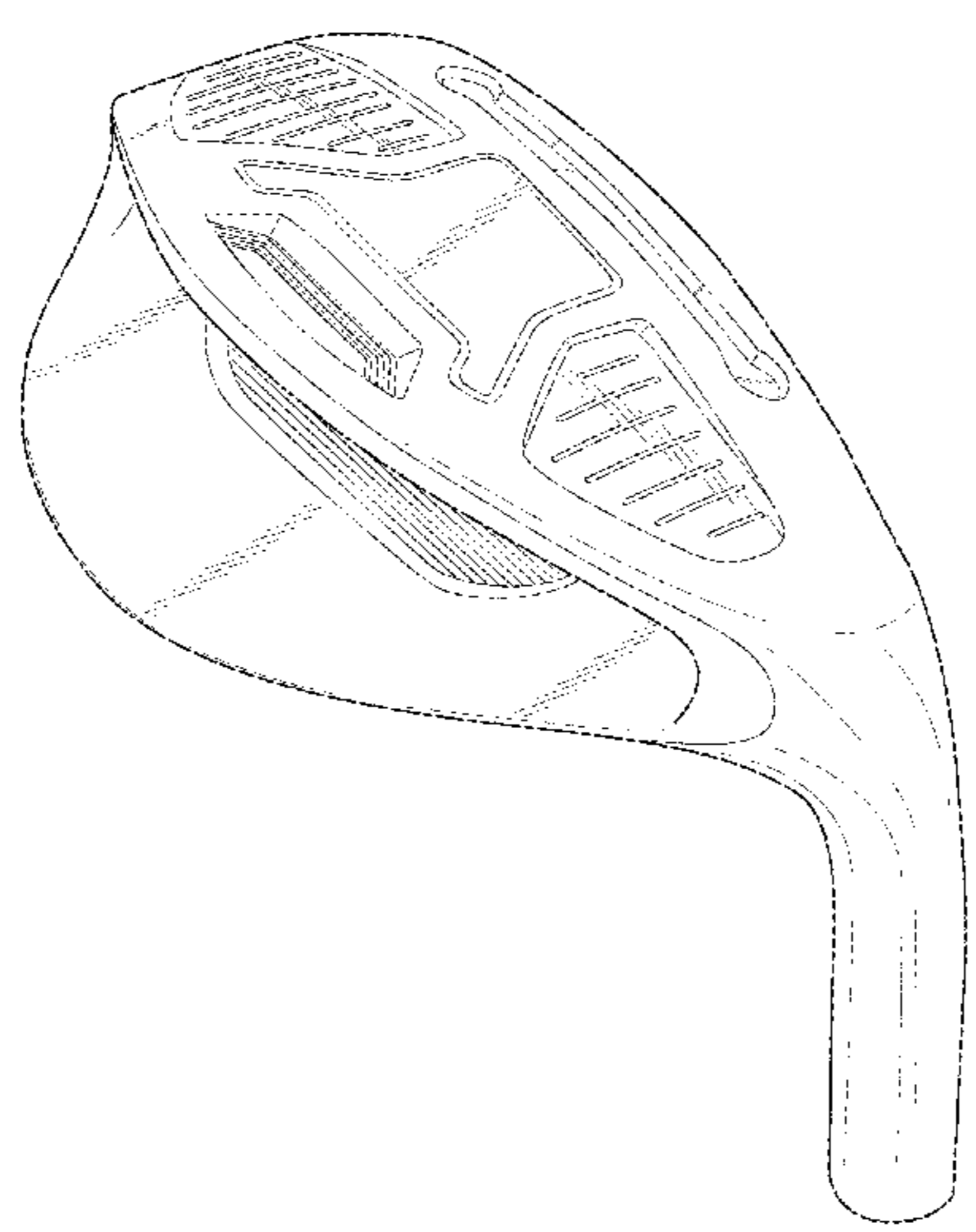

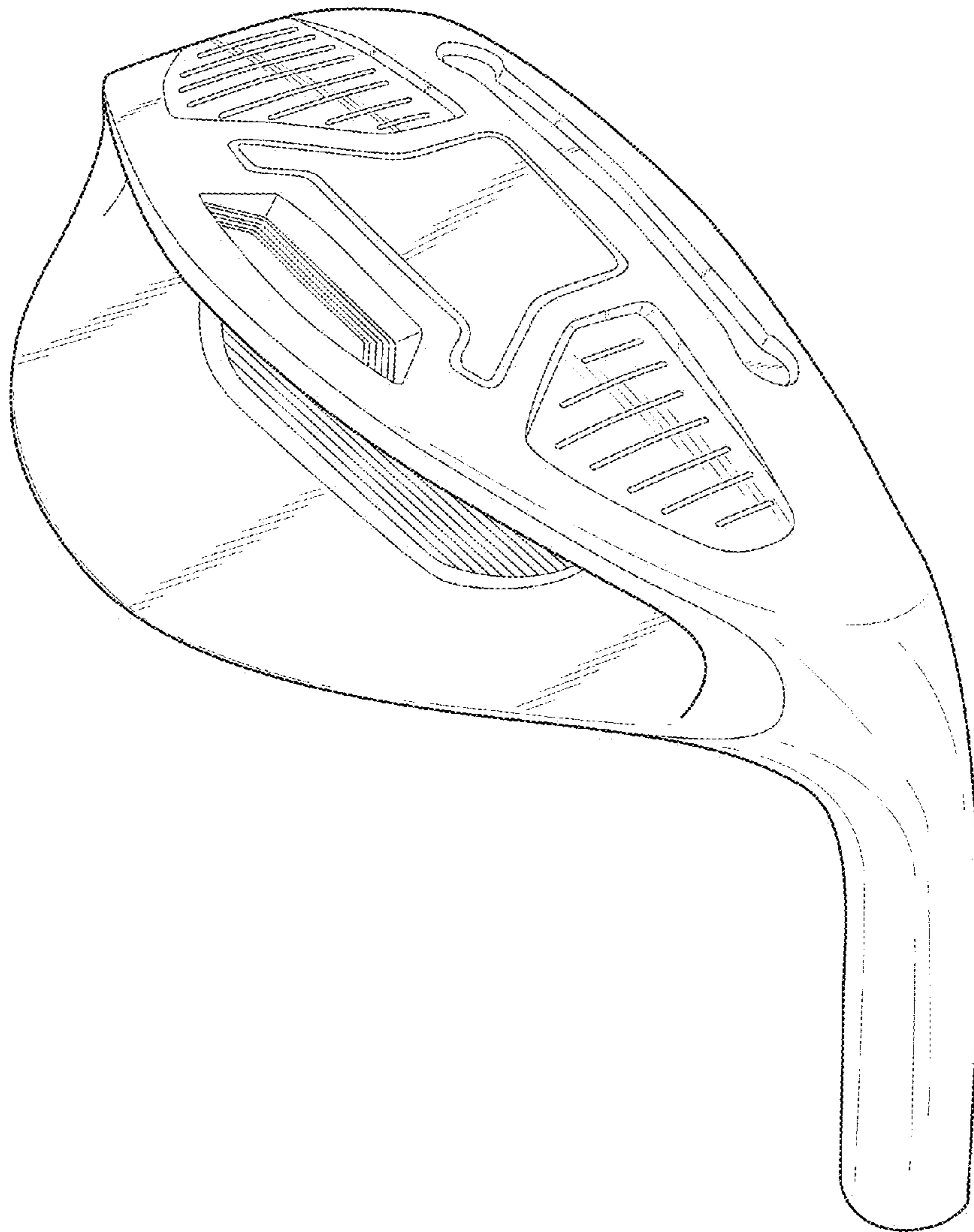
The ornamental design for a golf club, as shown and described.

**DESCRIPTION**

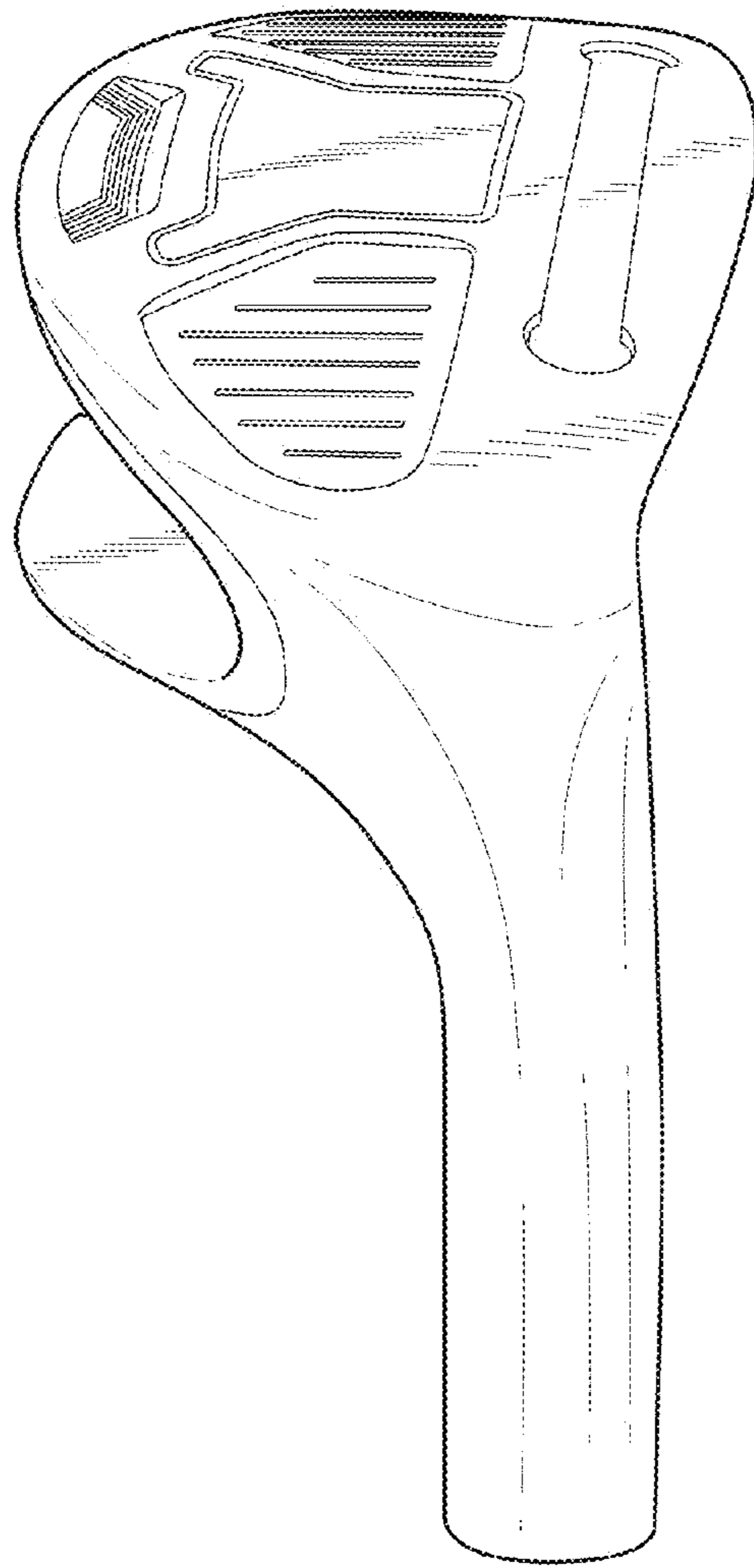
FIG. 1 is a right rear perspective view of a golf club;

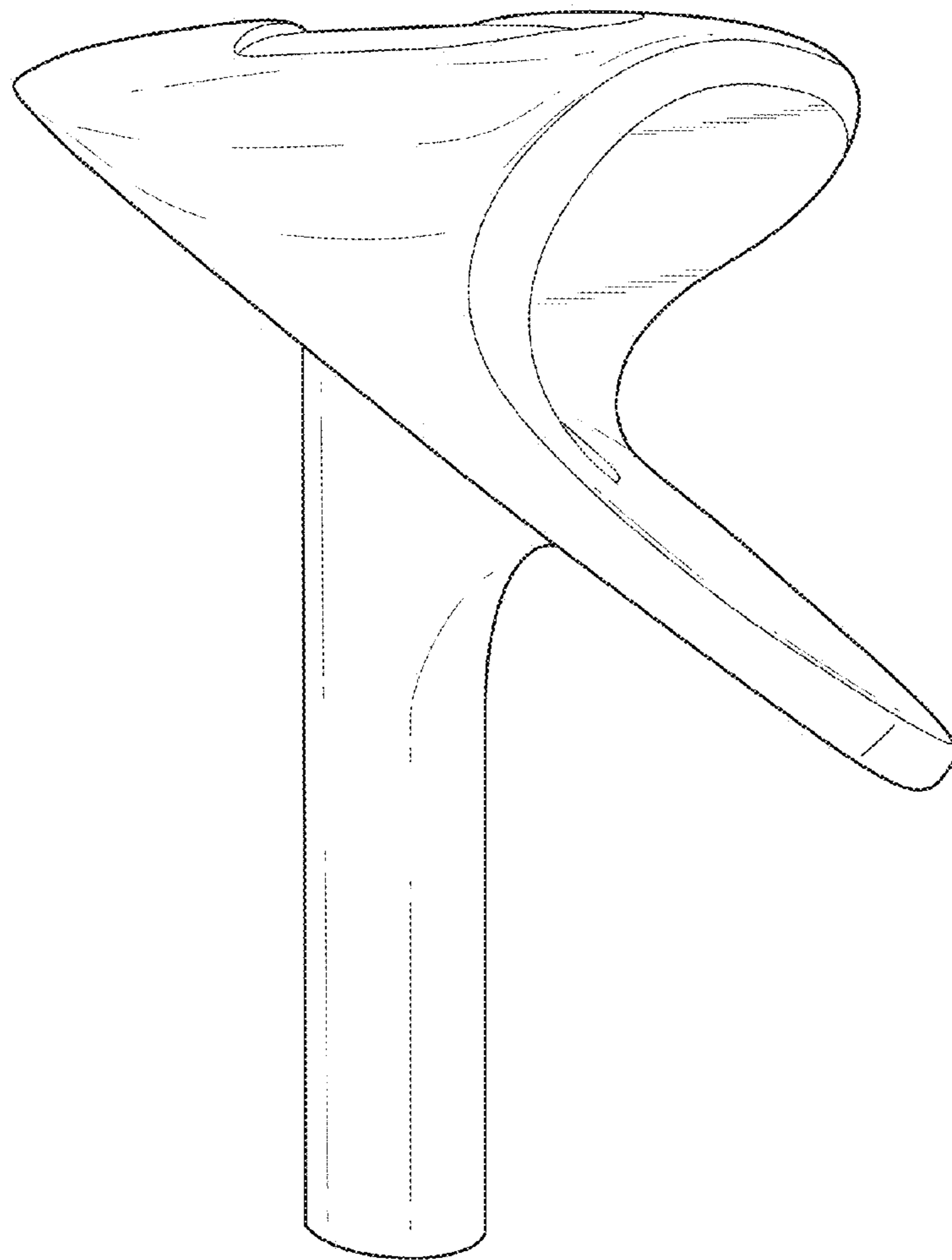




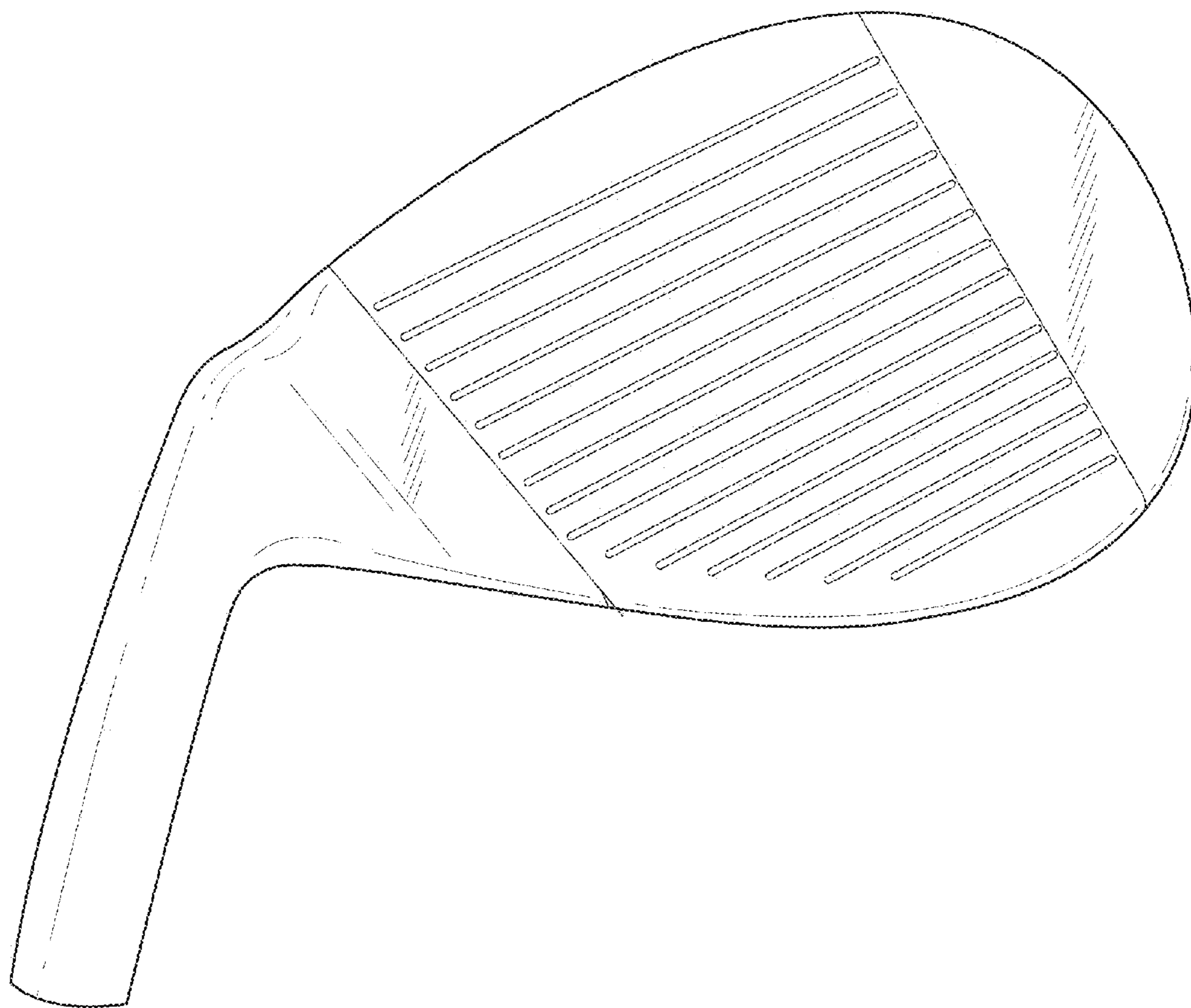

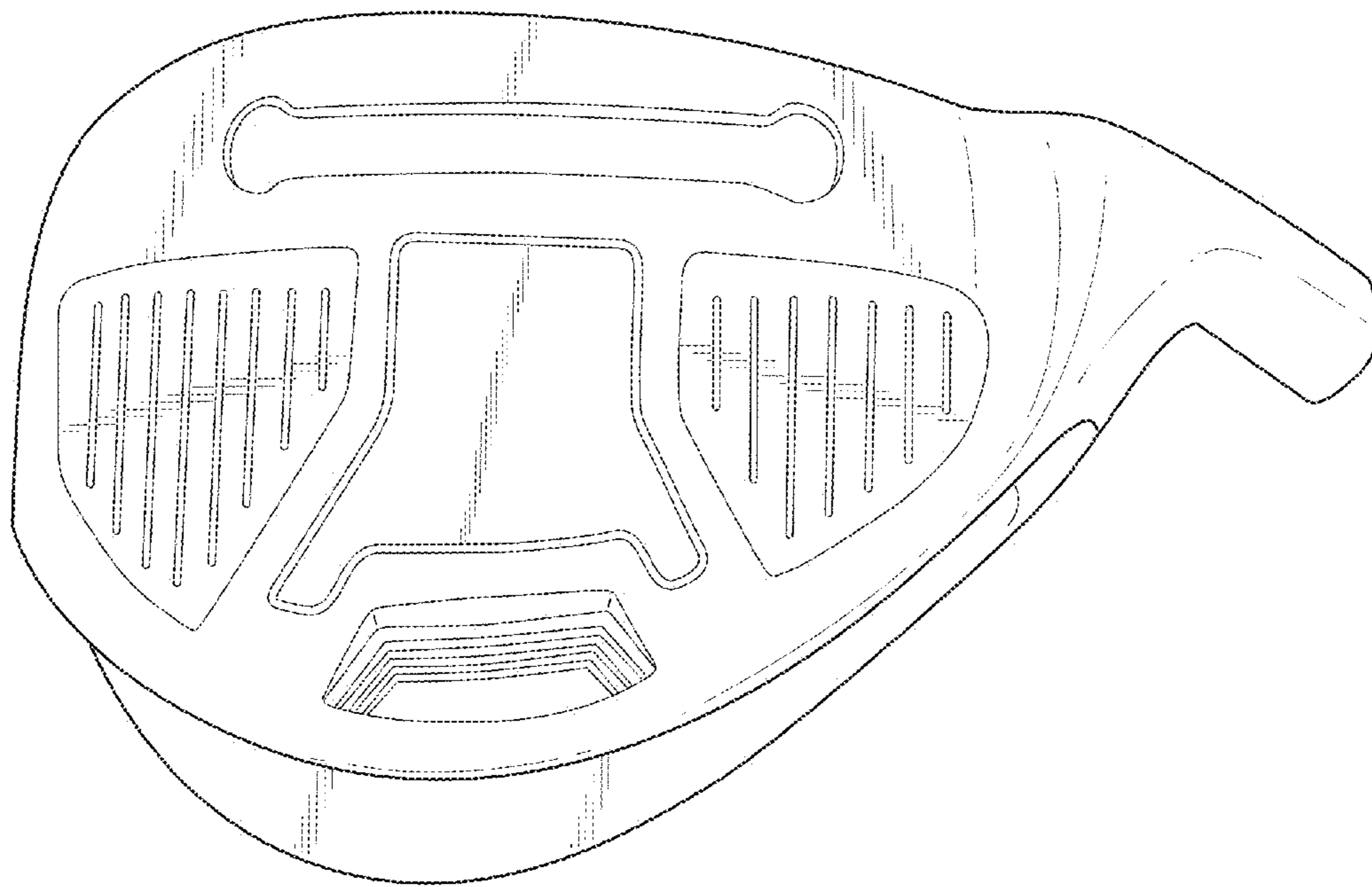

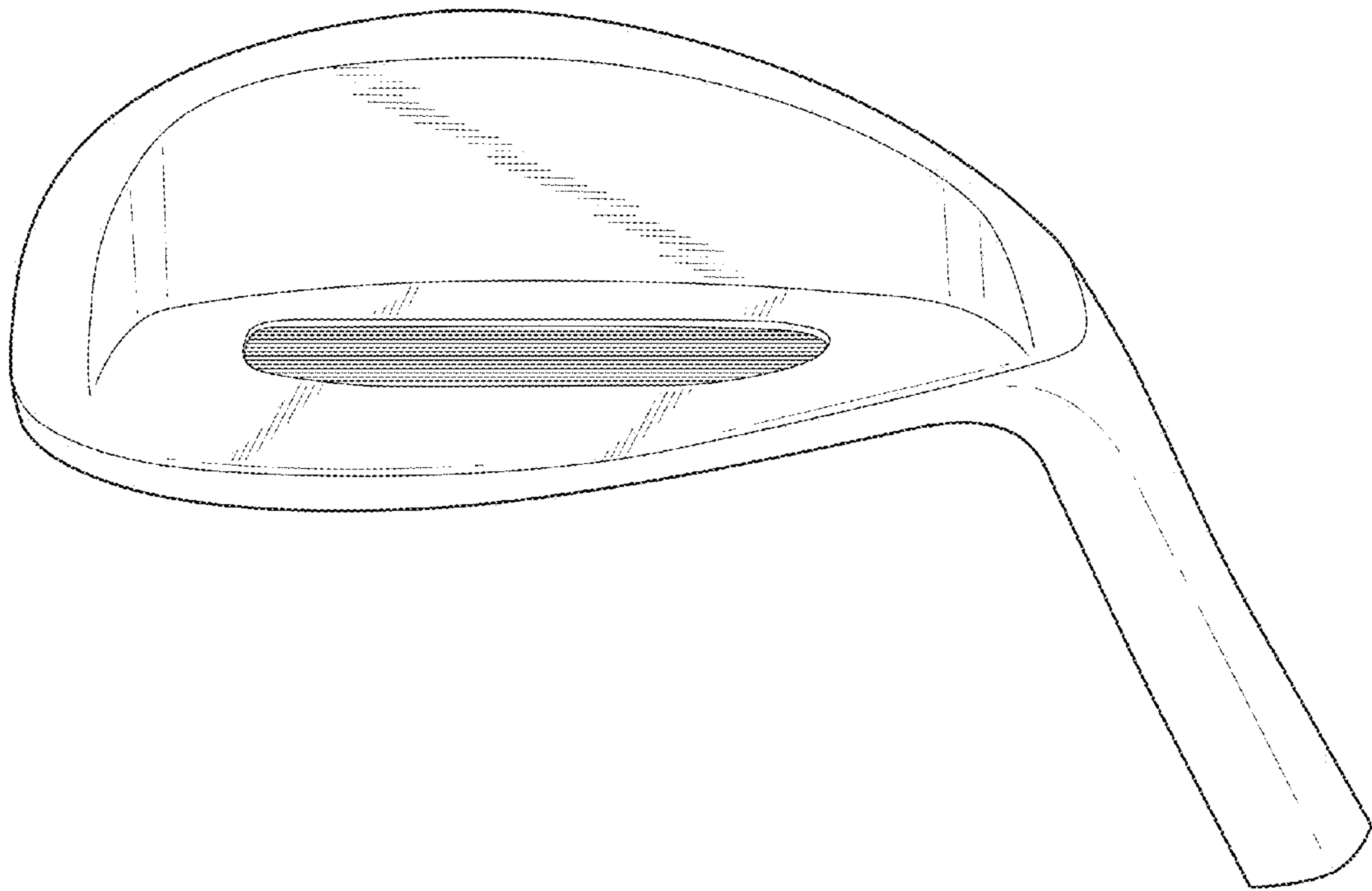

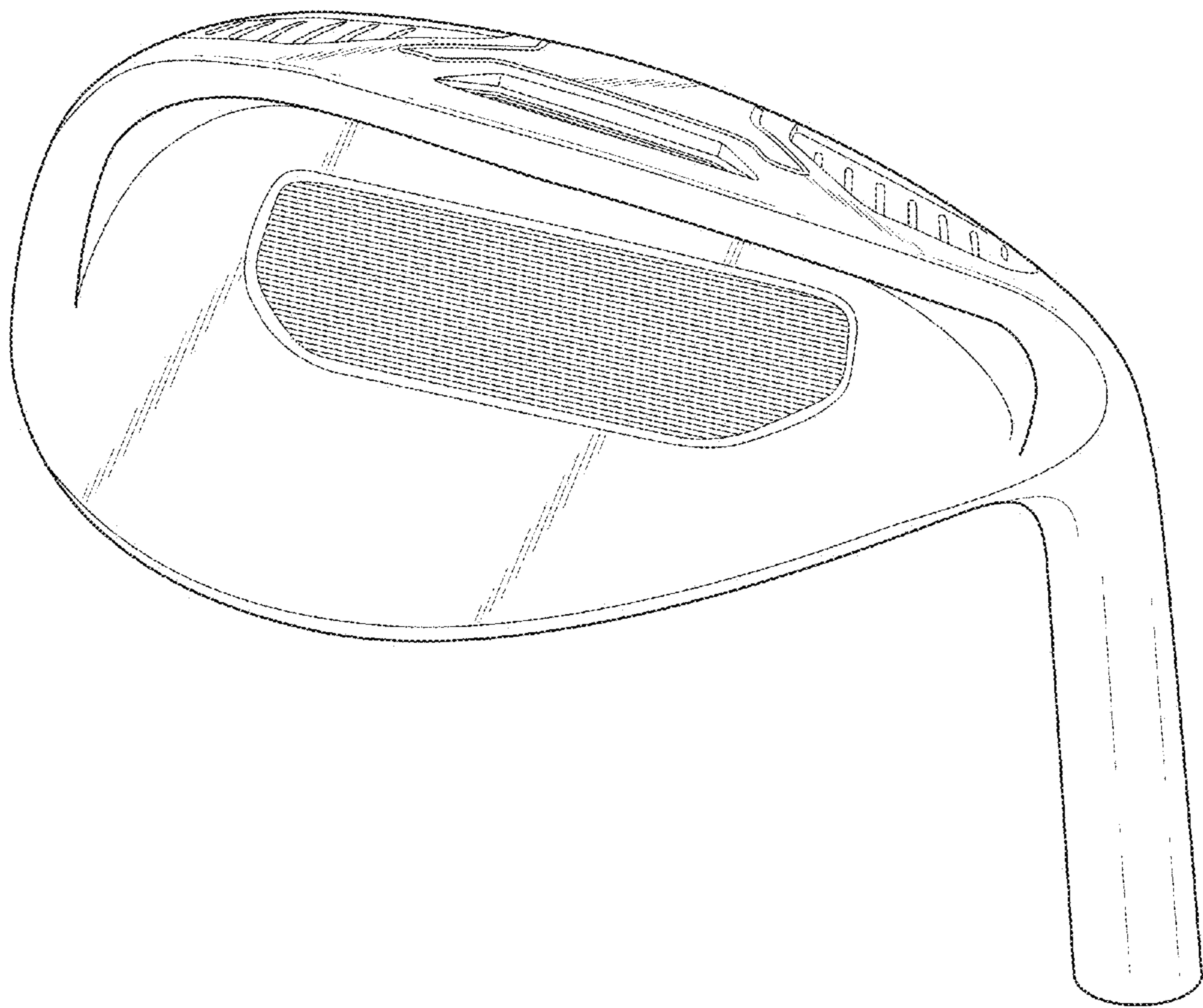
