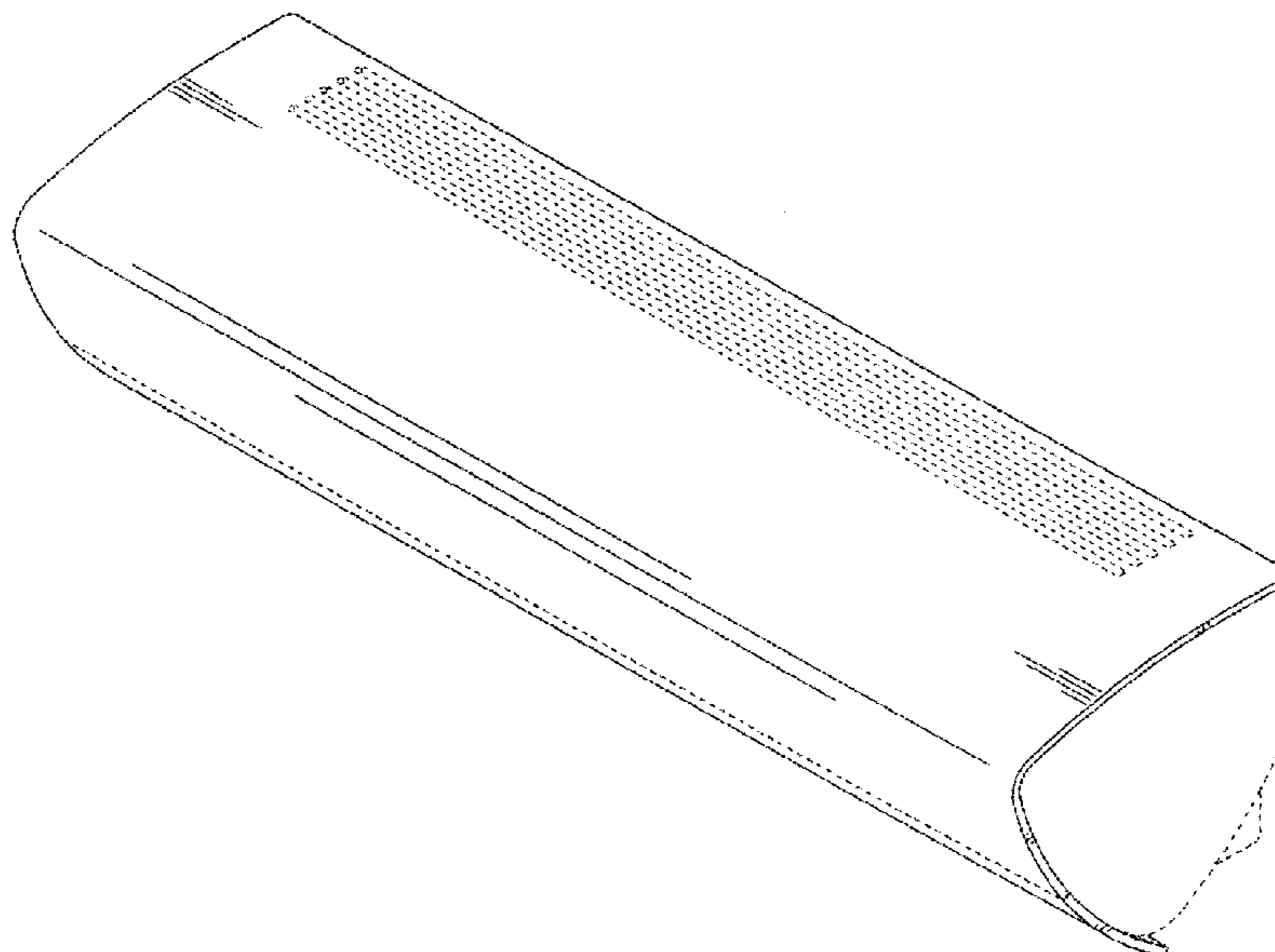
(57) **CLAIM**

We claim, the ornamental design for air conditioner, as shown and described.

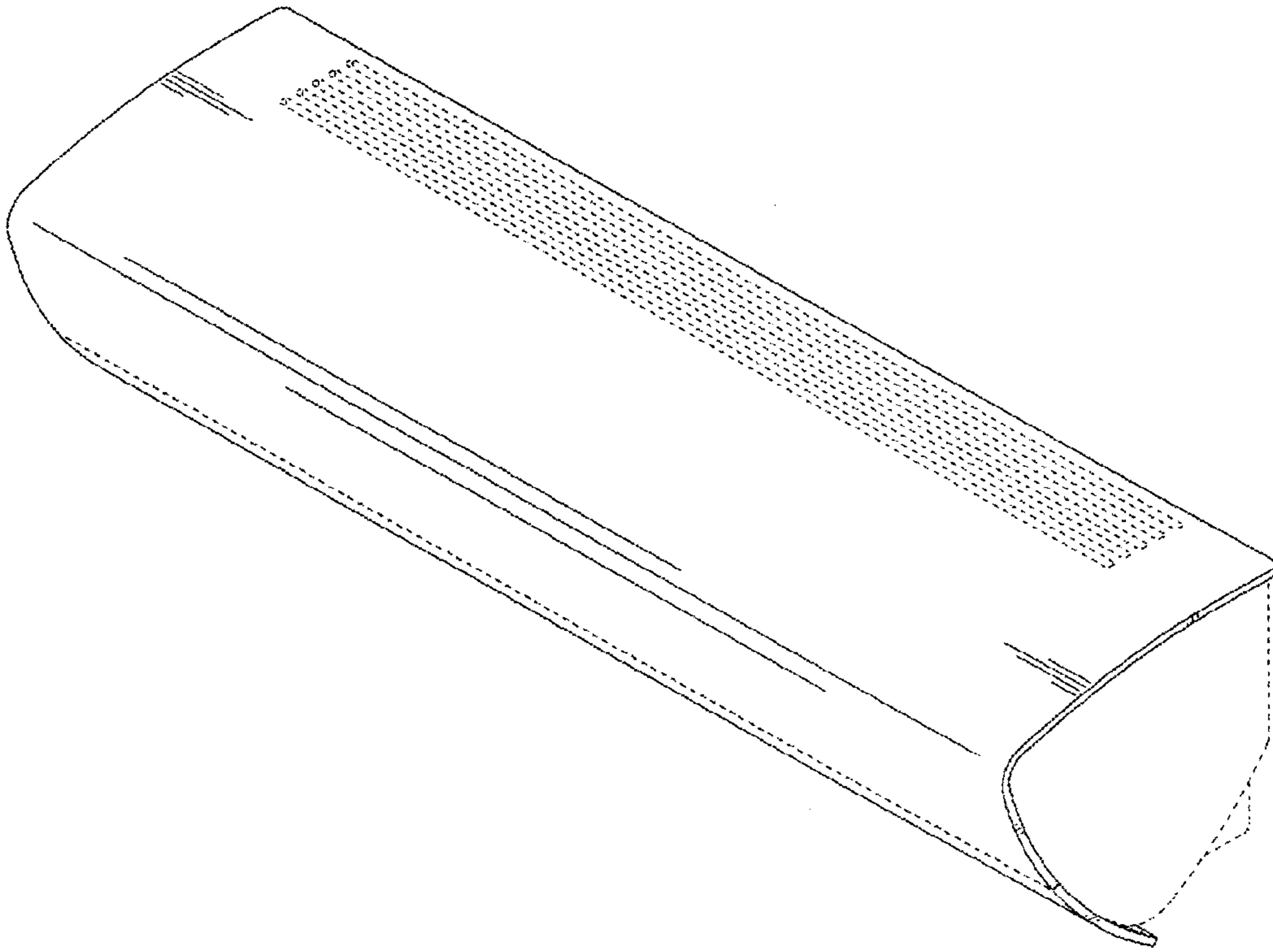
**DESCRIPTION**

The broken lines in the drawings illustrate portions of the air conditioner which form no part of the claimed design.

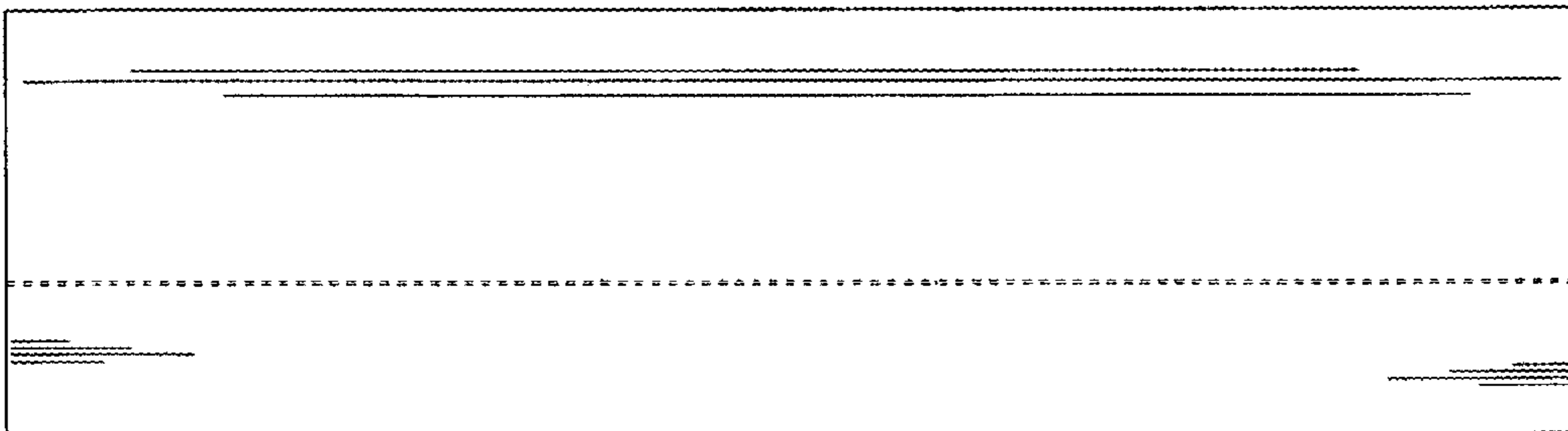

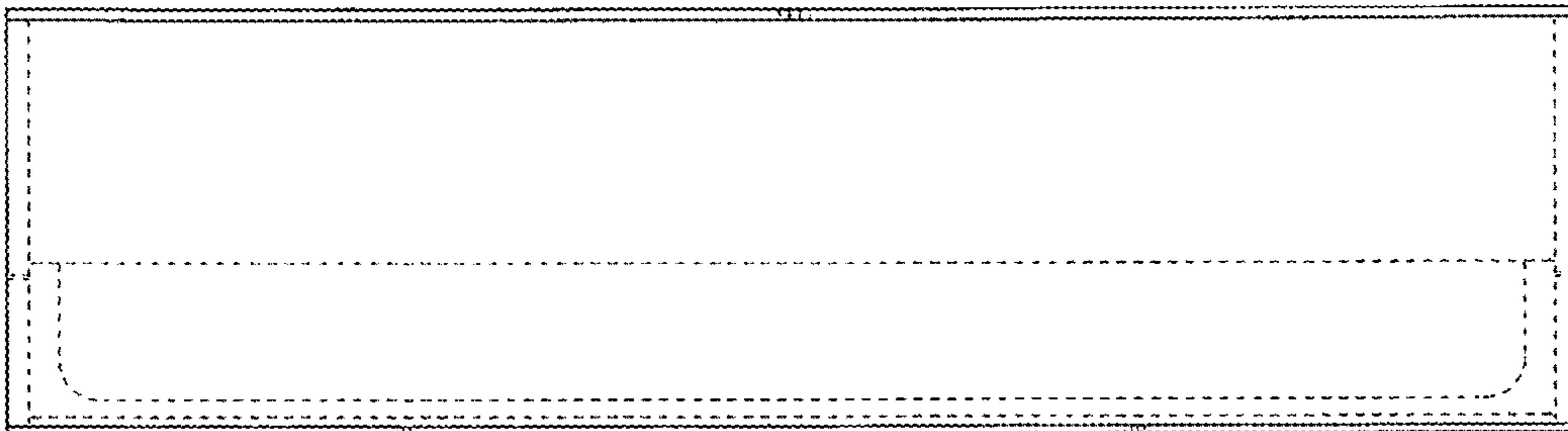

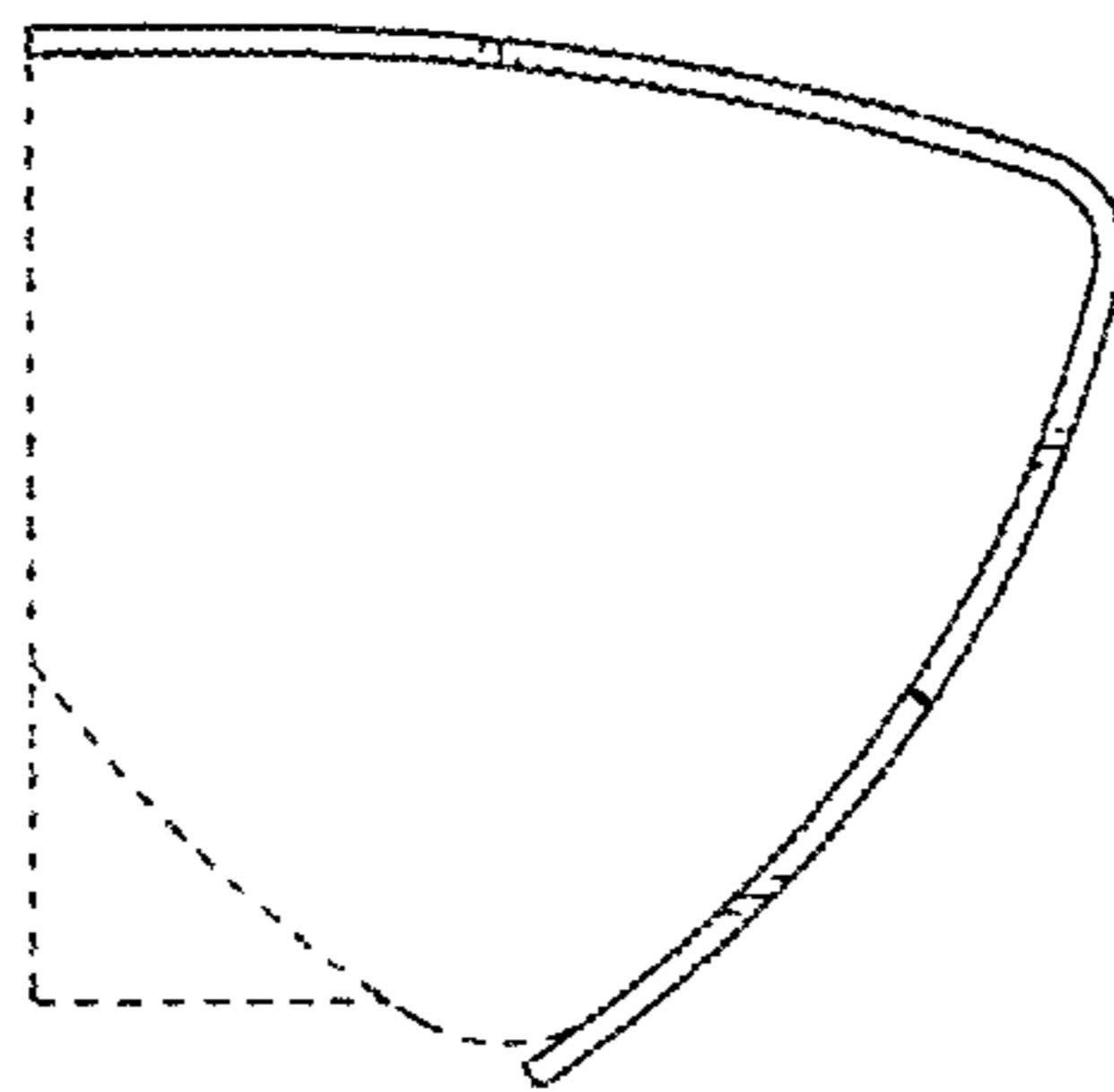

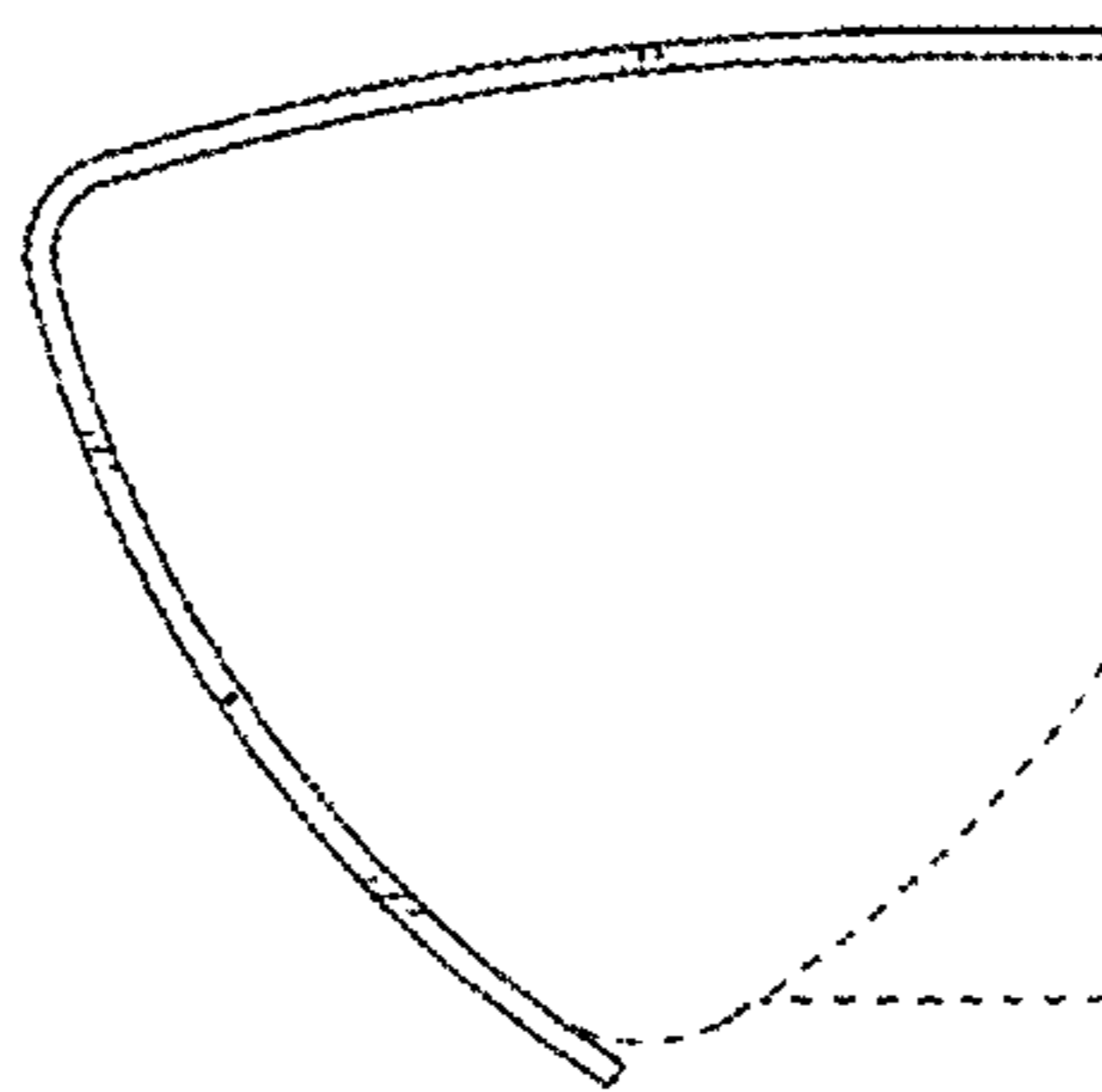

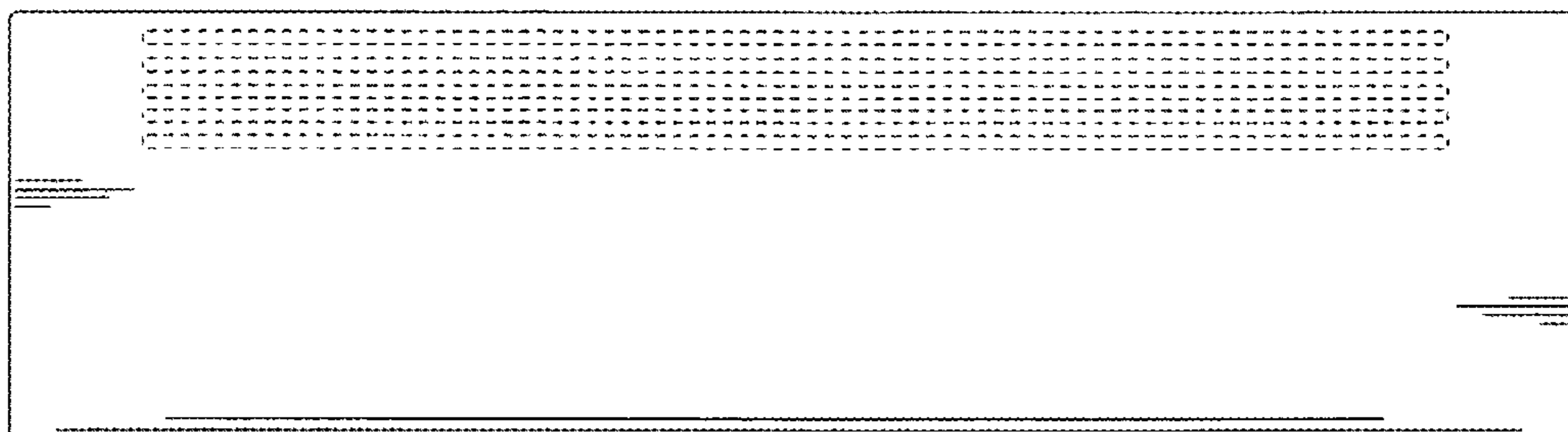
