DESCRIPTION

FIG. 1 is a front perspective view of the medical level device;

FIG. 2 is a top plan view of the medical level device of FIG. 1;

FIG. 3 is a bottom plan view of the medical level of FIG. 1; FIG. 4 is a front elevation view of the medical level device of FIG. 1;

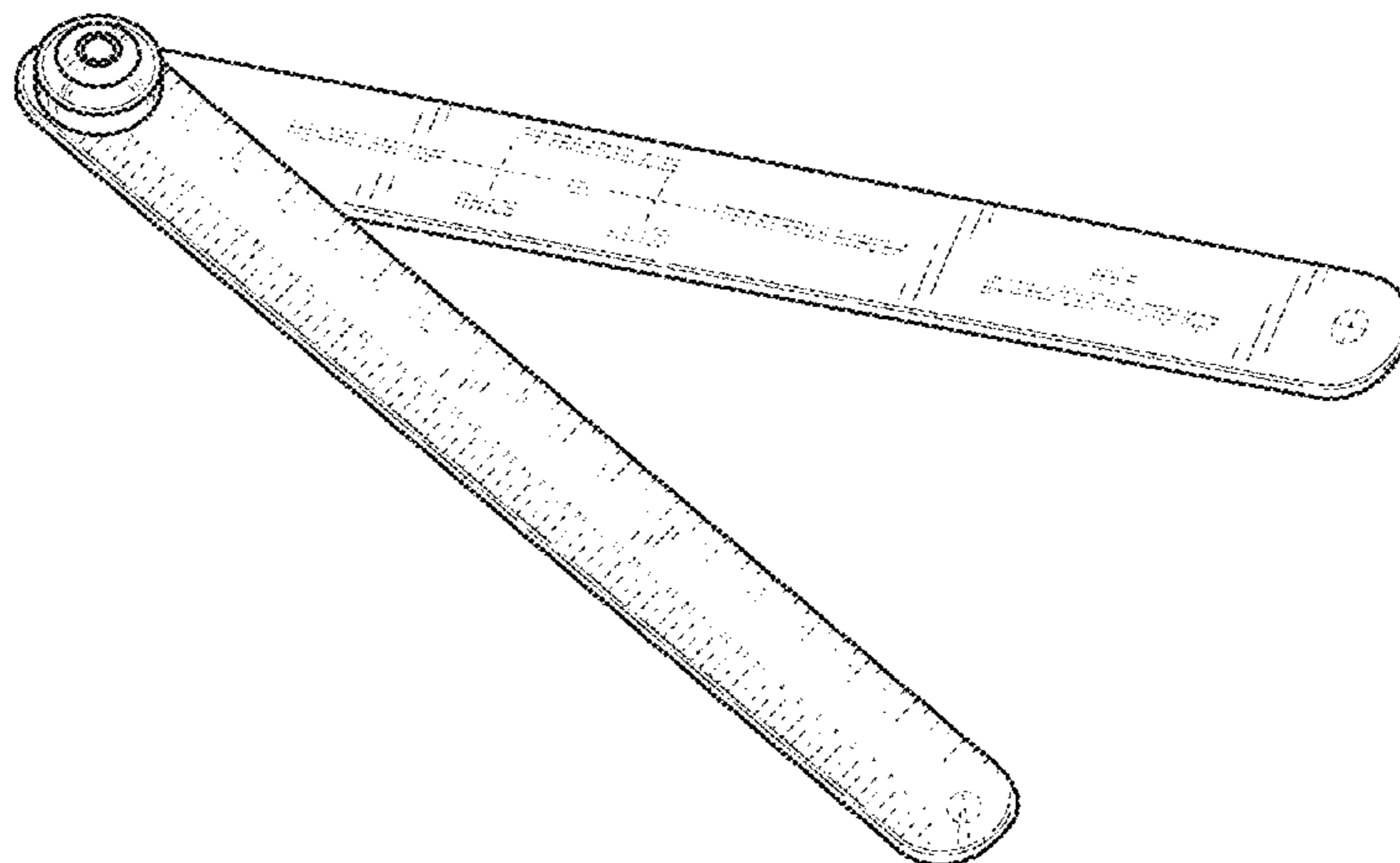
FIG. 5 is a rear elevation view of the medical level device of FIG. 1;

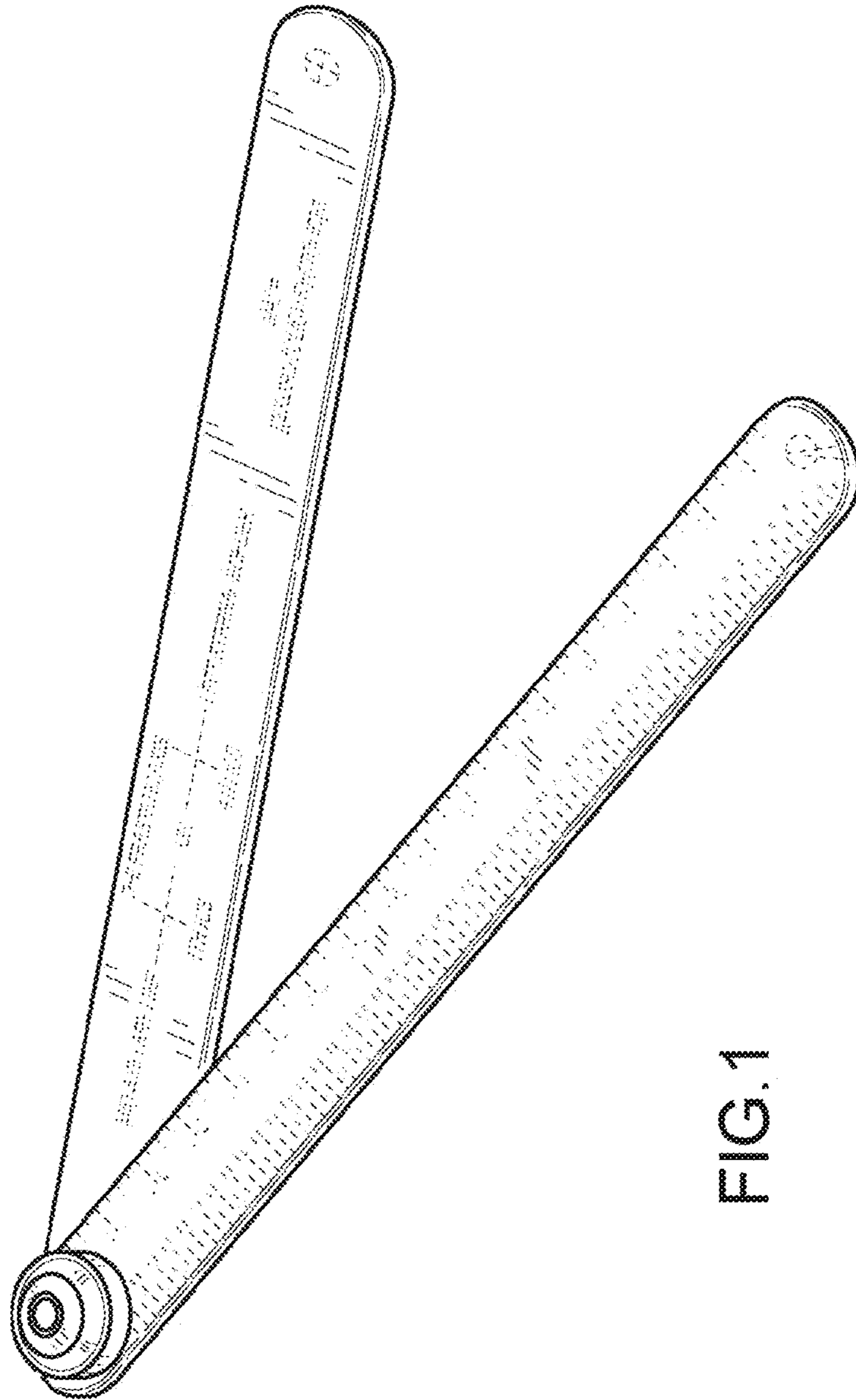

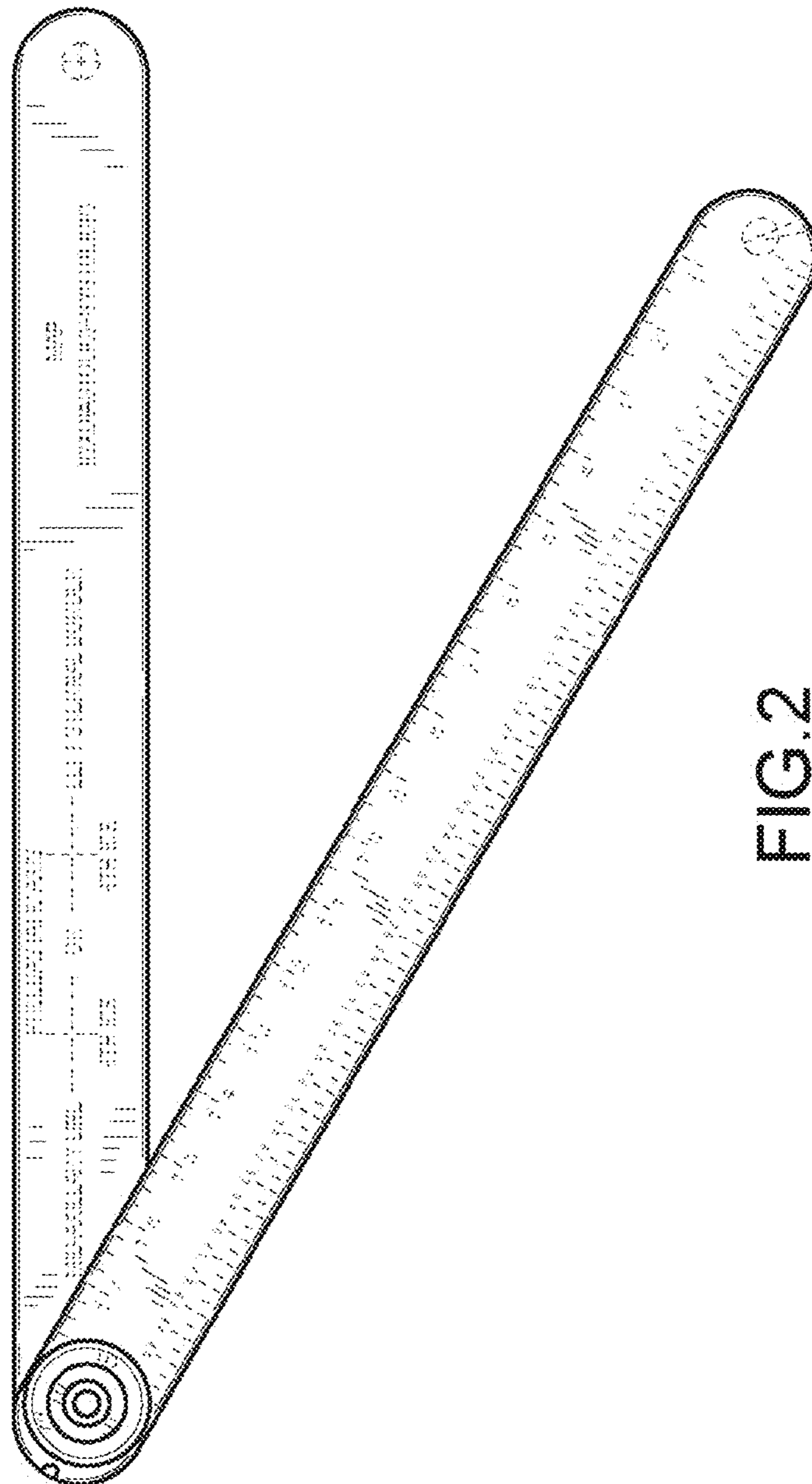

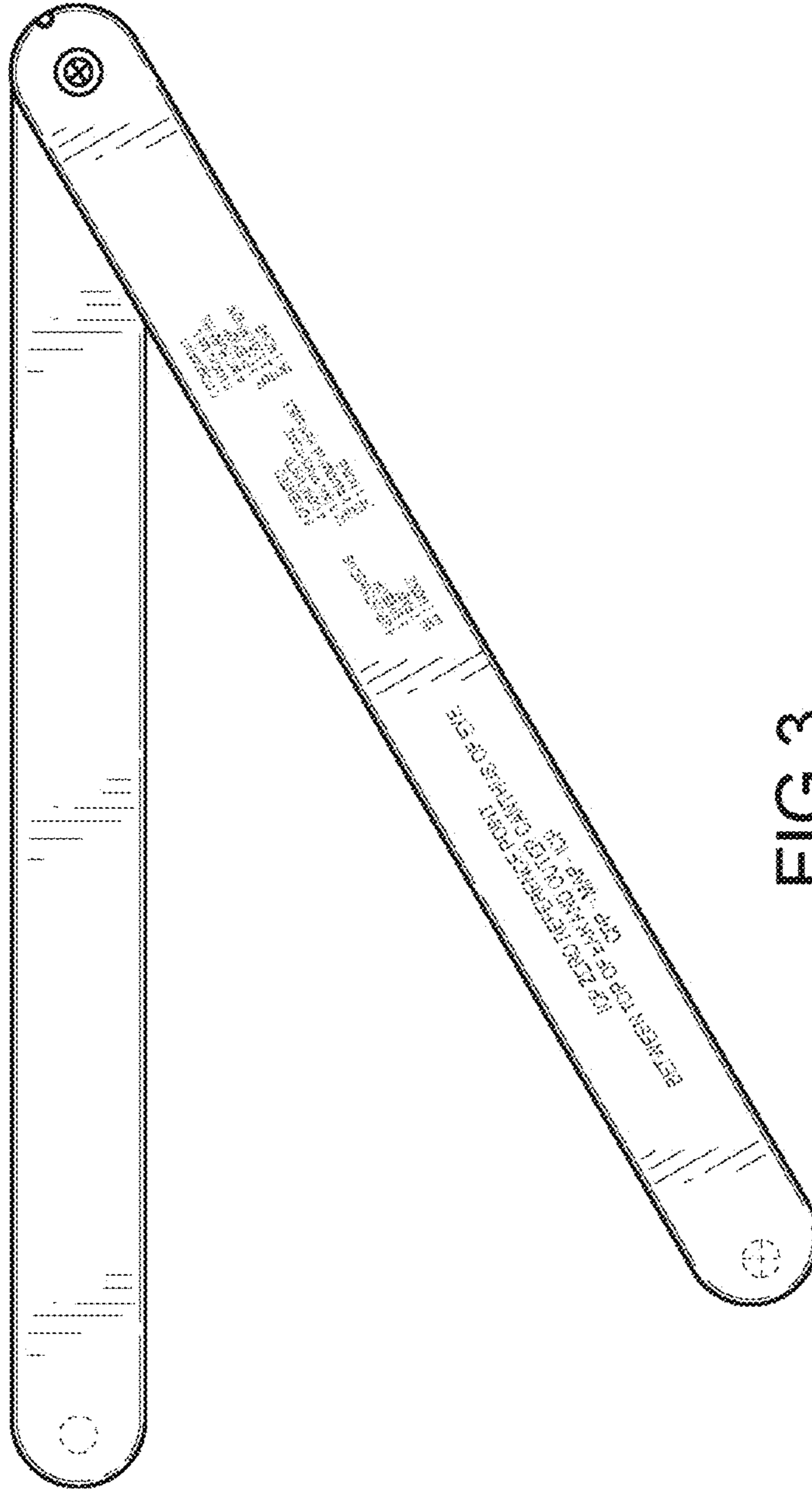

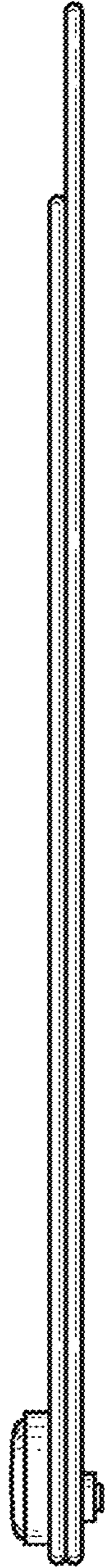

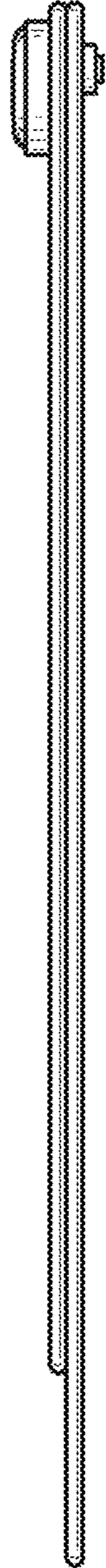

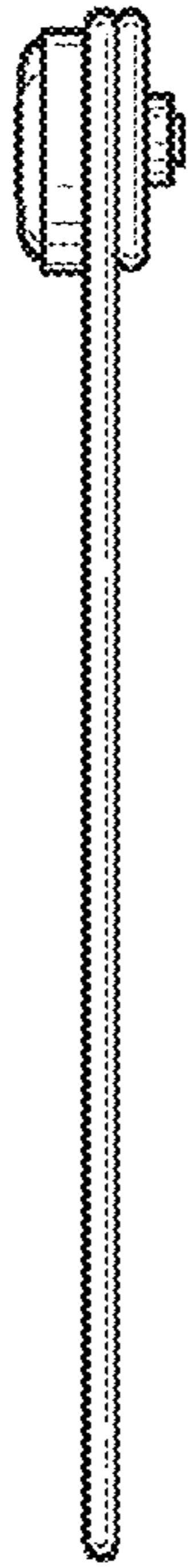

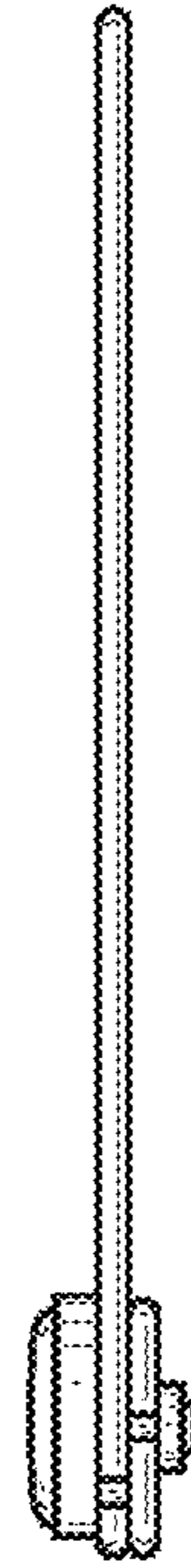
