(57) **CLAIM**

I claim the ornamental design for a compression wrist sleeve, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a compression wrist sleeve, as worn on the wrist of a user;

FIG. 2 is a front view of the compression wrist sleeve;

FIG. 3 is a rear view of the compression wrist sleeve;

FIG. 4 is a left side view of the compression wrist sleeve; and,

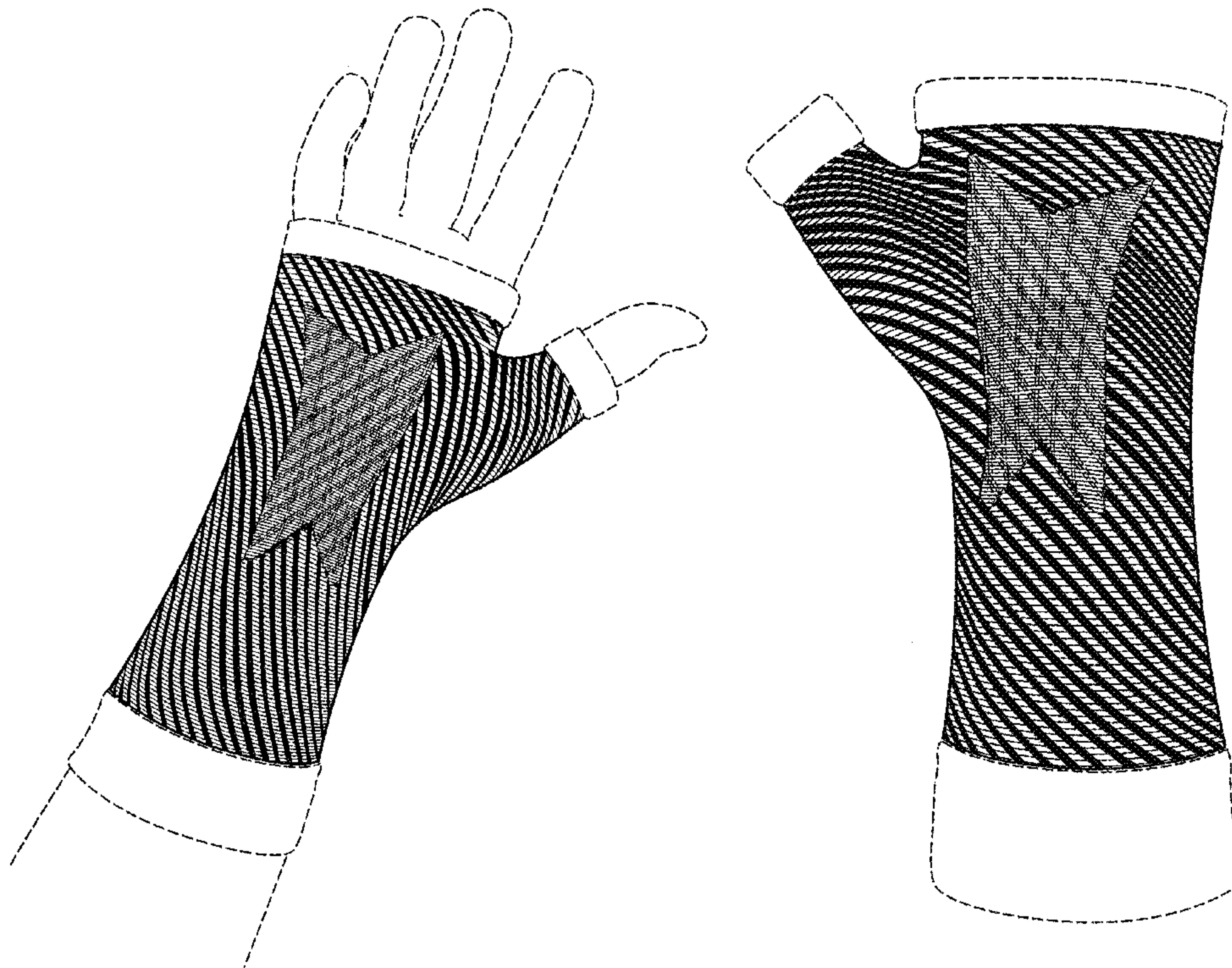
FIG. 5 is a right side view of the compression wrist sleeve. In FIG. 1, the broken line showing of a human hand is for the purpose of showing environment which forms no part of the claim. The broken line showing on the compression wrist sleeve is for the purpose of illustrating portions of the sleeve which form no part of the claim. The patterns on the sleeve represent claimed yarn and thread contrast.

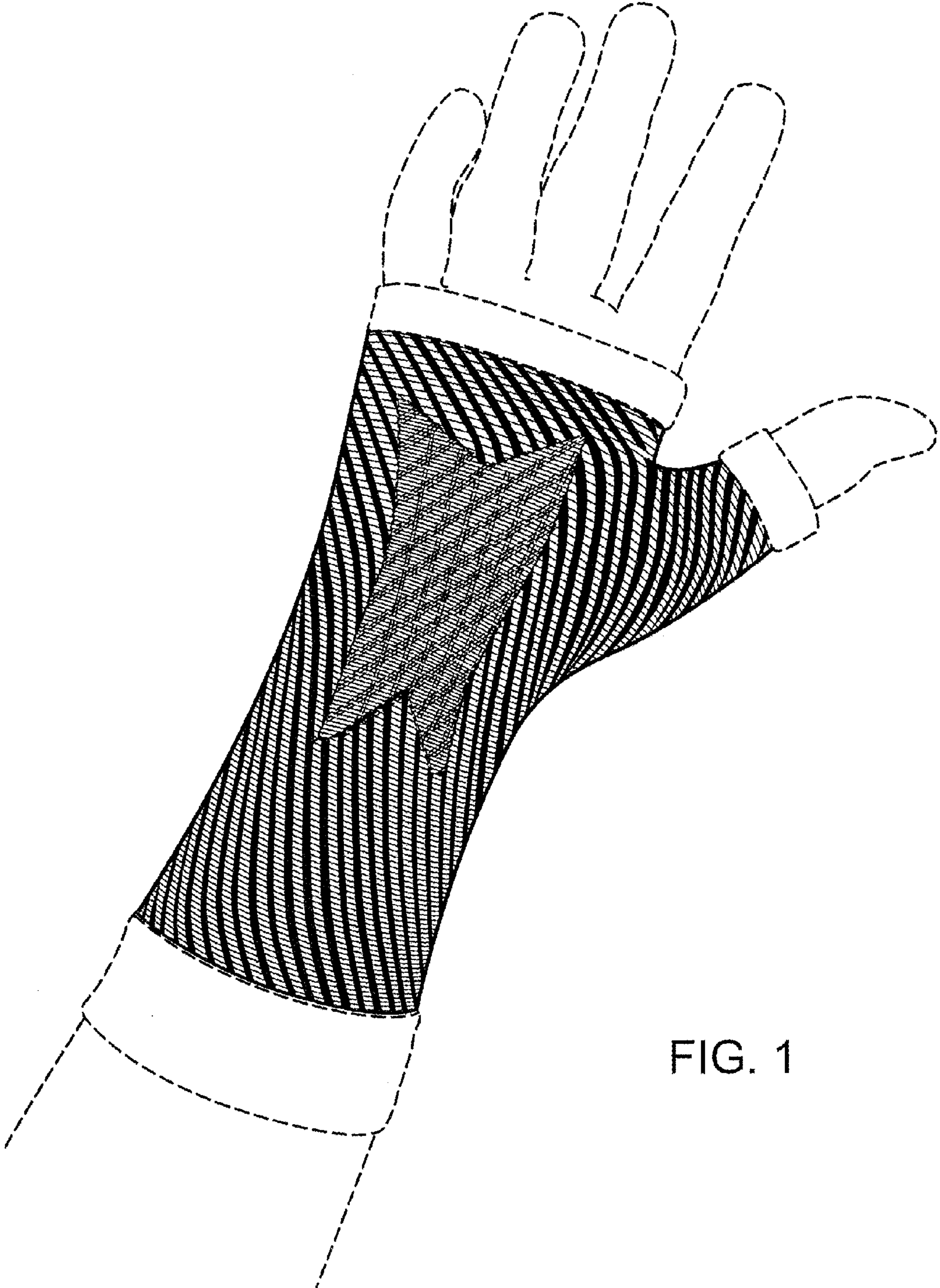

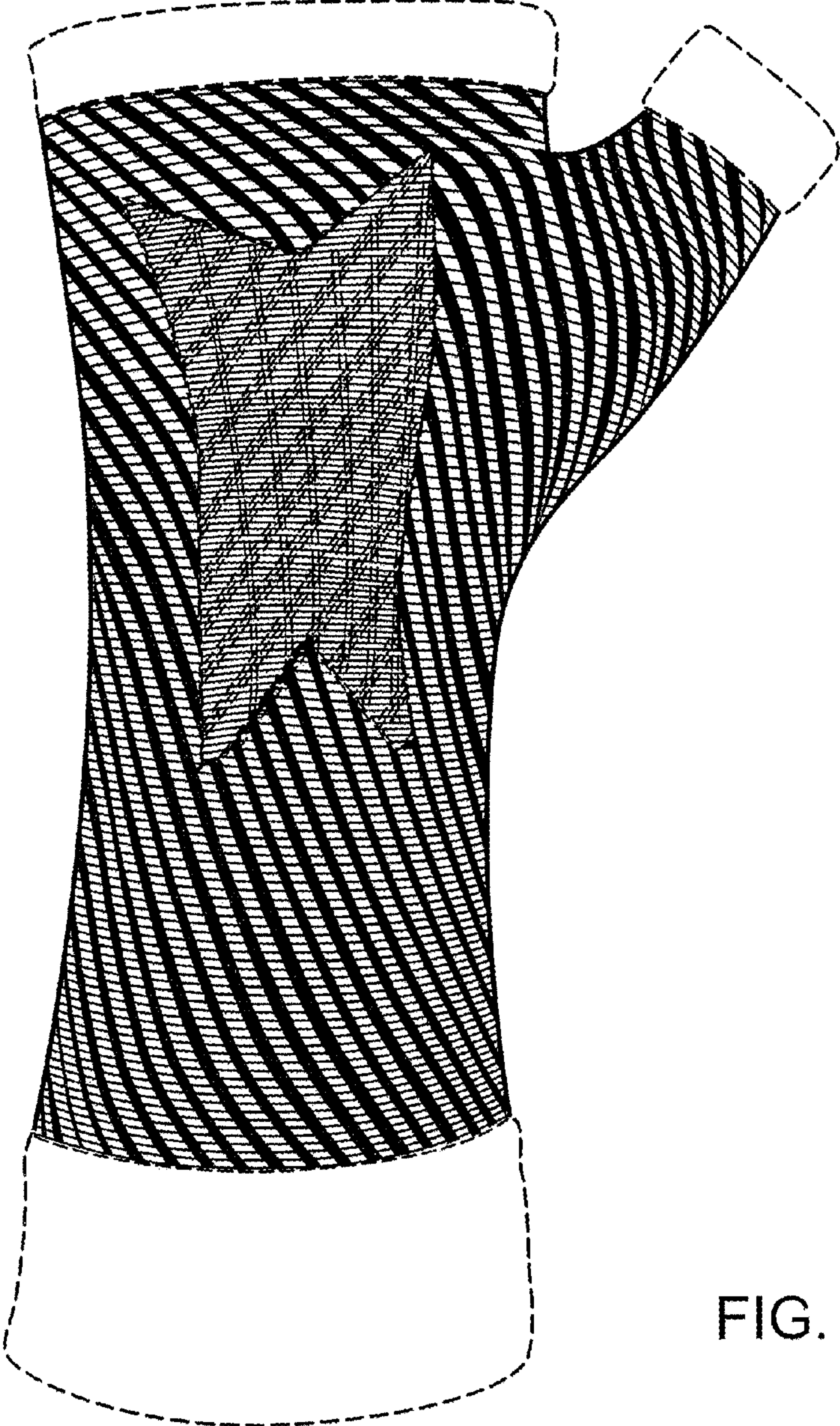

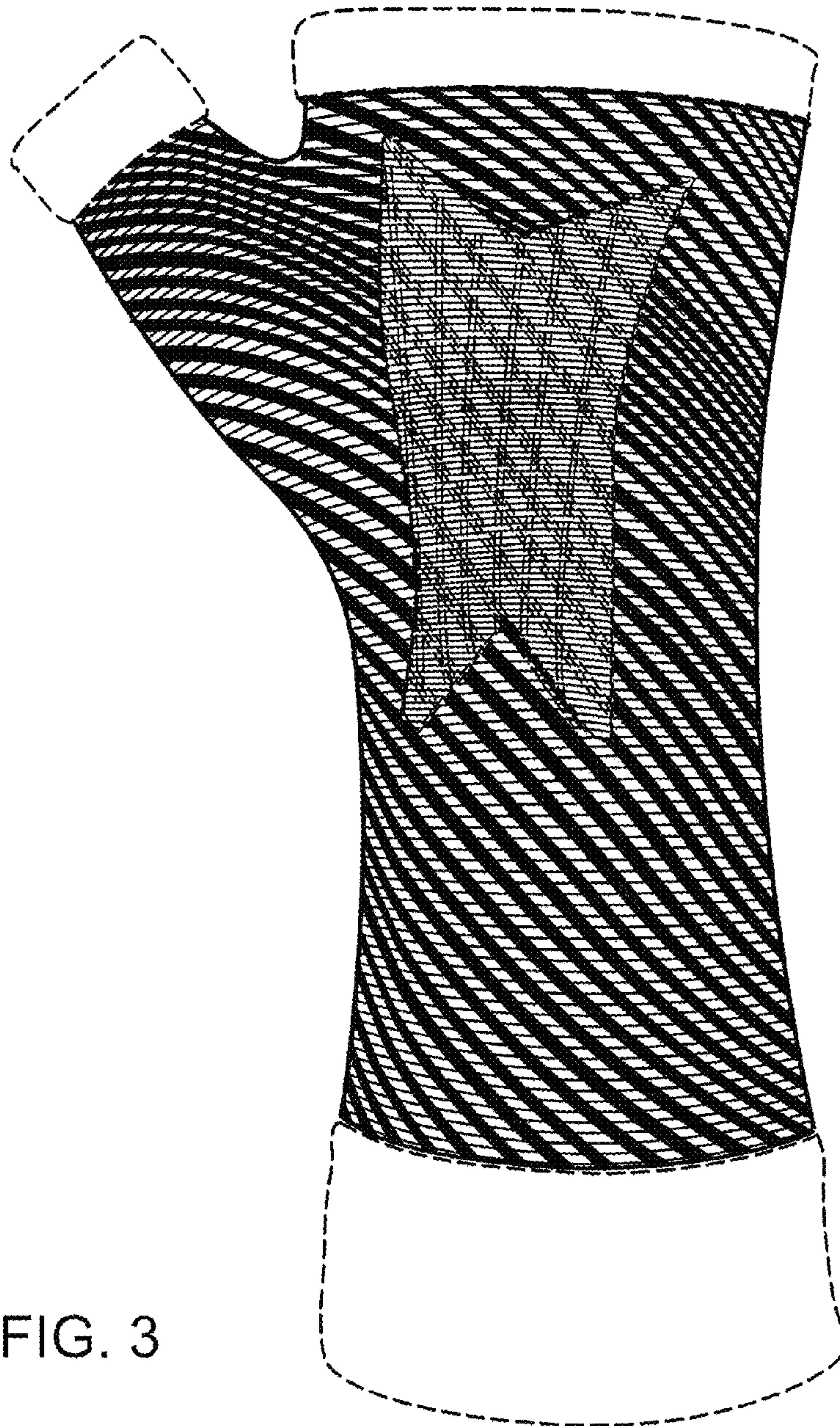

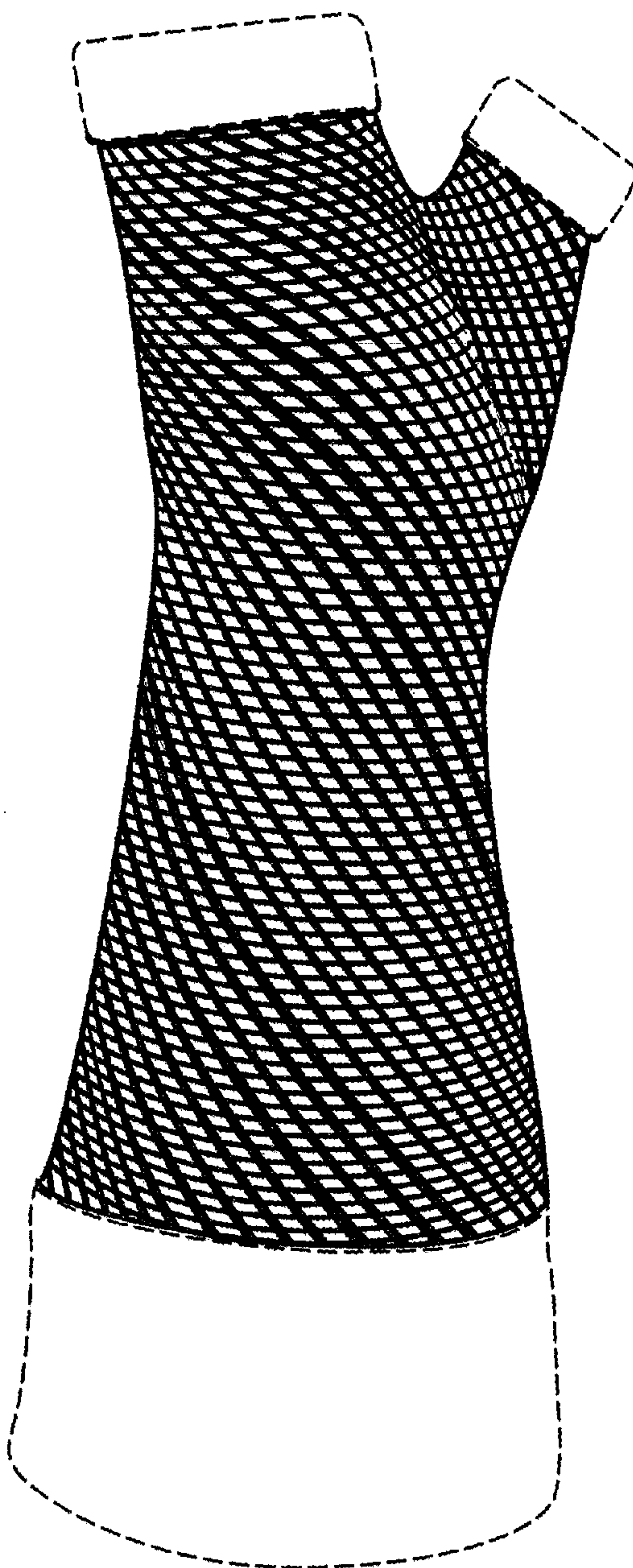

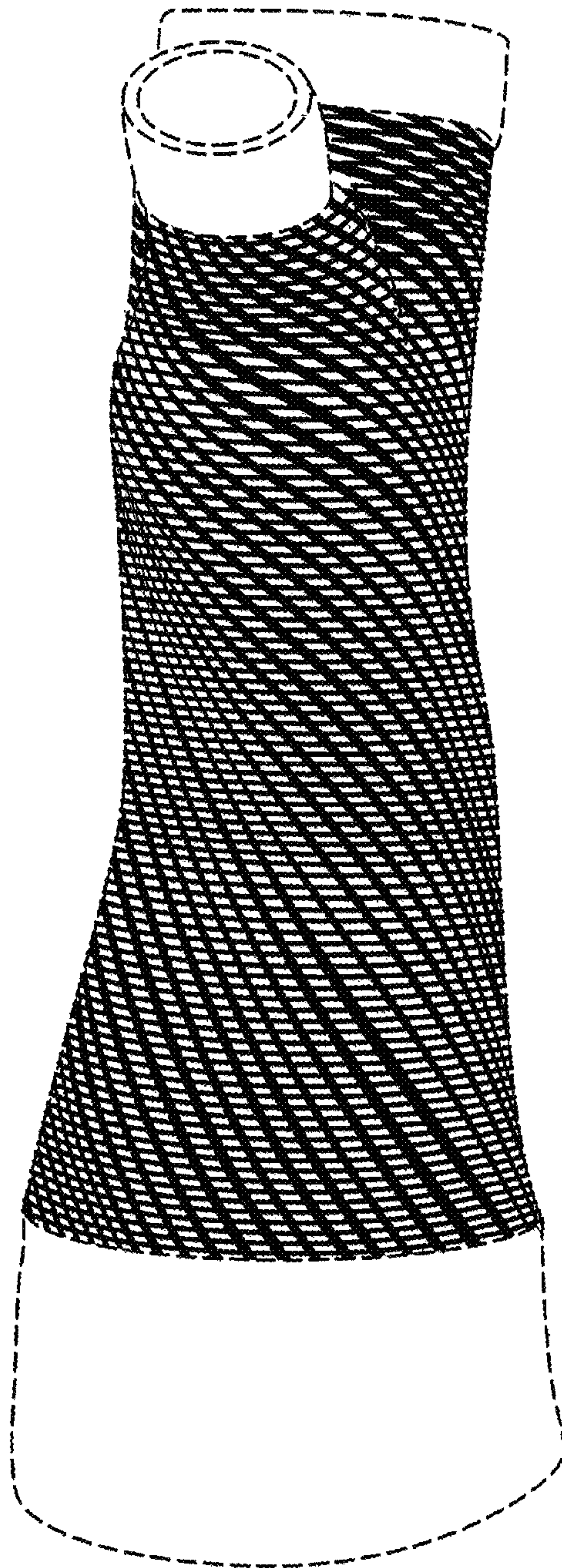
