(57) **CLAIM**

The ornamental design for a headlamp for a motorcycle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from a front and left side of a headlamp for a motorcycle;
FIG. 2 is a perspective view from a rear and left side thereof;
FIG. 3 is a perspective view from a front and right side thereof;
FIG. 4 is a perspective view from a rear and right side thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a front view thereof;
FIG. 8 is a rear view thereof;
FIG. 9 is a top plan view thereof;
FIG. 10 is a bottom plan view thereof;
FIG. 11 is an enlarged front view; and,

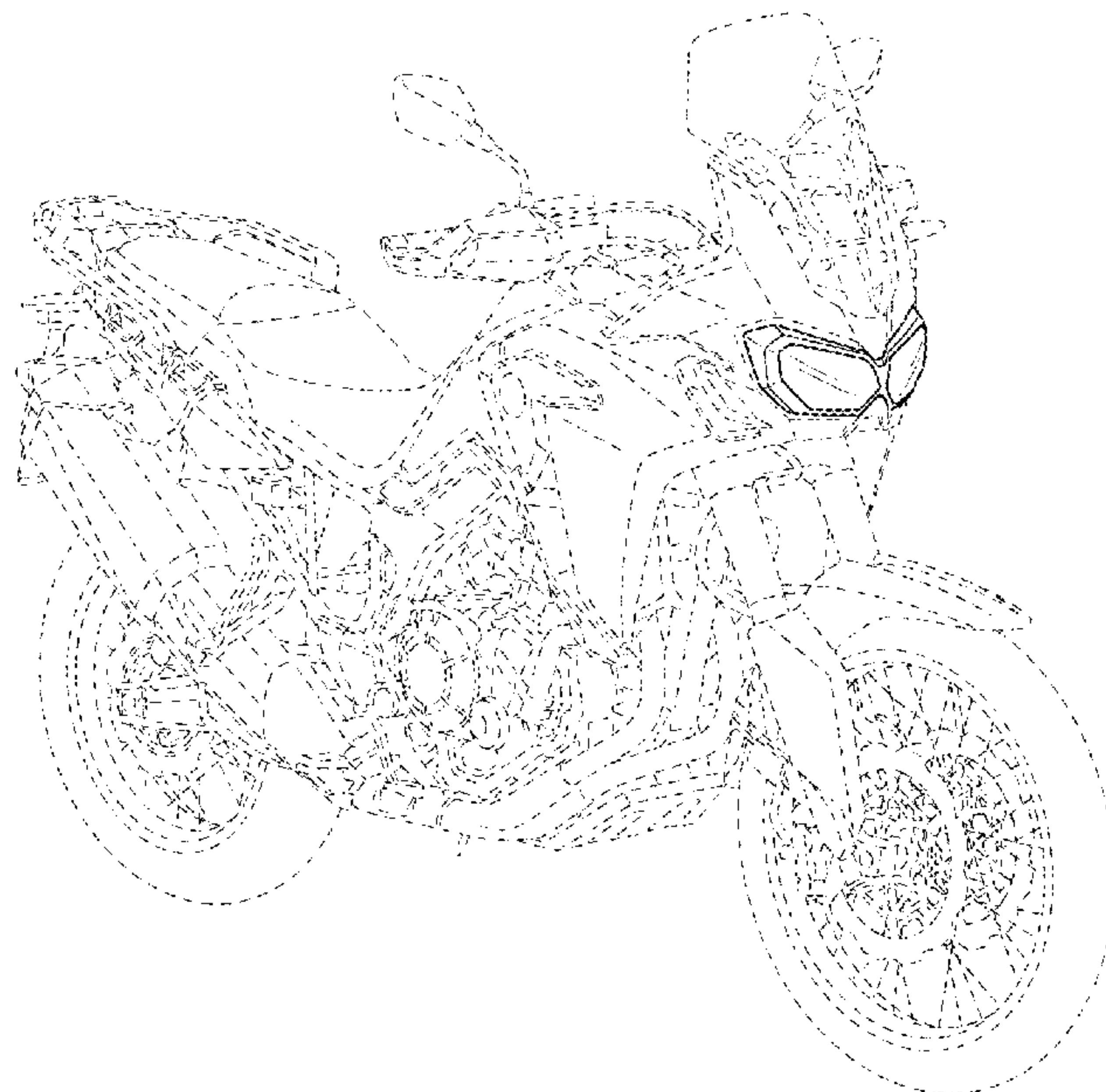

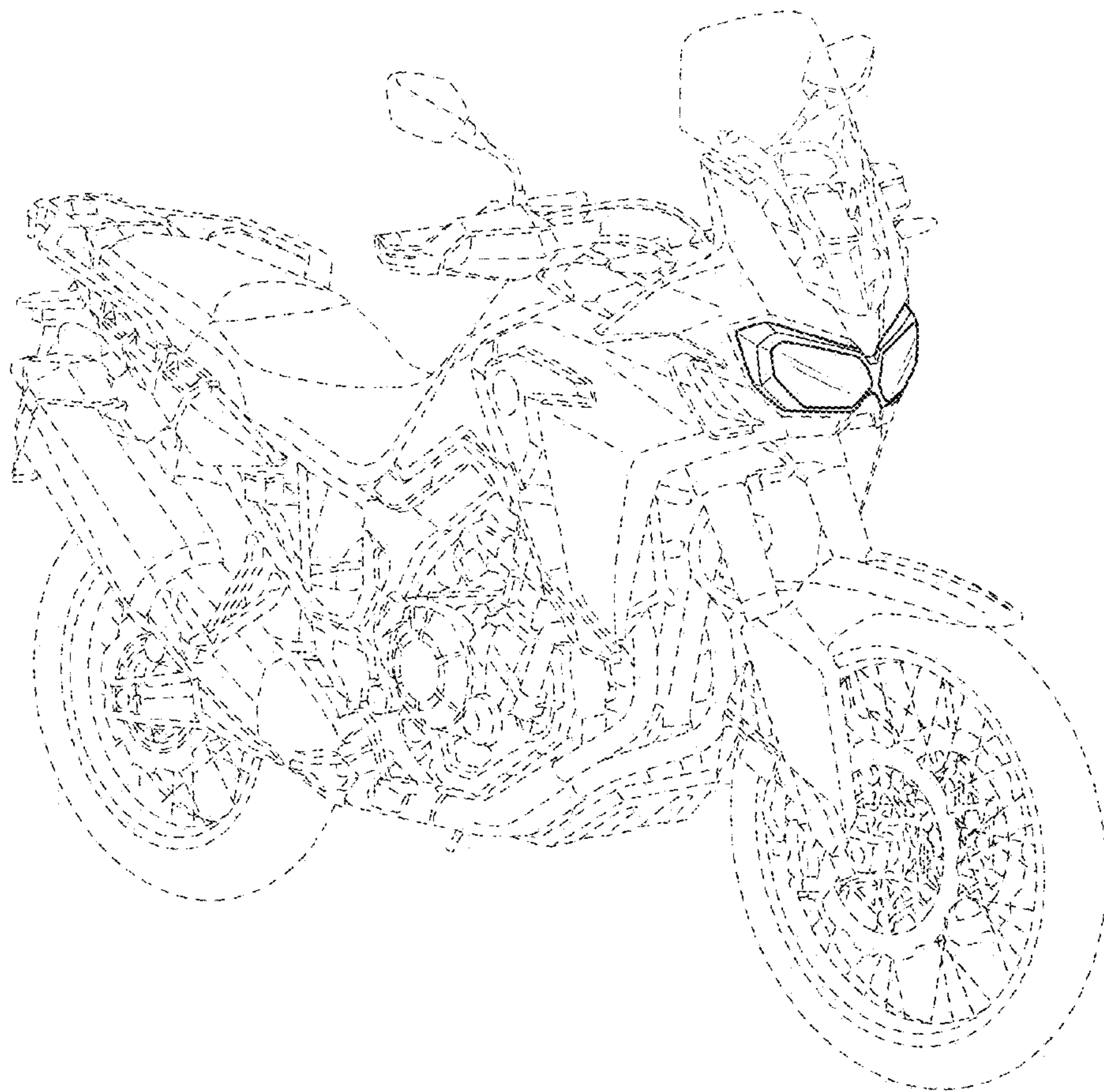

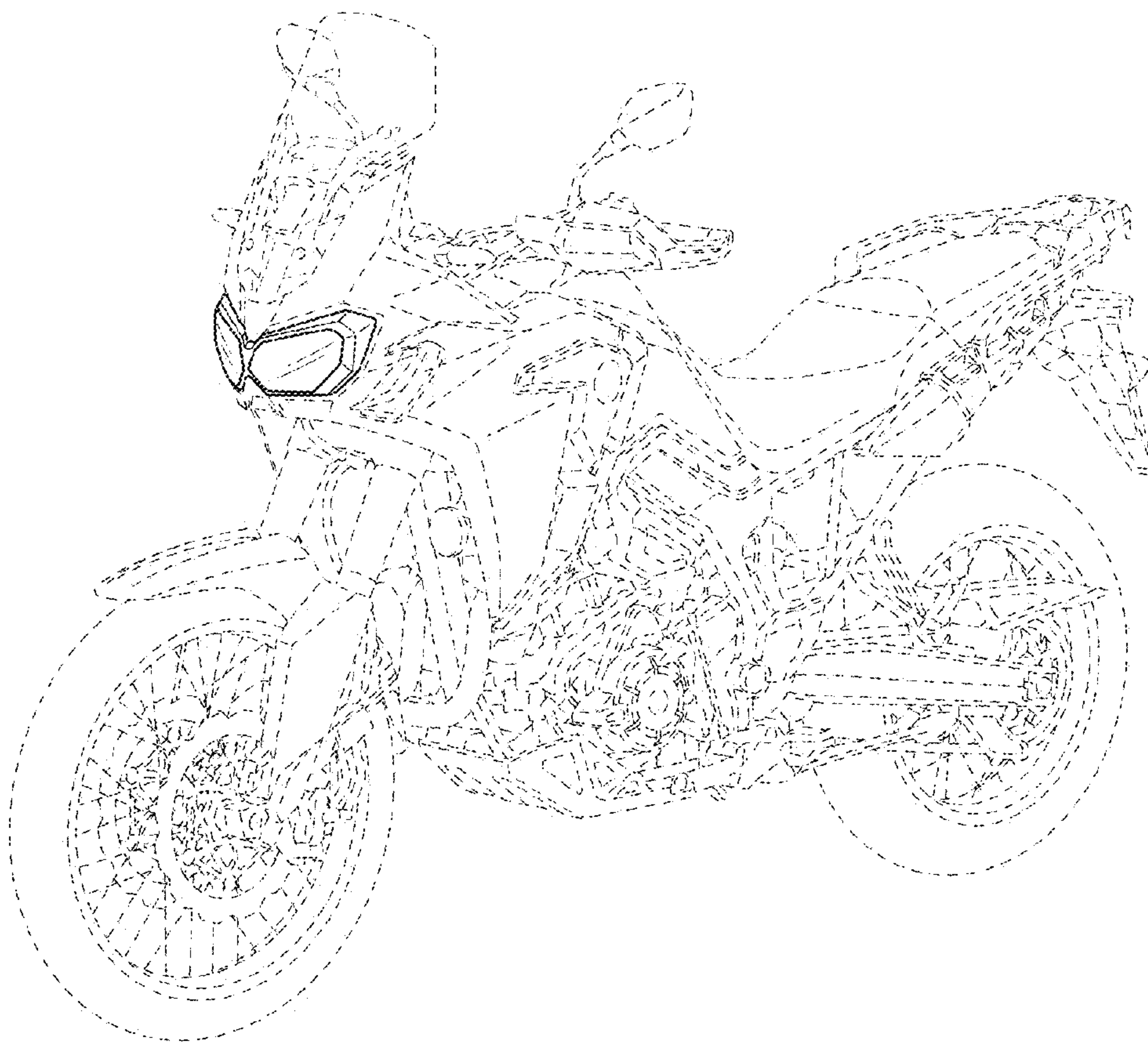

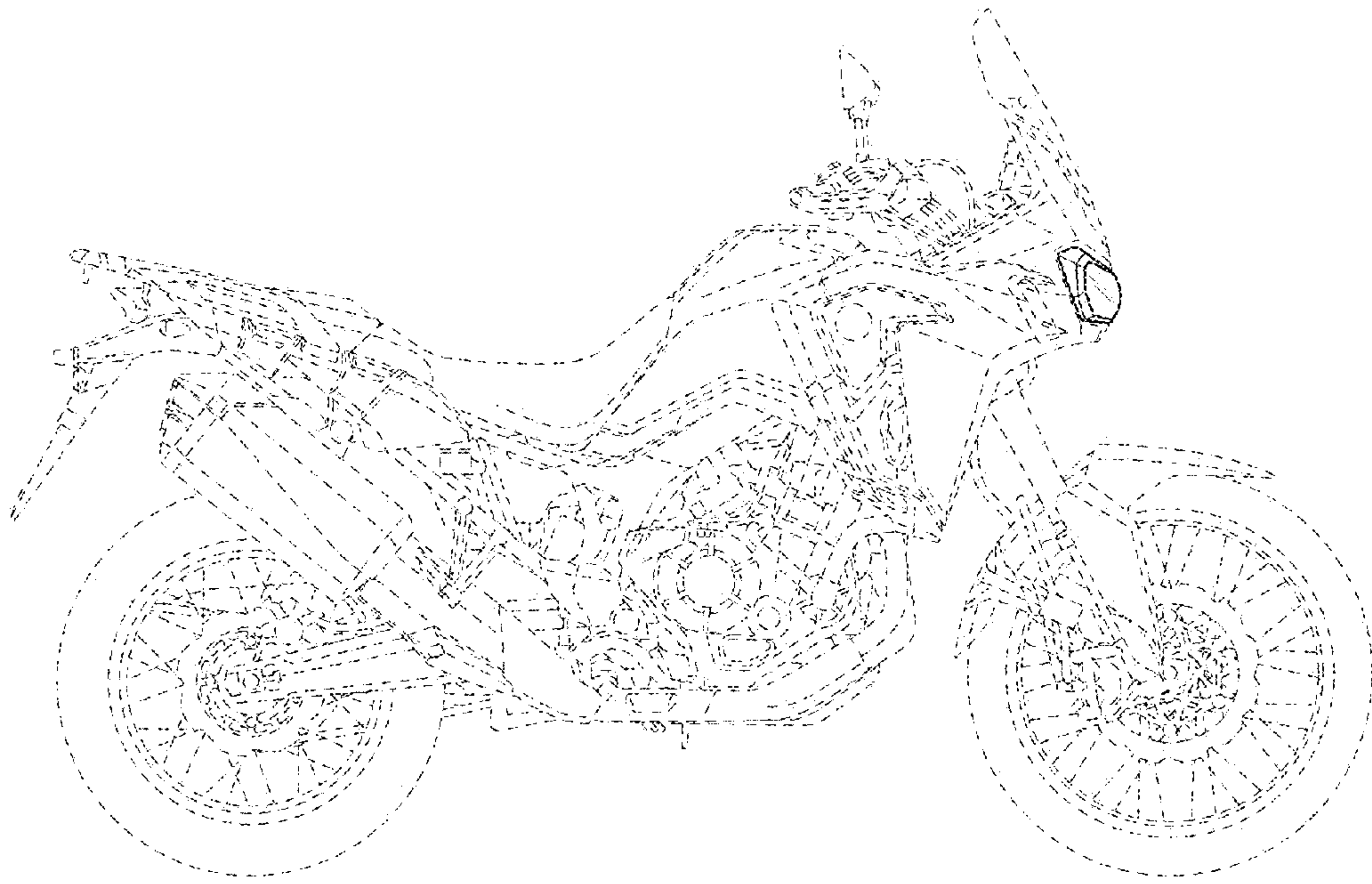

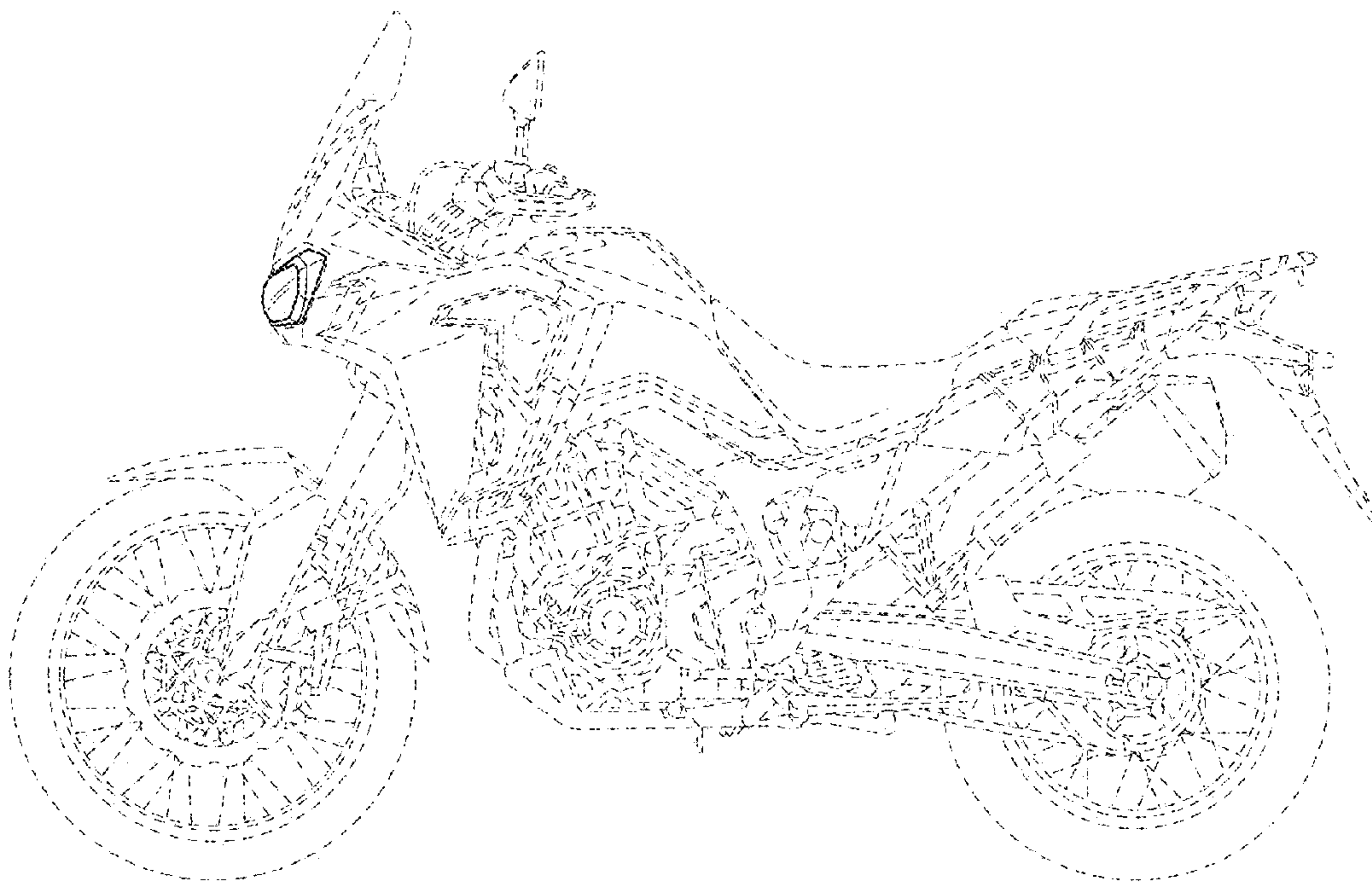

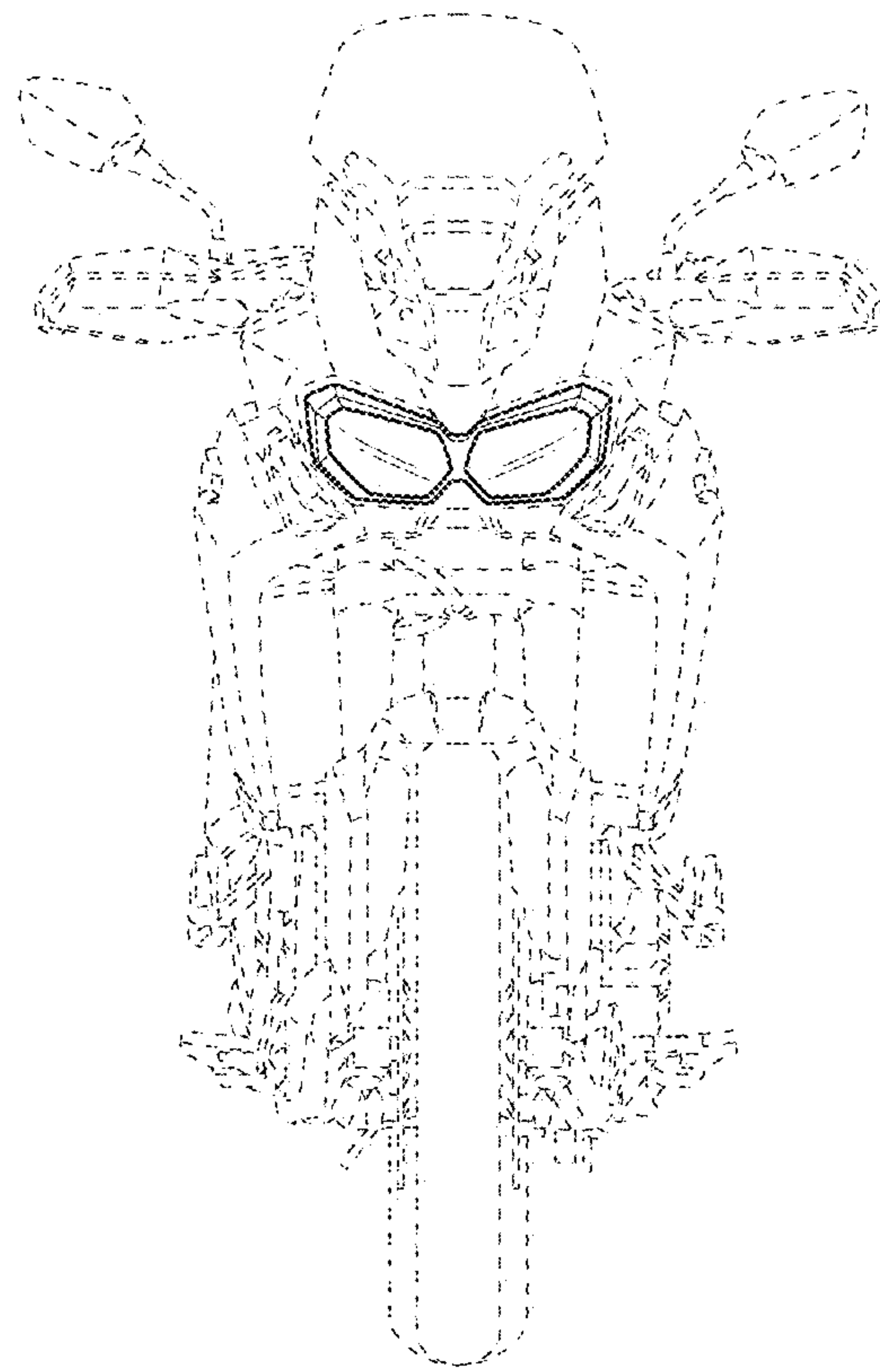

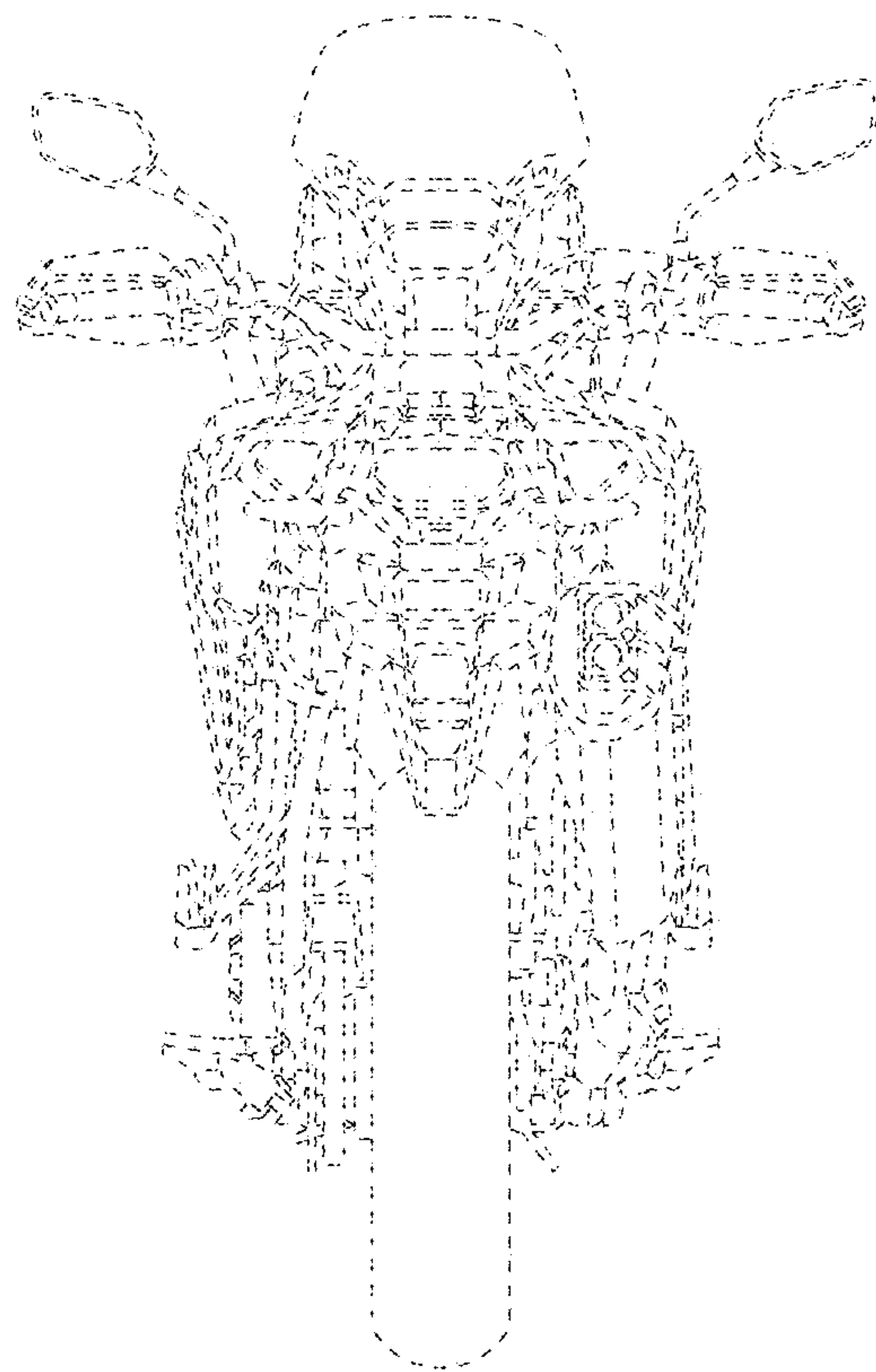

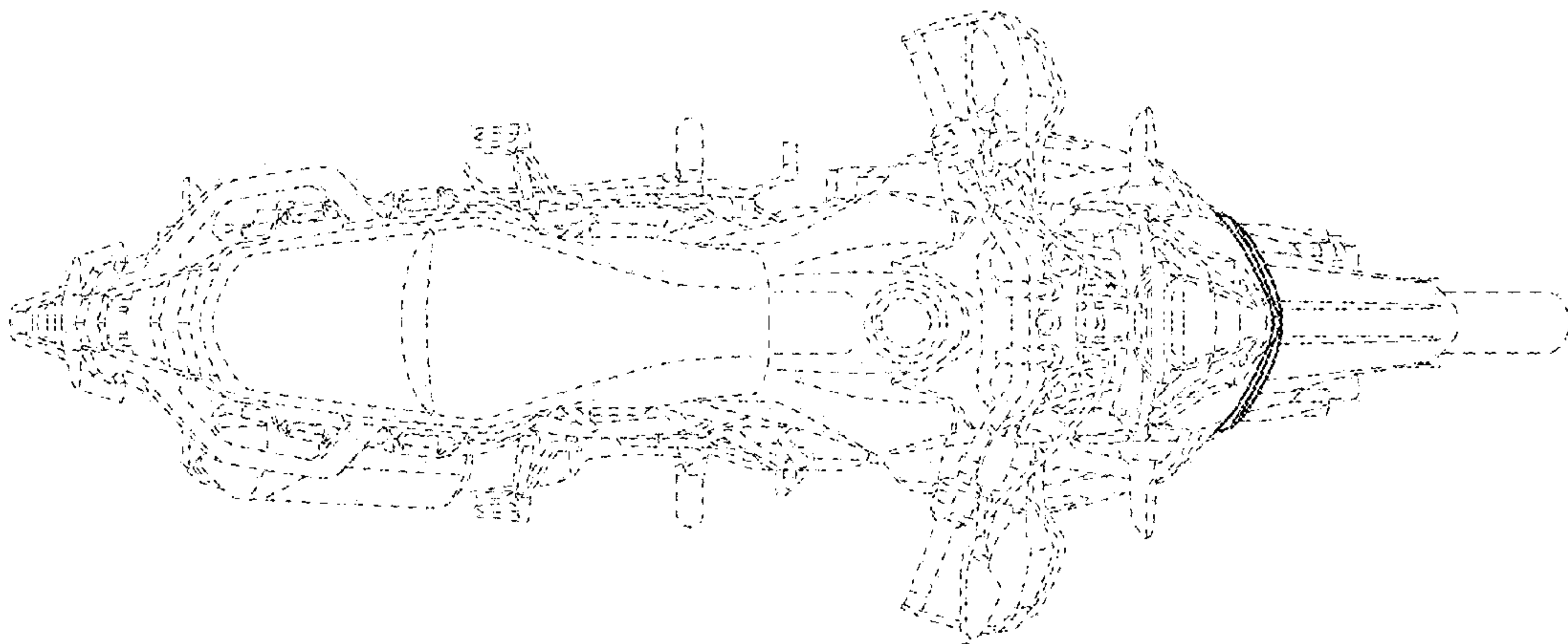

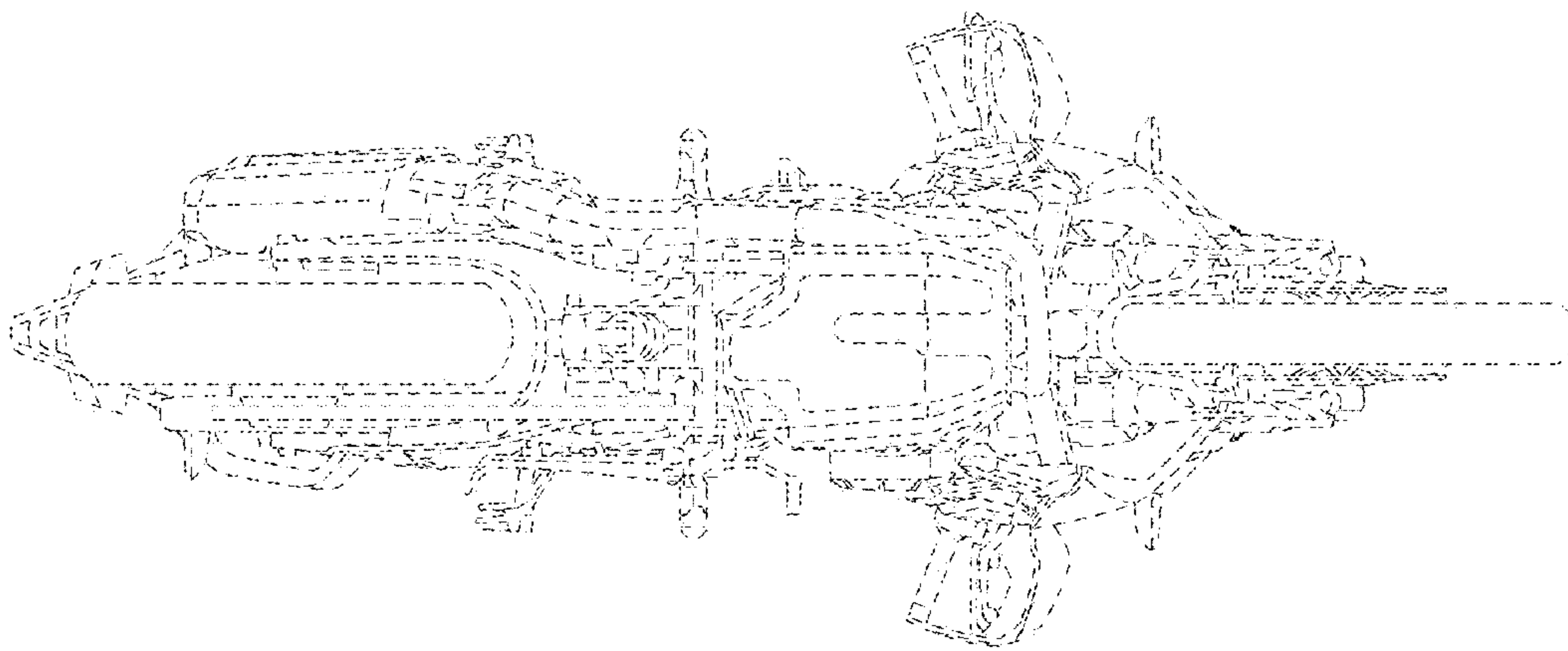

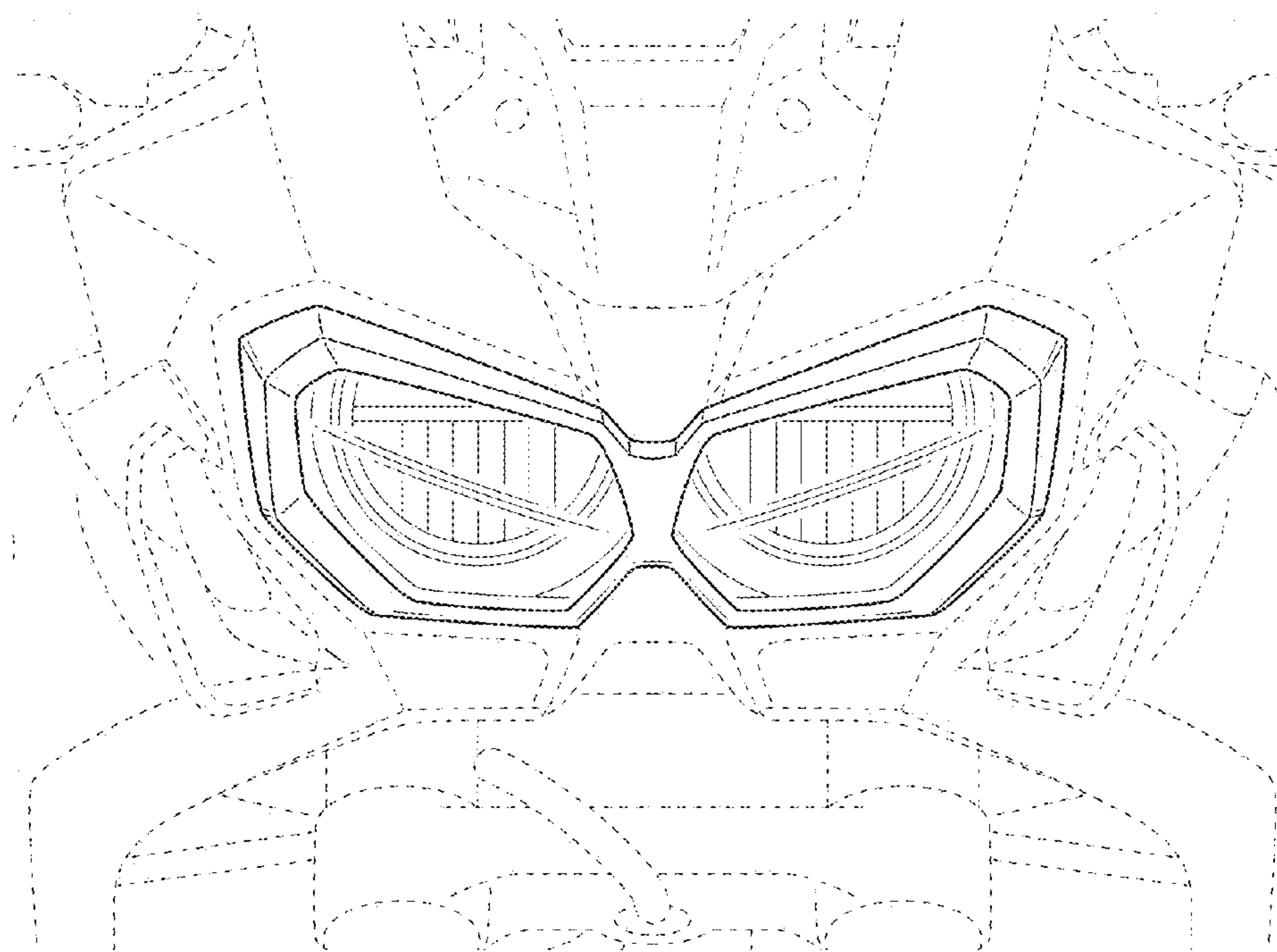
