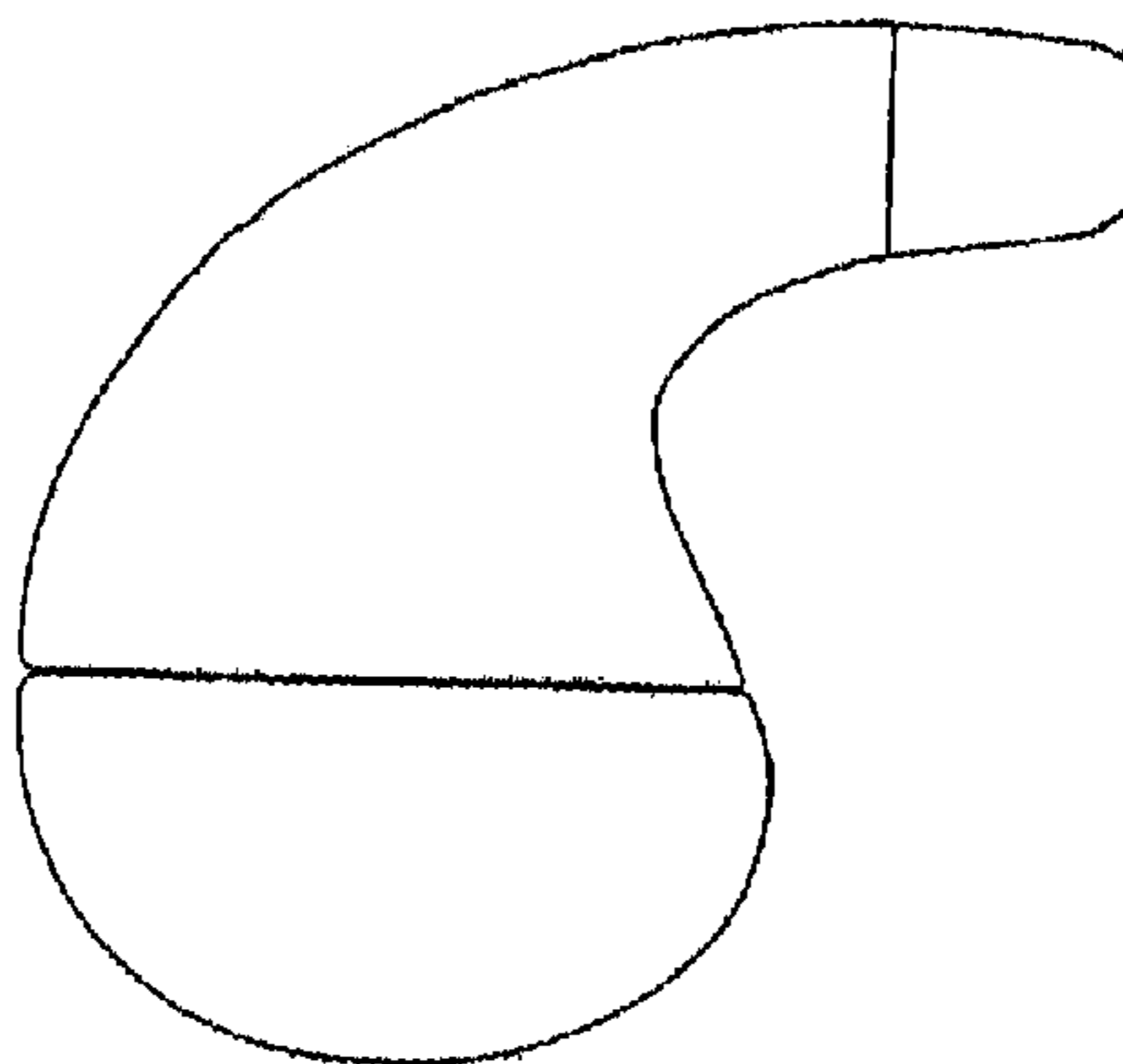
FIG. 1 is a right side view of a pipe according the invention.

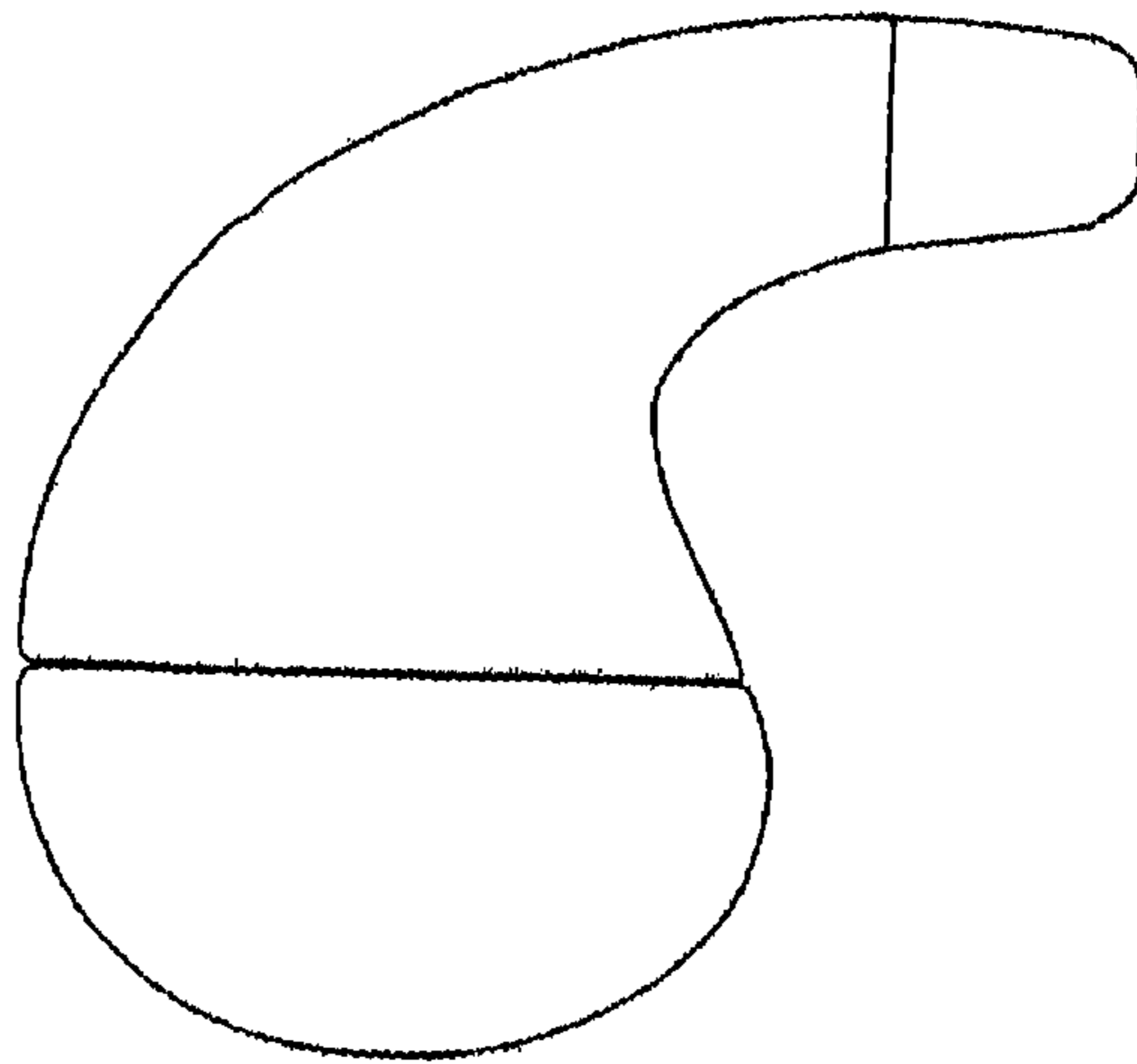

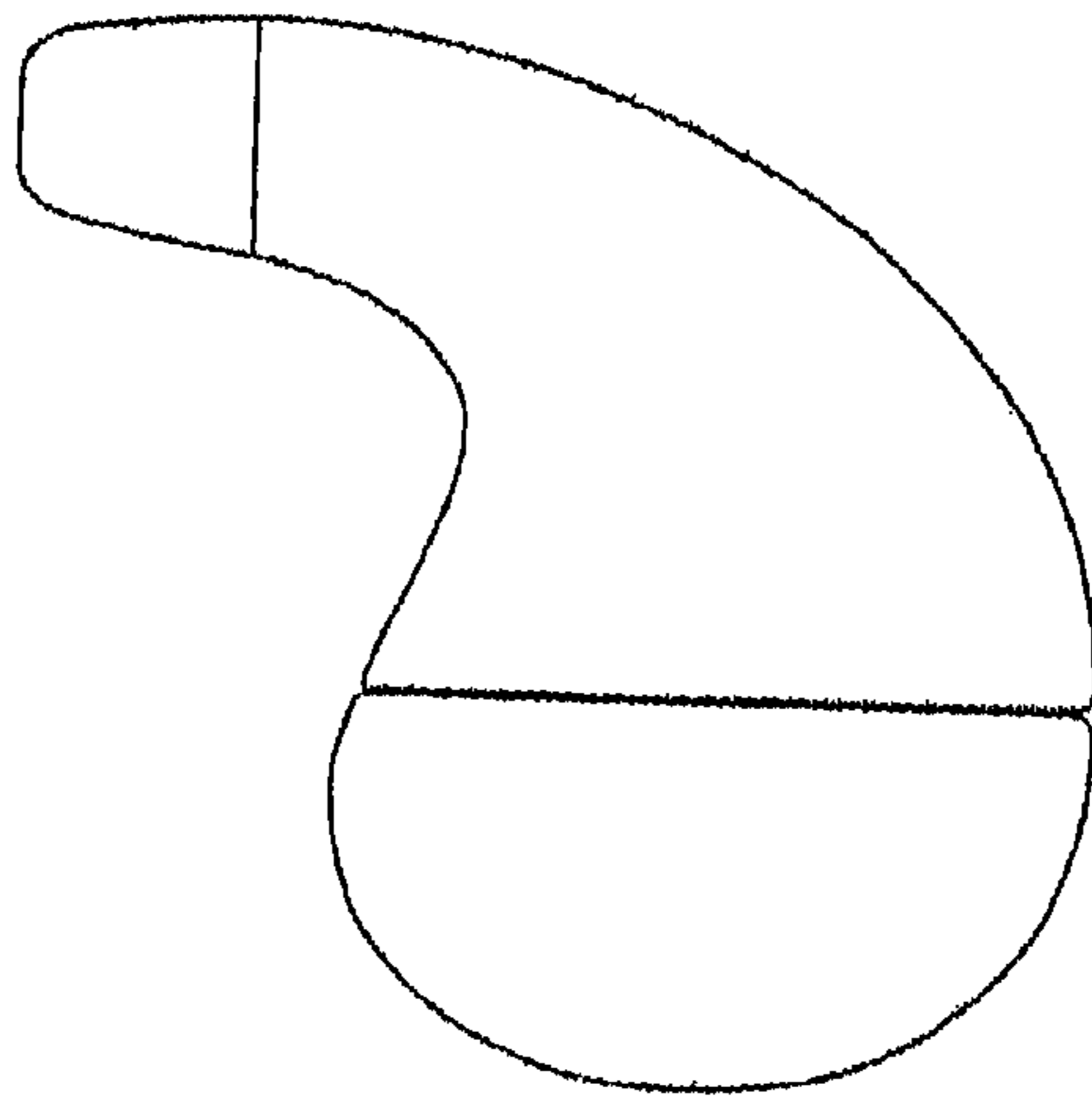

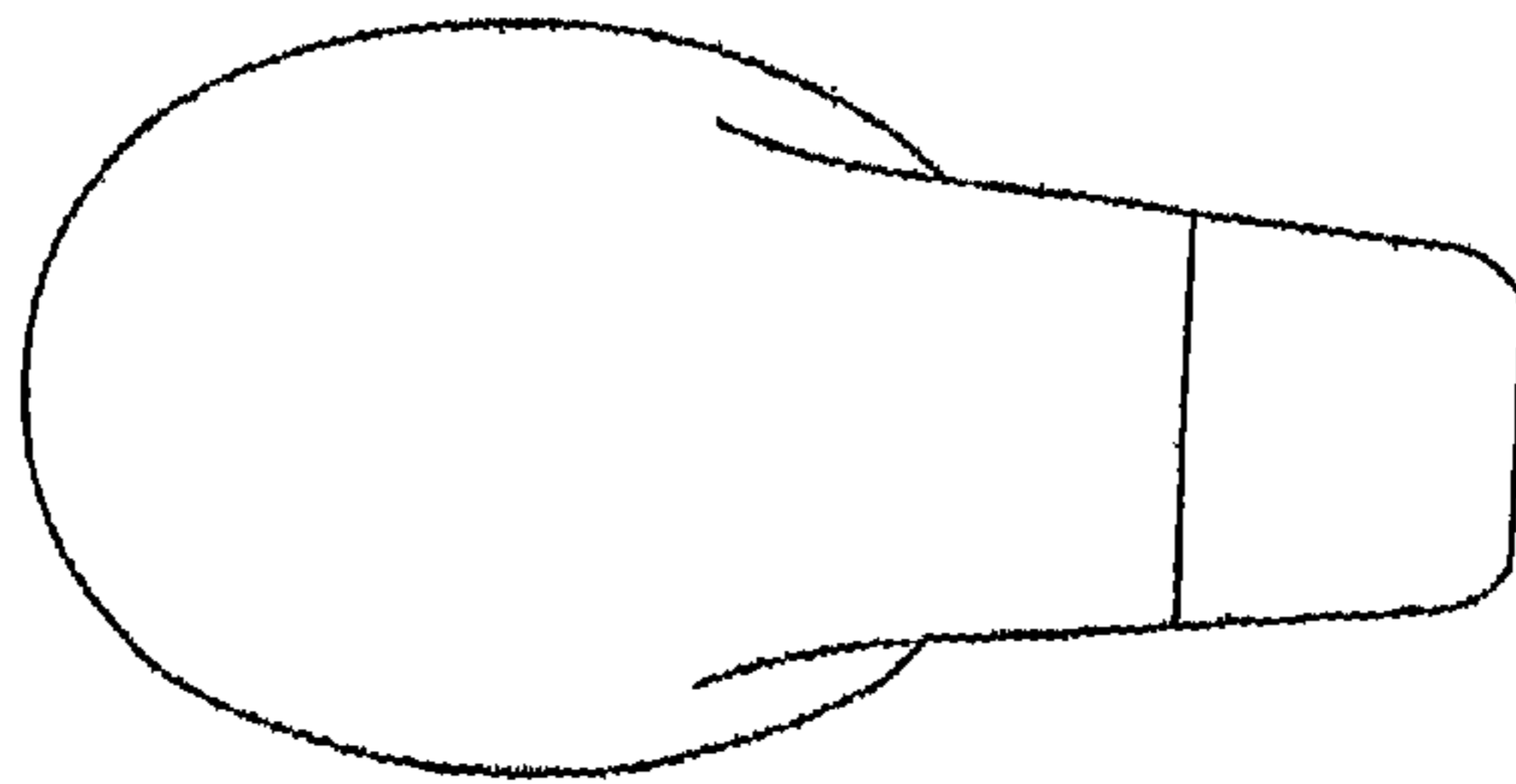

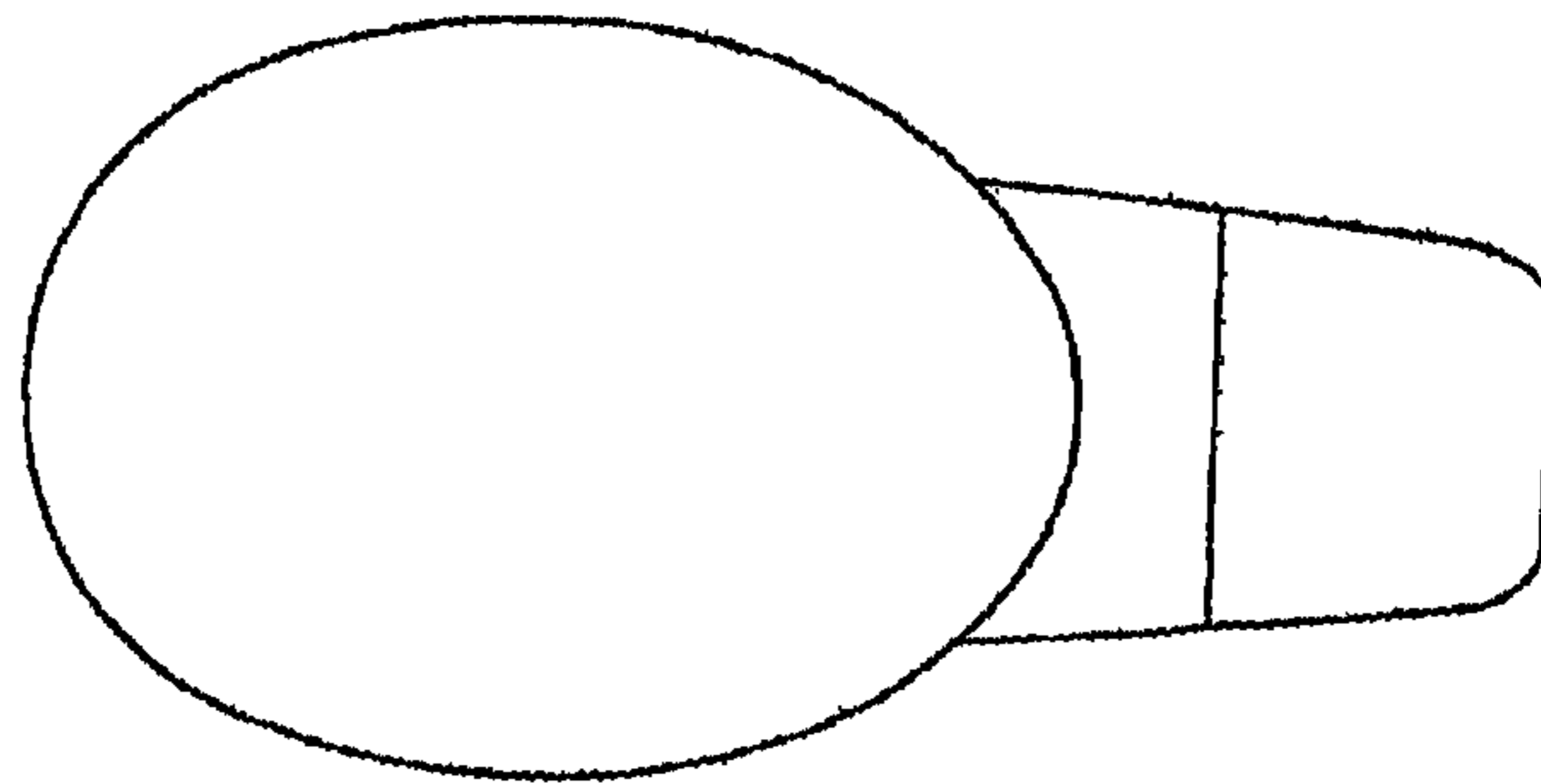

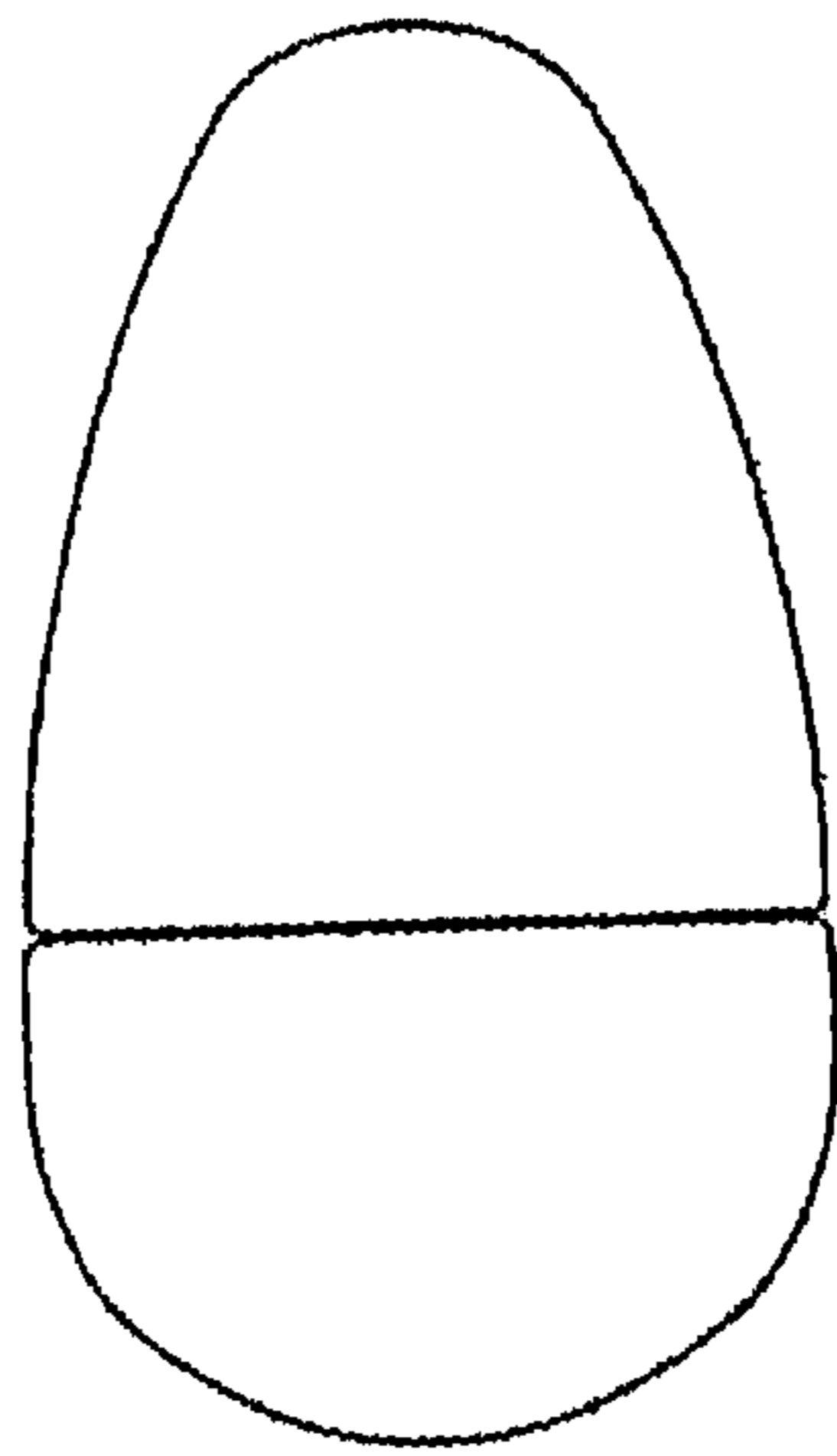

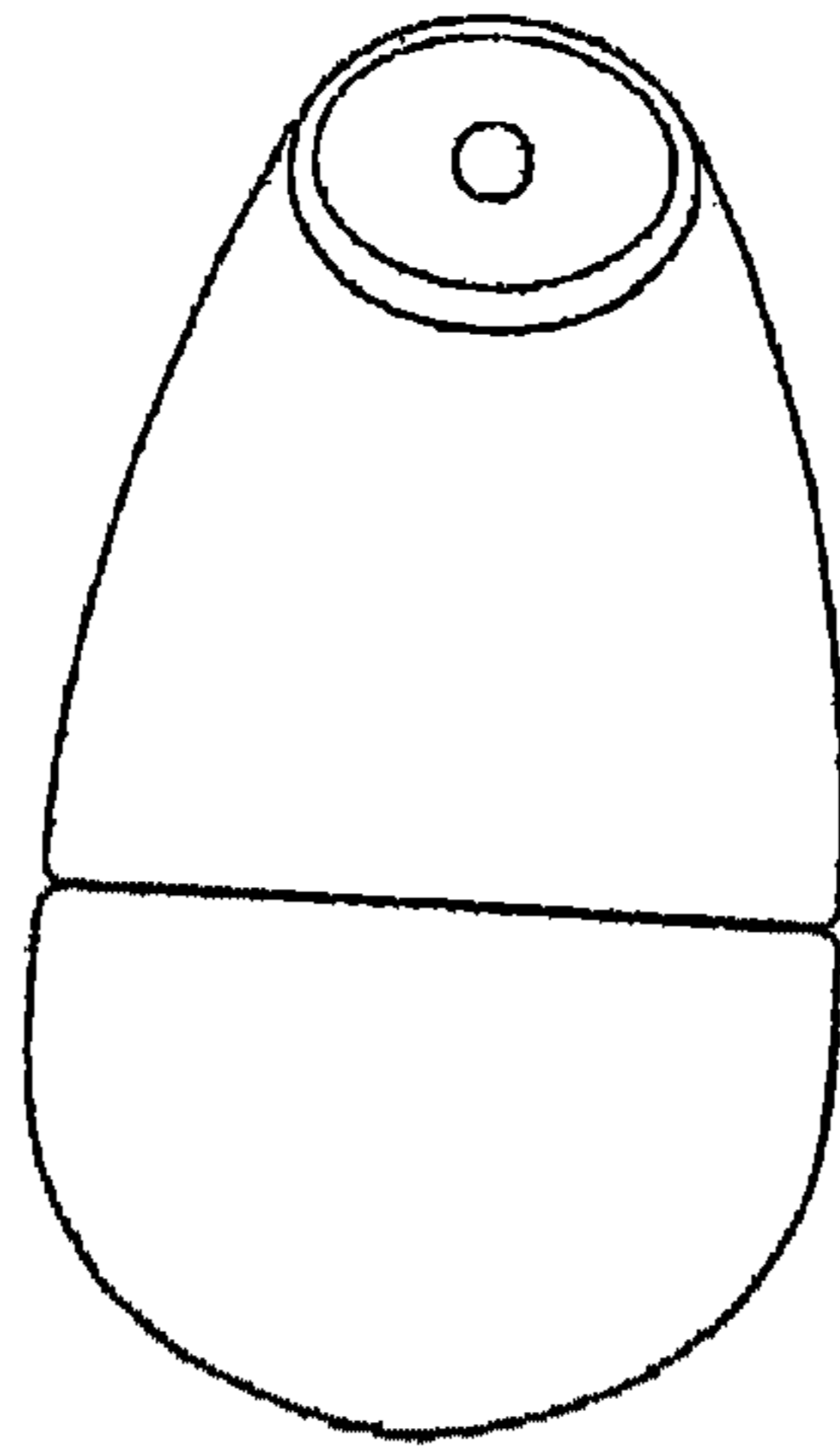

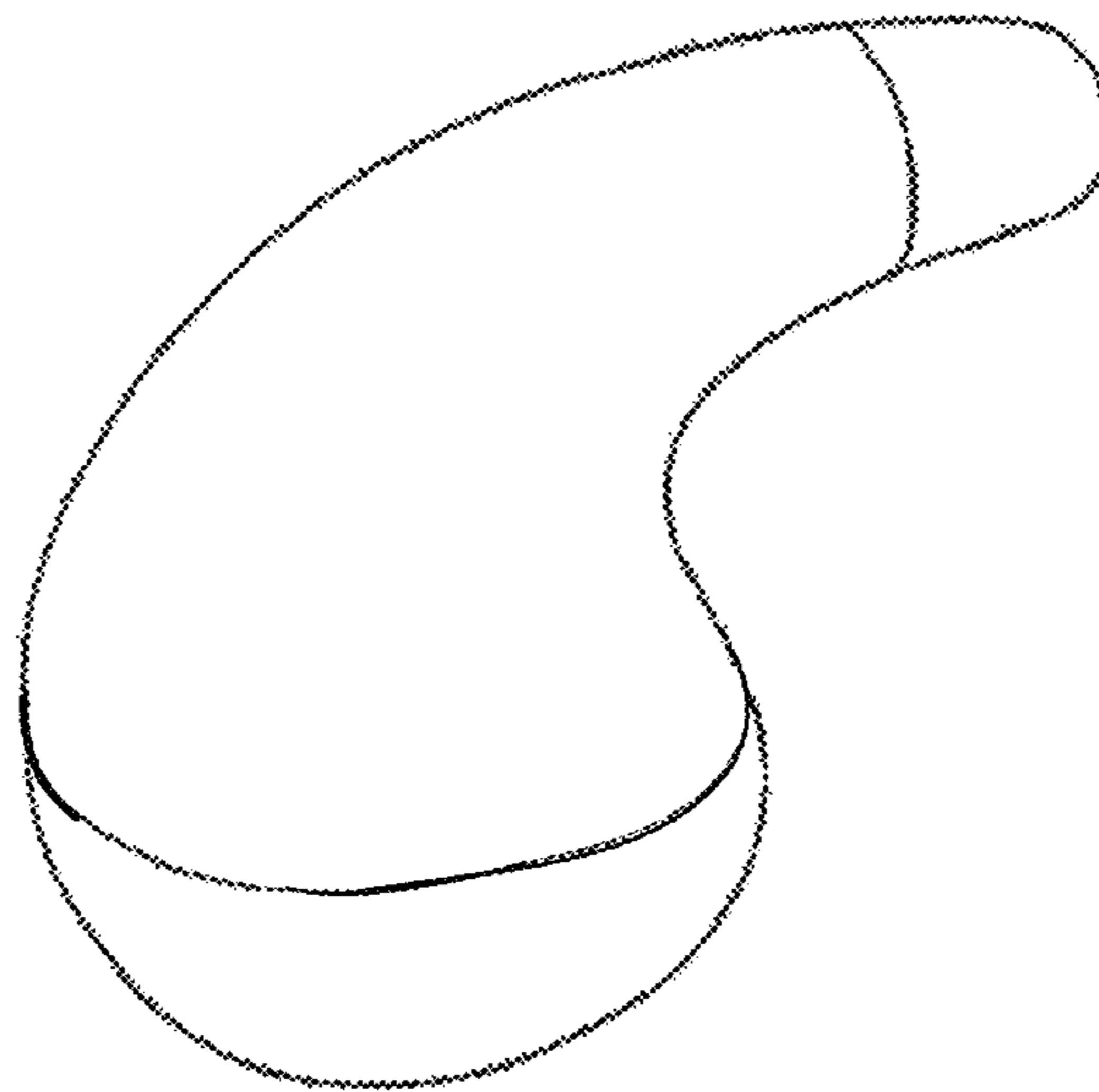

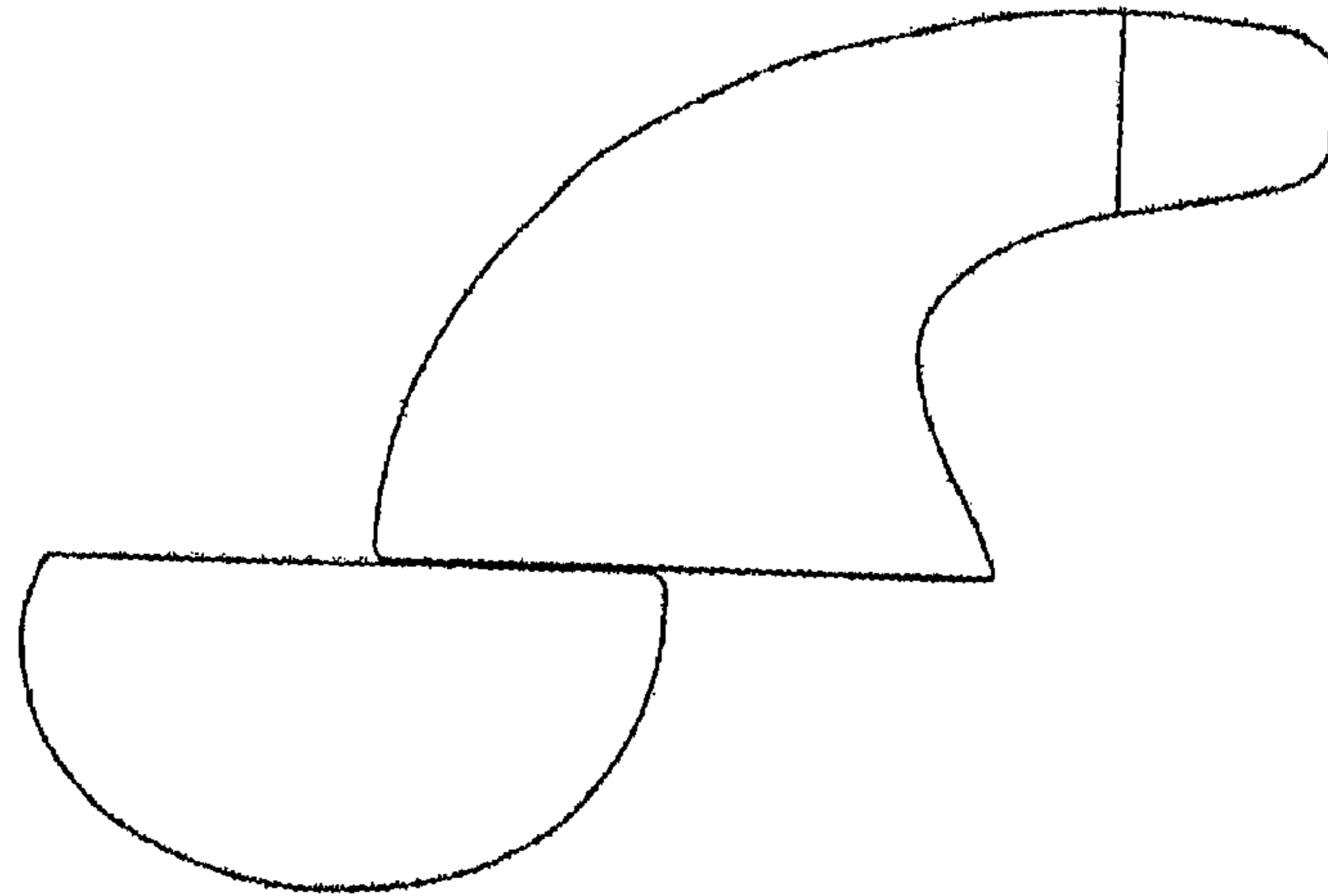

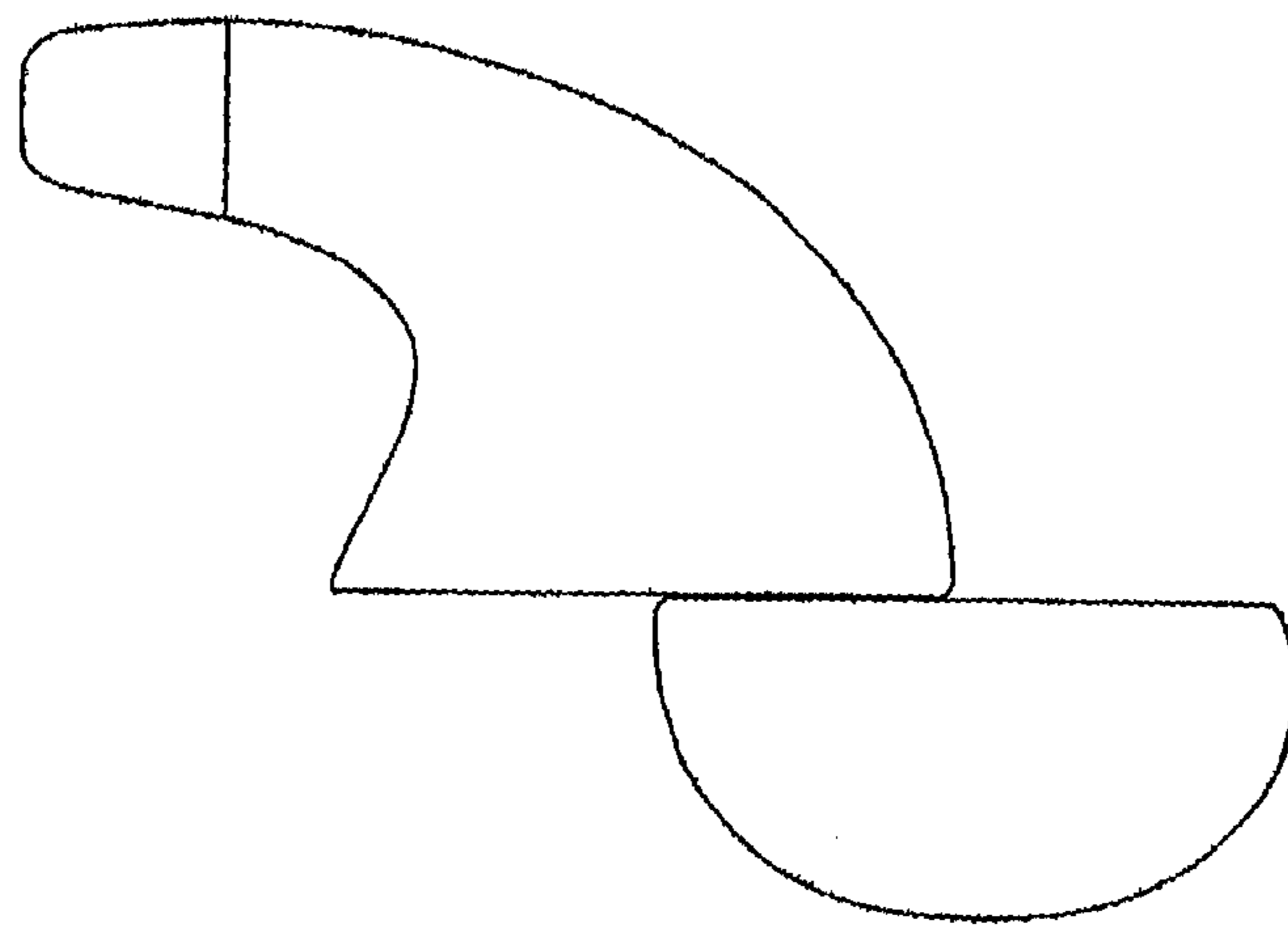

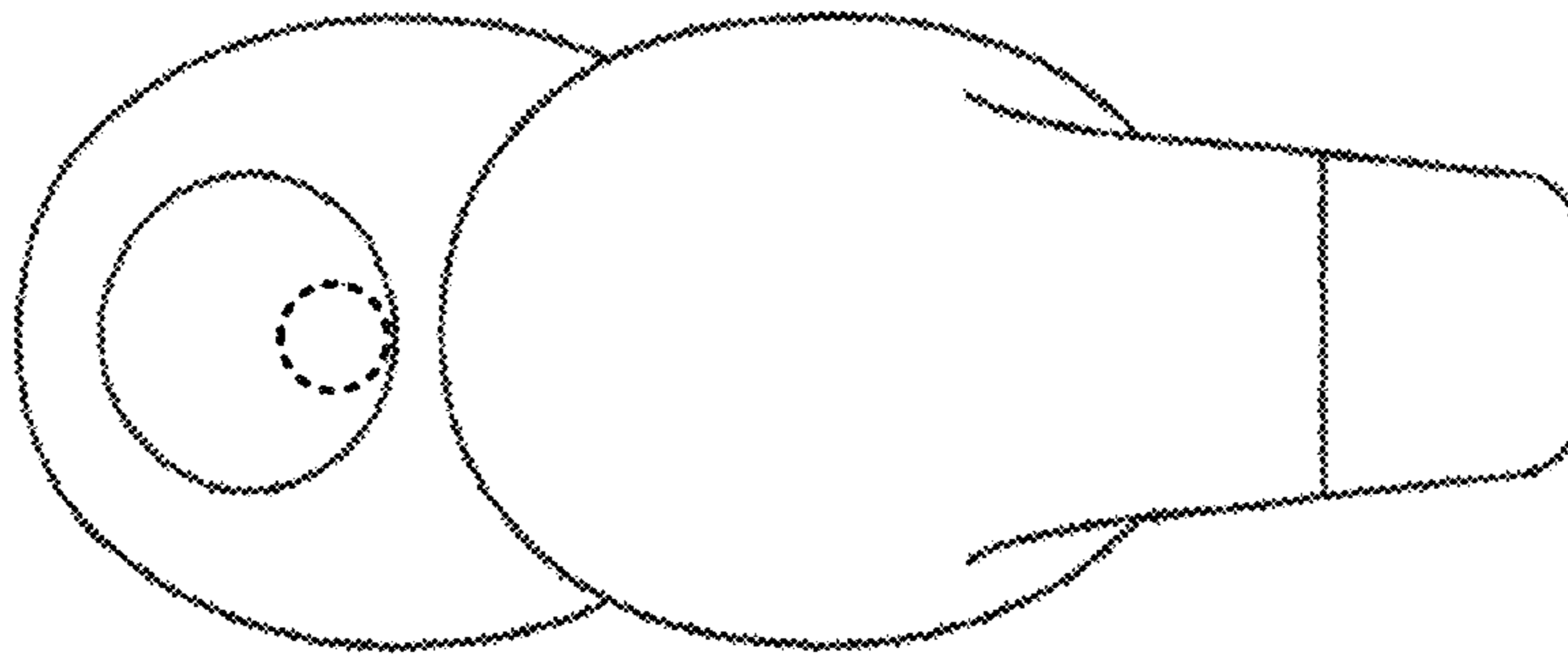

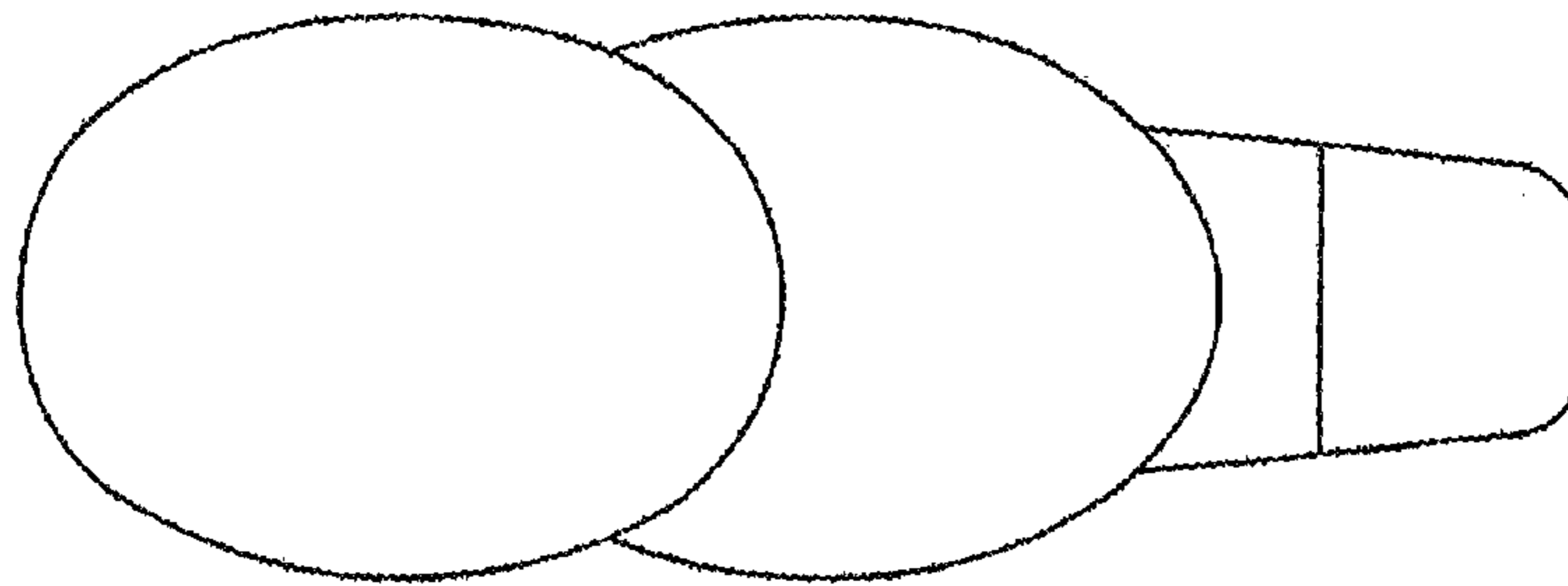

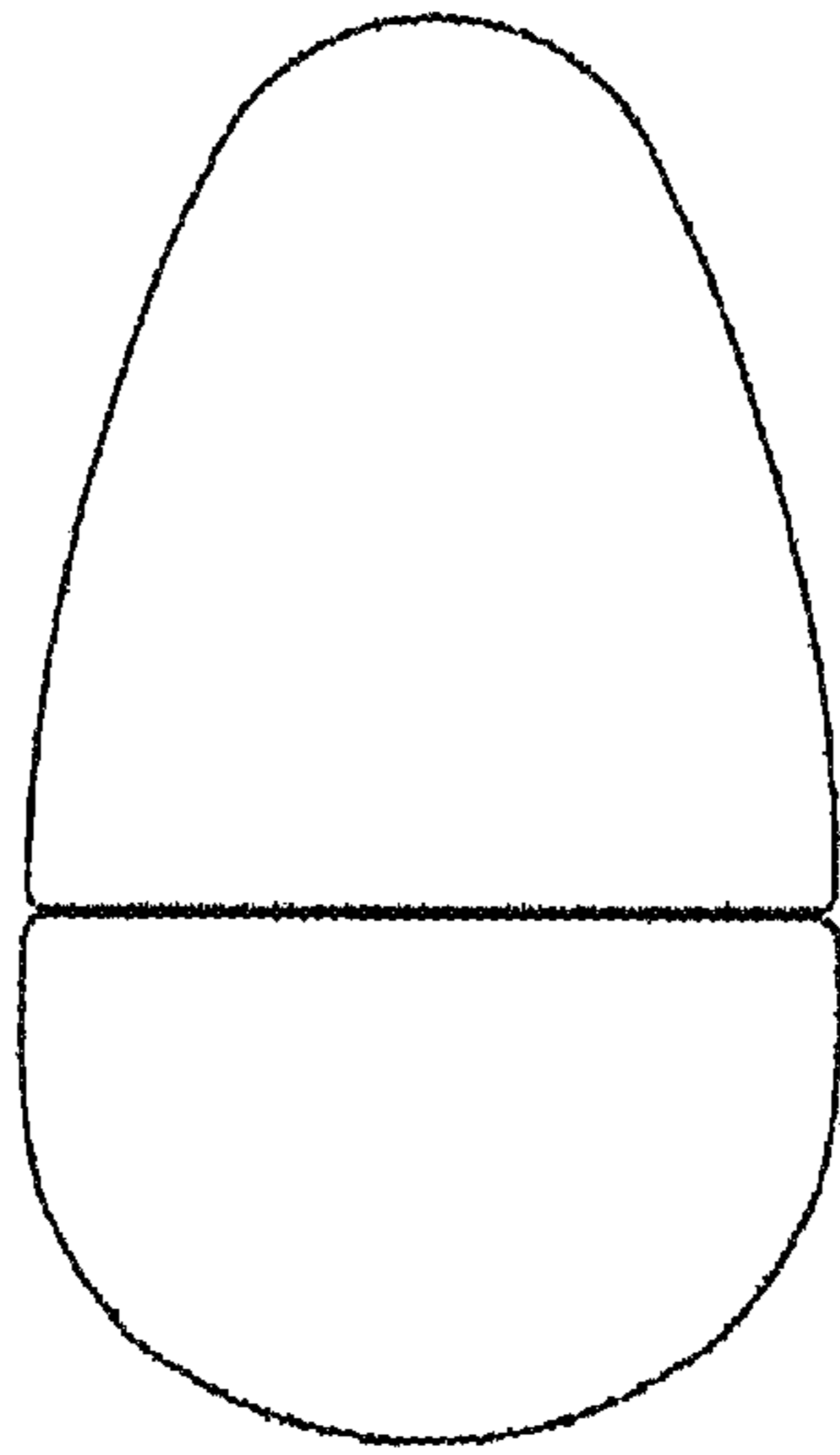

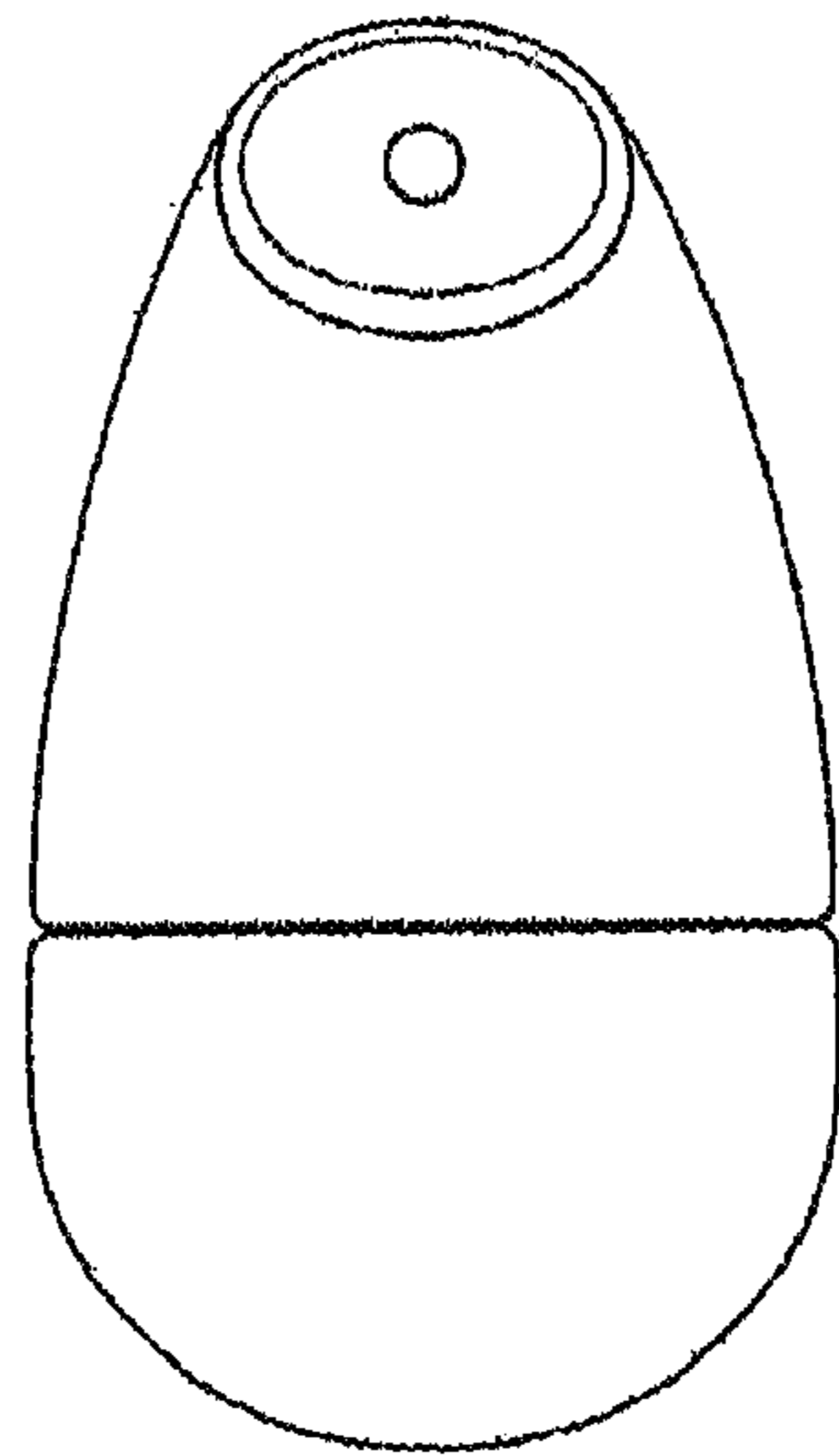

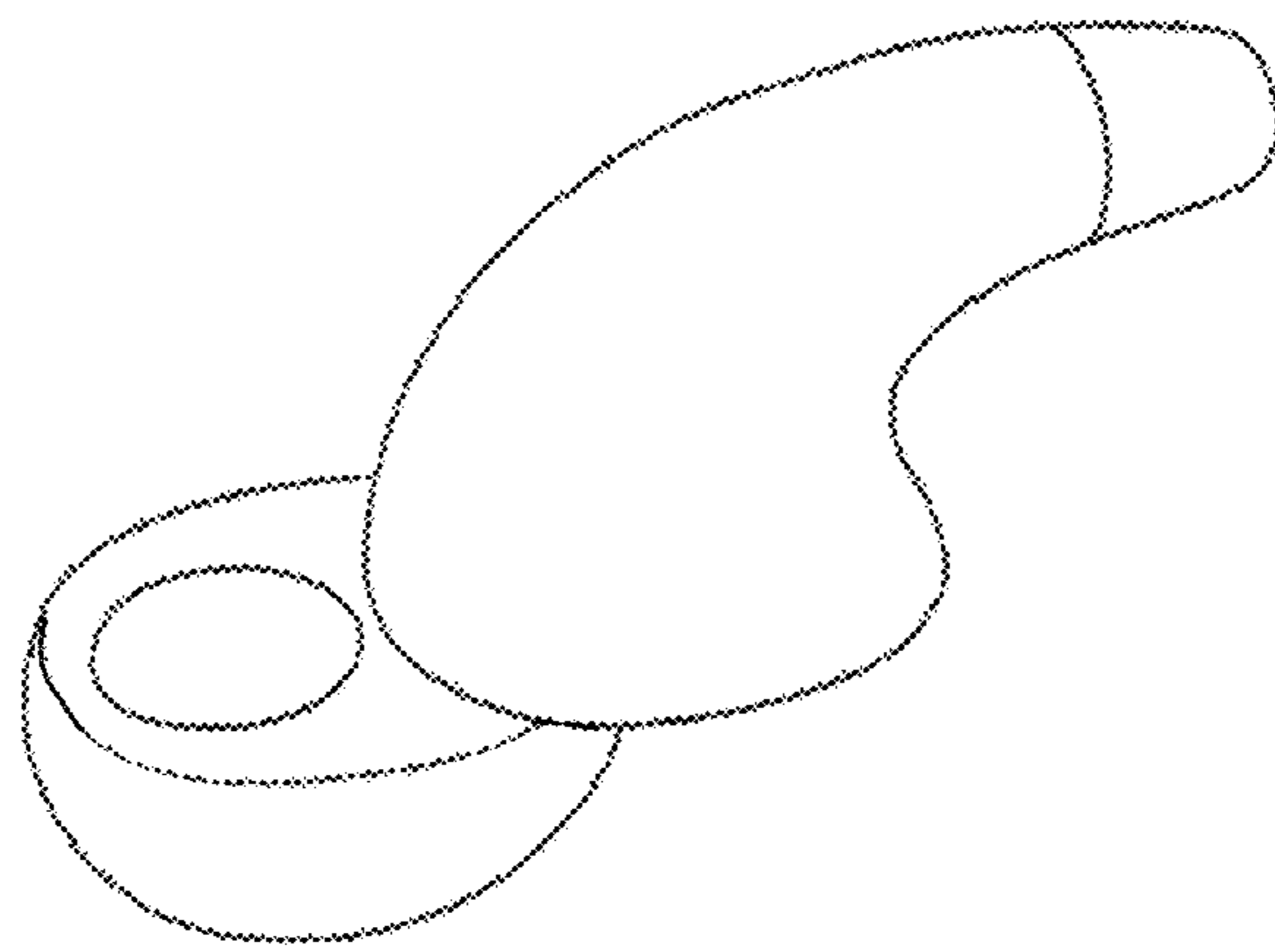
