DESCRIPTION

FIG. 1 is a top plan view of a wig base according to our new design;

FIG. 5 is a right side view thereof, opposite left side view being mirror image thereof.

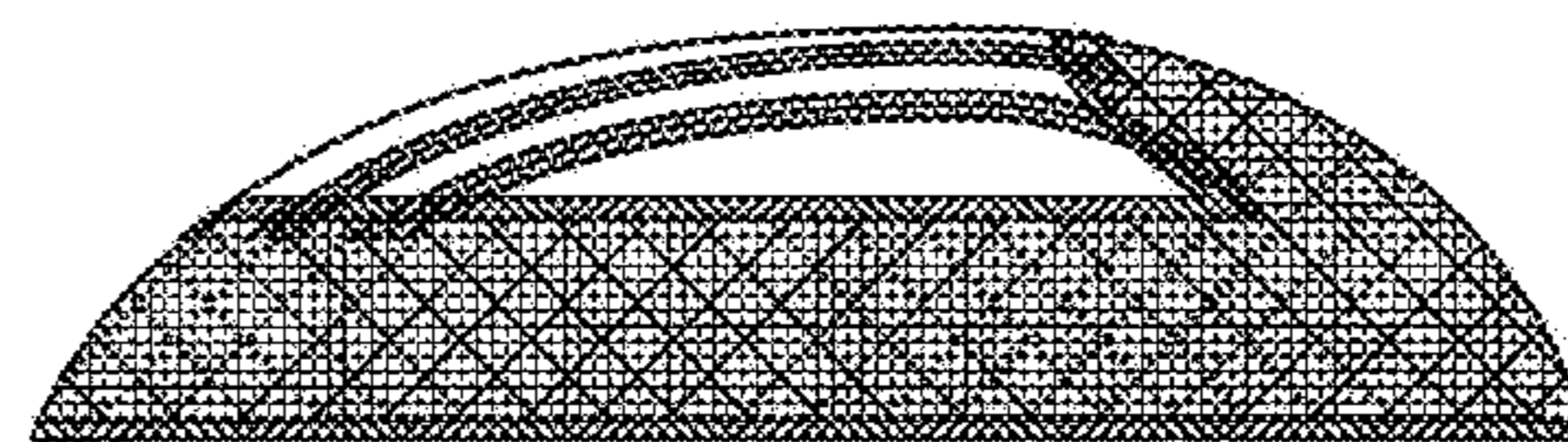
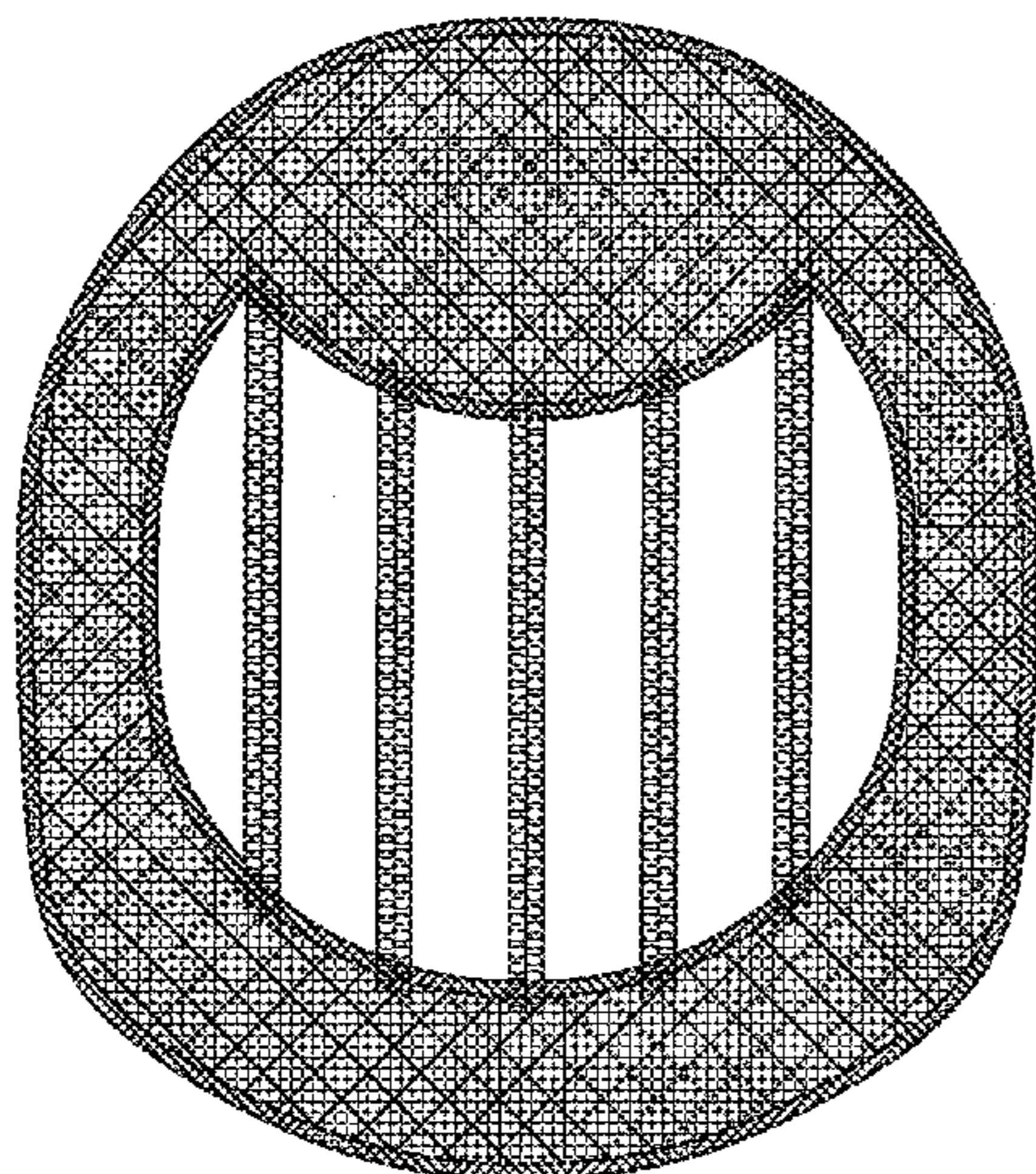

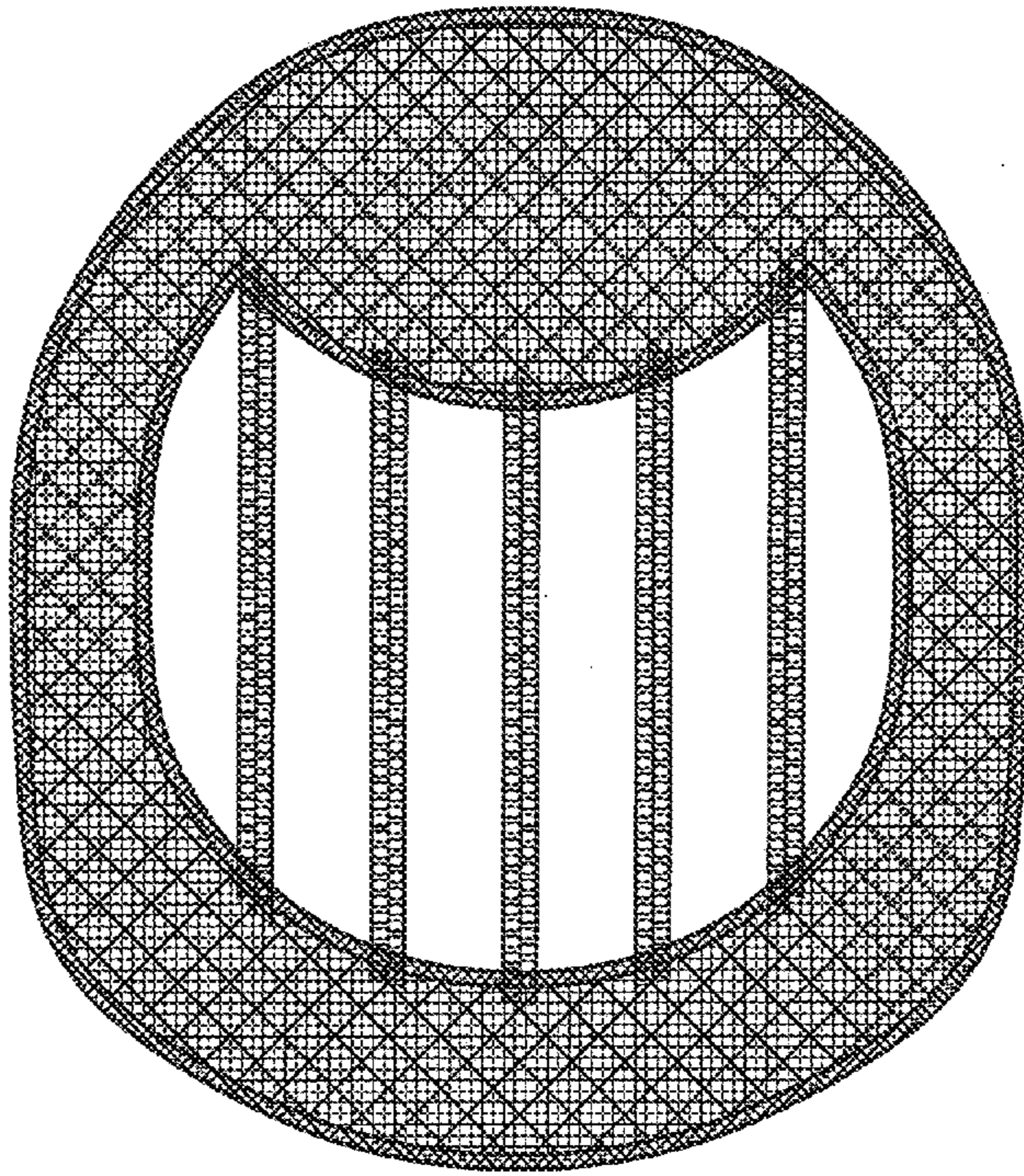

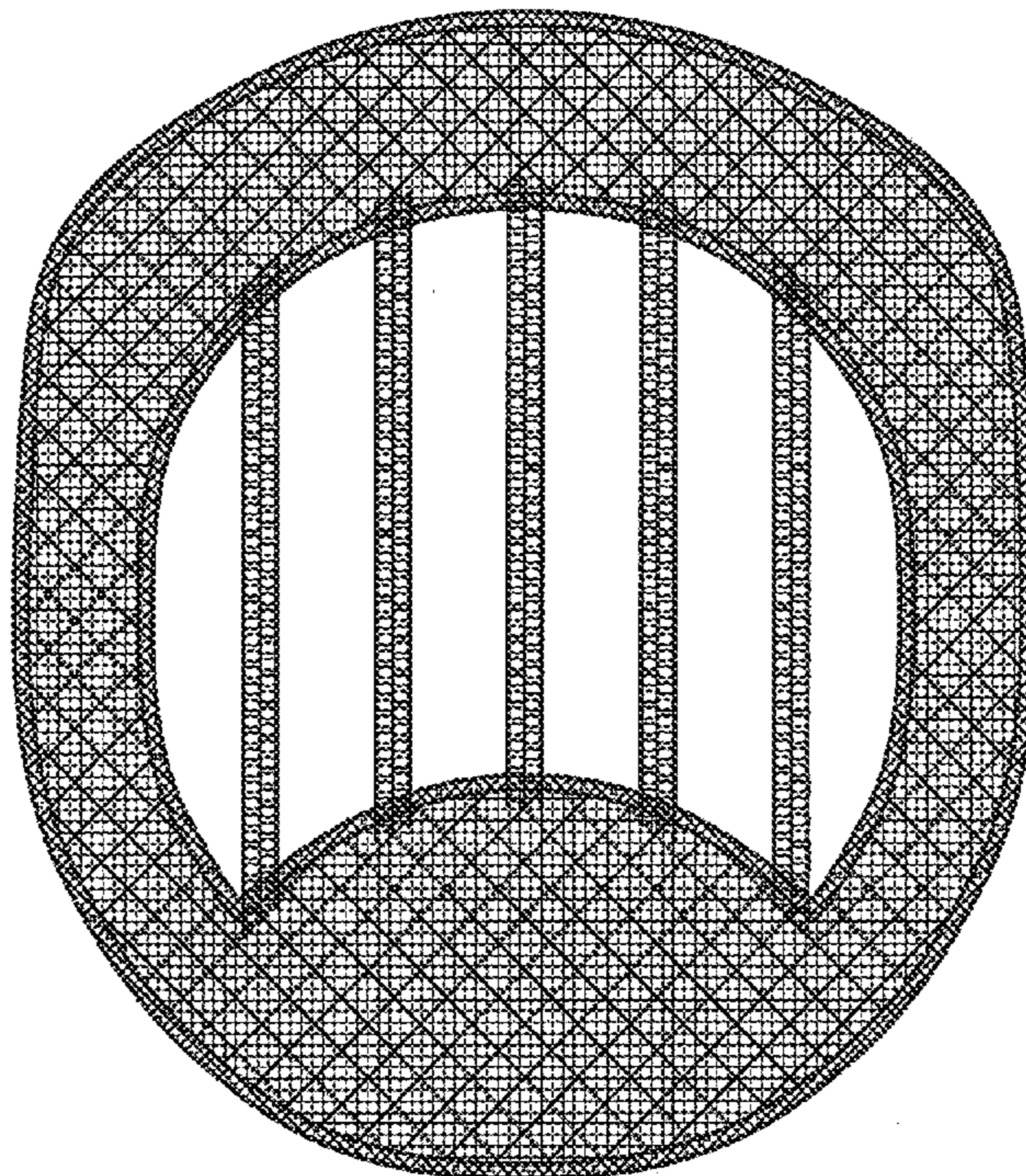

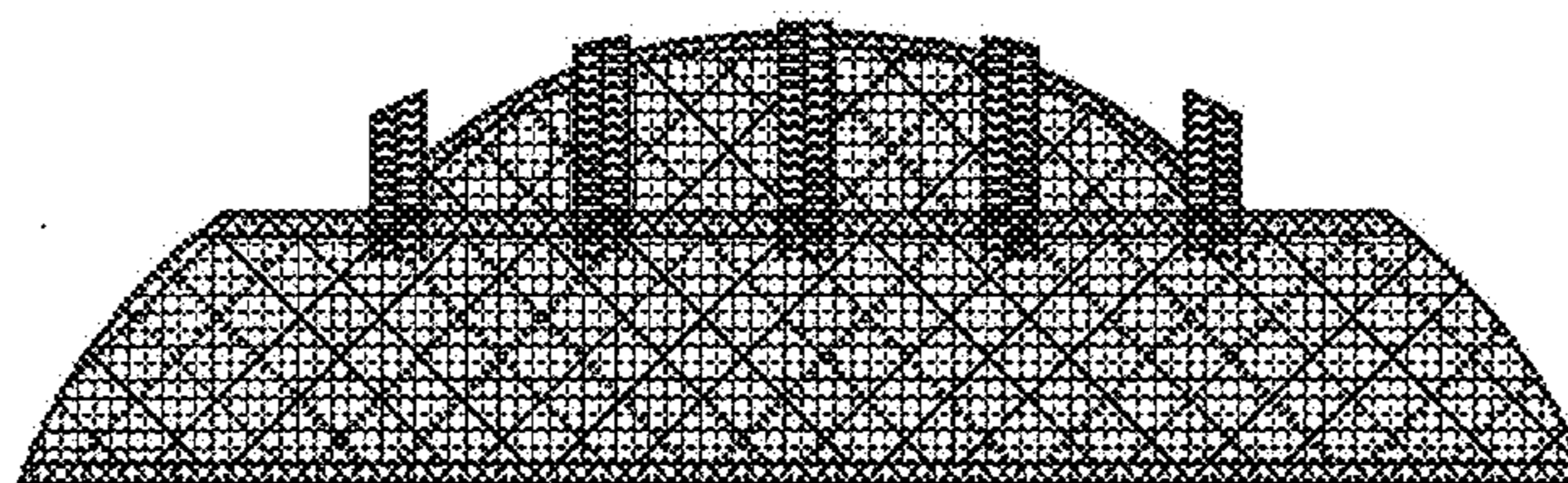

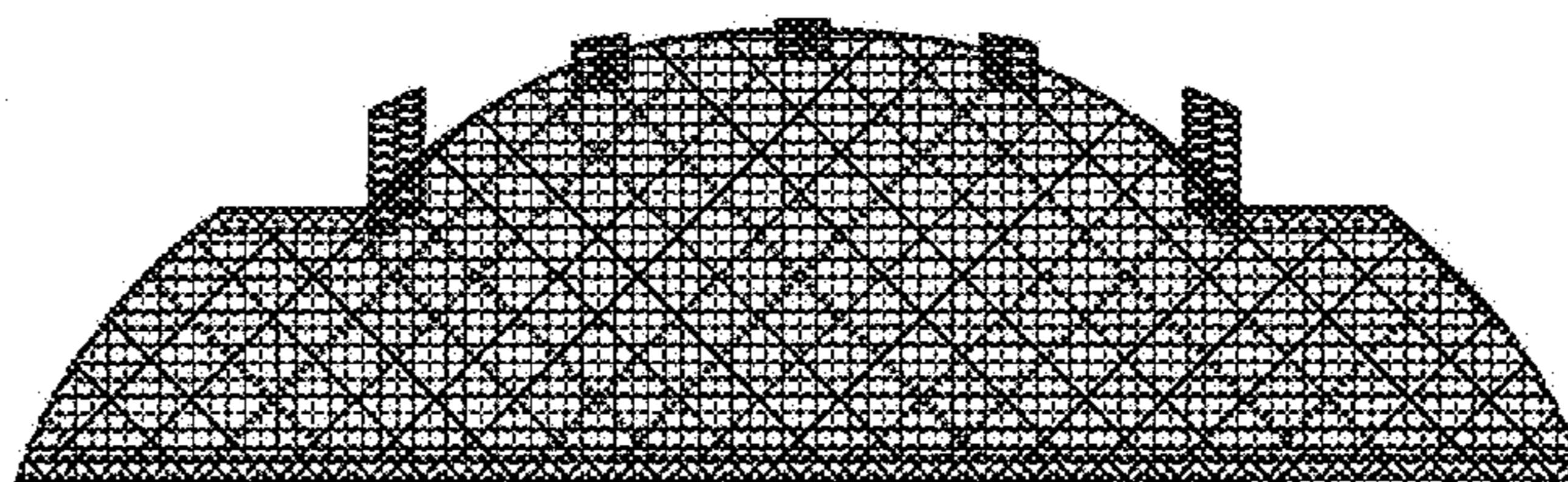
