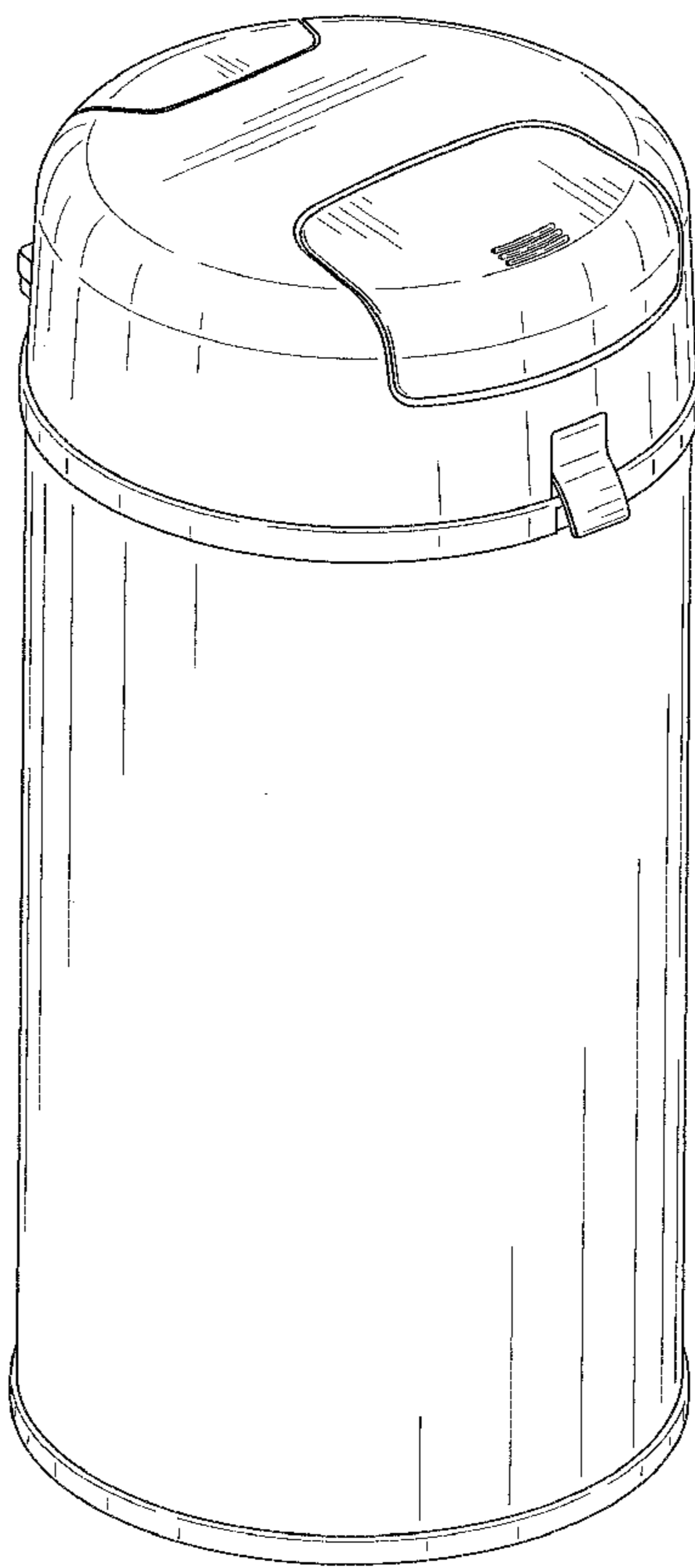

DESCRIPTION

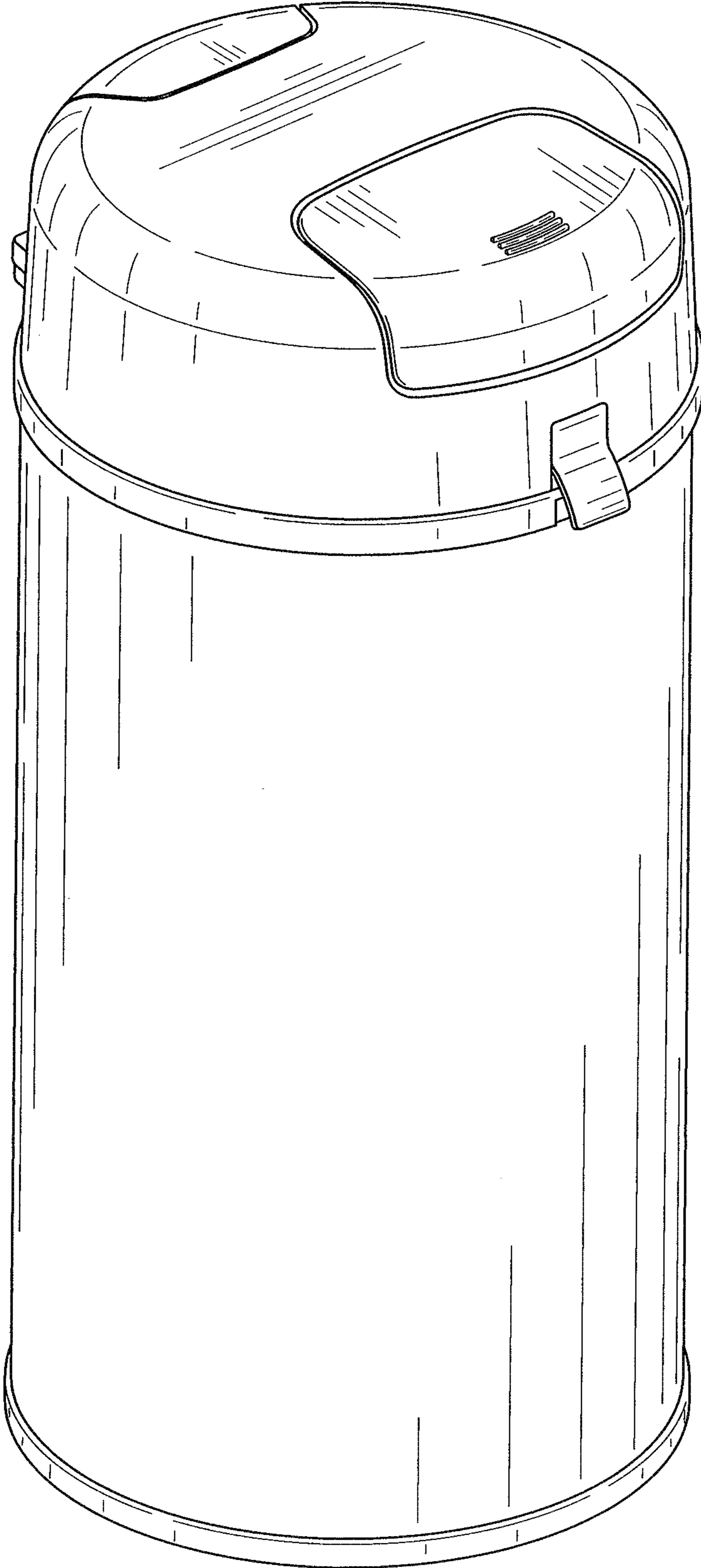

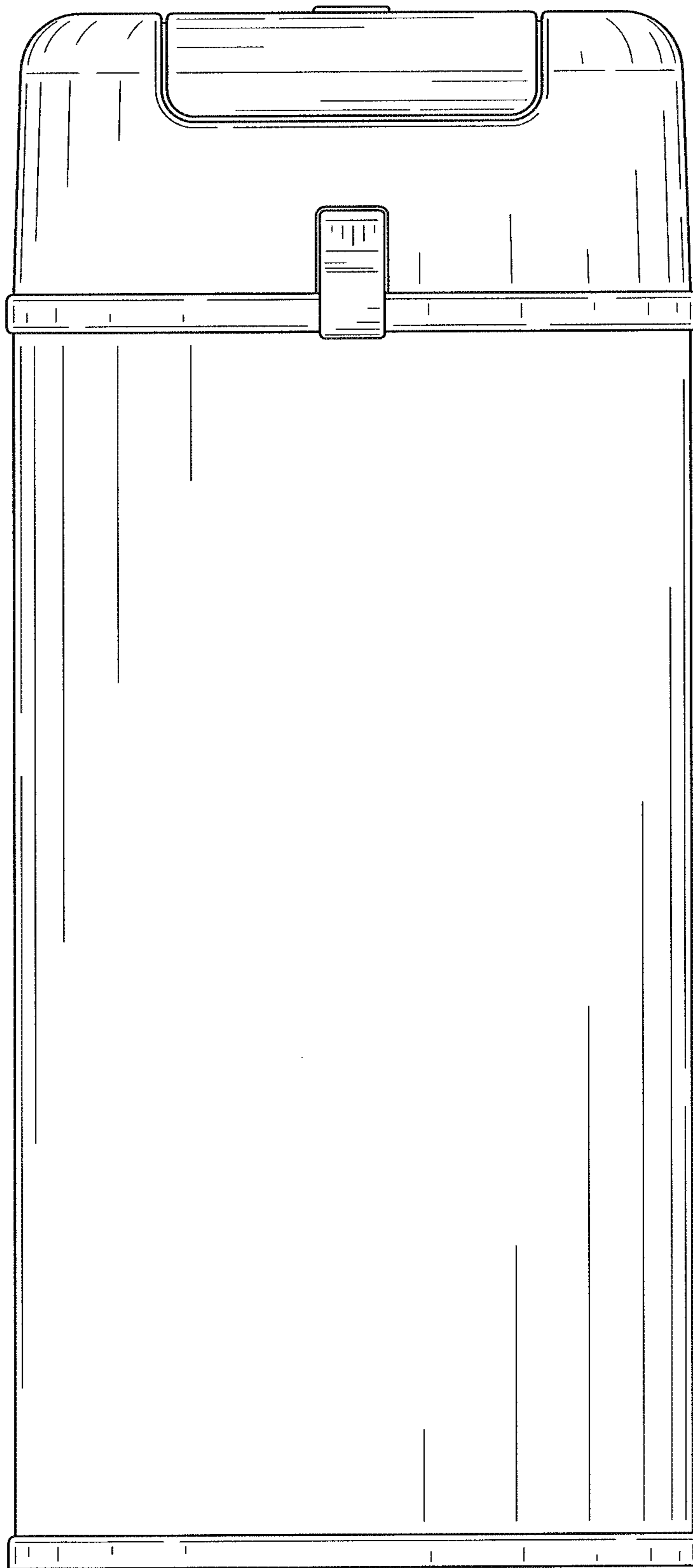

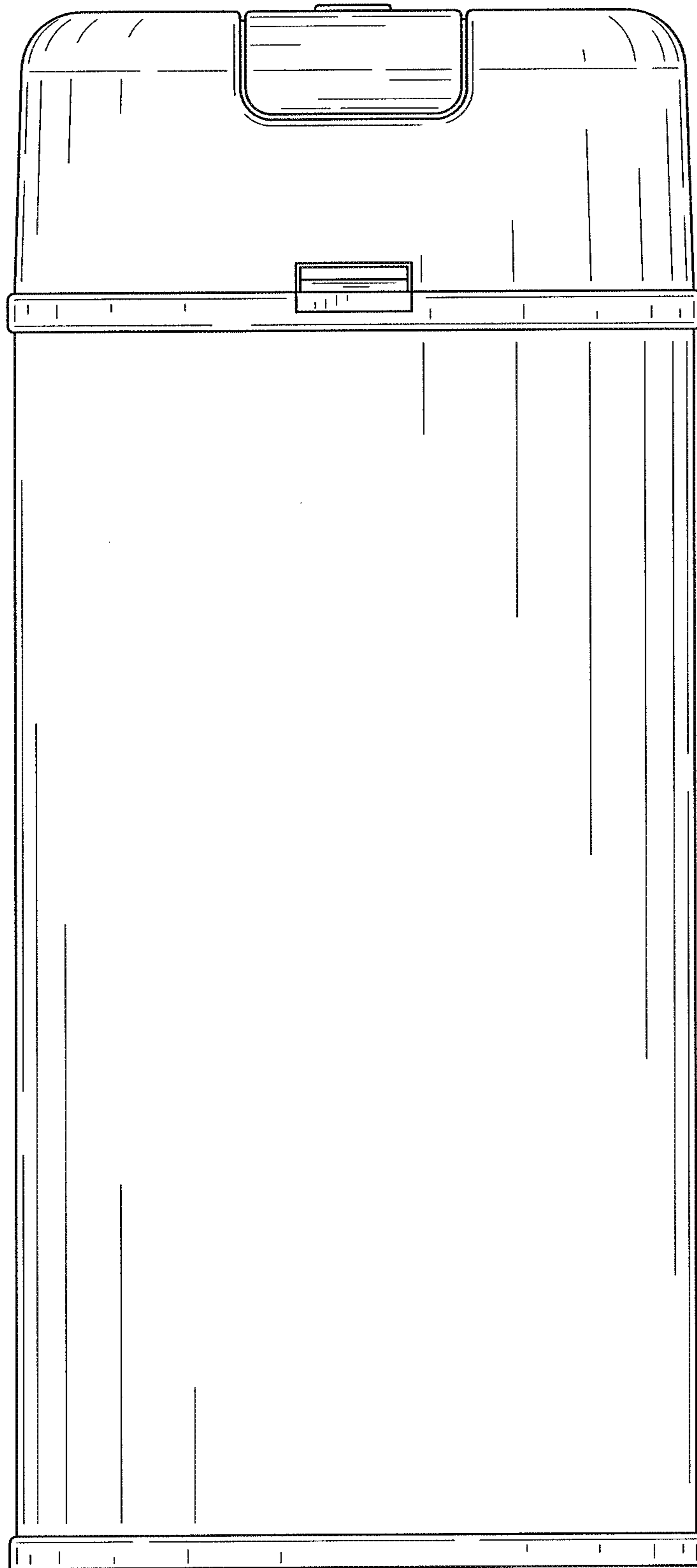

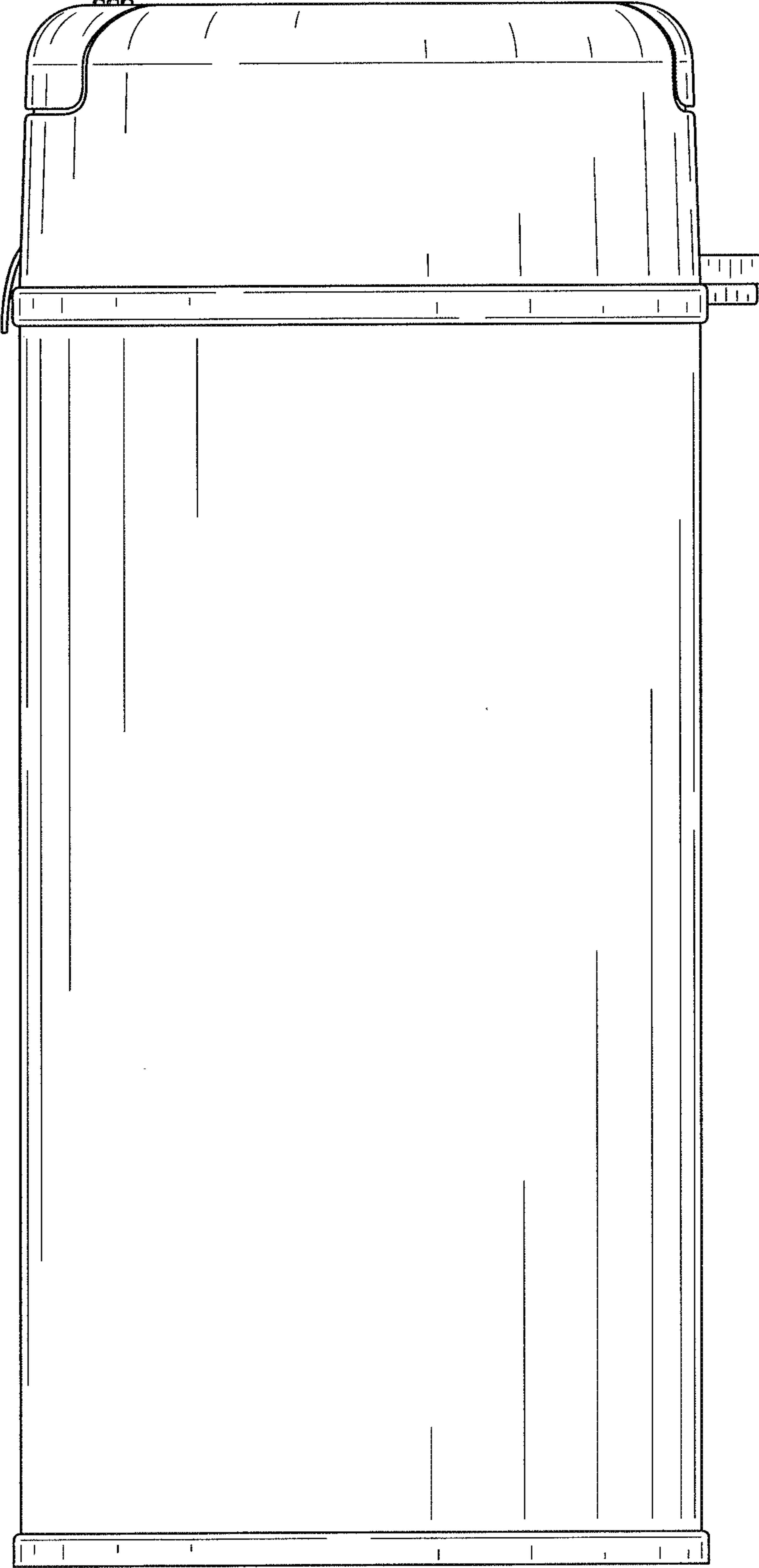

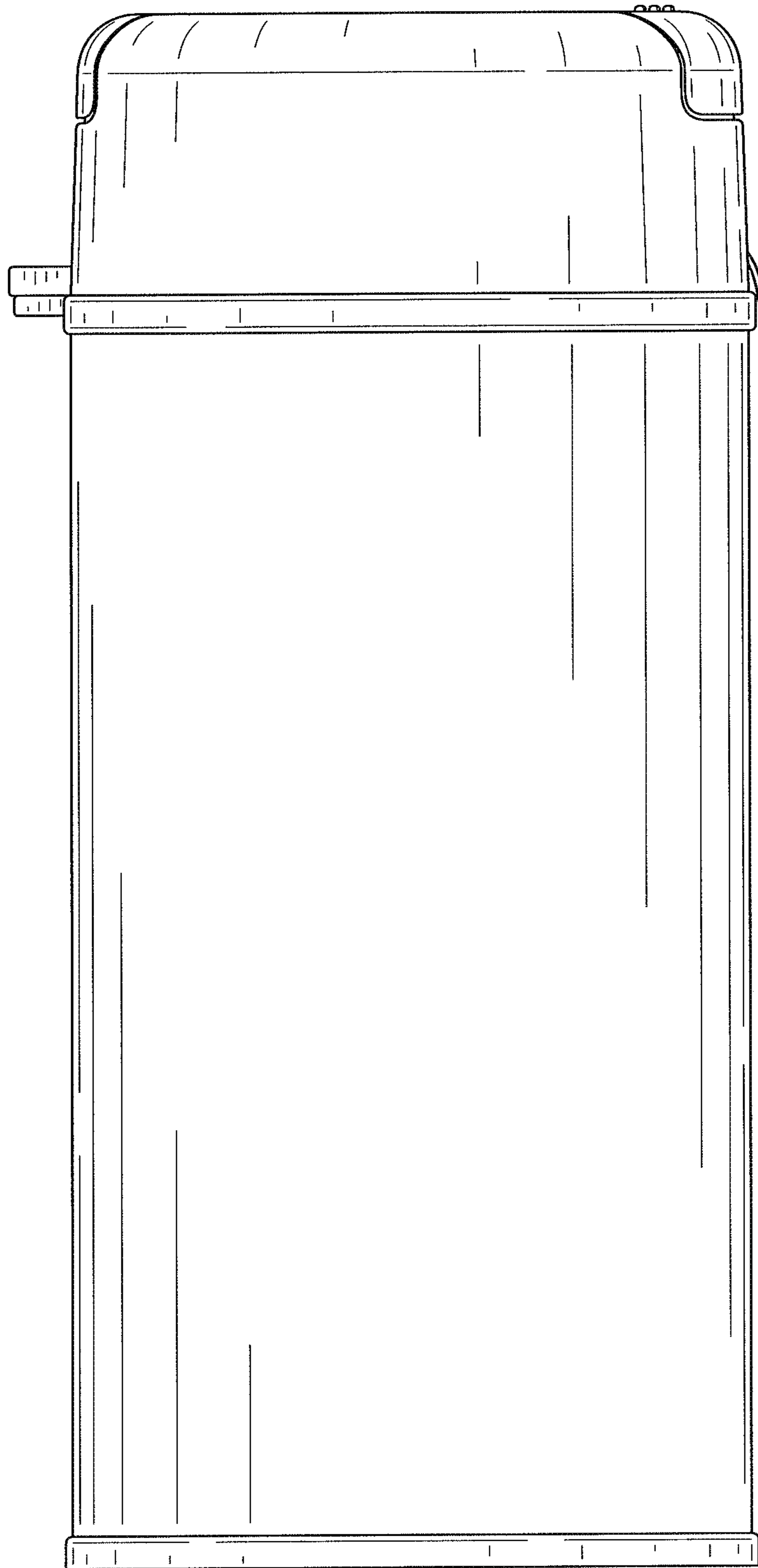

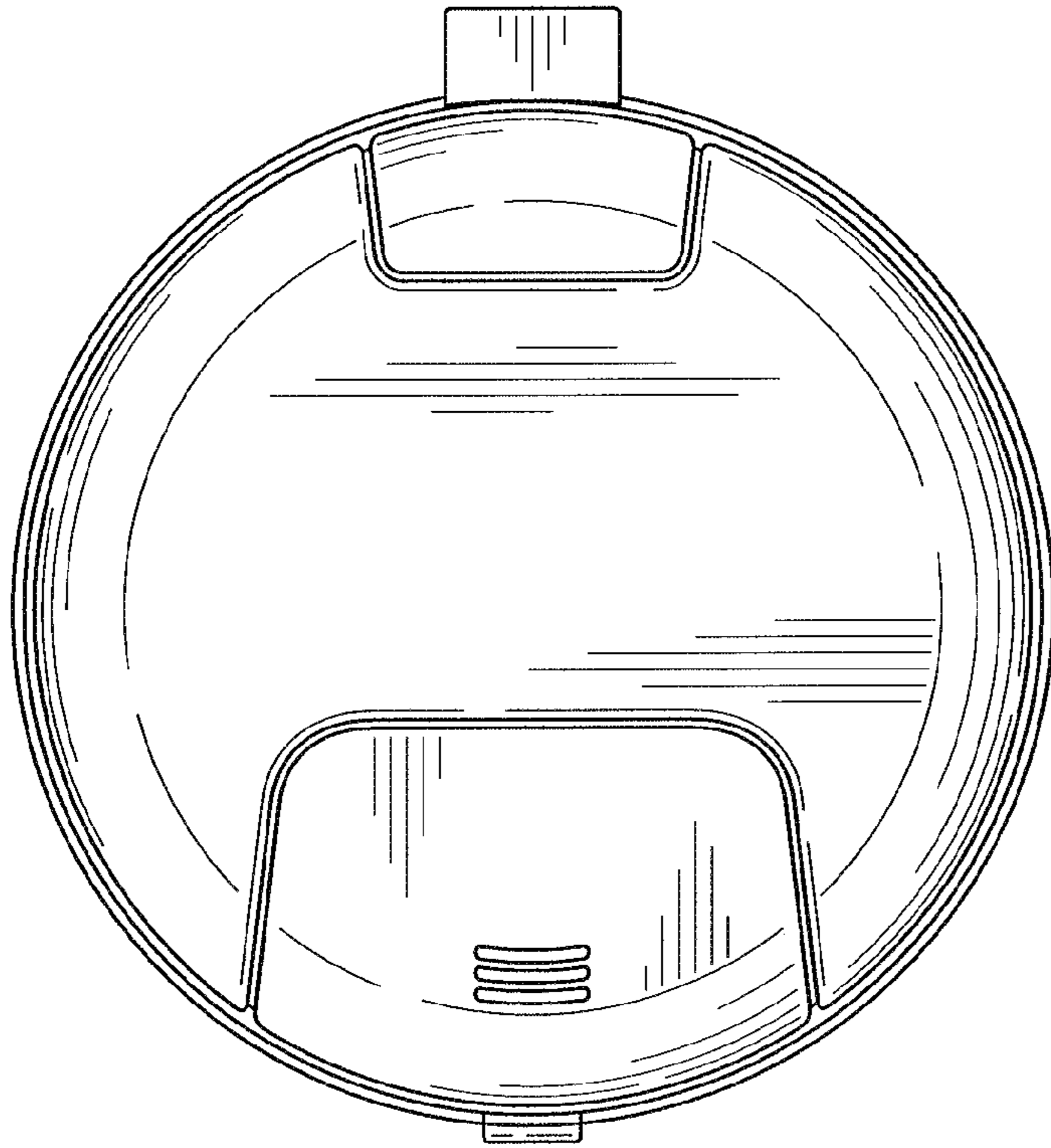

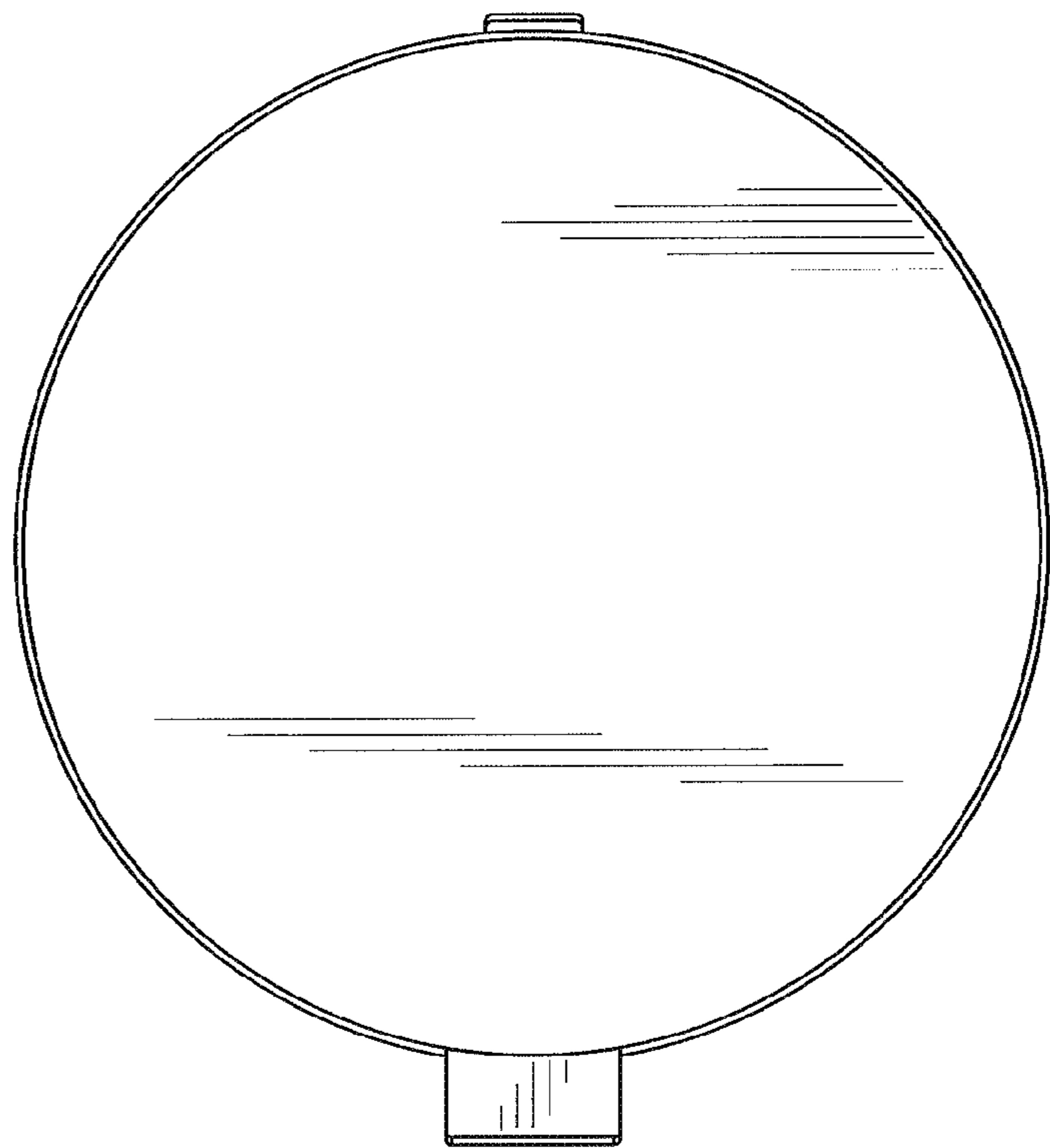

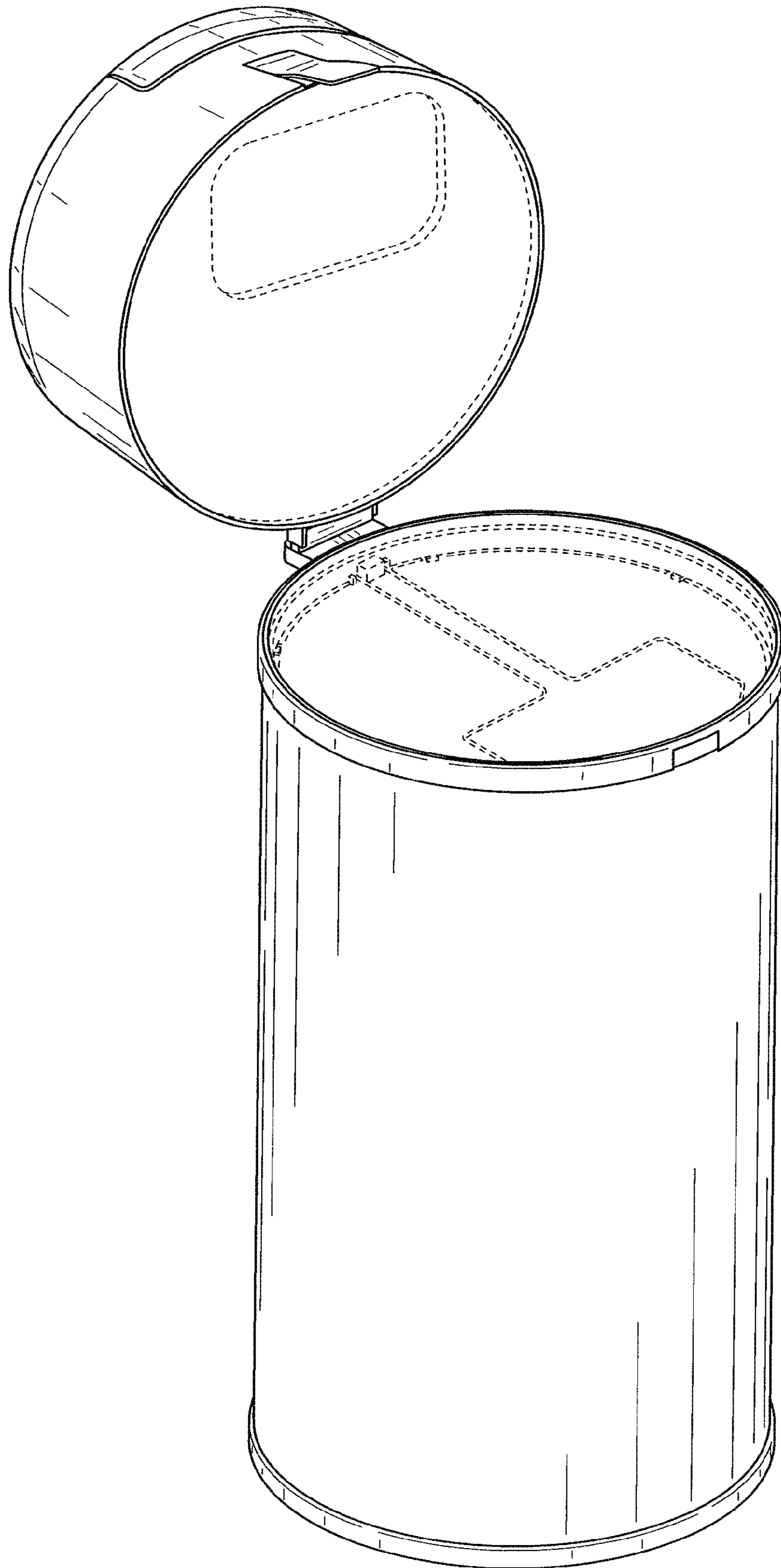

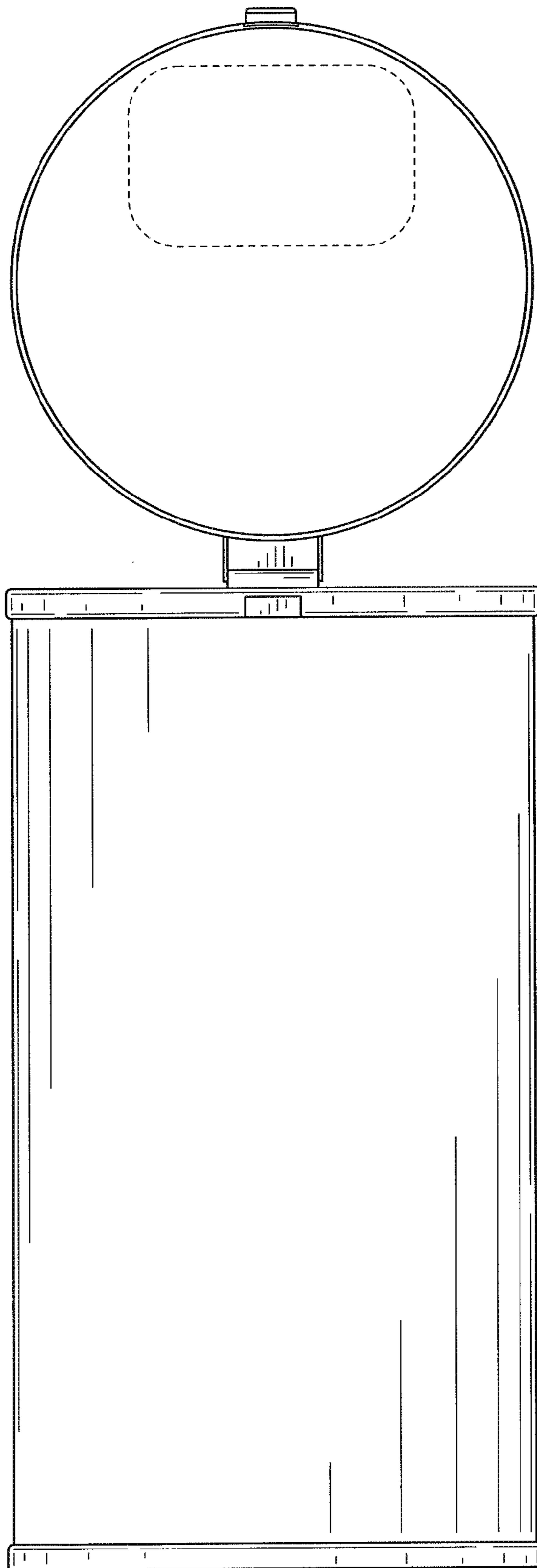

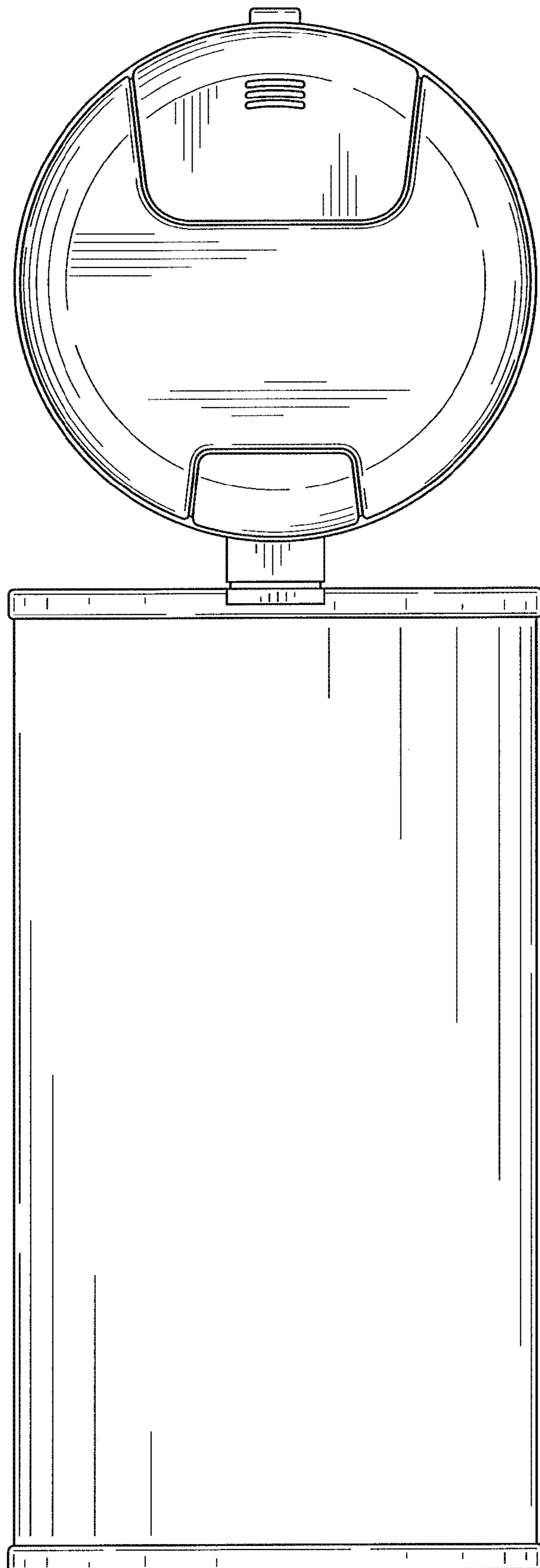

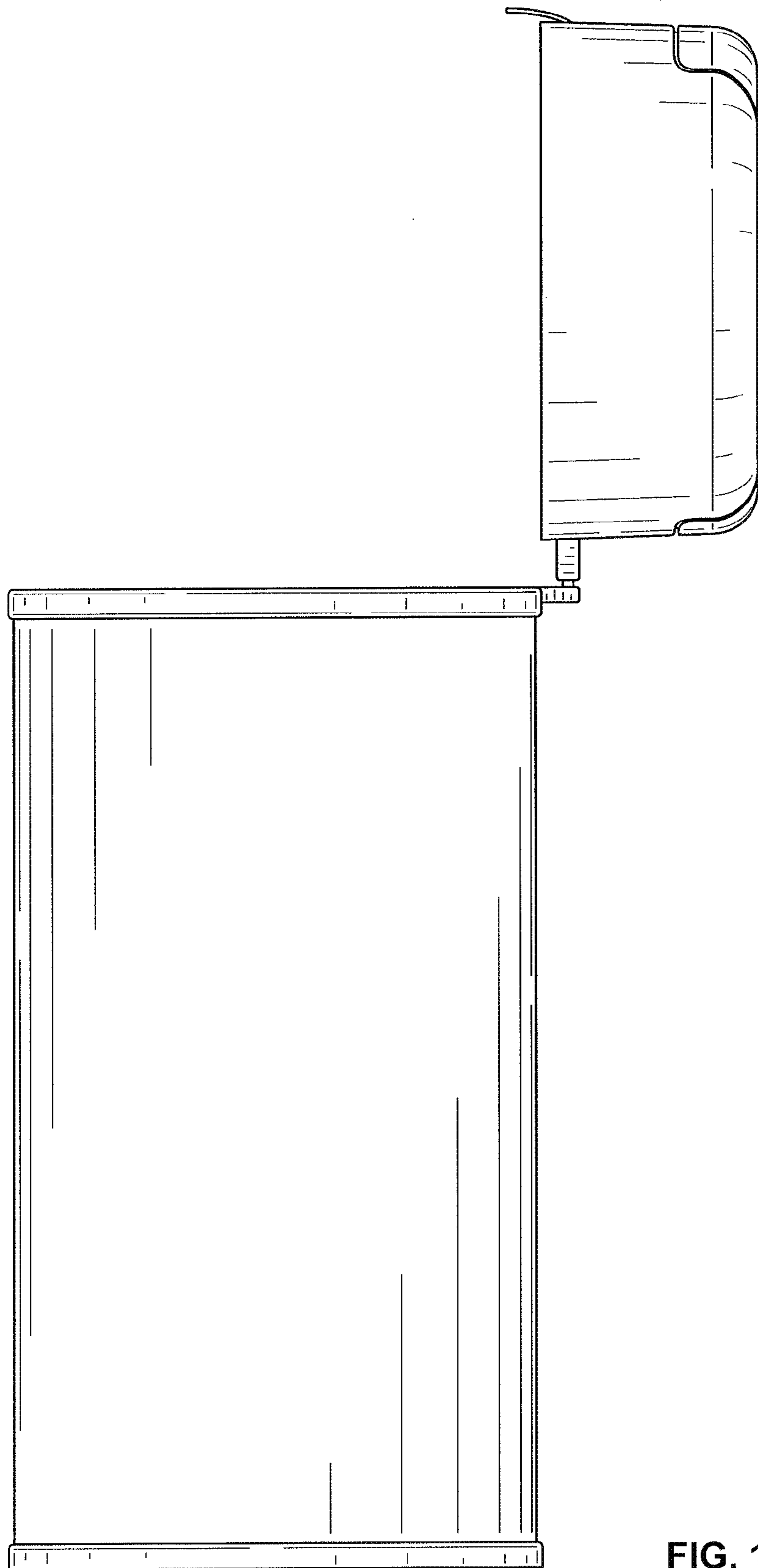

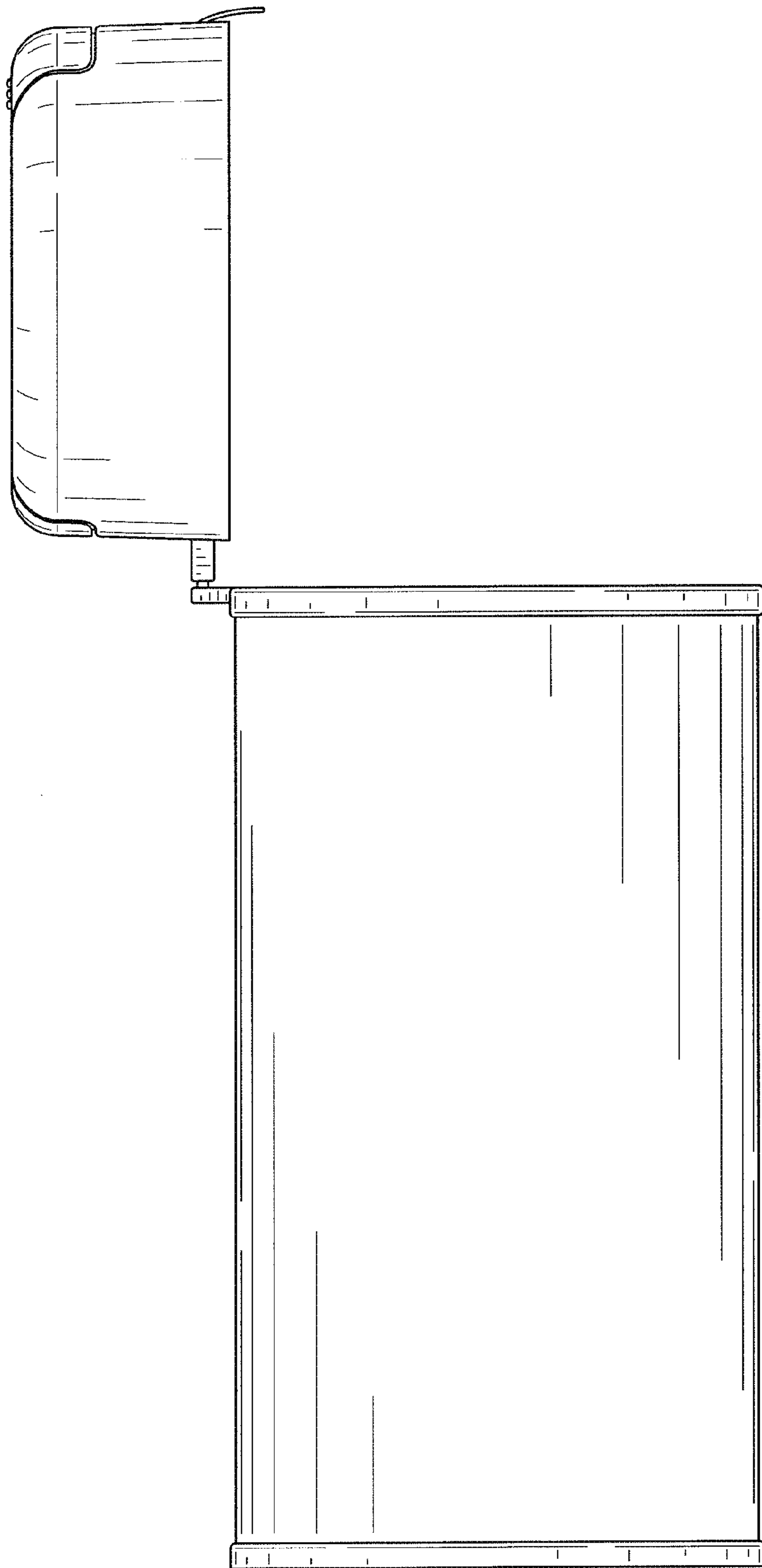

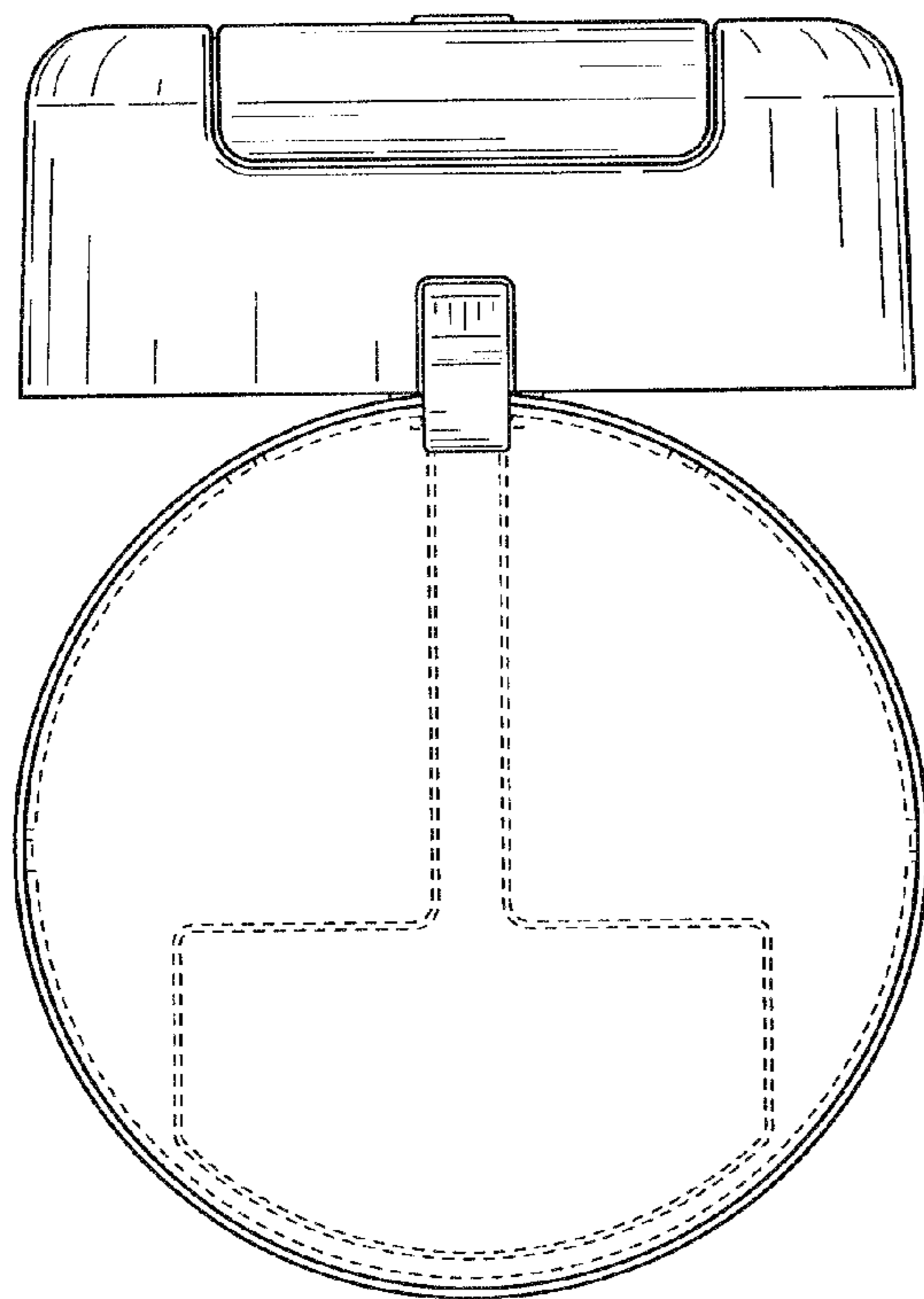

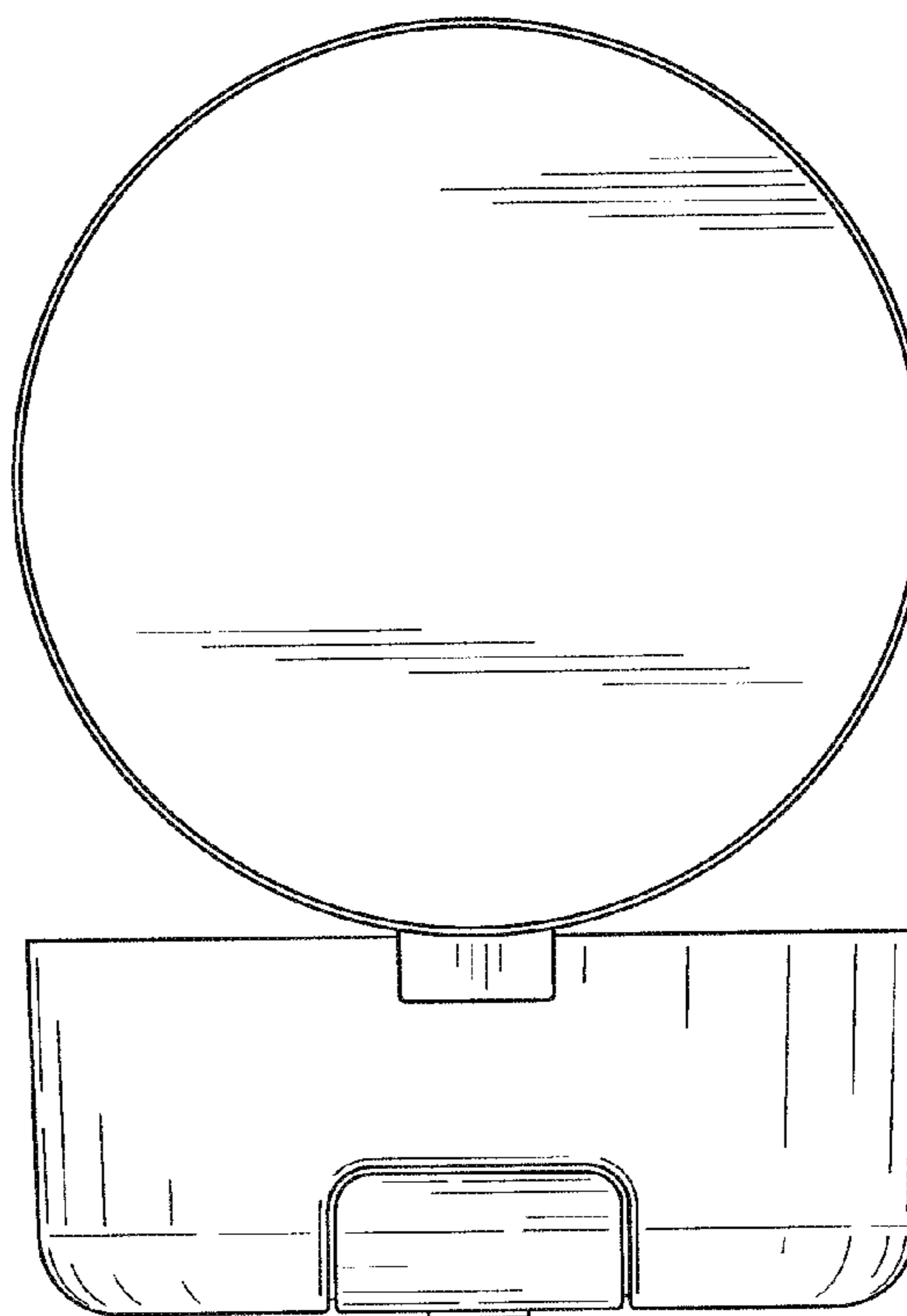
