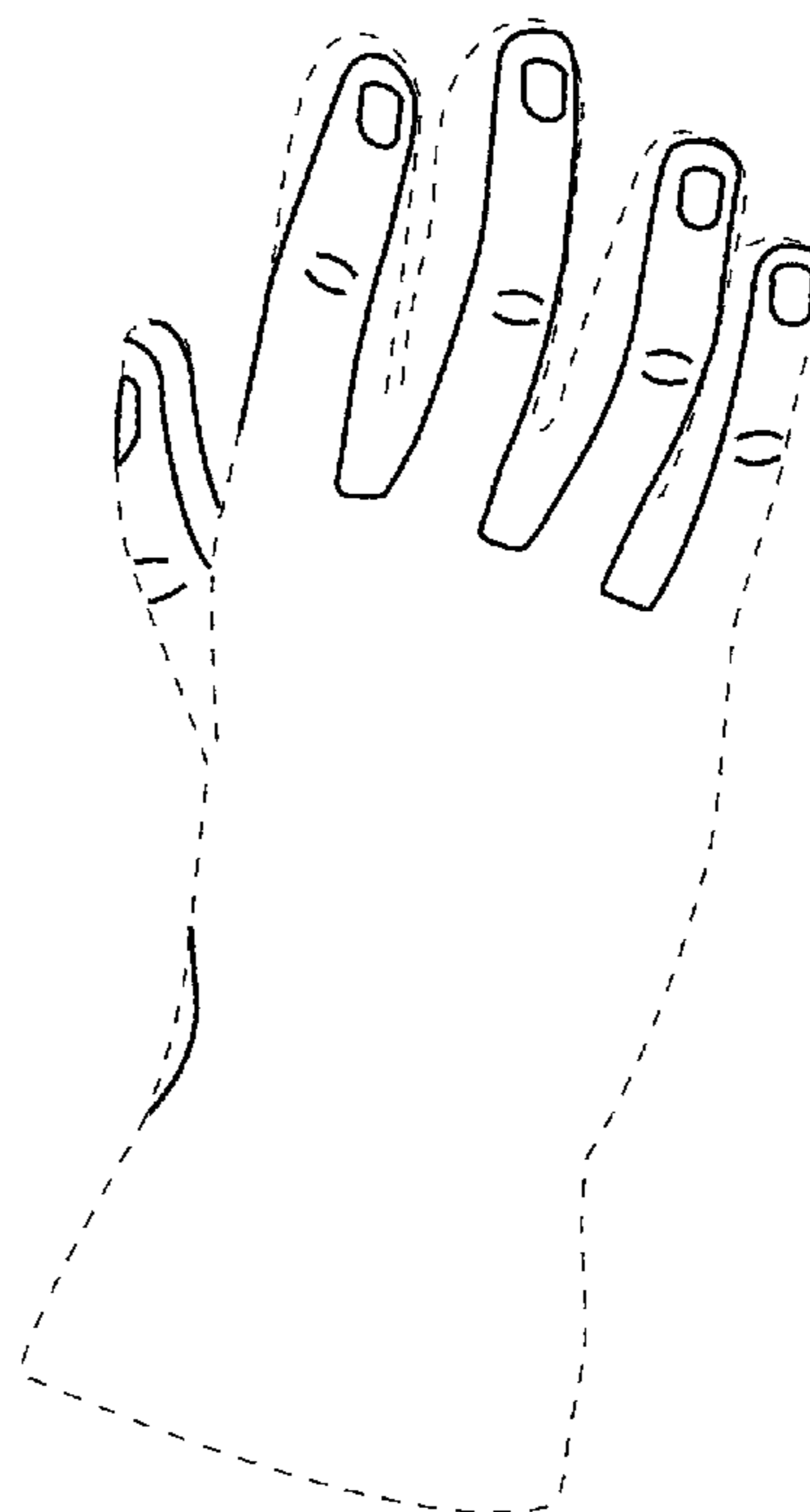
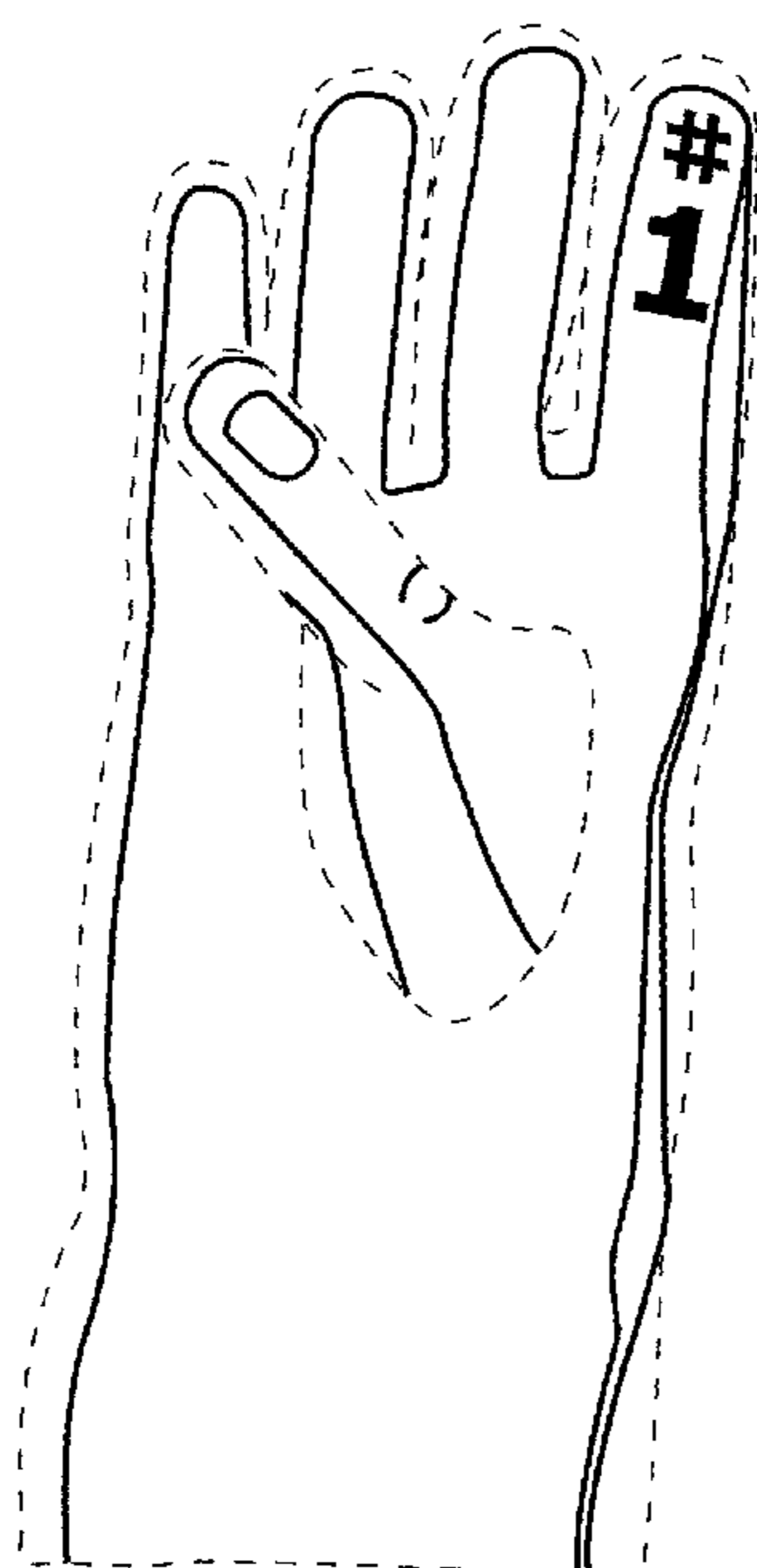
(57) **CLAIM**

The ornamental design for a glove, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the glove showing a thumb portion in a first position;
FIG. 2 is a rear perspective view thereof showing the thumb portion in a second position;
FIG. 3 is a right side elevation view of the glove in the position of FIG. 1;
FIG. 4 is a top plan view of the glove in the position of FIG. 1 with the fingers straightened; and,
FIG. 5 is a left side elevation view of the glove in the position of FIG. 1.
The design includes outlines of fingers and features of fingers, along with indicia on a finger outline. The glove shown in broken lines in the Figures illustrates those portions of the article to which the design is applied that form no part of the claim.

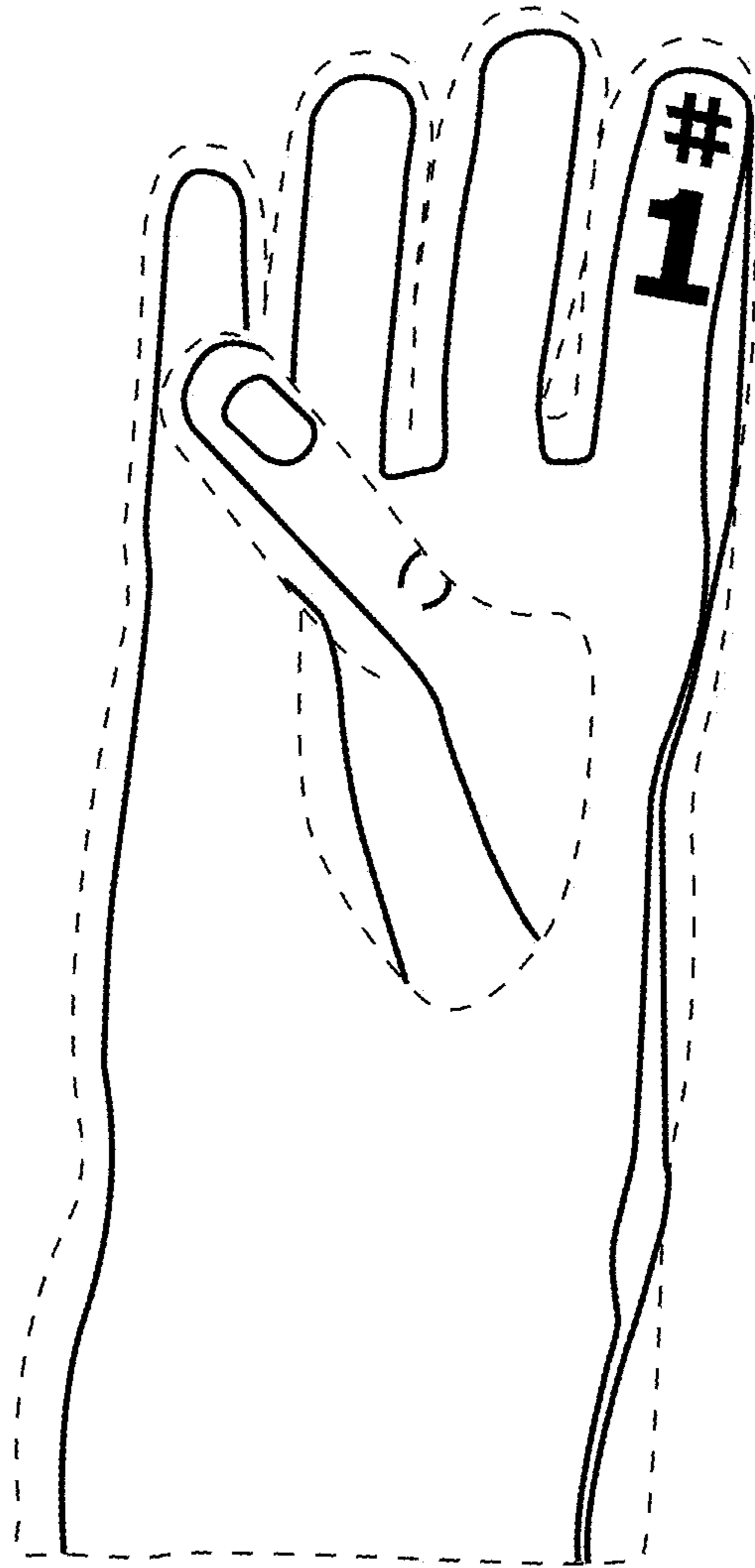

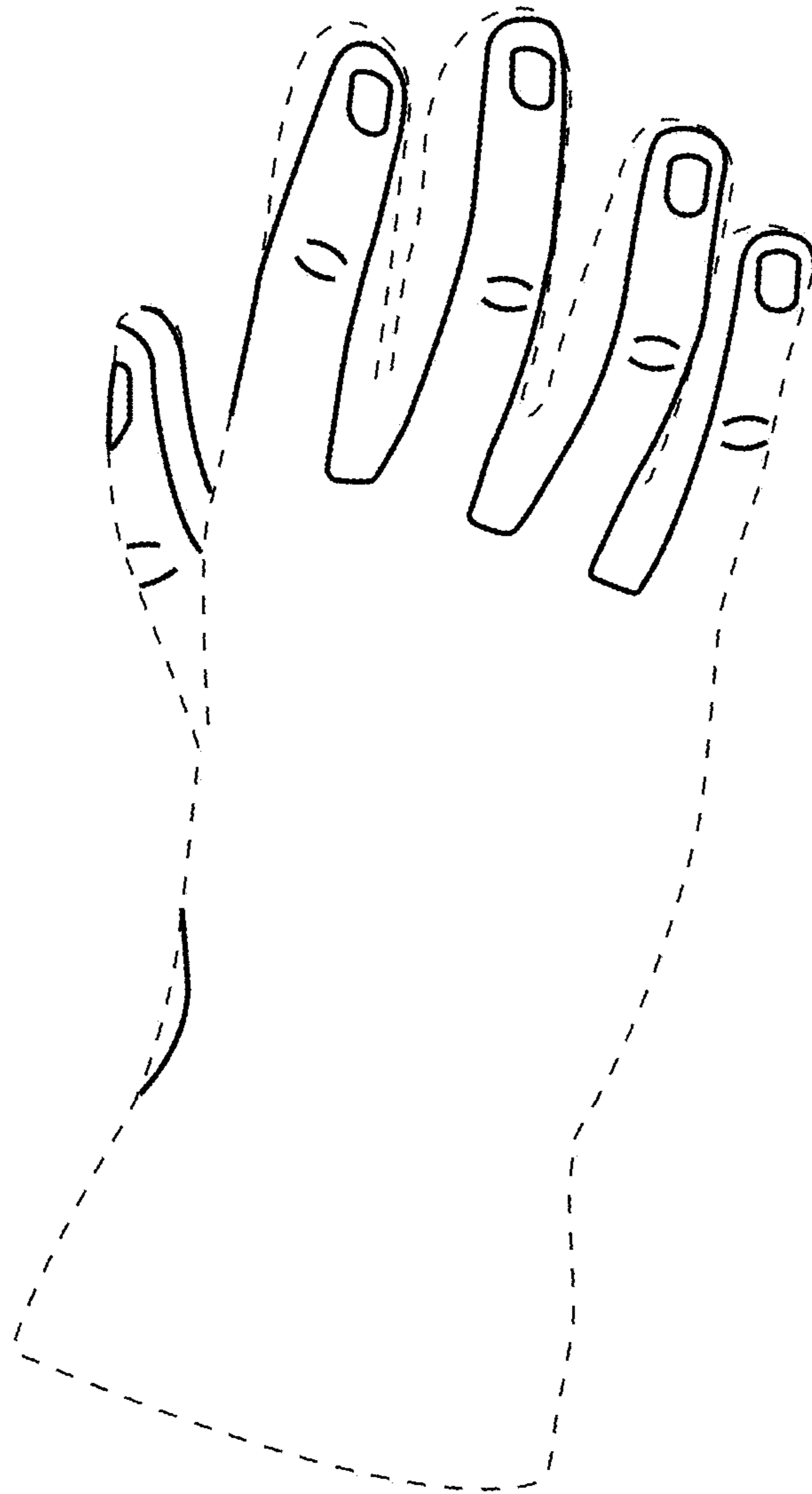

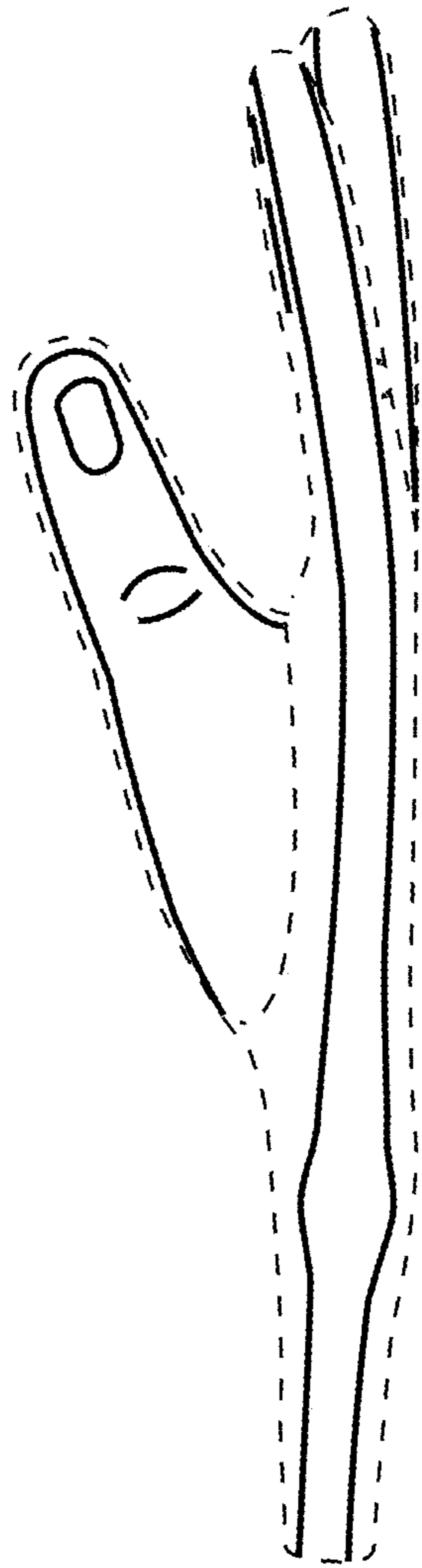

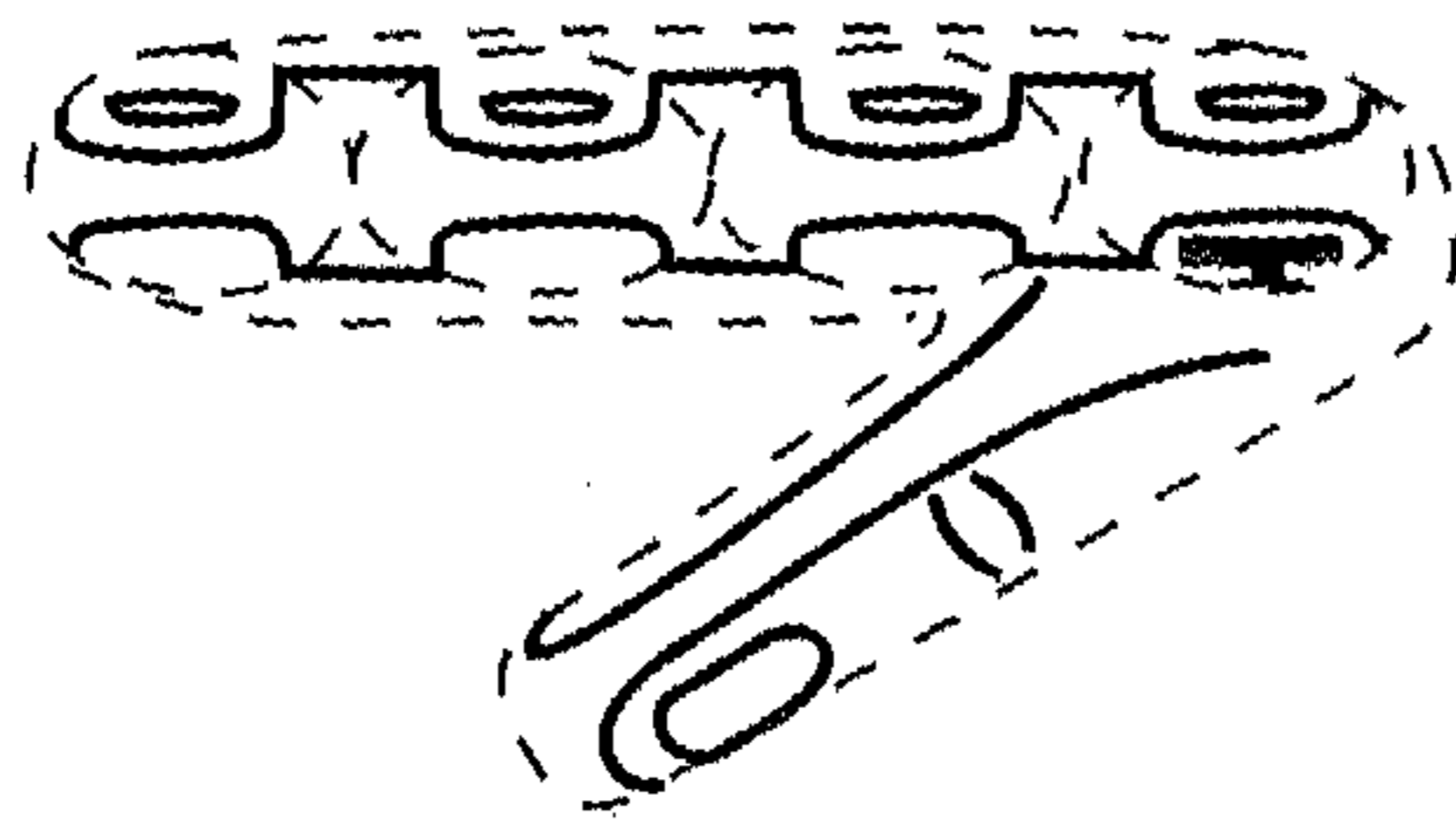

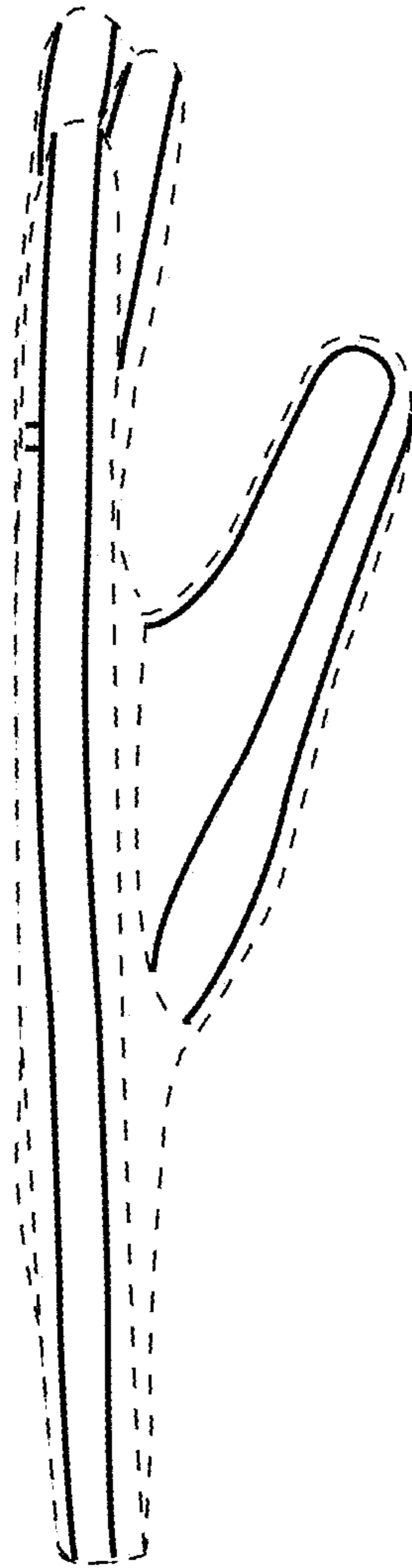
