FIG. 1 is a front view of trousers showing my new and ornamental design,

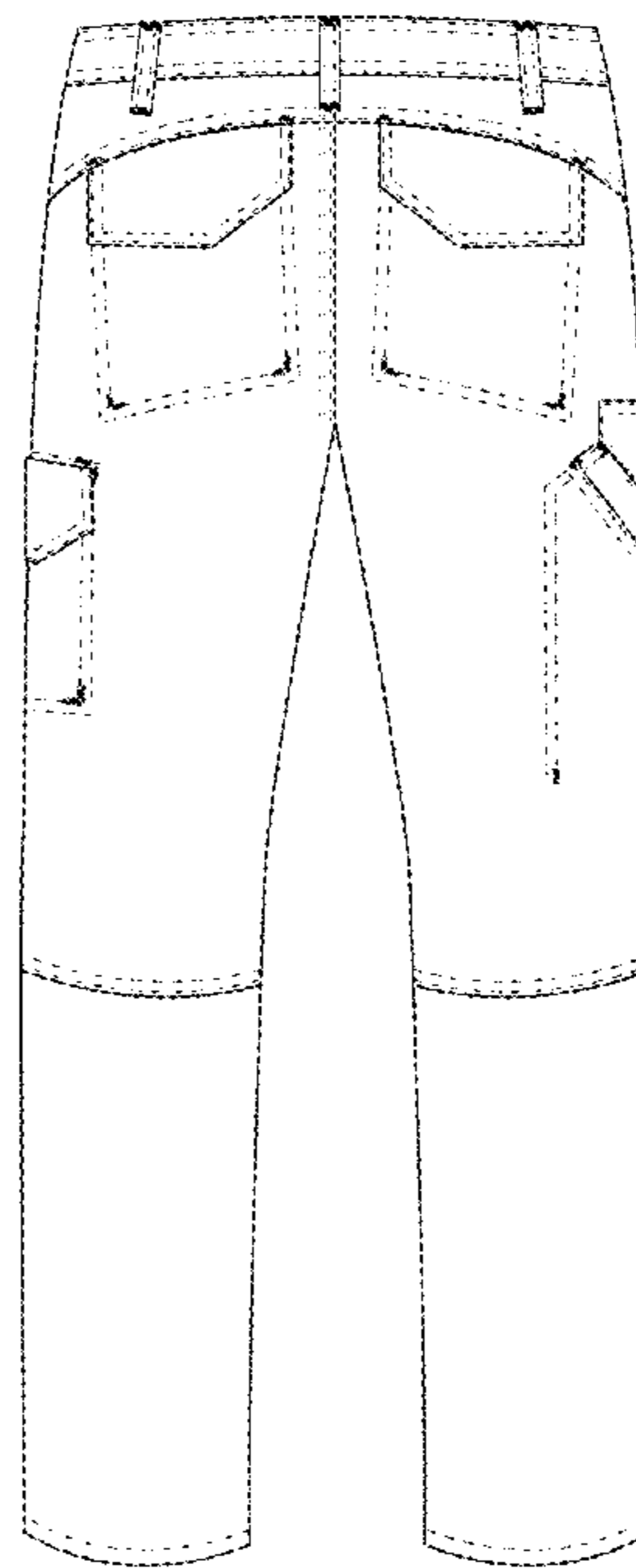
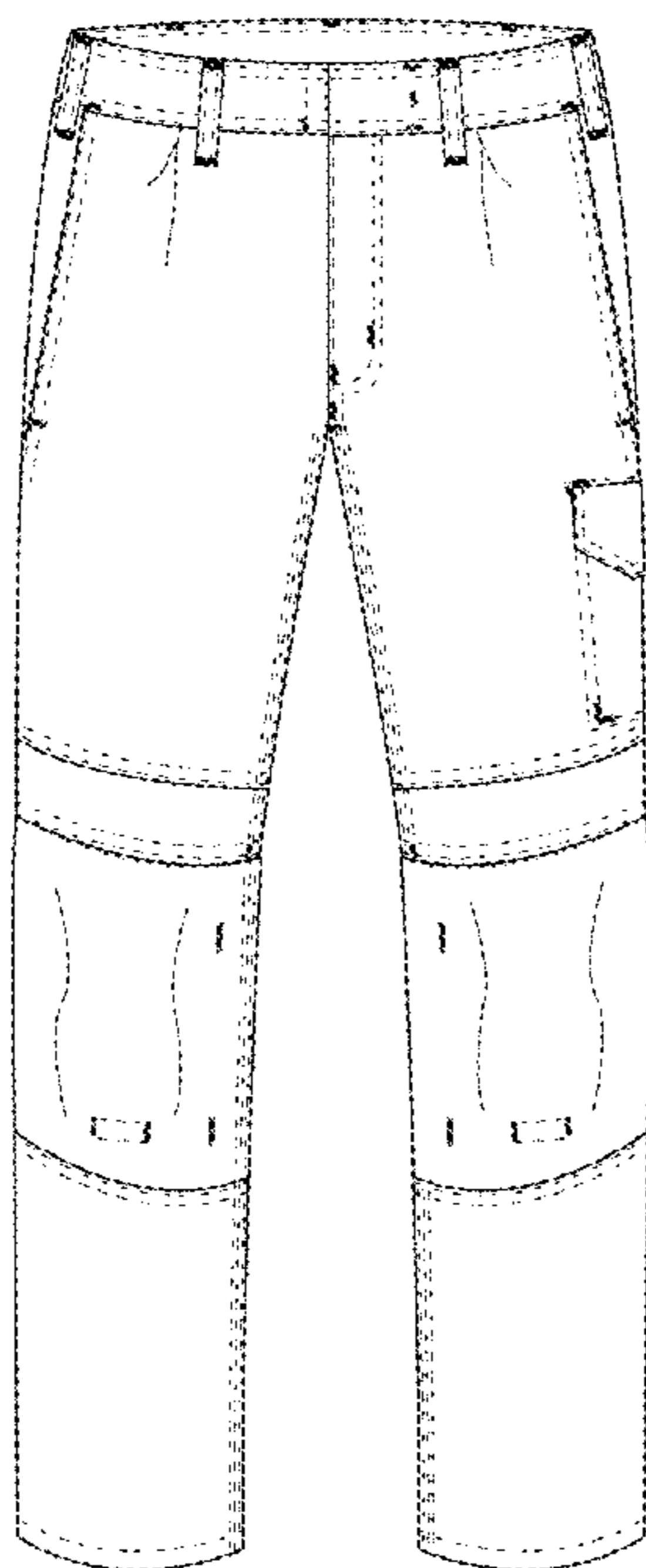
FIG. 2 is a rear view thereof,

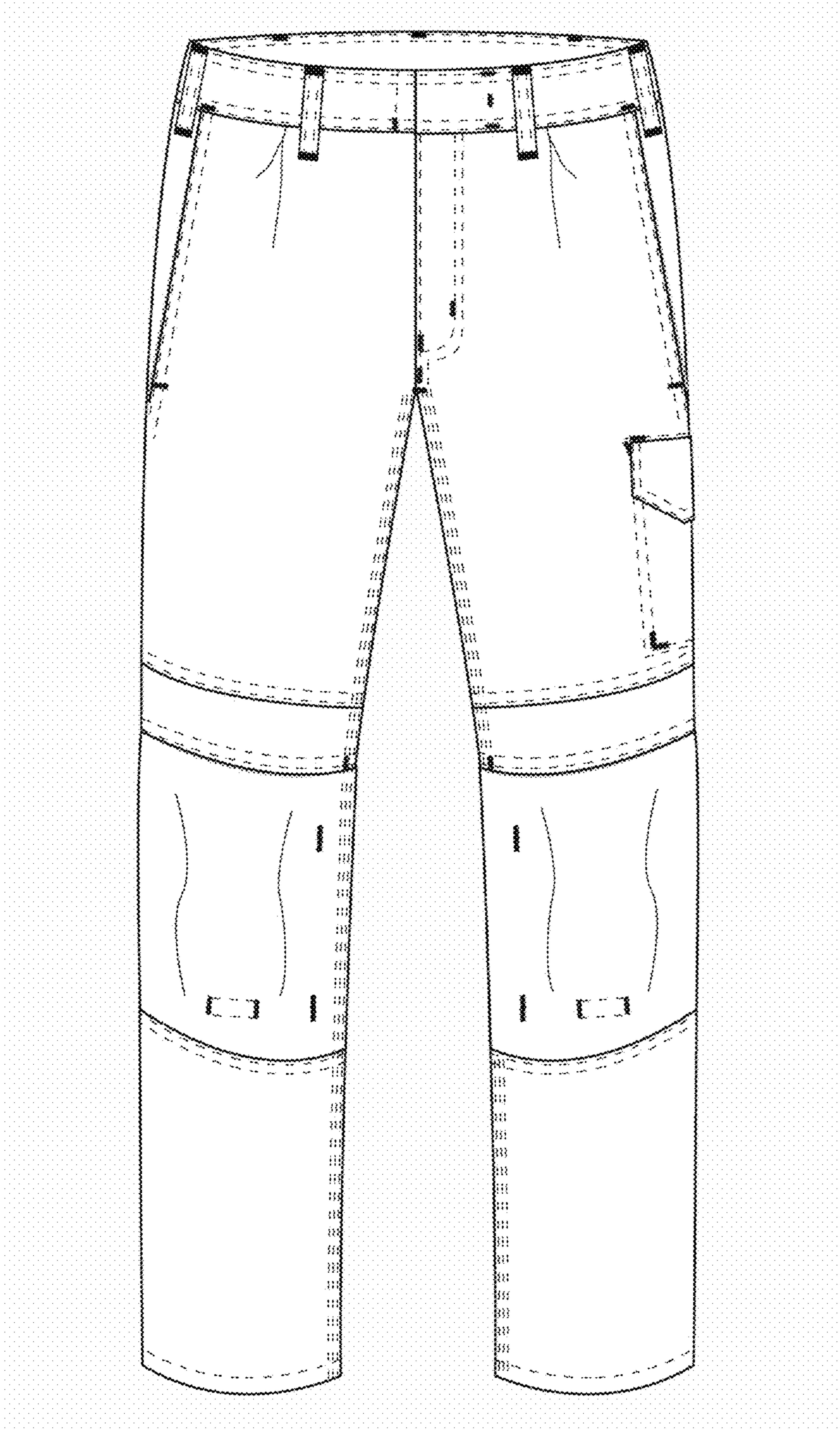

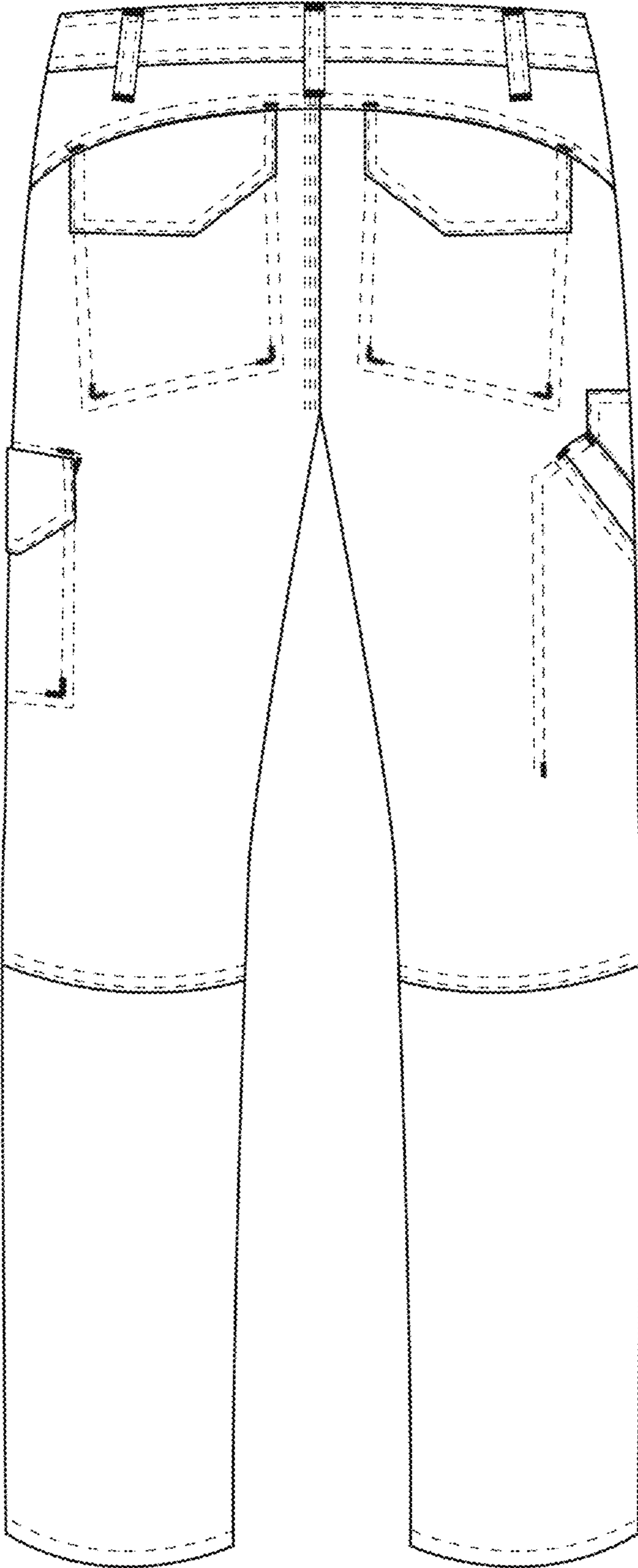

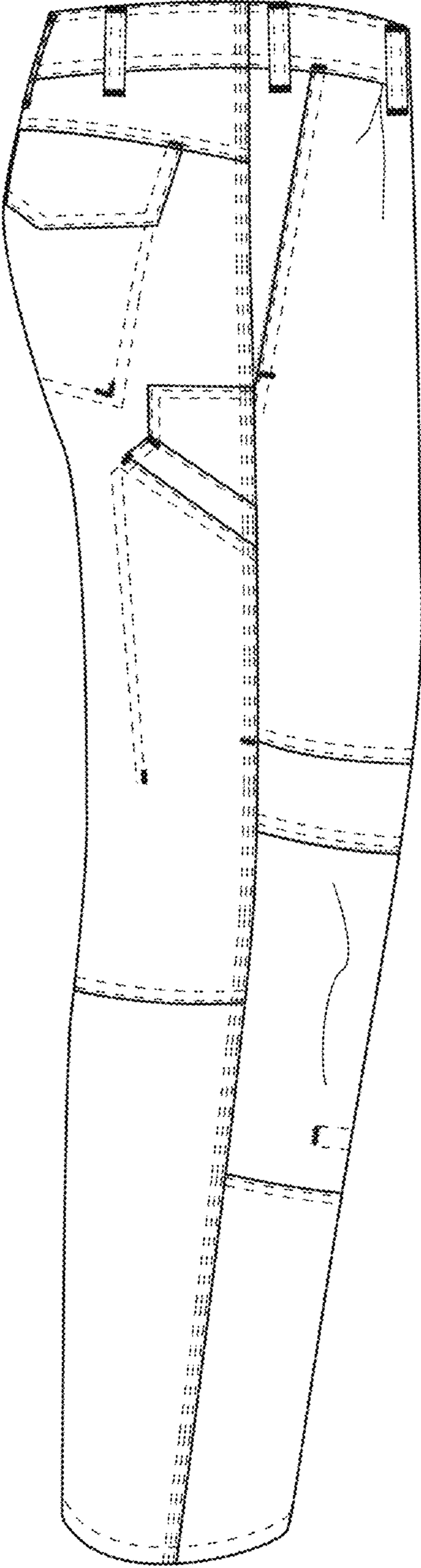

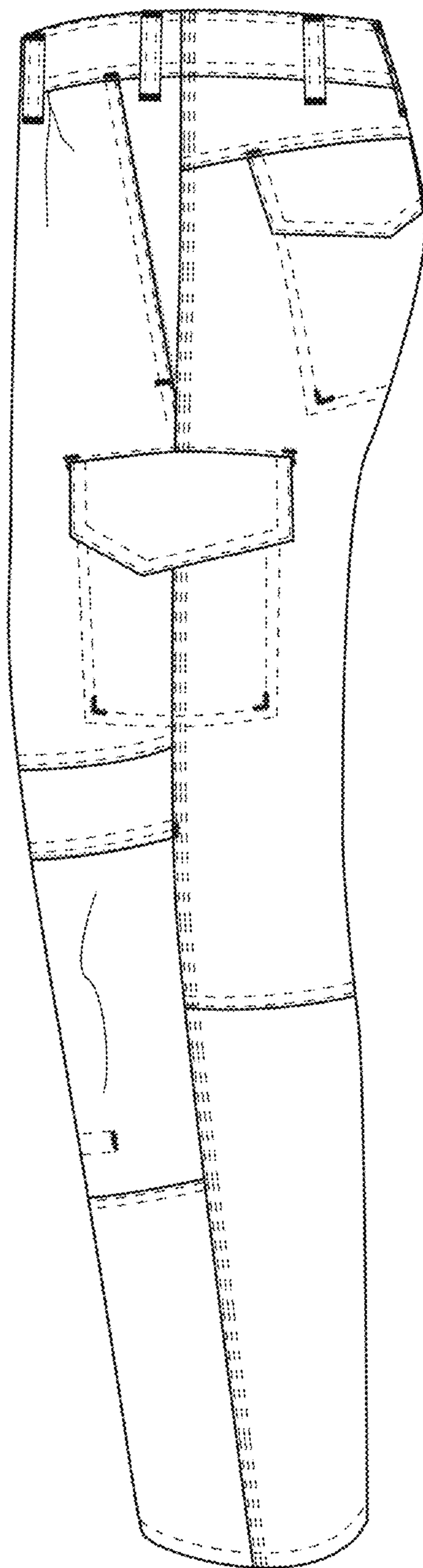
