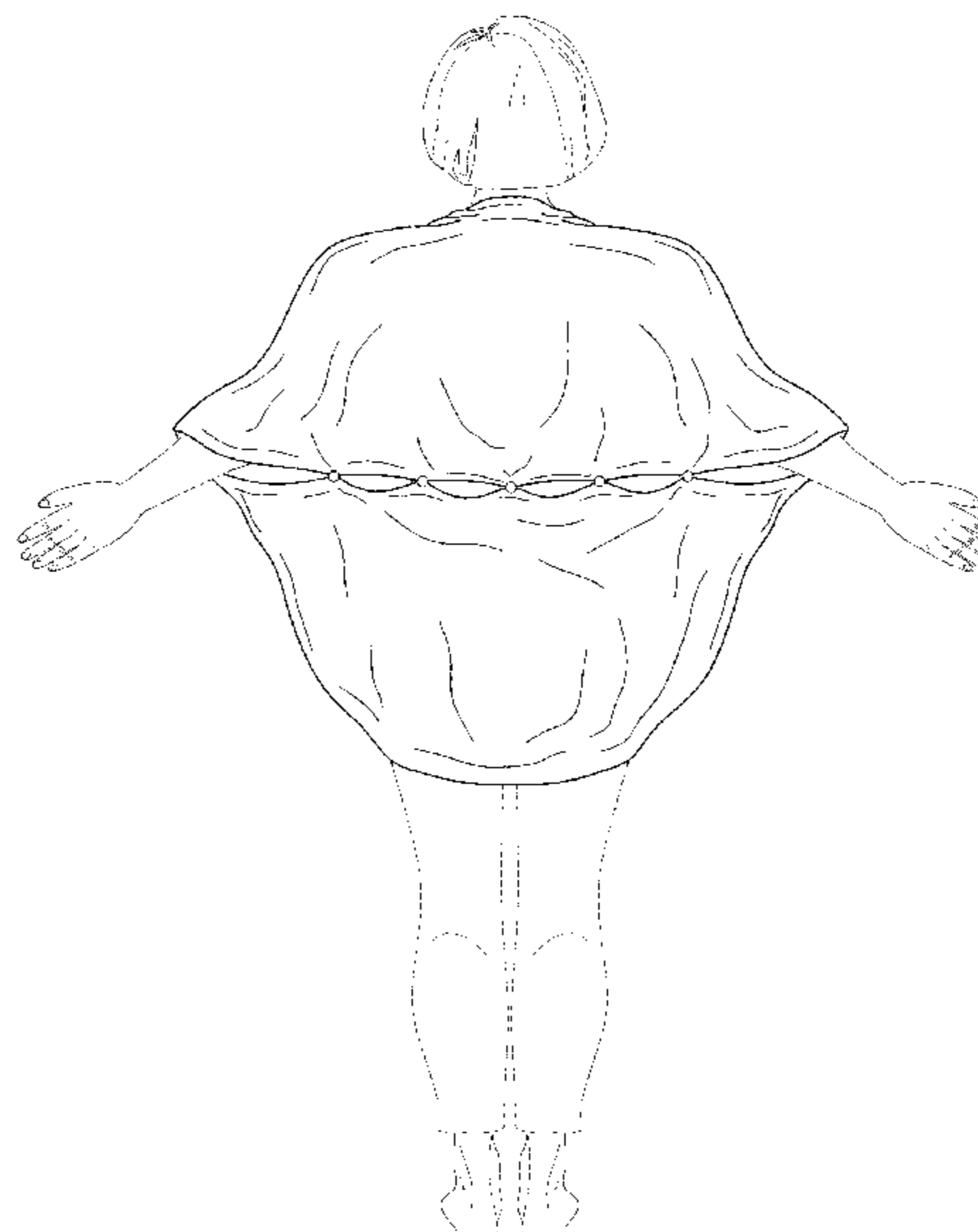
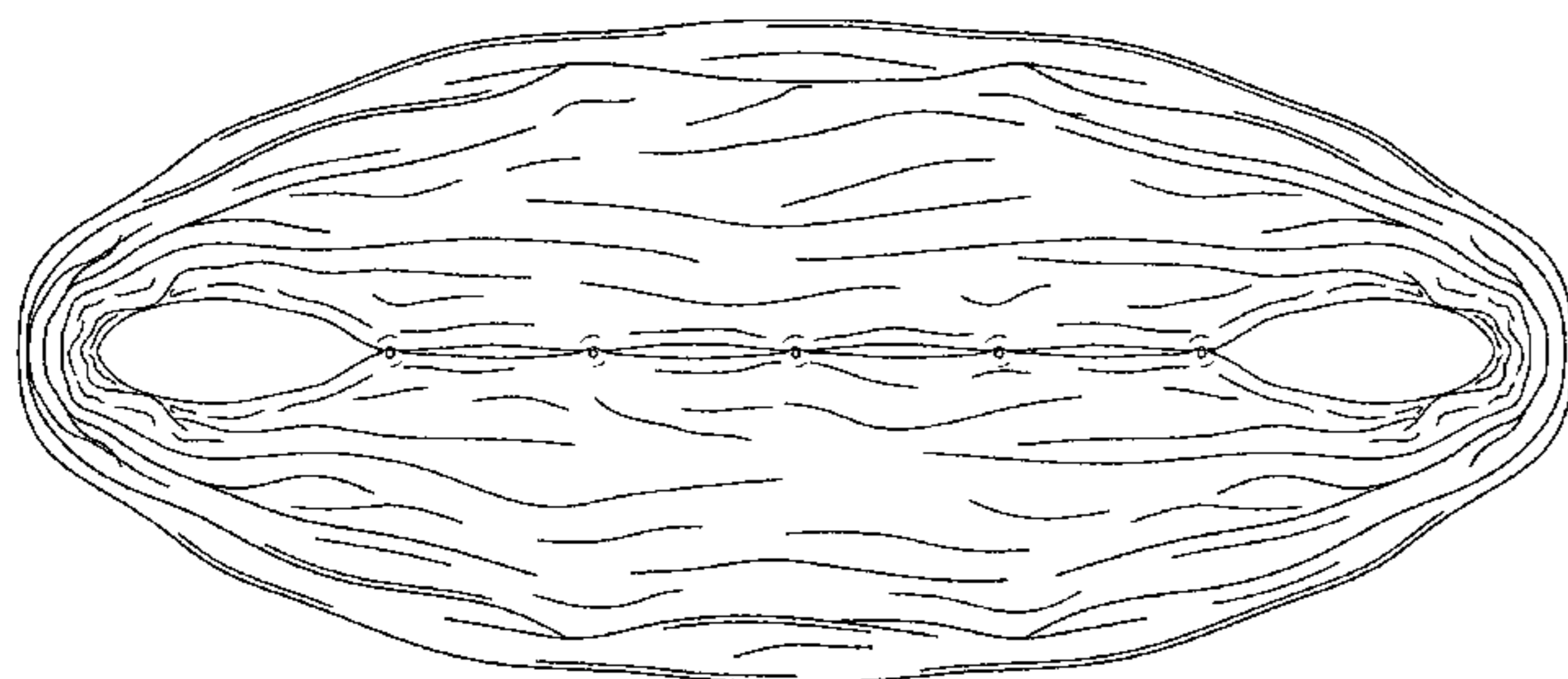
(57) **CLAIM**

The ornamental design for the convertible shrug, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the convertible shrug. FIG. 2 is a rear perspective view of the convertible shrug. FIG. 3 is a top plan view of the convertible shrug. FIG. 4 is a bottom plan view of the convertible shrug. FIG. 5 is a right side elevation view of the convertible shrug. FIG. 6 is left side elevation view of the convertible shrug. FIG. 7 is front elevational view of the convertible shrug. FIG. 8 is a rear elevational view of the convertible shrug. FIG. 9 is a rear view of the convertible shrug in use. FIG. 10 is a front view of the convertible shrug in use. FIG. 11 is a right view of the convertible shrug in use. FIG. 12 is a top view of the convertible shrug in use. FIG. 13 is a front view of the convertible shrug in use as a scarf. FIG. 14 is a front view of the convertible shrug in use as a scarf. FIG. 15 is a top plan view, with the fabric laying flat on the floor; and, FIG. 16 is a side view, but assembled in the shape to be used as a scarf. The broken lines shown in FIGS. 9-14 show the convertible shrug in use as worn forming no part of the claimed design.

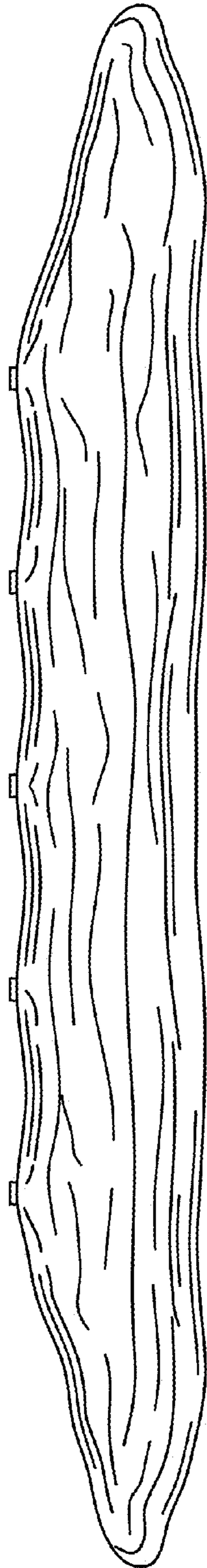

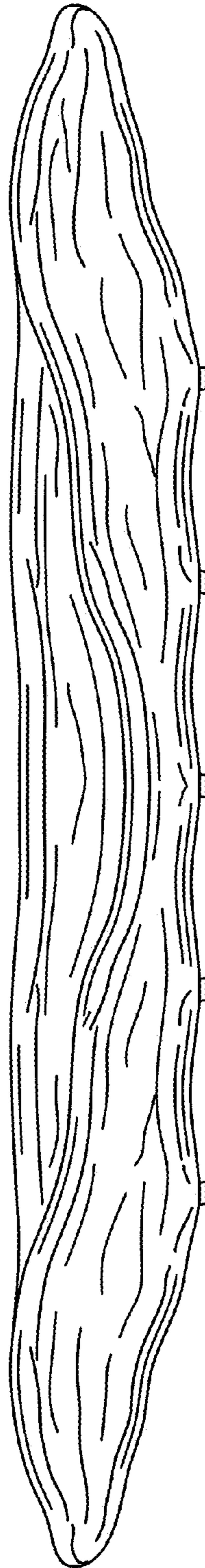

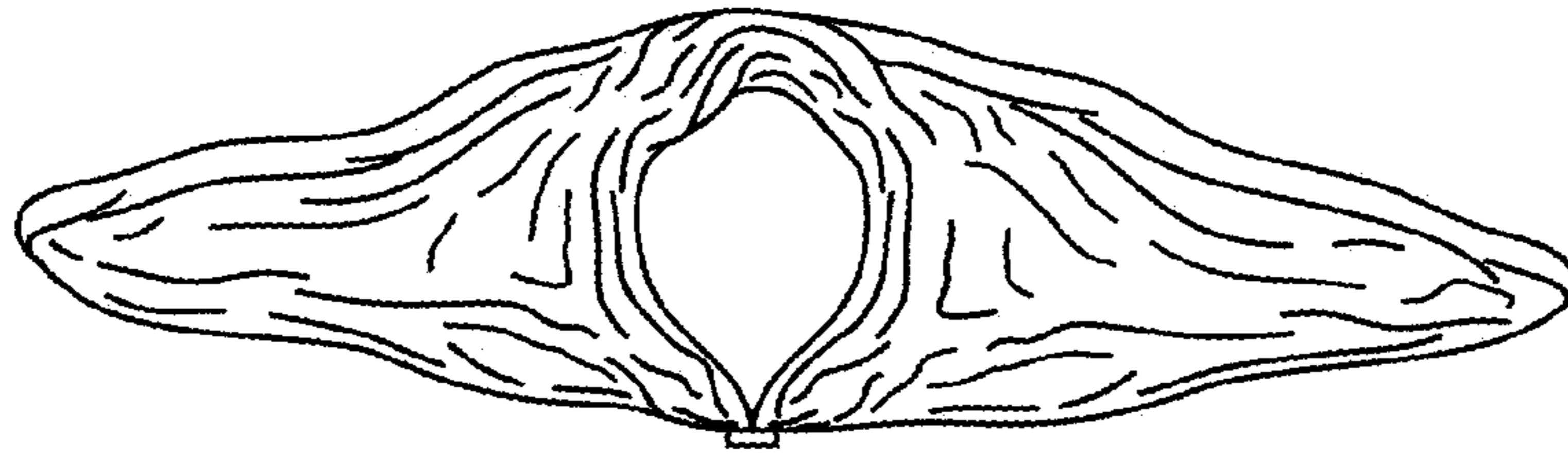

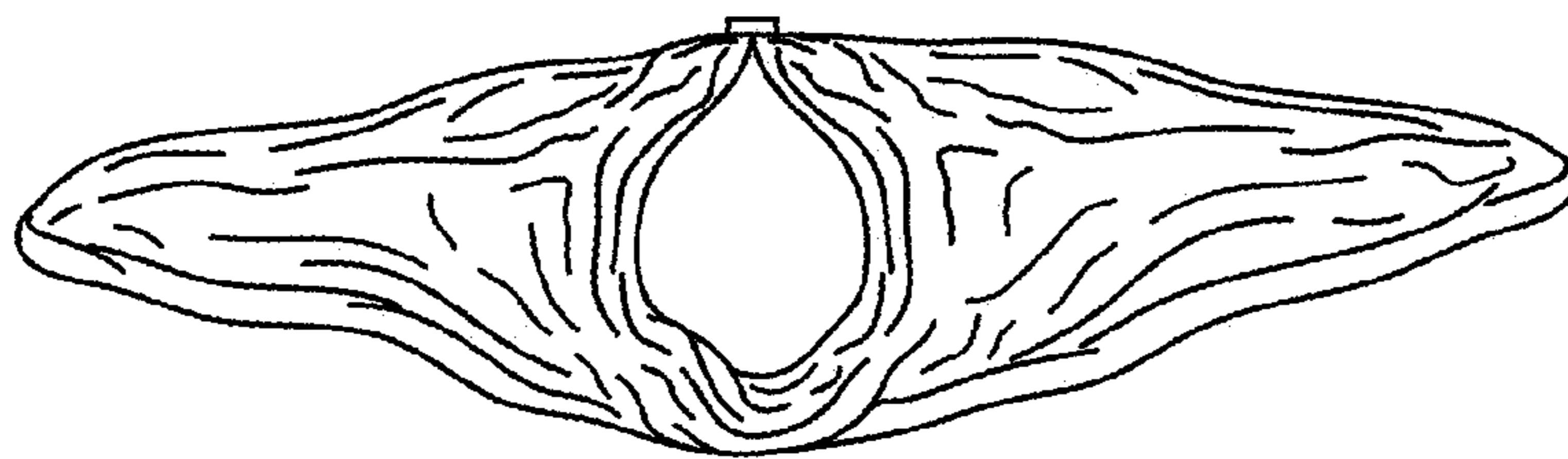

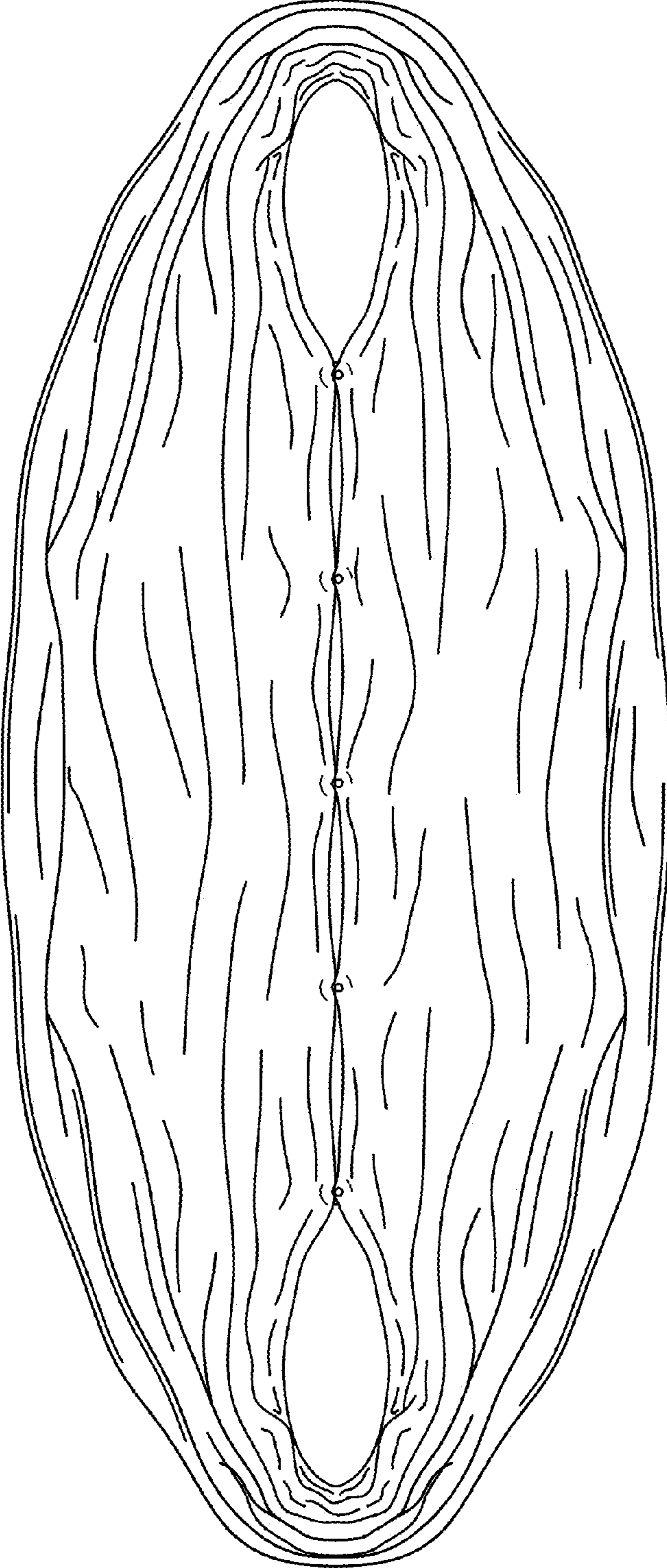

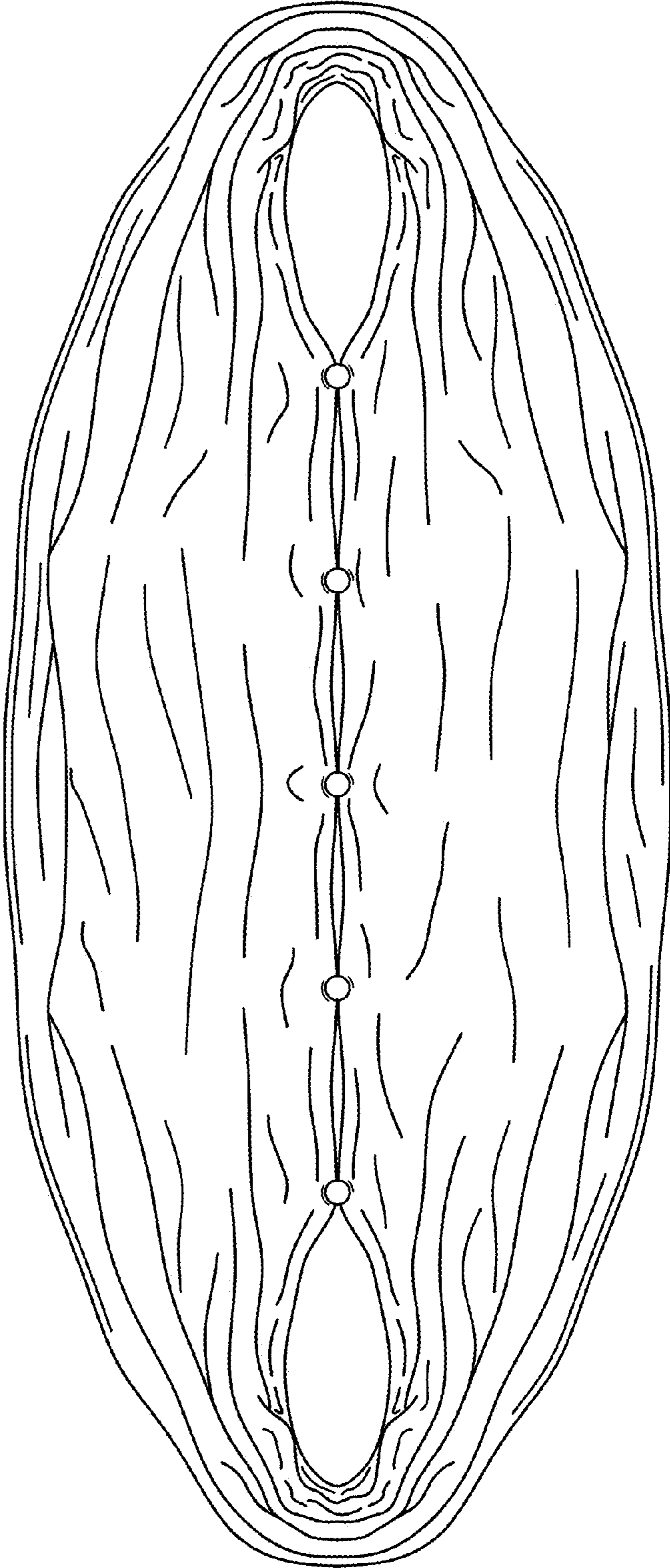

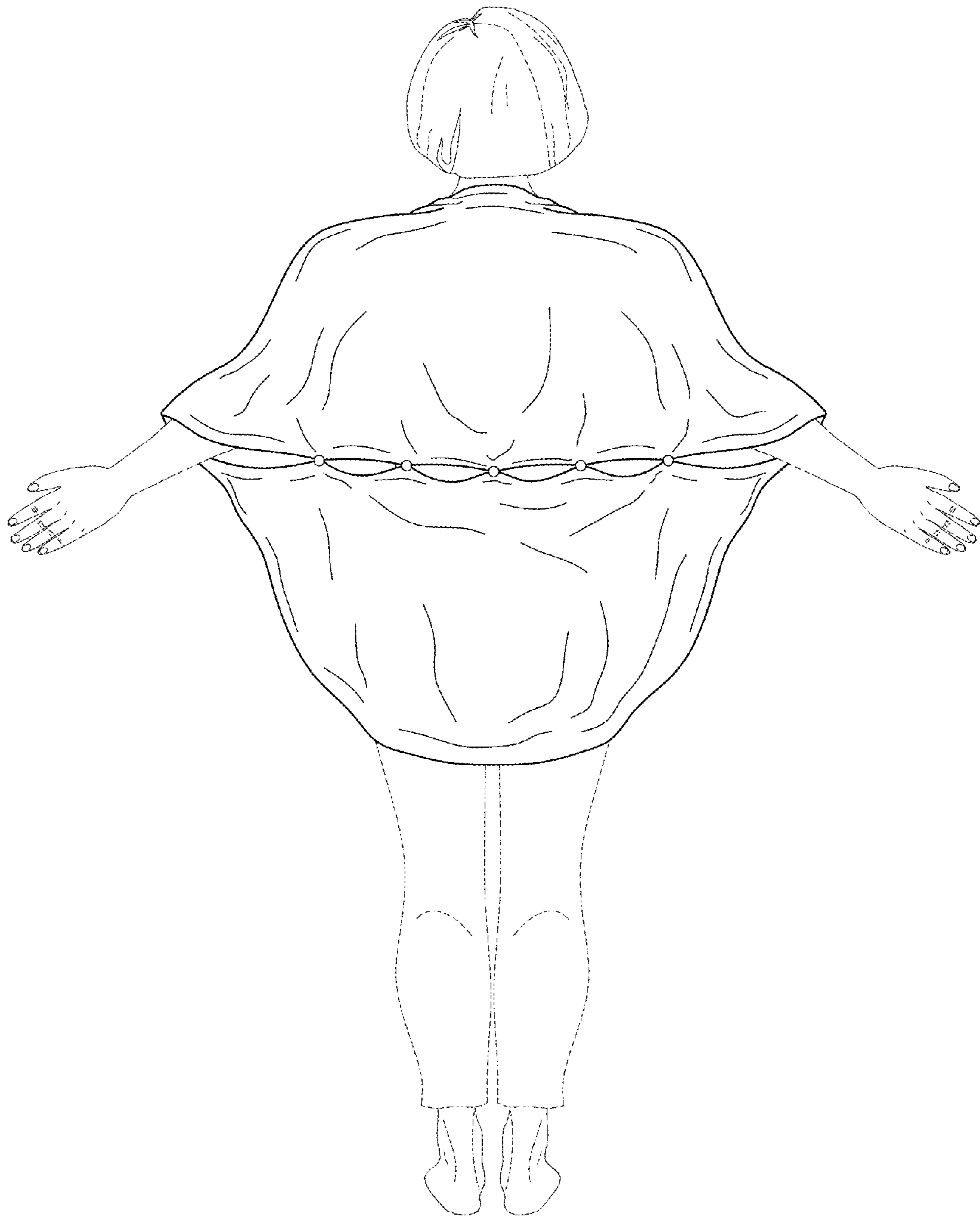

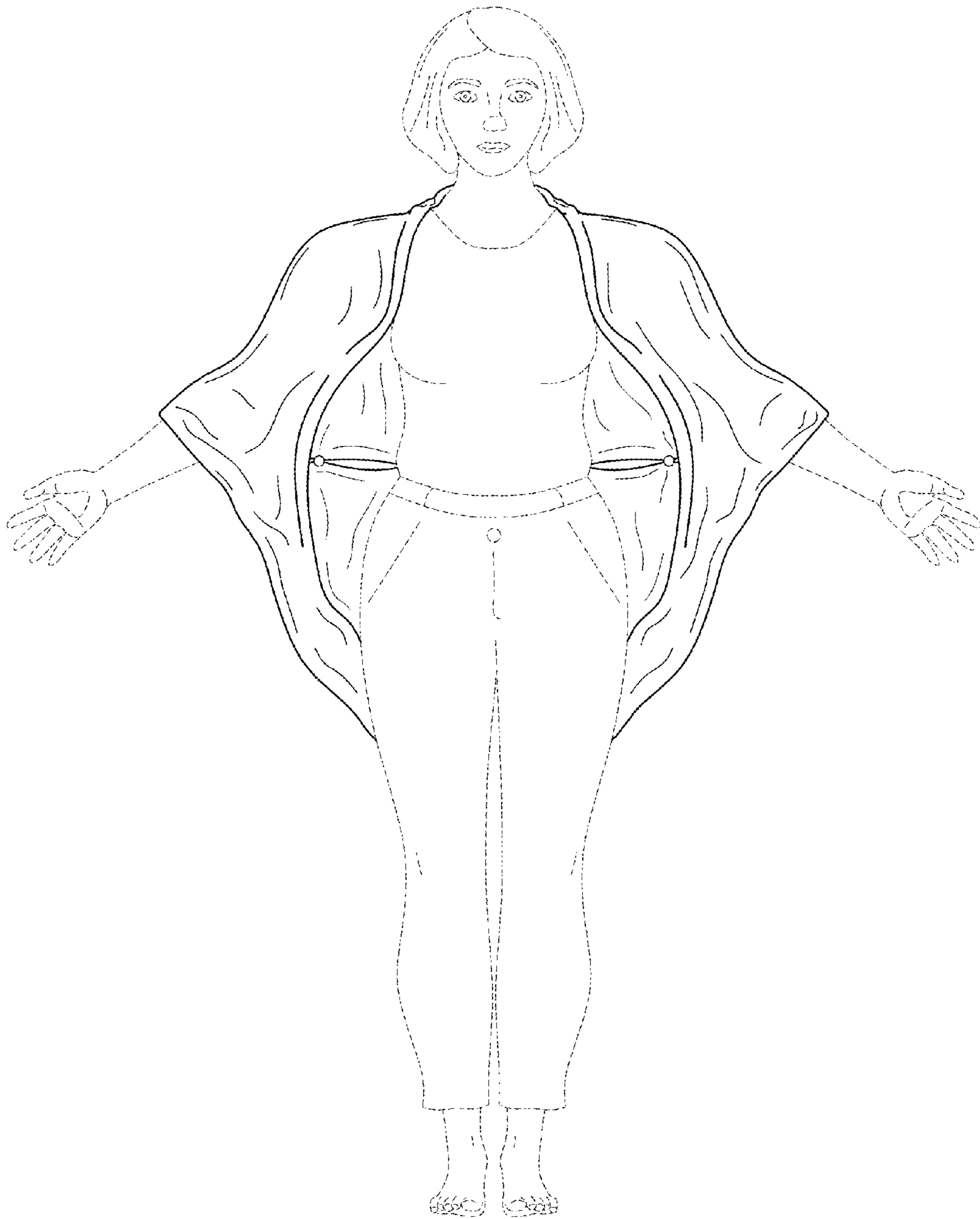

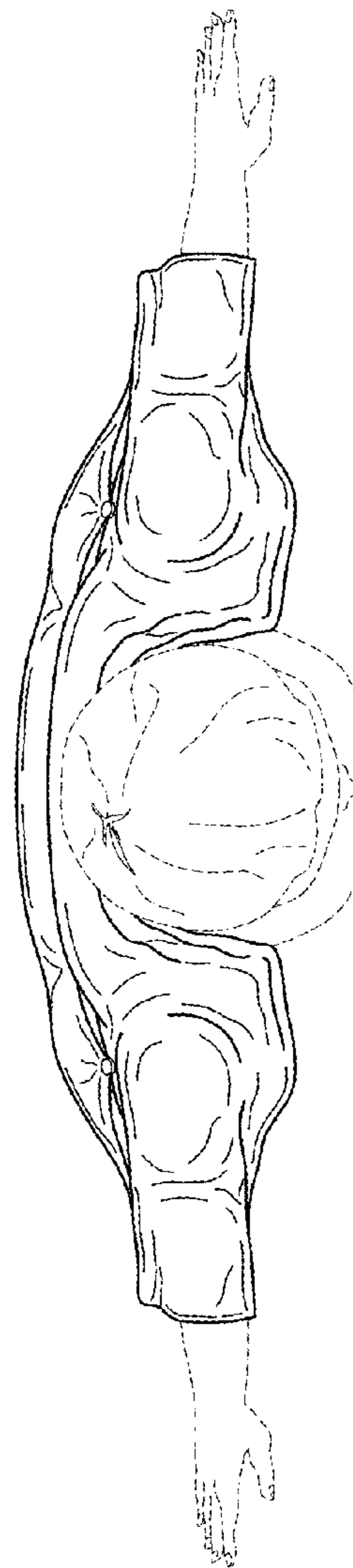

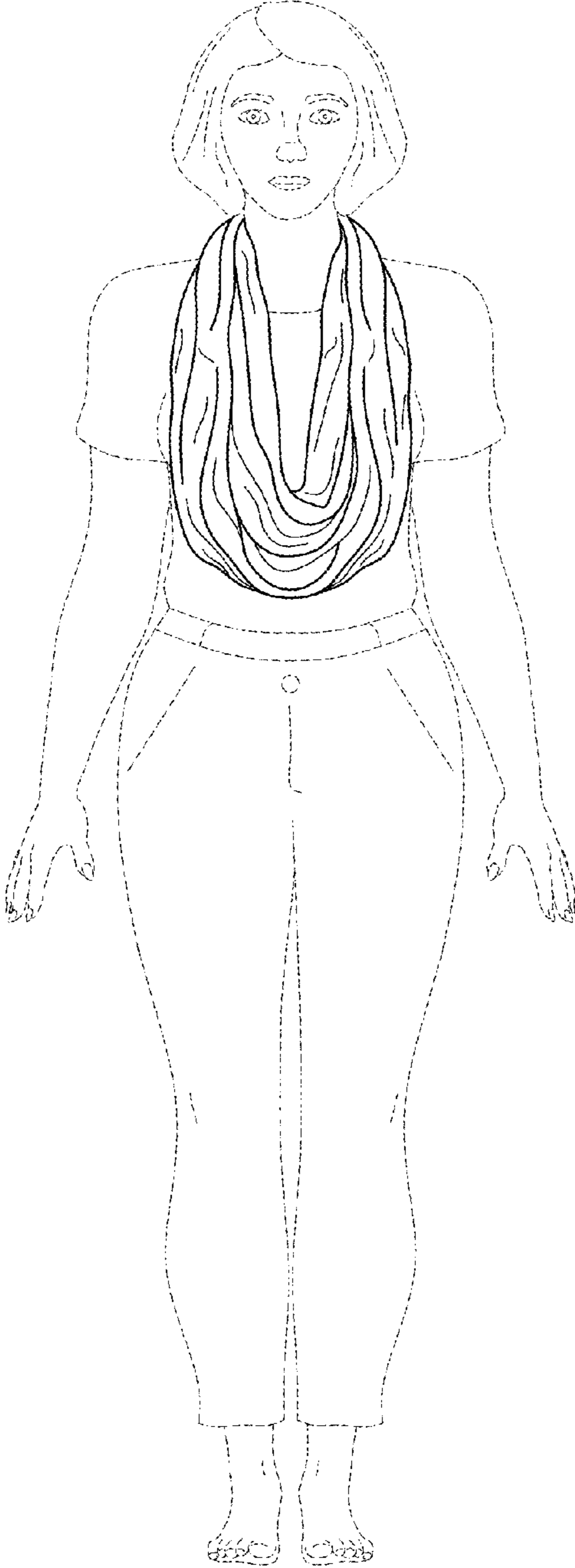

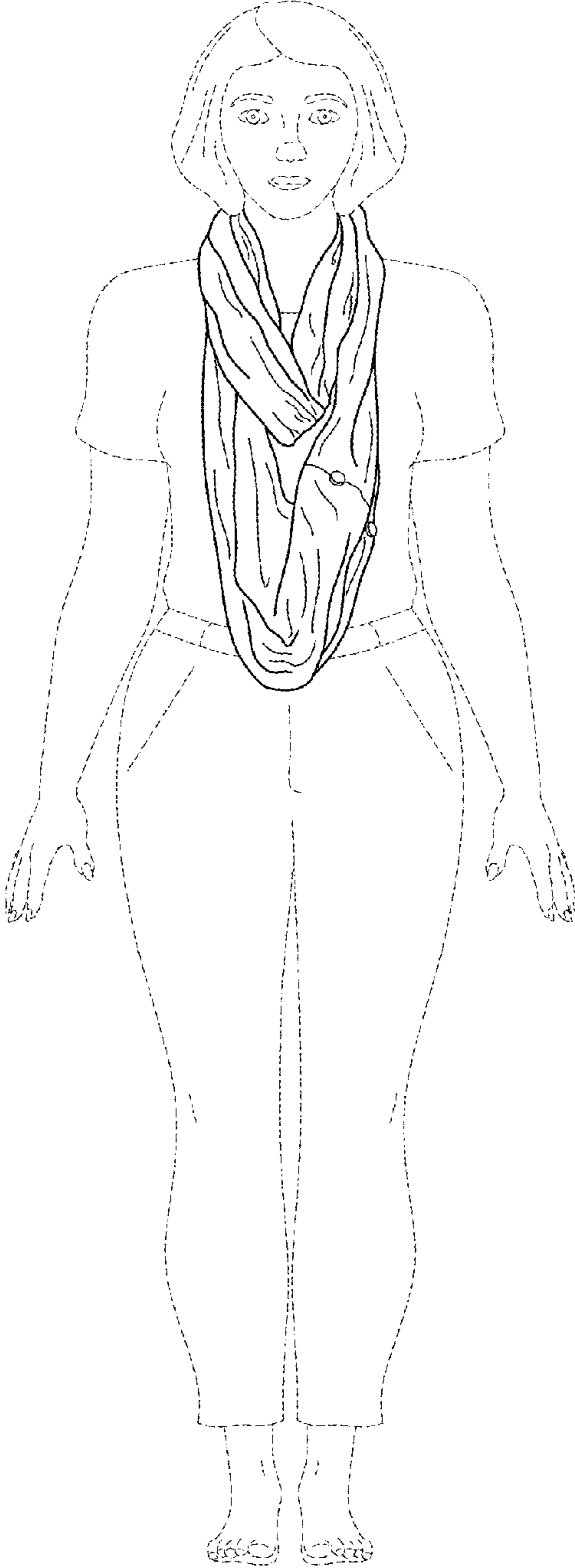

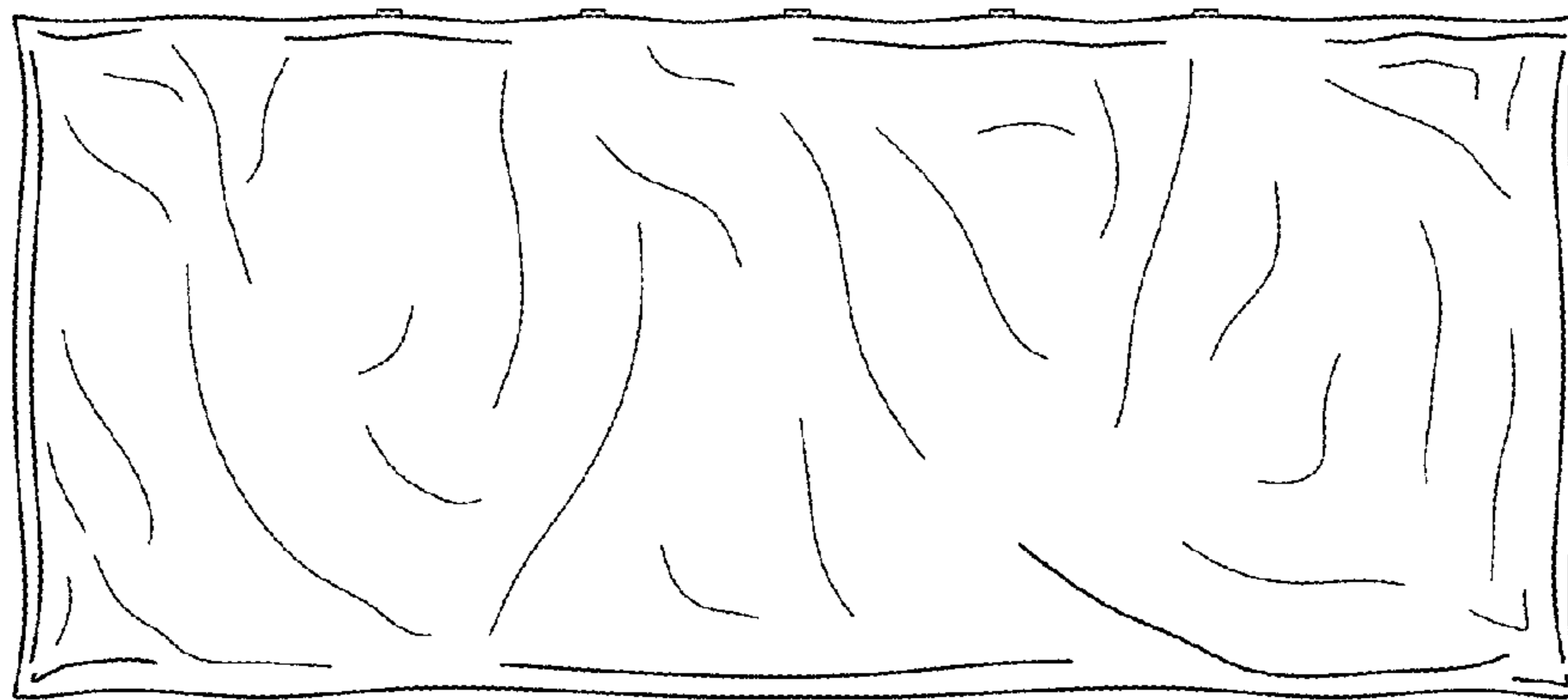
