shown and described.

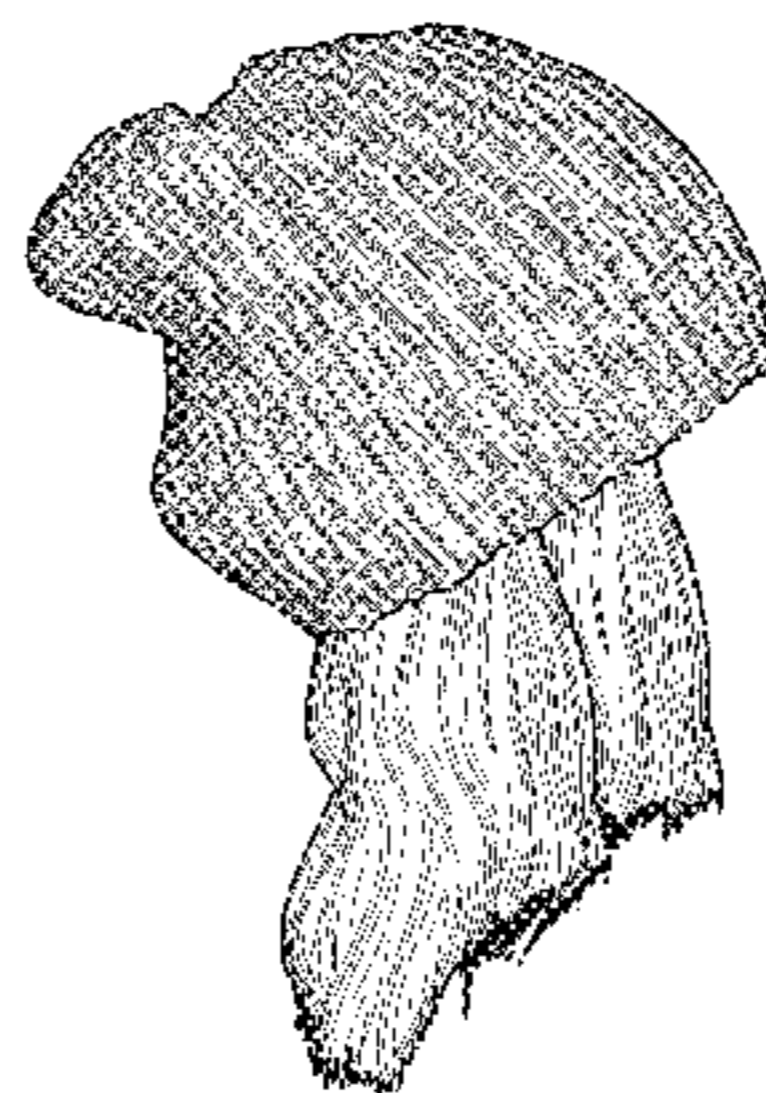
**DESCRIPTION**

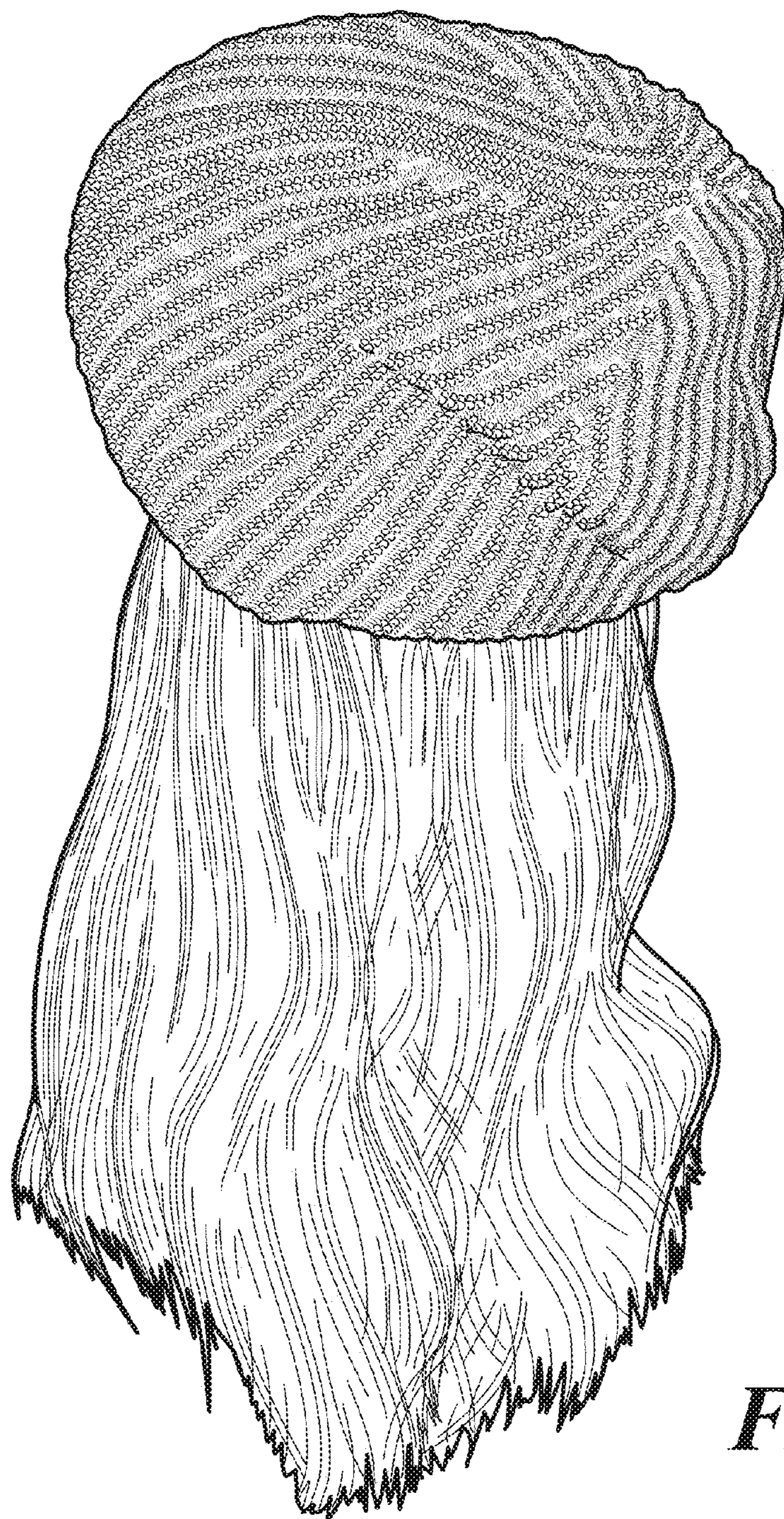

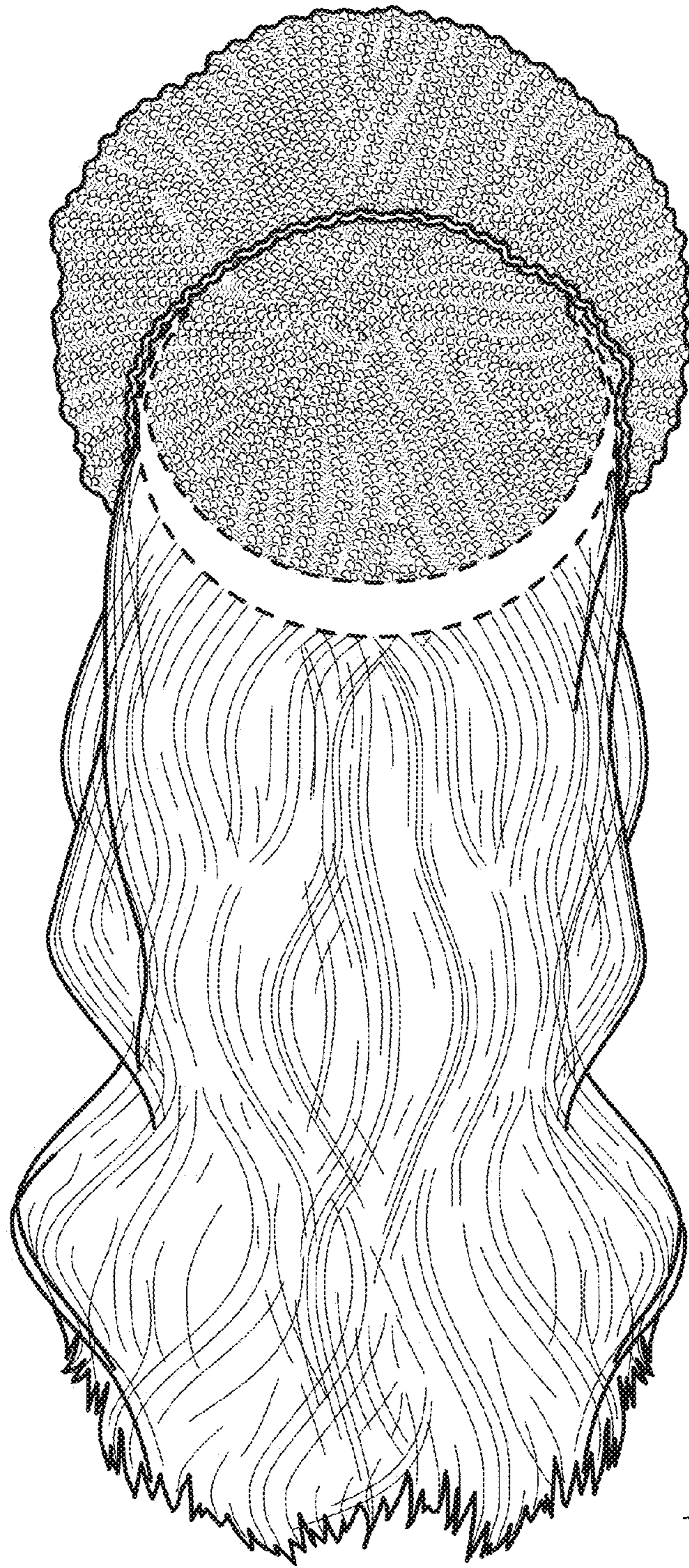

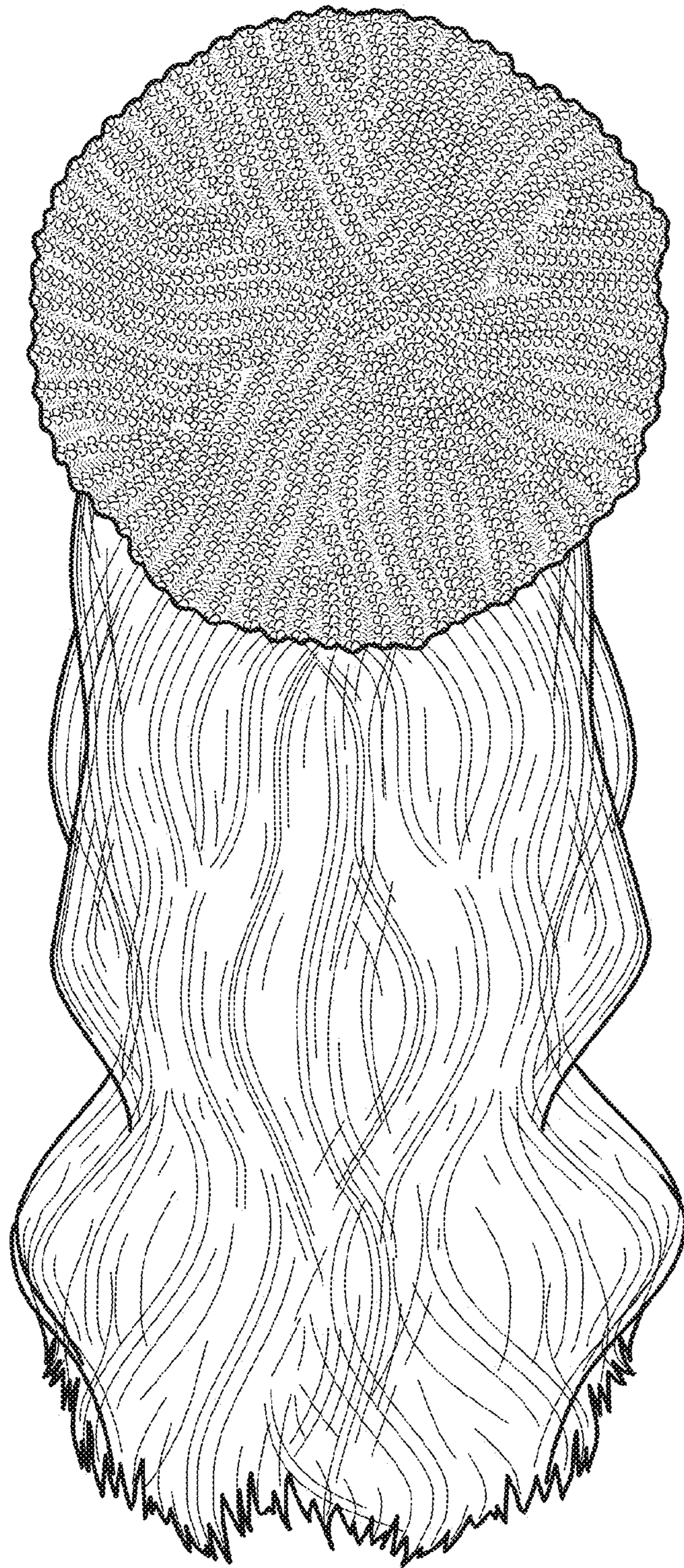

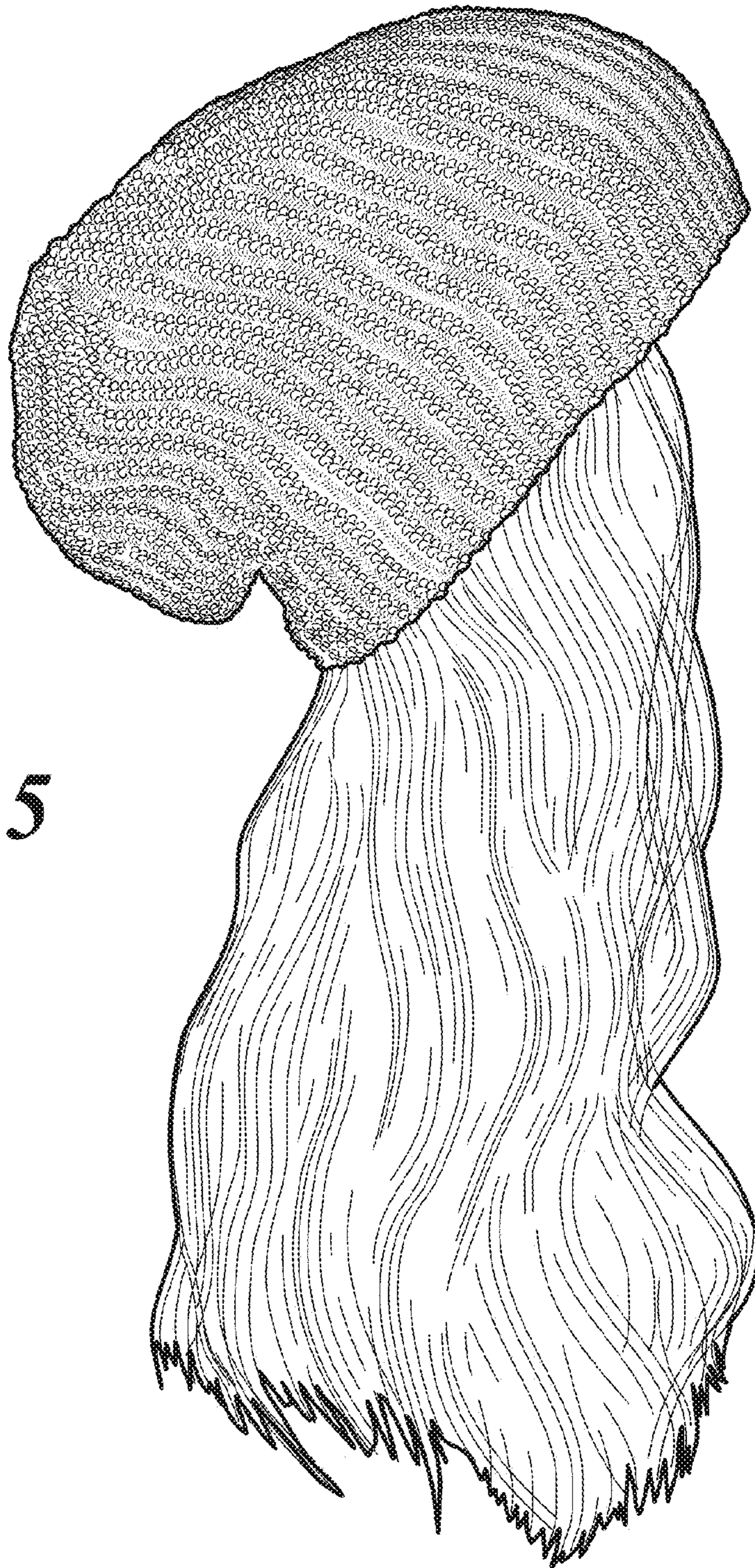

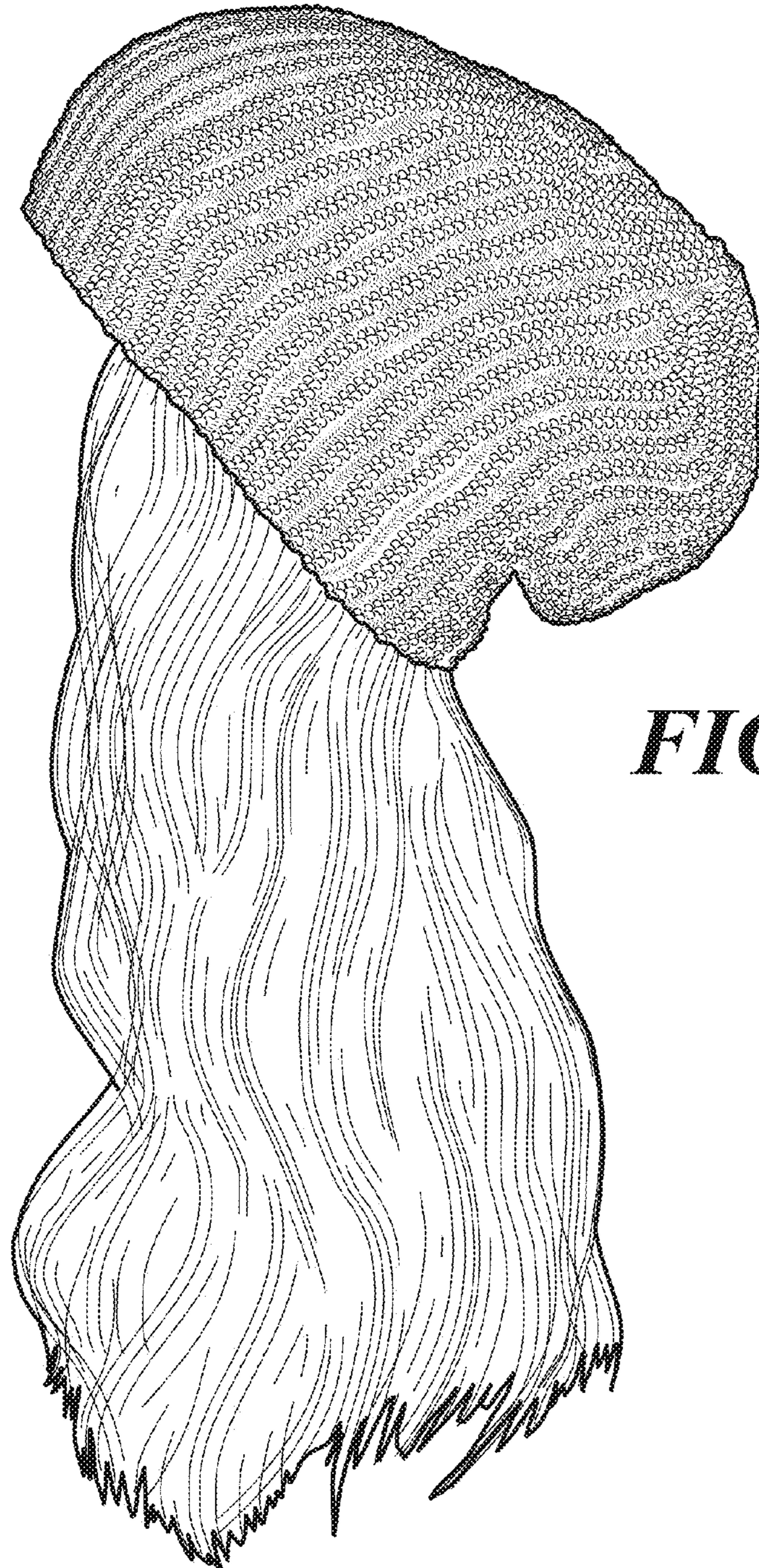

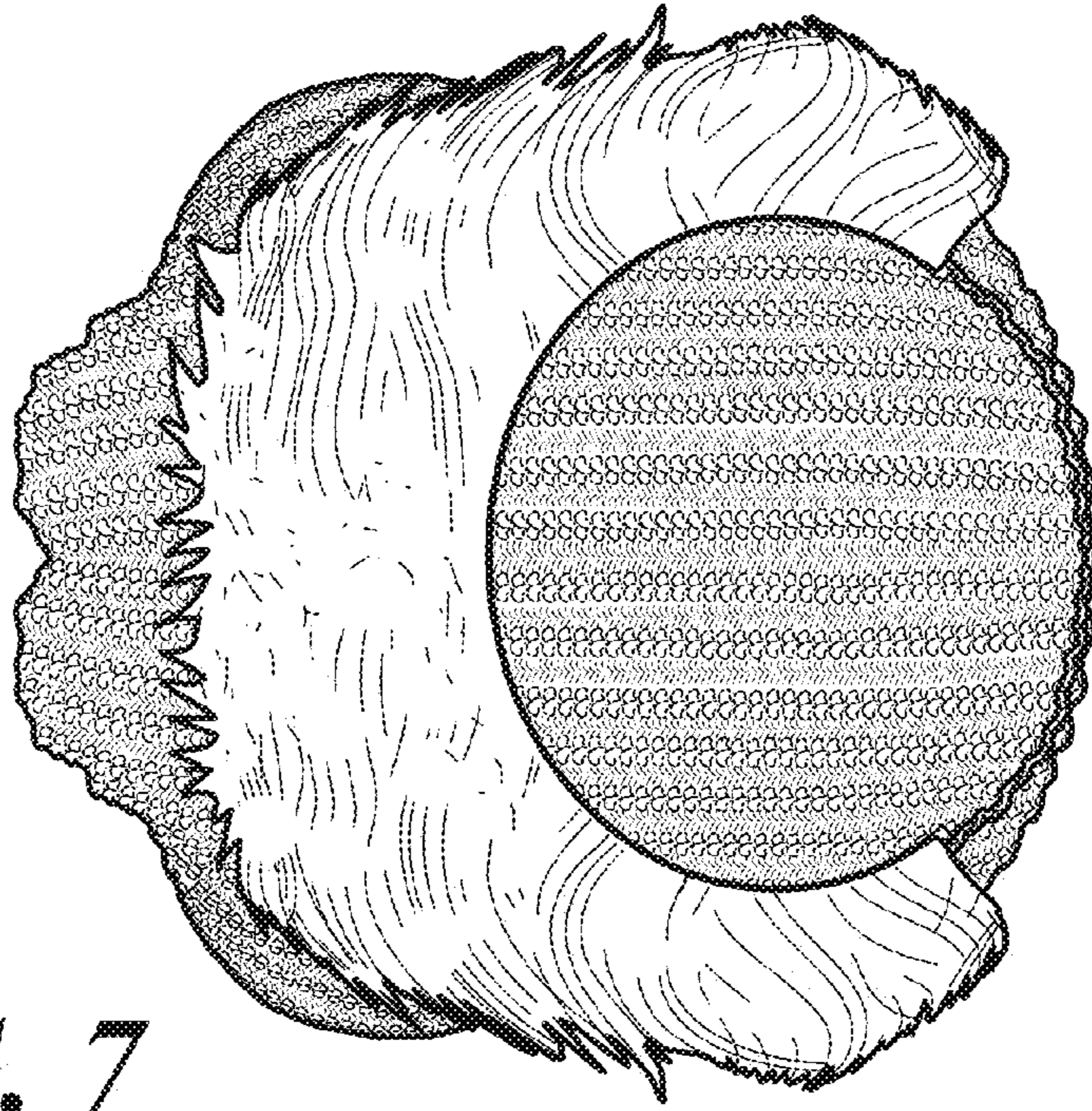

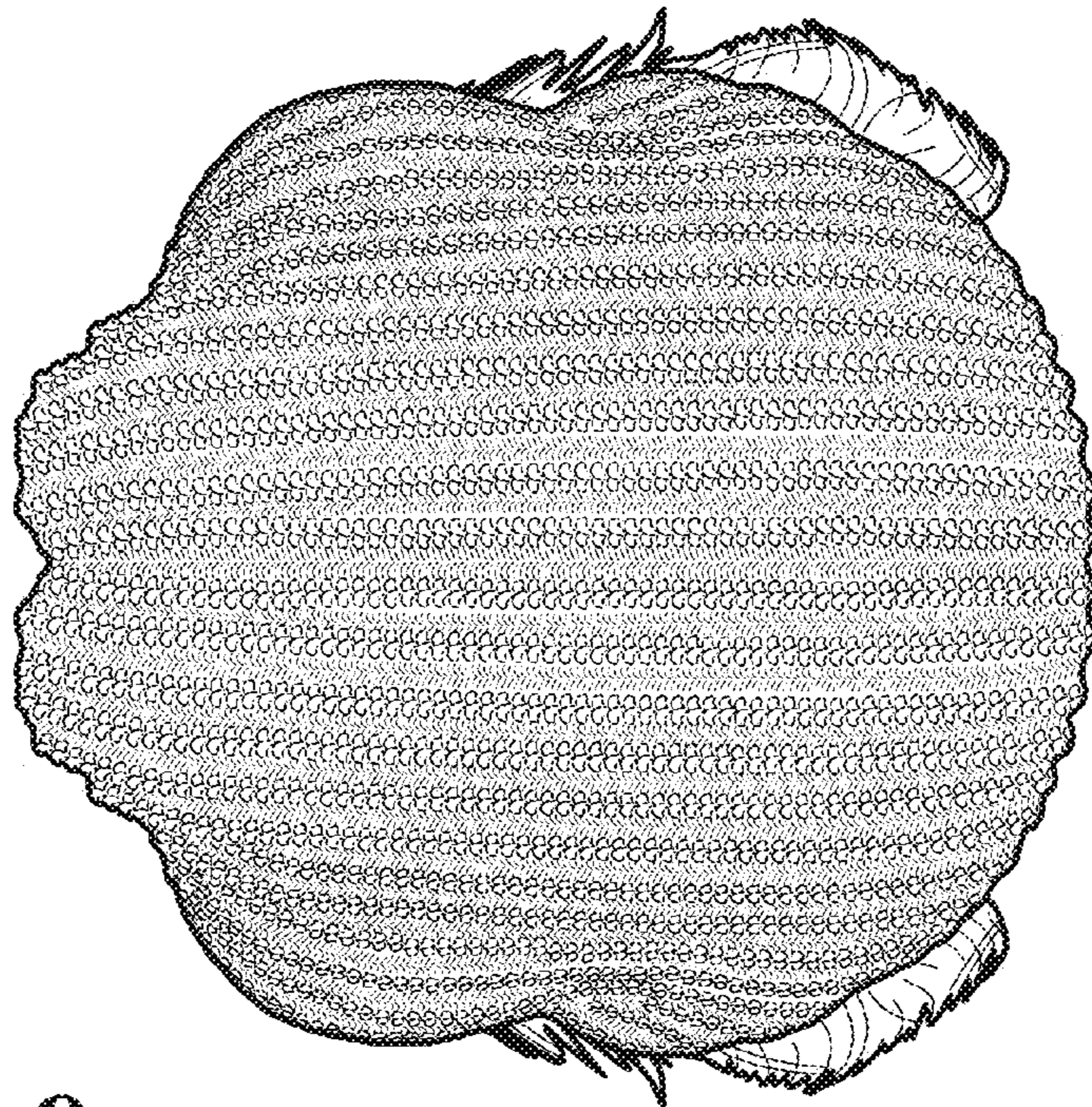

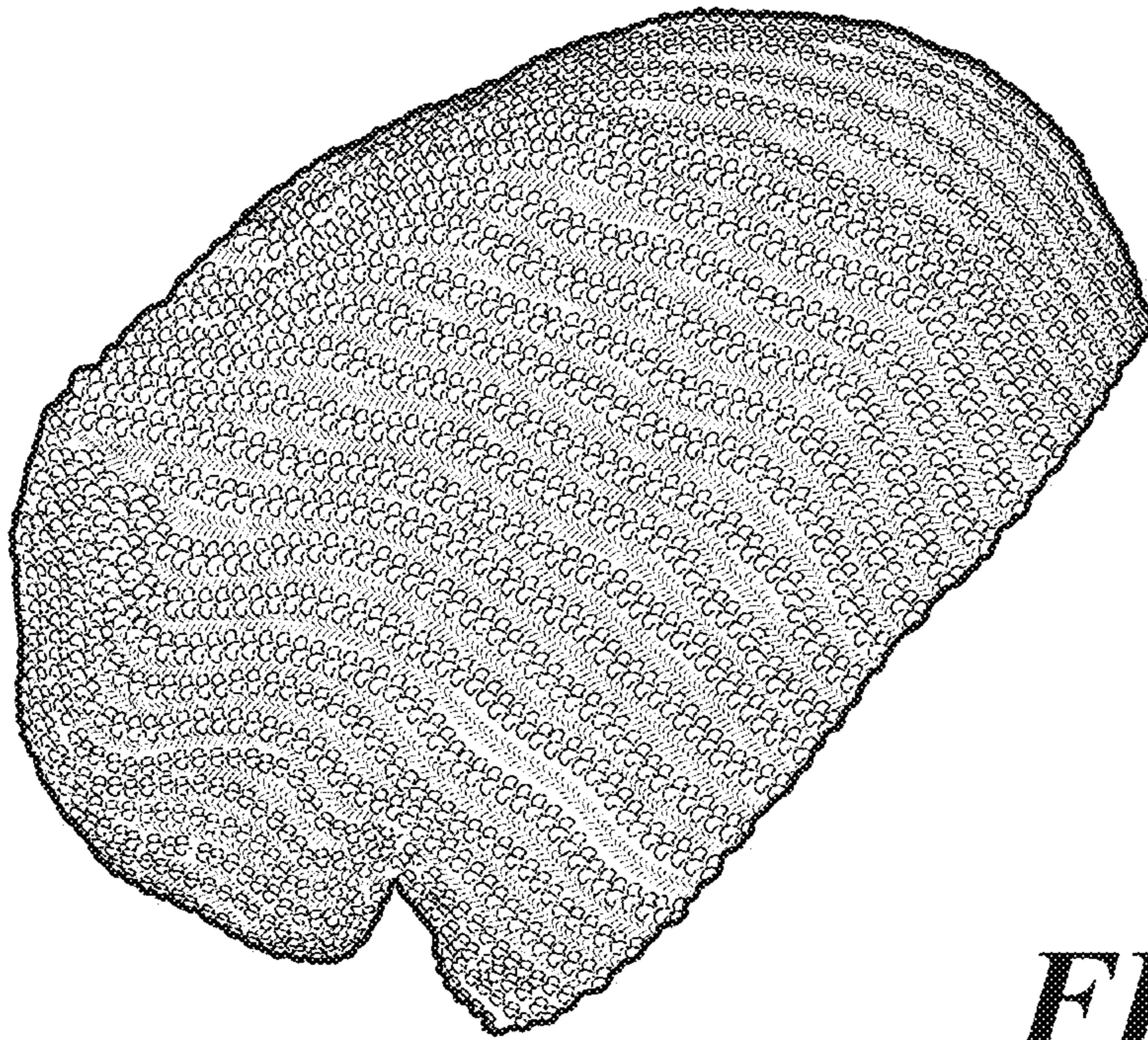

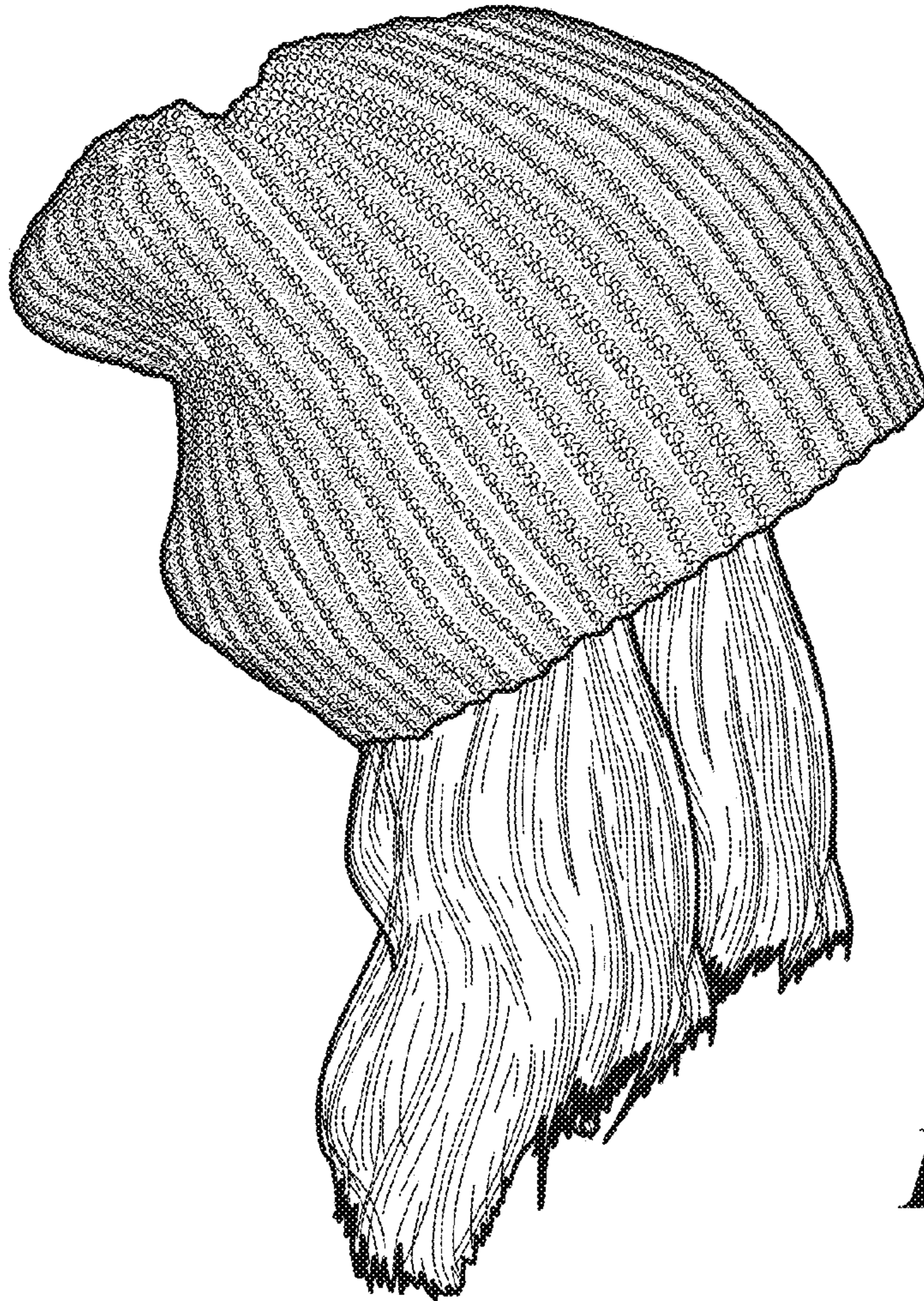

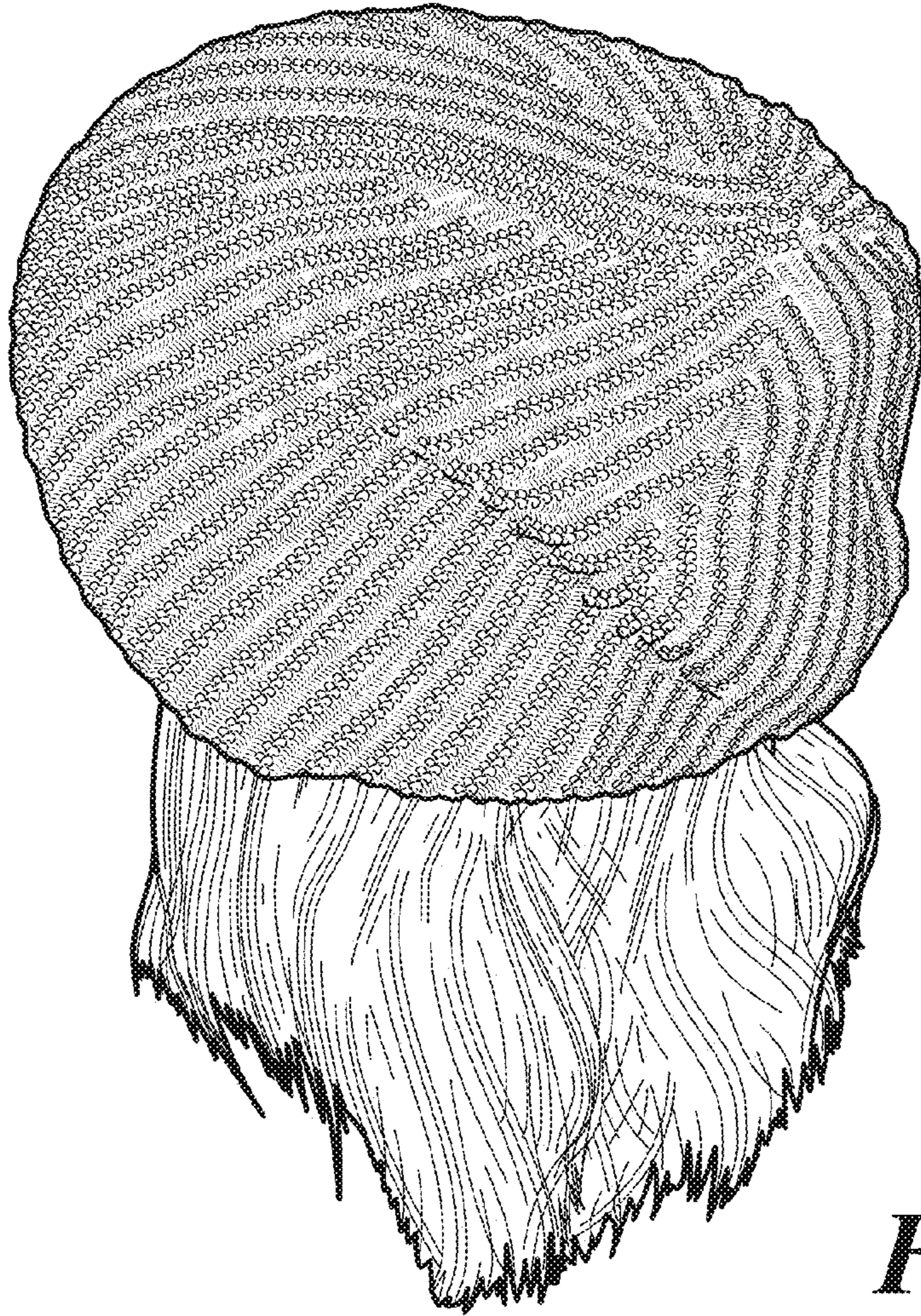

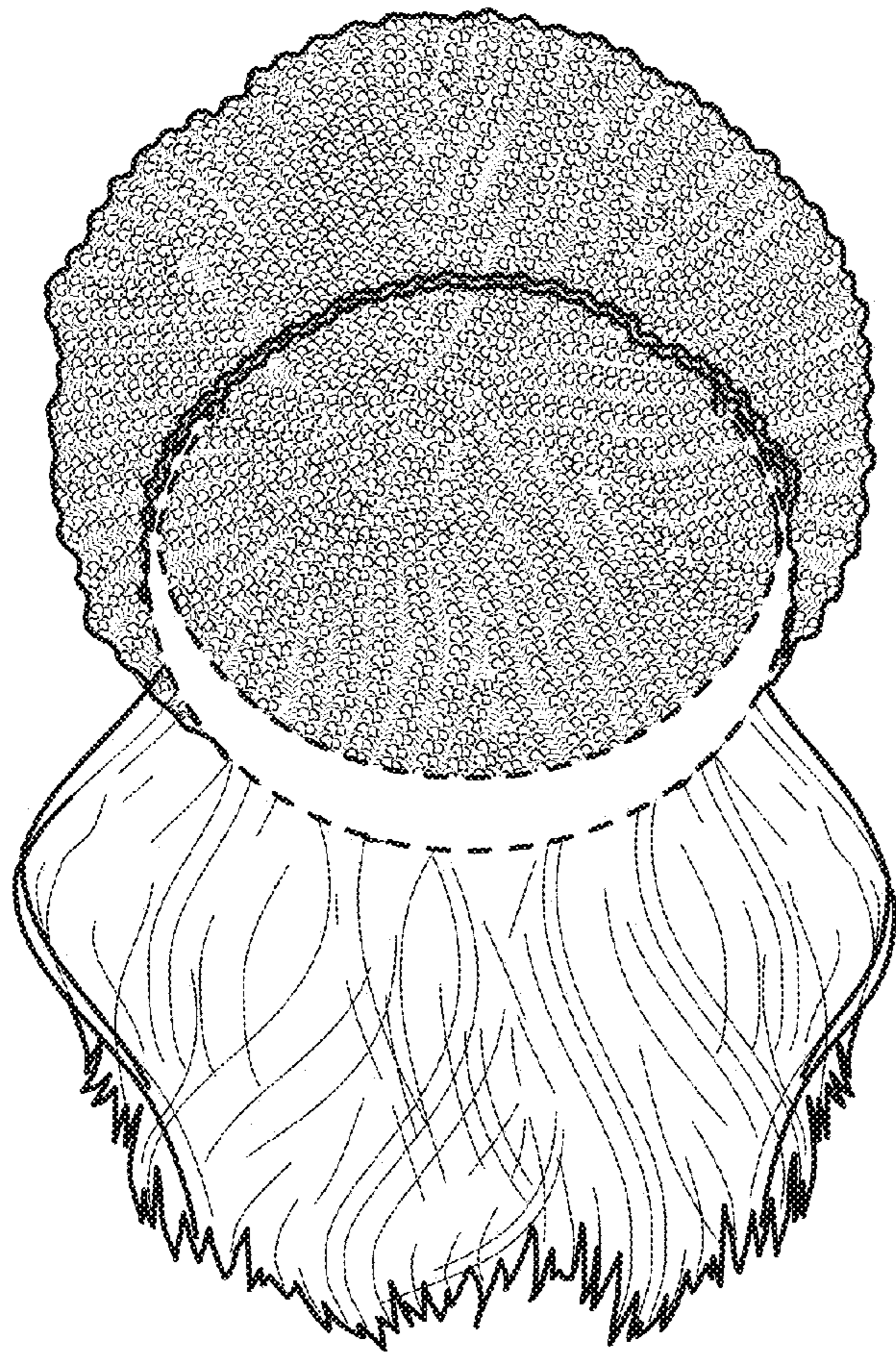
***FIG. 10***



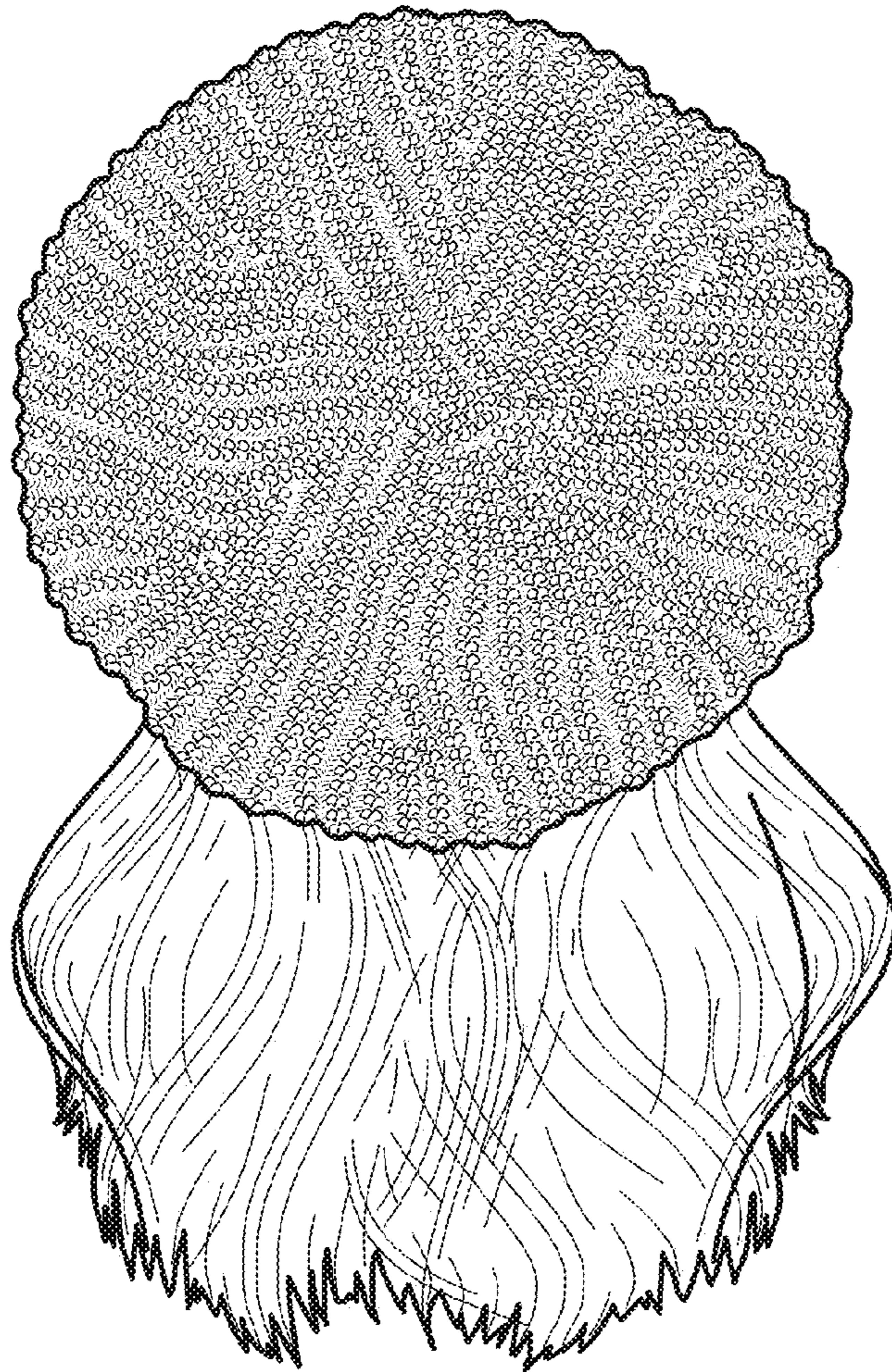
***FIG. 11***



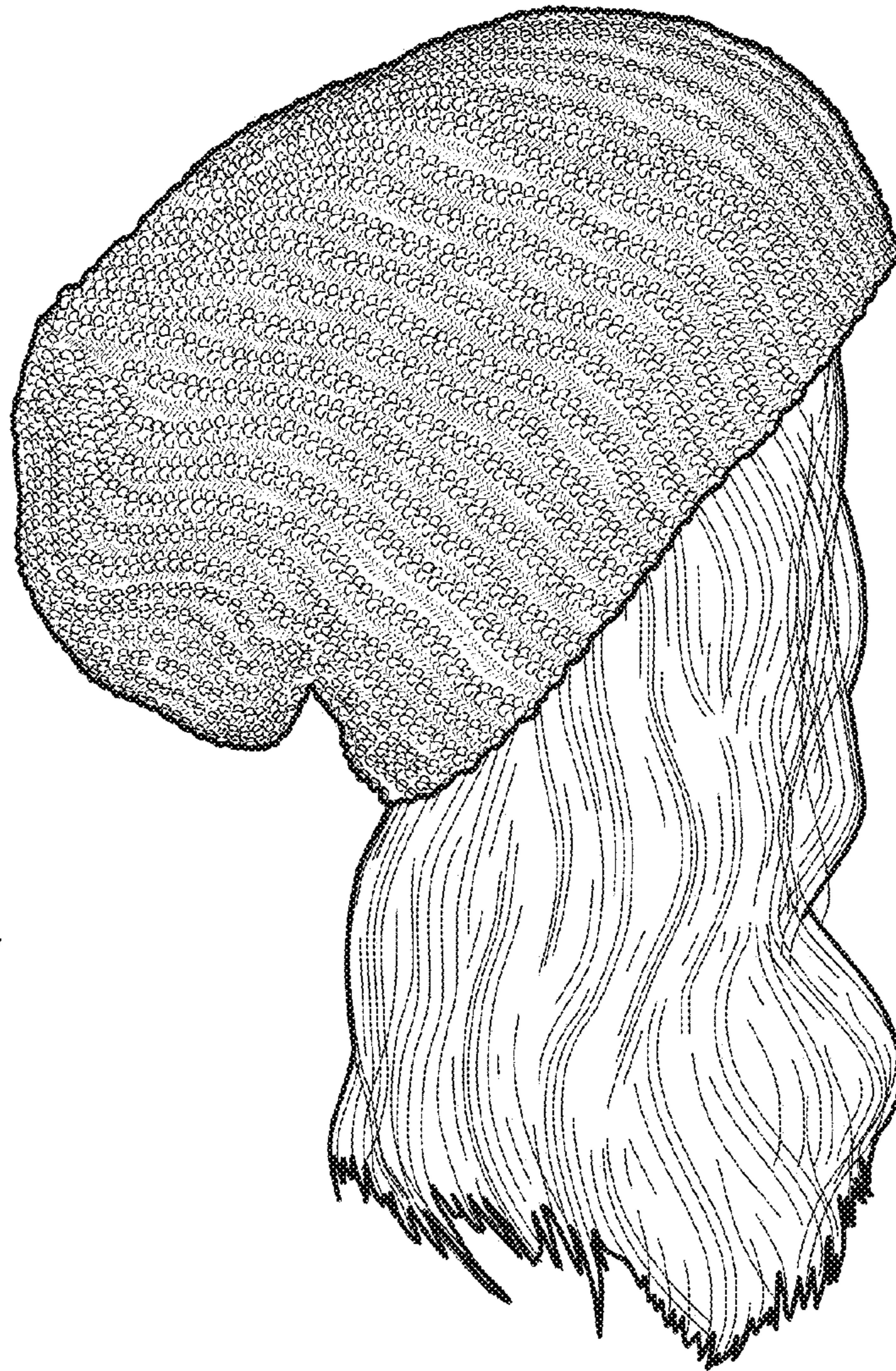
***FIG. 12***

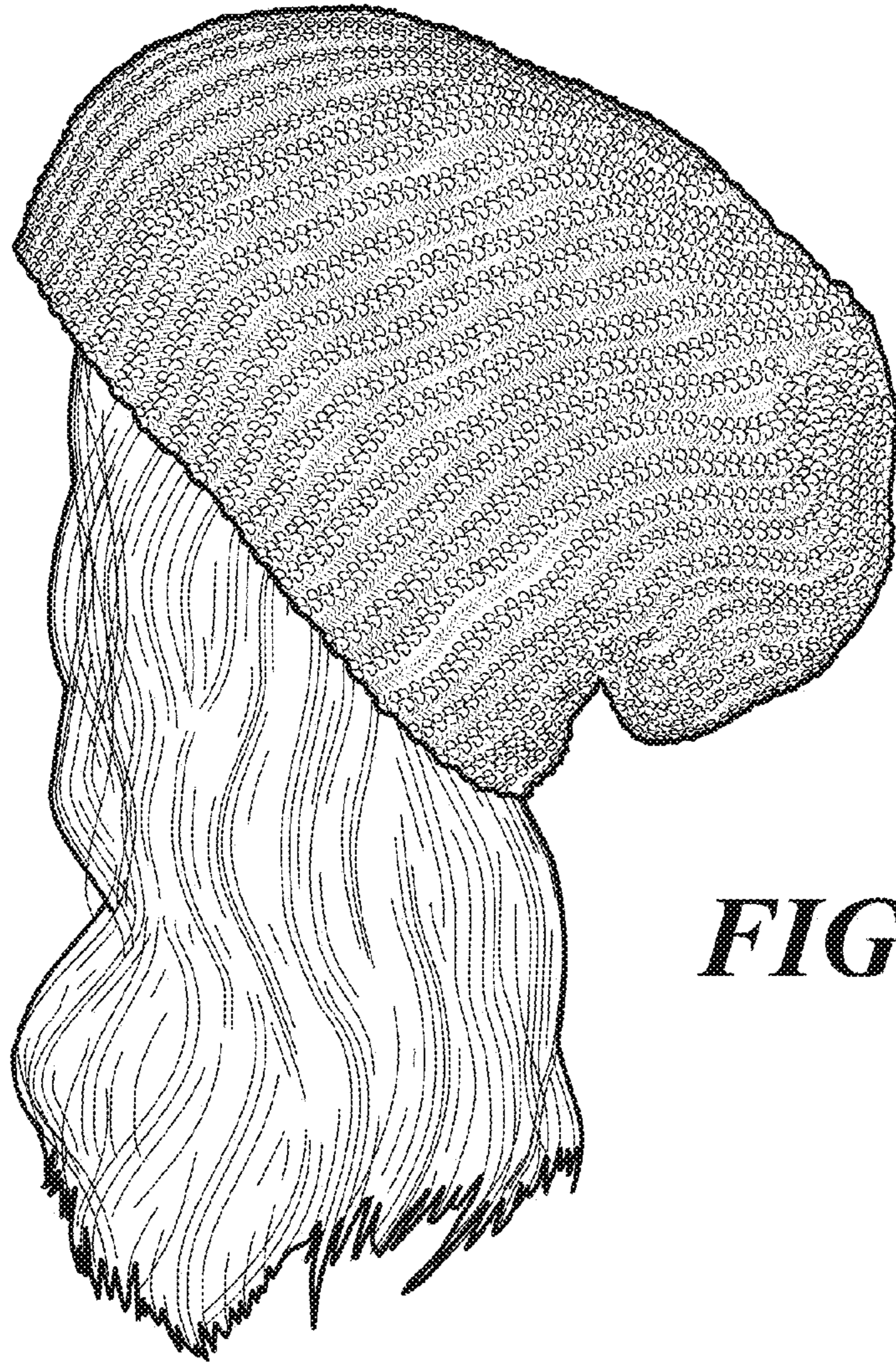


***FIG. 14***

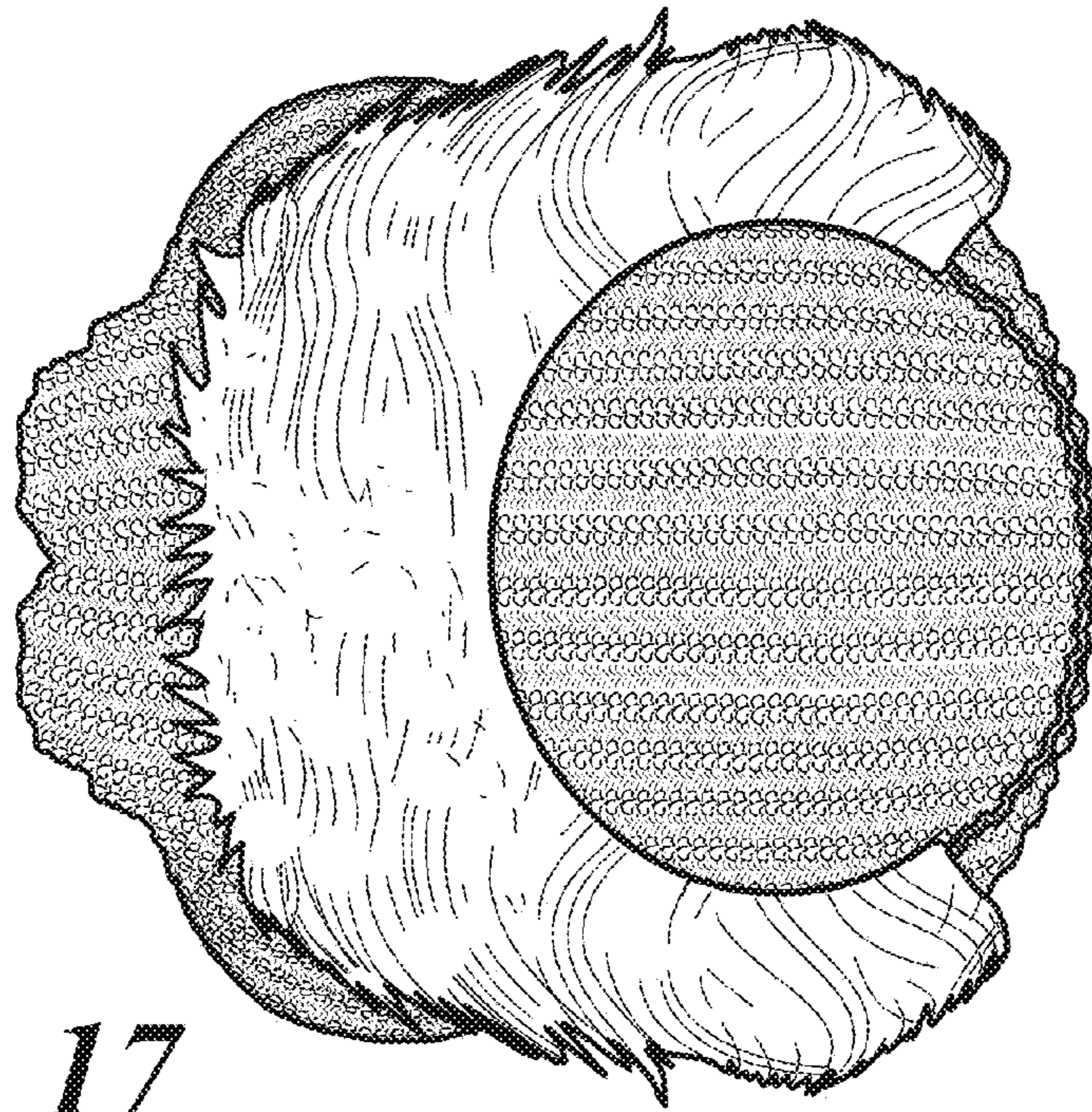


***FIG. 15***



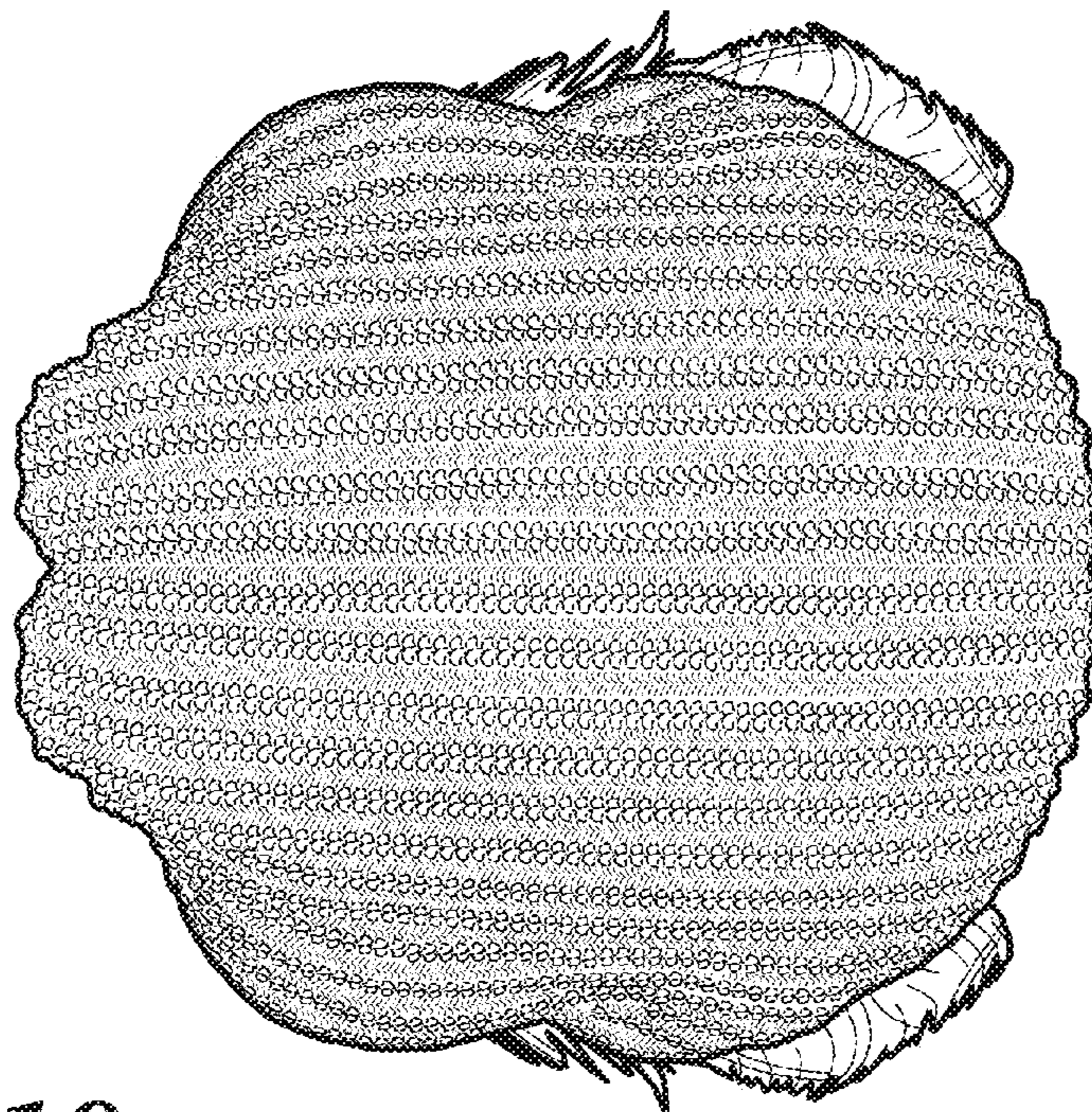


***FIG. 16***



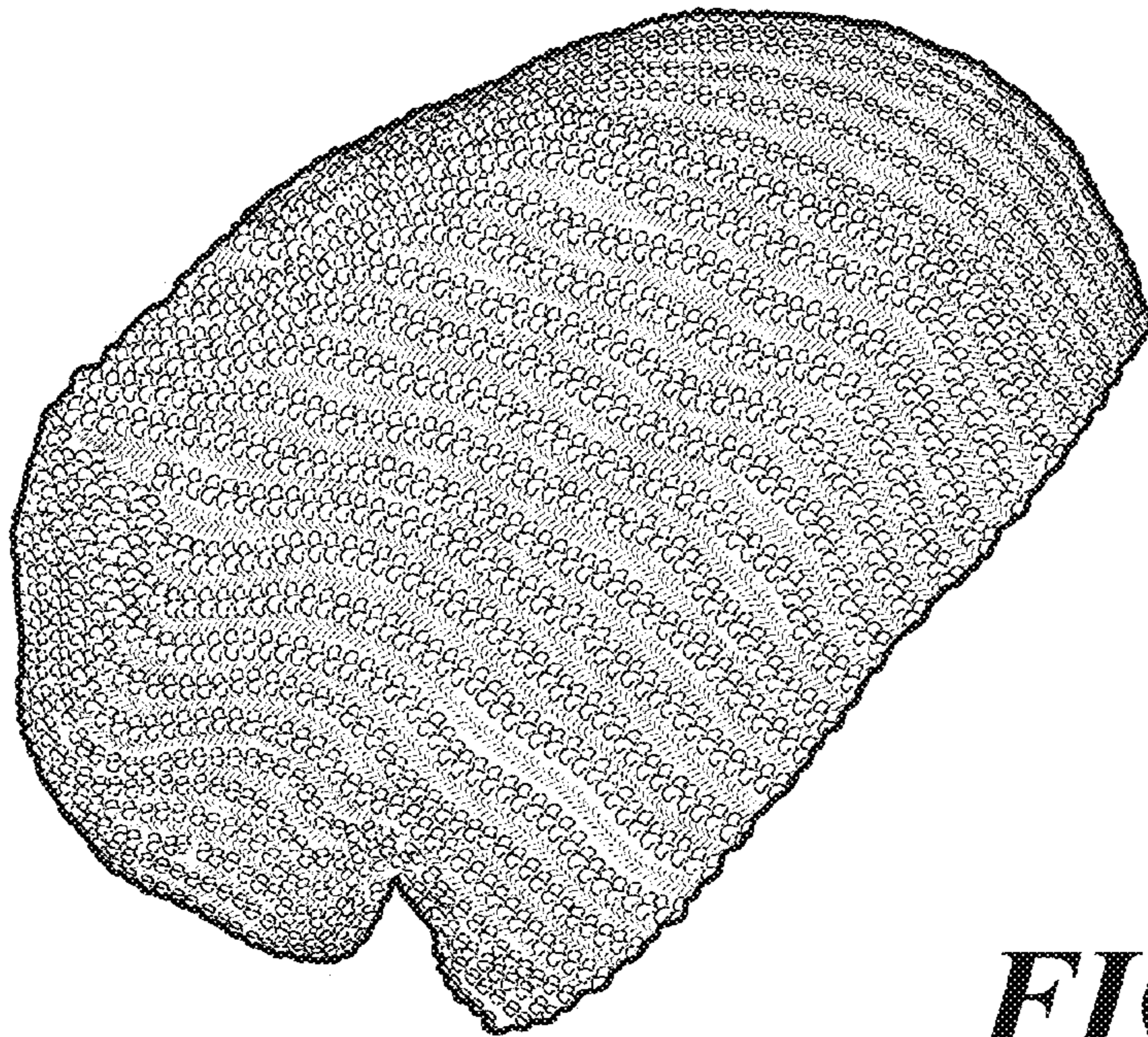

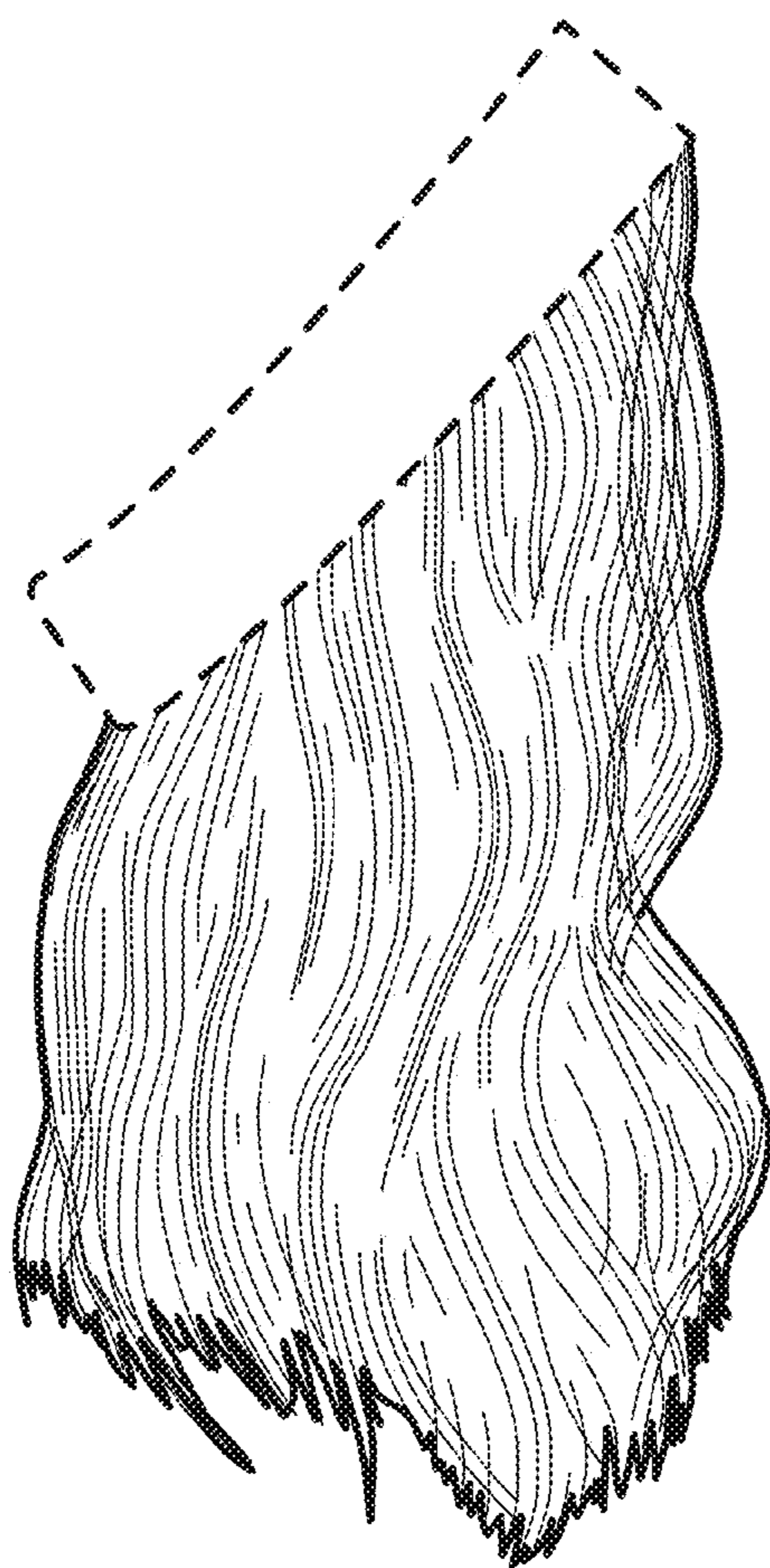
