(57) **CLAIM**

The ornamental design for a head covering hood, as shown and described.

DESCRIPTION

FIG. 1 is a front left side perspective view of a head covering hood in accordance with the new design as it may appear when worn;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a left side elevation view thereof;

FIG. 4 is a right side elevation view thereof;

FIG. 5 is a rear elevation view thereof;

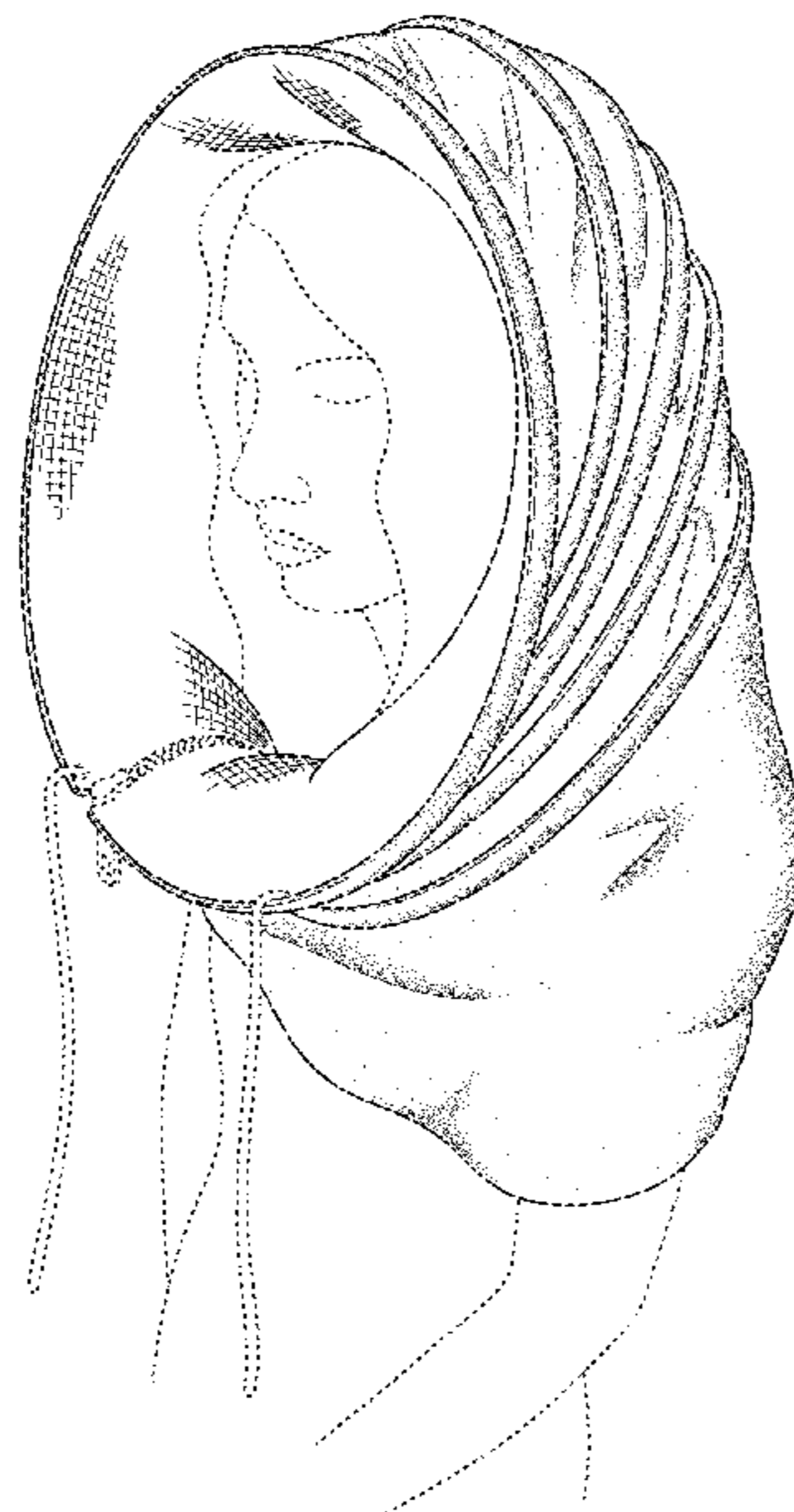
FIG. 6 is a front elevation view of the head covering hood in a compressed position;

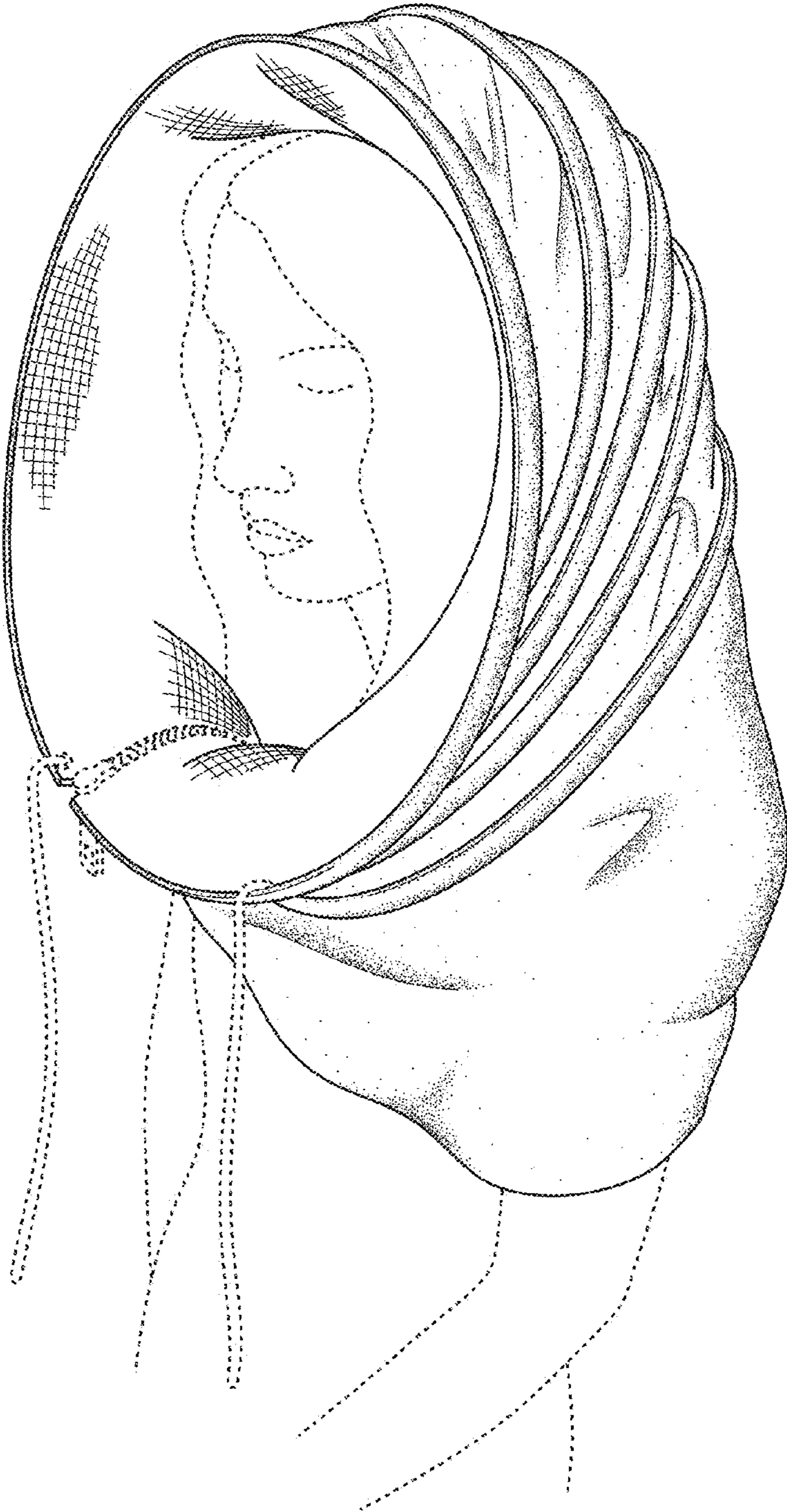

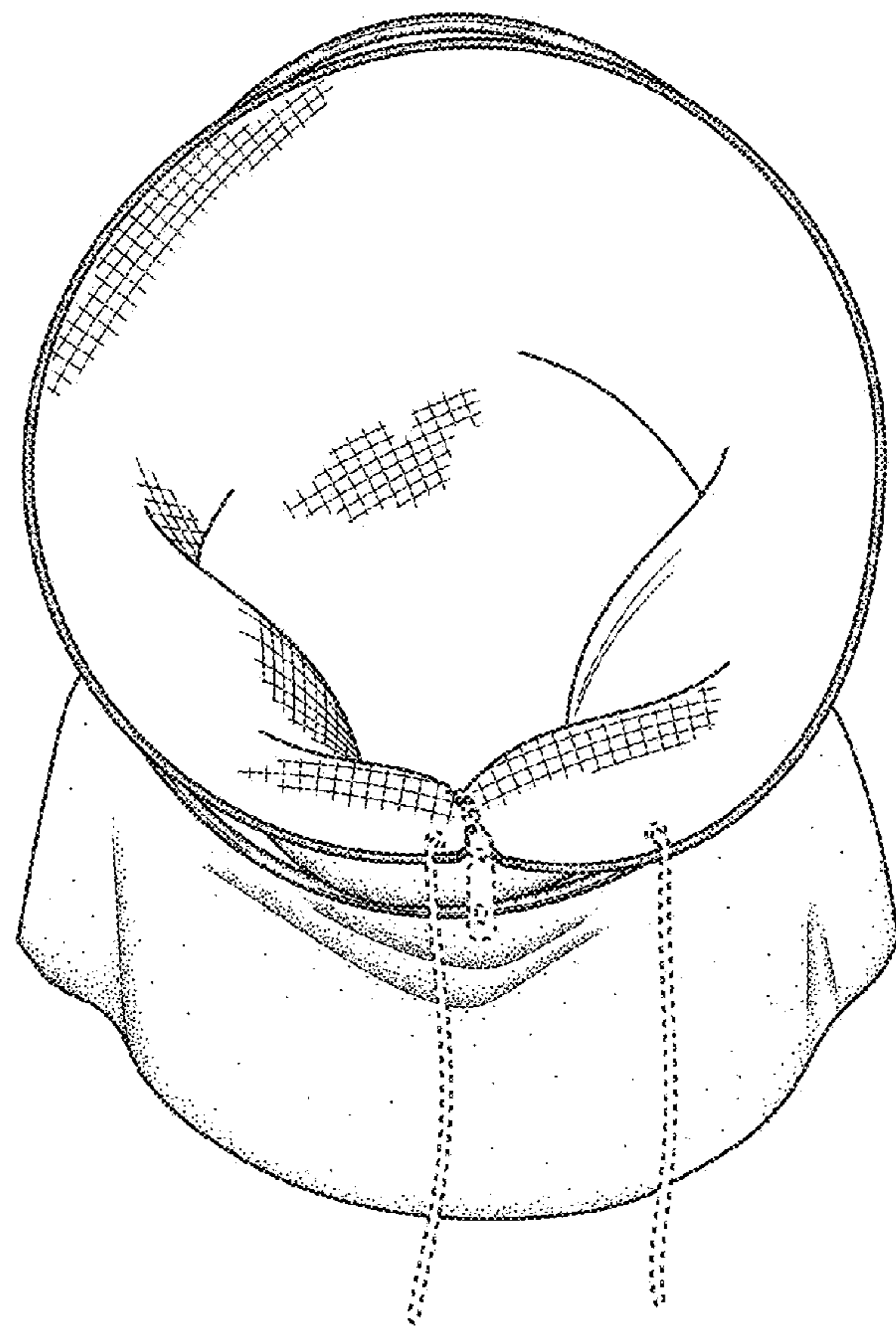

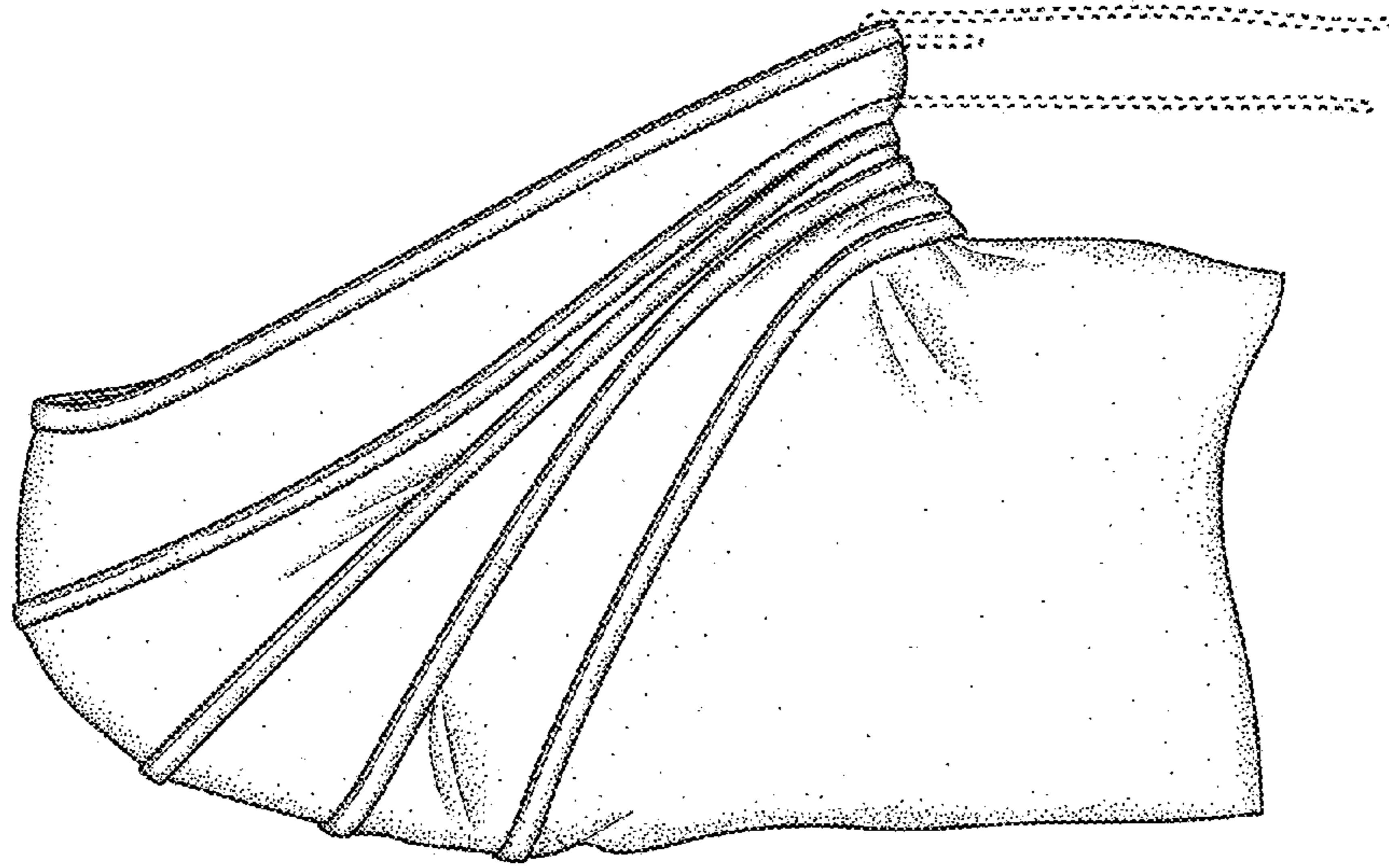

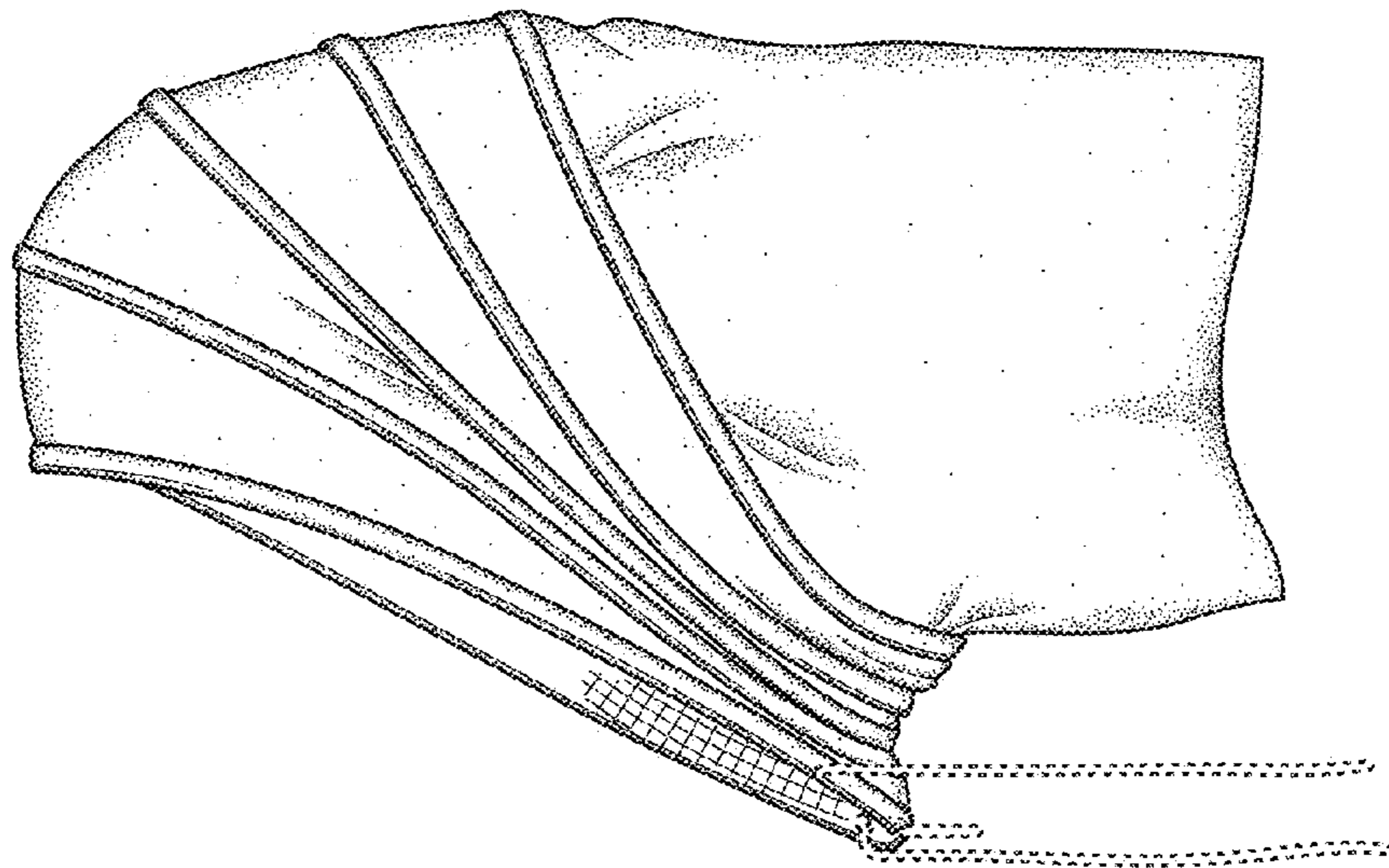

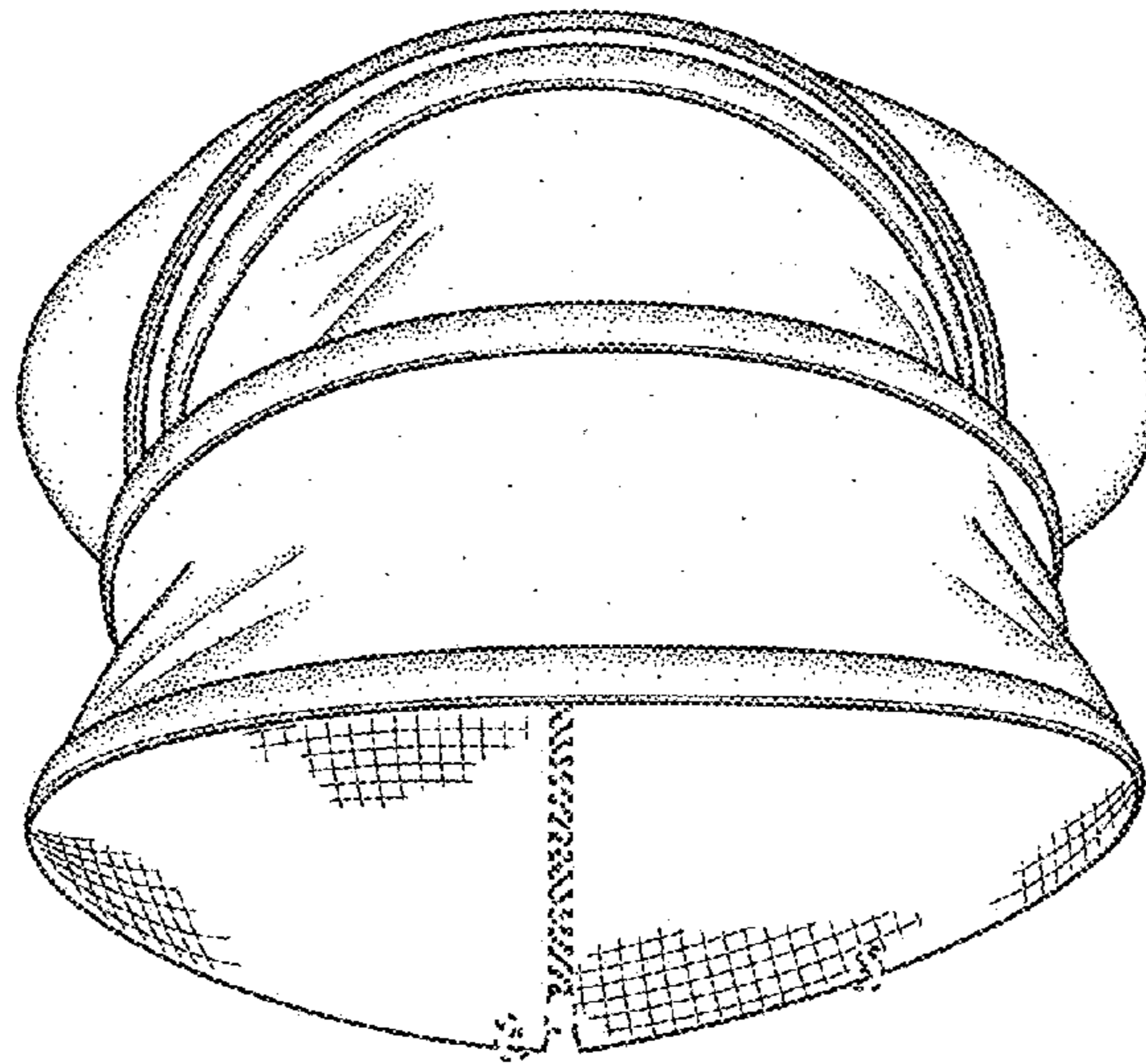

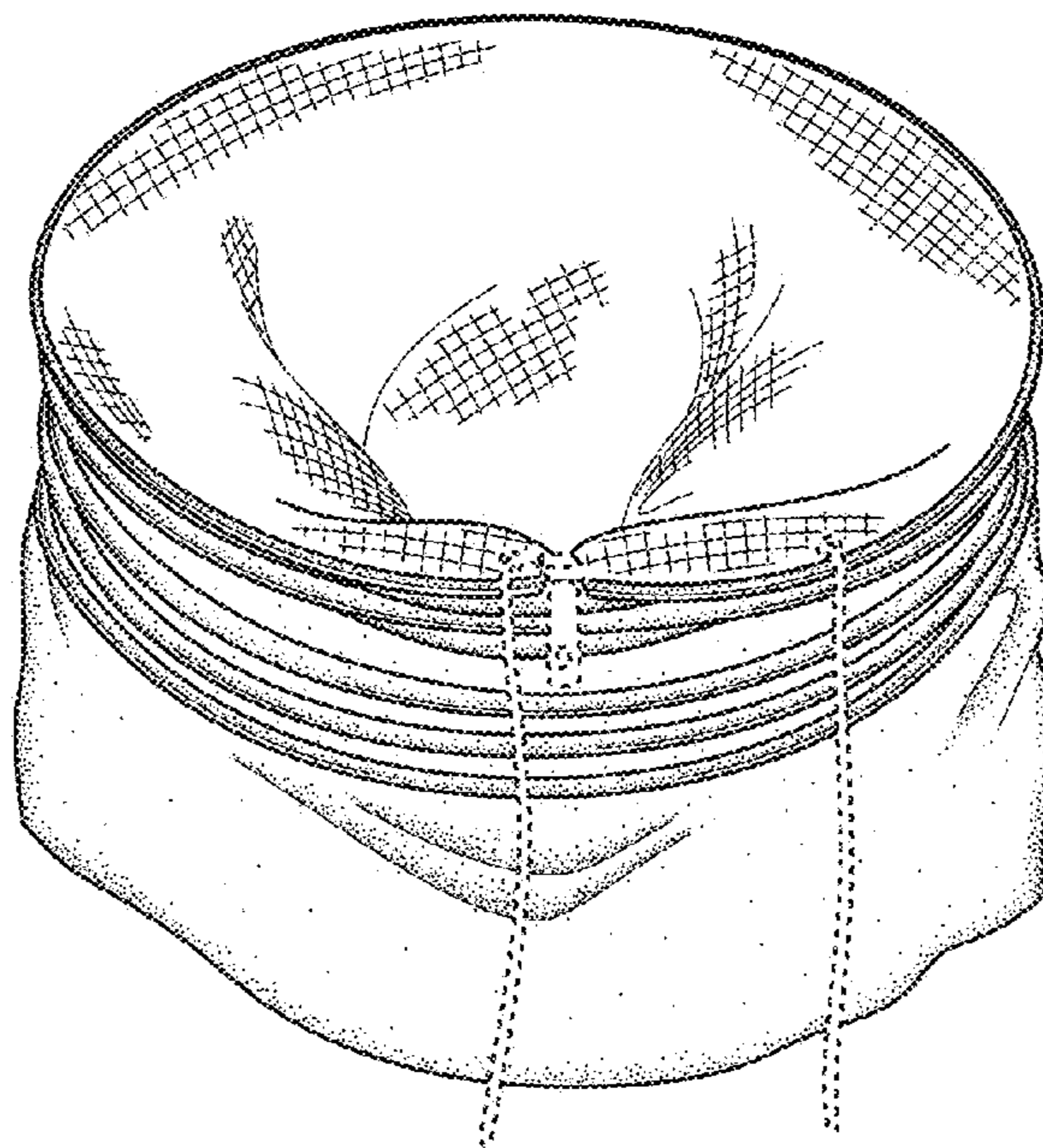

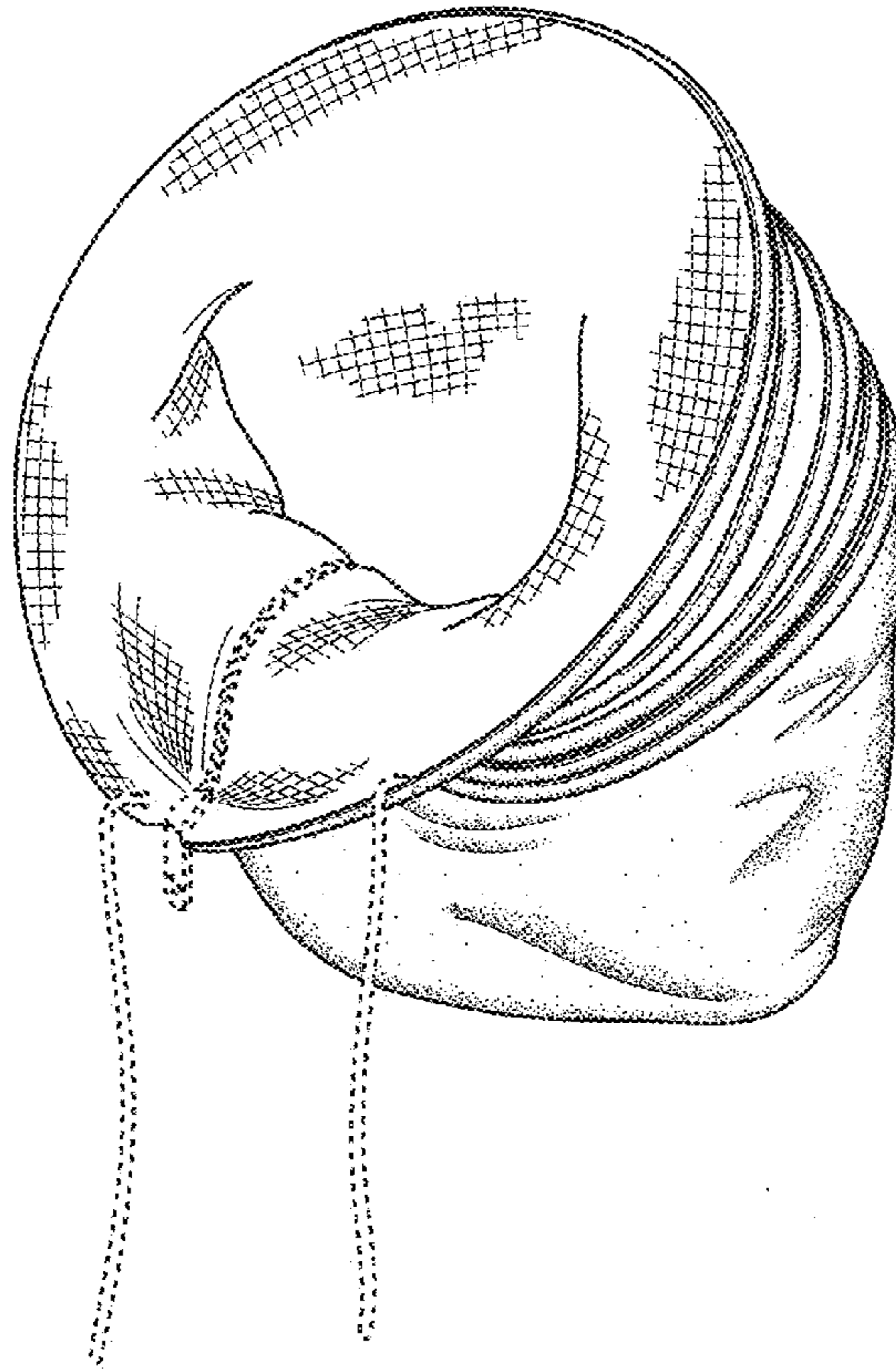

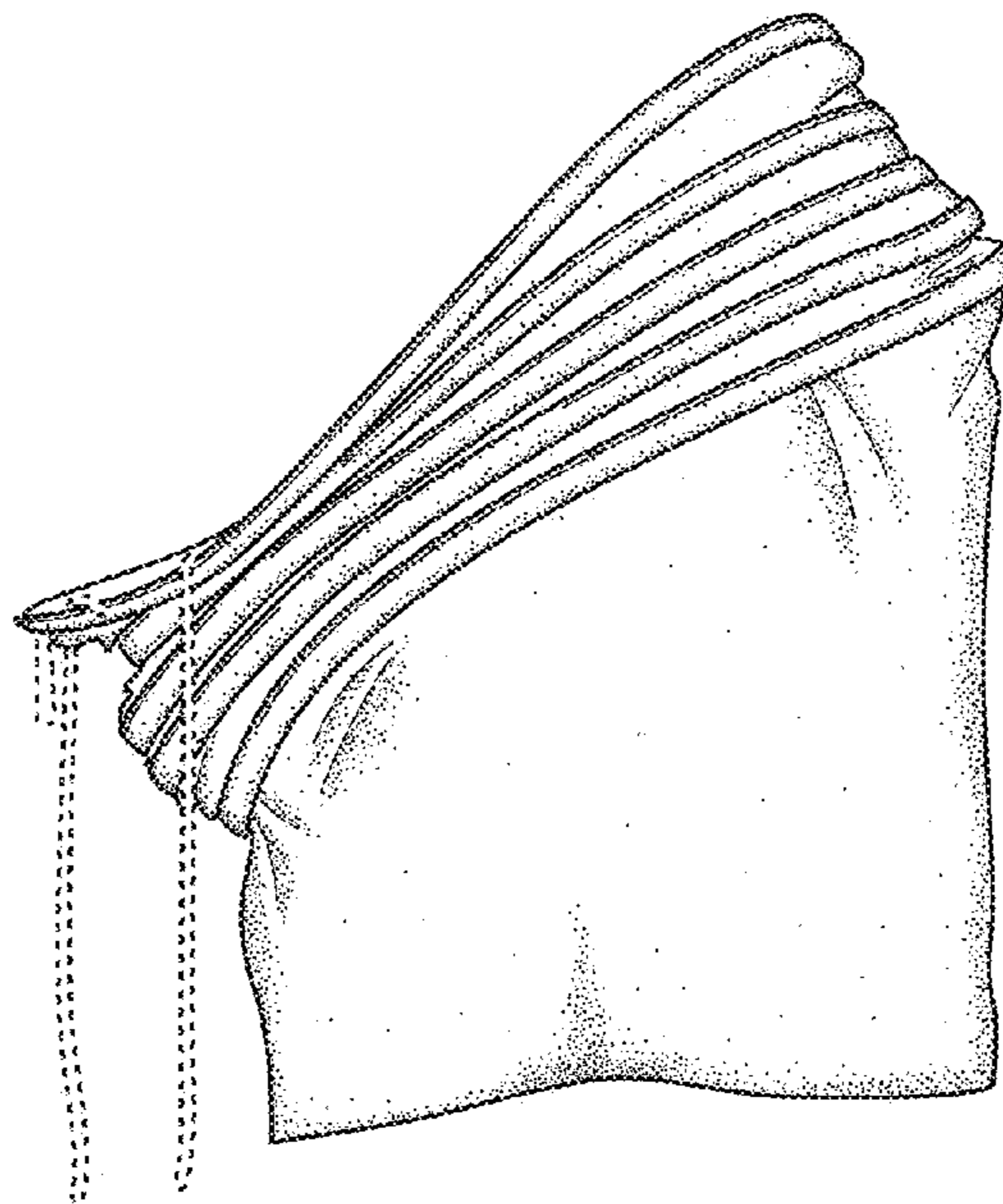
