(57) **CLAIM**

The ornamental design for a solid drawer and drawer frame, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a set of solid drawers and the associated drawer frames in an exemplary system shown in broken lines;

FIG. 2 is a perspective view of a selected solid drawer and associated drawer frame shown in FIG. 1;

FIG. 3 is an elevational view of the front of the solid drawer and drawer frame of FIG. 2;

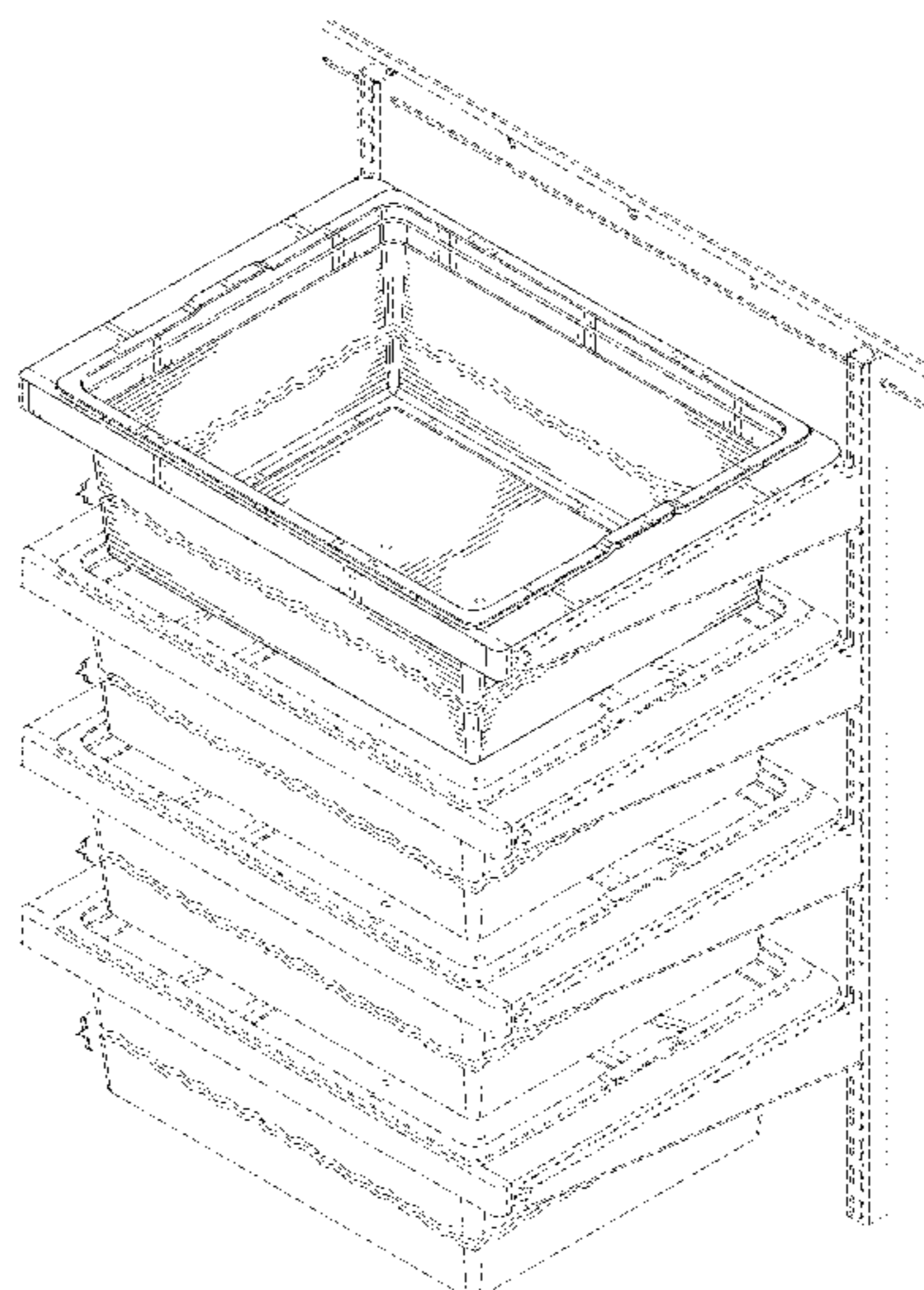
FIG. 4 is an elevational view of a first side of the solid drawer and drawer frame of FIG. 2;

FIG. 5 is an elevational view of a second side of the solid drawer and drawer frame of FIG. 2; and,

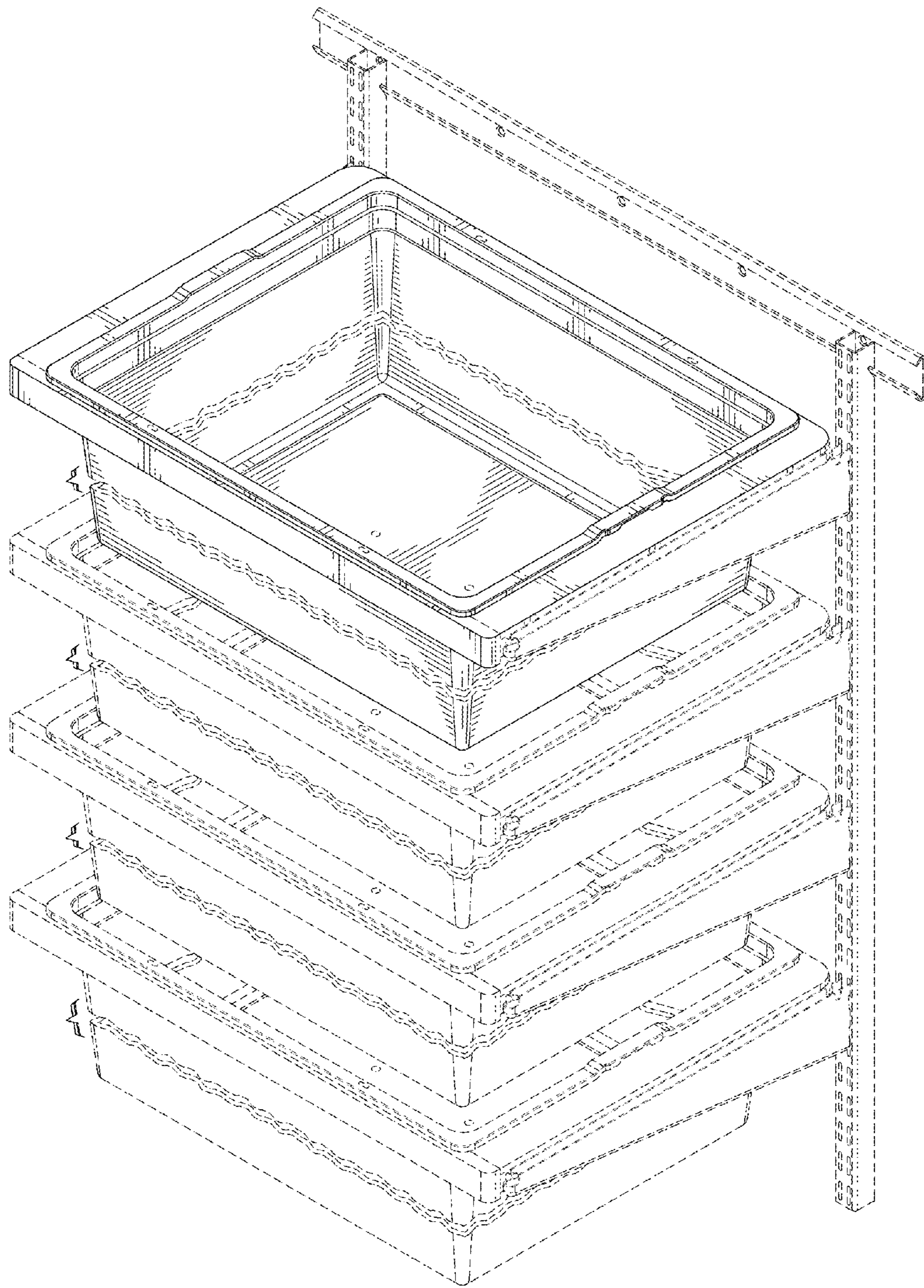

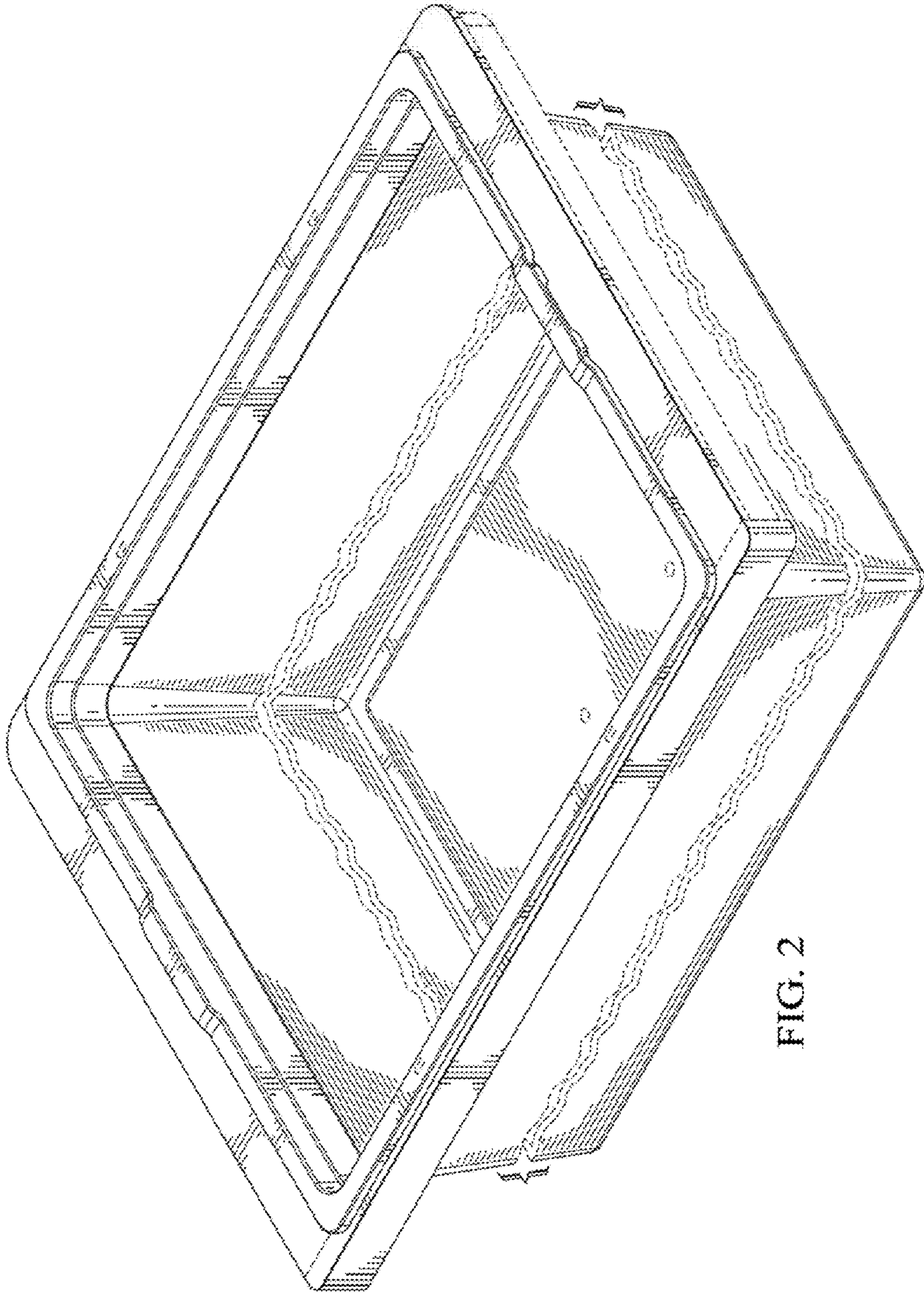

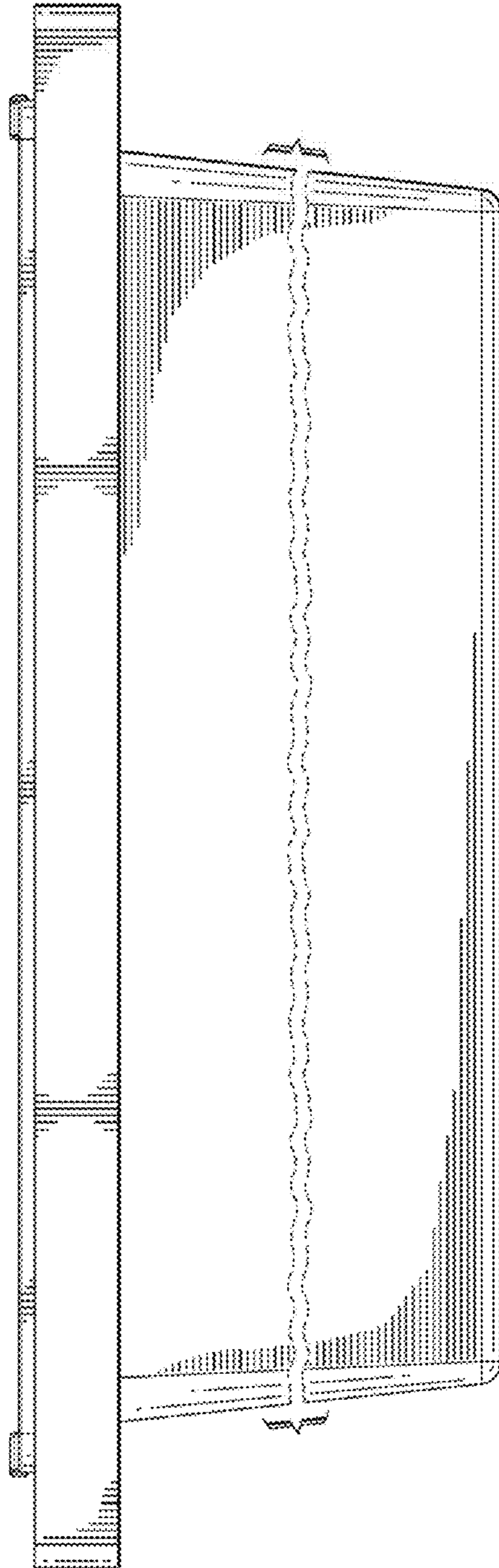

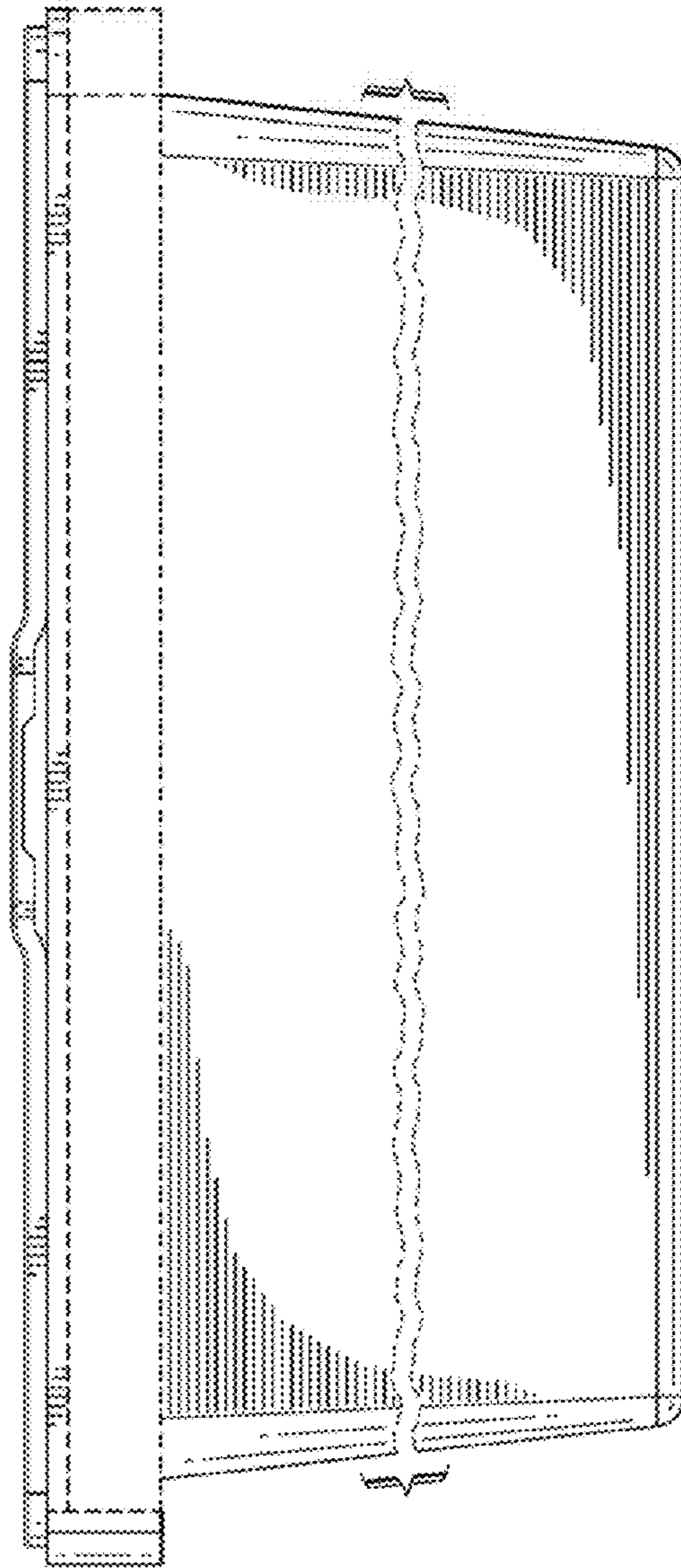

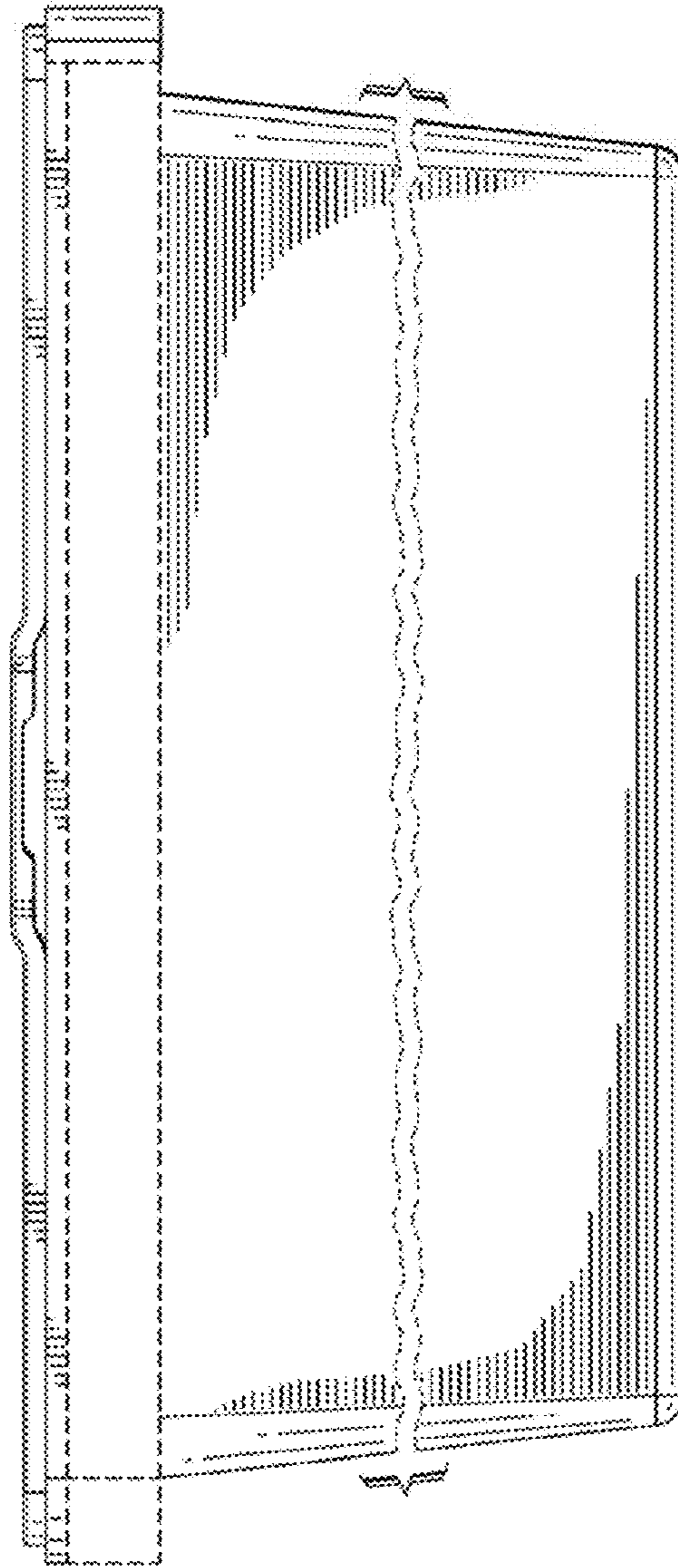
