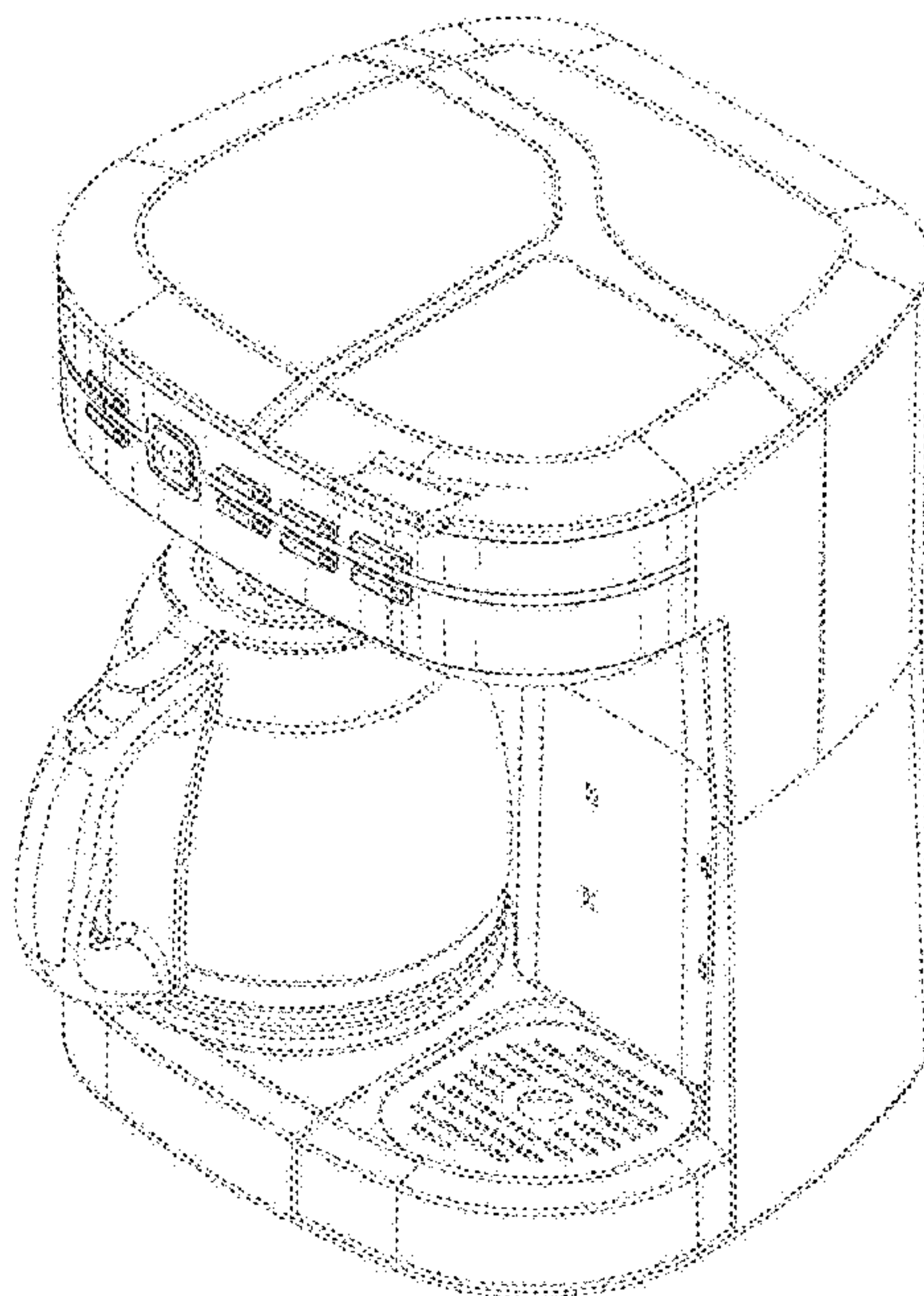
(57) **CLAIM**

The ornamental design for a beverage maker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a beverage maker showing our new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is the right side view thereof;
 FIG. 4 is the left side view thereof; and,
 FIG. 5 is the top view thereof.
 The two vertical broken lines adjacent the lateral sides of the shaded area represent unclaimed boundaries of the design. The two vertical broken lines within the shaded area form no part of the claimed design. The broken line showing of the remainder of the beverage maker represents unclaimed subject matter and forms no part of the claimed design.

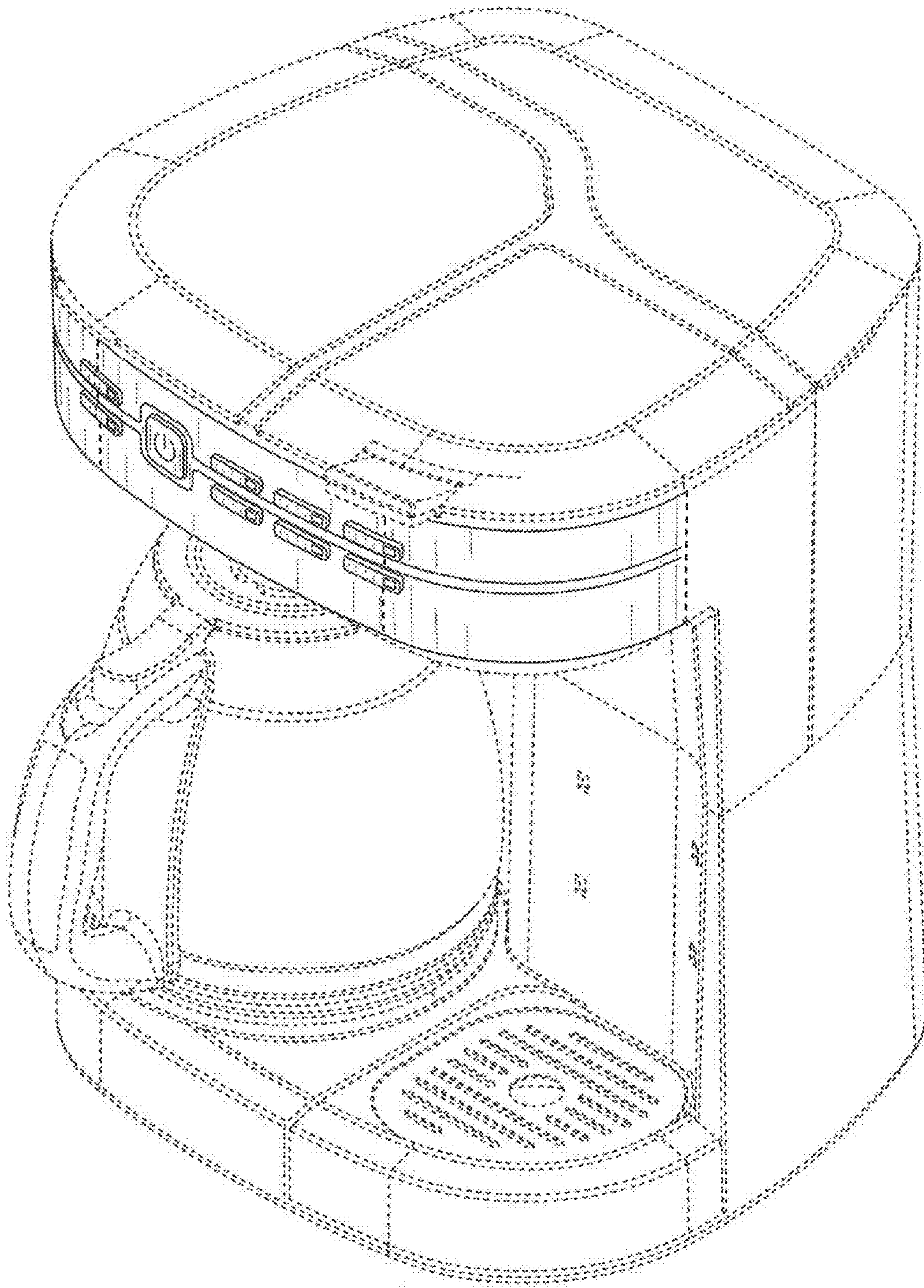

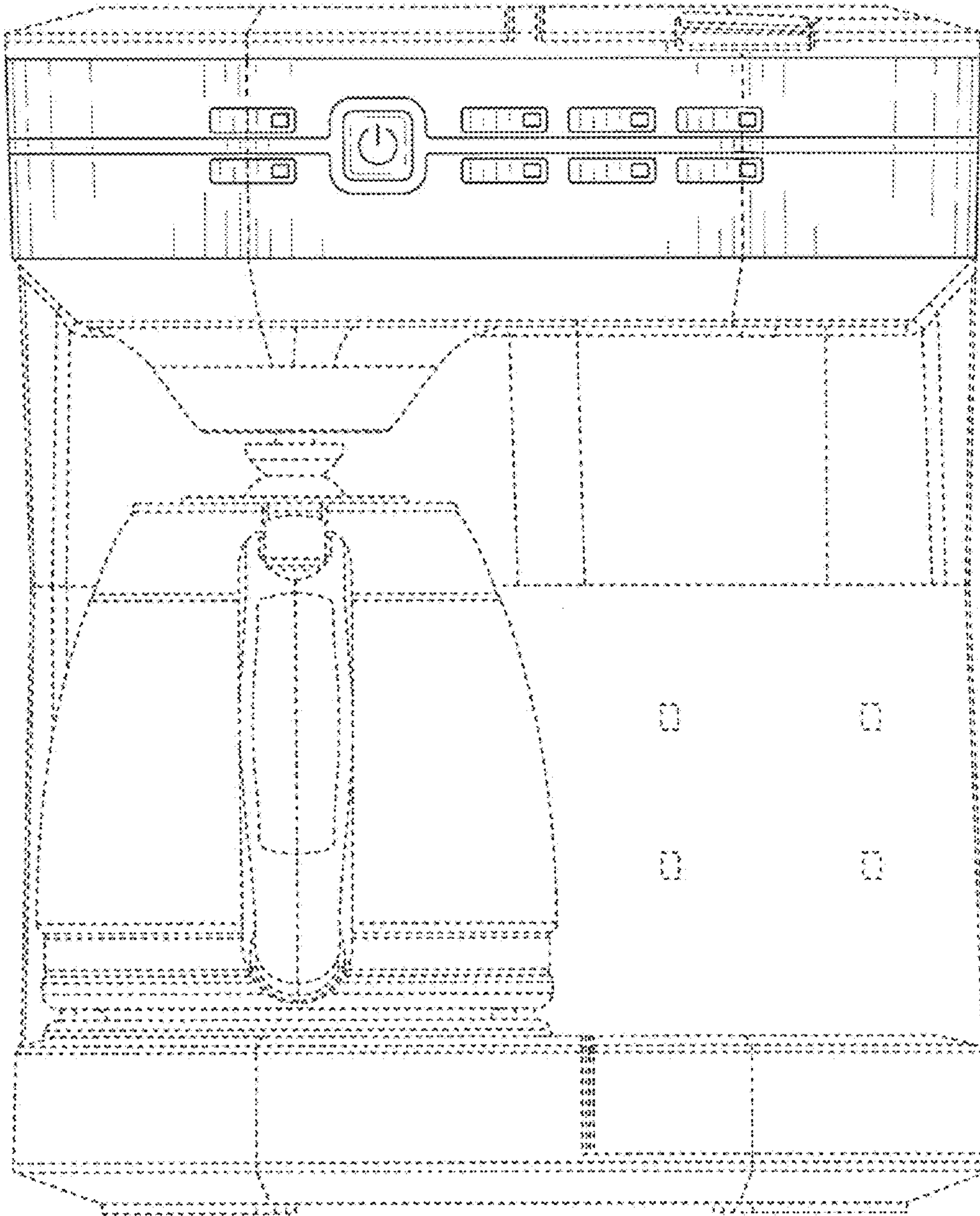

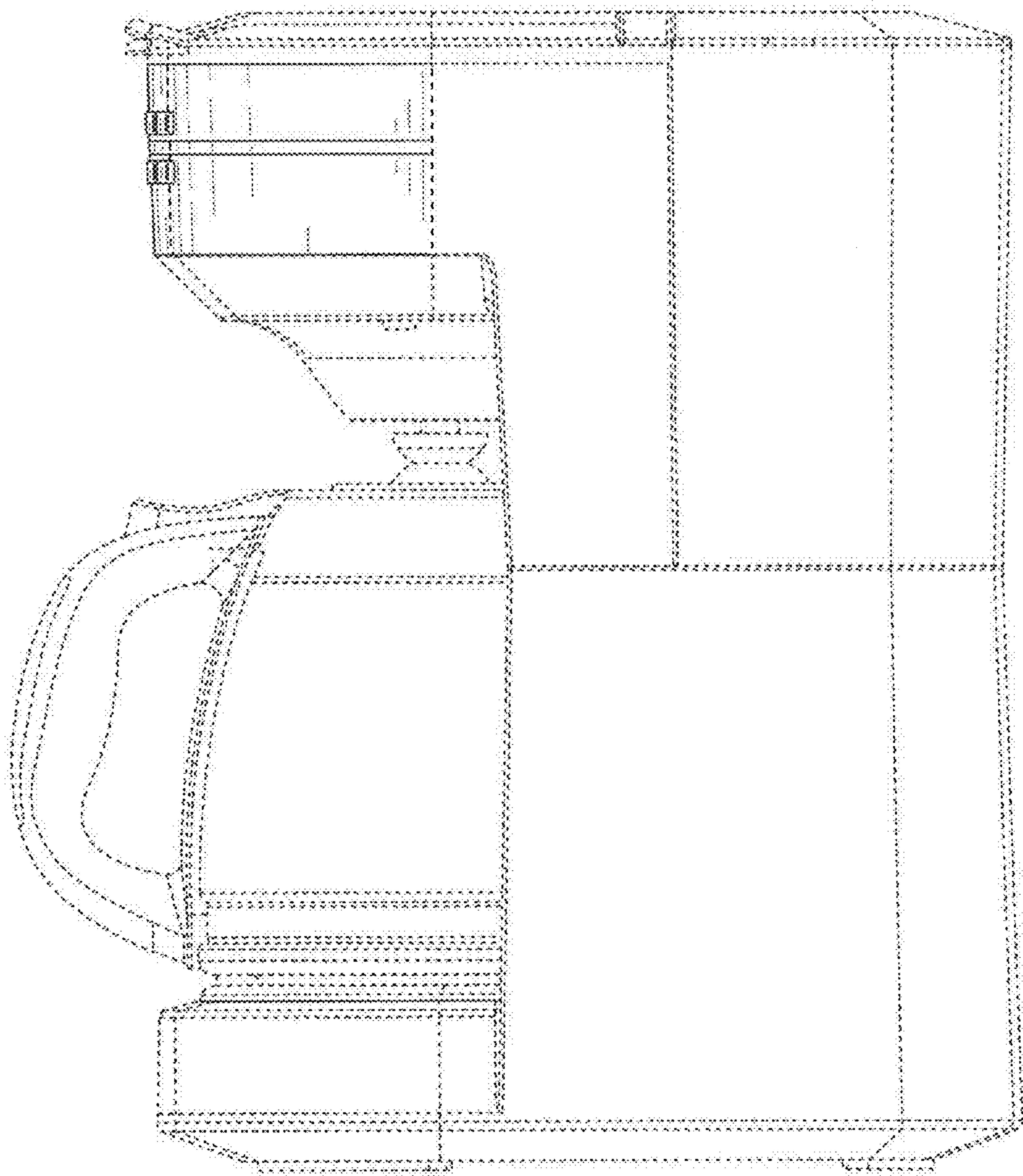

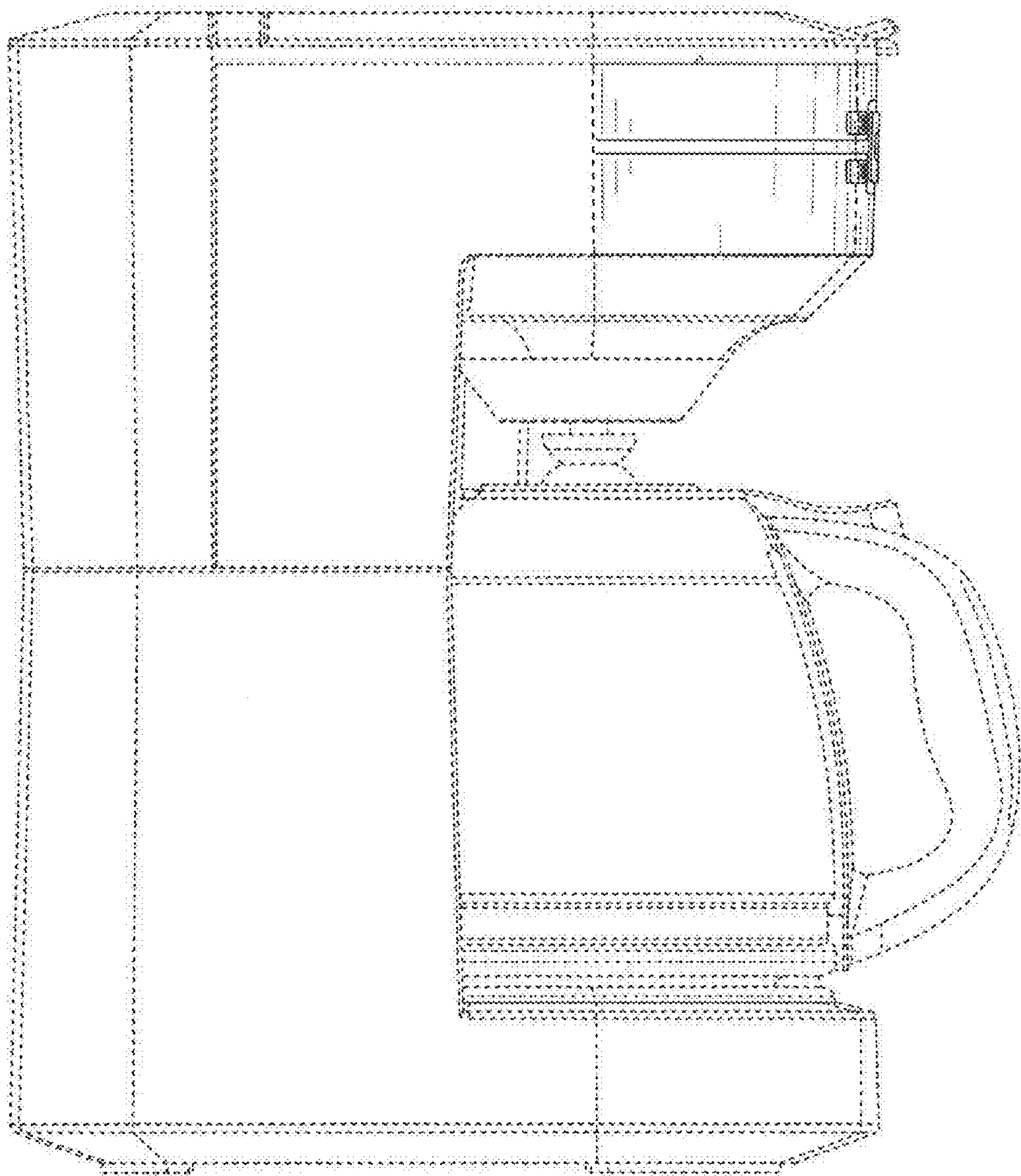

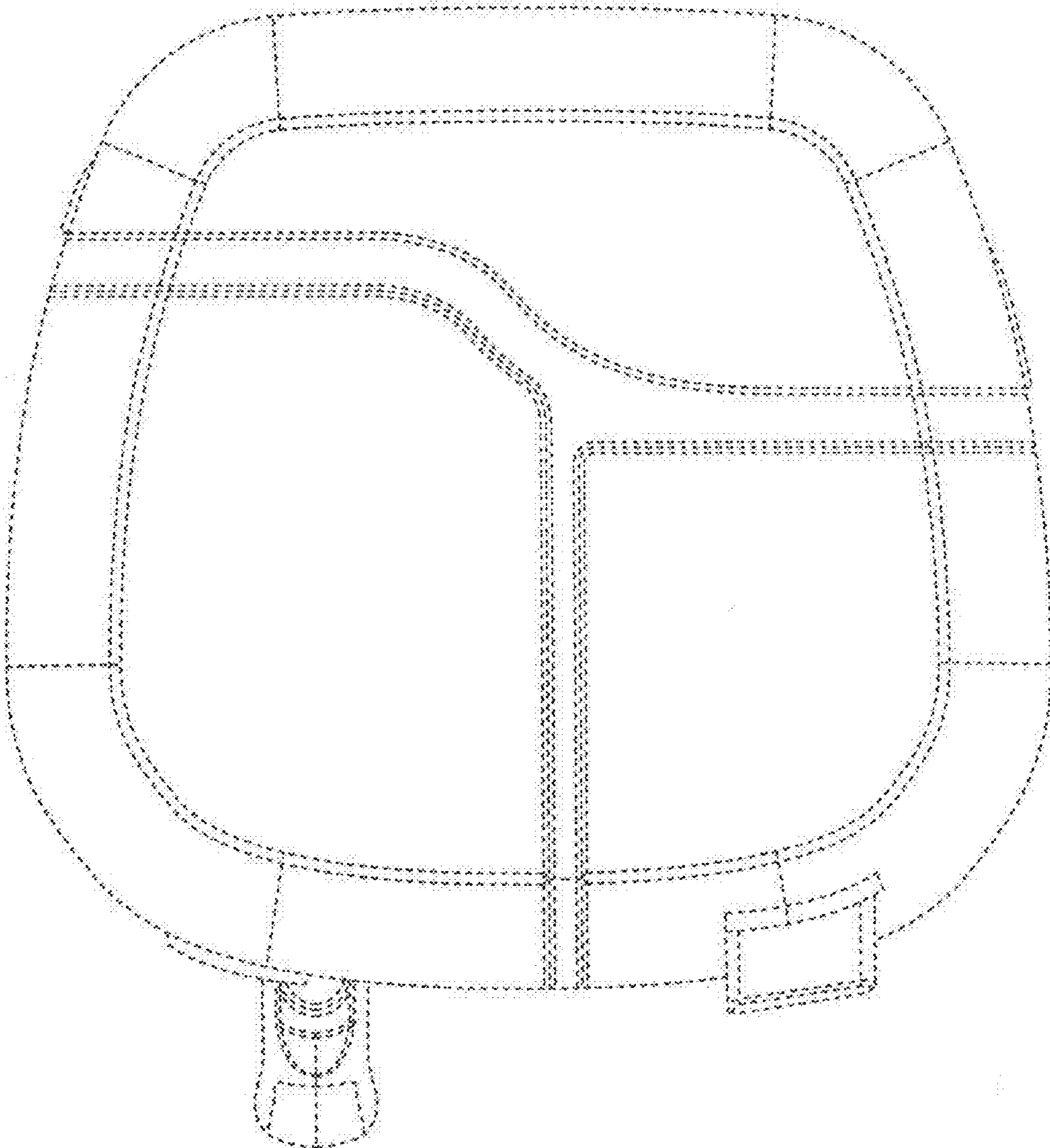
