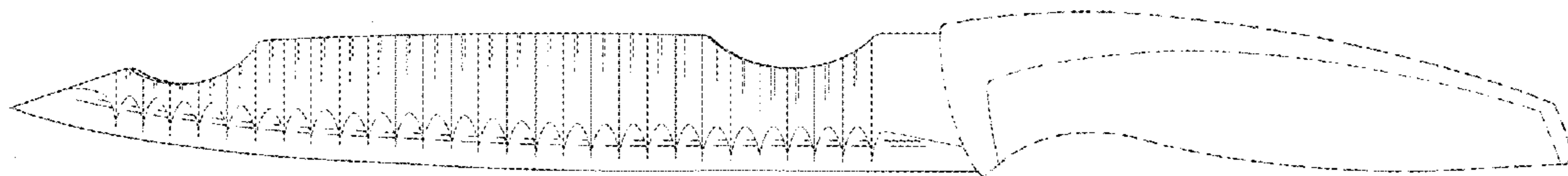

(57) **CLAIM**
The ornamental design for a long narrow knife, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a long narrow knife showing my design therefor;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a back view thereof; and,
FIG. 6 is a right side elevational view thereof.
The handle shown in broken lines forms no part of the design.

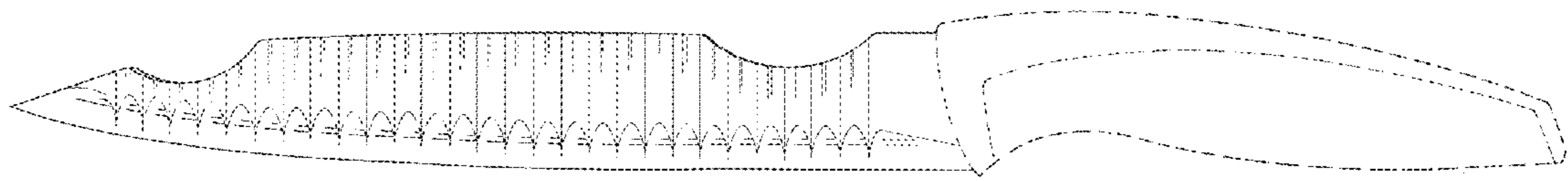

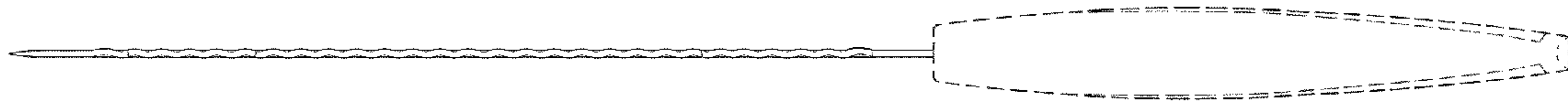

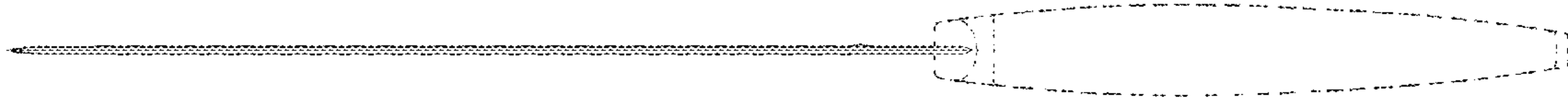

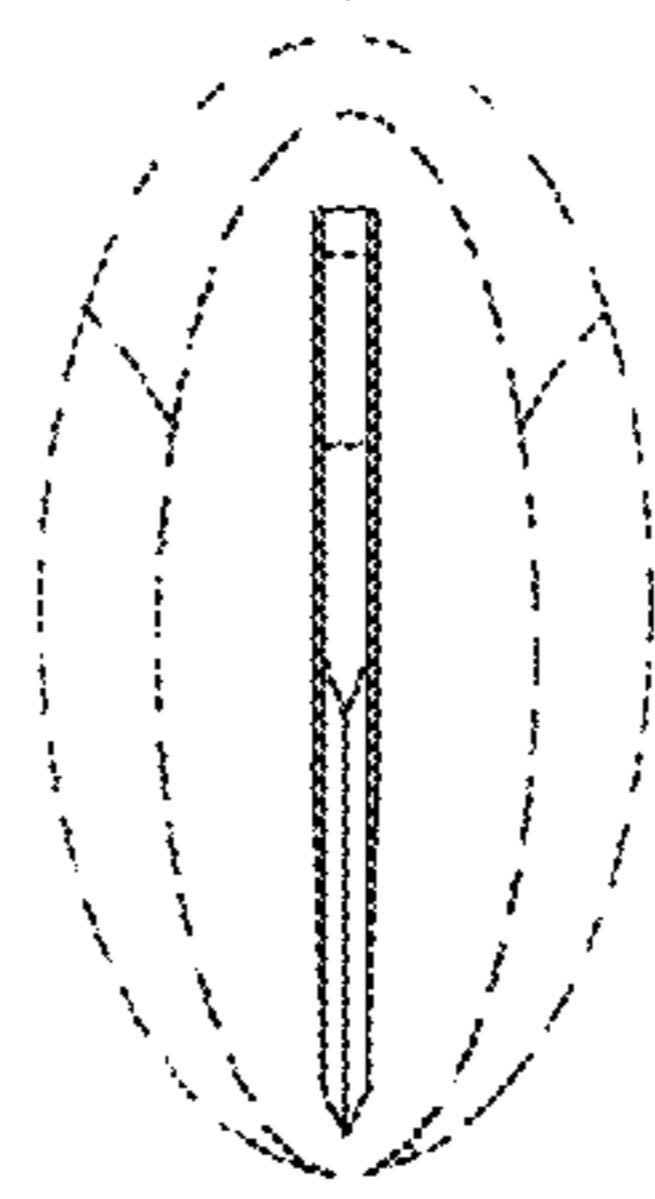

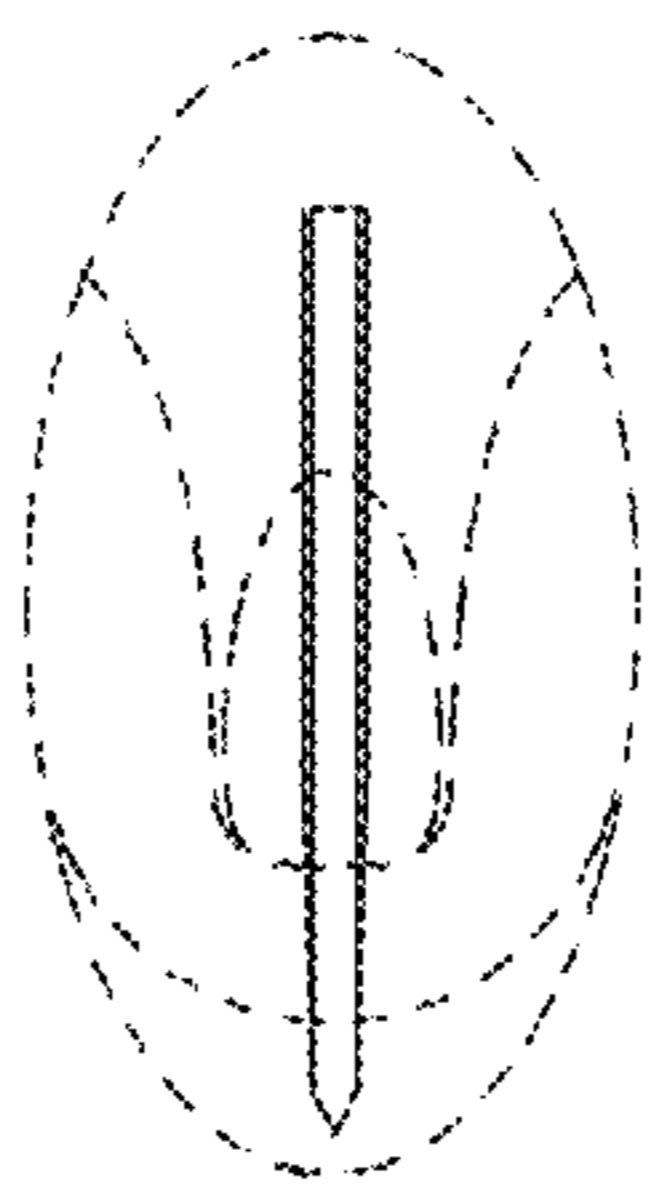

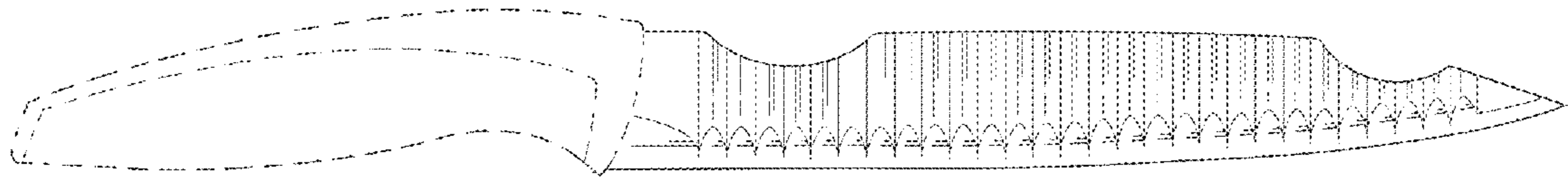
