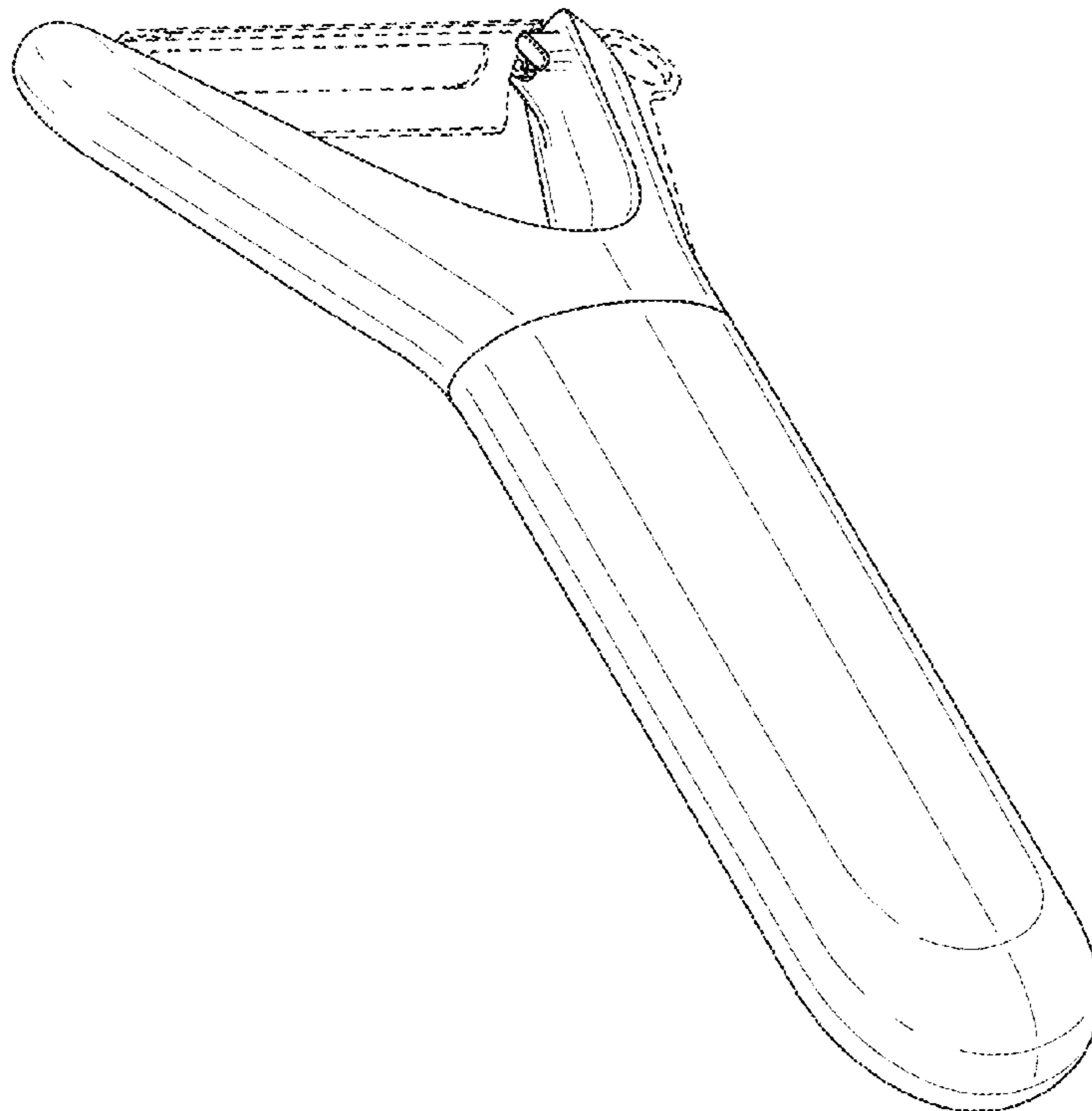

DESCRIPTION

FIG. 1 is a perspective view of the straight peeler showing my new design.

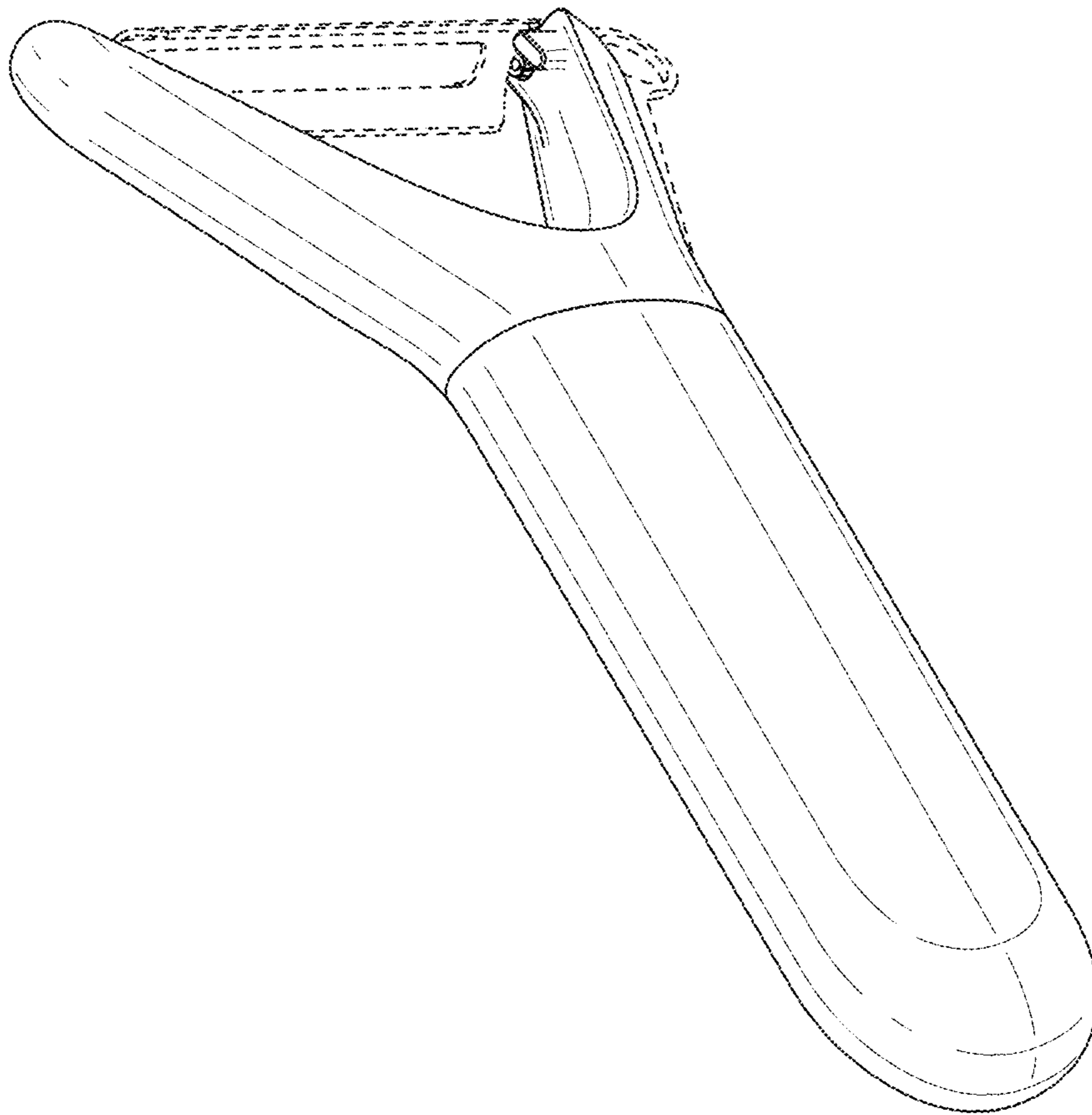

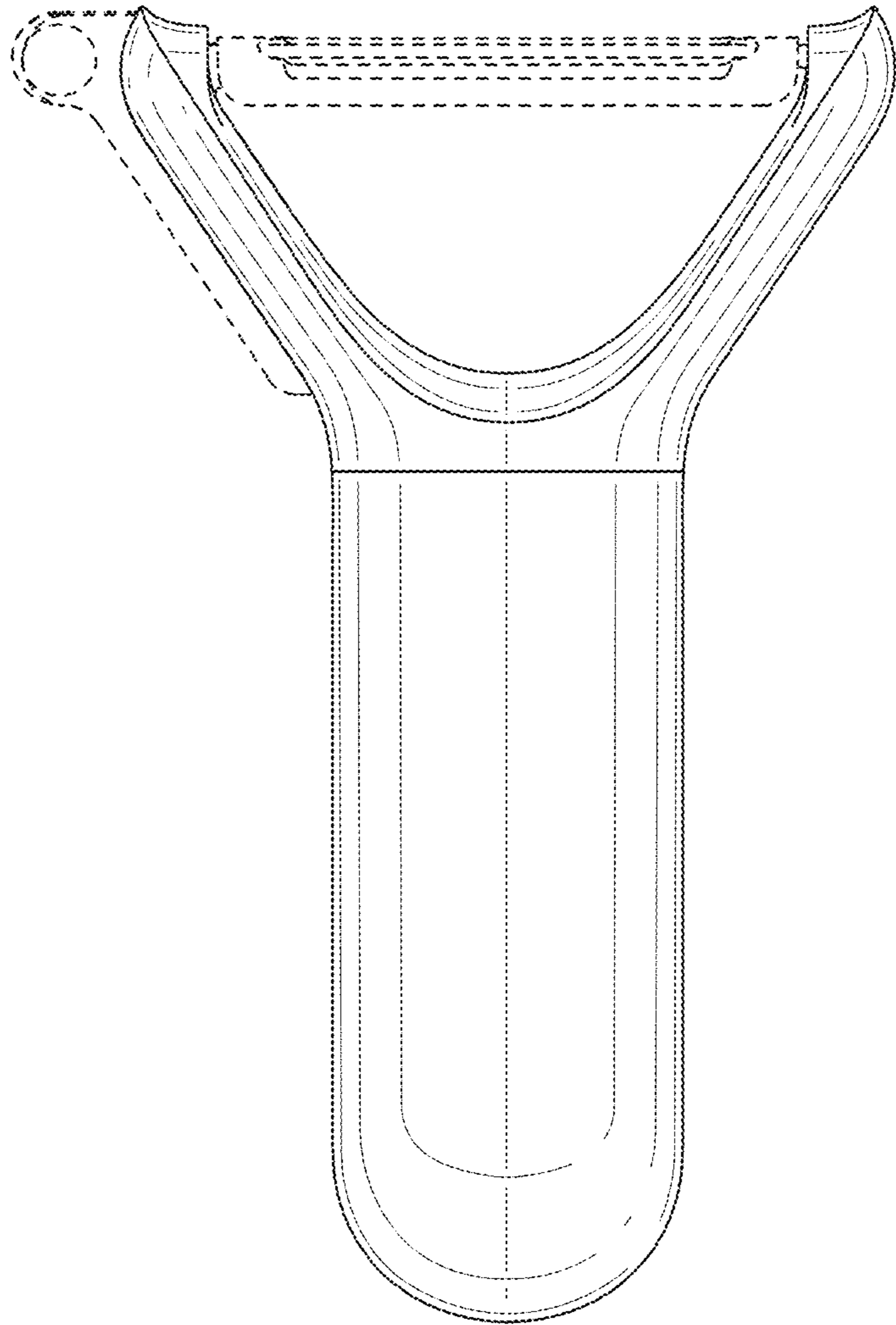

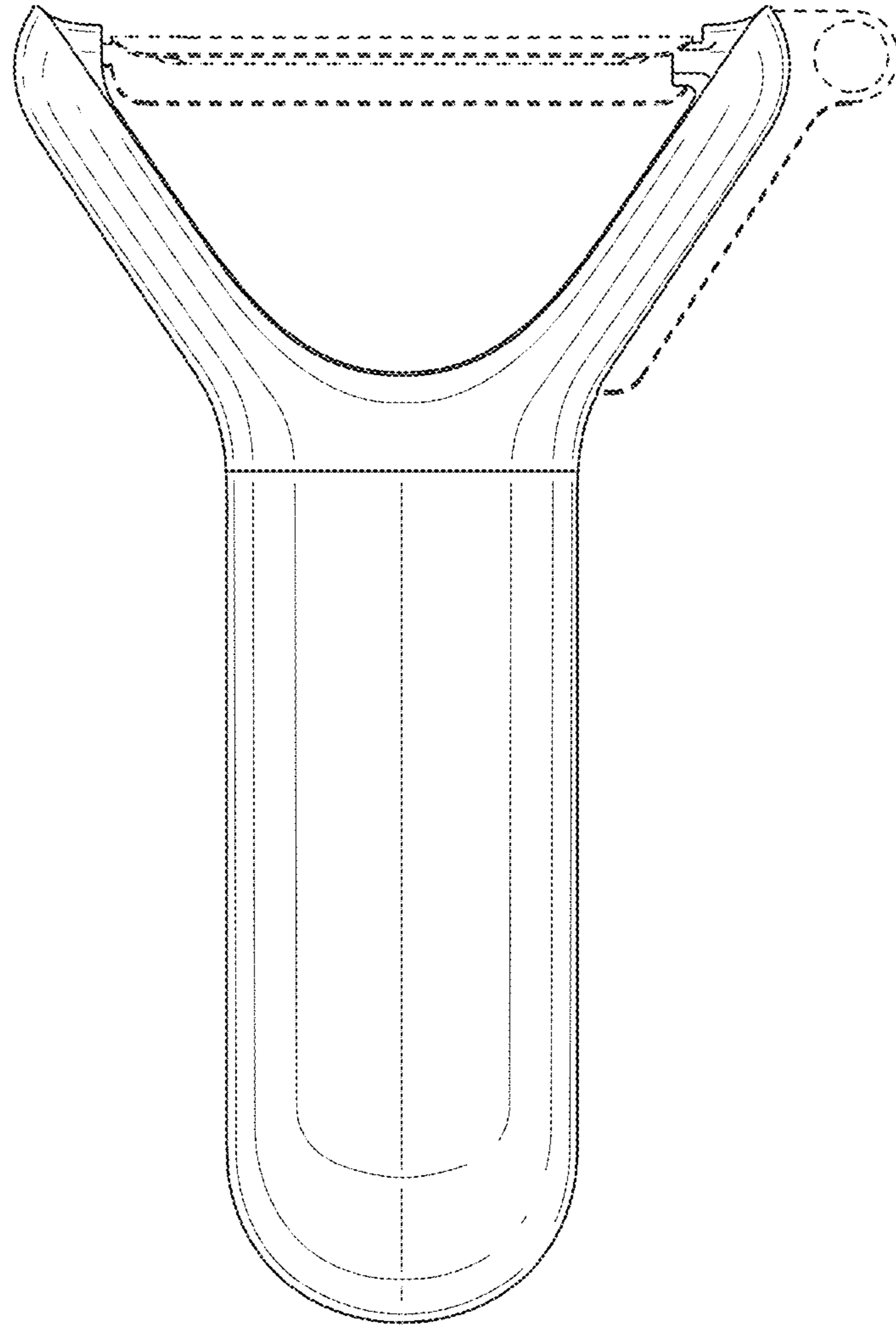

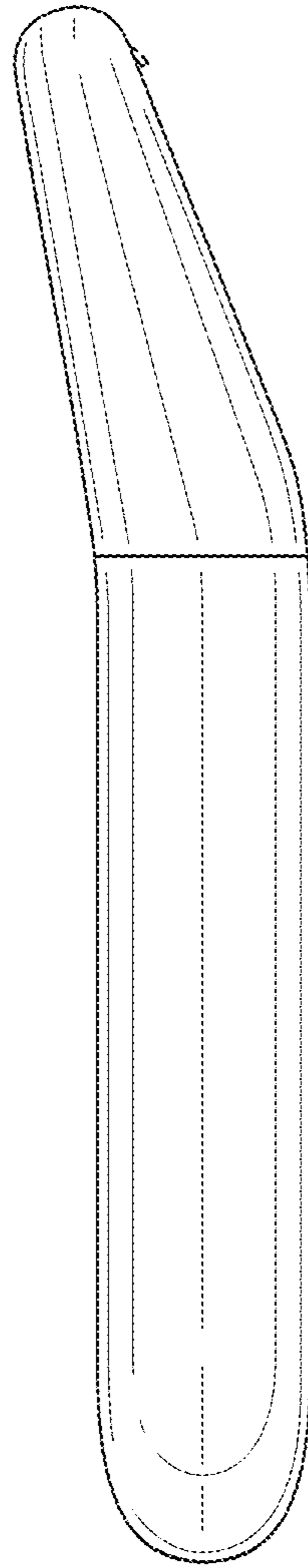

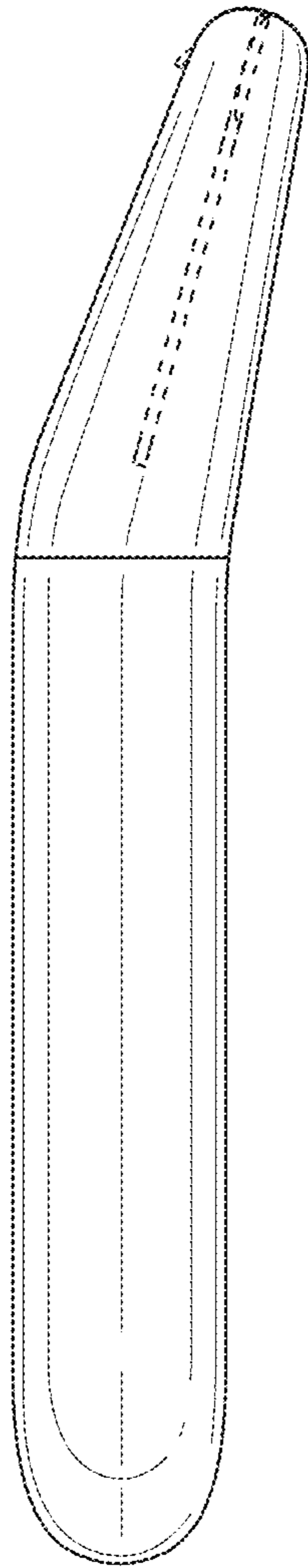

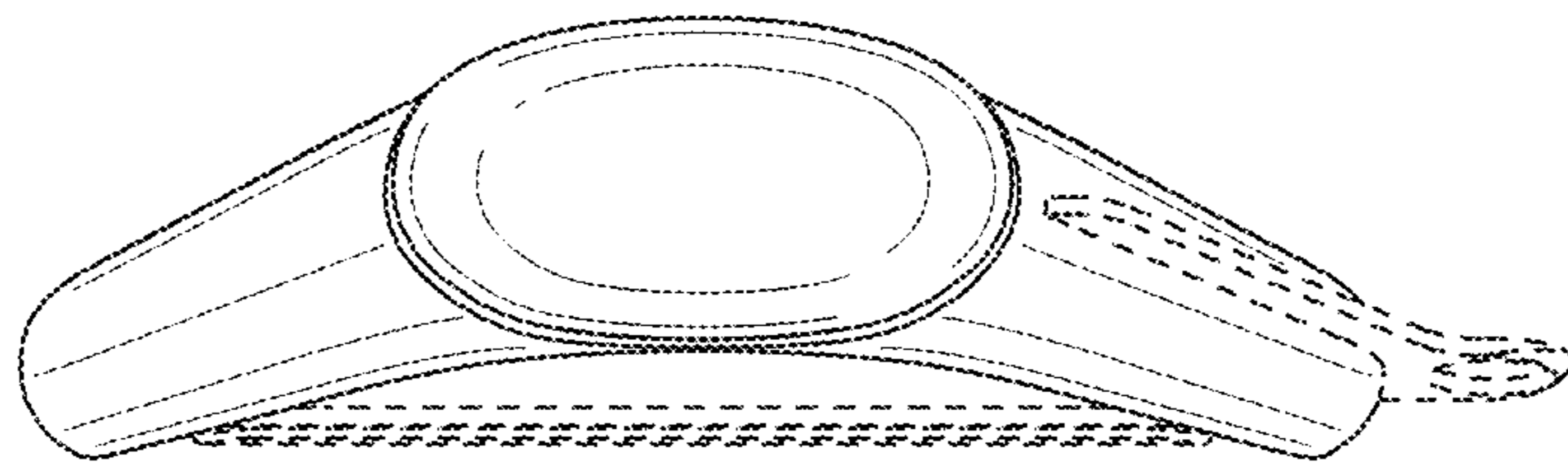

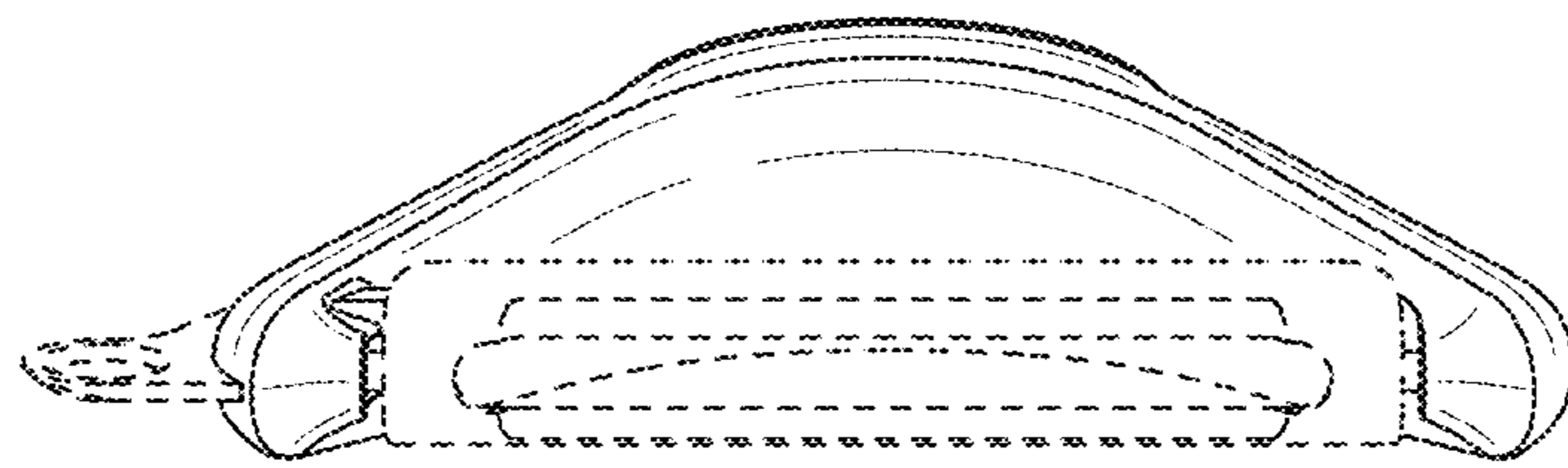

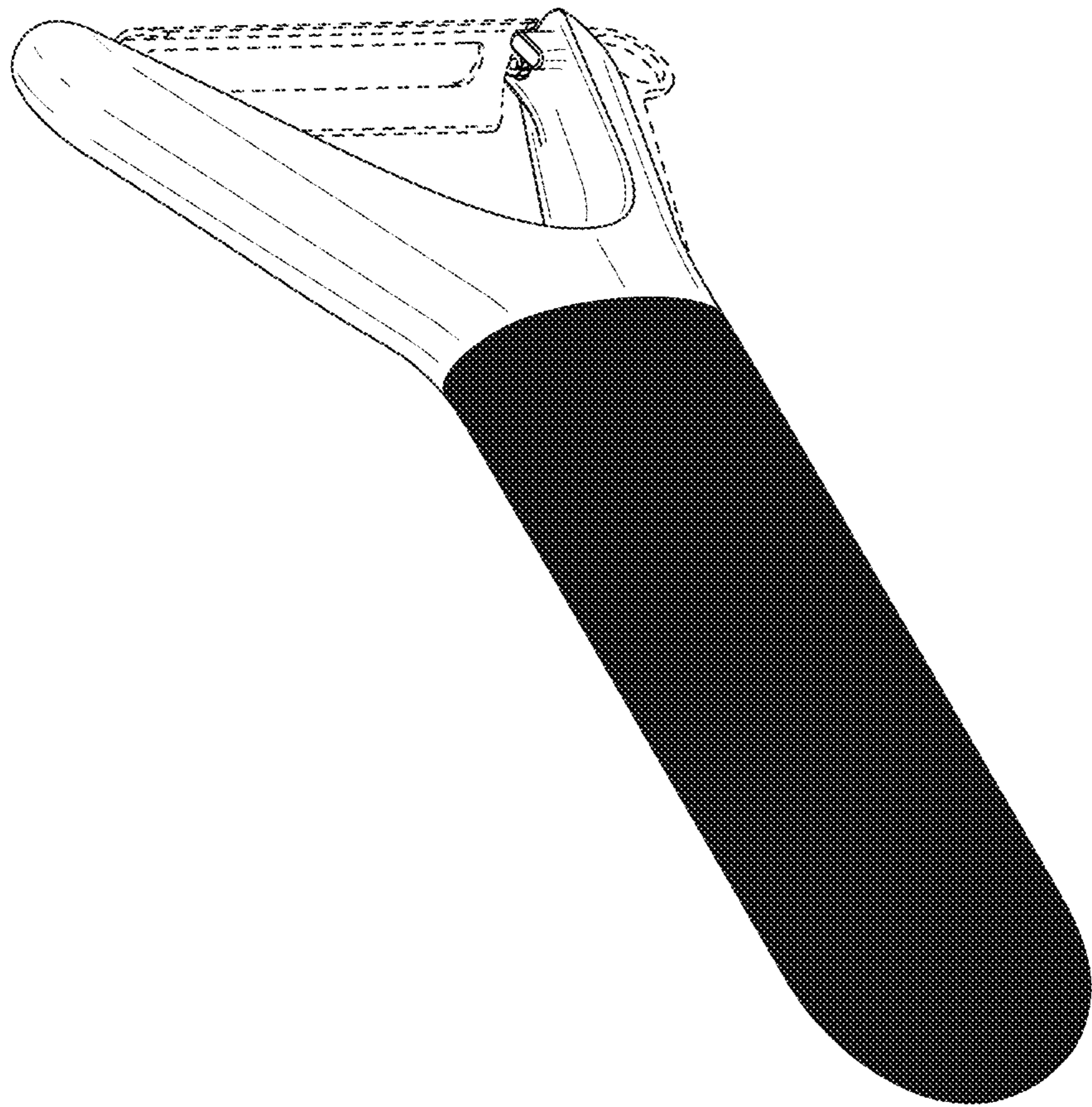

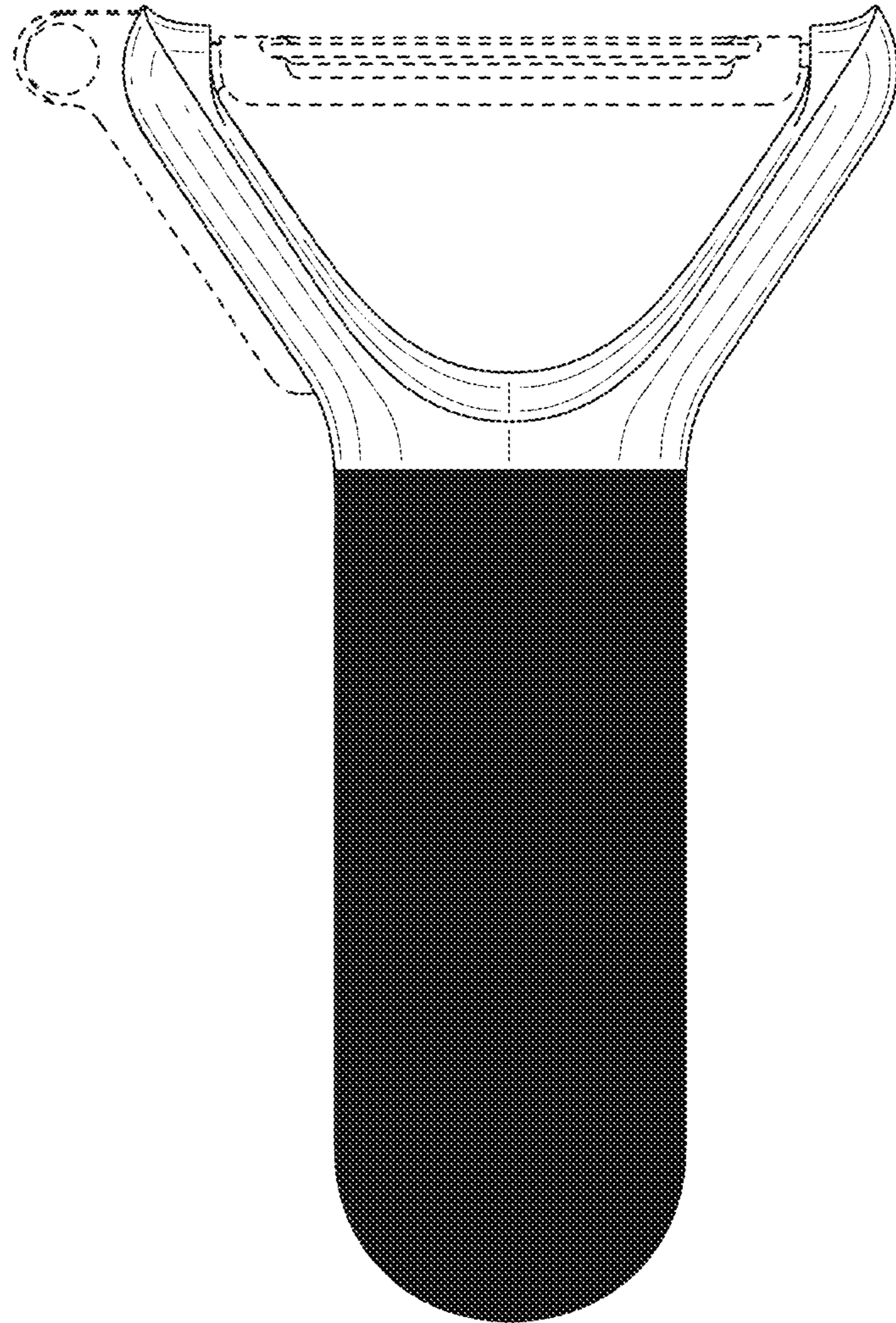

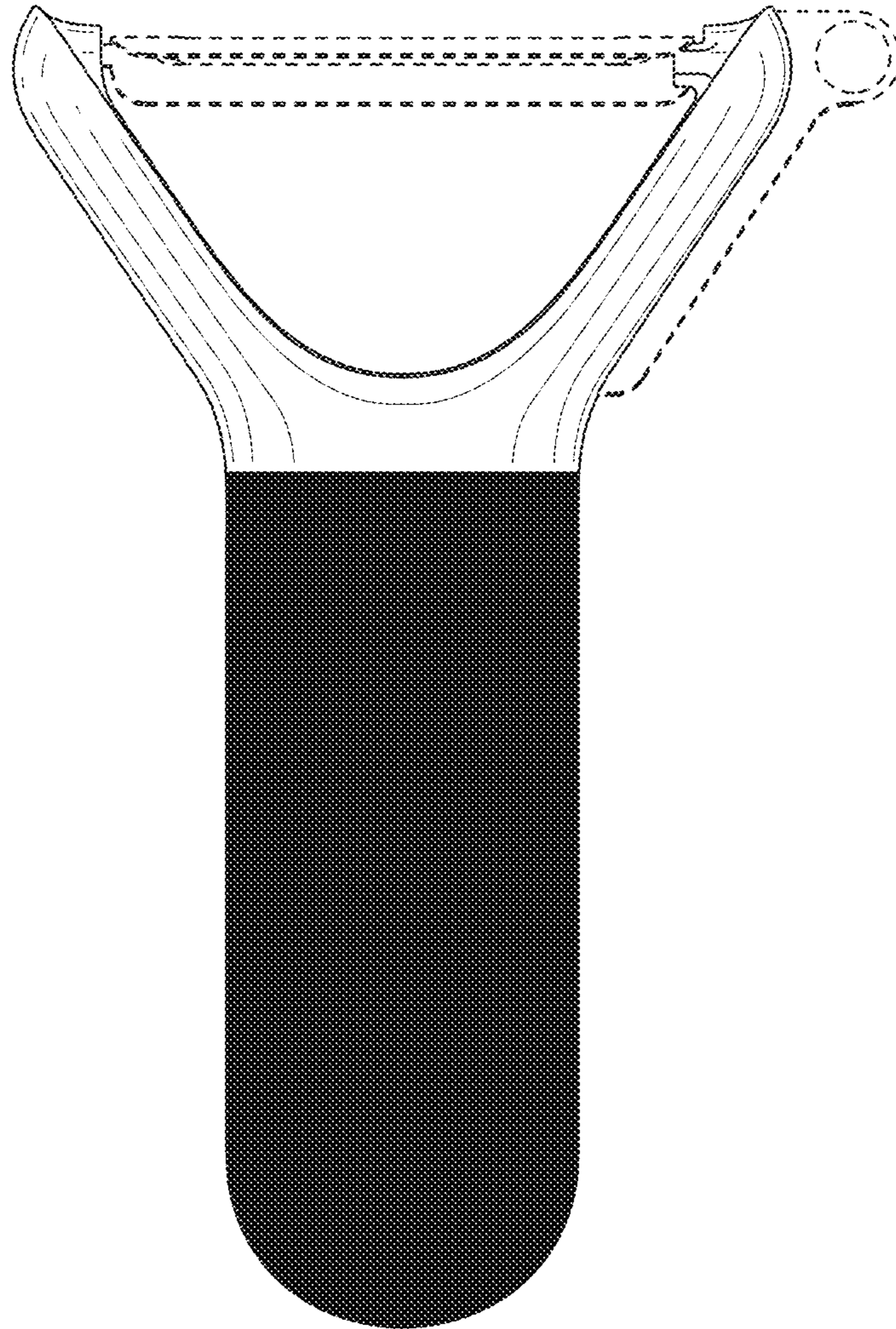

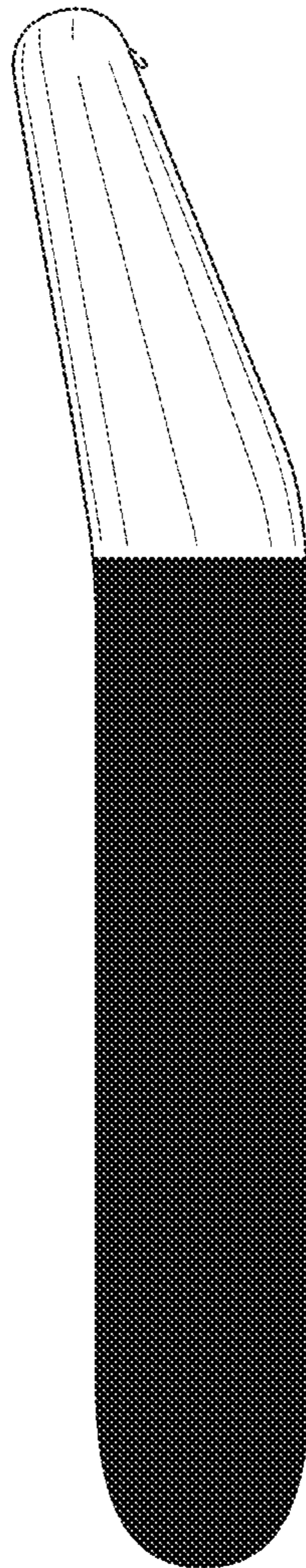

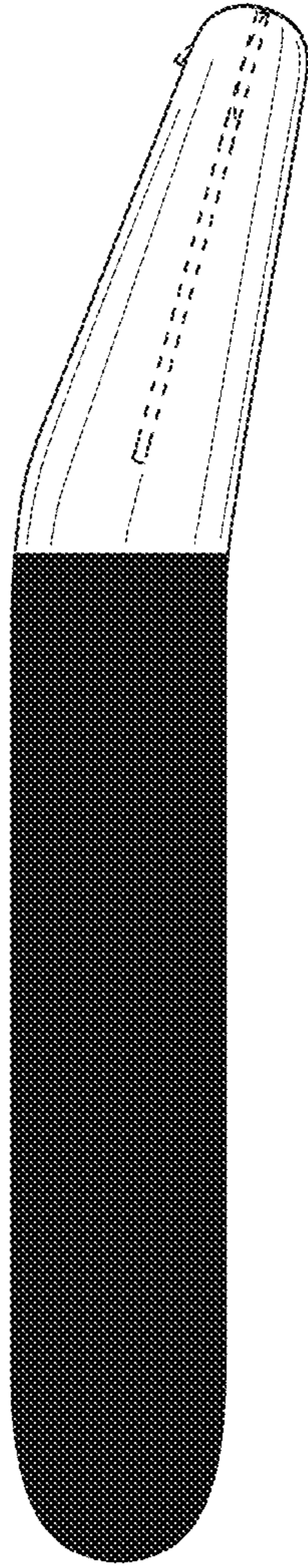

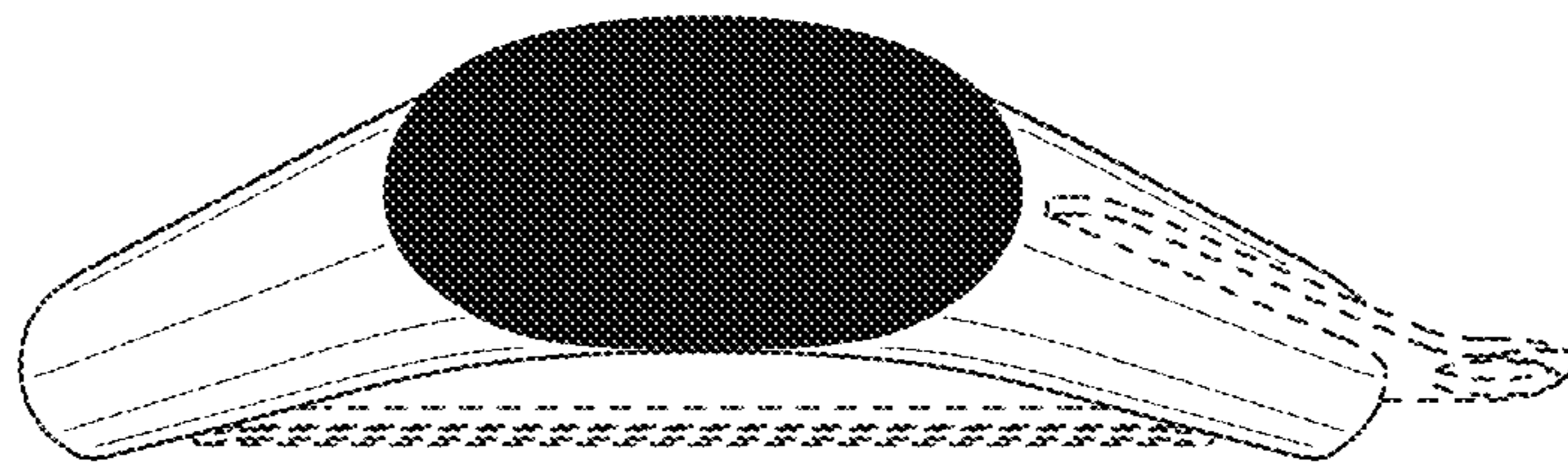

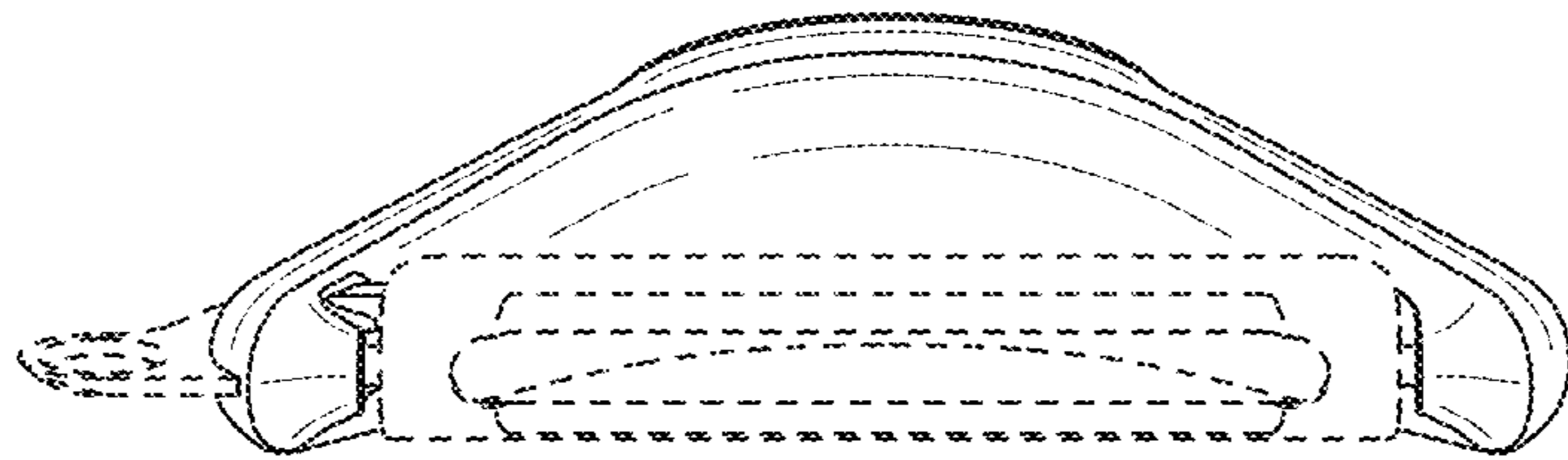
