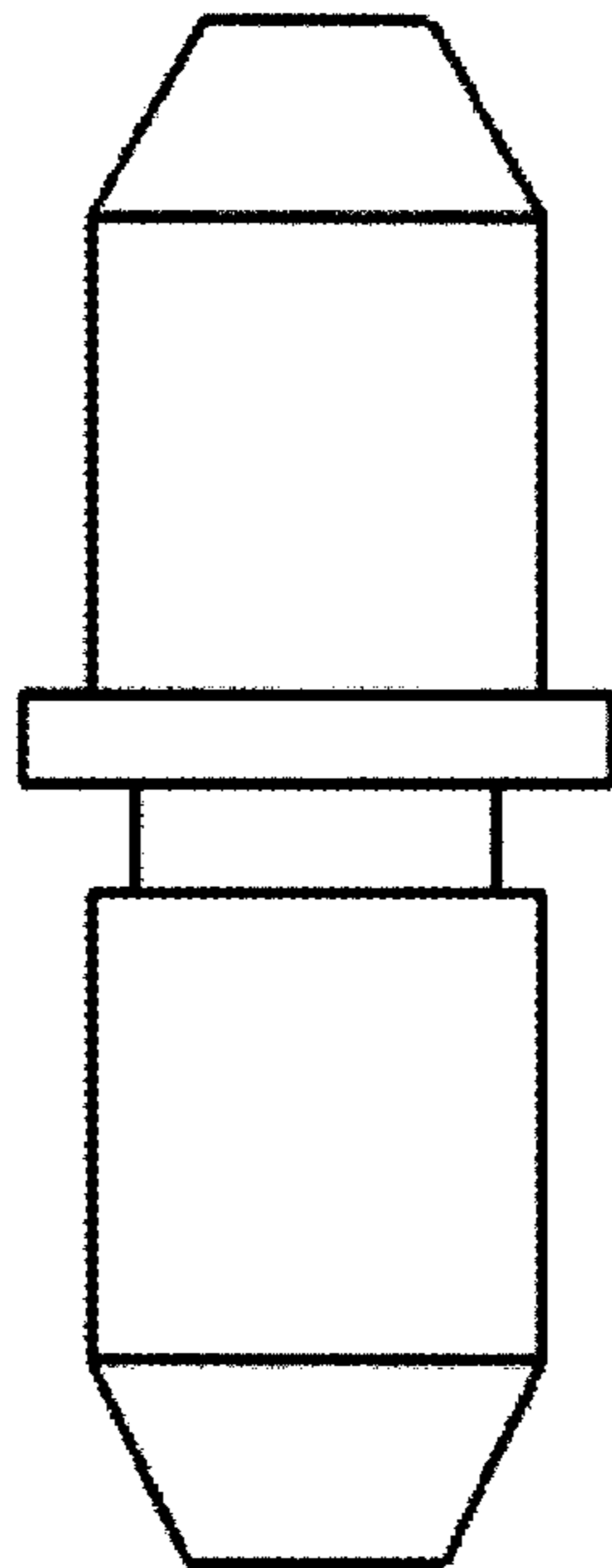
The ornamental design for a double-ended self-clinching guide pin, as shown and described.

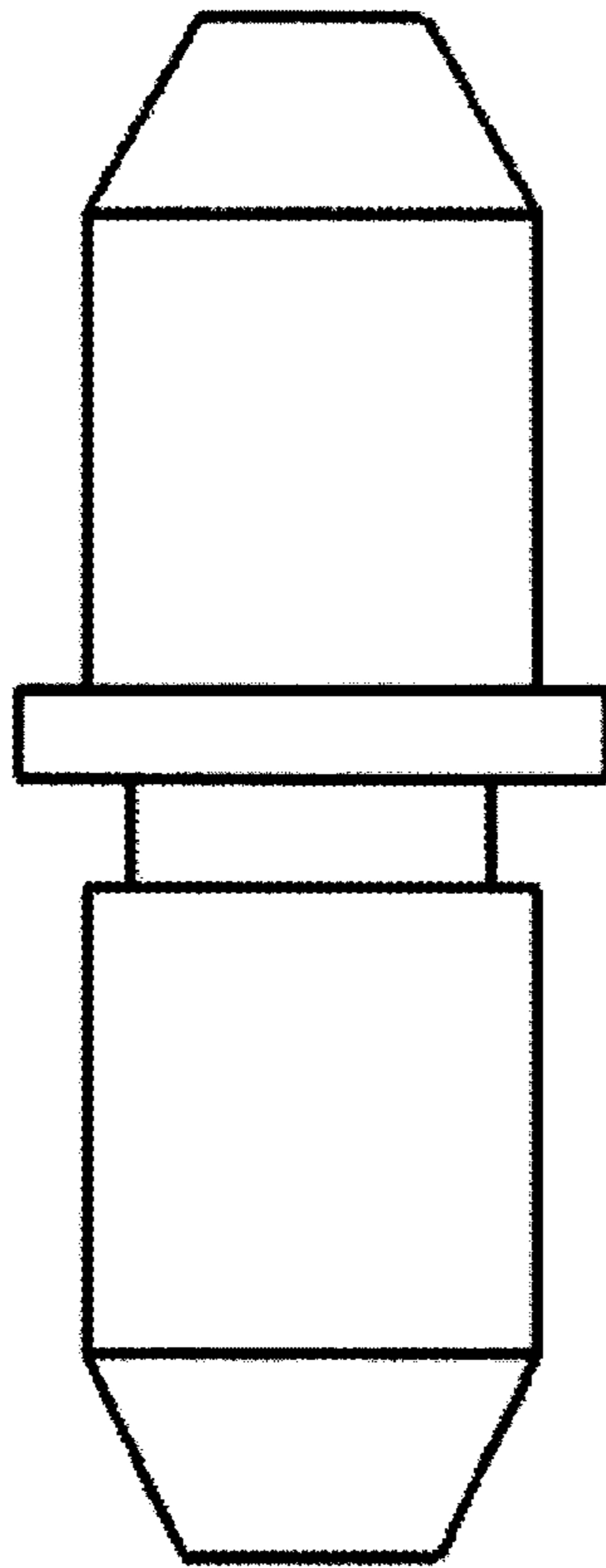

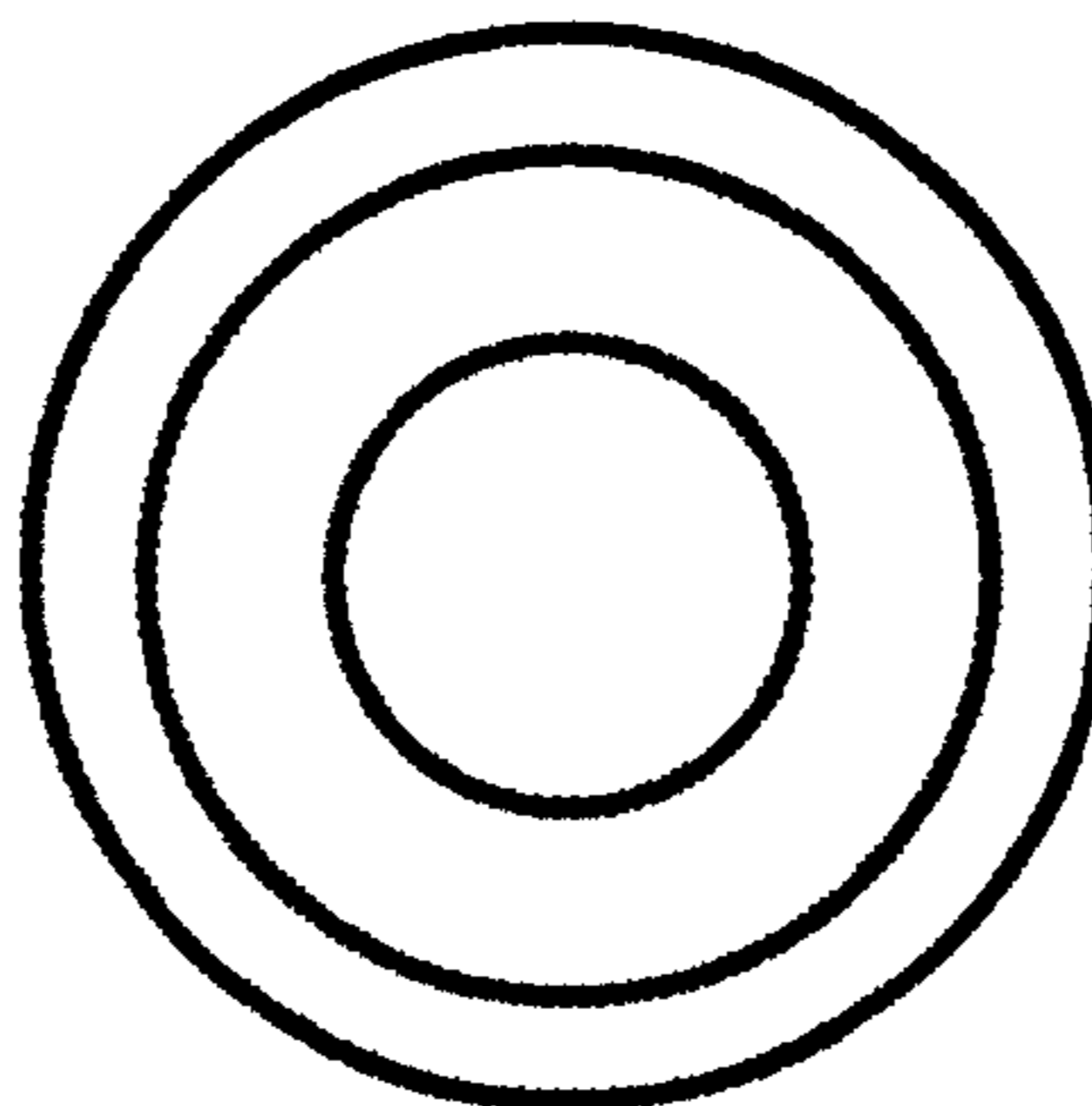
