DESCRIPTION

FIG. 1 is a top, left side perspective view showing the new design for a bottle;

FIG. 9 is a rear elevation view of the bottle from FIG. 1;

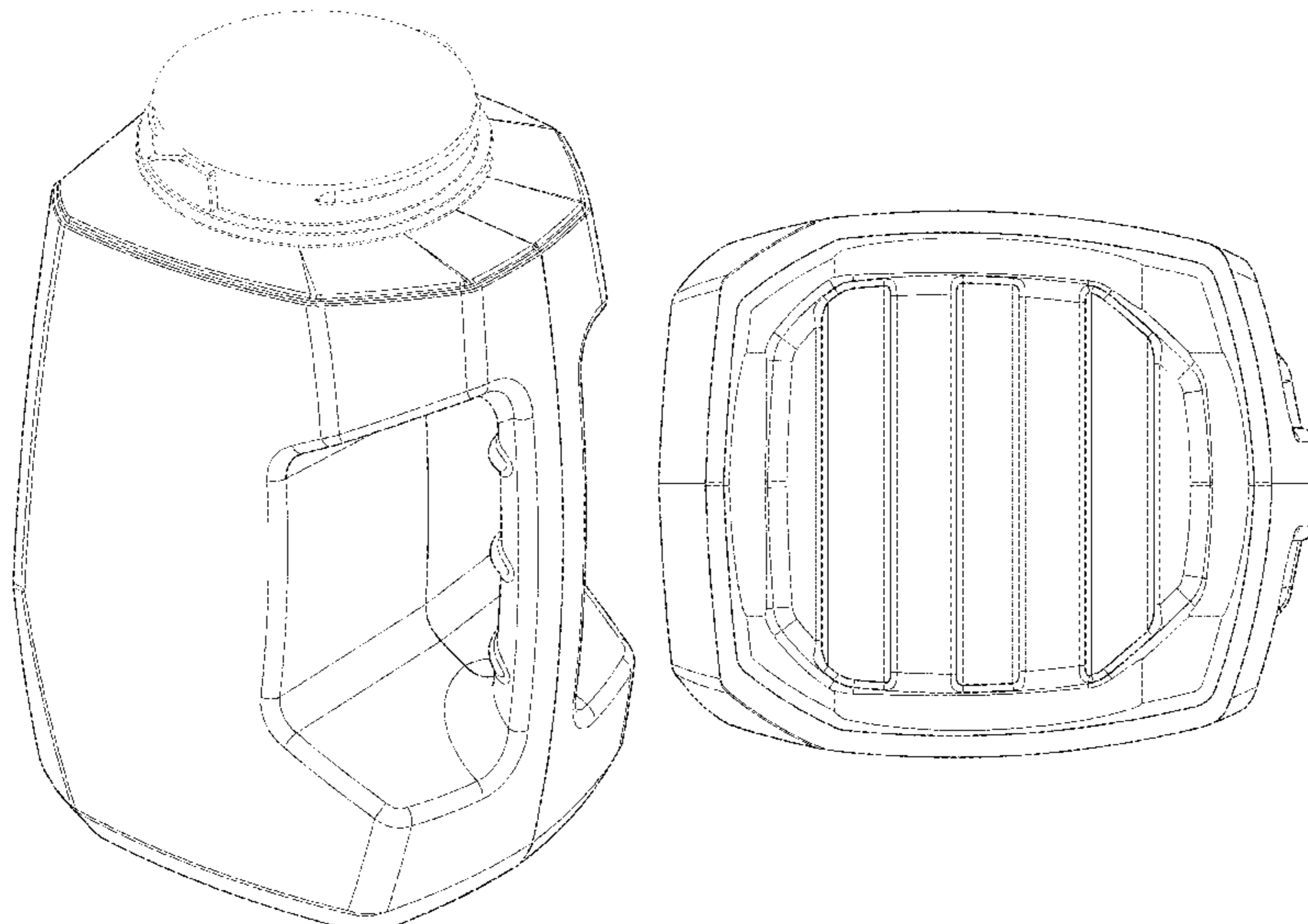
FIG. 10 is a right side view of the bottle from FIG. 1;

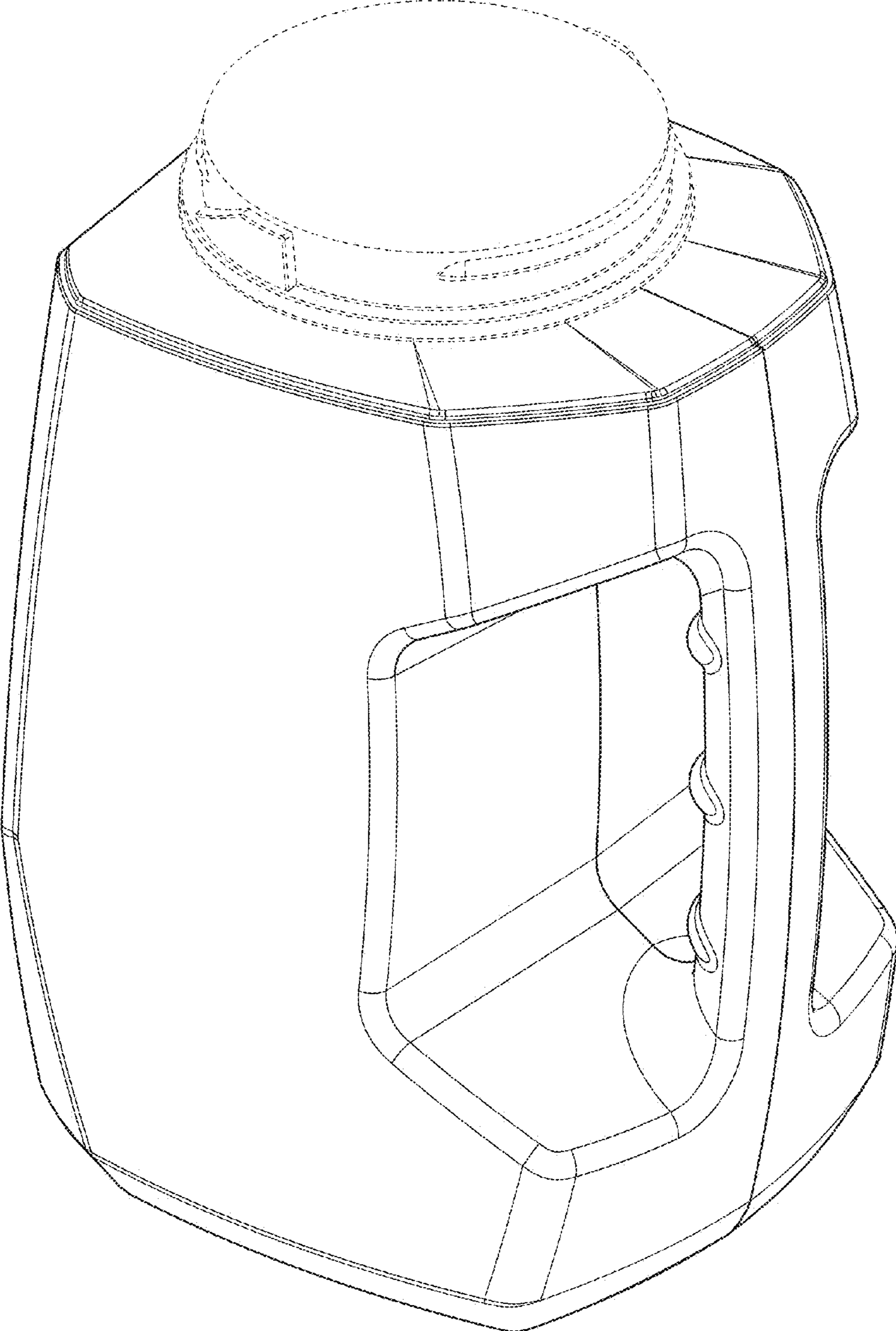

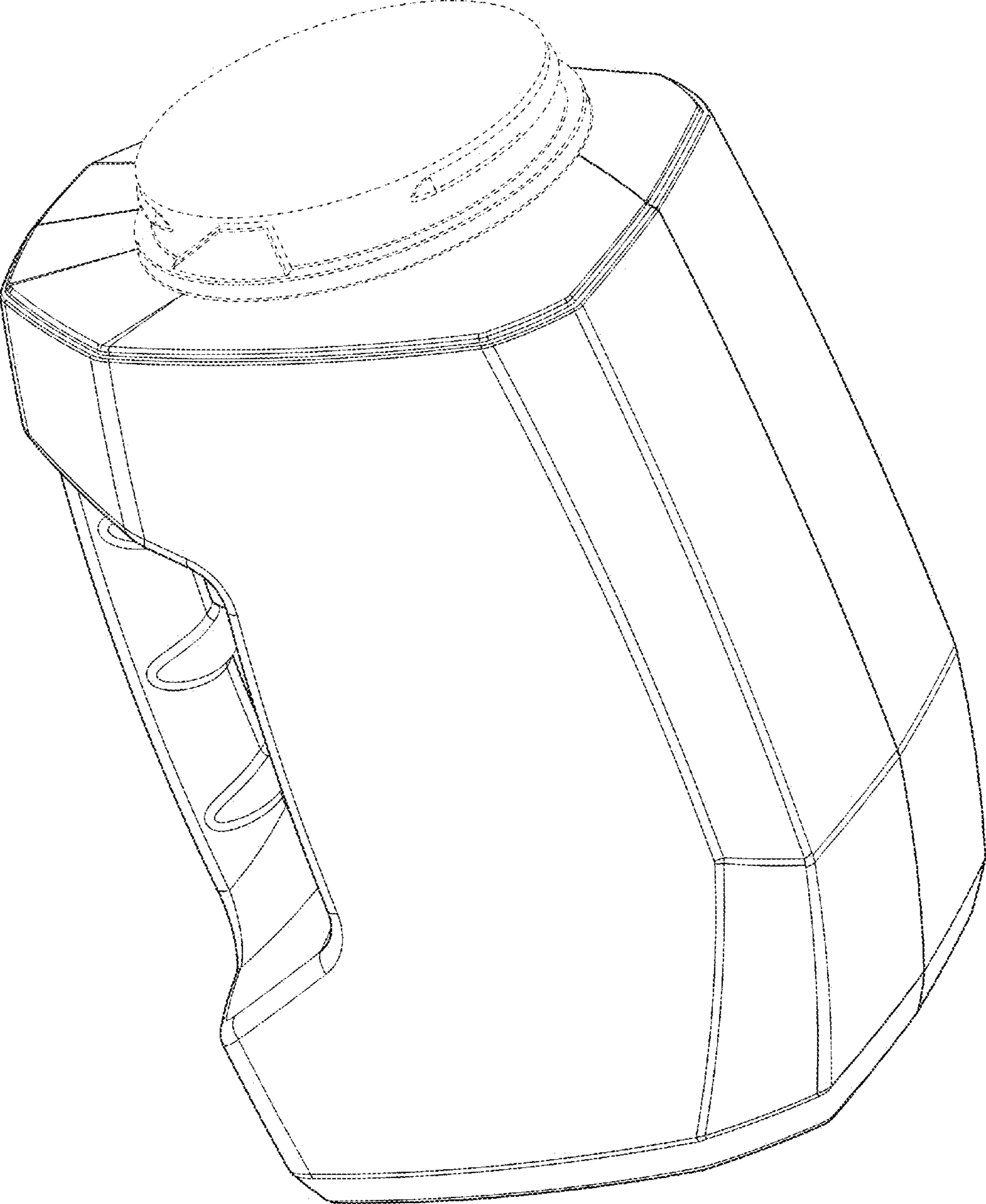

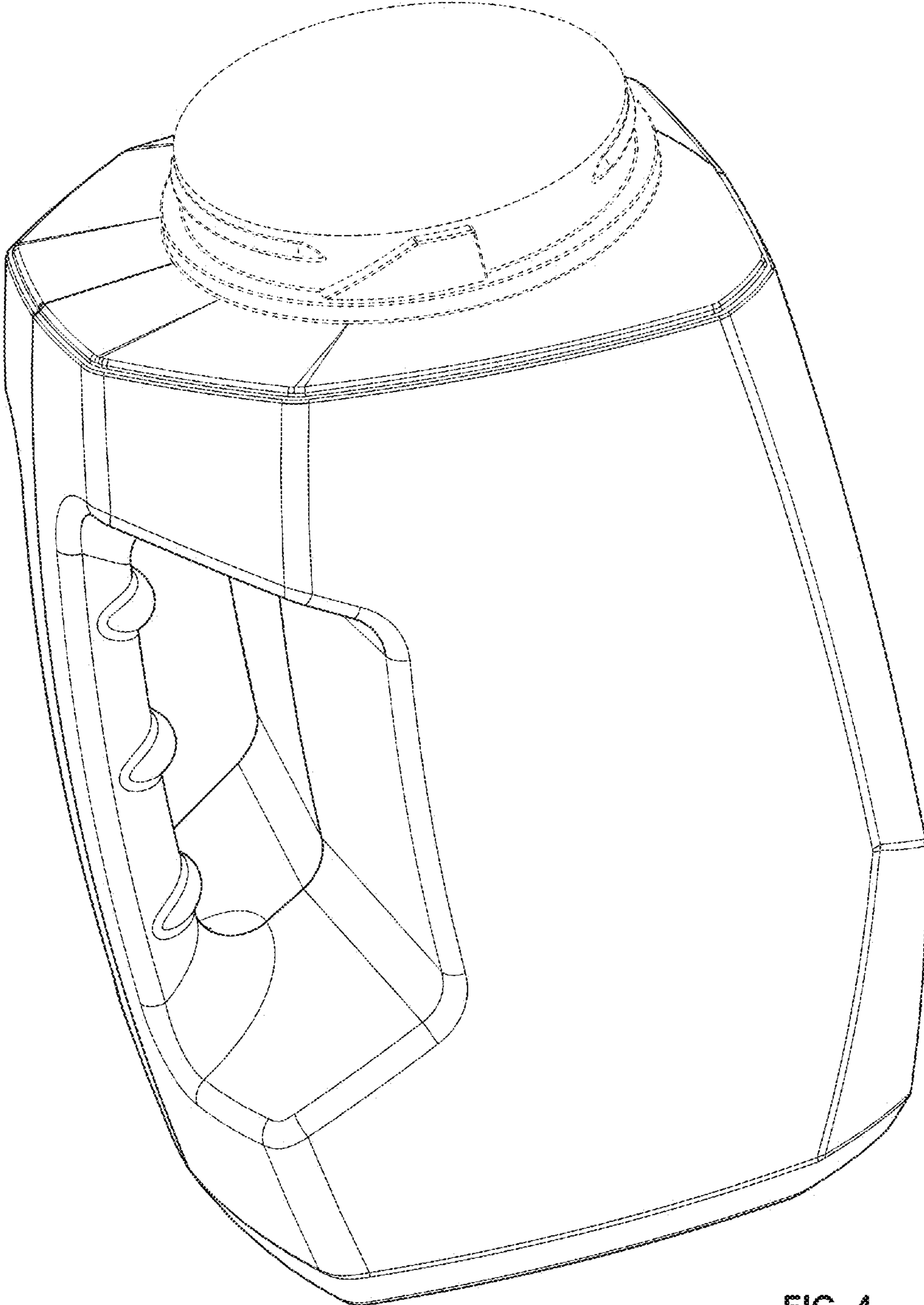

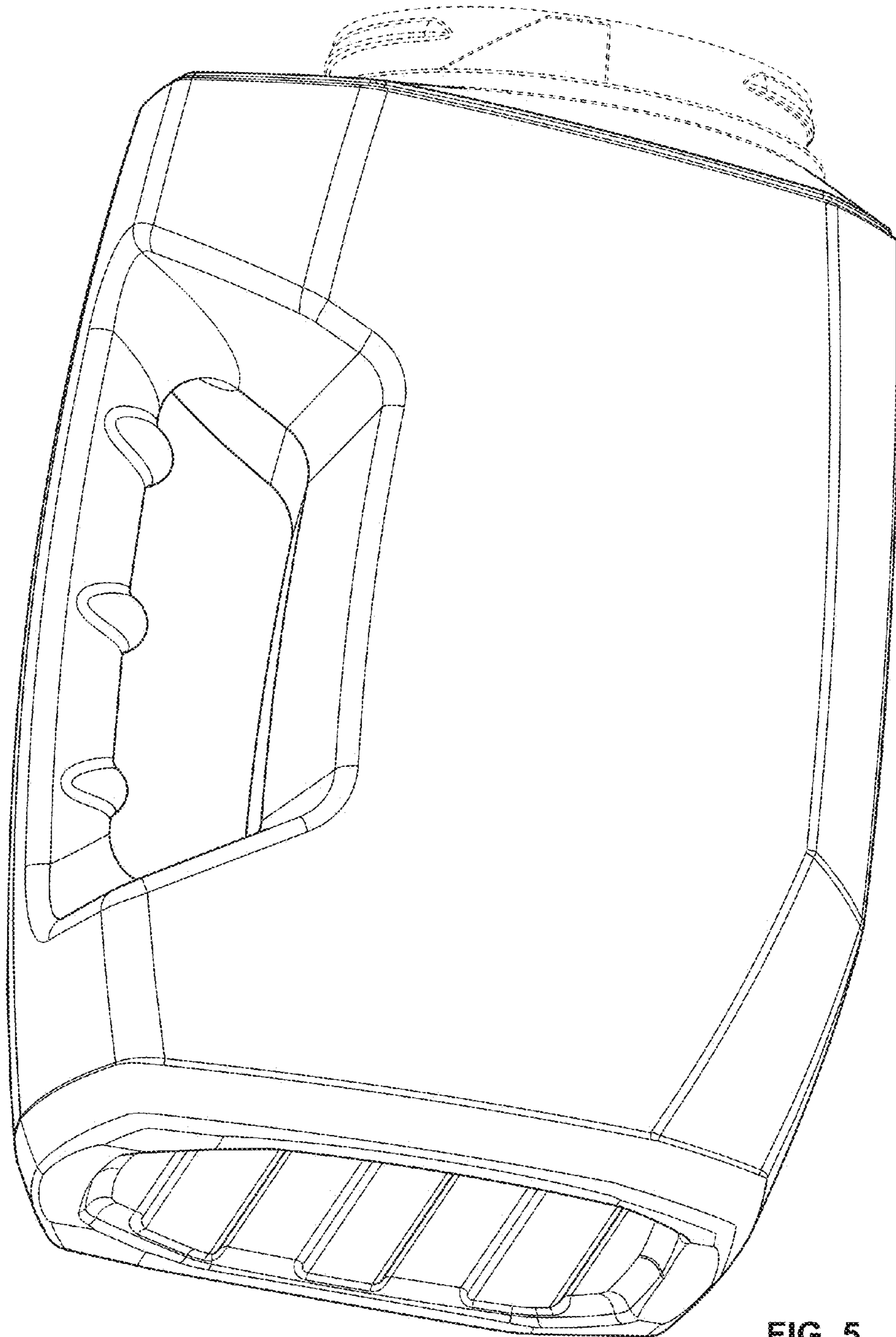

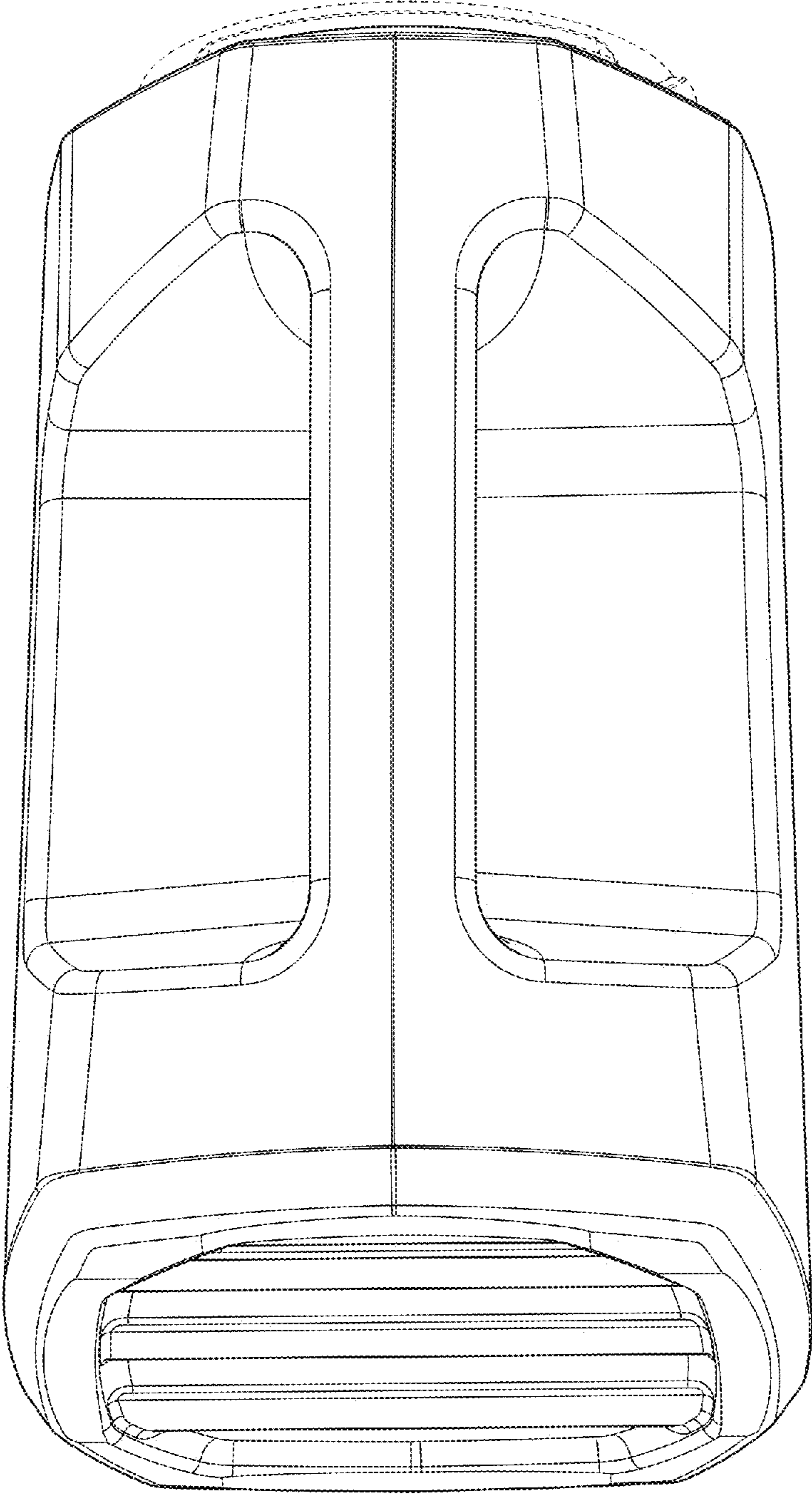

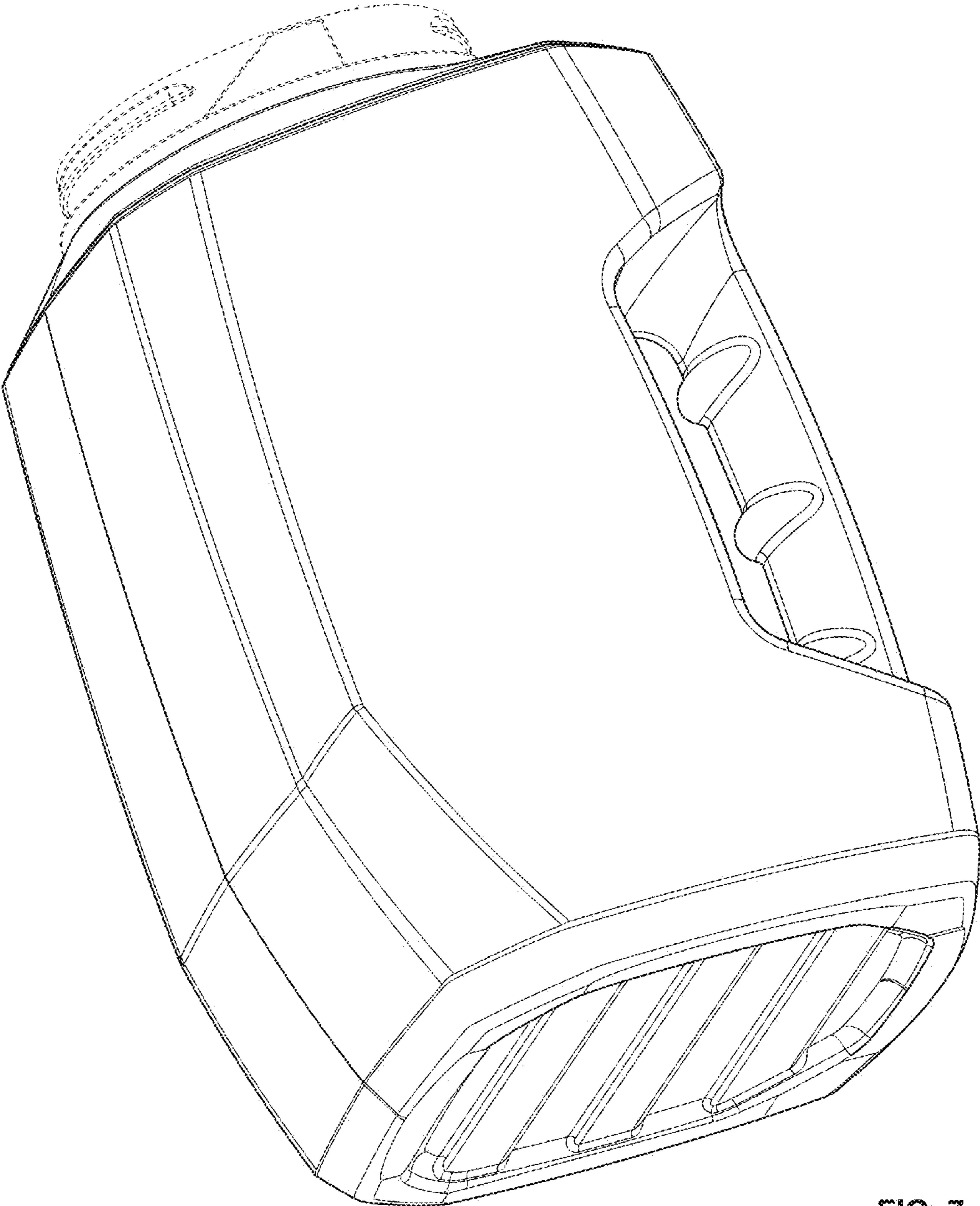

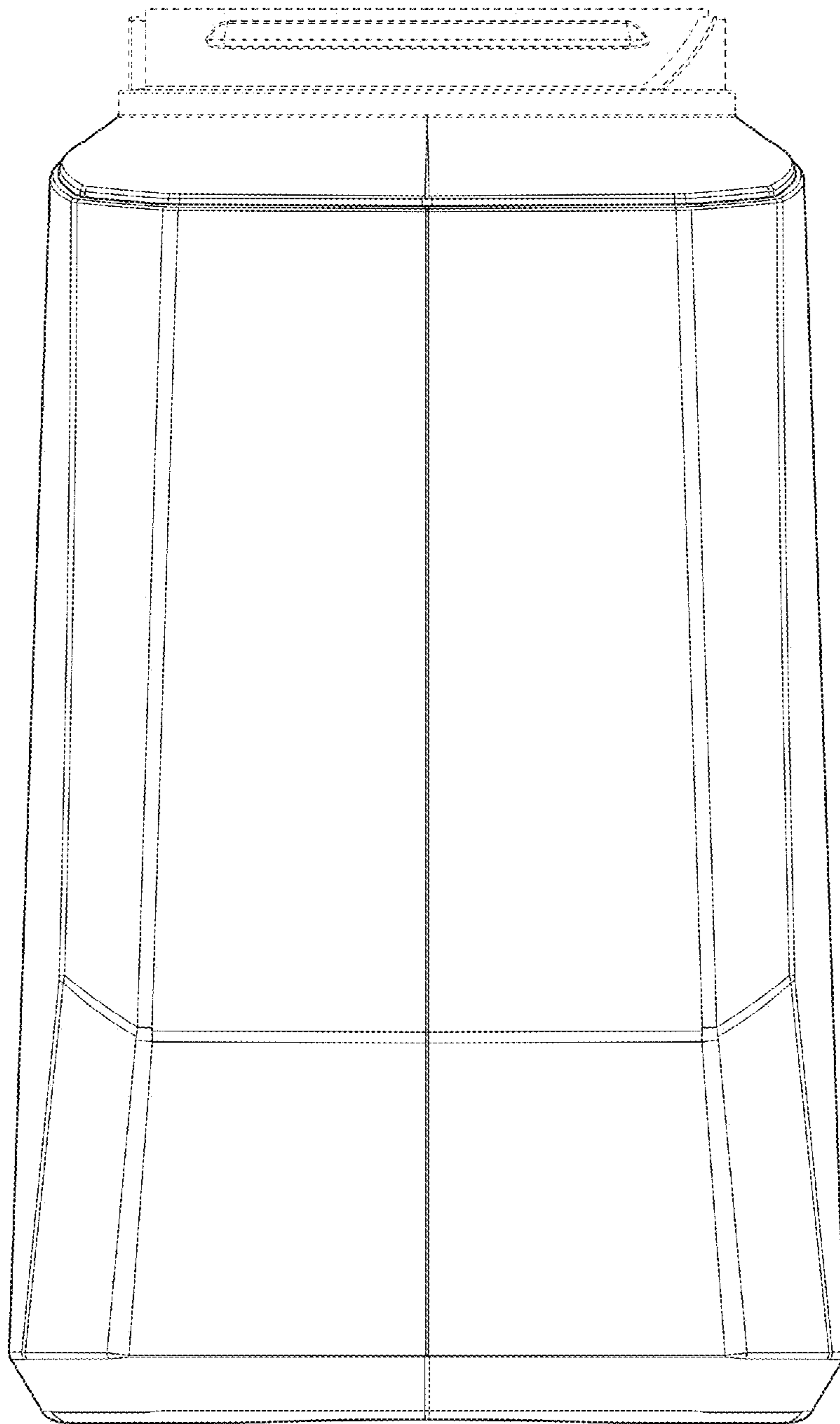

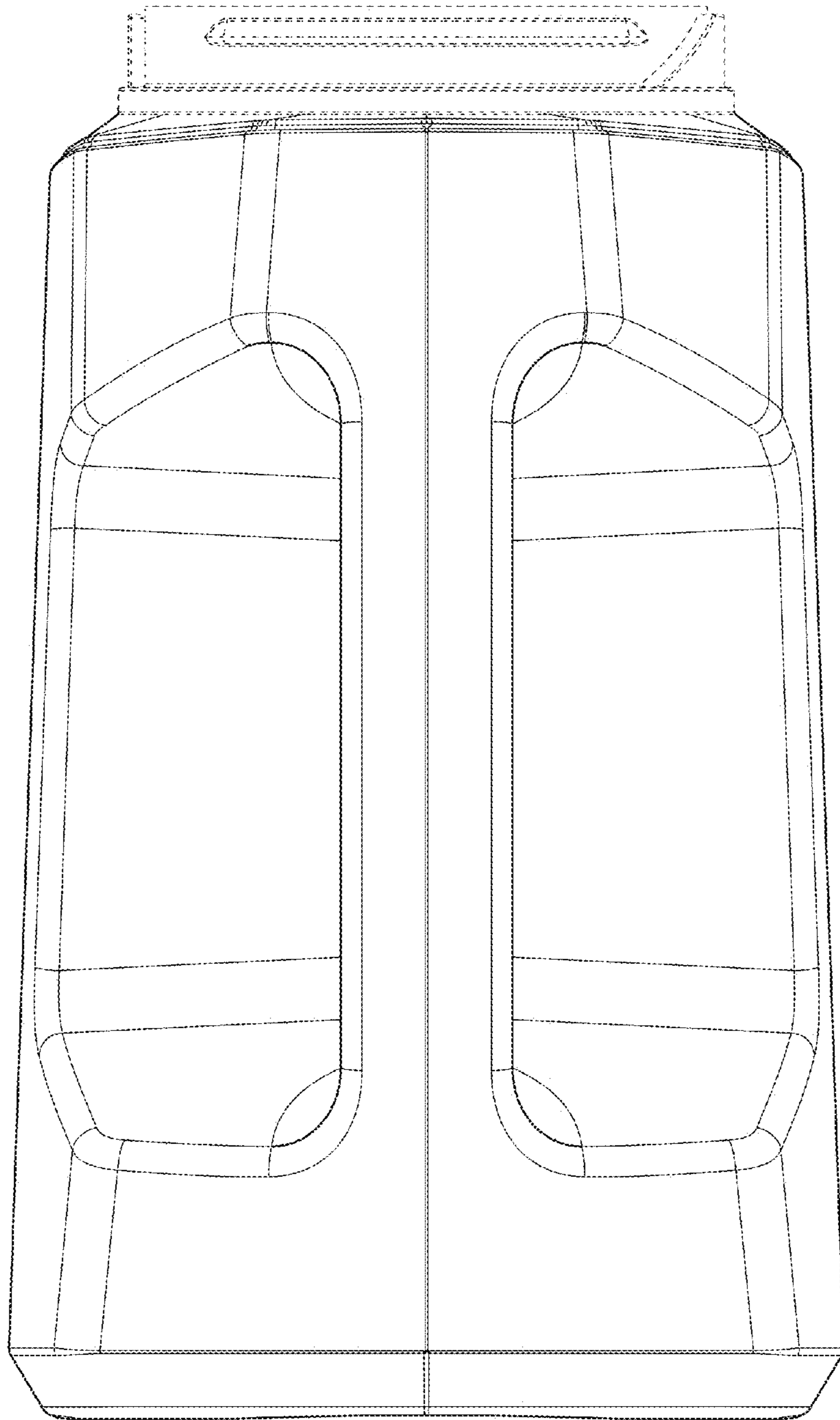

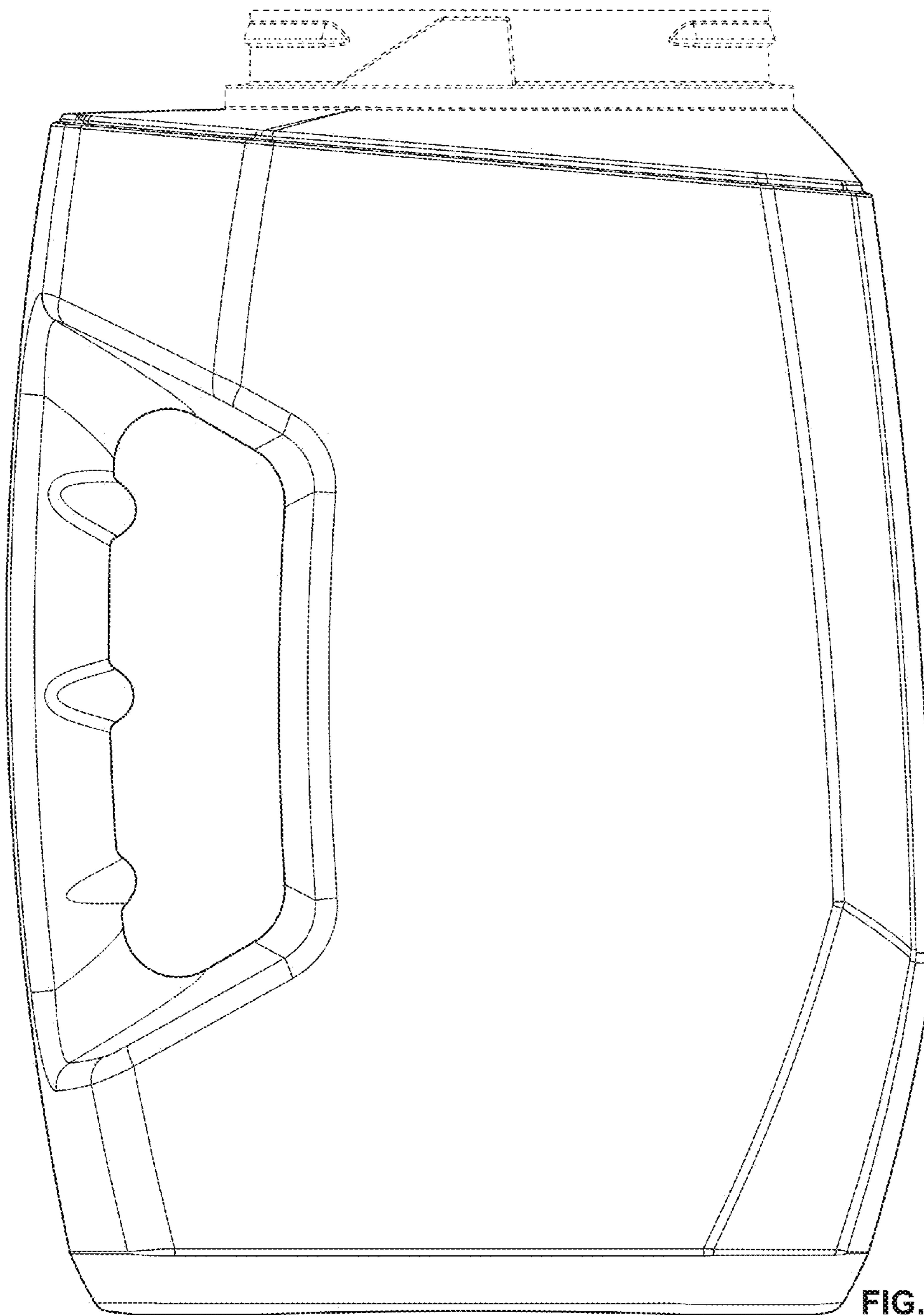

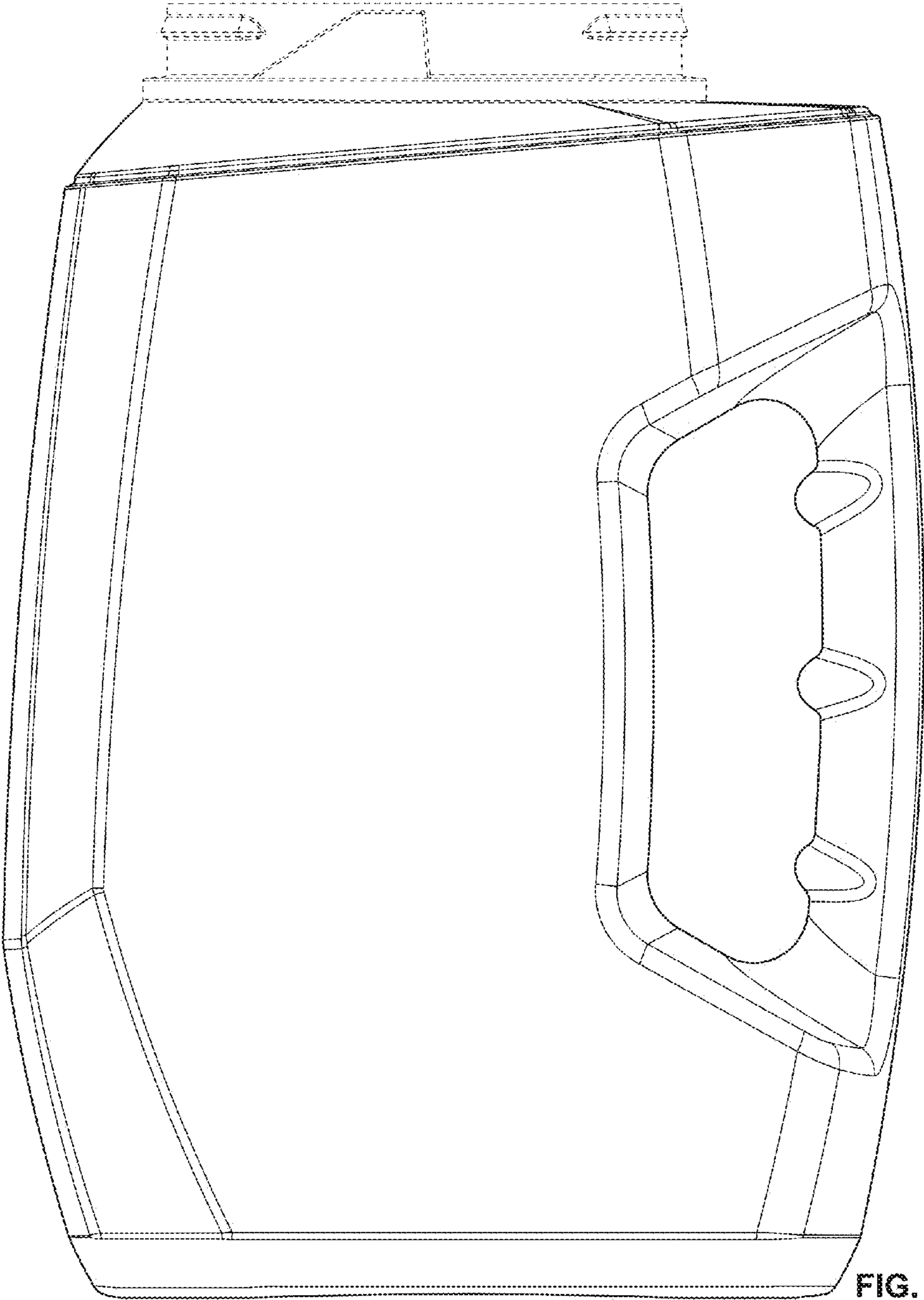

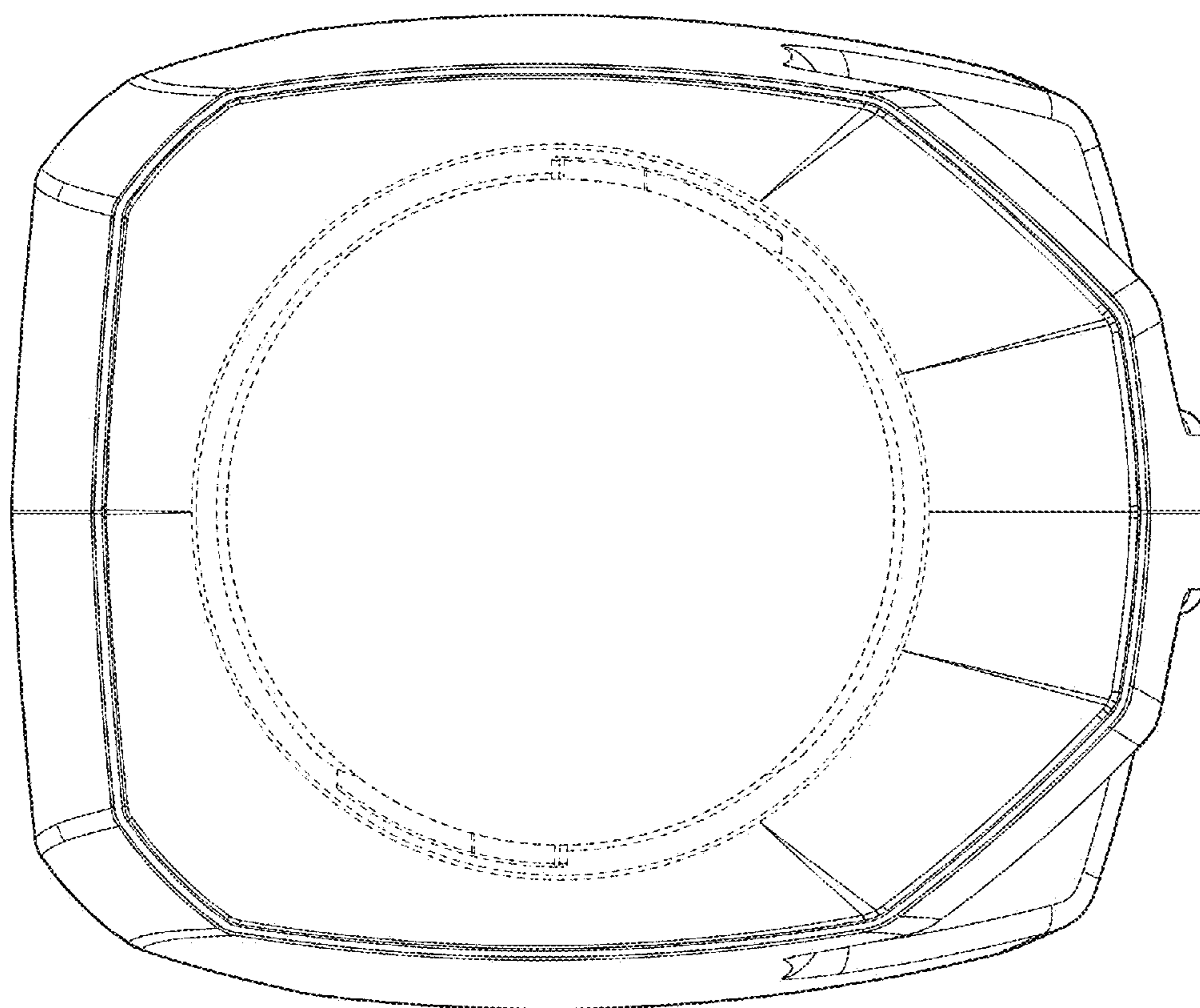

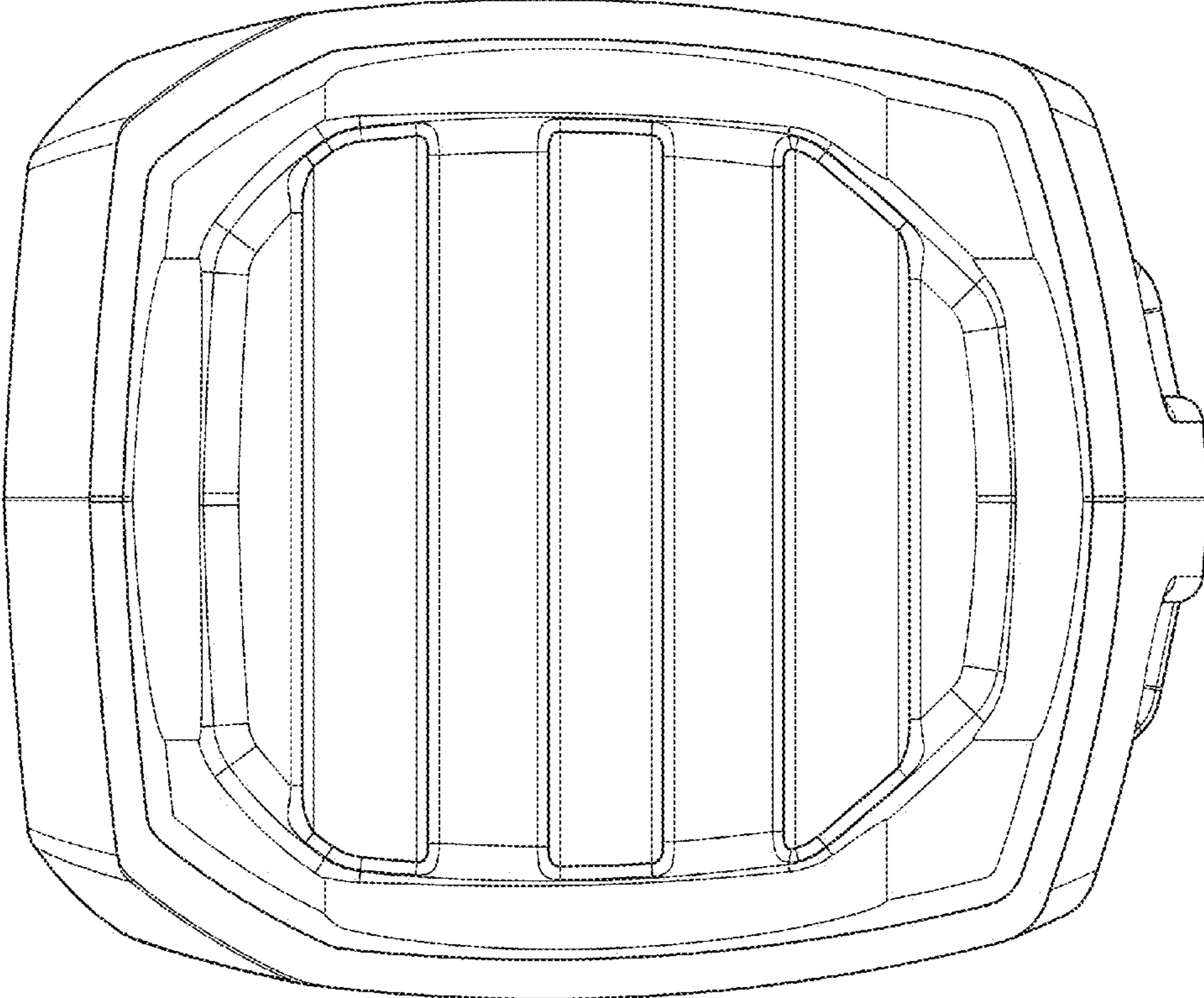
