DESCRIPTION

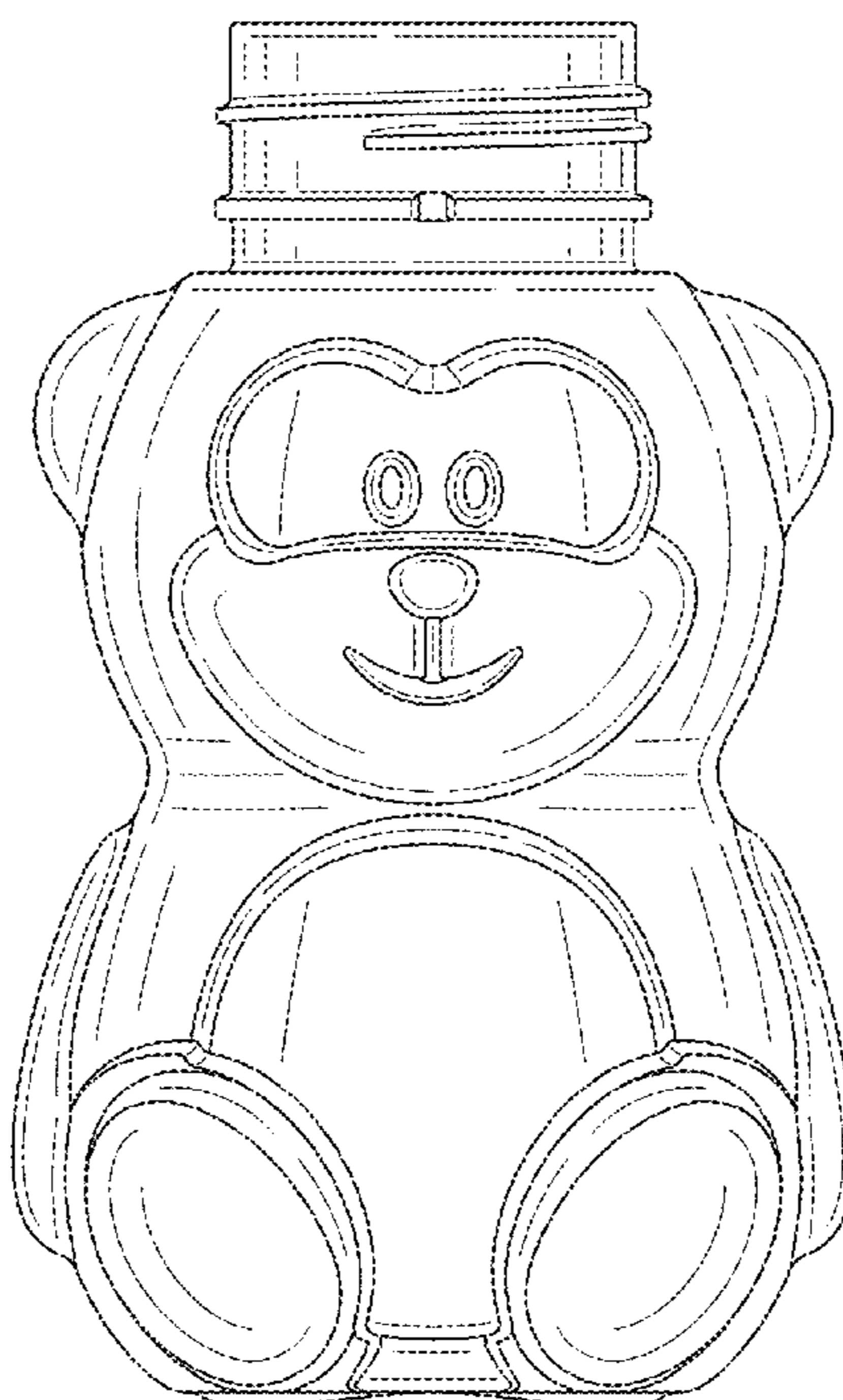
FIG. 1 is a top, front and left side perspective view of a bottle with bear shape showing my new design;

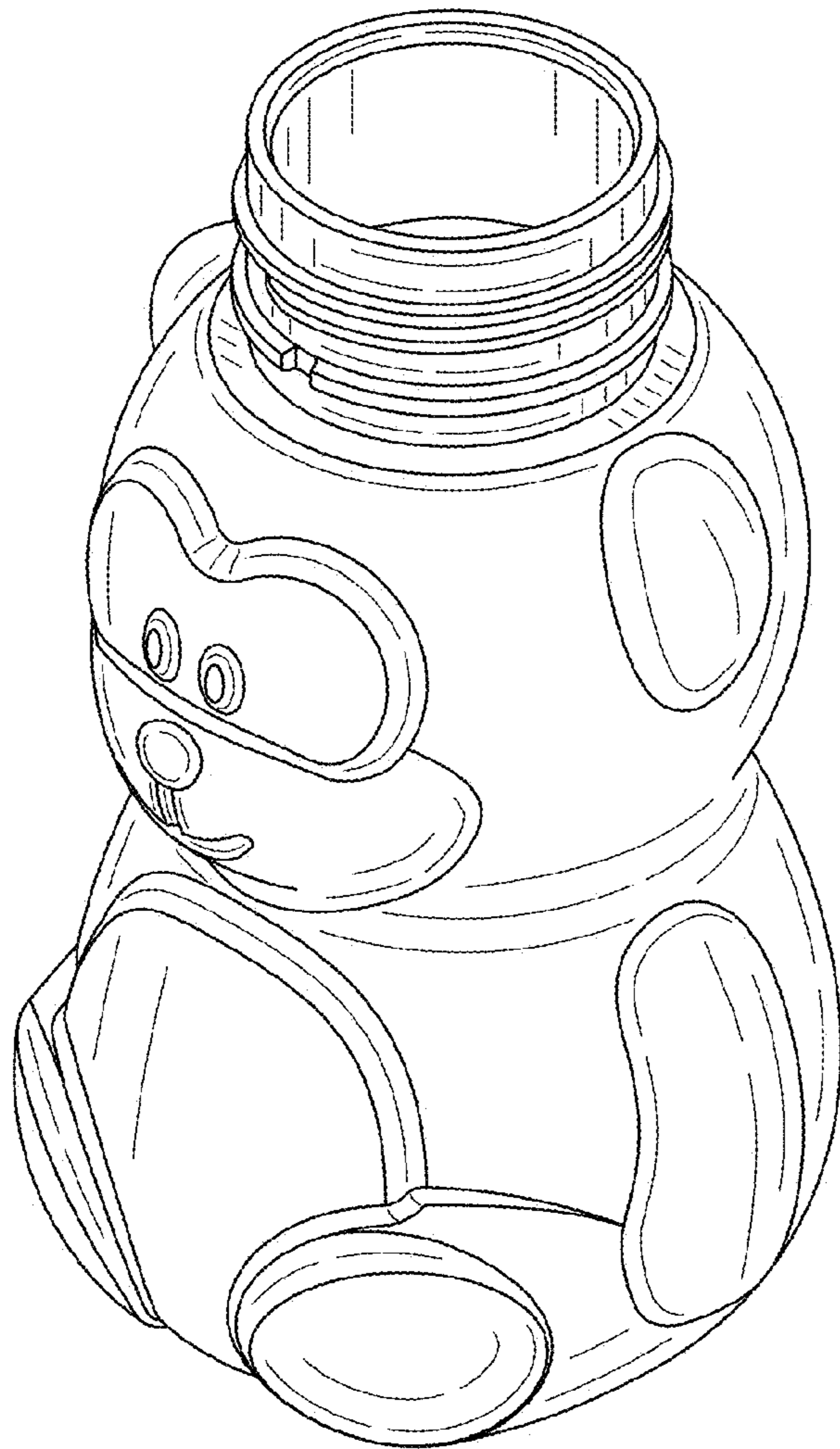

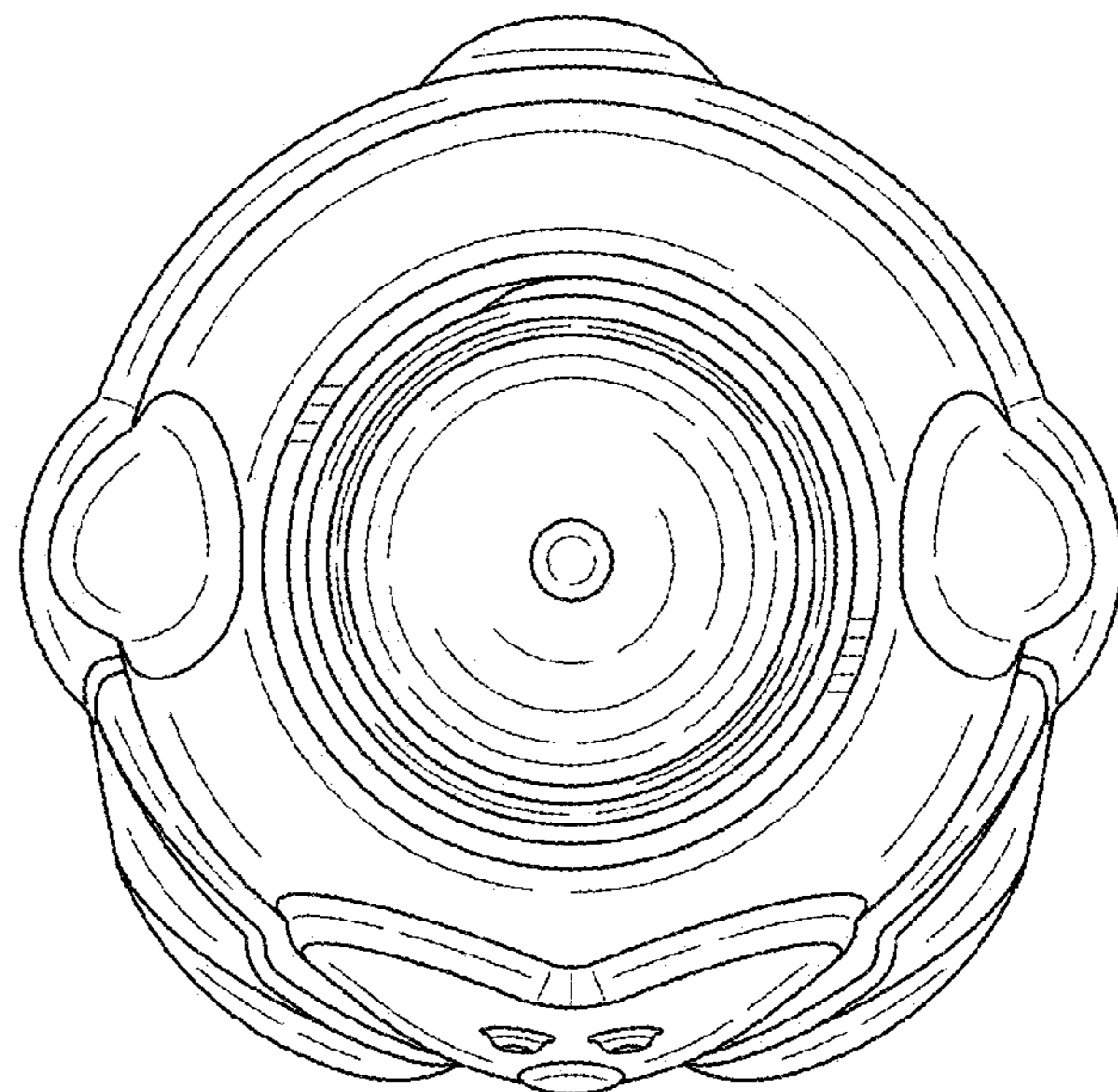

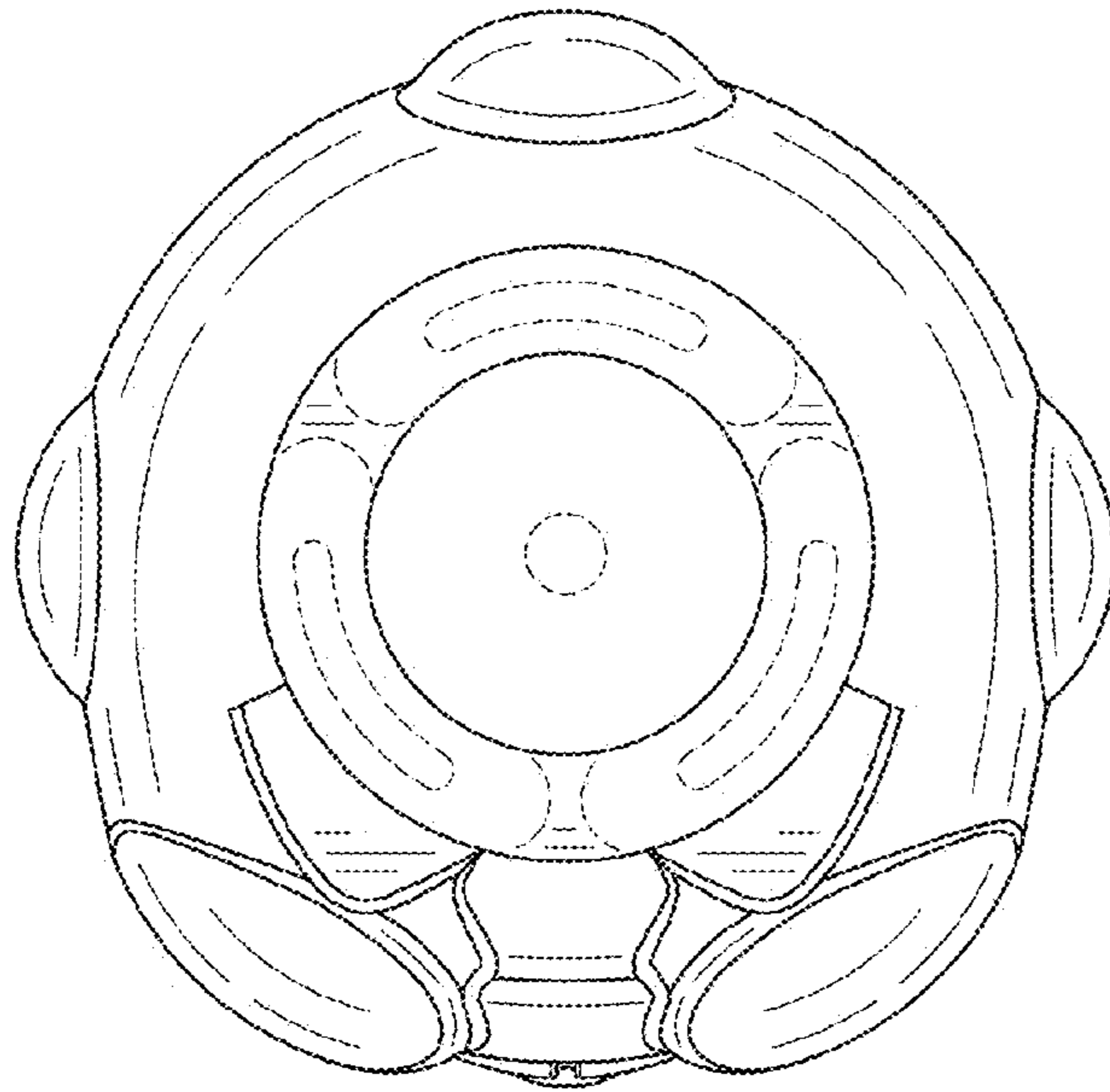
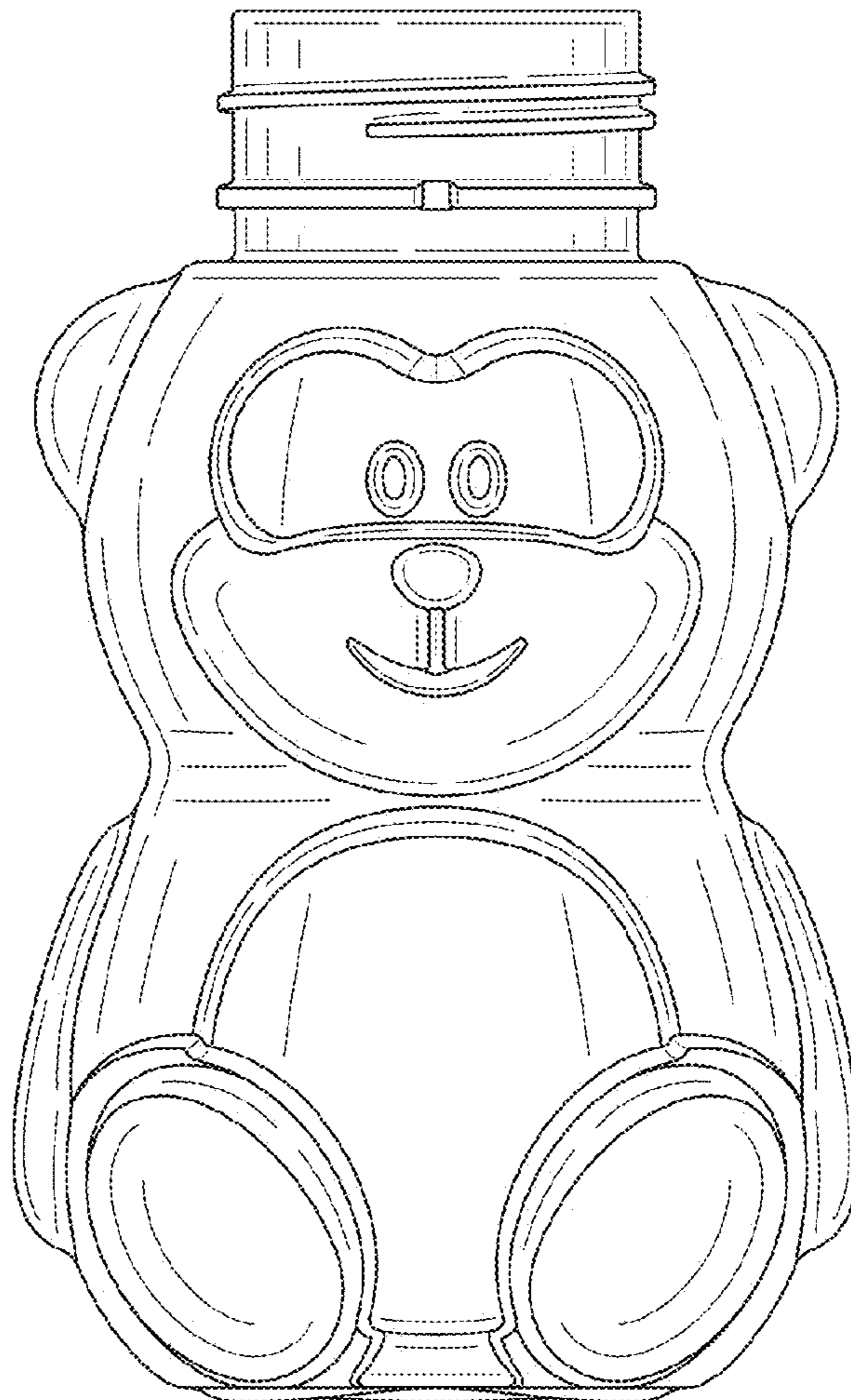

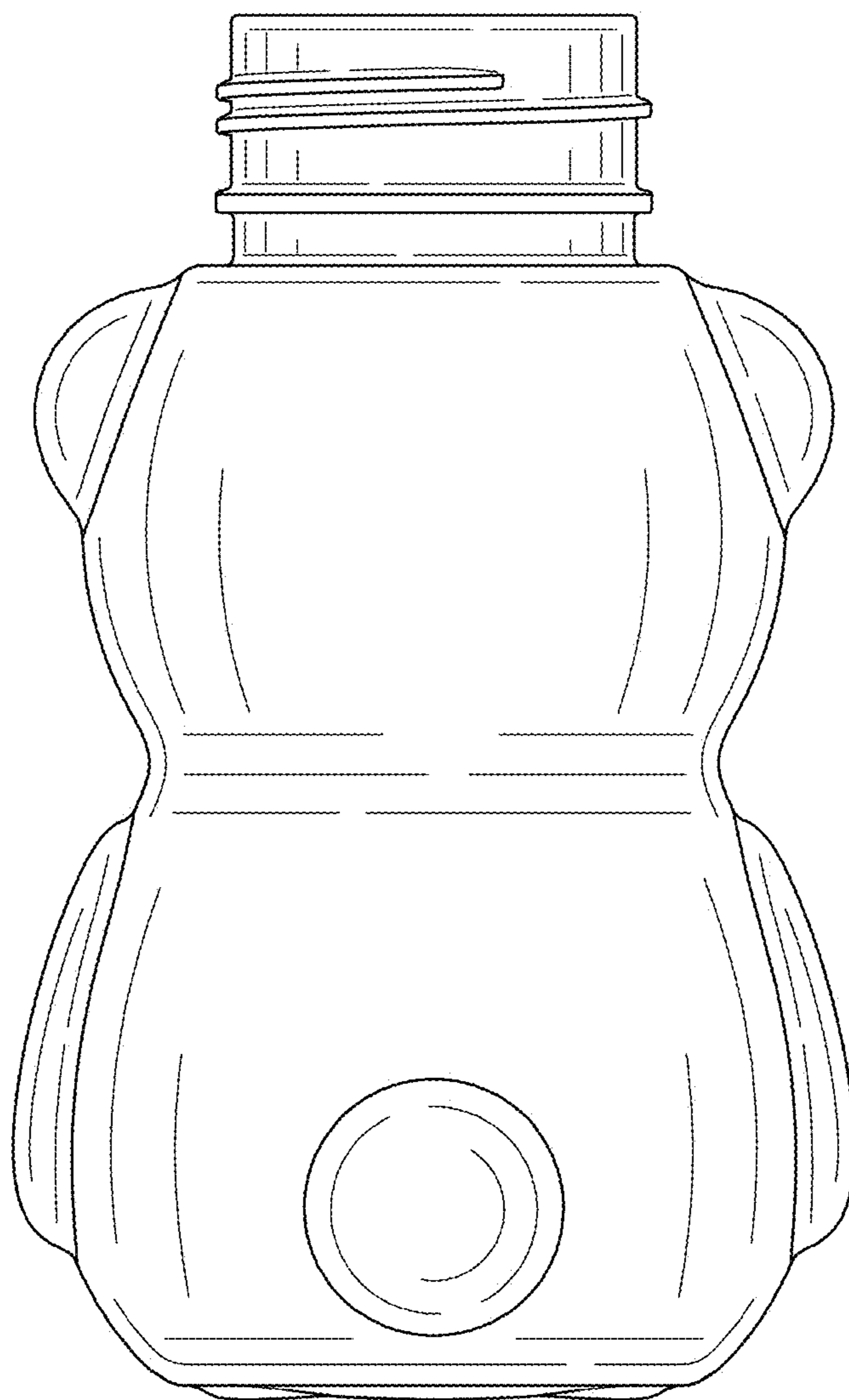

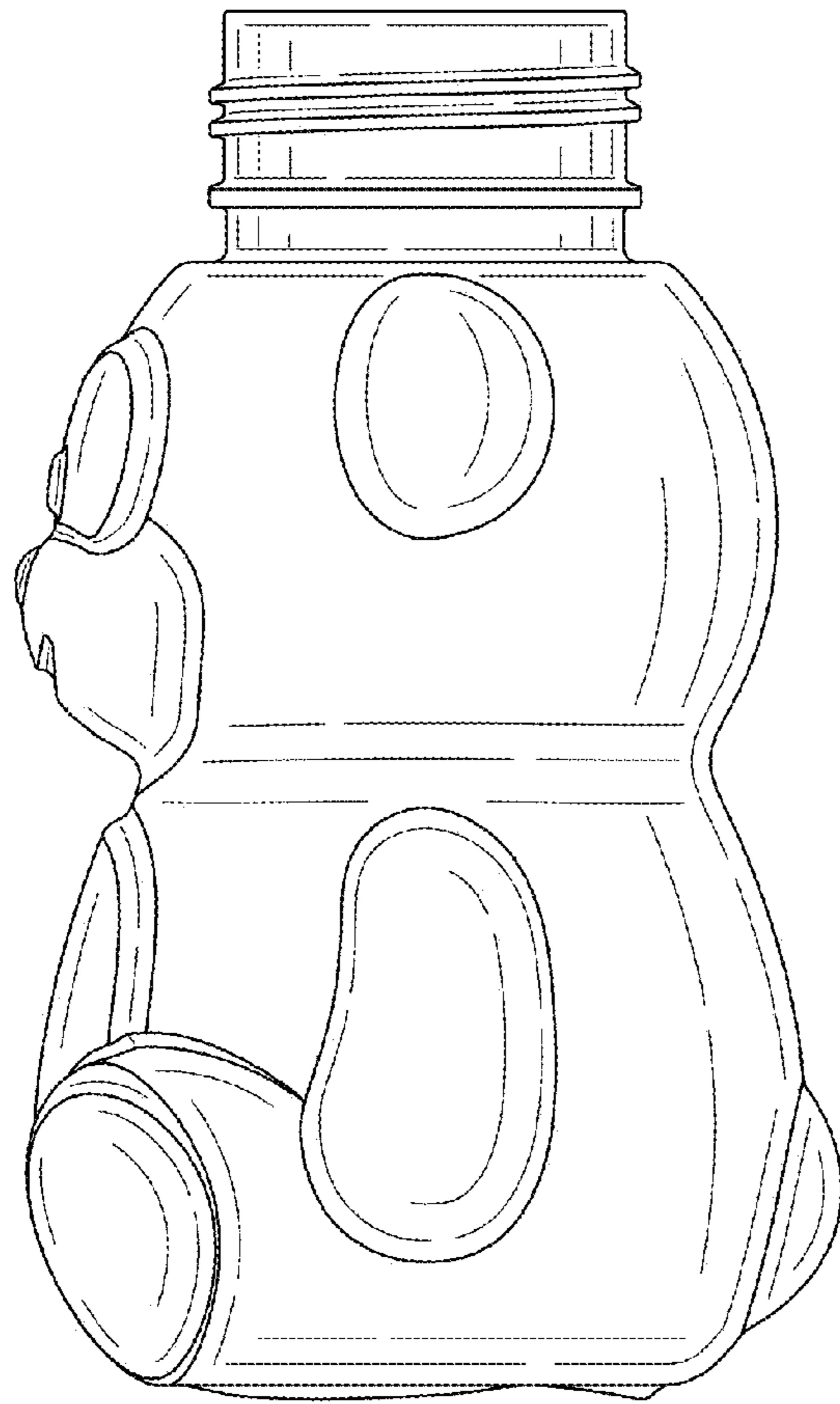

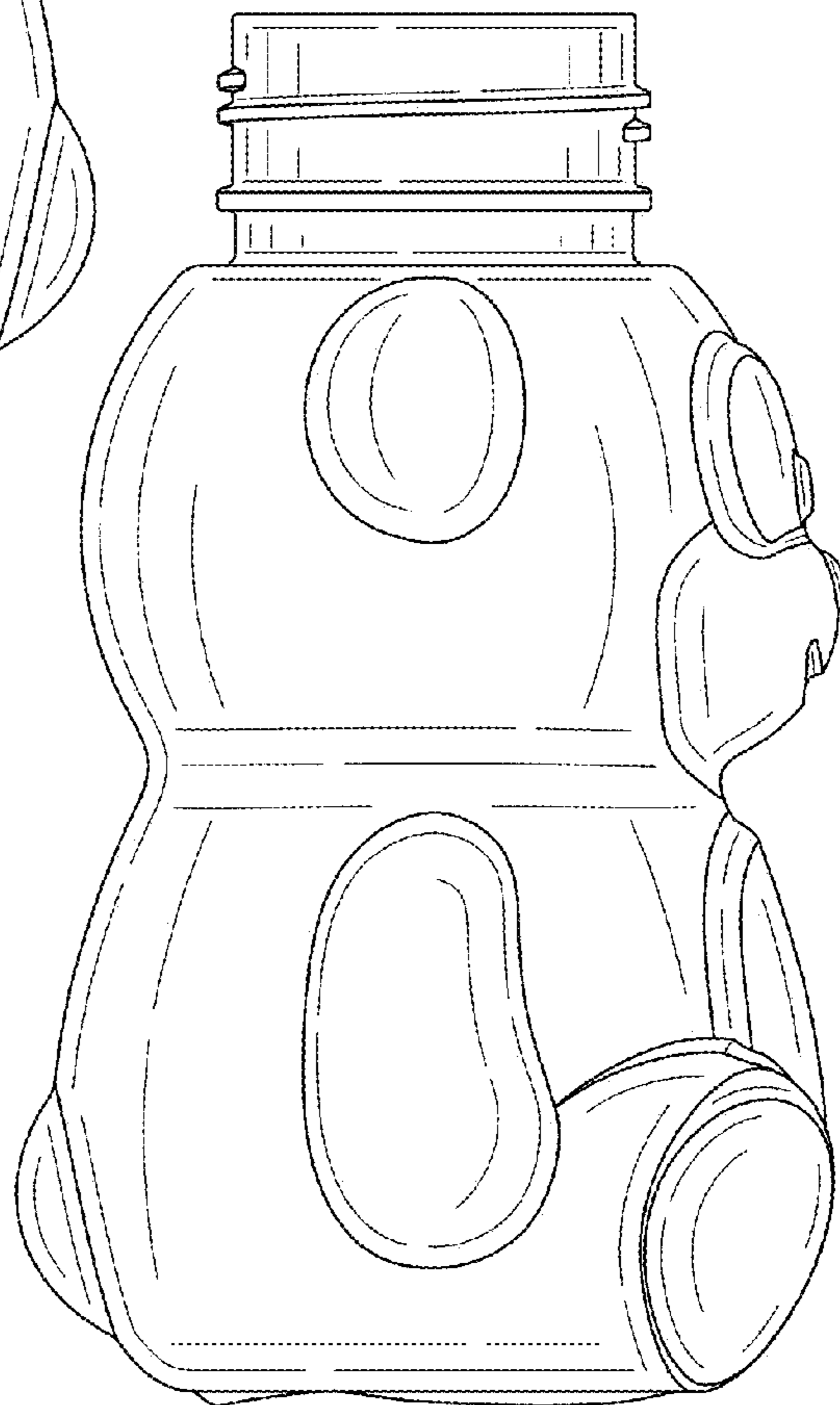
