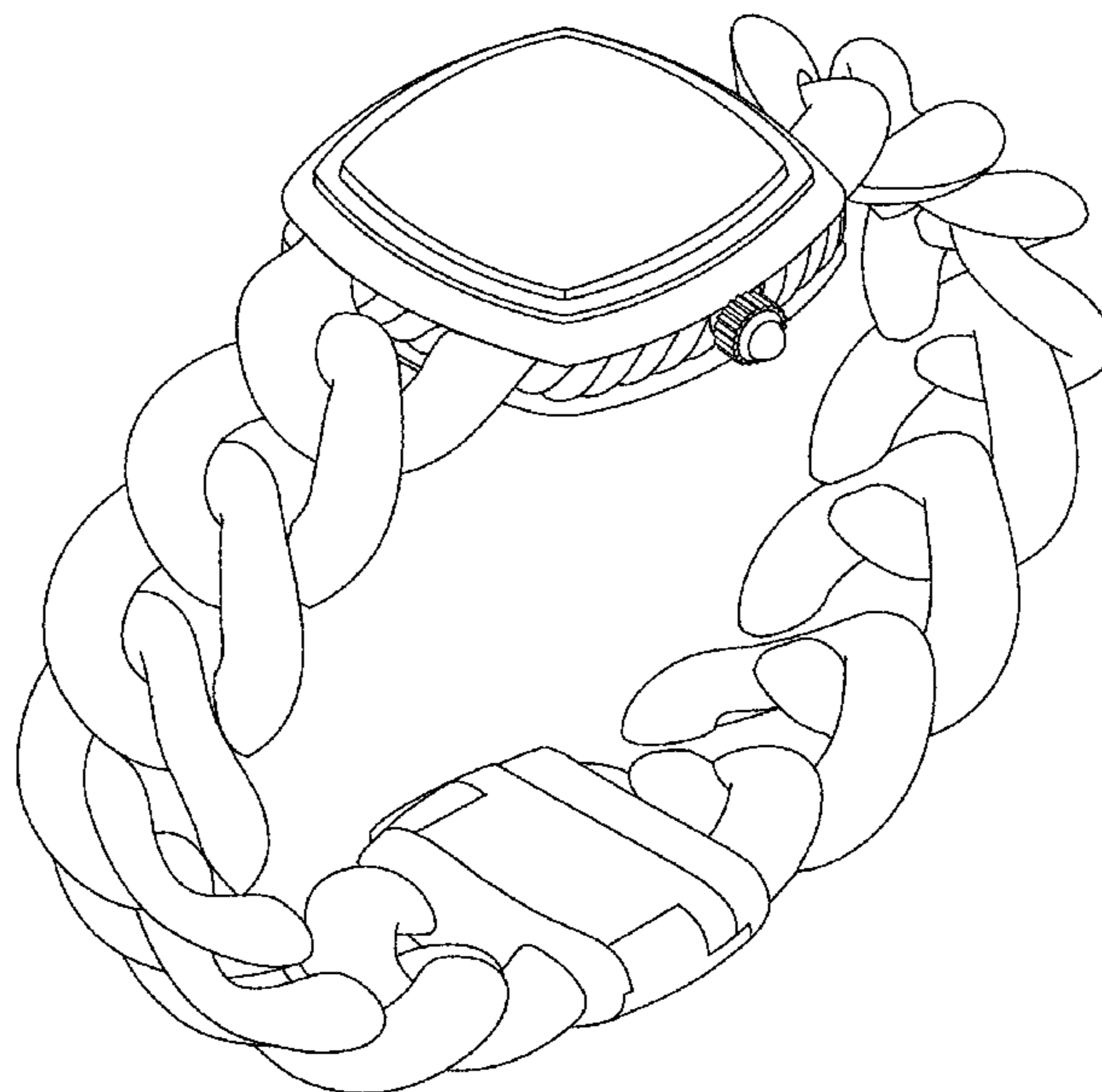
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a wristwatch showing my new design;
FIG. 2 shows a top plan view thereof;

FIG. 4 shows a front elevational view thereof;
FIG. 5 shows a rear elevational view thereof;

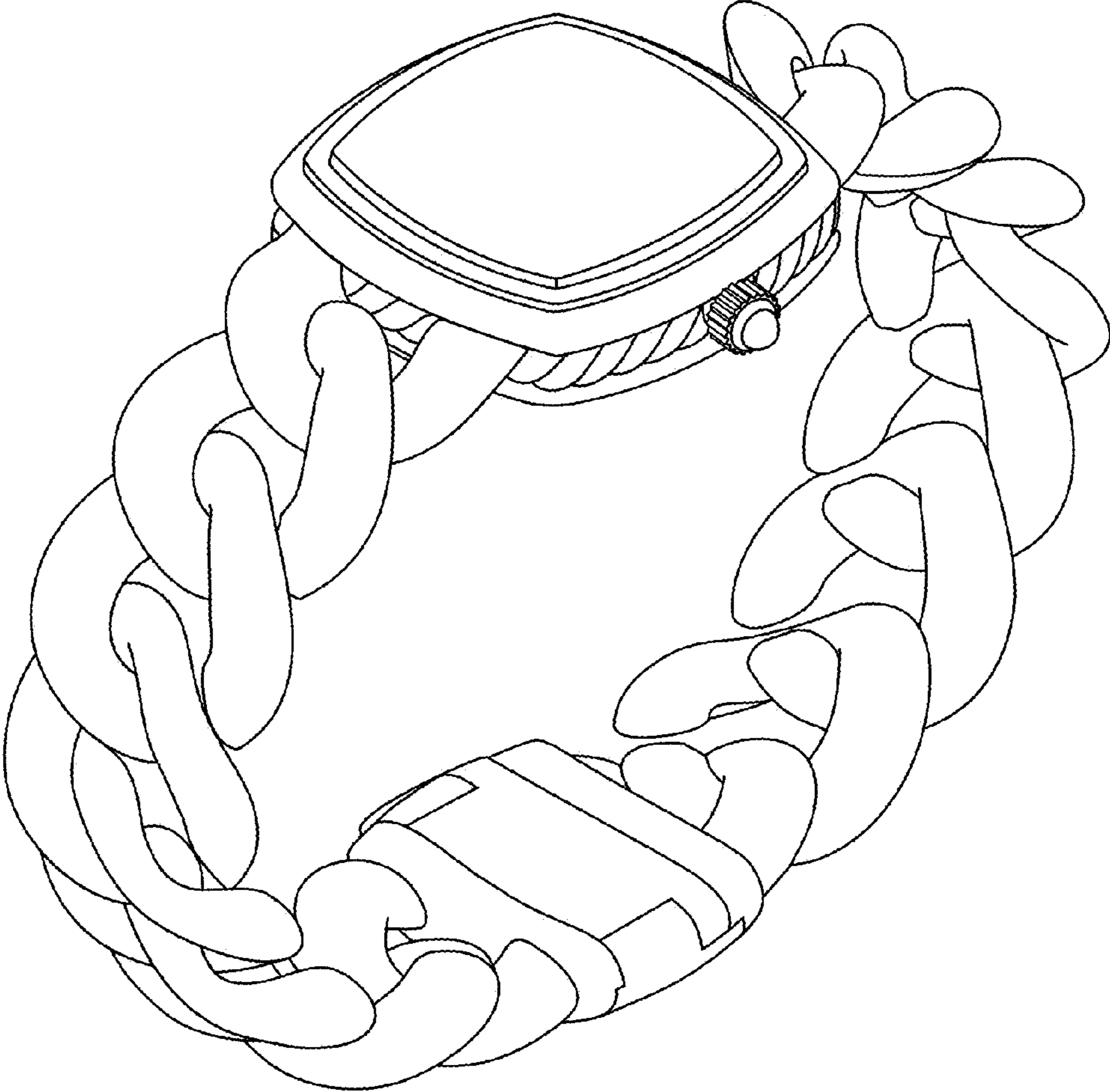

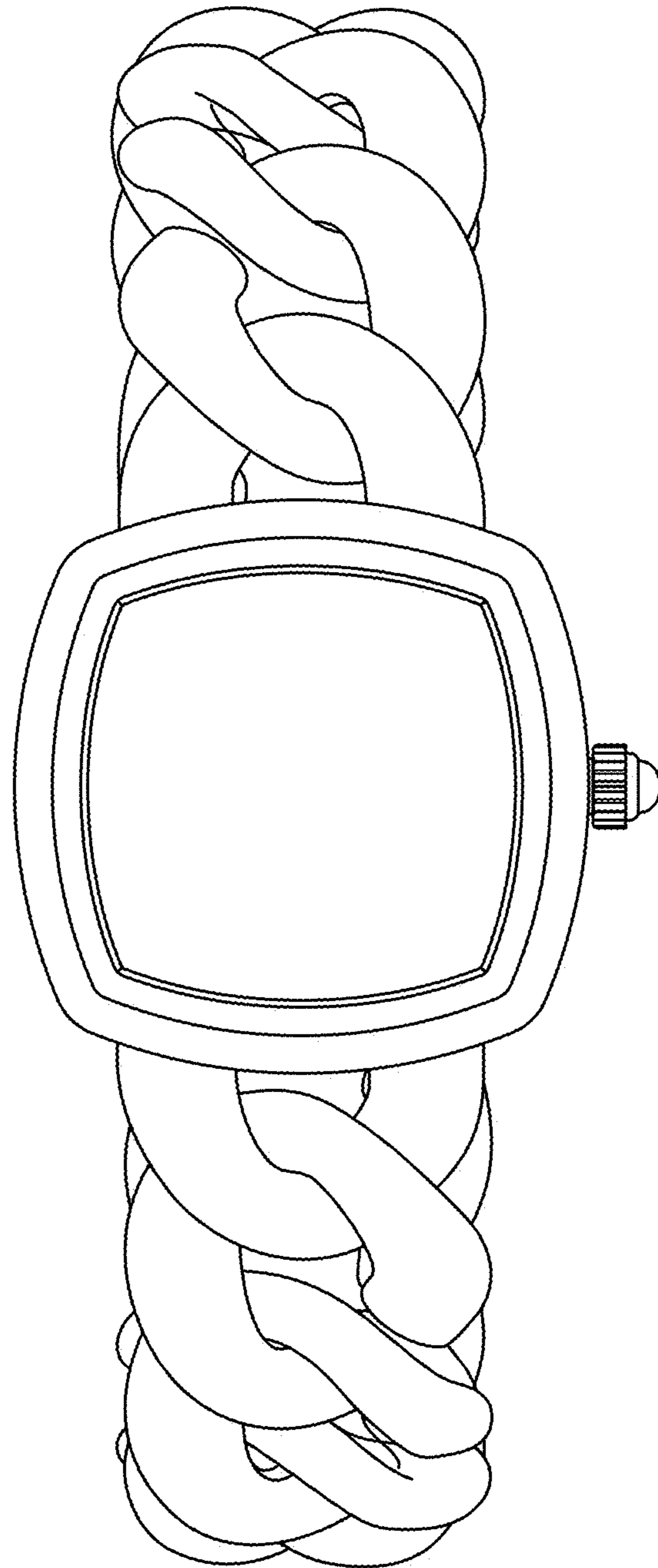

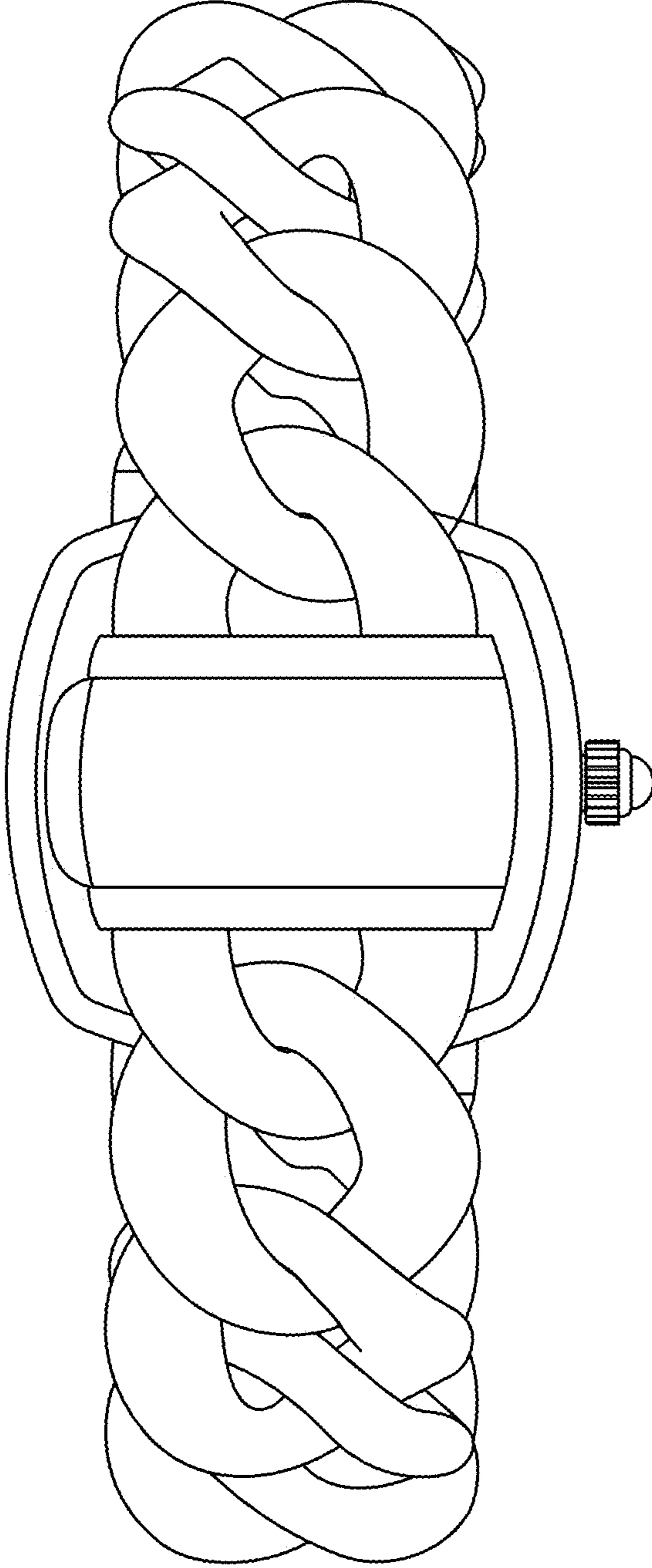

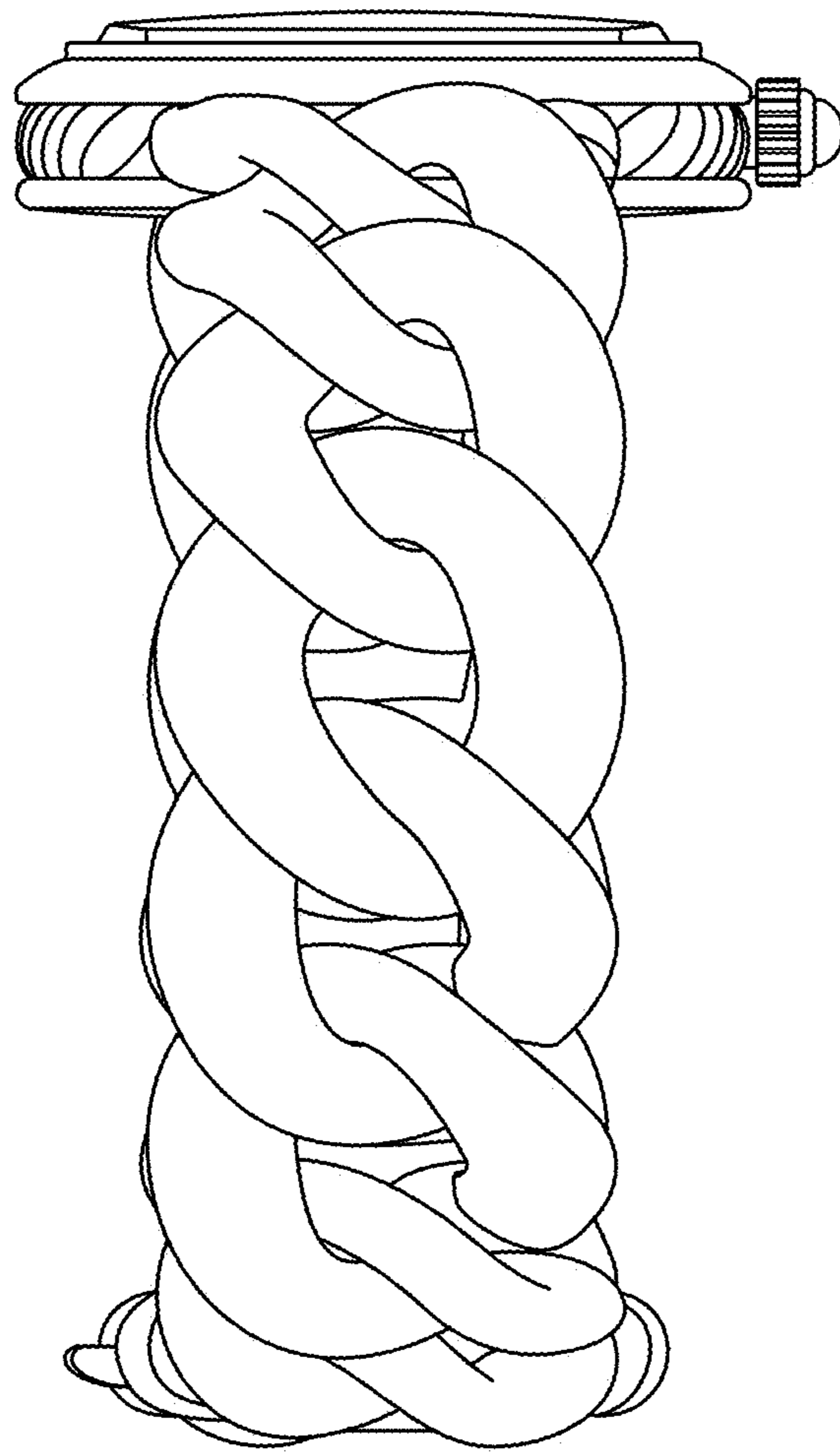

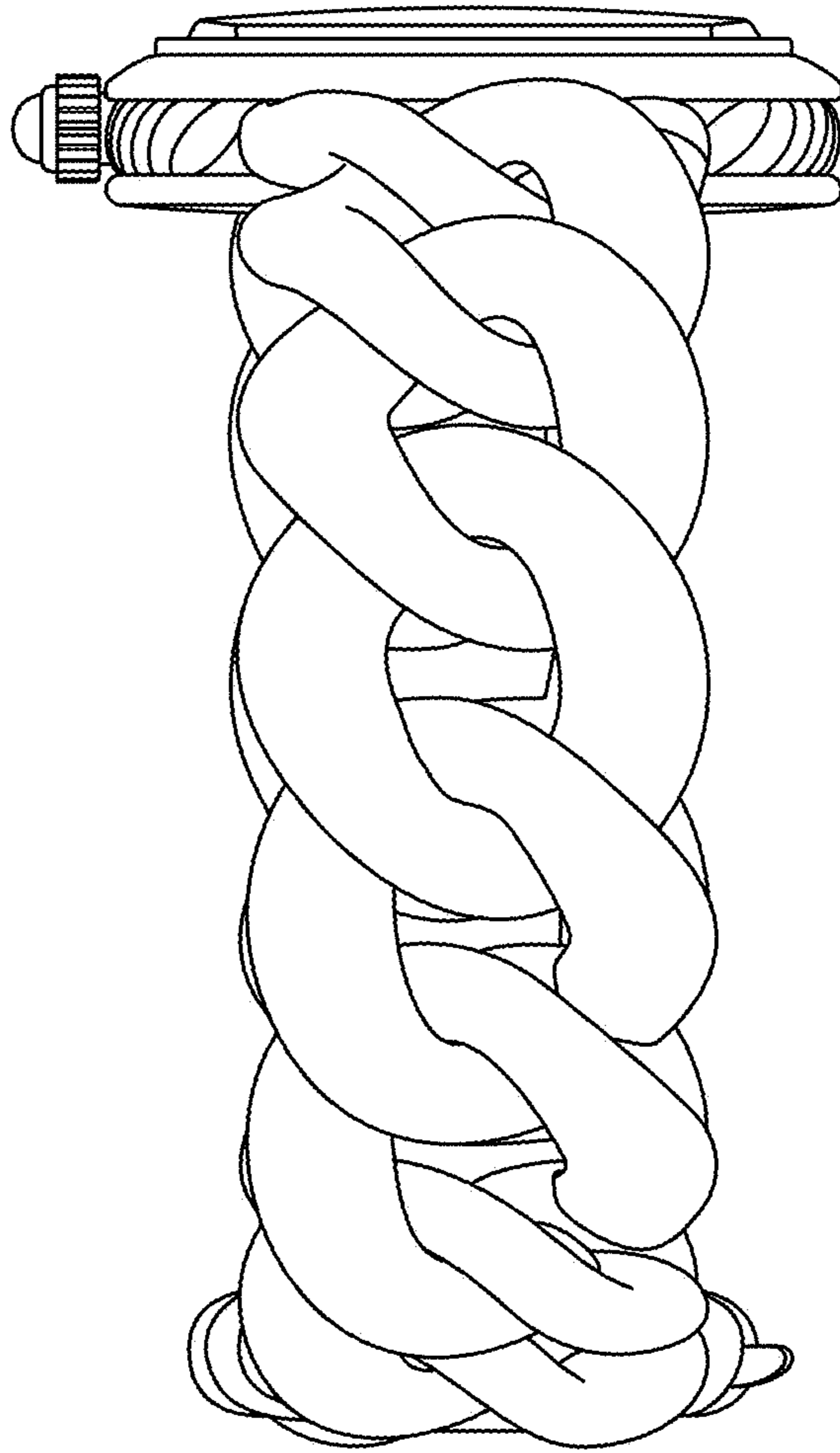

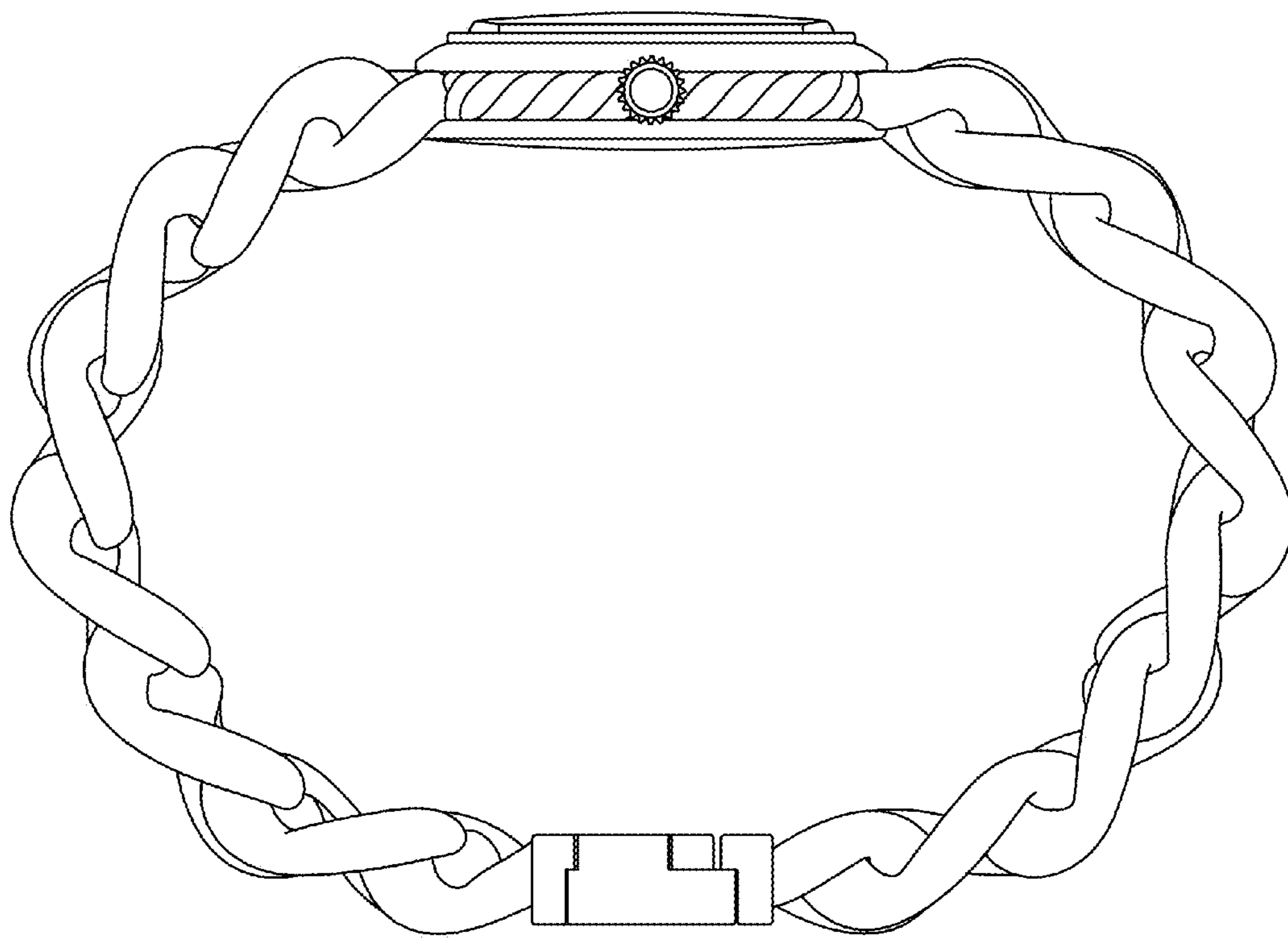

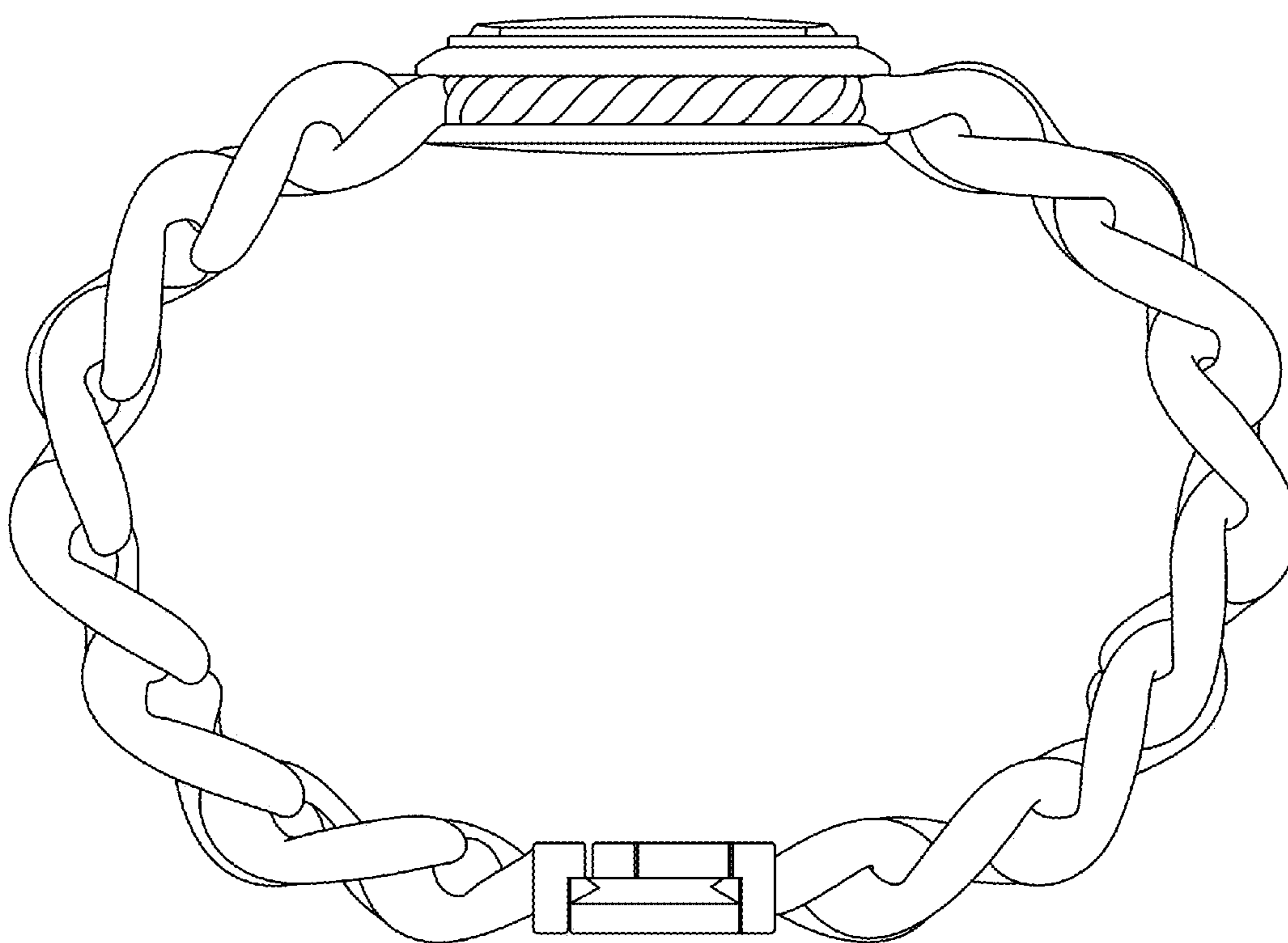

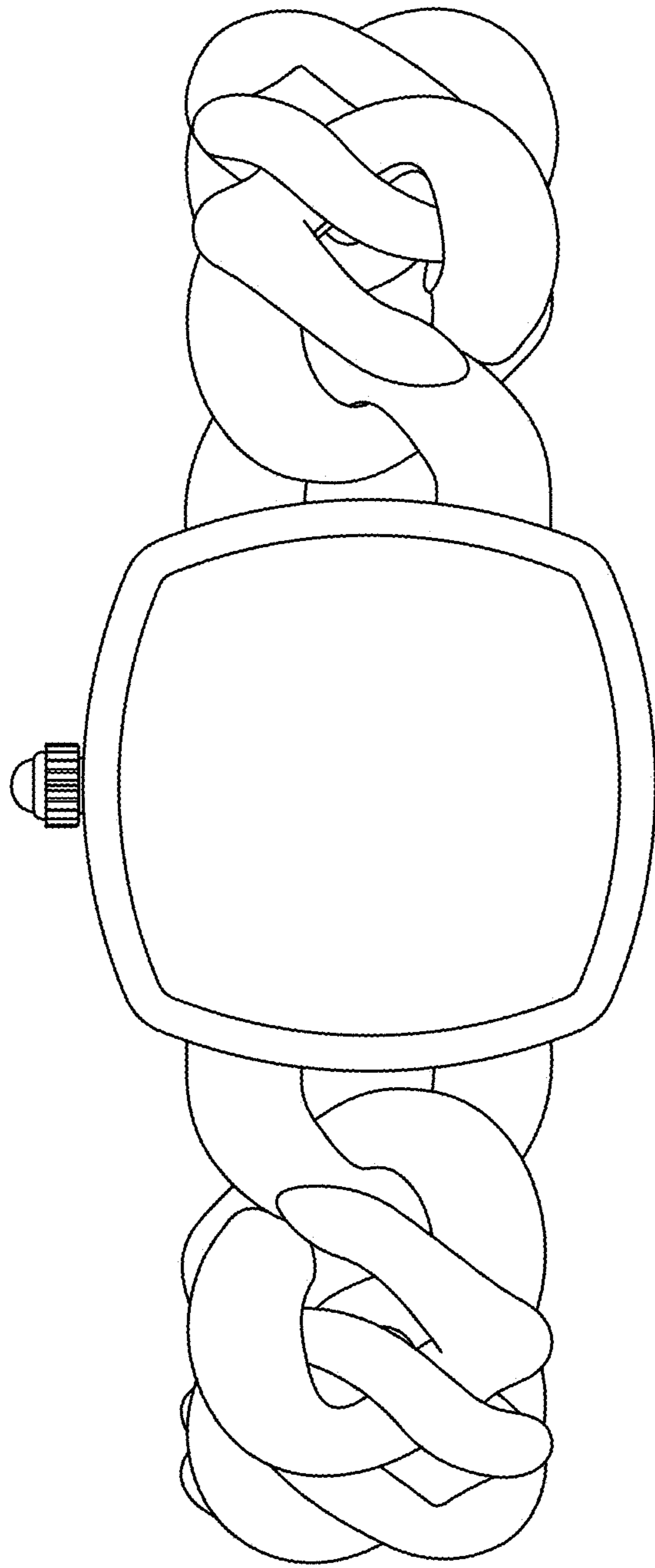
