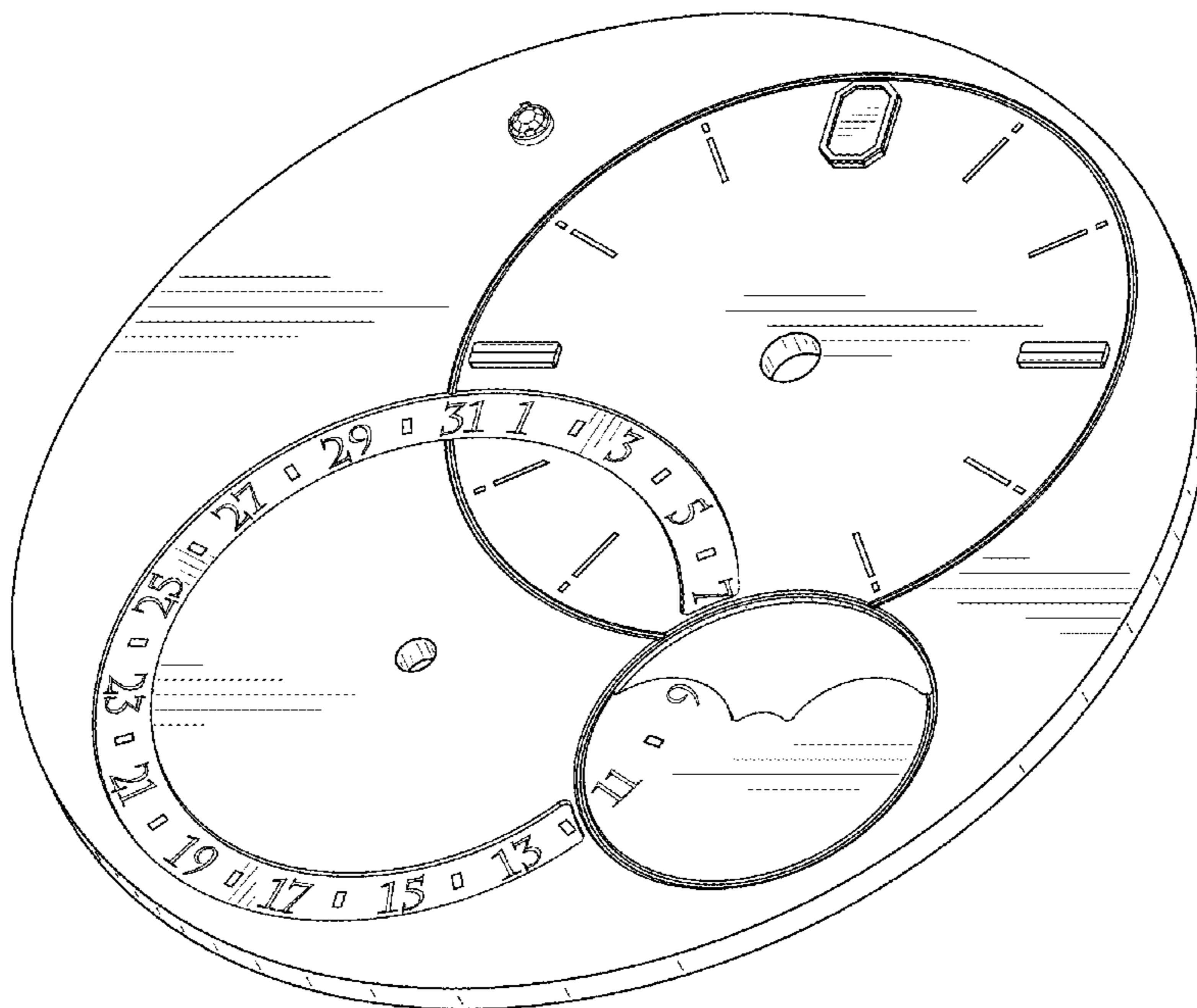
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front right perspective view of a dial showing my new design;

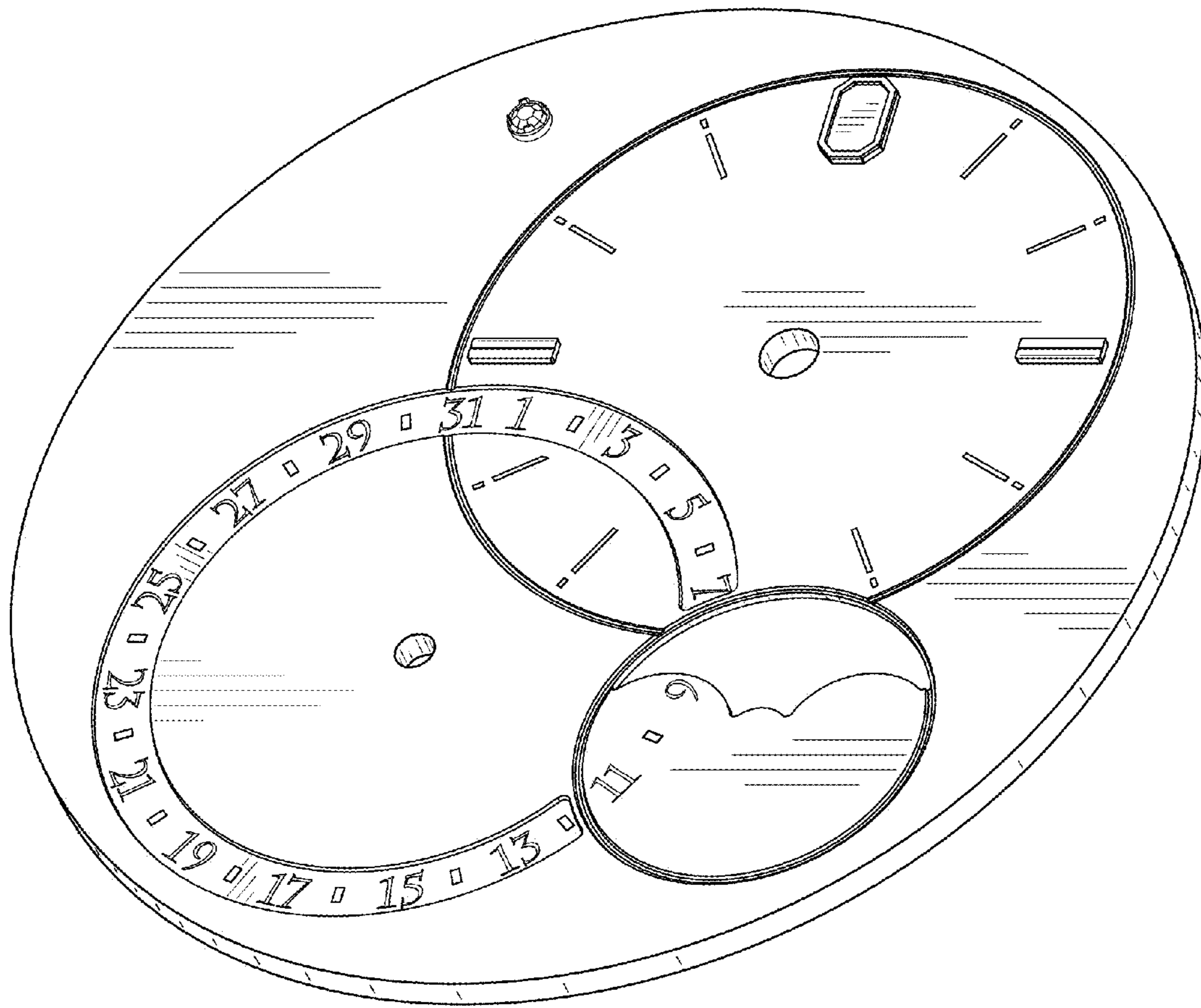

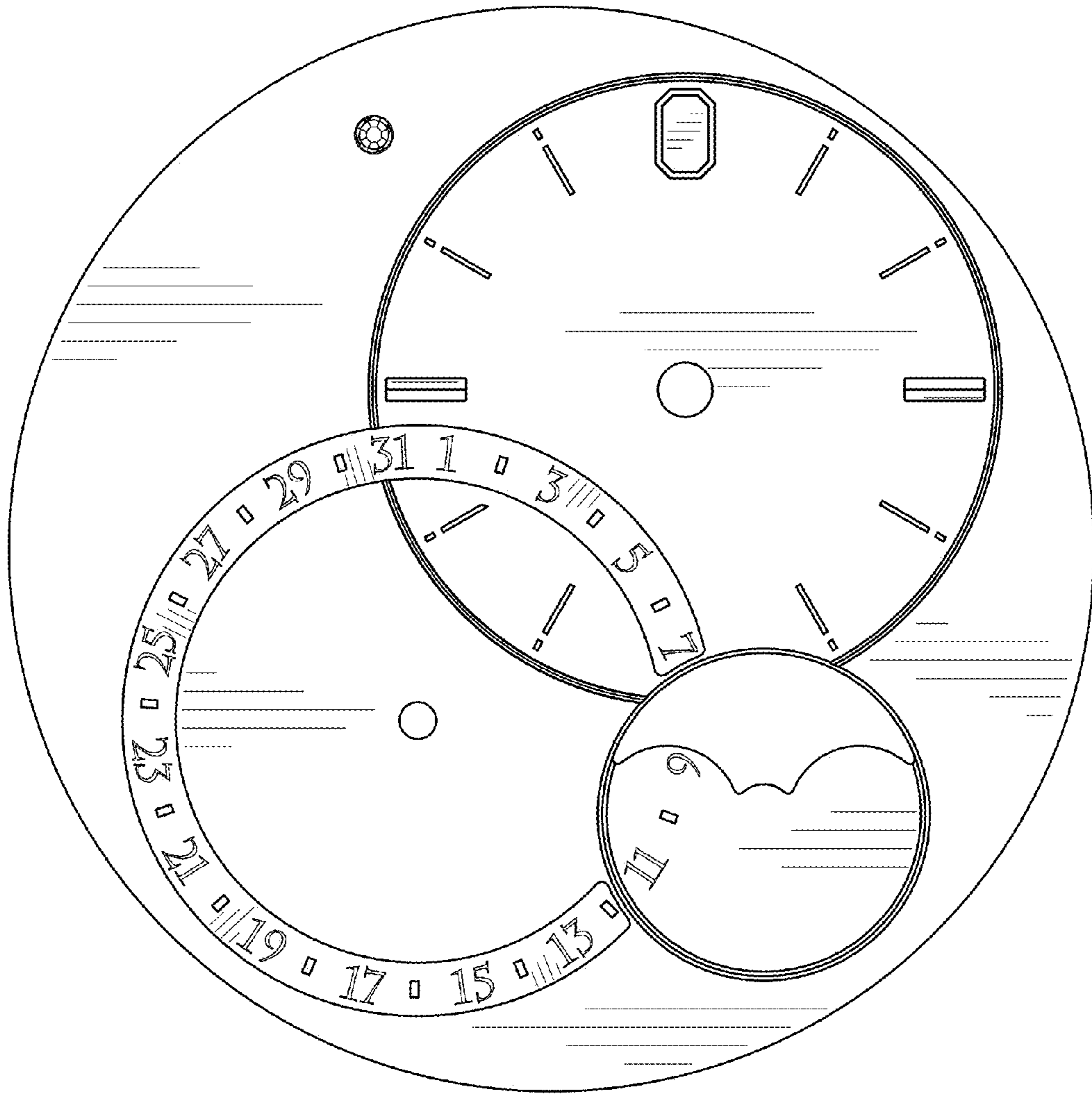

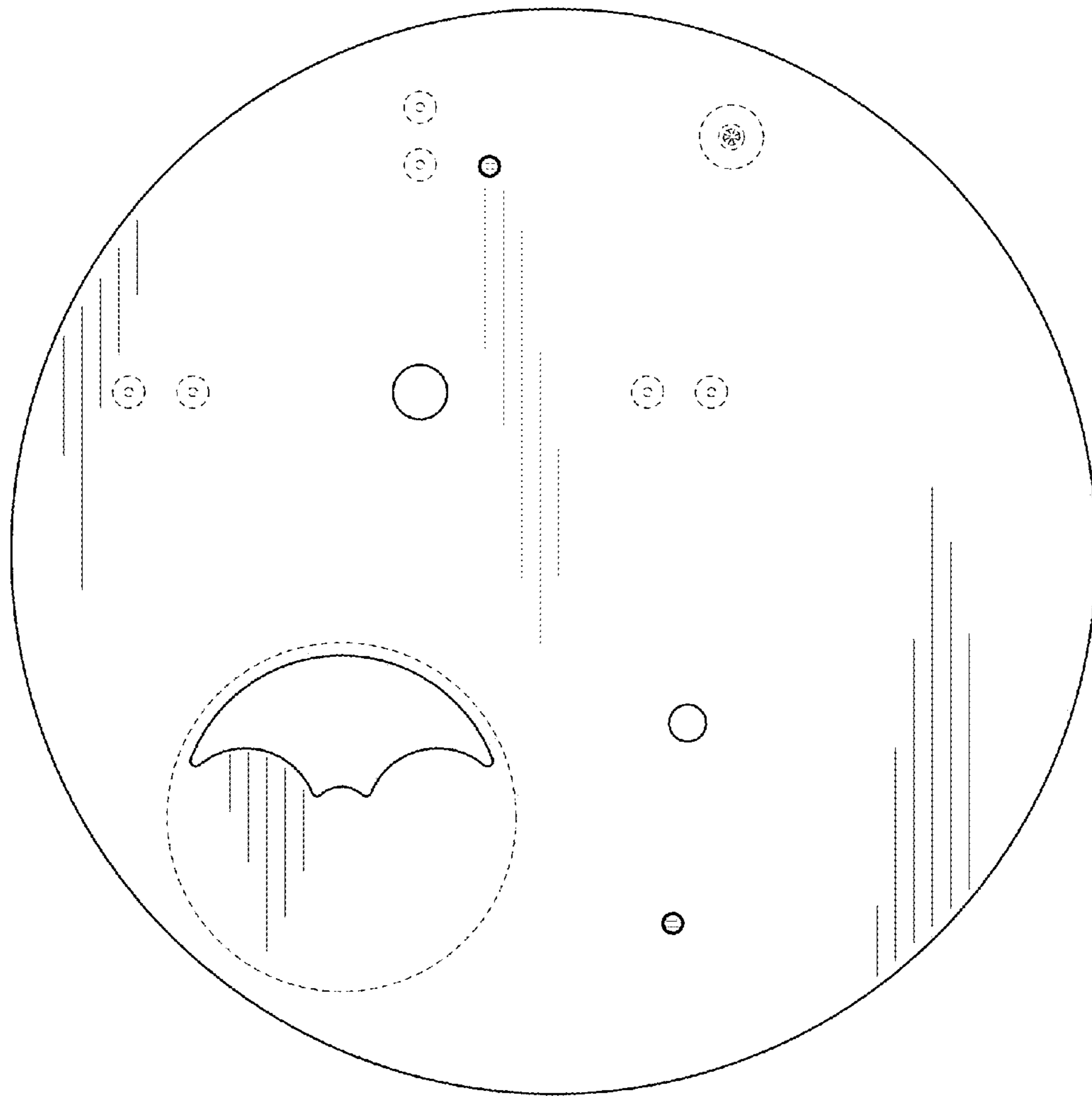

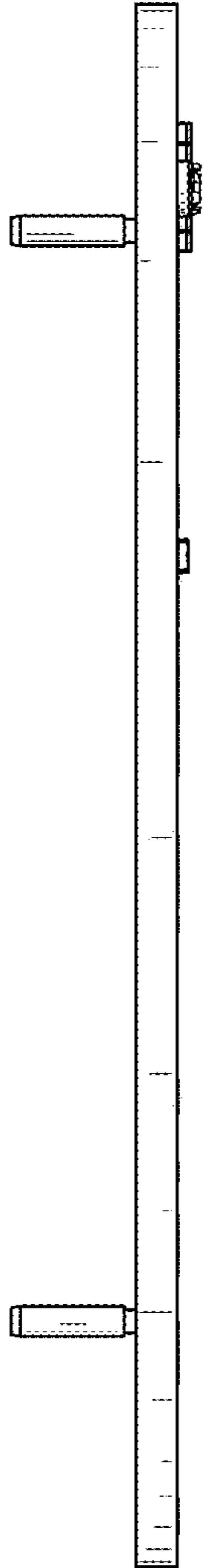

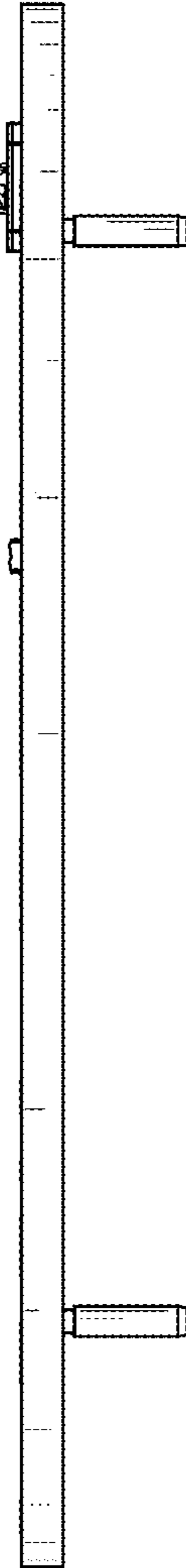

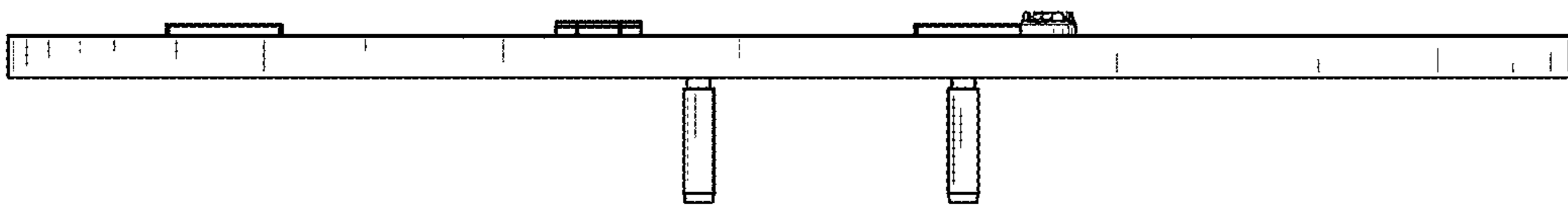

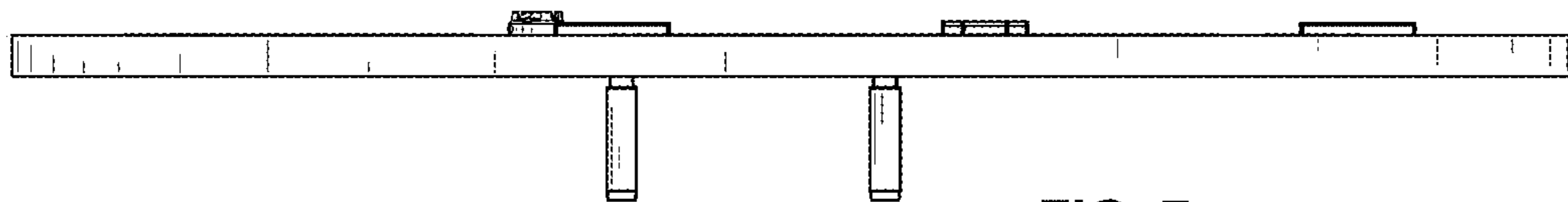
