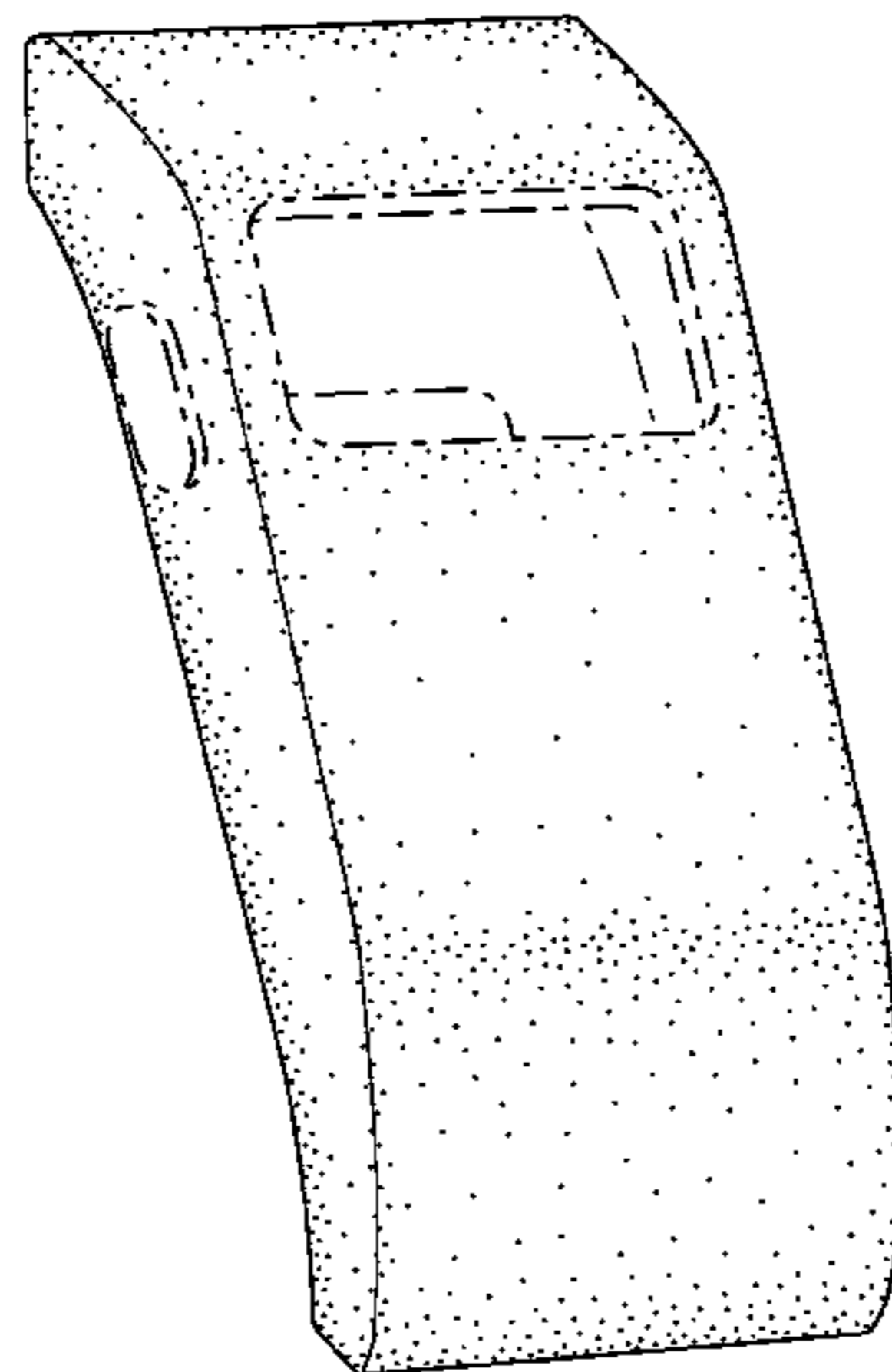
The ornamental design for a wrist band sheath, as shown and described.

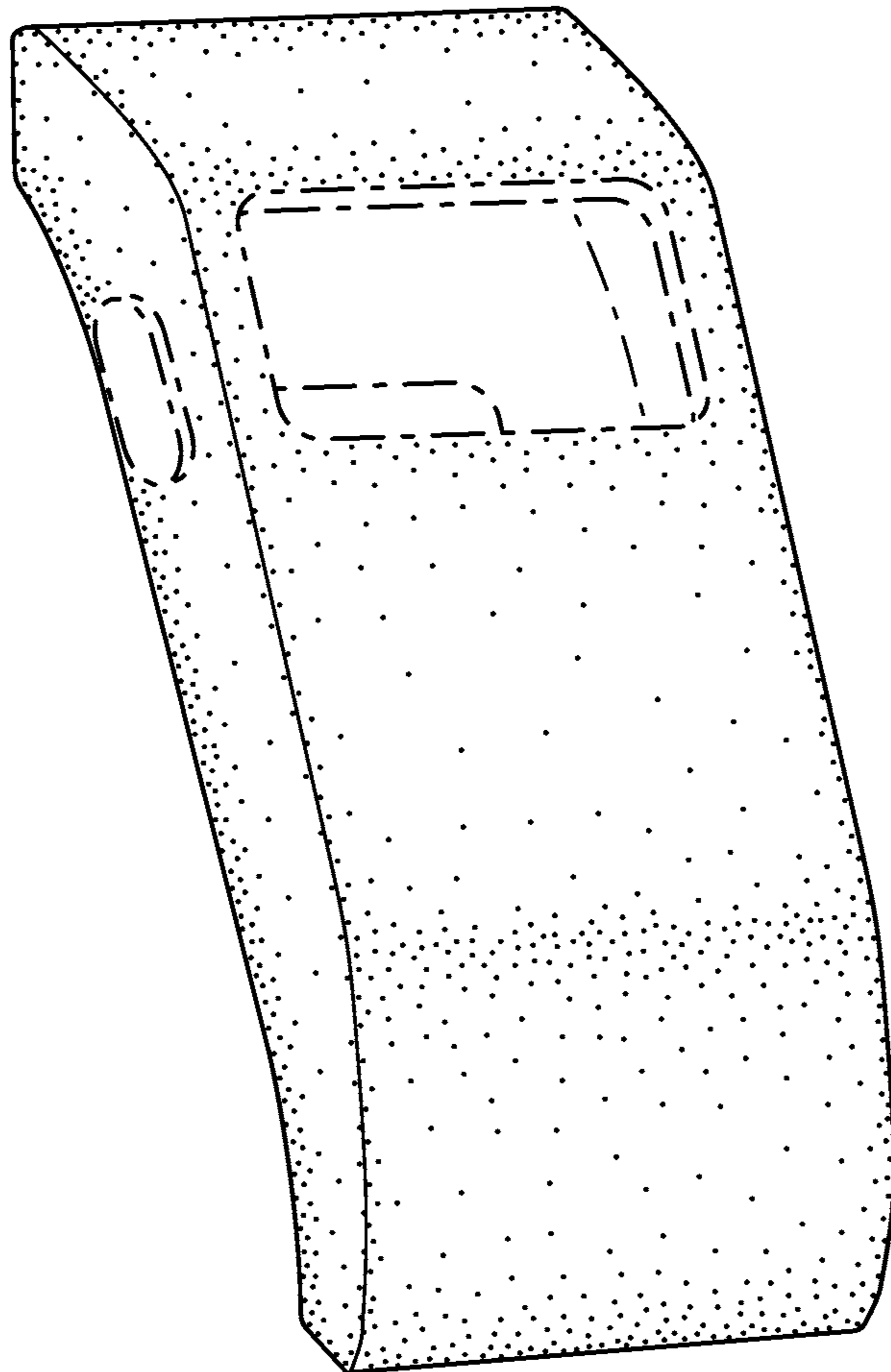

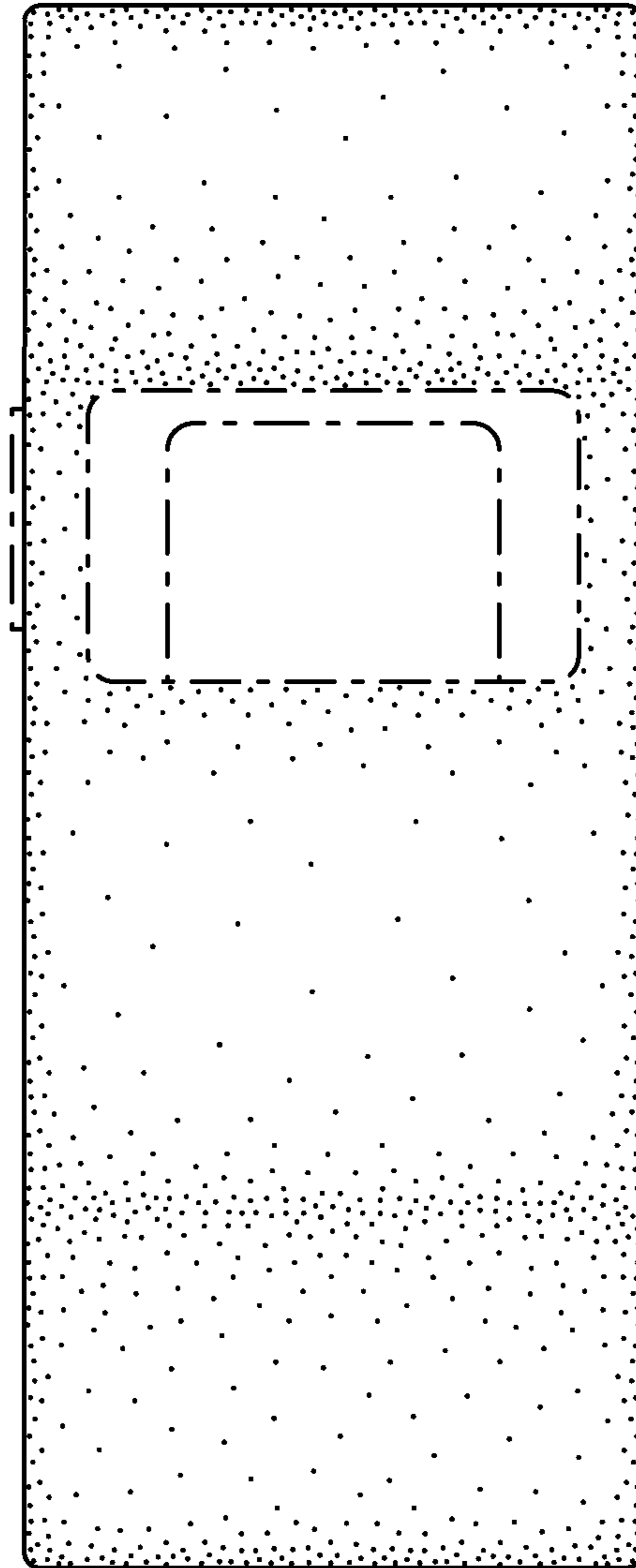

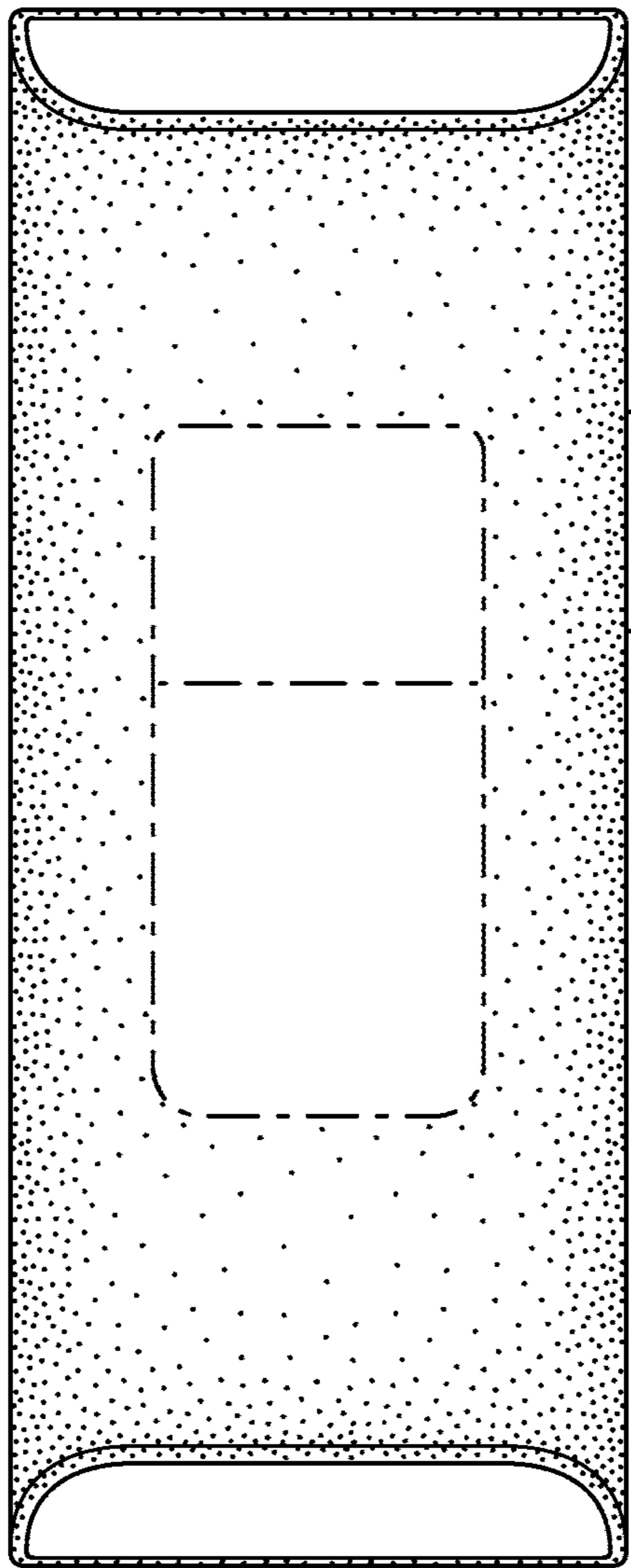

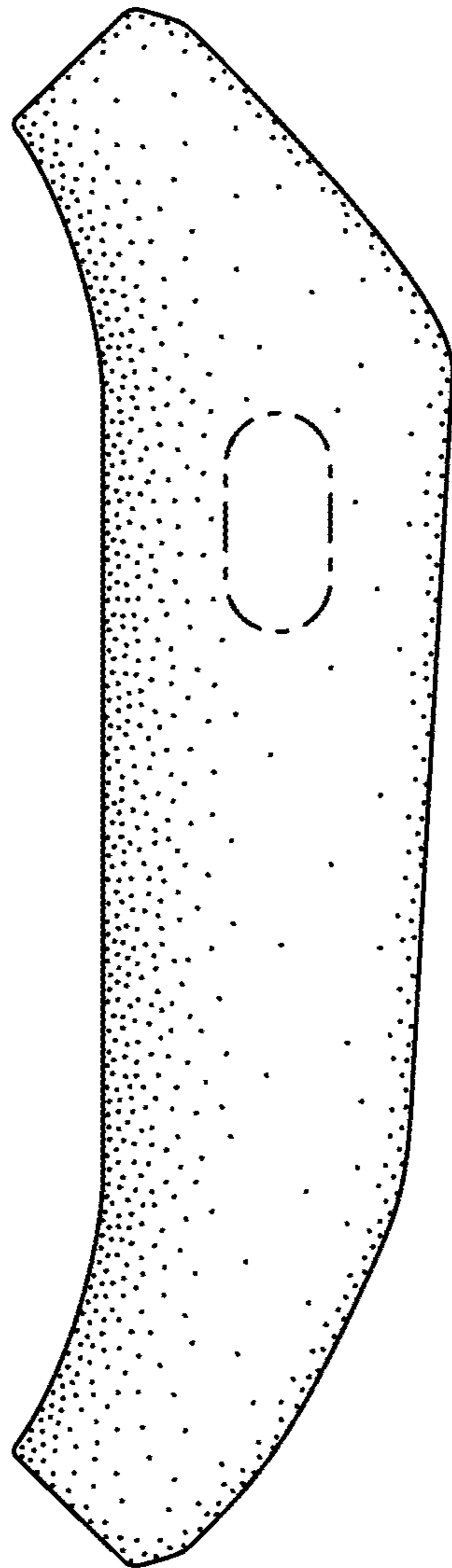

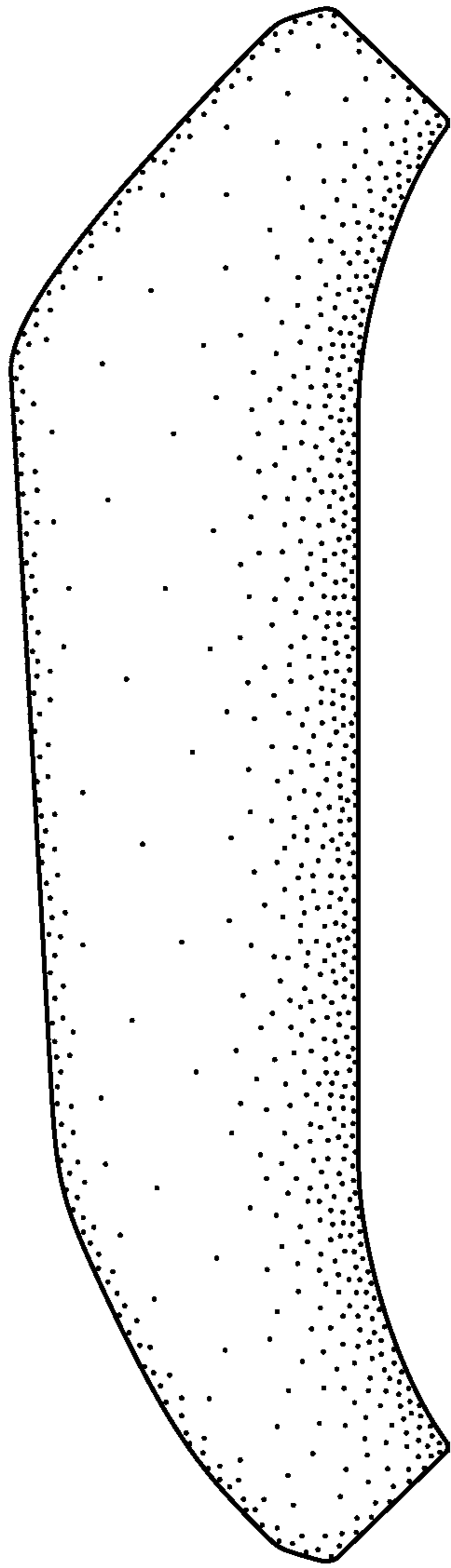

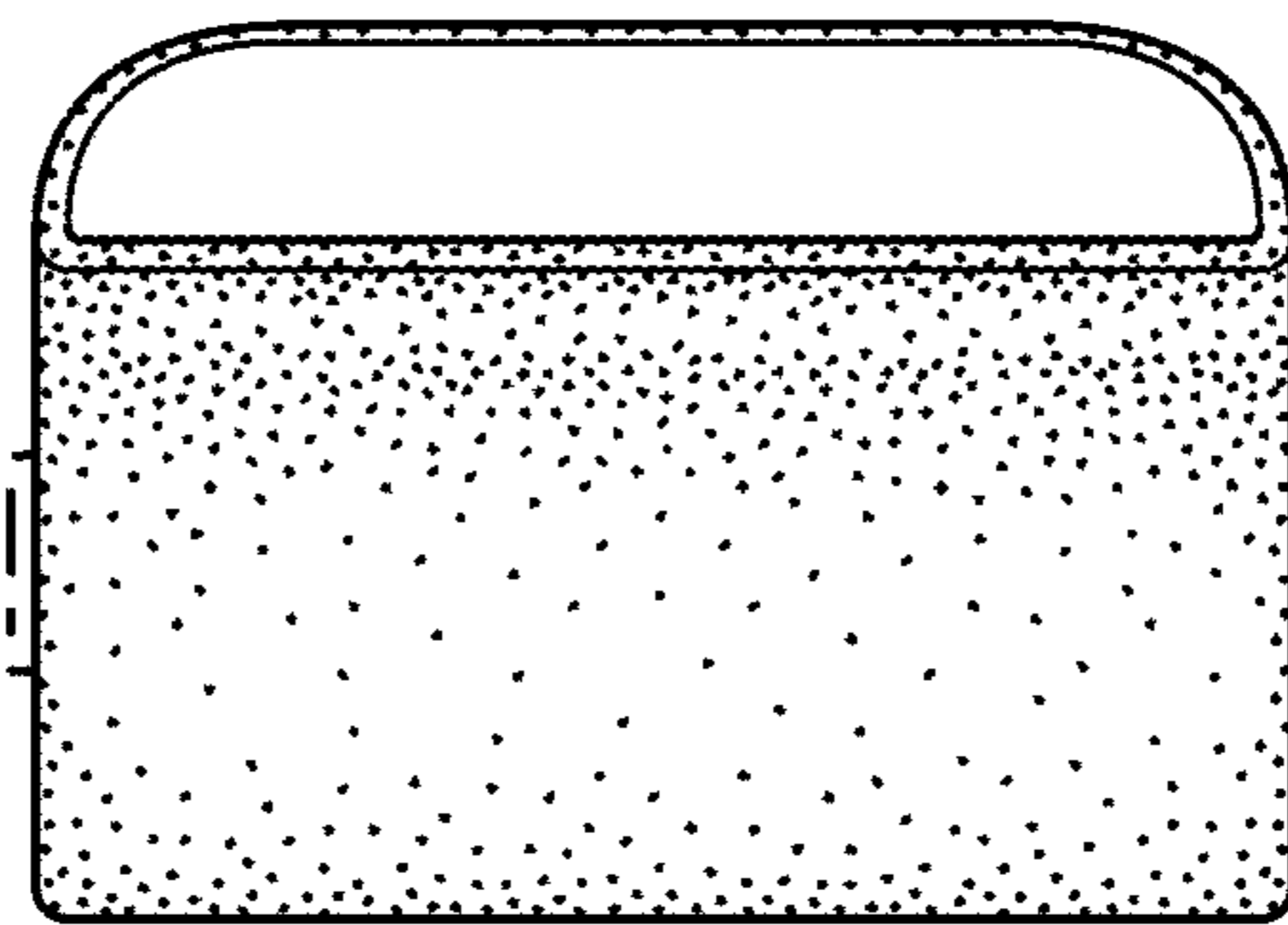

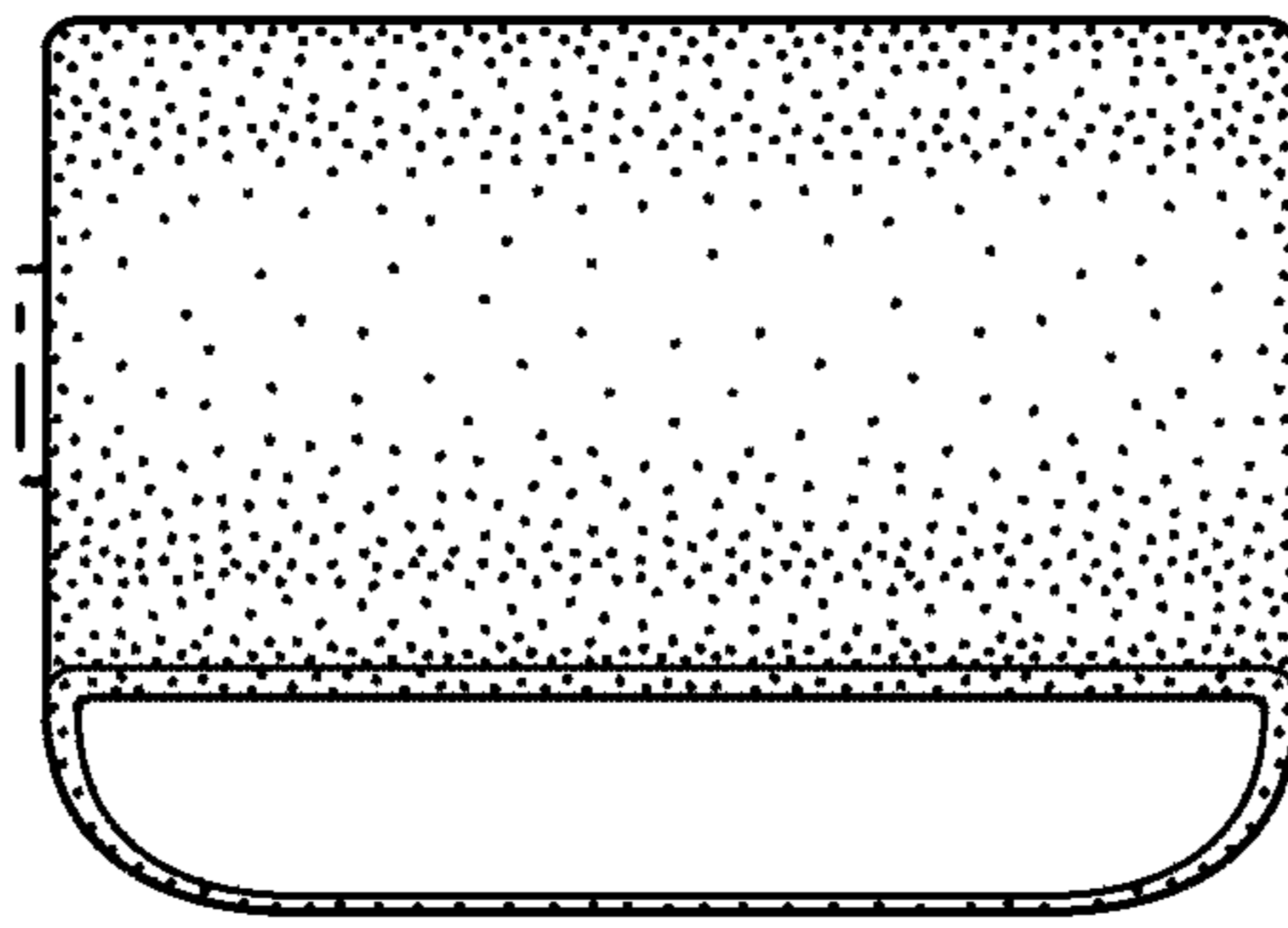

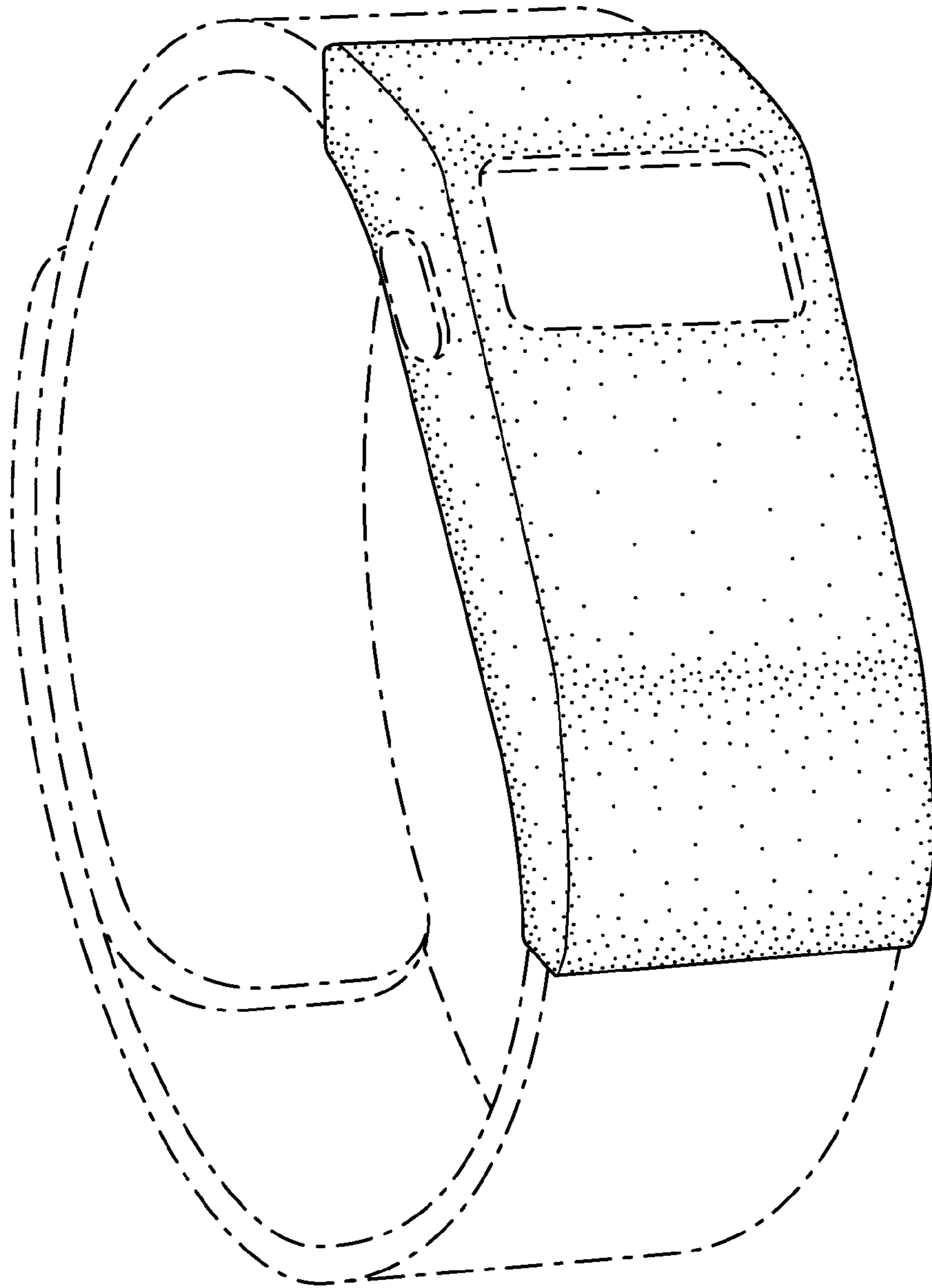

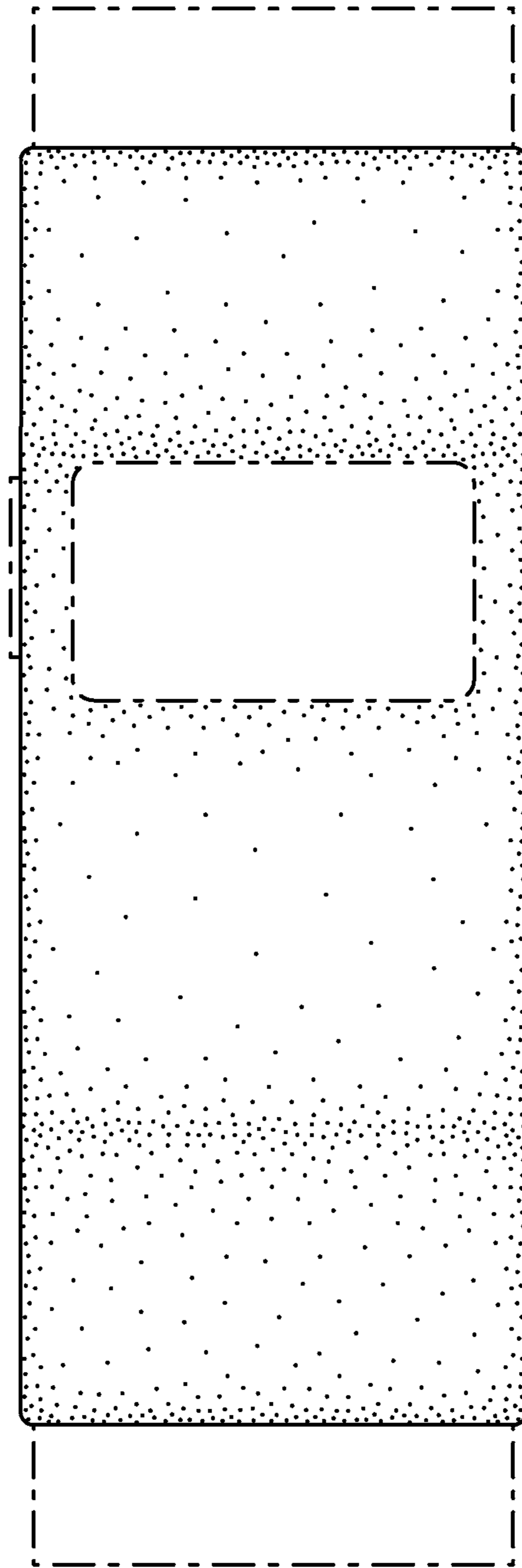

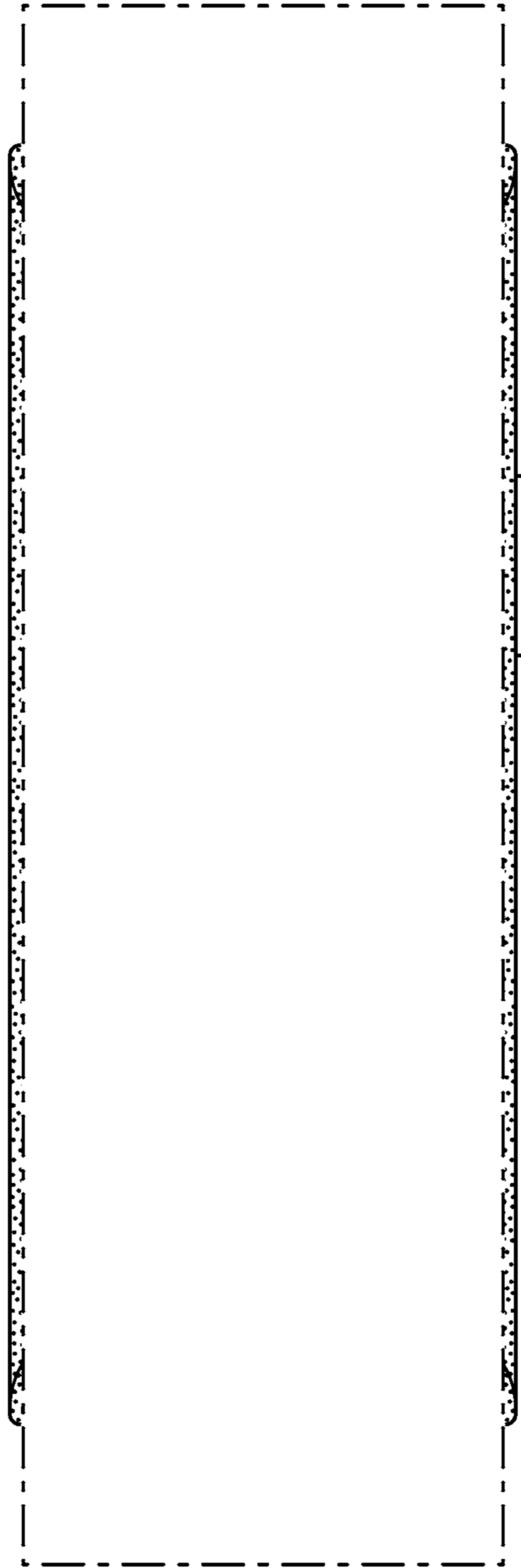

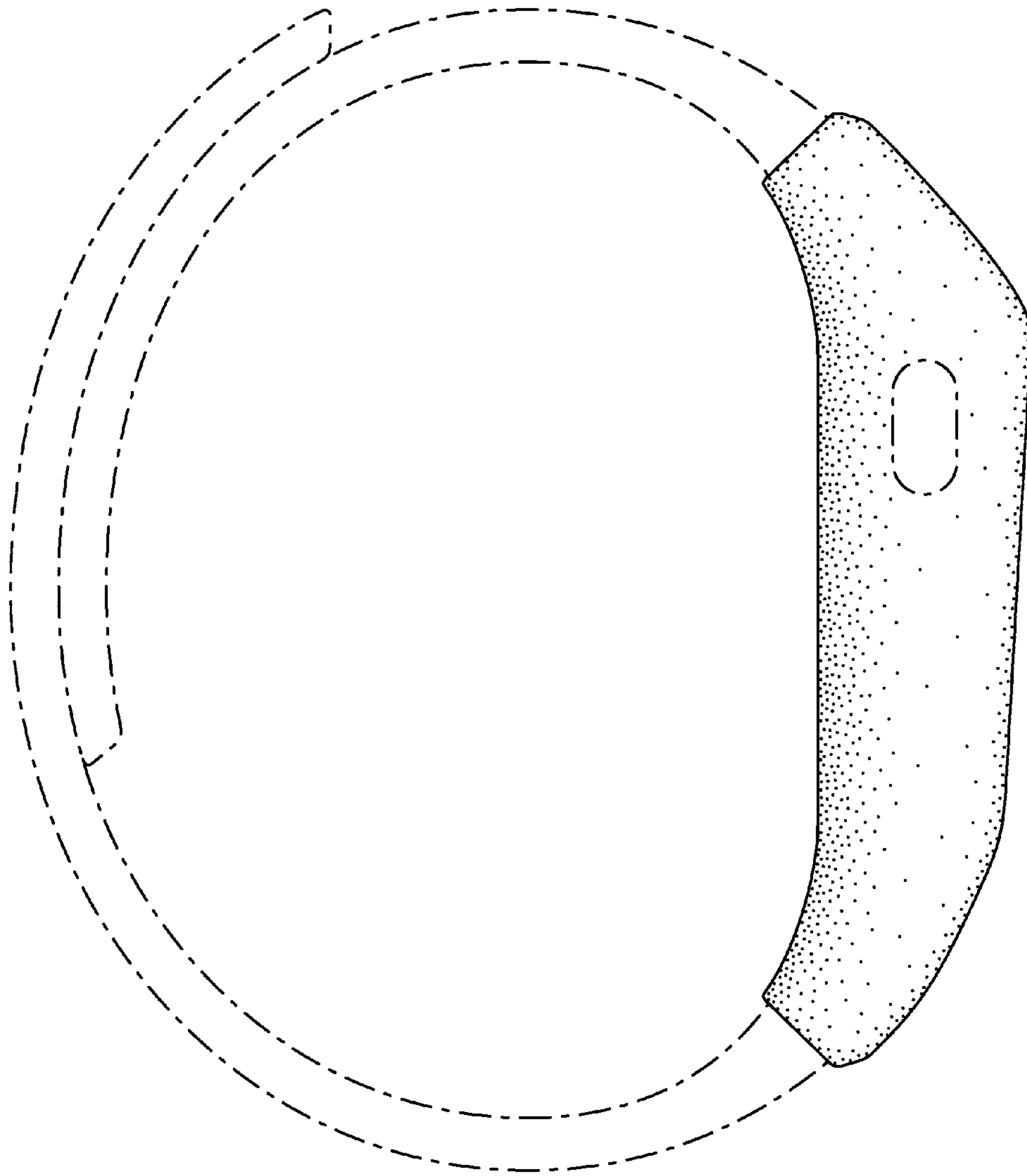

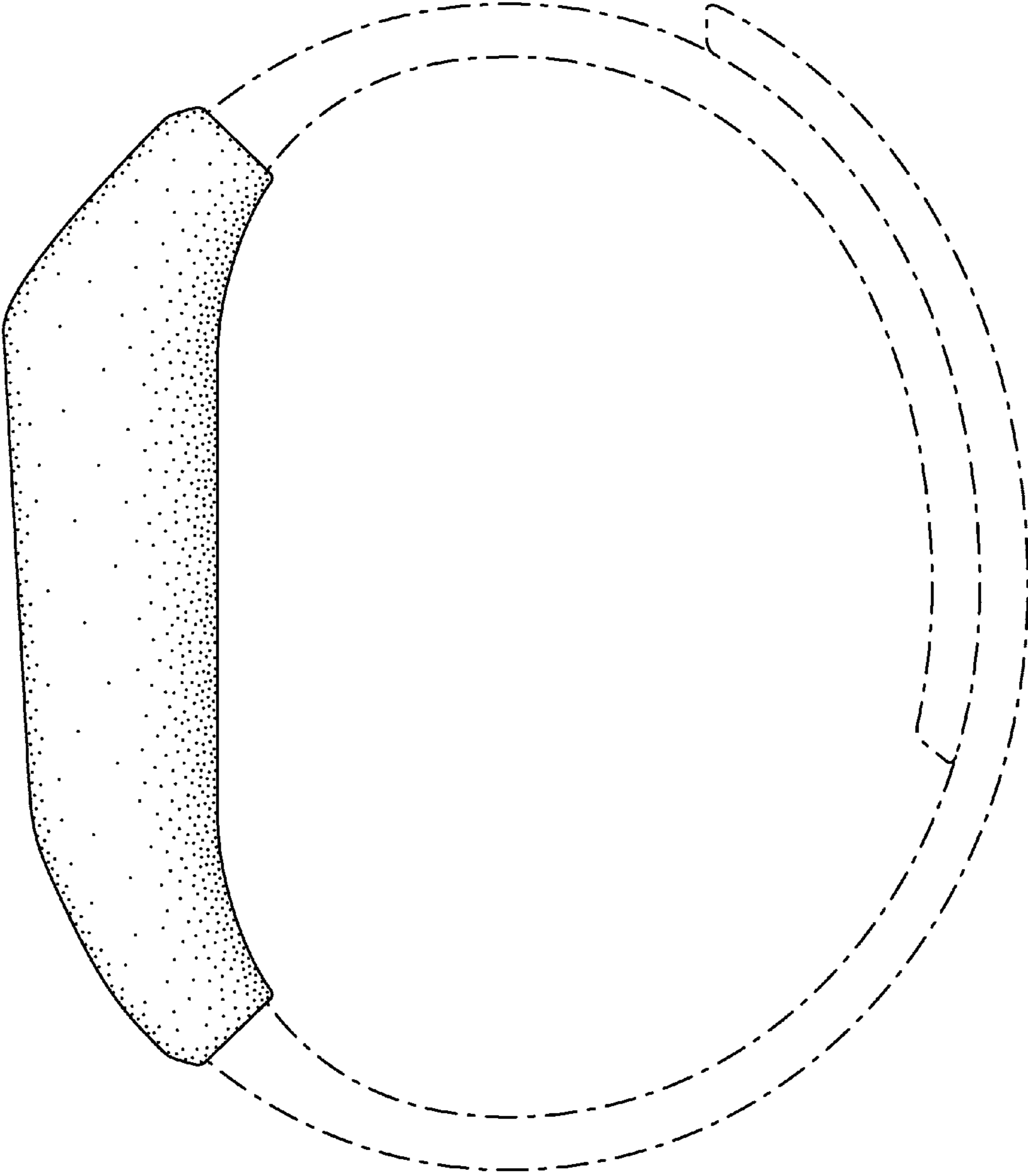

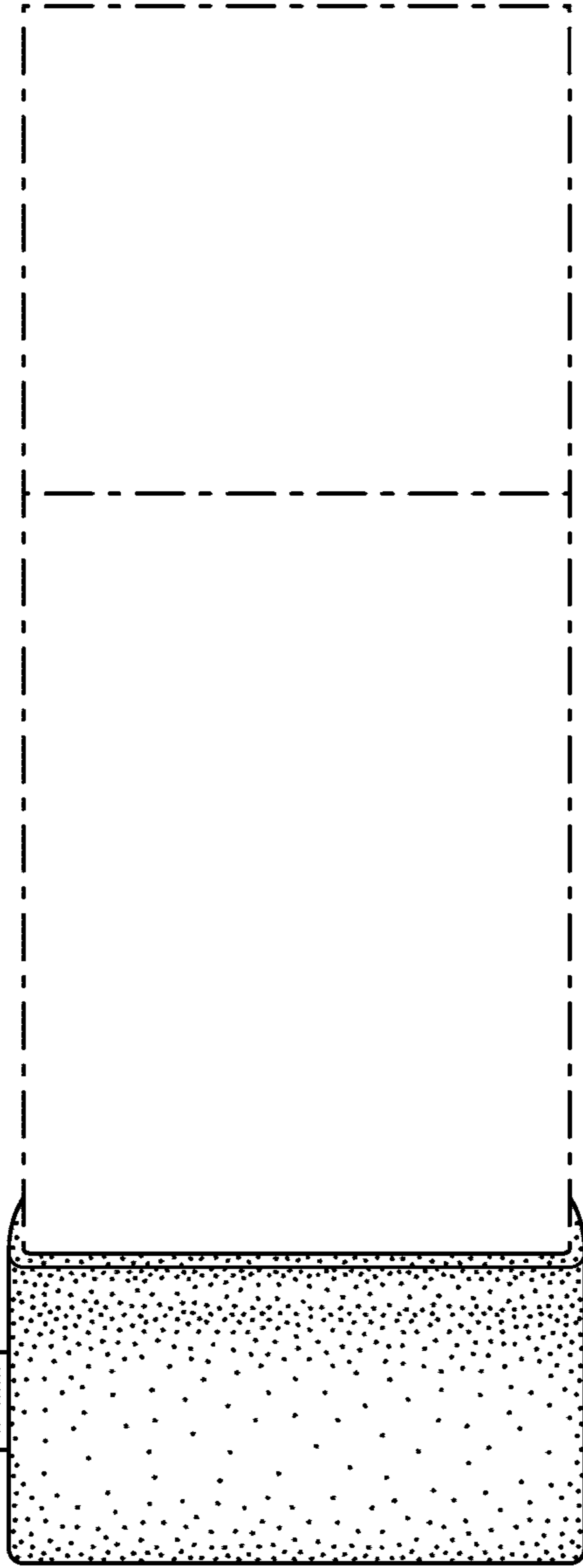

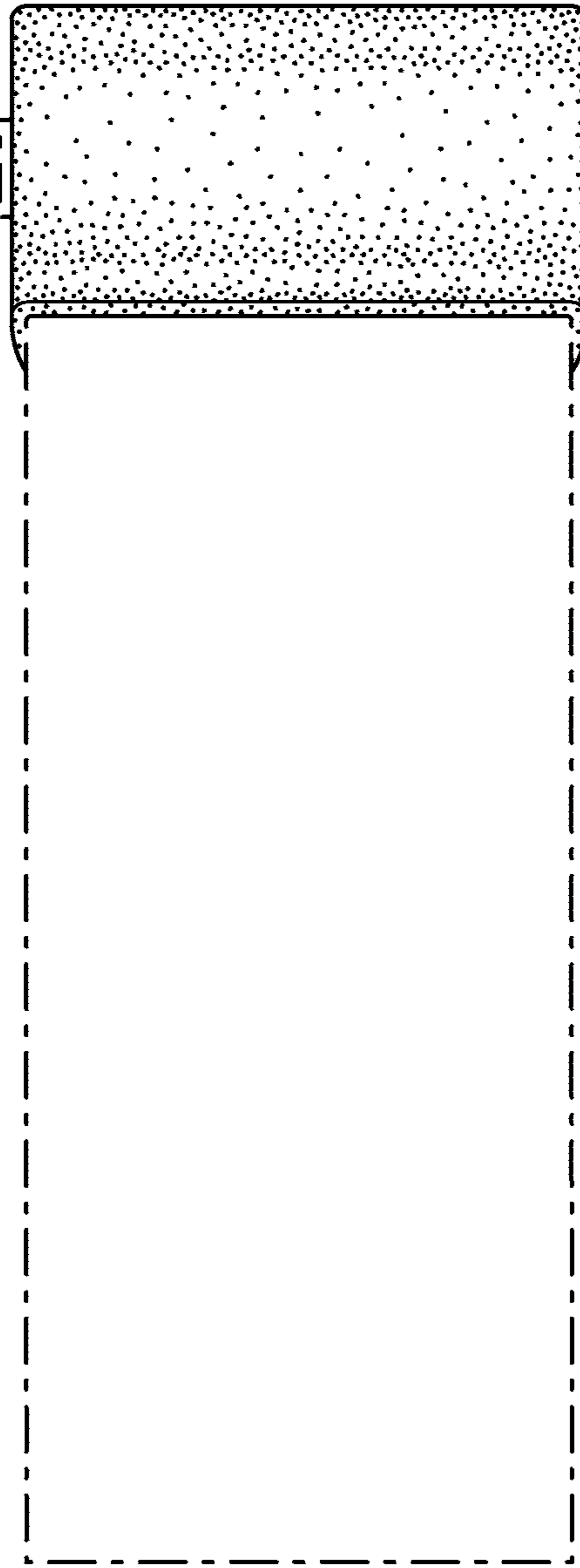
