(57) **CLAIM**

I claim the ornamental design for a giraffe trophy head, as shown and described.

**DESCRIPTION**

FIG. 1 is a right-front perspective view of the giraffe trophy head;  
FIG. 2 is a front view of the giraffe trophy head shown in FIG. 1;  
FIG. 3 is a right side view of the giraffe trophy head shown in FIG. 1;  
FIG. 4 is a back view of the giraffe trophy head shown in FIG. 1;  
FIG. 5 is a left side view of the giraffe trophy head shown in FIG. 1;  
FIG. 6 is a top-right perspective view of the giraffe trophy head shown in FIG. 1; and,  
FIG. 7 is a bottom-left perspective view of the giraffe trophy head shown in FIG. 1.  
The broken lines shown illustrate environment and forms no part of the claimed design.

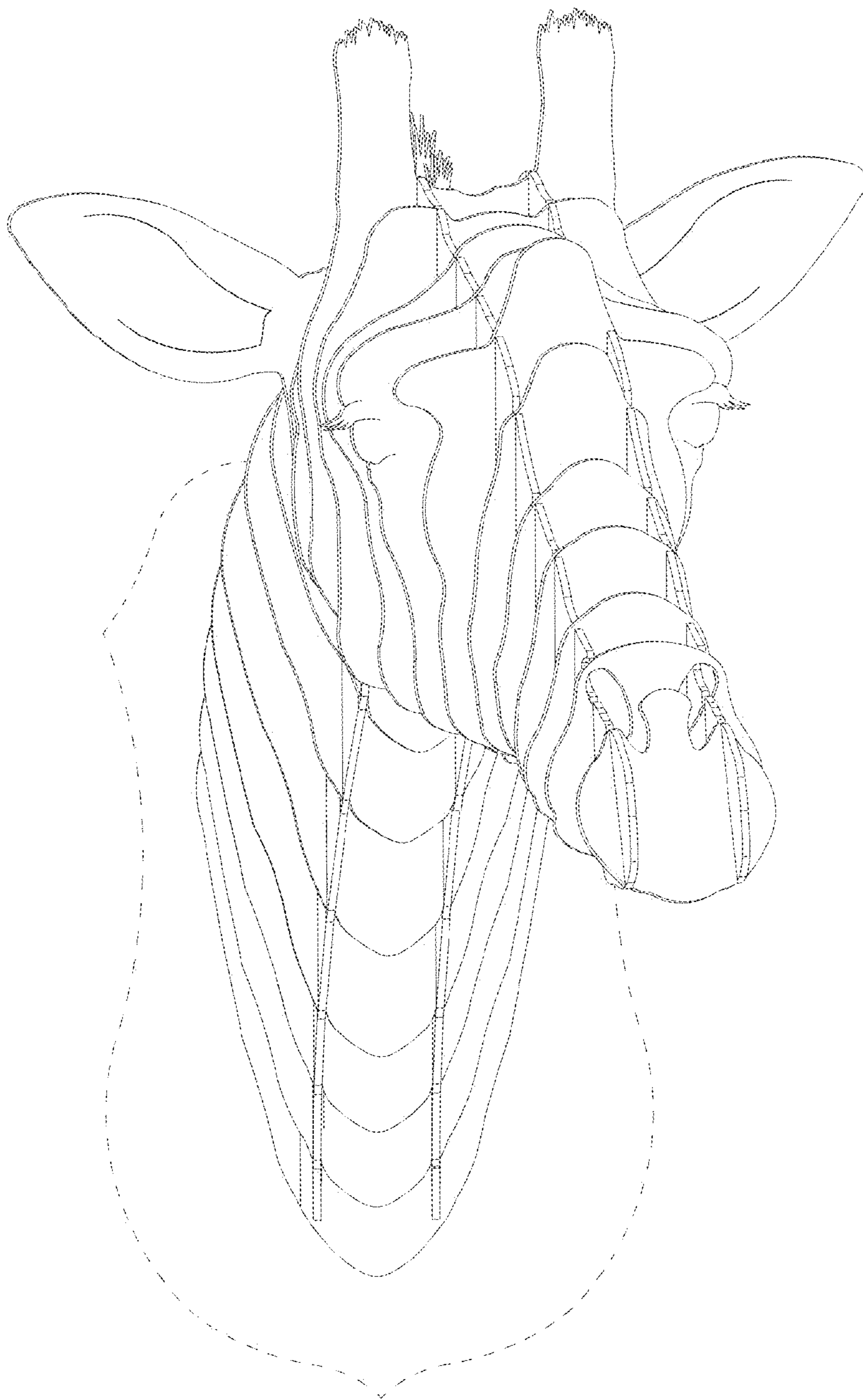

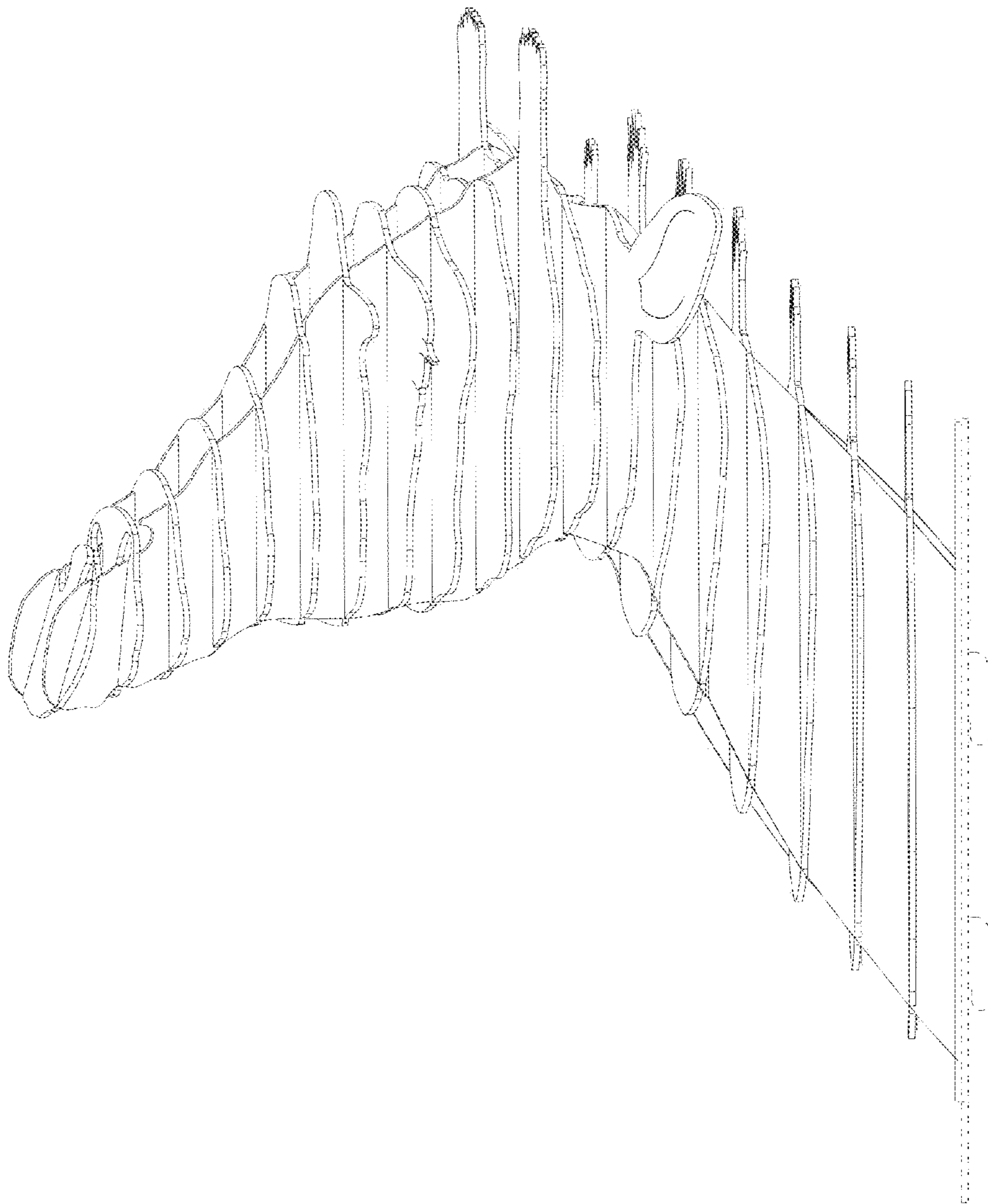

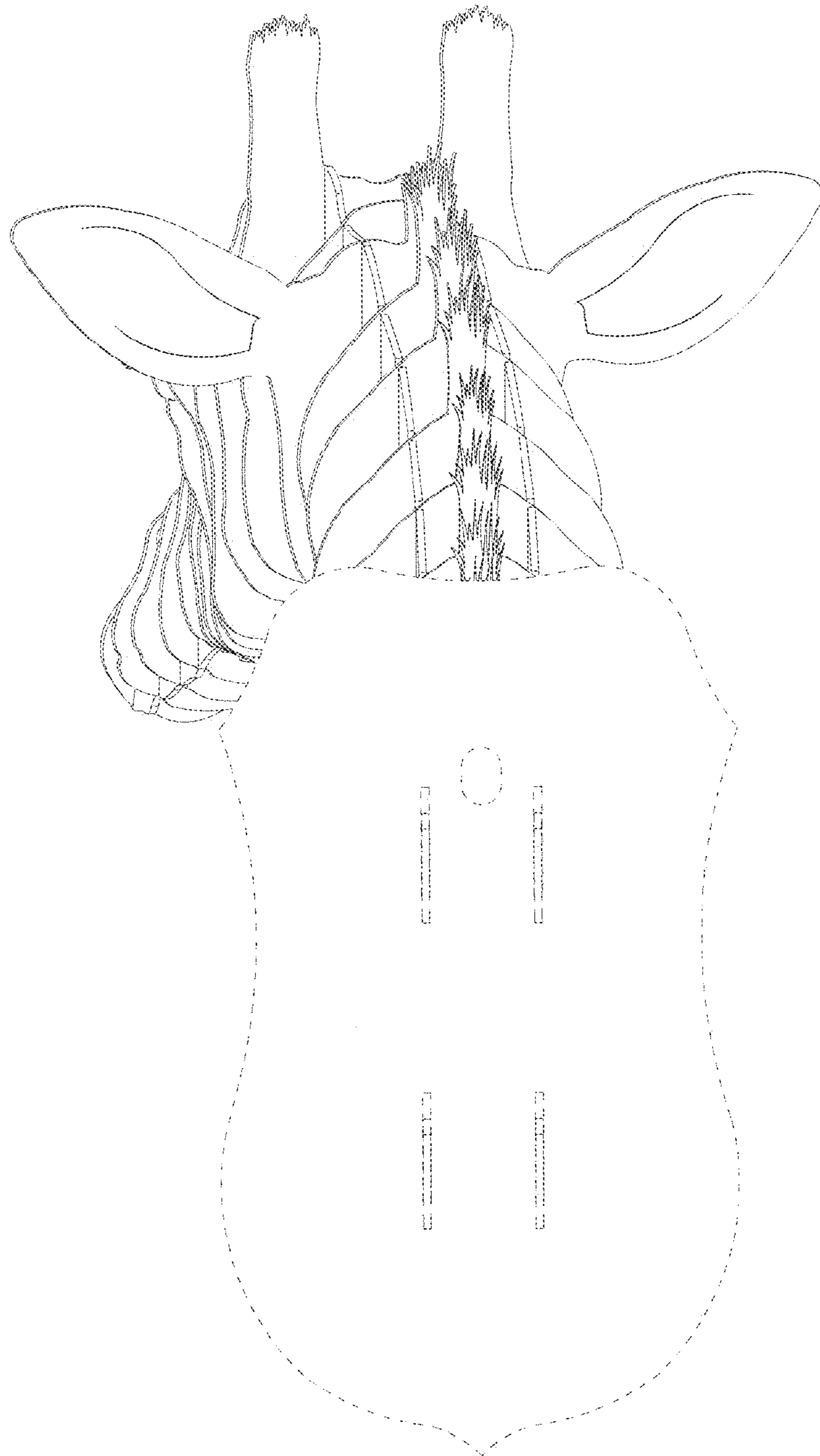

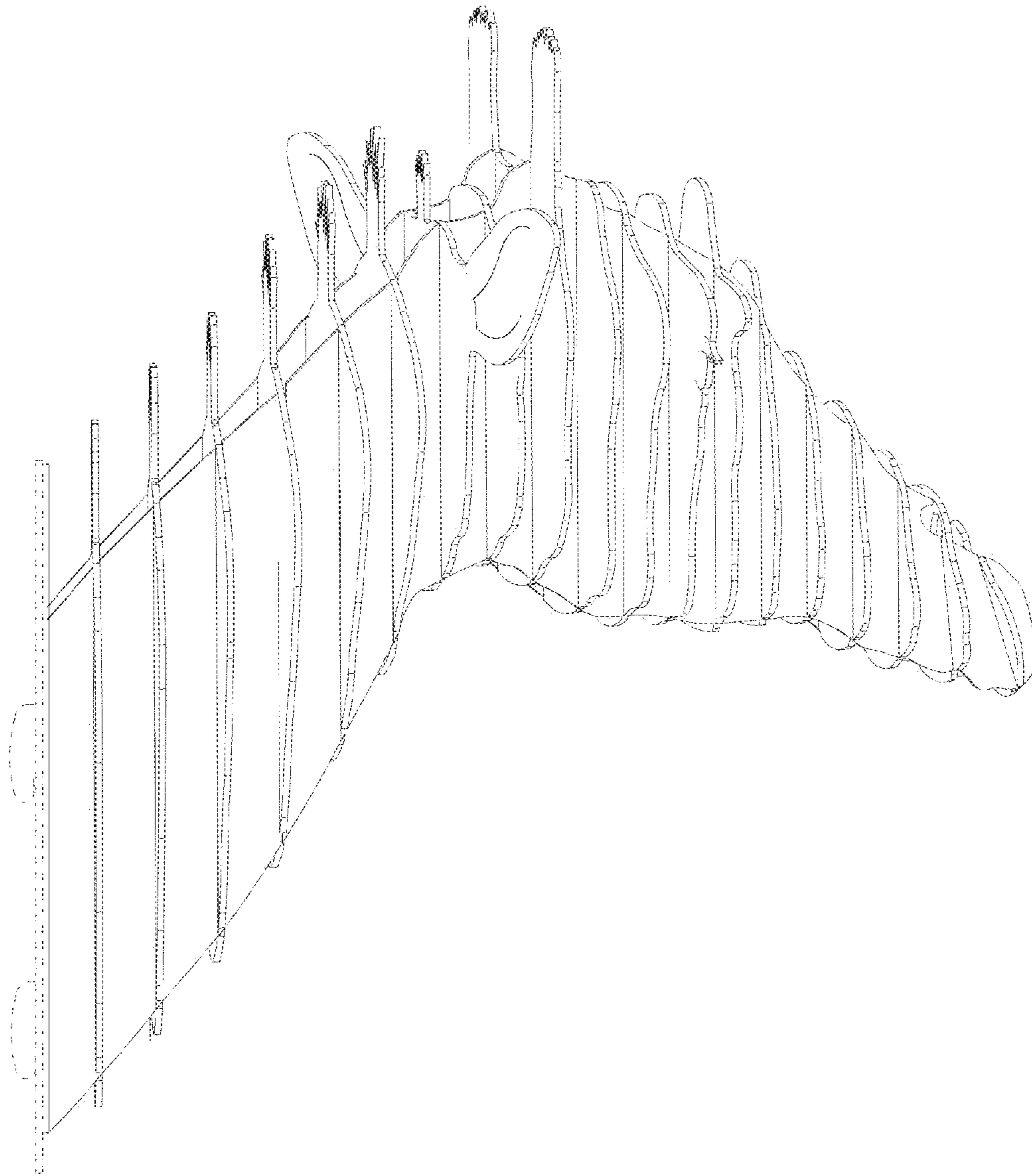

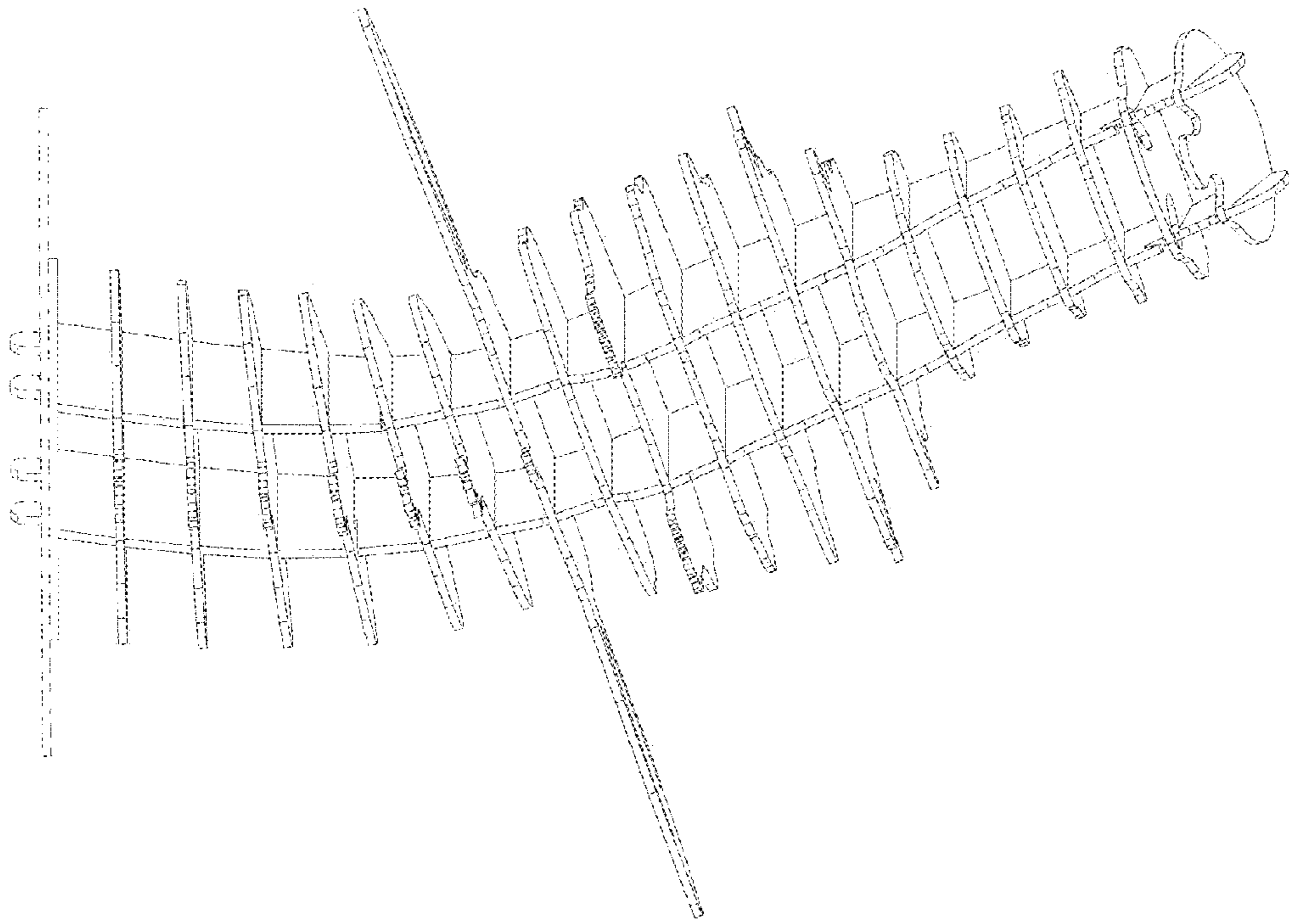

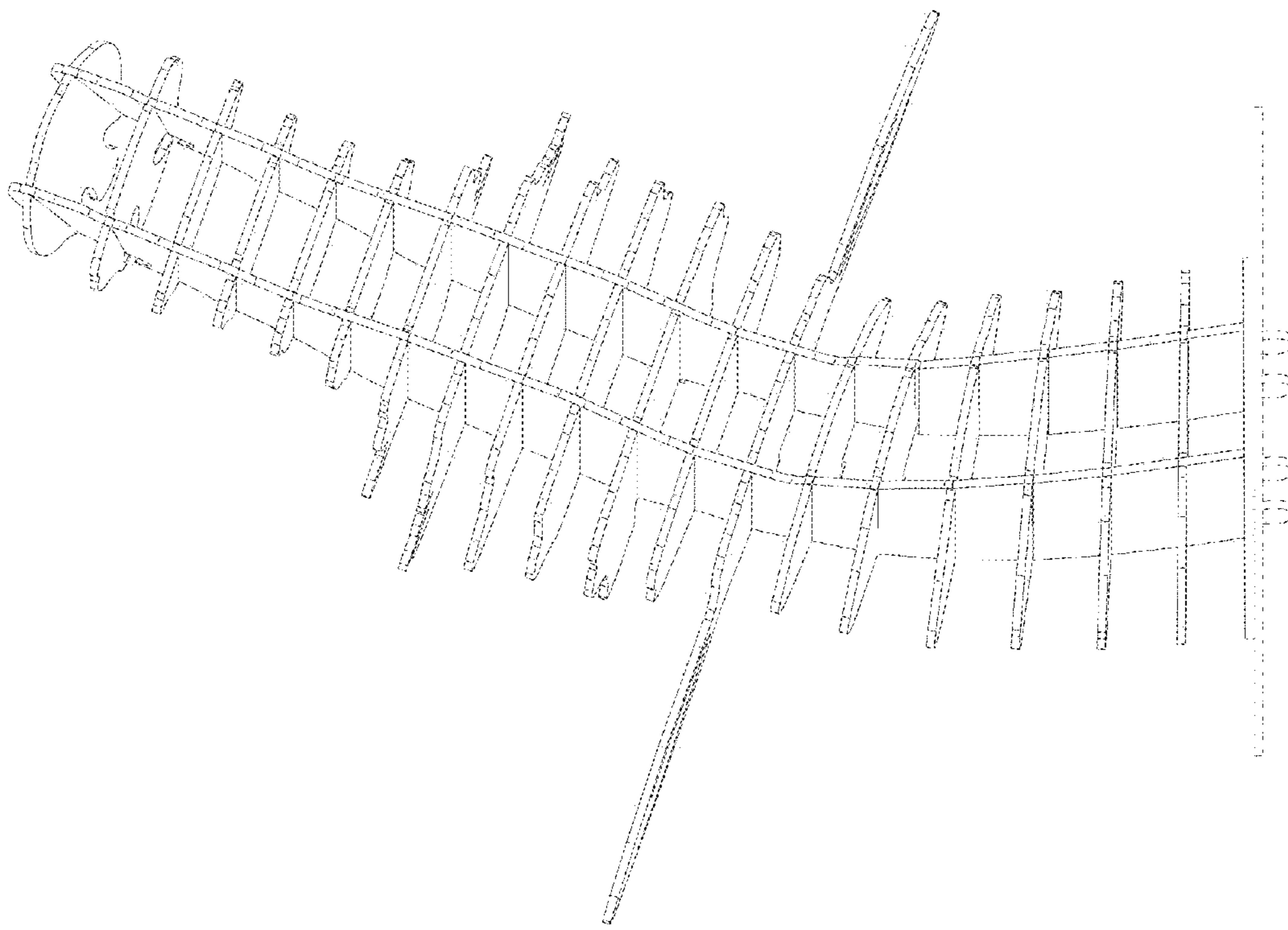
